Split City Council Approves Labor Agreement with Police Officers Association

Finally wrapping up negotiations that initially started back in 2014, the El Segundo City Council on Tuesday night approved a new labor contract with the El Segundo Police Officers Association (POA). The decision was a split vote, with Mayor Suzanne Fuentes and Councilmember Mike Dugan opposed to the deal. The agreement takes effect as of March 4 and will run through September 30, 2018.

Under the terms of the memorandum of understanding (MOU), the POA employees—currently 54 sergeants and officers—will now pay the full nine percent of their PERS retirement member (employee) share—applicable to both salaries and special compensation. To offset this concession, base salaries will go up 13.5 percent.

The MOU also modifies special compensation parameters by reducing the number of education incentive levels as well as the amount of tiers for longevity pay (from five down to three) for future hires. City Manager Greg Carpenter noted that these moves will result in long-term savings. Additionally, vacation payouts will be calculated at the base salary only rather than the regular rate of pay—thereby eliminating the nine percent employee pension contribution portion from the total equation. Sick leave will see a reduced hours cap and will also no longer be counted into overtime hours worked (unless it is forced overtime). Ten employees who already accumulated excess hours will get a one-time sick leave payout at the regular rate. The health insurance monthly contribution will max out at \$1,425 a month (up from \$1,334.91) and employees will be responsible for any further increases. The agreement also eliminates the annual \$750 uniform allowance, saving the City \$60,000 a year.

Carpenter pointed out that though the salary increase will cost the City an additional \$1.1 million-plus a year, the \$900,000 savings on the pension side erases most of it. The total additional hit to the City for 2016/17 is just

under \$250,000 with the vast majority of that due to one-time payouts. Next year's impact will be \$128,000. Carpenter opined that the agreement puts the City in a better long-term position dealing with future costs while also helping its recruitment prospects by offering more competitive salaries.

In voting against the deal, both Fuentes and Dugan spoke of their desire for consistency with all the bargaining units. The Mayor also stated that the POA “interjected itself in the last election” and “dragged out negotiations until it had a sympathetic Council.” Dugan added that “several items agreed on early were reversed” and felt that the entire process was “not our City’s finest hour.”

In supporting the MOU, Mayor Pro Tem Drew Boyles said the terms are more transparent, simplify various issues and reduce long-term pension costs. Councilmember Carol Pirsztuk

agreed, calling this a streamlined contract with simpler language for implementation. Councilmember Don Brann pointed out that the dragged-out negotiations hurt employee morale. He criticized the Council’s previous attempt “to solve all the issues in one fell swoop.” He added, “It’s all about trust and relationships and that’s how we got to tonight finally—and that’s how we’ll make progress and build hope in the future.”

Also on Tuesday, the Council adopted by a 3-2 vote (with Fuentes and Brann dissenting) the revised development standards for regulating two-story homes and second story additions in the R-1 single family residential area. As covered at the last meeting, the code does away with modulation (previously required indentations along interiors) that was viewed as confusing and prohibitive for architects and contractors. In its

Ask Around Before Hiring Rainy-Day Repairs

Everybody talks about the weather but nobody seems to do anything about it, Mark Twain famously said. The deluge of rain this season is the exception. It came a year later than anybody expected, and California residents and their water agencies to the north are working against the clock trying to avert major disaster in the town of Orville.

All of this wet stuff was a no-show last year after meteorologists warned of a powerful El Nino, which turned into a dud. South Bay cities reached their normal yearly rainfall amounts by Valentine’s Day, and that was before last weekend’s storms rolled through and dumped up to

four more inches. Rolling Hills had almost 17 inches before the weekend, while El Segundo, Manhattan Beach and Redondo measured 12 to 13 inches, according to Los Angeles County Department of Water and Power.

The arrival of the rain this season is a welcome relief for our parched state. However, it also exposes the effects of sun and the elements on buildings and roofs, windows and doors, and delayed maintenance and repairs to them. Rain damage to homes and commercial buildings worsens with every storm, especially back-to-back systems that don’t allow time for standing water to dry. It’s dangerous

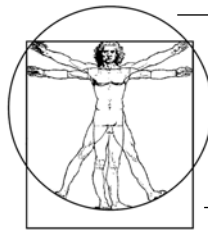

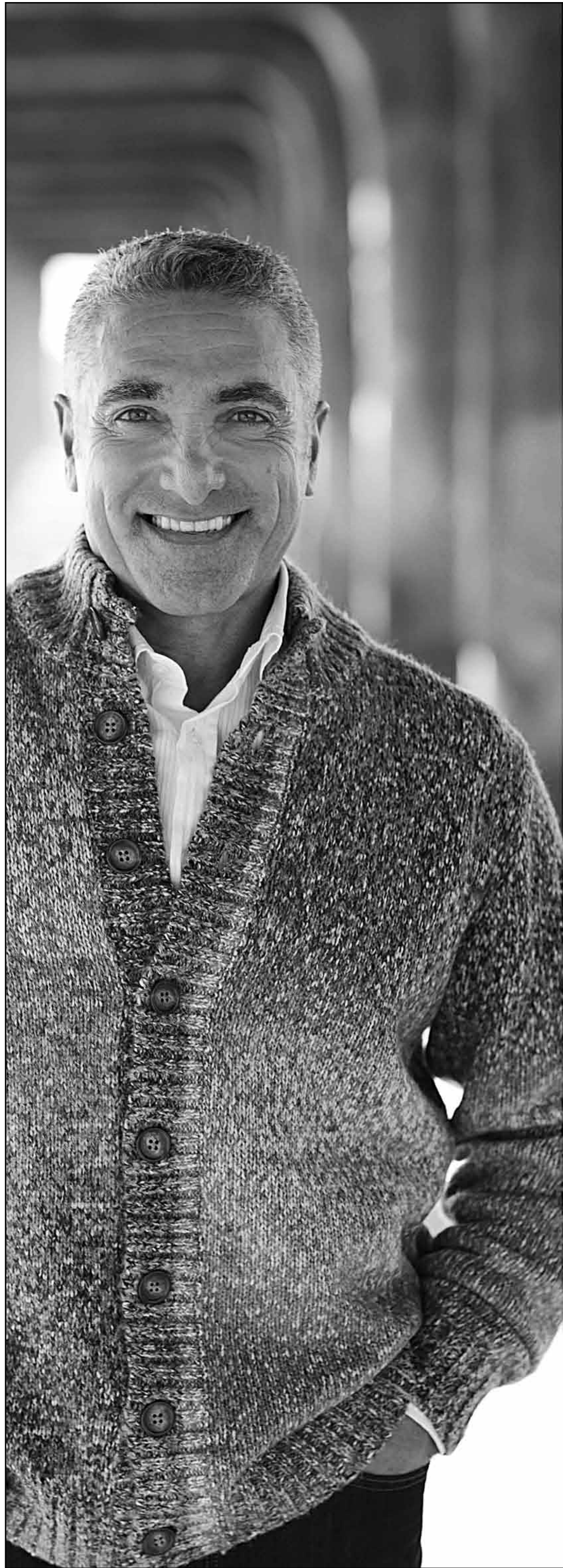

SoCalGas to Install New Pipeline in El Segundo, Manhattan Beach and Hawthorne

Southern California Gas Co.(SoCalGas) announced last week that work to install a new 2.8-mile natural gas transmission pipeline in the cities of El Segundo, Manhattan Beach and Hawthorne would begin in the week of February 20. The project will enhance the reliability of SoCalGas' natural gas pipeline system that serves homes, businesses and critical facilities in the region.

The excavation and pipeline installation work will begin in northwest downtown Manhattan Beach on Highland Avenue and extend along Highland to Rosecrans Avenue, then east along Rosecrans to the intersection of South Aviation Boulevard and 33rd Street in Hawthorne. SoCalGas crews have already installed 700 feet of the new pipeline from Highland Avenue to Alma Avenue and along Highland Avenue to about 39th Street and will not work in that area again.

Installation of the remainder of the pipeline will be conducted in several locations, with one crew working during the day and a second crew at night. The project is expected to continue through May 29, weather and other factors permitting. While crews work on each section, commuters should expect temporary lane closures and parking restrictions.

Lane reductions will be marked with traffic cones and be in effect during work hours, Monday through Friday from 8:30 a.m. to 3:30 p.m. on Highland and Rosecrans west of Sepulveda Boulevard. Construction on Rosecrans, east of Sepulveda, and along South Aviation, will be carried out at night, from 9 p.m. to 5 a.m. weekdays.

People passing by the work site may see excavation, equipment, vehicles and traffic control signage. Drivers should adhere to all traffic safety measures while driving past the construction zone. The nearby community may also hear some work-related noise and notice an occasional natural gas odor when final connections to the system are made.

SoCalGas strives to provide continuous service of natural gas to its customers while the construction work continues. Customers should not expect any interruptions in their natural gas service. If that changes, affected customers who may experience a temporary interruption in their natural gas service will be notified by SoCalGas directly. Customers with questions or concerns about the construction work may call SoCalGas' Customer Contact Center 24-hours a day, seven-days a week at 800-427-2200. •

Film Review

Every 40 Years Tells a Father's Rock Star Past

Film festivals are showcases for new movies that are hoping to get picked up for distribution. One that premiered at this year's Santa Barbara International Film Festival is *Every 40 Years* (for our exclusive interview with the film's directors, visit www.cinemacy.com)

Many people cringe at the thought of their parents' wild and crazy antics as young adults, during the years of pre-children responsibility. Director Eric Goldrich was so infatuated with his dad's unknown past life--a man whose title, as far as he was concerned, was only that of "father,"--that he set out to investigate his family's history. What he discovered about the identity of his unassuming dad turned out to be a giant surprise in the form of an underground rock and roll icon of the 1970s. This is the premise of the documentary *Every 40 Years*--an enjoyable journey of discovery and second chances.

Goldrich, along with co-director Ben Friedberg, takes audiences down memory lane as he explores his dad's involvement in the band Gunhill Road, 40 years after the group broke into the Billboard Top 40 charts. His father Steve Goldrich, (Piano/Vocals) and his bandmates Glenn Leopold (Guitar/Vocals), Gil Roman (Original Bass/Vocals) and Paul Reisch (Bass/Vocals), recount their days as an up-and-coming band, playing shows at the legendary venue The Bitter End in New York City.

While they seemed to have a promising career after the release of their first and second records (the latter of which Kenny Rogers produced), shady deals and other external factors caused the group to go their separate ways. Intimate interviews capture the heartache felt by the members at that time. Even 40 years later, the raw emotions are still there. However, when an opportunity arises to reunite for one final show, the former bandmates jump at the chance, much to the delight of their fans and the guys themselves.

The title is a bit misleading to me. For some reason the phrase "Every 40 Years" conjures up feelings of heaviness and dramatic longing. But after watching this film, one thing's for sure. If these guys weren't musicians, they would have made a killing as stand-up comics. Aside from being funny, it is obvious that those who are fans of Gunhill Road will get a kick out of seeing them back in the spotlight. Whether or not you're a Gunhill Road fan, the universal theme of passionate living and believing in second chances will no doubt resonate with audiences.

A balanced blend of thoughtfulness and boogie, *Every 40 Years* is as humble a film as the band members themselves. Once described as "The Best Opening Act" during a residency at The Bitter End, the film mimics the gravitas of an opening act band. It's fun, not too serious and, above all else, entertaining. •

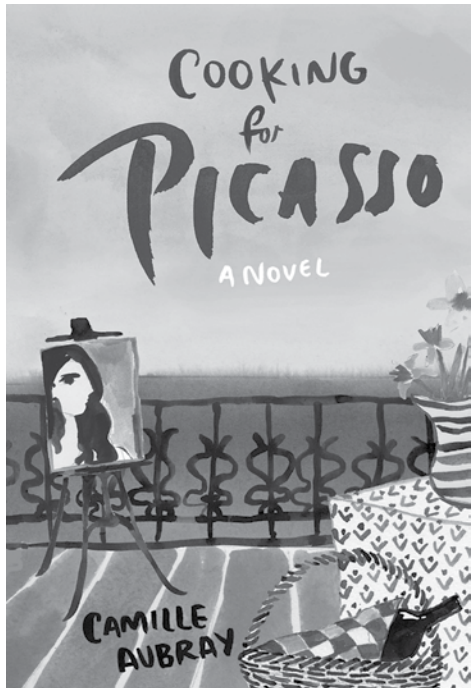

this year, we've had plenty of opportunities to do just that. If you're looking for titles to add to your to-read list, give Camille Aubray's *Cooking for Picasso* a try.

The novel opens in the French Riviera, spring 1936, with a 17-year-old Ondine delivering lunch from her parents' café to a mysterious new customer at a nearby villa. The patron turns out to be Pablo Picasso, and they embark on a heated summer of discovery and shared passions.

Fast-forward to present day, when makeup artist Celine discovers that her grandmother

Ondine once cooked for Picasso. With the hint of more family secrets to uncover, Celine embarks on a journey to the small French town where Ondine and Picasso met. While there, Celine unravels the mystery of her family's heritage, while also discovering her own passions.

Rainy-Day

to climb on a wet roof, and hiring somebody to do it is costly too.

Property owners understandably get nervous when they see leaky roofs, windows and doors. However, dishonest and unlicensed repair companies come out of the woodwork too when rain batters South Bay homes and businesses. Seniors are most vulnerable to sales pitches for storm repairs from construction companies, promoting a consumer alert from the L.A. County District Attorney's Office. "Advertisements on social media sites, flyers and other publications promising low-cost work such as roofing repair or flood protection may sound especially appealing to a senior on a fixed income," DA Jackie Lacey warned. "Sometimes the workmanship is so poor that the job has to be redone later. In some cases, contractors will require a very large payment before getting started and, once they get paid, the work is never finished."

Before hiring for storm repairs, ask family and friends to refer reputable contractors who are licensed and carry proper insurance. A homeowner can be liable for a slip-and-fall accident from a ladder or roof if a contractor

doesn't carry workers' comp insurance, authorities say. Remember to ask contractors if they're licensed, then verify it at the state Contractors State License Board (<http://cslb.ca.gov>).

Tips from the Contractors Licensing board about storm damage repairs include:

- Ask to see a contractor's license.
- Call 800-321-2752 to verify the license.
- Don't rush into decisions.
- Don't hire the first contractor who comes along.
- Get three bids, check references and get a written contract.
- Don't pay more than 10 percent down or \$1,000--whichever is less.
- Don't pay cash, and don't let the payments get ahead of the work.
- Contact CSLB if you have a complaint against a contractor.

Scams by unlicensed contractors and dishonest repairmen succeed when homeowners feel rushed to make a decision. If a contractor is applying pressure to sign a contract on the spot, then that can be a tipoff that he or she is a fraud.

Reputable construction businesses give a homeowner time to compare bids before

making a decision, the State Contracting Licensing Board says. A downpour is no exception. A Southern California winter storm may huff and puff, but it won't blow down the house. "Most of us overreact," said South Bay roofing contractor John Ramey.

Rainwater dripping from a ceiling is a good bet there's a roof leak. It doesn't always require the immediate attention of a roofing professional, according to Ramey. Climbing a roof in a storm is dangerous for a roofer, and costly for a homeowner for whom water damage is a huge concern. "Unless it's a major leak, don't panic. It's just water," Ramey said. "It's hot up in an attic, so mold isn't an issue with a roof leak. That water's going to dry out in minutes or hours."

Reputable roofing contractors--those with licenses, general liability and workers' compensation insurance, and references--are in heavy demand during a rainstorm. Riding out the storm can be a better option than hiring any available roof repair company on an inclement day. "All of the good roofers are super busy. So, you have to ask yourself, 'Hey, how come this guy can come out right


now?'" Ramey asked.

Local companies charge between \$300 and \$500 for an emergency repair or to tarp the roof. California does not have a "handyman" license. All construction work that costs over \$500 in combined labor and materials must be performed by a contractor with a CSLB-issued license.


One of the Contractors State License Board's best tools to catch unlicensed contractors is an undercover sting operation. CSLB conducts stings around the state on a regular basis, including one in December in San Fernando. Investigators each year arrest hundreds of unlicensed contractors who walk into undercover operations to bid on home-improvement jobs.

The CSLB is looking for residential and commercial properties in the South Bay to stage one- or two-day sting operations. Call 562-345-7600 or email SWIFTSouth@cslb.ca.gov to help protect consumers from suspected unlicensed contractors and shoddy repair crews who target seniors and use the weather as a ruse to take their money, and then blow out of town. •

A Soccer Story: Former ESHS Star Beats Injuries to Reach Goal

From my introductory days in the AYSO to playing for El Segundo High School in the mid-1980s and then continuing on throughout my adulthood in the South Bay Peninsula Soccer League (SBPSL), my passion and love for the game of soccer has never faded. There’s something motivational and sensational about suiting up in a uniform on Sundays, taking the field with your fellow like-minded teammates and participating in an action-packed competitive sport that demands all individuals work together as a unified team to achieve success and bring home a victory. As a long-time El Segundo resident and former Honors graduate, I was once the captain of the boys’ varsity soccer team and in 1986, we the Eagles, won the All Pioneer League title and I was voted to First Team All Pioneer League as well as First Team All CIF 3A Division.

Fast-forward to March 2014 and while playing in the SBPSL, I ruptured my right

ankle. I tore the fascial tissue, dislocated and partially frayed the Peroneus Longus and Brevis tendons and thus such an injury would require surgery to fix or else I would never walk, run or move the same again. I sought out the expertise of Dr. Carol Frey, who specializes in foot and ankle injuries at West Coast Orthopedics located in Manhattan Beach off of Rosecrans.

In short summary, my personal experience with Dr. Frey, her assistants and staff members was exceptional and I would highly recommend her services. She was the perfect balance of applying the brakes, allowing sufficient time for the tissue to fully heal and recover, in contrast to my continuous foot pressure on the throttle trying to accelerate my recovery. After four different casts, one walking boot and some major muscular atrophy, I was finally set free to start my next stage...rehab. I chose to do all of my own rehabilitation, for I have been a professional

to the finals when they were defeated by Hesperia, 3-0.

Over the last 12 seasons, the Lady Eagles have averaged 19 wins each year. Different coaches led the team to the title games. The list includes Sandi Berhmann (1974), Barbara Berhlohr (1976, 1977), Debi Cocks (1978) and Keith Cameron (2007).

This season, first-year coach Megan McCann will be at the helm and looks to continue the winning ways for the Lady Eagles. The former standout from a Boston prep school who played outfield for Providence College was a coach at Serra High School for two seasons before joining El Segundo High last season as an assistant. El Segundo aims for a two in a row and certainly has the right mindset for that to happen. The other goal is to extend the playoff run. Last season, the Lady Eagles faced West Torrance in the first round and fell in 11 innings--so revenge and something to prove will be on their minds.

“We aren’t set with someone playing one position--these girls can play all of them and there’s no drop-off,” she said.

The lineup stacks up like this. At first base will be sophomore Gaby Benjamin and freshman Jade Johnson. Benjamin started as a freshman and will also see action on the mound, while Johnson will see time at second base. Bailey Ernest comes from an athletic family and looks smooth at second base.

thing to root for every night. stead is an increase in floor to area ratio (FAR) from 0.53 to 0.60—which the top floor can take up a maximum of 0.25. Brann said he is not an advocate of larger houses and doesn’t think the higher FAR is a good idea. “El Segundo has lost some its charm here,” he lamented. Fuentes took issue with a provision that requires a three-car garage for houses built to 3,500 square feet or larger rather than the lesser 3,000 square feet mandated before the code change. She expressed concerns about adverse impacts on neighborhood parking. In contrast, Dugan indicated support for the garage requirements and said he doesn’t believe residents are creating parking issues in town—but rather “other people” such as airport employees trying to avoid paying fees in lots.

The Council also passed (with Boyles recusing himself due to a conflict) the new oversized vehicle parking ordinance described in detail at the previous meeting. Brann said he was pleased to see this go forward without any fees for permitting or registration, feeling it is strictly a quality of life issue. Fuentes urged citizens who are affected by the ordinance to let the City know if it’s not working.

An item to replace eight El Segundo Police Department (ESPD) 2011 Ford Crown Victoria vehicles with new Ford Explorer Interceptor models prompted a lengthy discussion. Councilmember Dugan did not wish to allocate the \$420,677 at once—preferring to stagger it over a few years to soften the budget impact on the City. In justifying the purchase, Police Captain Bob Turnbull emphasized the need to maintain a consistent fleet with the latest equip-

ment and safety features while also promoting a strong visual image as the department has recently rebranded. He reported that officers who left ESPD for other agencies mentioned that the patrol cars in their new cities were “superior by leaps and bounds” compared to those in El Segundo. Turnbull added that he did not want to split up the purchases over time, fearing that the 2018 model will have a different design and cost more to build out. Because of constant use and wear and tear, the first responder vehicles only have a three-year shelf life—thus prompting the need to move on from the Crown Victorias (which are no longer in production). The rest of the Council voted to approve the purchase.

Earlier in the meeting, Jeff Cason—the creator of Broadway in the Park---presented an early peek at the Fireworks Spectacular scheduled at El Segundo High School on the evening of October 7 as part of the year-long Centennial Celebration. The program will tell the story of El Segundo in snapshots from the town’s formation with the Standard Oil refinery and continuing through the growth of the residential community, the ‘50s and ‘60s beach culture, the rise of aerospace and aviation, the major role of sports, and the City’s overall legacy. Cason provided a few video sneak previews showcasing pyrotechnics, original music compositions and even dancing blue butterflies on the El Segundo High bell tower. Prior to the fireworks event, citizens will be able take part in activities planned across the street at Library Park. Before Cason’s update, Recreation and Parks Director Meredith Petit reported that the Centennial Celebration

now has two dozen sponsors who have contributed \$160,000 to help subsidize the various events planned during the year. She added that El SegundoTV is airing an oral history of the community and contacting long-time residents for interviews. The City will also have a pop-up museum and egg hunt coming up. Also, kids can still turn in submissions for the February “I Heart El Segundo” coloring activity.

During presentations, the Council recognized the Battle of the Badges event on February 12 during which police and fire personnel raised

\$4,200 for the El Segundo Education Foundation by competing against each other in a charity basketball game at the Toyota Sports Center (see this week’s front page photo). Prior to this presentation and to open Tuesday’s meeting, Police Chief Mitch Tavera asked for a moment of silence to honor fallen Whittier Police Officer Keith Boyer who was shot and killed by an alleged gang member after responding to a traffic collision this past Monday. Officer Patrick Hazell also sustained injuries during the incident, but is expected to survive. •

ACE-certified fitness trainer for over 25 years and thought my current knowledge and abilities would get the job done right. I wasn't looking to simply walk again or just fulfill activities of daily living. As a former competitive amateur bodybuilder, powerlifter, multiple-sport participant and one who lives a very active lifestyle,

I was setting my recovery aspirations much higher--performance!

Less than one year later, I was back on the field conditioning myself to hopefully compete in one of the largest men's adult league amateur soccer tournaments in the United States held in Las Vegas--the King Cup 2015. Four weeks into live game speed play and driving to shoot on goal, three defenders collided with

me in the penalty box and took my left knee out in the process. There I was again, lying face-down on the turf pitch, smelling the foul rubber black pellets as reality was painfully swelling in my throbbing knee. I spent the next three days on the couch immobile, leg elevated, swapping out bags of ice. Yes, I've

had many a friend and family member suggest I give the game up and I seriously contemplated that depressing idea, but I came to an entirely different conclusion. Arnold Schwarzenegger said it best, "I'll be back!"

After the swelling finally subsided, I did a self-analysis of my knee. I had anterior, posterior, medial and lateral damage, but I thought my menisci were intact. I figured I

would evaluate every two weeks to see if I improved in any area of pain free range of motion, joint stability and/or muscular strength. If not, then I would seek out professional help and services. Thankfully, albeit some weeks only by millimeters, I made consistently slow but positive progress. One year later, after

in three days played in six soccer games to win the over-40 division, King Cup Championships. Talk about a complete turnaround in emotions, I went from the depressing thoughts of never playing again to achieving victory and jubilation of soccer success.

Looking at the team photos past and

completing my rehab protocol and weight room activity to acceptable levels, the next four to six months I would be focusing on athletic field work conditioning. So, after a year-and-a-half since the left knee injury and two-and-a-half years since the right ankle rupture, I really felt I was ready to play again and the King Cup Tournament was quickly approaching in January of 2017. I signed up with a team and

present... The Lady Eagles have a daunting schedule as always. They'll be entered in the El Segundo Tournament, the West Torrance Tournament and the Savannah Tournament

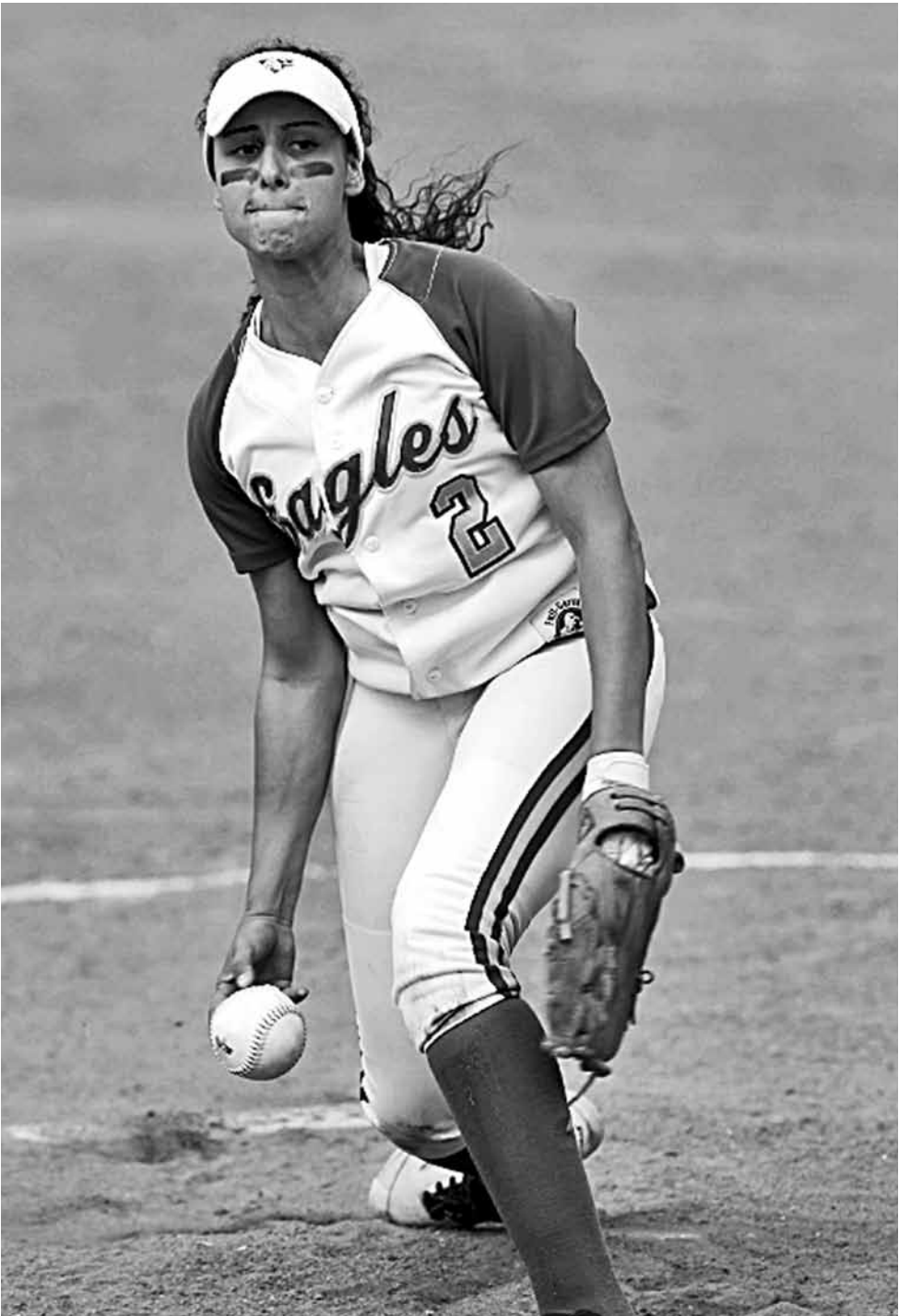
