# Marisa Janicek's Star Continues to Rise in the ES School District

When I caught up with Marisa Janicek, she said she was "honored and embarrassed" to be selected for our weekly profile. She definitely deserves the "honor."

Janicek, the El Segundo Unified School District's [ESUSD] Assistant Superintendent of Educational Services, has been a top player in the District since she was selected by El Segundo's "Mr. Education," Bill Watkins, among others, in the summer of 2005 to take over as principal at Center Street School, after serving the District in assistant principal roles.

What did the veteran educator Watkins see

In 2016, Janicek continued her ascent in the ESUSD, taking the position of Executive Director of Educational Services, a post she held for two years before being promoted to Assistant Superintendent.

She writes on her resume that she strives to "continue to lead by transforming education for a changing world." She constantly touts the collaboration and caring of all the people who make the District so successful; families have relocated to El Segundo specifically because of the quality of the school system.

in Janicek that made him feel comfortable turning over the principal's office to her and putting her at the forefront of educating and impacting some of El Segundo's youngest learners?

# **Field Fight: City Council Discusses Raytheon Situation**

Micro unit housing, a potential two-acre land gift, the Downtown Specific Plan, and a mid-year budget report with requested amendments were all part of the regularly scheduled El Segundo City Council meeting last Tuesday evening. In addition, El Segundo youth continue to appear to be without a Raytheon softball diamond to play baseball on this Little League season due to a decision by Raytheon to hold that field for use by its employees and not El Segundo Little League. Last year, shortly after the city negotiated land swaps and amendments to previous deals to accommodate the new Los Angeles Chargers football team's headquarters, Raytheon allowed Little League to use its softball and baseball fields. This season, Raytheon is exercising the agreement (which states they only need to let the city have access to two of their three fields—one is a baseball field, one a softball field, and one a soccer field) and retaining the use of its softball field for employees, leaving Little League without a field it relies on to accommodate the number of teams and youths who've signed up to play.

In response was a public comment from Greg Maechlin, a board member of the El Segundo Little League, who asked the city to follow up with Raytheon to help them regain the use of a field for the 400 See City Council, page 11




# **Check It Out**



# <u>Film Review</u>

## The Story of Film: A New Generation Is a Must-Watch For Any Movie Lover

Jordan Peele's Nope packed a lot of themes into its 2-hour 10-minute runtime. Some themes were more obvious (human attempts to control uncontrollable forces), while others were more subtextual (filmmaking as a tool to shape our understanding of cultures). Like any good film, different themes will resonate with different people for different reasons. Various perspectives and takeaways further fuel the post-screening conversation, which can lead to a broadening of world views or

Either way, there is a passion that lingers with the audience because, in one way or another, they have been affected by what they saw on screen. That's the power that Jordan Peele and countless other filmmakers harness when they make a movie.

This effect that cinema has on us is at the heart of filmmaker and critic Mark Cousins' epic documentary, The Story of Film: A New Generation. With a runtime of just under 3 hours, Cousins follows up his previously released miniseries The Story of Film: An Odyssey (2011) by compiling some of the best moments in film history to prove Morgan Rojas

how cinema is continuing to innovate year after year.

The film pays homage to legends of the past by opening with a beautiful monologue praising Singin' in the Rain's Stanley Donen, The Piano's Jane Campion, Varda par Agnès' Agnès Varda, and other auteurs we cinephiles hold in high regard. "Who are their equivalents in the 21st Century?", Cousins asks somewhat rhetorically, as we revisit clips and scenes from some of the most revered classic and contemporary films of all time.

Cousins' main thesis statement is expressed by showing how different film genres have evolved over time. The structure of modern Musicals, Slow Cinema, and Action films are compared to films of the past, proving that filmmakers are not reinventing the wheel as much as they are building upon it. It can be argued that George Miller's Mad Max took inspiration from Buster Keaton's The General. Todd Phillips' Joker is more similar to Disney's Frozen than ever imagined. Apichatpong Weerasethakul's Cemetery of Splendor and Kelly Reichardt's Certain Women tell the same tale, through different lenses.

Cinema is always finding new ways of reinventing itself. Whether it be visually with the integration of sophisticated AI as seen in Martin Scorsese's The Irishman, or thematically by breaking the rules of genre like Jonathan Glazer's Under the Skin which blended the boundaries between documentary and narrative - The Story of Film: A New Generation proves that film is not dead.


#### Tennis Team



I eventually decided to stay home full-time, and we just always remained friends.

"I think one of Marisa's biggest strengths is she genuinely has an appreciation for every single person who plays a role in the school community," Baldino said. "The students, the parents, the teachers, certificated staff, classified staff, admin, etc. – she sees the value each individual adds to the process and treats everyone with respect. "Everybody is in it to help kids," she said. Recreationally, Janicek likes to run, hike, bike, and spend quality time with her family, including her children, Allie and Max. She also likes to "give back" to her adopted hometown, citing her volunteer work for the Kiwanis Club, the National Charity League, and the various local youth sports teams. And she likes to read, which comes in handy as she tackles the rigors of entering a doctoral program. It would not be a surprise if, in the not-too-distant future, the title "Dr. Marisa Janicek" was imprinted on her business cards. So, who better to comment on Janicek's career path than Dr. Melissa Moore, the Superintendent of the ESUSD? "I would like to think that Marisa considers me a mentor. I believe she hopes to be a Superintendent in the future. "Her institutional knowledge," Moore continued, "understanding of the El Segundo community, empathy, compassion, and kindness are strengths. Marisa is always willing to lend a helping hand to all members of our leadership team. She consistently has a smile on her face and a positive mindset in approaching all her duties with joy."



## **City Council**

Little League families who will be impacted by the loss of its use. The ball field issue was raised at the previous City Council meeting, and city staff provided an update. During this meeting, City Manager Darrell George said the city had been making "valiant attempts to reach out to them, discuss the opportunity with them" (Raytheon). Recreation, Parks, and Library Director Aly Mancini, who has been in talks with a Raytheon representative, said that she and City Attorney Mark Hensley had reviewed the contract and that Raytheon was within their right to exercise the use of one of the three fields. George said he would reach out to Raytheon to make a "last effort here to reach out to them personally." Council member Lance Giroux, who spoke out on the field use at the last council meeting, once again quickly took to the microphone to voice his distaste for Raytheon's handling of the field usage and the unfolding debacle. "So, just to give another little history lesson on this. We were thrown a couple of little bones, and those bones were thrown at us so that we would forget about the seven acres of green space that was part of their development agreement. And the first bone was we were going have more use of these fields. So, however it got written or what was said in this chamber is apparently two different things." In answer, Hensley said,

"No, I went back and watched the video. It was very specifically...."

Interrupted by Giroux, Giroux then added, "Mark, I'm not getting on you, Mark, I'm getting on them, OK, because the spirit of that deal was to allow that group (Little League) to use those fields in lieu of the green space that we negotiated years ago. So, that's what was happening. And that's not what happened." He continued, "I absolutely knew this was gonna happen. I knew the timing; it was gonna happen. And it happened right on the spot. And it's terrible that this is what it's come down to because it's affecting 400 kids and 400 families in this city. I'm not putting it on you; I'm putting it on them. They knew what they were saying, and it didn't come through. So, I don't know what else we can do here. But I gotta tell you, from a public relations standpoint... So the largest employer (in El Segundo), um, they don't seem to care too much about that piece of it, though, and that's really sad. So I don't know who else we can talk to or who we're talking to right now, but we need to push a little bit harder on this 'cause this problem's not gonna go away. We have more and more families in this town playing these sports, and we simply do not have the space for it. And we forfeited that space to allow the Chargers to come in here. We gotta do more than what we're doing.

I don't know what we need to do, but we need to do more than what we're doing."

Noted Mayor Pro Tem Chris Pimentel, "I think it's a bit disappointing that at the time their representative was very genial and that if there were issues like this that popped up, we'd be able to work it out. Now he, I think, retired within months of the deal being finalized. And we were very concerned at the time that this might be the likely result, that we were going to be dealing with the rule of man and not the rule of law, or conversely, we'd get the rule of law when we thought we'd deal with the rule of man. So, I think if there's anything we can do to appeal to their good graces and the spirit of the agreement, vice the text of it, I think that would benefit all of us." In other news, the council heard an update on the Hyperion Water Reclamation Plant and its ongoing upgrades and construction work due to a July 2021 emergency at the City of Los Angeles-owned-and-operated plant, including the potential of windbreaks being installed, a spreadsheet in the works to monitor and track the plant's progress, the hiring of consultants by the City of LA to assist, the publication of weekly plant reports, city staff meeting with the new representatives for the City of LA's City Attorney's Office and eighty percent completion of the plant's perimeter road project, resulting in less noise

and vibration.

Council also discussed the state's density bonus law, which includes micro units of housing that Mayor Drew Boyles said represented an opportunity for young adult residents who grew up in El Segundo and are being priced out by today's housing market climate and affordability to live in the city; a potential land gift of two acres (council asked city staff to return with more information on the land, its value, potential uses, etc.); the city's mid-year budget and proposed amendments (i.e., business license tax is down due to the loss of Best Buy and decreased employer headcount due to layoffs, closures), legal fees to cover 11 lawsuits against the city from former employees; increases in overtime for police and fire department personnel, and more. Council also heard a brief presentation on the status of the Downtown Specific Plan, which is moving from six districts to four: Main Street; Richmond Street; Grand Avenue, and Civic Center. And the council also discussed how to record or present committee meetings so the public may watch them later or tune in live. For months, community members have asked the council to record the city's Diversity, Equity and Inclusion committee meetings.
