Students Impress at State Civic Learning Summit

At last month's California Civic Learning Summit in Sacramento, a group of El Segundo middle schoolers made their case as seasoned public speakers, demonstrating maturity beyond their years and a sophisticated grasp of critical issues that impact their local environment. The five youngsters were the only students in the entire state invited to come up to the podium to address the audience at the event that promotes civic engagement.

The visit resulted from the group's recognition for a class civic engagement assignment undertaken when they were still fifth graders at Richmond Street School (RSS) in the spring of 2024. That campus, along with Center Street (CSS) and El Segundo Middle (ESMS) schools, earned California Democracy School designations at the California Civic Learning Student Award Ceremony hosted by the Los Angeles County Office of Education at the Richard Nixon Library & Museum in Yorba Linda last May.

The then-fifth graders presented projects focusing on environmental issues—particularly waste concerns and possible solutions connected to El Segundo's coastal location. The topics were as follows: "The Great Pacific Ocean Patch" (John Caban); "Waste Spew Off the Coast of El Segundo" (Maya Graiff); "How Can Plastics Hurt Animals?" (Makenzie Hart); "Protecting Our Beaches" (Iris Pimentel); and "Our Oceans" (Emery Plotkin).

While in Sacramento, the youngsters fielded questions from the crowd (which included teachers, superintendents, and even State Supreme Court justices, among other notables), attended a luncheon, and chatted informally with the adults. "The attendees were impressed at how articulate, well-spoken, and engaged our students are," El Segundo Education Foundation Chair and parent Christa Caban said. "They saw this as a turning point in education. They were like little rock stars that day." Caban added that the trip up north further inspired the students to continue the path forward and to "see what they can do next."

Dana Brooks, the fifth-grade teacher at RSS who oversaw the class projects last spring, said

she was "beyond proud" of her former students for their dedication to making a meaningful impact in their community. "Through a civics lens, they explored the impact of waste, identified key stakeholders, and developed thoughtful solutions to address the problem," she said. "I was incredibly impressed by their commitment, collaboration, and ability to present their findings with confidence while watching them present at the California Civic Learning Summit. Their research was thorough, their ideas innovative, and their passion for making a difference truly inspiring. This project not only deepened their understanding of sustainability but also empowered them to use their voices for meaningful change."

Parent Celia Plotkin called the summit "truly inspiring" and noted that the kids' work left a lasting impression on the attendees, who commented on how inspired they were by the students' passion, leadership, and commitment to making a difference in their community and beyond. "Not only did they demonstrate confidence and poise in their presentation skills, but they also showcased a deep understanding of what it means to be a civic-minded student," she said. "They spoke thoughtfully about the importance of using their voices to advocate for positive change in their schools and communities. Their ability to engage with adults and reflect on their growth as responsible citizens was remarkable. These students truly represent the future of engaged, thoughtful citizens."

RSS Principal Carie Oulashian lauded the

youngsters for their efforts in "stretching their newly formed civic muscles" to earn an invitation as the only student speakers at the summit. "This experience has shown them—and all of us—the power of their ideas and actions," she said. "I am also deeply grateful for our positive and resourceful teachers who embraced something new and saw an immediate, inspiring impact. Opportunities like this remind us that when students are given a voice, they rise to the occasion in remarkable ways."

The movement to prioritize civic engagement at El Segundo Unified began in 2019 when Social Sciences instructor Craig Gast applied for El Segundo High School to become a Democracy School. "I do a project with the City of El Segundo with my seniors and a Mock Congress," he noted. "After the High School was awarded the Democracy School designation, I began to work closely with [Assistant Superintendent] Marisa Janicek to bring civics projects to the fifth and eighthgrade students in the hopes of applying for all our schools to get the recognition."

Gast worked closely with teachers and principals two summers ago to expand the civic-related curriculum to meet state requirements. "Once they implemented them in the classroom, I wrote applications to the state for all three schools, and we received a visit last spring to verify the projects." That led to the honors at the Nixon Library, and the rest is history. "We are among only a small



ESUSD Board Meeting Report

The following information covers the February 28, 2025 ESUSD board meeting and was taken from ESUSD website:

Recognizing El Segundo Middle School Model United Nations

The El Segundo Middle School Model United Nations (MUN) program is an educational initiative that simulates the workings of the United Nations, allowing students to engage in diplomacy, negotiation, and problem-solving. Participation in this program helps students build important skills, including public speaking, collaboration, and critical thinking.

On December 8, the ESMS Model UN team participated in the CONDOR Model United Nations VI Conference, hosted by California High School. During the conference, students represented countries from around the world in committees focused on real-world issues including climate change, human rights, and global security.

Congratulations to the following students for their outstanding efforts and participation in Model UN: Lochlan Aussem, Tyler McCaverty, Toby Wright and Vaibhavi Landa.

Presentation on Mid-Year Local Control Accountability Plan (LCAP)

Assistant Superintendent of Educational Services Marisa Janicek presented an update

on the Local Control Accountability Plan (LCAP) to the board. The LCAP goals align with both the ESUSD strategic plan and state criteria. This marks the first year of the district's current three-year LCAP cycle (2024-2027).

The goals for this LCAP cycle are:

Goal One: Promote a positive learning environment while ensuring high-quality education to enhance student achievement and prepare well-rounded individual for college and career success, prioritizing social and emotional well-being.

Goal Two: Promote parental and community engagement.

Goal Three: Strengthen the workforce by recruiting and retaining high-quality employees while enhancing personnel capacity, all while maintaining fiscal health and addressing school safety, long- term infrastructure, and facility needs.

Citizens Bond Oversight Committee Chair Presents Report

Citizens Bond Oversight Committee Chair Cheryl Smith presented the Measure ES Annual Report for the fiscal year ending June 30, 2024. Measure ES was originally approved by voters in November 2018 to fund upgrades, replacements, and repairs throughout the district.

number of schools with this recognition, and I am working hard right now to get Arena also recognized so that we can be only the second district in the state to have the entire district as Democracy Schools," Gast added. "I believe the students were asked to go to Sacramento because they are trying to pass legislation requiring all schools to have civics projects."

Said legislation is Senate Bill (SB) 584, introduced on February 20 by State Senator Monique Limon. If passed, it will, among other components, "require Social Sciences to also include civic engagement experiences with governmental institutions" for grades

one through seven. The bill also aims to implement a Civic Engagement Pathway Program for grades one through eight along with recognition for participating pupils.

The goal is to make civic engagement a cornerstone of state education at the elementary level. "These kids are part of something groundbreaking," Caban said.

Meanwhile, the El Segundo Board of Education will recognize the five students at its March 25 meeting. "Their hard work is a testament to the power of civic engagement and the influence young people can have when given the opportunity to lead," Brooks said. •

Golf Team Marches On

El Segundo High School's boys golf team won a league title and the school's first golf CIF championship in 2024. With most of the core players returning, expectations are high for 2025. Head coach David March, who is starting his third year after the program's resurrection, has prepared his team for another title run.

Coach March says the team worked out during an eight-week summer program, playing rounds at Westchester Golf Course and The Lakes. During the fall months players had weekly qualifying rounds at Westchester GC to determine seeding and what level they'll play on. This season, there were so many players interested in the sport that a junior varsity team was formed. Other activities the team did were one practice a week at Westchester GC (range time, chipping, and putting) and two days in the weight room as a team. Prior to the season starting the team played two rounds a week at Westchester GC, two rounds a week at The Lakes GC working on their short, and one day in the weight room as a team.

The defending CIF champions have reason to think another CIF title could be a reality with the return of Jack Harris (Senior) - 2024 1st Team All Bay League, 2024 Bay League Individual Champion, 2024 CIF Individual Qualifier who recently committed to Stevens Institute of Technology. Lukas Da Silva (sophomore) - 2024 Bay League MVP, 2024 Bay League Individual 3rd Place Finisher, 2024 CIF Individual Qualifier, and advanced to the CIF Individual State semifinals.

Other sophomores are Shaan Ty Patel - 2024 1st Team All Bay League, 2024 Bay League Individual 2nd place finisher, and 2024 CIF Individual Qualifier. Joey Schobel - 2024 2nd Team All Bay League and Remy Romero -

2024 Bay League Individual 5th place finisher and 2024 CIF Individual Qualifier.

Coach March says he is excited about the depth this season and the direction the program is headed. Nainoa Breeden (senior), Emmitt Lozano (senior), Ryan Sowder(senior), Matias Alcocer Arauz (junior), and Ronald Lemus (junior) all return and have two years

of experience playing golf at the high school varsity level.

With the popularity of the team sport, the addition of a junior varsity squad will push the varsity players to keep up their game. Newcomers include Tate Pintens (Jr.), Andre Sugden(Jr.), Brandon Kim(So.), and three freshmen, Dylan Agness, Veeraj Nayyar, and Justus Yzquierdo.


The schedule is loaded with non-league matches and big-time tournaments. Coach March said, "I built out the non-league schedule to play tough non-league matches against highly ranked CIF teams from last season to help prepare us for the playoffs." The schedule includes matches against Brentwood, Palisades, Chaminade, Valley Christian, Chadwick, Mira Costa, Quartz Hills, and Windward.

The tournament schedule will be an upgrade from last season in the number and quality of opponents. They will return to the Walnut Gold Division Tournament, where they placed third last season against mainly D1 and D2 teams. The second tournament will be the South Bay Classic hosted by Peninsula, where they face off again against mostly D1 and D2 teams. The third and final tournament is a prestigious one that Coach March is most proud of. "We got accepted into the Champions Invitational hosted by Wilson HS. It is one of the country's biggest high school golf tournaments."

The Champions Invitational tournament will occur in Palm Springs at Tahquitz Golf Course. The field includes teams from 10 states, including the best high school golf teams from Texas, Missouri, Georgia, Arizona, Utah, and Canada. Past champions include current pros like Colin Morikawa, Patrick Cantlay, Rickie Fowler, Jordan Speith and Will Zalatoris. "This will be a great test for us and help us prepare for our goal of qualifying for the CIF Division 1 Team Championships," said Coach March.

As far as the league schedule is concerned, the Eagles should be the team to beat after winning the 2024 Bay League Team and Individual Championships last season. "We

Soccer Season Ends in Dramatic Fashion

After a CIF playoff run that led El Segundo to the semifinals of Division 1, the Eagles found themselves with a spot in the Division 2 Southern California regional tournament. However, their placement as the 5th seed meant that El Segundo would have the tough task of playing away from home in the first round. The Eagles were slated to face off against the Lindsay High School Cardinals, and a whopping 3.5-hour drive up to the San Joaquin Valley. The game ended in regulation 1-1 and a scoreless overtime period, forcing the outcome to be determined by penalty kicks. The Eagles would lose 3-2 on penalty kicks.

After a week of rest, the rejuvenated Eagles squad was ready to conquer yet another hurdle. The game began and despite the roaring Lindsay home crowd, it was El Segundo that struck first. Eagle captain Ricky Martocci's cross from a corner was met by a soaring Erik Fallon as the defender climbed the ladder to nod the ball into the back of the net.


El Segundo's early goal subdued the home crowd's roars and the Eagles sunk into defense for the remainder of the half. Lindsay looked to attack for the rest of the period, but two crucial saves by El Segundo keeper Andre Sugden kept the Eagles in front 1-0 heading into halftime.


The second half was much the same with El Segundo's defense withstanding almost constant pressure from the Cardinals. Finally, after 80 minutes of pressure, Lindsay broke through and tied the game 1-1 in the waning moments, ending in regulation in a tie. The overtime period went scoreless, and the game headed to penalty kicks. After a back-and-forth shootout, with Eagles keeper Andre Sugden stopping two Lindsay spot-kicks, El Segundo would fall 3-2 on penalty kicks, ending their season.

The Eagles had fought hard all season long. They overcame tough opponents and defied all odds brought upon them from the start of the year. They were victorious against Mira Costa for the first time in ten years and made their longest CIF playoff run in five years. El Segundo finished the season with a 17-7-1 record, was a semifinalist in the CIF Division 1 playoffs, and was a regional quarterfinalist; a truly fantastic campaign. With eight of eleven starters returning next year, the future looks bright for the Eagle's boys' soccer program. •






Film Review

Rule Breakers Review: Some Rules Are Made to Be Broken

Angel Studios kicked off International Women's Day by releasing the inspiring historical drama *Rule Breakers*. Conventional in its storytelling yet powerful nonetheless, the film is based on the true story of Roya Mahboob, one of Afghanistan's first female IT entrepreneurs. It charts her relentless determination to give young girls the opportunity to study science and break free from the country's oppressive regime. In addition to correlating to Women's History Month, *Rule Breakers* is releasing ahead of National STEM Week, which begins on March 14th.

Roya Mahboob (Nikohl Boosher) is an iconoclast. As the founder of Afghanistan's women's robotics team and a global advocate for women's education, she lives to inspire others. Despite her country's belief that educating girls is an act of rebellion, Roya continues to defy naysayers and critics by championing STEM in the local school system. She understands the importance of introducing kids, especially young

girls, to science. It's no secret that educating the youth is their only way out of the current social oppression.

Despite Roya's good faith attempts to modernize the country, she is continuously met with the harsh reality that not everyone wants women to have autonomy. But this doesn't deter Roya. In fact, quite the opposite. Taking matters into her own hands, she organizes a small robotics team of four high school-aged girls. Together, they create a stunning mine detection robot made from old car parts. Their invention quickly earns them global attention. With all eyes on Afghanistan, Roya finally has her moment to prove to the world why education is not just a choice, but a right.

Rule Breakers is a classic underdog story with a happy ending. Academy Award-winning director Bill Guttentag (Soundtrack for a Revolution) tells this inspirational drama with heartwarming conviction, despite its formulaic, paint-by-numbers Hollywood structure. While there is nothing inherently wrong with this execution, it does feel too conventional and safe, especially for a story about a woman known for pushing the boundaries. However, giving Roya Mahboob and Afghanistan's first robotics team a platform to share their story is a film worth watching and supporting. •

Towed by Toad written by Jashar Awan and Cranky Makes A Friend written by Phuc Tran illustrated by Pete Oswald



Our second new picture book, *Cranky Makes A Friend*, is about a crane that is a righty who is given the job of training a new kid on the block; a crane that is a lefty.









NOTICE OF ORDINANCE CITY OF EL SEGUNDO **ORDINANCE 1669**

AN ORDINANCE AMENDING EL SEGUNDO TITLE 5, CHAPTER 2 OF THE EL SEGUNDO MUNICIPAL CODE TO PROVIDE FOR THE FRANCHISING COMMERCIAL/MULTI-FAMILY SOLID WASTE, RECYCLABLES, AND ORGANICS COLLECTION AND TRANSPORTATION REMOVING **PROVISIONS** AUTHORIZING ISSUANCE OF COMMERCIAL/MULTI-FAMILY SOLID WASTE COLLECTION AND TRANSPORTATION PERMITS, AND ADDING PROVISIONS FOR PERMITTING OF TEMPORARY ROLL-OFF/BIN SERVICE PROVIDERS.

SUMMARY OF ADOPTED

This ordinance deletes the current provisions in Chapter 5-2 of the ESMC regarding a permit-based system for commercial/multi-family solid waste service providers and instead provides for the franchising of said services on either an exclusive or non-exclusive This ordinance also adds provisions allowing for the permitting of

temporary roll-off/bin service providers throughout the City.

The whole number of the City Council of said City is five. The foregoing Ordinance No. 1669 was duly introduced by said City Council at a regular meeting held on the 18th day of February, 2025, and was duly passed, approved and adopted by said City Council, approved and signed by the Mayor, and attested to by the City Clerk, all at a regular meeting of said Council on the 4th day of March. 2025. and the same was so passed and adopted by the following vote:

By law, the Citizens Bond Oversight Committee is responsible for overseeing the bond, closely examining the books, and ensuring the district is not spending money on items outside the scope of the bond. The committee is composed of members representing various community subgroups to ensure multiple perspectives are considered.

As of June 30, 2024, all Measure ES bonds have been sold, and a total of \$67,064,745 has been spent over the bond's lifetime. In Fiscal Year 2024, \$14,724,094 was allocated as follows: \$1,253,810 for modernization, \$12,711,037 for new construction, \$37,108 for safety and security, and \$722,139 for overall bond management

In this year's independent audit of Measure SOS, there was one finding in the financial statements. Auditors identified material errors that required adjustment, but this was not a repeat finding and was corrected by the district. There were no other issues reported in the audit.

Based on its review, the Citizens Bond Oversight Committee determined that ESUSD remains in compliance with state requirements and that bond funds are being used for the purposes specified in the ballot language.

District Goals Survey

Superintendent Jason Johnson shared a presentation reviewing a draft of the district goals survey, which will begin to be distributed next week. Based on prior board discussions, district staff identified three areas of focus: Pathways to Excellence, Community of Well-Being, and Legacy of Innovation and Sustainability.

The survey will be distributed to students, staff members, and families to gather community feedback. The board reviewed each survey question and provided input for improvement.

Additional Board Actions

The board approved Contract Change Order Two with Archico Design Build, Inc., for the 24- 006 District Office Modernization-Site Work Project.

The board approved payment to the Division of the State Architect (DSA) for final fees related to the El Segundo Middle School gymnasium project.

The board voted to accept the Notice of Completion for the District-Wide HVAC Replacement Project, which replaced 28 HVAC units. They also accepted the Notices of Completion for the Richmond Street Elementary School Corridor Connection Project and the High School Band and CBI Building Project.

The board approved a work authorization with TELACU Construction Management for accounting and administrative support for Measure ES.

The board held a public hearing and voted to accept both ESUSD's and the California School Employees Association's initial proposals for amendments to the Successor Collective Bargaining Agreement for the 2024-2025 fiscal year.


