City on Track to Complete Top Priority Projects in Current Year

Perhaps lost among all the recent talk about residents paying for solid waste collection for the first time ever and disagreement about which groups ought to receive swim time at the new aquatics facility is that the City of El Segundo is in the midst of an unprecedented spate of ongoing projects. Keeping in mind the mantra to “provide a great place to live, work and visit,” the 2018/19 Strategic Work Plan features 59 goals, objectives and activities with the vast majority expected to be completed during the current fiscal year. Only a few will delay to 2019/20, while none fell through the cracks.

In ranking overall importance, the El Segundo Council identified the 11 highest priority items with the Tier 1 designation. Finance Director Joe Lillio recently outlined the highlights in a first quarter report. The projects comply with the five primary goals established by the Council for the three-year strategic plan.

With public safety one of the areas deemed most critical, the City implemented a plan to recruit and train police officers. The work in progress is a collaboration between Human Resources and Police Chief Bill Whalen with his command staff to review and analyze current efforts to recruit lateral officers, academy graduate and officer trainees to build sworn personnel back to allotted numbers.

Also a top item on the list is the desire to increase community awareness of the need for disaster preparedness. For this, the police and fire departments teamed up to add 14 members to the growing Community Emergency Response Training (CERT) program. The new hybrid class included on-line training at the CERT member’s discretion with a hands-on, eight-hour manipulative training session to complete the program.

As part of the goal to approach its work in a financially strategic and responsible way,

the City continued to address its pension liability – given dire estimates that project those costs gobbling up ever-larger chunks of future expenditures. To attack the problem, the Council approved \$2.5 million in the 2018/19 budget to pay down the long-term debt in order to reduce interest payments over time. Various actions resulted in over \$6 million in savings over the next 25-30 years. Additionally, new labor agreements with the police and firefighter associations included clauses for employees to pick up additional portions of their own pension costs. Another priority activity is to continue on a sustainable financial path, solve future deficits and maintain revenues. The City hopes to accomplish this through current labor negotiations, a pension ad hoc committee and the strategic plan itself. And in order to promote economic growth and vitality for businesses and the community, the City also made it a Tier 1 priority to continue to advocate for its interests regarding LAX impacts.

The general goal to develop and maintain quality infrastructure and technology led the Council to grant top priority to improving City facilities through completing a conditions assessment and making subsequent improvements. This project is underway, with draft reports finished and under staff review before the item goes to the Council.

Another primary objective for the City is to develop a choice employer and workforce. The Tier 1 activity to achieve this involves developing a new approach to human resources incorporating “Learning Based” organization principles with innovations such as the first Leadership Development Academy. Other components include computer-based training opportunities for staff and an employee wellness program. In another Tier 1 item, Information Services Division staff will continue

to implement new projects as part of the Technology Master Plan.

Under the overall goal to enhance customer service and engagement, the Tier 1 activities included developing a communications program under the new Deputy City Manager, with a plan set to go to the Council in the next month. Staff is also in the midst of working with the various committees, commissions and boards to update bylaws in order to clarify roles and expectations. Also in progress is a plan to strengthen relationships between Council, executives and staff.

Of the 14 Tier 2 activities, 11 are on track for completion this fiscal year with the other three expected to complete in 2019/20. Just a few of the notable projects: Completing current labor negotiations, filling vacant positions to bolster service, developing a multi-year capital improvement plan, digitizing document imaging of historical plans and records to aid in public accessibility, and implementing emergency operations center (EOC) software. Meanwhile staff continues to research new revenue options for operations and infrastructure and has launched preliminary discussions with other cities to explore a future statewide ballot measure to get relief from low property taxes. Coming up are talks to create a development fee for the arts, a review of the business license tax, Council discussion of the CenterCal/TopGolf negotiations in early spring, consideration of creating a risk manager position to minimize liability claims, and implementation of an accessory dwelling unit ordinance that reflect changes in state requirements. A refined focus on economic attraction is also ongoing.

Of 31 projects classified as “other activities,” 26 will be done this year with five set for 2019/20. “None of the 59 are expected to be unattainable,” Lillio said. •

U10 and U12 Girls Soccer Teams Cap Off Great Seasons

Two El Segundo teams from Region 92 advanced far this season. Both the U10 Fire Girls and U12 Premier All Star teams moved on in the AYSO Section 1 All Star Tournament that includes squads from all over Southern California as well as Nevada. The tournament features the teams from six divisions that win or place in their area all-tournament. Area 1D comprises the six sections from Westchester down through the South Bay and encompasses about 10,000 youth players in the overall pool.

The U12 girls advanced to Riverside after beating Redondo when the game was tied and remained so after two 15-minute over-time periods. The game went to a shootout where El Segundo and goalie Cadee Baird emerged victorious. It was a season of some exciting games, impressive teamwork and dedication. Coached by Joe Lococo with

Assistant Coach Jake Guy, the U12 team players are Cadee Baird, Arianna Barrios, Yuvia Bernauer, Riley Dawson, Sage Guy, Kennadi McAndrews, Natalie McAndrews, Tess McAndrews, Ashley Perkins, Lola Peterson, Charlotte Stewart and Chloe Thiel.

The U10 Fire Girls were the region champions who advanced to Section playoffs in Riverside. Audrey Camarillo led the way with seven goals in three games to advance them to the semifinal the following day. The girls gave it their all, losing a closely contested match 2-1 to end their season at 20-2. Coached by Miguel Camarillo with Assistant Coach Dan Thiel, the U10 players are Daniela Bacil, Sammie Barragan, Sam Brady, Emma Burke, Audrey Camarillo, Scarlett Thiel, Olivia Torres and Peyton Zajic.

ES School Board Does Double Duty Tuesday Night

The members of the El Segundo School Board have had a busy two weeks recently as they worked towards seamlessly implementing the Long-Range Facilities Master Plan in the wake of local voters passing a \$92 million school bond ask last November. On the evening after the last regularly scheduled meeting, held on Feb. 26, the Board quickly reconvened to meet for more than 2 ½ hours for a budget study session that included reviewing the current US economic outlook, current California economy, state funding that impacts all school districts, and also Governor Gavin Newsom's initial budget proposal and how El Segundo Unified School District is directly impacted by fiscal decisions and allocations that emanate from Sacramento. The members also reviewed what appears to be a stable enrollment rate in District schools, as they await the Governor's "May revise" to his initial budget numbers crunched this past January.

On Tuesday evening the Board not only held the regularly scheduled open meeting, commencing at 7 p.m., but also gathered at 5 p.m. to get an update on the implementation of District special education initiatives and programs. They also looked at funding options to "meet the needs of our students," said Superintendent Dr. Melissa Moore, and offer a continuum of services that reflect the needs of special education students. Of the 5 p.m. meeting, Moore said, "We are trying to build Board awareness, because, frankly, there are challenges."

The members next quickly heard special presentations from Student Representative to the Board Matthew Trivasat, and El Segundo Education Foundation CEO Carol Pirsztuk. Pirsztuk thanked SKECHERS for its support of local education, which garnered the District a hefty \$116,000 check that will go towards funding the physical education programs at Center Street and Richmond Street Elementary schools.

Next on the agenda were a couple of recognition presentations, helmed by El Segundo High School Principal Dr. Melissa Gooden. Engineering students who participated in a recent engineering games contest at Raytheon were feted for their exploits, as were the members of the boys high school varsity soccer team that again steamrolled their way to not only a CIF divisional crown, but for the second year in a row captured the coveted regional championship with a hard-fought victory against West Torrance.

Recognized for their first-place standing in

the Raytheon Math Challenge, in which 30 schools participated, were Luke Calimilim, James Lim, and Trevor Loe, who were singled out for their "achievement, critical engineering skills, and teamwork." Speaking of teamwork, more than two dozen of the abovementioned soccer players received recognition as did Coach Andrew Kelley and his staff.

Gooden congratulated both the recognized scholars and the athletes, emailing prior to the meeting that "the accomplishments of both groups are truly amazing," and noting the soccer team's "spectacular season. The hard work and dedication paid off with another CIF Championship."

Kelley spoke briefly, deflecting the praise for the exploits of his squad to the team members and handing out certificates of commendation to the players who were able to attend Tuesday's meeting.

Middle School Acting Principal Ali Rabiei, bolstered by Acting Assistant Principal Sarah Davlantis, was the next presenter and detailed a new bell schedule program at the campus. Rabiei noted that it aims to grant more uninterrupted instructional time, garner greater student learning, decrease student homework load, and aid depth in instruction and learning.

This is the second time in the past two years that the bell schedule at the middle school has been reconfigured to support student learning and engagement. As currently structured, the 2019/20 bell schedule will feature a Monday that will include eight short learning periods, and then morph into a Tuesday-Friday schedule with four longer periods of instruction that, said Moore, would hopefully allow teachers to "dig deeper" into the subject matter and provide more engaging activities for the students. Rabiei said the whole idea of revising the bell schedule is formulated with the thought of "what's best for kids."

Chief Business Official Kimberlie Linz detailed the Education Code-mandated second interim report to the Board regarding the state of District finances for the 2018/19 school year and the next two years. There are three possible certifications that can be filed, from positive to a negative. El Segundo Unified will file a positive certification, which means the District is on track to meet its financial obligations for the remainder of 2018/19 and the next two school years. Moore mentioned prior to the meeting that not all California school districts are able to post a positive certification, citing layoffs and other budget considerations as mitigating factors in the certification process.

El Segundo Eagles Softball and Baseball Preview

With the El Segundo High School softball and baseball teams dodging raindrops to start the season, it has been a challenge to show off how good they'll be. The softball team is off to a 4-3 start and is ranked seventh in the first CIF Southern Section Division 4 polls. The baseball team has started off 3-4, with all three wins coming in extra innings.

Softball Team Looks to Defend Ocean League Title

The Eagles are the defending Ocean League champions and return 11 players including seven starters from last year. The Eagles are solid throughout the lineup, though they'll miss Monique Benjamin (.427; 1.24 ERA), Kat Kakuske (.383 and eight doubles) and Rosalind Williams (.327 and 13 runs scored) who all graduated. Returning will be a formidable lineup that returns five hitters that had a batting average of .368 or better, including one of the top hitters in the South Bay who hit .492.

Head coach Megan McCann is in her third year and is upbeat as the season gets underway. She should be excited about a team that is young, but filled with experience with plenty of senior leadership. She says the team is looking forward to competing for and defending their Ocean League title and going deeper in the playoffs.

Last season the Eagles weren't expected to win 17 games, let alone win the program's first league title in years. Then they defied all odds and defeated the top-seeded team in the playoffs. El Segundo's Cinderella season came to an end in the quarterfinals. This season the

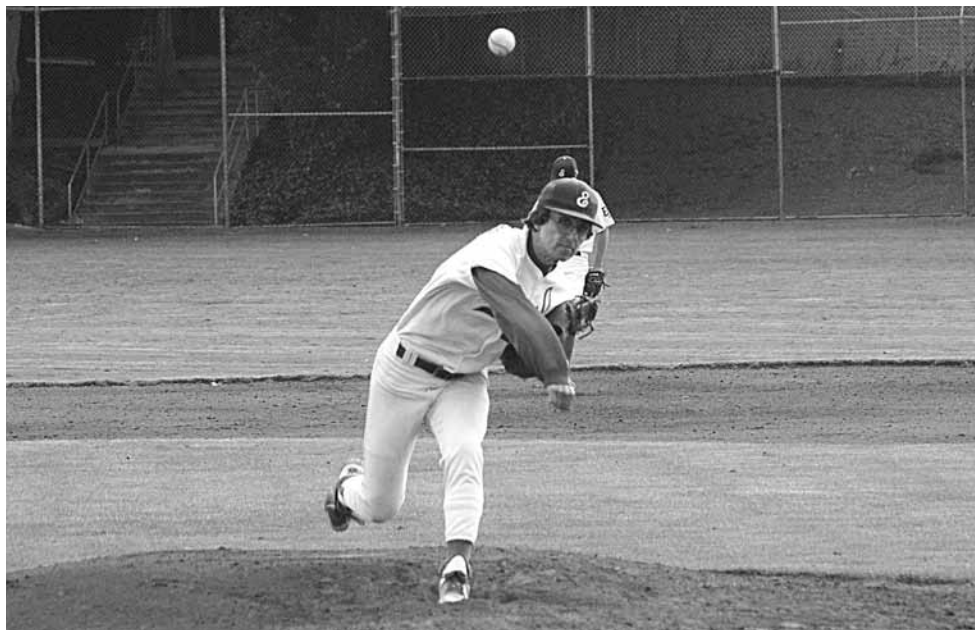
Eagles are highly regarded and have been given the respect they deserve. They are gearing up for a season to top their 17 wins from a year ago and go further in the postseason. They have the balance, depth, pitching and certainly one of the best hitting lineups in the South Bay.

Leading the Eagles will be a core of seniors that will challenge opposing team's pitching staffs. Adri Hebert is one of the top third basemen in the area besides being one of the team's captains. When you consider she led the last season's team in hitting (.492), home runs (5) and triples (5) you can see why she's a threat in each at-bat. In the first seven games to start this season, Hebert hasn't missed a beat and is hitting .500 with four stolen bases while also providing flawless defense.

Audrey Butler is the other captain who leads by example. She could be one of the better outfielders in the South Bay and is another tough out. She hit .387 as a junior and is off to a fast start this season. Four-year starter Kaili Reitano will be counted on to do a little of everything. She hit .438 as a junior, was one of the top pitchers and filled in as a middle infielder. Those roles haven't changed and she will be counted on for her offensive power. Julia Chavez is a three-year starter who has supplied the power in the lineup. She led her team in home runs and RBIs as a sophomore and junior and is hitting .412 with nine RBIs in the first seven games this year. The other senior is Kaela Little, a two-year starter who anchors the outfield with her speed in centerfield.

A key four-year starter, Gaby Benjamin, will miss an undermined amount of time after injuring

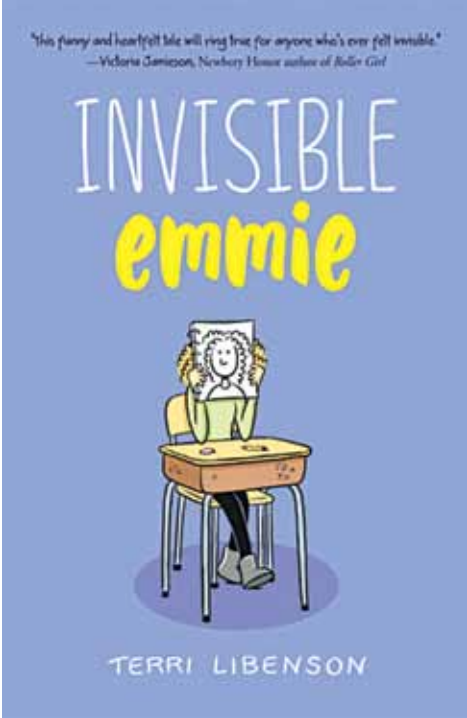


Check It Out

The Moon Landing in Remastered Magnificence

As we study history, both now and in the future, we learn that some of the most transformative and world-changing moments of our human experience were captured through antiquated technologies of old photographs and bits of film. And while these images and sequences are iconic in their simplicity and singularity, the viewer is still left to wonder

huge computers that communicated with the astronauts in space – Neil Armstrong, Buzz Aldrin and Michael Collins – feels more like a time machine than a space shuttle. We watch many of the uniquely coordinated shuttle launches, dockings, landings and splashdowns all come together in a magnificent way. It's no wonder *Apollo 11* won the editing prize at Sundance this year.

Apollo 11 is an insurmountably captivating viewing experience. While history

what else went into that moment. Fortunately, we are in a time where the dedication to historical restoration and education can amplify and nearly recreate these transformative moments– which is what the new documentary *Apollo 11* so effectively does.

The feat of re-presenting history in a way we have never seen before is what we witness in Todd Douglas Miller's documentary *Apollo 11*. This recreation includes not only the restoration of archival footage – most of which has never been seen before – but it is also remastered for the big screen (unfortunately, by the time this review has come out, *Apollo 11* will have ended its IMAX run). The footage, which originally captured the world-changing moon landing in July 1969 and was intended for some undetermined future project, has been magnificently remastered in a way that is entirely mind-blowing.

The experience of seeing this archival footage – starting from the days spent prepping the launch at Cape Canaveral and leading up to the history-making shuttle take-off attended by thousands of people, is due to *Apollo 11*'s captivating editing. The reason why the film is so gripping is that it is edited to feel as suspenseful as a Hollywood movie, something more than just a documentary composed solely of historical footage. Seeing inside NASA's command centers of antiquated technologies and

can feel so abstract and unreal, it goes to show the unbelievable risk and achievement that it was to land on the moon. We have an idea of the moon landing pictured in our minds – and to a millennial like me, it is the photo of Neil Armstrong standing next to the American flag on the deserted moon. Hopefully for others, watching *Apollo 11* will inspire more moments of looking skyward and taking in the awe of this incredible accomplishment. And if that is the case, then this film has likely done what it set out to do.

Apollo 11 is rated G. 93 minutes. Now playing in theaters, including ArcLight Beach Cities. •

Consent agenda items included an agree- ment with Zooga Yoga to work with Eagles’ Nest students; and an agreement to have guest speaker Richard Kuo address middle school students on March 27 to help them, accord- ing to District-provided notes, “overcome low self-esteem, a negative self-image, depression, and other teen challenges.”

Action items included the certification of the previously mentioned second interim report by the CBO; approval of a consultancy agreement with Education Elements, Inc.; adoption of a new District job description for a school psychologist-special programs; approval of a new District position, bond contract specialist/ accountant; and ratification of a short-term posi- tion, licensed vocational nurse, that will be in play for an estimated four-to-eight weeks while the full-time nurse is out on medical leave.

Regarding passage of the District’s school- site safety plans, Board President Nancy Cobb emailed that the plan took in the “unique needs of each site,” and that to “ensure the safety of students and staff, we have had to move from open to closed campuses,” with all visitors now signing in and students mandated to sign out if they leave campus during school hours. Moore commented, “We want to make sure our students our safe,” and that current school safety plans incorporated recommendations made by Actus Consulting after the group had conducted campus safety assessments in the spring of 2018.

The second-to-last action item passed was an agreement with PBK Architects to plan, design and supervise various projects for the District as it implements the Long-Range Facility Master Plan. The Board also approved an agreement with CSDA Design Group to plan, design and supervise the modernization of the El Segundo High library. “This is something that we have wanted to do for several years, but didn’t have the funds,” Moore said. She also noted how the District was excited to partner with CSDA, a local design group.

Moore then highlighted the District infor- mational calendar, including Friday evening’s Middle School Advanced Ensemble Spring Concert, and the Richmond Street Elementary STEAM night that starts at 5 p.m. on Thursday, March 21. Board member reports followed, with Moore capping the evening with her Superintendent’s report.

The next regularly scheduled El Segundo School Board meeting is on the docket for Tuesday evening, March 26. •

Location: The project area is generally east of Pacific Coast Highway and north of Rosecrans Avenue, between the existing alignments of the Union Pacific Railroad (UPRR) and Burlington Northern Santa Fe (BNSF) railroad. The eastern limit of the project area is near Douglas Street.

Applicant: City of El Segundo

Project Description: The City of El Segundo (City) proposes to extend Park Place from Allied Way to Nash Street with a railroad grade separation to implement a critical project as identified in the City’s 2004 General Plan Circulation Element Update, its 2005 Traffic Impact Fee Study Update, and the Southern California Association of Governments (SCAG) 2017 Federal Transportation Improvement Program (FTIP). Park Place currently exists in two segments with a roughly quarter mile gap across an undeveloped area which consists of Union Pacific Railroad (UPRR) and Burlington Northern Santa Fe (BNSF) railroad spurs. The project would implement a gap closure to develop Park Place as an alternate east-west route between Pacific Coast Highway and Douglas Street to relieve congestion along portions of Rosecrans Avenue and Pacific Coast Highway as well as to improve local traffic circulation and access to and from the I-105 freeway. The California Department of Transportation (Caltrans) District 7 is the lead agency under the National Environmental Policy Act (NEPA), while the City is the lead agency under the California Environmental Quality Act (CEQA). There are four Build Alternatives and a No-Build Alternative under consideration.

Required Approvals. The Park Place Extension and Grade Separation project would require City of El Segundo approval of Environmental Assessment (EA 1152): a) to certify a Final Environmental Impact Report and b) to adopt a Mitigation Monitoring and Reporting Program.

The Planning Commission will make recommendations to the City Council regarding this approval. A duly noticed City Council hearing will be scheduled once the Planning Commission acts on this approval.

Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, or religion will also be required.

The City of El Segundo hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated

against on the basis of race, color, national origin, ancestry, sex, or religion in any consideration leading to the award of contract.

The Contractor’s duty to pay State prevailing wages can be found under Labor Code Section 1770 et. Seq. and Labor Code Sections 1775 and 1777.7 outline the penalties for failure to pay prevailing wages and employ apprentices including forfeitures and debarment.

Five percent (5%) will be deducted from each progress payment and retained by the City. The remainder less the amount of all previous payments will be paid to the Contractor. Pursuant to Public Contracts Code (“PCC”) § 22300, the Contractor may substitute securities for retention monies held by the City or request that the City place such monies into an escrow account. The Contractor is notified, pursuant to PCC § 22300, any such election will be at the Contractor own expense and will include costs incurred by the City to accommodate the Contractor’s request.

In entering into a Public Works contract, or a subcontract, to supply goods, services, or materials pursuant to a public

works contract, the **Contractor**, or **Sub-Contractor**, offers and agrees to assign to the awarding body all rights, title and interest in, and to, all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Section 15) or under the Cartwright Act (Chapter 2 [commencing with Section 16700] of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, services, or materials pursuant to the public works contract or the subcontract. This assignment shall be made and become effective at the time the awarding body tenders final payment to the **Contractor**, without further acknowledgment by the parties.

Bids must be prepared on the approved Proposal forms in conformance with the Instructions to Bidders and submitted to the City Clerk, 350 Main Street, City of El Segundo, in a sealed envelope plainly marked on the outside:

No bid will be accepted from a **Contractor** who has not been licensed in accordance with the provisions of the State Business and Professions Code. For these projects, those acceptable classes of license shall be “**A**.” The successful **Contractor** and his **Sub-Contractors** will be required to possess the correct license for their project classifications, and valid City Business Licenses from the City of El Segundo.

The City of El Segundo reserves the right to reject any or all bids, to waive any irregularity, and to take all bids under advisement for a period of **ninety (90) calendar days**.

Any contract entered into pursuant to this notice shall become effective or enforceable against the City of El Segundo only when the formal written contract has been duly executed by the appropriate officer(s) of the City of El Segundo.

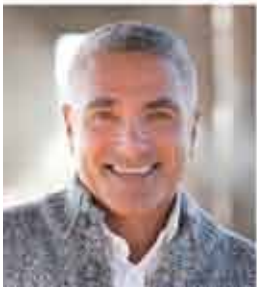
