City Emergency Declared to Slow Coronavirus

El Segundo city officials have declared a local emergency for the coronavirus epidemic and closed the city's bars, beer pubs and after-work hangouts where alcohol is served. Dine-in service at restaurants also is prohibited for two weeks and possibly longer. City Manager Scott Mitnick issued the citywide order on Monday in response to warnings from public-health officials that the COVID-19 virus had expanded quickly. The City Council on Tuesday backed the city manager's decision to shutter social-gathering places through March to keep people unknowingly carrying the virus from mingling in crowds. And to keep the number of new cases as low as possible. The restriction on El Segundo businesses took effect Monday and affects breweries, wine bars, cigar lounges, nightclubs and all bars that serve alcohol. They, along with the restaurants, may continue to sell food that must be picked up or delivered. The mandatory closures will be reviewed in two weeks and again in 60 days if the public-health emergency continues. Cafeterias, commissaries and nursing homes are exempt. The dining ban doesn't apply to food services at defense contractors or transportation and chemical facilities with kitchens that serve employees meals. Grocery stores and food banks aren't restricted either, and neither are pharmacies. Violators could be charged with a misdemeanor that is punished by a \$1,000 fine and up to six months in jail. Officials at Tuesday's council meeting emphasized El Segundo has no confirmed cases of the COVID-19 virus. Manhattan Beach has four cases, and that proximity shifted

El Segundo's emergency-response task force to a higher state of alert, Fire Chief Chris Donovan revealed Tuesday. Inglewood has one case, and there are two in Westchester.

An El Segundo coronavirus response task force was formed before Sunday's announcement by Gov. Gavin Newsom that he was calling for more stringent measures, including asking anyone 65 and over to stay home-bound, to deal with the expected spread of COVID-19. Fire Chief Donovan acknowledged Tuesday that the epidemic represents an extraordinary event for the city. He assured the council El Segundo's emergency services are trained and

ready to continue to deliver critical city services and to deal with 911 calls from residents. "Our police and fire departments continue to remain fully staffed" and are responding to calls for assistance, he said.

The city manager has assumed the role of director of city emergency services. The city has released daily updates about closures and steps taken to protect city employees during this time of uncertainty. "Stay informed, stay alert, and stay safe," Mayor Drew Boyles advised El Segundo residents watching Tuesday's council meeting, which was open

In Los Angeles, Kitten Rescue **Helps Forgotten Felines**

According to an article by LA Weekly in 2015, Los Angeles was home to anywhere between 1 million and 3 million stray cats. Now, in 2020, that number most likely favors the ladder.

Worst of all, there's thousands of cats-if not more-that have no chance of ever being domesticated. Whether due to their feral nature or challenges with disease, a tremendous number of cats are doomed to roam the streets of LA forever. Then again, Kitten Rescue makes it their mission to help forgotten felines find a new home.

Sandra Harrison-Executive Director of Kitten Rescue-explains how the

non-profit all started with a kitten in a paper bag.

"It was the spring of 1997. Kitten Rescue founder, Sue Romaine, was leaving her volunteer shift at the West Valley Animal Shelter. She then met a gentleman carrying a brown paper bag. The bag had a tiny, four-week-old kitten inside of it. He was headed to the shelter to turn it in. The man told Sue that he had brought the siblings in the day before, but this one had been hard to catch. 

Dr. Goldstein doesn't guarantee success; in fact, the documentary doesn't shy away from showing the natural complications that come from a terminal illness. It profiles a handful of dogs, including Waffles, Scooby, and more, as their distraught owners go I'm pro-sanity," he confidently expresses at one point in the film. The Dog Doc exposes a whole new process of thinking when it comes to the treatment and care of our beloved pets, and is a must-watch for animal lovers and progressive thinkers alike. •

Over twenty years later, Kitten Rescue has saved and successfully adopted (found homes for) more than 21,600 cats. Not to mention, they provide a nursery, a sanctuary and rehabilitation programs for hundreds more on a daily basis.

"We can have 40 to 50 kittens at a time in the nursery where they're bottle fed," says all kinds of stories and hardships walk freely with a sense of compassion and playfulness.

The assistant manager at the sanctuary-Kelly Milam—explains that the area is mostly for "special needs" cats, but there's some adoptable cats here," however, every cat is up for adoption.

"Of course, there might be harder-to-place cats here. Like when we get returns, this is where they would come. In one case, the

Harrison. "It is really labor intensive because it has to be every two to four hours. Plus, it's the beginning of kitten season, so we have our nursery manager, Lindsay Reeves, working with a full staff, servicing kittens like clockwork."

Like Harrison mentioned, "kitten season" refers to the period between March and October when most unaltered cats go into heat. Especially in warmer climates, kitten season can happen twice a year. A female cat can actually go into heat any time during the year, which is why rescue shelters have such a hard time managing the overpopulation.

"Take feral cats, for instance," says Harrison.

"In 2017, we also launched a 'working cat' program for feral strays. Overall, a feral cat is an unsocialized cat, so just because they're a stray doesn't necessarily mean they're feral. With a true feral cat, you can't touch it because they've been born wild and they're already wired that way. They're untamable, so the feral cats that we pull, we place them in barns as working cats to catch mice and do their thing on ranches and farms-getting them out of the shelter and giving them a chance to live happy lives."

In fact, Harrison shares that 10% of all feral cats aren't feral at all. They're only scared, and through Kitten Rescue's sanctuary-rather than cats being euthanized by shelters-they're given a second chance to acclimate into the world with loving owners.

Walking further back into the property at 3519 Casitas Avenue, the sanctuary takes on a rustic atmosphere. In clean, cozy rooms, cats with



to the public. Bottles of hand sanitizer were placed in front of each council member - all of whom attended in person. They were given a rare option, due to the governor's emergency declaration on Sunday, to be counted present via a video link.

El Segundo City Hall is closed to walk-in visitors except by appointment. The lobbies of the police and fire departments remain open to the public. Tuesday's council meeting also allowed visitors, though public remarks were submitted by email and read by the City Clerk. Three residents messaged the City Council, all urging members to be vigilant about the COVID-19 situation and asking about the quarantine area being set up at Dockweiler State Beach. People who test positive for the coronavirus and need a place to isolate themselves for the 14-day waiting period will be moved into trailers at the beach. The email writer's concern was whether people in quarantine could leave and come into El Segundo, potentially spreading the virus and foiling the city's best efforts.

Signs were placed on the chairs in the council chambers Tuesday admonishing anyone who attended to sit six feet apart. That recommendation, known as social distancing, comes from the U.S. Centers for Disease Control that also recommends frequent hand washing for 20 seconds and limiting gatherings of people to 10 or fewer. All city commission and board meetings are canceled except for the Planning Commission and in only to hear timely matters of importance that involve property owners' vested interests. It is unknown at this time how long the boards will be dark.

El Segundo's emergency task force is meeting daily and monitoring the fast-moving developments on the COVID-19 epidemic. The mayor and city manager attended a meeting last week with Los Angeles County Public Health officials after it was disclosed that two people in Manhattan Beach contracted the virus. At that meeting, the public-health officials coordinating the epidemiological fight won't alert city managers when someone from their communities tests positive for the virus. When pressed for an explanation, the county health specialists said they are bound by patient privacy laws.

Residents and employees in the city are encouraged to support local restaurants and retailers during the coming weeks when small businesses will feel the effects of the local emergency order. The El Segundo Chamber of Commerce has created a Gundo-to-Go program for pickup and delivery of food from local restaurants. Mayor Boyles said the Small Business Administration is prepared to make loans to help affected businesses get through the financial impacts already taking place here. Coronavirus preparedness dominated the nearly hour long meeting. Little League Suspends Play Due to Health Crisis

Add the El Segundo Little League to the suspension of their league schedule like the NBA, NHL, MLB and the MLS leagues. Those professional leagues have decided to halt play because of the Coronavirus pandemic. Little League International operates more than 6,500 programs in more than 84 countries, and therefore, has recommended that leagues exercise an abundance of caution and implement a temporary suspension of all league activities until no earlier than April 6. The ESLL President, Christibelle Villena, sent out a notice to all league coaches and players reflecting on what Little League International conveyed. "We are aware of the recent progression of the Coronavirus here in Los Angeles and throughout the world. Little League International (LLI) recommends a temporary suspension of Little League activities and we have agreed to follow it. Effective immediately, El Segundo Little League will temporarily suspend all Little League-related activities until Sunday, April 12, with the season resuming on Monday, April 13. This suspension includes games, practices, clinics, cages, meetings and Picture Day.

Resuming the season and rescheduling any games, Picture Day and other activities after Spring Break will depend on any further action required by the schools or government agencies. At this point, everything is day-to-day/hourto-hour, so things can change quickly and we appreciate everyone's patience and flexibility."

On related news, the California Interscholastic Federation Southern Section (CIF-SS) is monitoring the developments related to the Covid-19 virus, also known as the Coronavirus. Other than canceling the state basketball championships, the CIF-SS has no plans to cancel or reschedule upcoming events. El Segundo high school administrators will be closely monitoring the situation and will take proactive measures to ensure their students and faculty are safe. If the situation continues into the spring championship calendar, then the CIF-SS will take appropriate action.

The annual South Bay All-Star Basketball Games, scheduled to be played Friday, March 20 at El Camino College, have been canceled due to the current Covid-19 virus situation. There is a possibility the games, one for boys who are seniors and the other for senior girls, will be rescheduled. •
