# **El Segundo Attorney Provides Counsel on Workplace Issues**

Ms. Holguin can help. This mantra pervades Vida Holguin's business, conversation, and personality. A hard worker, a fierce advocate for workers' rights, and an independent businesswoman, Holguin practices law as an attorney here in El Segundo.

A ninth-generation Californian and a fourthgeneration Santa Monican, Holguin grew up in a family of eight, with four brothers and three sisters and a stay-at-home mom near the Santa Monica airport. She has a story or two about sneaking into the airport after hours as a child. Her father was a construction worker and builder. accepted to the University of San Francisco, a Catholic school, which lessened the blow.

It's clear speaking to Holguin that she has a big brain and an even bigger heart. Majoring in sociology, she thought she would be a social worker or perhaps a probation officer. He later paid a \$1000 scholarship to help her pay for school.

Local mayor, Robert Pullen-Miles of Lawndale, has done an impressive job running his city. And he is seeking higher office. Pullen-Miles is one of four candidates on the ballot for an April 5 special primary election called by the office of Governor Gavin Newsom. The election winner will become the Assemblymember for the 62nd district. This territory includes El Segundo, Lawndale, Gardena, Hawthorne, Inglewood, Westchester, Playa Vista, Hyde Park, Athens/Westmont, Marina del Rey and Venice.

Why does Pullen-Miles think he is the person to fill the vacant Assembly post?

"I want to use my state assembly experience, coupled with my local government experience," Pullen-Miles said, "which uniquely qualifies me to serve the community and differentiates me from my opponents. I am the only person on the ballot who has chief executive experience."

Pullen-Miles thinks that, through his experience in working in different governmental positions, he is best able to champion the causes of his constituents. "I want to take my vast experience to Sacramento."

### **Pork Pies and Pickled Onions**

You should never hold a country's institutional food against it, but after four years of boarding school, we can certify the English version as downright horrifying. We won't go into detail, but take the dismal British reputation, multiply it out several times, and you start to approach the twilight zone on the other side of a culinary wilderness. An allowance of £5



Steak and Ale Pie at Ye Olde Cock Tavern on Fleet Sreet. per trimester (in 1965) went almost exclusively to supplementing the school diet with pennypinching forays into the pubs, chip shops, tea rooms, and cheaper immigrant restaurants of Canterbury.

So the shock on returning thirty years later wasn't the gourmet revolution that had transformed London and even the British hinterlands into a mecca for high-end culinary expertise—sooner or later, all those French, Italian, and Spanish immigrants were bound to take matters into their own hands. The bigger surprise was how so many of the basic British foods of yore had disappeared.

Take fish and chips, for example. The issue wasn't so much that the staple had gone missing, but that it had migrated upmarket. In the old days, an anonymous white fish and thick-cut potatoes were deep-fried in cheap beef fats and vegetable oil, then wrapped in yesterday's newspaper. No matter how ugly the weather, you consumed them on the street outside a take-out shop, with a dash of salt and a shower of pungent malt vinegar.

Today, and especially in London, true chip shops are few and far between (in the Isles as a whole, their numbers have dropped from 30,000 to a paltry 10,000, to serve 72 million hungry souls). It might be healthier that you no longer have to scrape off yesterday's want ads, and sit-down restaurants might fry everything in this-and-that-free, government-approved oils—but then they smother the dish with all manner of foreign flavored mayonnaises and tartare sauces. And ketchup! And worst of all, they even make you choose the fish.

We don't mind that the kidneys have disappeared from 90% of the steak and kidney pies. Or that the fast food chain Wimpy finally woke up and took the ham out of their once gruesome ham-burgers. We don't even mind that you can no longer break a tooth on a Yorkshire Pudding. But it took us days of searching London to find a genuine pork pie—in a humble corner of the entrance to Leadenhall Market—and even then, it was heated.

For the unfortunates who have never tasted the original, pork pies consist of unmentionable pork parts, cured and mashed together, baked in a thick, individual water crust, then See Travel, page 15

### **Eagles Look Good in Sweep of North Torrance**

The El Segundo baseball team's strength has been their pitching to start the season. But against North Torrance, they showed another side by sweeping the Saxons 16-7 and 7-1 to begin their Pioneer League schedule. The Eagles had something to prove against a team that swept them a season ago and have defeated the Saxons 23 out of the last 28 times the two teams have faced each other since 2005.

In the first game, the Eagles took an early first inning 1-0 lead when Evan Smith doubled and later scored on Lucas Bonham's RBI single. But the Saxons countered with a two-run home run by Delshawn Lanier in the bottom of the inning and took a 5-1 lead after two innings. In the third inning, the Eagles took advantage of six walks to score six runs, highlighted by Bonham's three-run double. In the fifth inning, leading 8-5, the Eagles put together a five-run inning bolstered by Bonham's two-run home run to right-center field. In the sixth inning,

El Segundo pounded out five more hits and scored three more runs in the rout.

The 16 runs were easily the best offensive output the Eagles have put together since defeating Peninsula 20-0 nearly a year ago to the day. Bonham was 4-for-4 and a triple shy of hitting for the cycle and had eight RBIs to lead the 15-hit attack.

In the second game, Brady Engelhardt started for the Eagles and ran into some early first-inning troubles. The Saxons had three consecutive singles to open the game and scored their only run on an error. A double-play ended the inning, and Engelhardt seemed to take control after the first inning. He limited the Saxons to just two walks until the seventh inning, when they had two but failed to score.

The bottom of the first took advantage of two errors and some timely hitting to take a 4-1 lead. In the third inning, Bonham doubled and later scored on a sacrifice fly by Anthony Temesvary. Cooper Gamble was hit by a pitch See Eagles, page 10

### Western States Champions

The season had started the first week of September, yet it was now just days before St. Patty's Day. The El Segundo B12U League Champs found themselves taking their record of 20 Wins, two Ties, and no Losses to Morgan Hill, California, for the final stage - the AYSO Western States Championships. Four Section winners would be set to battle it out for the crown in the second largest AYSO tournament in the country, outside of only Nationals. These four Sections would cover California, Nevada, Oregon, Washington, and Alaska - an area that represents over two-thirds of all the registered AYSO players in the nation! Just getting here was an accomplishment in itself - but just getting here was not the end game for these boys.

Gundo opened the semifinals against San Diego South Bay with a 6-1 victory. Kuno Inghram and Xavier Gomez would have two goals apiece, while Caz Inghram and Leo Toivanen added one each. Van Parker and Willem Siegloch played key roles in the attack, helping keep possession moving the ball around as the boys looked for openings. The defense, led once again by Louis Lappe and Lucien de Saint-Aignan, was stellar in limiting opportunities. Johnny Amaral, Ian Smigelski, and Marcus Dell, provided defensive support on the wings, solidifying the backline.

When the opposition had chances, Cooper Bartha was between the posts, stonewalling all comers. The boys were happy to pick up their 21st win on the season, but there was still one more to go.

The Finals would come against a very strong team from Cutler, California - a team with no weak spots and extremely good ball control. Cutler had good speed and were very active with keeping the pressure on, but more importantly, they were very disciplined and worked well together.

Cutler made it a point to attack the wings and then work the ball back into the center, looking to string out the Gundo backline of four defenders, creating passing lanes while searching for scoring opportunities.

Gundo would weather the fast pace of Cutler out the gates, staying calm and composed. Then, three minutes in, Marcus made a defensive stop, passed to Xavier in the middle, who carried forward before finding Kuno on the right wing. Kuno would fly forward, blowing past two defenders and scoring on a hard high shot far post, putting Gundo up 1-0.

Cutler came right back less than two minutes later, attacking down the right side, then back into the middle, only to be stopped by Cooper with an outstanding block which

### Your Neighborhood Therapist

### Dear Neighborhood Therapist,

It's that time of year: I see lots of families struggling to figure out college. My daughter is a high school junior and I know that next year she will struggle with many of the same problems. It seems so overwhelming to think about how many different options there are. My daughter is a good student, but she may not get into every place she wants to go to. Do you have any suggestions about how to think about colleges?

– Not Stressed (Yet!), El Segundo

### Dear Not Stressed,

What to do after high school can be stressful for students and their entire families even when they all know exactly which next steps to take. There is not one right or wrong way to think about college, but I have two ideas that might be helpful.

First, there is a benefit from doing a little bit of thinking before attending college, and approaching it with a little bit more intentionality than most of us do. Here are a few questions to get started.

We should start with the obvious: does she want to go to college? She does? What is it about college that makes her want to go? First, what do you want college to do for you? Are you more interested in how it can help your career, or the experience that you hope to have while you're there? Is college for your daughter more about forming a friend group, or gaining a specific skill-set? Somewhere in the middle?

Thinking about these questions and writing down the answers would be a good step to take sooner rather than later. I suspect that even going through the process of doing this - answers to the questions can change! - will lower the anxiety level somewhat.

Lowering the anxiety level brings us to the

second idea: the same thing that keeps any university or college from being a perfect fit also keeps it from being a terrible fit. There are so many variables that you simply cannot account for them all. Students are going to change over the course of their time in college. Circumstances around them will change.


There will be excellent and lousy instructors, experiences and opportunities anywhere. Every university and every college will have unique traditions and details the others do not. Even if you do get into the college of your choice, you will definitely miss out on certain experiences available at other colleges. There is simply no way to do it all.

In other words, it's worth paying attention to how you approach the college experience, but it's probably not worth agonizing over the "perfect" school, because no such thing exists (easier said than done, I realize).

Finally, remember that part of the college experience is convincing you how great the college experience is. There is an element of branding and salesmanship that's designed to make you want to pay them now and become a donor later on. There is nothing inherently wrong with this, but it's good to account for it as you consider your options. Most people enjoy their college experience even if it's not their first choice, and - don't forget this! - they go on to have lives that do not revolve around their college experience.



Across The Desert, by Dusti Bowling, is a scorching portrayal of what life is like for a child who has a parent with an addiction. We find our main characters, Jolene and her mother, living in a dilapidated apartment where there is little food and less parental care. Jolene is living her life in clothes that are two sizes two small. Cloth markers that serve as symbols to mark the date, two years ago, when her mother could no longer care for her. This lack of care is due to her mother's opioid addiction, which started after suffering

# Film Review

### **'Alice' is Part-Slavery Film, Part-Blaxploitation Riff**

Where to watch: Now playing in theaters. Alice opens with a shot of a woman running desperately through a field. More specifically, she's a Black woman in a plantation dress, so we have an idea as to why she's likely in fear. She runs until she stops. And then, she lets out a blood-curdling scream. A curiously anachronistic title card covers the screen: "Alice," in a very 70s style font.

This intro and title card reveal is stylistically cool, but also a bit clunky. So is most of first-time feature filmmaker Krystin Ver Linden's directorial debut, *Alice*, in which a ward, he decides to let her stay with him to look after her.

Now able to read books in Frank's apartment, she phonetically sounds out words like "slavery" and "Emancipation Proclamation"–which would have been more powerful if silently conveyed. It's this sort of deliberateness throughout *Alice* that makes the film a little too heavy-handed.

If you're able to get past the awkward writing, then you'll likely appreciate all of the fun that is to (eventually) come. Alice's education and consumption of Black culture are captured through different pop culture

runaway slave escapes her plantation, only to find herself in the 1970s Civil Rights-Era South.

It's a hell of a premise (actually, I learned that it's also very similar to the 2020 horror film *Antebellum*, which I've yet to see). *Alice* is one of those films with a really interesting concept but not great execution. For this reason, I think some people will really dig it for its inventive and fresh storytelling but if you're like me, you won't be able to escape the problems with its awkwardly mashed-up tone and narrative incomprehension.

It's almost halfway into the film when Alice finally asserts herself (running away from that intro's plantation) and the movie makes its reveal. It's not exactly a spoiler to give away what happens next (think M. Night Shyamalan's The Village). In fact, I think people's interest in this movie will be roused by knowing that once Alice runs away and gets to the side of the road, she's almost hit by a car zooming down the highway. It's not the Antebellum south, but somehow, 1973. She's picked up by truck-driving Frank (Common), who gives her a ride into town. He apparently doesn't find it odd that not only is she struggling to comprehend everything around her in wide-eyed panic, but she's also covered in blood (there's a struggle she's involved with before she gets here). Frank takes Alice to the hospital, but when he sees that she might be admitted to the psychiatric media: in magazines like Ebony and Rolling Stone, Stevie Wonder and Nina Simone, and on TV like Sanford & Son and Black Panther news. And then, all roads lead to Alice's most transformative moment: going to the movies to see Pam Grier's iconic classic "Coffy," the singular moment that then shifts the movie from slavery film, to time travel movie, to wild Blaxploitation ending (think *Django Unchained* meets *Back to the Future*).

While there are some problems with the story, it's undeniable that *Alice* is still a fresh new story and interesting vision from a first-time filmmaker, whose idea and concepts should be celebrated.



game-plan, but end-up being miles away from the actual implementation of their policies.

The special election ends on April 5, with most, if not all, registered voters having received a mail-in ballot. If none of the four candidates receive 50%, plus one vote when the tabulations are made, there will be a June 7 run-off that would involve the top-two April 5 vote-getters. Assemblymembers' terms are for two years, with a maximum of six two-year terms. The candidates are battling to complete a term that expires on December 5, 2022.

During our recent 25-minute phone conversation, Pullen-Miles touched on various subjects, including the rampant polarization plaguing the body politic. "We have to recognize that we need members in the state Legislature who are consensus builders," he said, "who can see other points of view. We must have people willing to work out compromises when we have to compromise. That does not mean negating your integrity, but everyone has the right to be represented. I have always been a consensus builder; I have never been one to engage in divisive politics."

During his tenure as Lawndale mayor, which began in 2014, Pullen-Miles said that he cites achieving a balanced budget and bringing new business entities to Lawndale, which was incorporated in 1959, as major accomplishments.

"We are one of the healthiest cities, financially, in L.A. County," he said, while also citing accomplishments such as the christening of a new library, a new community center, and city green space, with the opening of three recreational parks.

Not surprisingly, Ari Ruiz, currently working as Pullen-Miles campaign manager, thinks

### his boss has the right stuff to move up the political ladder. "I think he has the vision and the experience to hit the ground running on day one," Ruiz emailed.

Pullen-Miles has been endorsed by many prominent politicians, including Supervisor

Janice Hahn and California Superintendent of Public Instruction Tony Thurmond. Another definite positive for the Pullen-Miles campaign: He has won the endorsement of the California Democratic Party.

So why is there a stand-alone election on April 5? The special election was necessitated when Assemblymember Autumn Burke resigned her post on Feb.1 to take a job with a renowned Sacramento firm specializing in governmental affairs. Pullen-Miles had worked for Burke as a district director. So, the job has been open for two months. The three other candidates listed on the ballot are Tina Simone McKinnor, Hawthorne City Council member Angie Reyes English, and Nico Ruderman.

Why does mayor Pullen-Miles want to become an Assemblymember?

The Pullen-Miles backstory. He moved from Oklahoma to California with \$25 in his pocket in search of better opportunities. For a while, it was challenging. He was unemployed and did not have a permanent place to live. He spent months "couch surfing" while temporarily staying at friends' homes.

Pullen-Miles moved to California to pursue a career in the entertainment industry. But he soon felt the financial sticker shock that we California natives, unfortunately, have known for years. It is not cheap to live in the Golden State. He was homeless for a stretch, spending the night, at one point, behind a Wendy's in Compton.

He looked for work and lived in Long Beach "for a very brief time" before settling in South Bay. Attempting to continue his educational studies, he seized a couple of collegiate degrees while still trying to find his way in California.

He worked for a few years as an Emergency Medical Technician in the Long Beach area, then landed a support position for an Assemblyperson in the California state assembly. He continued to work in government, including working for Ted Lieu, a United States congressperson. He later worked for seven years for Assemblyperson Burke.

Pullen-Miles said that his interest in working on the governmental side was piqued when he was playing in a band and he discovered that one of his bandmate's fathers participated in local government. "Public service and politics," Pullen-Miles said, "was always something that I was interested in."

In 2004, Pullen-Miles became the first African American elected to serve in the Lawndale City Council. He dug into issues involving Lawndale youths and, in 2014, was elected as the first African American mayor of Lawndale.

Mayor Pullen-Miles and his wife Léna are the parents of three daughters. They live in Lawndale, and when Pullen-Miles is not thinking about governmental activities, he loves spending time with his "three beautiful daughters" and wife...riding his bike, and walking around town. "There is not a block that I haven't walked," he said.

So, what is Pullen-Miles vision for the 62nd Assembly District? "More affordable housing for low-income families," he said, as well as tackling the homeless crisis, which, he said, cannot be separated from [affordable housing], "part-and-parcel." He would also like to start a mortgage and rent trust fund, which would benefit lower-income families and ramp up local job opportunities while leveraging multiple growth options at community colleges. "Someone, somewhere," he said, "took the "community" out of community colleges. "Our community is not receiving our fair share of funding sources for training programs."

Does Pullen-Miles look at an Assembly position as a stepping-stone for higher office?

"You do the best to serve the people you serve when you have the opportunity, and if you are so blessed to take other opportunities," he said. "My immediate future is working in the Legislature, but who knows after that?" •



### Vida Holguin

five of her siblings, with extra care for her sister, born with Down Syndrome. Even with the tremendous loss of her mother, and the newly added responsibilities she undertook, Holguin went on the graduate with a law degree from Berkeley Law school.

Her career was kickstarted, and she went to work with Hughes Aircraft Company, which was the largest employer in California at over 80,000 employees, as their in-house employment counsel. This work saw her on tiny Cessna planes in choppy weather and traveling to rural and agricultural areas. When Hughes underwent a major layoff, Holguin fielded emotional calls from middle-aged employees begging to stay. Her heart ached for them, and she strengthened her resolve to help employees and employers find the best working solutions.

She went on to work for the State Bar of California as a Senior Trial Counsel, navigating complex and often tricky litigation. Her cases informed the opinions of the California Supreme Court. She's worked with unions on contract negotiations, grievance and arbitration, and federal court work.

In her personal life, Holguin met and married the love of her life. With the addition of four kids, Holguin took a small break from work for the minor task of having two of her children only fifteen months apart. Needless to say, Holguin knows the meaning of a hard day's work and a busy schedule.

For the last couple of decades, Holguin has owned her practice and operated out of El Segundo, offering legal counsel and help with all matters regarding employment law. When she says employment law, she refers to workplace discrimination, whistleblower issues, wage and time claims, sick pay, and unionization. Sexual or racial harassment claims, wrongful termination cases, and labor issues come to her for her expertise in the complex state and federal laws surrounding employment and workers' rights.

Being in the world of law, Holguin has had a front-row seat to the best and worst of the justice system. After spending some time as a prosecutor for the state bar, she shares that she has been privy to instances of lawyers doing, or trying to do, some less than ethical business. Early on in her career, she was advised: There will be a time in your career when you are asked to do something unethical. Don't do it. It is your license, not theirs.

Holguin has held fast to this advice and is motivated by nothing other than changing the lives of those she helps. For example, Holguin had a client who had a stutter, and she was able to help him sort through a legal maze. Long after their work together, she bumped into him in a market. A clear "thank you" rang out as he recognized her and shared with her how her service had impacted him in the workplace and his personal life.

At 72 years old with four grown children and six grandchildren these days, Holguin no longer works in litigation, though she continues her practice, always striving to help those in need. Ms. Holguin can help. •

drenched with a pork broth that jellifies and protects the cold dish from spoiling. In olden days, every pub sported a jar of pickled white onions on the bar. These could be ordered with the cold pie or a hunk of aged cheddar cheese and Branston Pickle (nowadays gussied up as a "Ploughman's Lunch"). But as far as we can tell, no longer.

We have no objection to the disappearance of Chop Suey from the Chinese restaurants. And we hardly mind that canned tomato sauces have vanished from even the most Anglicized Italian restaurants. But watercress and butter sandwiches? Potted shrimp paste and Marmite sandwiches? Beans on toast? Where did they go? Ben once lived on buttered toast with tomatoey, canned beans (Heinz, no substitute, of course). Nowadays, even when you do find this onetime ubiquitous offering, you can hardly taste the tin.

And we're still not sure about modern bangers. We understand that they should contain some meat to go with the cereal filler, but 42% minimum? Sounds a bit extreme. Sounds like the pre-Brexit European Union might have stuck its snooty, regulatory fingers into our favorite British pies, fish, sandwiches, and sausages.

And this brings us to the main issue. In London at least, foreigners have always served up some of the best food on the planet, but their



expertise was reserved for the nouveau riche and upper classes. It's a little known fact that the British aristocracy put the Bordeaux wine region on the map and for centuries bought up bringing him here (in 1963), the menu had dropped its Anglo tendencies in favor of classic Indian cuisine from the east coast of the subcontinent. Try the tasting menu with a bottle

the entire stock of what they poetically named "Claret". Cesar Ritz established the London Savoy as the most famous and expensive hotel on Earth before getting fired for financial irregularities and inventing his own brand.

But average Tommies and their families—and schoolboys on skimpy allowances—lacked the disposable income to even dream about the liver and onions at the Savoy Grill, the special of the day at Selfridges, or the afternoon tea at Claridge's or the Saint James. With world wars, blockades, and rationing, they were lucky to find anything besides fish and chips (which oddly were never restricted). But nowadays, edible food has gone mainstream, and there is simply nothing to be done about it.

We can't leave the topic of eating out in London without mentioning two of our favorite restaurants on the planet—and it should come as no surprise that neither finds its roots in the British Isles.

Veeraswamy on Regent Street opened in

from a superb Maharashtran vintage (not on the wine list, but ask for it).

In 2011, the Russian Arkady Novikov opened the Novikov Restaurant and Bar as two eateries in the same location on Berkeley Street in Mayfair. The Northern Italian half isn't bad, but the Pan-Asian kitchen and dining room are spectacular. They require a minimum of three visits and a prodigious appetite on each outing to work your way through the menu. You could pick your dishes blindfolded and come away thrilled.

You'll notice that we haven't mentioned afternoon tea at the Ritz, even though it's an iconic experience that requires a reservation weeks in advance. We didn't mind our last visit to the haughty, overcrowded venue, where the highlight was the aristocratic wife at the next table studiously ignoring the snores of her husband, while saving him from repeated near-falls. But tea as a drink is a hard sell in our family. And as an experience, Afternoon Tea has nothing to do with the food or the tepid liquid. It should be taken outdoors on a lawn terrace, dressed in tie, jacket, pretty hat, and flowered dress, with oodles of croquet, badminton, and polite, inane conversation.

But those days, like most such days, are long gone.
