Former ES Councilmember Brann Reflects on Controversial Ancestor

Well before the advent of Fox News, CNN, podcasts, social media influencers, cell phones (or any phones, for that matter), television and radio... there weren't many mass communication options available to get people's attention if you wanted to stir things up. But if you lived in Waco, Texas, in the mid-1890s, you couldn't help being aware of a rogue newspaper called the Iconoclast that showcased the writing talents and controversial viewpoints of a certain William Cowper Brann—one of the most polarizing figures in journalism in that particular era. Over a four-year period, Brann ruffled more than a few feathers with his vitriolic editorial rants railing against-among other targets—Baptists, Episcopalians, the British, Black people, women's "wickedness," and most notably, Baylor University. His relentless attacks on Waco's esteemed institution of learning ultimately cost him his life. More on that later...

If the last name rings a bell, it's no coincidence. William Brann was the great-grandfather of longtime El Segundo resident and former two-time City Council member Don Brann, who enjoyed a lengthy and fruitful career in education as a teacher in town and eventually as superintendent of the Wiseburn School District and a founder and board member of the Da Vinci Schools.

Don Brann and his wife Sari traveled to Waco several months ago to attend a lecture recounting the troubled life and times of his great-grandad—a man to this day still reviled in those parts. "I didn't know much about him before 2008 other than he was a writer in Texas who got under people's skins," he said. "That year, my father passed away, and I inherited papers and memorabilia connected to my great-grandfather. It sat around my

garage for years, but then I decided to donate it to the Baylor archives." Covid delayed his Texas trip to 2022, but now the university has the coveted material. William Brann is one of only a handful of historical personalities still actively researched by Baylor scholars.

Born in Humboldt, Illinois, in 1855, William Brann lost his mother when he was only two, and his father sent him to live with the Hawkins family. Though records indicate he was fond of his foster parents, the youngster ran away from home at the age of 13 to seek fame and fortune. He survived—barely—by taking on various disparate odd jobs, including hotel bellboy, semipro baseball pitcher, opera company manager, and locomotive brakeman/fireman. Despite only a third-grade-level

education, he was a gifted communicator with an extensive vocabulary and natural writing ability. A job in a print shop spurred William Brann's interest in journalism and led to a job as a cub reporter with stints at several papers. He got married at the age of 22 and had a son and two daughters. Now a family man with responsibilities as a provider, he took his career to the next level with positions at major newspapers in Galveston and St. Louis. He also tried his hand as a playwright, though this pursuit was unsuccessful.

Tragedy struck in 1890 when the couple's 12-year-old daughter committed suicide. Determined to forge ahead, William Brann moved the family to Austin and used all his savings

Vision Grows for City-Hosted Arts, Festivals

The city's arts and cultural program will get a new coordinator sometime this year, though the qualifications and expectations of the person hired to manage the public arts and events program will change.

El Segundo has been without a coordinator since January when Randy Niessen left the role after less than a year to accept a similar title with Manhattan Beach. Niessen, a Canadian-born artist and artistic manager with an impressive resume, reportedly felt Manhattan Beach's approach to the arts was a better fit for him.

His departure cast uncertainty within the Arts and Cultural Advisory Committee


about how much programming the city could accomplish without a coordinator to schedule events, organize participants and musical acts, and find corporate sponsors.

John Pickhaver, the chairman of the city's arts and culture panel, urged council members not to leave the position vacant. Having a qualified professional on staff at City Hall to plan, organize, and possibly expand the current lineup of events to include more exhibitions and small events is essential if El Segundo wants a high-profile cultural arts programs, he said.

"Eliminating or reducing the role of the cultural arts coordinator position would undo

ESUSD Board Meeting Report

The following information covers the March 11, 2025 ESUSD board meeting and was taken from ESUSD website:

CBO Presents Second Interim Financial Statement

ESUSD Chief Business Official Kimberly Linz presented the 2024-25 Second Interim Budget Report. Highlights of the report included:

A negotiated settlement with the El Segundo Teachers Association (ESTA) resulted in a 1% salary increase across the board and an additional \$650 in benefits. The governor's proposed budget for 2025-26 currently includes a projected cost of living adjustment (COLA) of 2.43%.

The district added a Board Certified Behavior Analyst position, as well as six additional classified positions. The district is putting forth a Positive Certification, meaning it will meet its obligations in the current year and the next two years.

The Board of Education voted to accept the Second Interim Budget Report. It was then submitted to the Los Angeles County Office of Education.

Eagles' Nest Preschool and The Learning Connection

Guadalupe Grijalva, executive director of Eagles' Nest Preschool and The Learning Connection (TLC), shared a presentation with updates on both programs.

The Eagles' Nest Preschool has officially relocated to Richmond Street School, bringing with it all materials, manipulatives, and toys. The Eagles' Nest experience continues to be the same in the new space.

Students are continuing to participate in hands-on learning activities, music lessons, and block parties.

This year, there was a big push for student collaboration. El Segundo High School students are working as interns in the preschool program. Other students have been visiting to lead STEAM activities or complete school projects.

Students from El Segundo High School's Workability program regularly visit RSS and CSS to earn money and gain work experience.

Enrichment funding has been used to purchase KiwiCo STEAM kits, school gardening supplies, and other academically enriching materials.

This year, a lot of work has been done in professional development sessions to define the ESUSD Graduate Profile for The Learning Connection.

Additional Board Actions

The board agreed to vote for the following candidates to serve as representatives on the California School Board Association's Delegate Assembly: Robert Cancio (Norwalk-La Mirada USD); Christine Chacon Kennedy (East Whittier City ESD); Yesenia Cuarenta (Paramount USD); Ernie Nishii (ABC USD); and Christine Saavedra (El Rancho USD).

The board voted to enter into a Site Lease and Facilities Agreement with 2H Construction, Inc. for the Eagles' Nest, Arena High School, and district offices Modernization projects.

To apply for modernization funding, the California Department of Education (CDE) must first approve all plans and specifications.

to start his own paper, the first Iconoclast. It failed quickly and left him penniless. After brief writing assignments in San Antonio and Houston, he accepted an editing position for the Waco Daily News. The guy just couldn't keep a steady job. Ever restless and starving for a creative outlet for his own voice to reach the general public, he gave the Iconoclast another go. This time, it stuck. In less than a year, the circulation swelled to over 100,000 readers—an astounding number for that period. Responding to a detractor's description of him as an "apostle of the devil," William Brann signed off on his articles as "The Apostle." And he thrived on the attention. "If he were around today, he would have millions of followers on social media," Don Brann said.

William Brann's publishing run in Waco proved to be short-lived. In 1897, he began to focus his venom on Baylor after revelations that a 13-year-old girl taken in by university president and Baptist preacher Rufus Burleson was repeatedly assaulted and raped by Steen Morris—Burleson's son-in-law's brother. The girl became pregnant, lost the baby, and eventually was abandoned and discredited. Brann wrote a series of scathing articles railing against the school for its hypocrisy. It made him famous and earned him a fair share of supporters, but it also raised the ire of angry opponents who decided to take matters into their own hands. One evening, a group of students kidnapped him at gunpoint, beat him to a pulp, dragged him around campus by a rope, and intended to tar and feather him until faculty stepped in. In return for not pressing charges, Brann agreed to sign a letter promising to leave town. Yet he stayed put and continued to write, though he slightly toned down the content. Meanwhile, tensions mounted around him to the point that two of his friends died in a gunfight. Not a big surprise for a town nicknamed "Six-Shooter Junction." Street duels were commonplace back then.

Brann was an accomplished orator who received offers for speaking engagements around the country and launched a successful tour. Love him or hate him, the man was an 1890s version of a bad boy rock star. It all came to a screeching halt on April 1, 1898. Baylor supporter Tom Davis (whose daughter was a student there) found Brann walking solo along Waco's Fourth Street and shot him in the

back three times. Despite a punctured lung and profuse bleeding, Brann managed to pull out his own pistol and return six rounds to mortally wound his assailant. He then somehow walked to the police station to issue a statement before succumbing the next day. The *Iconoclast* folded six months later, and the family found its way to Southern California in 1916.

Buried in the large Oakwood Cemetery in Waco, William Brann's gravestone, carved in the image of the "lamp of truth," became a prime target for vandalism. "It has been missing for years," his great-grandson said. "At one point, students stole it and it was found floating in the river when the tide was low. Then it was taken again and it hasn't turned up since."

How does Don Brann feel about having such a notorious figure as an ancestor? "I don't stand for what he stood for, but I can see how he may have influenced me in certain ways," he admitted. A self-described independent viewed by some as a "maverick" during his Council tenure, he more often than not found himself as the lone dissenting (or approving) vote. "I spoke my mind even if my opinion didn't go with the flow," he said.

Don Brann stepped down from the Council in 2019 to concentrate on his work with Da Vinci and then retired from the latter role in 2023. Since then, he has devoted his free time to mentoring individuals for leadership positions. He and Sari enjoy traveling and often fly to Idaho to visit their daughter and grandson (age 17 and an aspiring musician). Now 80, he says he feels great (aside from some predictable aches and pains), walks frequently, hits the gym regularly, and just celebrated a half-century of residency at the same home on California Street here in town. He also provided extensive research and key contributions to the recent publication of Wiseburn's history from 1960 to today. Interestingly, that school district was established in 1896—when the Iconoclast had just become a big deal in Waco. Would William Brann have been proud of his great-grandson's accomplishments? "I think he would have appreciated that I told it like it is and didn't worry about the fallout," Don Brann said. "In that way, I am a lot like him. Some people didn't agree with me, but not enough to shoot me in the back or have me tarred and feathered..." •



Thank You Very Much Review: Andy Kaufman: The Offbeat Anti-Comedian

Thank You Very Much asks a very simple question: Who is the real Andy Kaufman? The answer, however, is not as straightforward. With his controversial and gonzo style of comedy, Andy Kaufman was a provocateur. An iconoclast. He found pleasure in confusing and outraging audiences. Some people loved him for this while others found it incredibly annoying. He may not be everyone's cup of tea, but there's no denying that his tea was on a meteoric rise in fame. From the filmmakers behind Uncut Gems (Elara) and Won't You Be My Neighbor (Tremolo Productions), Thank You Very Much is a long overdue exploration into the all-too-short life of a one-of-a-kind comedic genius.

Filmmaker Alex Braverman sorts through never-before-seen archival footage and speaks with some of Kaufman's closest friends, colleagues, and family members to craft a portrait of the curious Andy Kaufman. The consensus among the group is that Kaufman is an artist in the truest sense of the word. His artform is his act, with an "always-on" persona that had everyone questioning the lines between reality and fantasy. Was he really an awkward guy with a high-pitched foreign accent? Or was he more like Tony Clifton, a rare steak-eating, womanizing drunkard? Through interviews, we learn that no one was ever 100% sure who the real Andy Kaufman was.

But there's a downside to being a full-time jokester... no one knows when you're telling

the truth. Andy Kaufman was diagnosed with and later died from lung cancer at 35 years old. And still, people thought he was faking his death. Danny Devito admitted to not believing it, thinking it was just another one of Kaufman's outlandish pranks. Some people even poked his coffin to make sure he wasn't messing around. In death, as in life, Andy Kaufman kept everyone on their toes. I'm sure he would have been thrilled to know that this would be the legacy he leaves behind.

Thank You Very Much brings to life an engaging timeline from Kaufman's early days, starting at NYC's The Improvisation in 1963. From here, we see tons of archival footage from his standup sets, all still hilarious and relevant today. Braverman makes it a point to also infuse the darker moments of Kaufman's life, including homelessness, addiction, and a traumatic childhood event about his family's decision to cover up the death of his grandfather. He overcame a lot of adversity in his short existence, thanks in part to his belief and practice of Transcendental Meditation. The film goes into more detail on how exactly this form of meditation literally saved him.

If Andy Kaufman were alive today, would he have liked his private life examined so publicly? Would he revel in the fact that some people still believe that he is alive and his death was just some elaborate hoax? While *Thank You Very Much* does an excellent job of reminding audiences of the once-in-a-generation talent that was Andy Kaufman, the real truth is we may never fully understand him. One thing seems clear though: he couldn't have written his legacy any better. •

Eagles Have a Week to Remember

The El Segundo Eagles had a week to remember. The baseball team swept a key Pioneer League home and home series, the softball team shut out the Pioneer League favorites, and the golf team continued its winning streak.

Baseball Team Sweeps South Torrance

If the Eagles were going to win their first league title in six seasons, they would need to go through the South Torrance Spartans to do so. With some luck, good pitching, and timely hitting, the Eagles swept the Spartans. With the Pioneer League and its five teams, it means playing each team three times. In their first meeting, the Eagles capitalized on an error and a subsequent passed ball to defeat the Spartans 1-0.

The second game at South turned out to be another game of opportunities for the Eagles, and they won handily 7-1. They took advantage of Spartan ace Peter Broughton's wildness and ineffectiveness by scoring four runs on six hits and five walks. The hard-throwing right-hander struck out thirteen in the game, but this time, he didn't make it out of the fourth inning after throwing 88 pitches.

The Eagles did most of their damage in the second inning when they scored three runs. Ben Lee, Sam Forthuber, and Kyle Whalen each reached base, and Lincoln Quaintance's two-run double made it 3-0. In the third inning Reed Abrams was hit by a pitch and scored on Whalen's RBI single. El Segundo would score two more runs in the sixth and one more in the seventh inning. The Spartan's only run of the game came on a fifth-inning solo homerun by Isaac Orozco.

The Eagles pounded out ten hits, led by Chase Mattoon, who had three doubles. Porter Robbins started and threw effectively for 5.2 innings before giving way to Reed Abrams who retired all four batters he faced.

The Eagles completed the season series sweep of the Spartans with a 7-4 win. There was no shortage of big plays in this game, which started in the first inning. The Spartan's Dane Rhodes hit a ball off the fence in center field. Eagle centerfielder Ben Lee got to the ball quickly and threw a strike to Chase Mattoon at second base. Mattoon applied the tag on Rhodes, trying to stretch a single into a double. That play was big since the Spartans went on to load the bases and come away with only one run

before an inning-ending double-play. In their half of the first inning the Eagles evened the score when Logan Brooks hit an RBI single that scored Austin Holman.

In the second inning, the Eagles took the lead on Sam Forthuber's RBI single, scoring Jaiden Rico to make it 2-1. Logan Brooks' fourth-inning solo homerun made it 3-1, and the Eagles tagged on another run in the fifth inning for a 4-1 lead. But in the sixth inning the Spartans closed the gap on a two-run single by Tyler Dow. With the score 4-3 in the bottom of the sixth inning the Eagles got some timely hitting from Lincoln Quaintance. With two on and two out, Quaintance turned on a fastball, and he hit it 375 feet for a three-run home run and a 7-3 lead.

In the seventh inning the Spartans made some noise with their bats by getting three hits and the benefit of a walk. They loaded the bases but could muster up just one run before the Eagles closed the door for their Pioneer League win.

The two-win sweep keeps the Eagles in control of the Pioneer League. With their 3-1 record, they hold the fate of their first Pioneer League championship since Craig Cousins guided the Eagles to a Pioneer League crown in 2010.

The board voted to pay the CDE to review the plans and specifications for El Segundo High School, El Segundo Middle School, and Center Street Elementary School.

The board approved the proposal from Geo-Advantec, Inc. to provide DSA-Special special inspection and testing services for the Eagles' Nest, Arena High School, and district offices Modernization projects.

The board approved the 2024-25 and 2025-26 Transportation Plan.

The board approved the proposal from JR Universal Construction, Inc. to construct walls, install doors, paint, and install electrical equipment to subdivide three classrooms at El Segundo Middle School to accommodate district staff during construction at the district office.

The board accepted the proposal from More Prepared to provide safety supplies for the district.

The board voted to approve the release of select employees who are currently employed on a one-year contract. Some staff members were hired to temporarily replace a full-time employee who was on leave, while others were funded by temporary funding sources that are no longer available.

The board approved a \$60 monthly stipend for those district administrators who use their personal cell phones to handle afterhours emergencies, staff coordination, and communication with community members.





years of progress and weaken El Segundo's cultural infrastructure at a time when neighboring cities are expanding theirs," Pickhaver advised the council ahead of Tuesday's discussion about cultural arts plans and funding for 2025.

The cultural arts program and who will lead it dominated Tuesday's City Council meeting, with the council hearing presentations about the program's future direction for 75 minutes. Council members were clear they still want El Segundo to host arts and cultural activities, including the summer concert series in Library Park, the downtown art walk, and the Festival of Holidays and Tree Lighting. City leaders also gave assurances another coordinator will be hired.

Though the position is arts-centered, other management skills are needed that go beyond having an arts or curator background, the council agreed. Members came to a consensus that the full-time role seems more administrative than artistic because it involves many daily activities, akin to running a small business.

While an arts-programming job without a guaranteed salary might discourage artistic directors from applying to work for El Segundo, the council made it clear Tuesday that it prefers a candidate with an arts background but is willing to consider someone with strong project management skills who understands city government.

The next coordinator can expect to work on permitting and explaining the city's public art funding program to businesses considering moving into El Segundo. The arts and culture leader also must be someone who can work and communicate effectively with other city departments, including Community Development. The coordinator, as the only paid city employee responsible for the cultural arts, relies on a team of volunteers.

One of those is Pickhaver, who presented a vision for the city's arts and cultural program. The vision included a mention of El Segundo someday hosting a music festival or a film fest, along with more artist-led sessions. The City Council liked many of the new goals and ideas for promoting music, visual arts, and writers, including the city's new poet laureate, who the Arts and Cultural Committee introduced on Tuesday.

The council approved a \$350,000 cultural arts budget Tuesday, which included hiring a replacement for the salaried position to run the cultural arts program. However, at the suggestion of Councilman Lance Giroux, the \$110,000 salary would be paid primarily from the Cultural Development Fund as an incentive for the new coordinator to keep the fund replenished. He reasoned that a new director would be incentivized to apply for arts grants and focus on business development to replenish the fund with sponsorship money and gifts from corporate partners.

The city expects to have \$1 million in the Cultural Development Fund, with another \$900,000 to be collected if two companies that have pulled building permits complete their projects in El Segundo as planned, according to Recreation and Parks Director Aly Maninci. The events and program costs for 2025 cost \$350,000, including the coordinator's full-time salary and an additional summer concert in the park, she explained.

Poet laureate Kweku Abimbola introduced himself to the City Council and talked about what he hopes to accomplish through smallgroup writing activities and discussions. His first public event is a Blue Butterfly poetry walk at 10 a.m. on Saturday, April 19. The event is free and open to all ages. Participants will meet at the 600 block of West Imperial, between Loma Vista and Hillcrest.

The young award-winning writer from Gambia holds a master's degree in fine arts from the University of Michigan. His first fulllength poetry collection, "Saltwater Demands a Psalm," was published in 2023.

As the city welcomed its new literary representative, Mancini, the Arts and Cultural Committee also bid farewell to Hope Anita Smith. She served as El Segundo Poet Laureate from 2022 to 2024 and was the first person to hold the title. A native of Akron, Ohio, she lives in Los Angeles, where she teaches poetry-writing workshops. The city pays a \$9,500 stipend to the person chosen as the poet laureate.

The city also plans to select three artists to lead a collaborative public-art projects that get El Segundo residents and community members involved in the process, according to Mancini. Each artist will donate one piece of art, which will be added to the city's permanent collection. This project runs through 2026.

The Cultural Development Fund is authorized to issue grants to support cultural festivals and celebrations organized by local nonprofits, pay for arts and culture-themed trips for seniors and students, and host artists' talks and presentations.

In other council actions:

The El Segundo Police Department will spend \$50,000 to replace lockers for patrol officers and relocate them within the police station. Mayor Pimentel had sticker shock over the price of the 24-by-24-inch lockers and asked Police Chief Saul Rodriguez if there was another vendor who could give the department a better price. The council approved the chief's request on a narrow 3-2 vote, with Pimentel and Drew Boyles casting the no votes.

The affordable senior-living apartments at Park Vista need improvements, which will require capital improvements that El Segundo may not be able to afford with local government budgets tightening. The council asked that a preliminary study be done into whether selling the property to a company specializing in senior housing would benefit the residents without subjecting them to market-rate increases in the current rents. The city, which uses a property management company to operate the senior complex, limits rent increases to 1 to 2 percent per year.

Union representative Ray Lawson with the Western States Carpenters union warned El Segundo city leaders about wage theft and tax fraud being committed by contractors. Lawson said that construction companies are paying cash or underreporting the actual number of

skilled tradesmen on local building project to avoid being subject to the wage and withholding laws. City Manager Darrell said the city's policy is to check that its contractors pay prevailing wages on government work and comply with the law.

Final approval was given to revise the parking requirements for multi-family developments and to implement the Housing Element Program 9. The new formula for developers to follow is based on the Pacific Coast Commons project, which is approved but the developer hasn't broken ground yet. •

in shutting down a dangerous lineup.


With the win the Eagles are atop the Pioneer League but face another challenge on Friday when they host the Torrance Tartars.
