New Poet Laureate Looks to Put El Segundo on the Write Path

“In the shadow, /words call us, words call us/ and we go...” This line, written by the esteemed late poet Lucille Clifton to conclude her work “Ones Like Us,” continues to serve as the mantra for El Segundo’s new (and second) Poet Laureate, Kweku Abimbola. With a vision to inspire local writers to express themselves through the power of words, Abimbola wasted no time getting the ball rolling. His inaugural event is set for this Saturday, April 19, at 2 p.m., titled “The Land Remembers: Blue Butterfly Poetry Walk.” The gathering will take place at the Imperial Strip and Memory Tree Row with a nature walk followed by a poetry workshop beckoning participants to “document the sensory details and imagined conversations happening around the plant and animal life around them.”

Abimbola sees this and other upcoming workshops as a way to bring together diverse groups of poets and community members while highlighting the importance of environmental sustainability in this area and the surrounding areas.

Born in the tiny West African country of Gambia but also of Ghanaian, Nigerian, and Sierra Leonian descent, Abimbola gravitated to poetry and literature at a very young age. “My grandfather’s words were the first to call

me,” he said. “Thus, my first memories of literature were the leather and soprano of his voice carrying above the cross-legged chorus of my siblings and cousins. Most of all, this literature was an invitation to remember and perform. His stories of our Gambian swamp dragon, Ninki Nanka, the marine spirit, Mami Wata, or rulers like Mansa Must were malleable and dynamic. From the moment they left his lips, they belonged to us, and it was up to us to keep and eventually recite them. This upbringing in West African oral literature continually inspires me to create similar safe spaces of communal creativity and intellectual freedom for my students, colleagues, and community members. It’s an ethos I’m excited to continue as El Segundo’s Poet Laureate.”

Born in Gambia, Abimbola grew up across West Africa and then moved to America. “Believe it or not, El Segundo was the first city my family moved to in the United States, so this appointment as Poet Laureate feels like a unique full-circle moment,” he said. An honors graduate in English and African-American Studies at the University of Virginia, he obtained his Masters in Creative Writing at the University of Michigan—earning a prestigious summa cum laude designation in the process. “While my passion for the literary arts began in childhood,

I have been honored with opportunities to hone this passion through literary non-profits, like Detroit-based Inside Out Literary Arts,” Abimbola noted. “At Inside Out, I worked as a teaching artist, teaching poetry and creative writing workshops to K-12 students in the Detroit public school system. My intersectional pedagogical approach allowed me to pair creative arts education with advanced skills such as public speaking, grammar mechanics, and social/emotional learning.”

Through these experiences, Abimbola discovered how poetry can foster self-awareness,

Scott Houston Announces Candidacy for Assembly

Mitchell to represent the Second District, where he is helping to lead the county’s long-term planning for a rapidly aging population that will require healthcare, housing, and transportation infrastructure specifically for this population.

Sports in El Segundo Takes a Spring Break

Last week, the El Segundo sports world took a break—a Spring Break—and it couldn't have come at a better time. The boy's golf team was one of the rare active teams. Others took the week off to regroup, attend to injuries, and take a breather in anticipation of a playoff berth run.

The Spring Break marks the halfway point of the spring season schedule. The high school CIF playoffs are still four weeks away, but preparation has been an ongoing theme all season. So when the opportunity comes around to take a pause, it can be rewarding.

Golf Team Faces Top Teams in Invitational

The El Segundo high school's boys golf team has made significant strides and they have been rewarded. The team won a CIF Championship in 2024 in just its second year. So, head coach David March entered the Eagles in the Champions Invitational Tournament to challenge his team this season and help prepare for another CIF championship. Coach March said, "Being invited to the Champions Invitational Tournament was a major accomplishment for our program. The fact we are only starting year three and got invited to a national level tournament against some of the best high school golf teams in the country truly shows the commitment level of our players and parents."

The tournament was played at picturesque Tahquitz Golf Resort in Palm Springs and included fifty top high school golf teams from seven states and Canada. El Segundo's team went through a six-month process to apply, have their players ranked, and have their scores reviewed, and then was accepted into the field of fifty teams.

The two-day tournament used a college scoring format. Five golfers score the best four in each round. In high school league play, the team consists of seven and uses scores of the top five. High school tournaments use a similar format, using six players and scoring the top five. Coaches can coach during the

hole such as read putts, pick yardages, and advise shot selections. Unlike high school matches, where the coach can only talk to the players after they finish putting prior to teeing off on the next hole.

This is the only high school golf tournament that gives junior world ranking points, which is key to being recruited to play golf at the collegiate level. It brings together the who's who in high school golf. "It's a great experience to prepare our players for college-style tournaments at the next level," said Coach March. Senior team captain Jack Harris has committed to play next season at Stevens Institute of Technology where he will major in Engineering. The other four players who attended are all currently being recruited and are expected to be recruited after their sophomore summer.

The experience of playing in a college-level format was a major step toward their goal of playing golf at the collegiate level. "I am extremely proud of the way they battled as a team throughout the three rounds. Our

ES City Council Discusses Increases of EDCO's Bills

EDCO bills will increase by \$2.50 starting next month as El Segundo winds down a cost-sharing arrangement that lowered the price that residents pay for trash service. By shifting the true cost of EDCO's service, the City Council figures to save \$70,000 per year — money that could be needed to operate The Plunge when it reopens early next year.

Under the new rate structure, minus the city's \$5.31 monthly contribution, El Segundo residents will pay \$21.34 for residential service for a year, then \$23.47 beginning in May 2026. Their bills will continue to rise until they reach \$30.61 in May 2029, which is the final year of EDCO's current contract with the city.

Councilman Drew Boyles said it was the plan all along for residents to shoulder

the full cost of EDCO's trash-removal and disposal service. He was on the council in 2019 when EDCO and the city signed the current deal for solid-waste management.

"We were at that time one of two cities in California that subsidized solid waste, the other being San Diego; they have since disconnected it. We're last. So, I absolutely think this is necessary," Boyles said.

He added that city residents get an incredible value from EDCO, paying only \$7 per week on average for barrel pickup. Landfill rates, transportation and disposal costs are rising, and Boyles said El Segundo can expect to pay more for trash service when the EDCO contract runs out and a new deal is reached.

El Segundo's share will drop to 20 percent, leaving residents to shoulder 80 percent of

Minted Review: From Astounding Cultural Movement to Financial Collapse

It's bittersweet to think back to the days of the early NFT boom. We were still in the thick of COVID-19 caution but slowly coming out of quarantine when TikTok and Tiger King monopolized the collective consciousness. Then comes NFTs, a revolutionary form of digital art that initially seemed like a fad but ended up becoming a cultural disruptor. In the new documentary *Minted: The Rise (and Fall?) of the NFT*, filmmaker Nicholas Bruckman charts the wild ride of the art world's former darling.

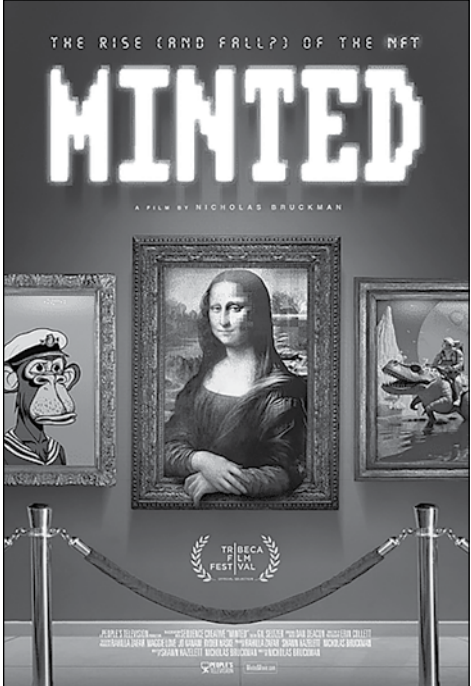
An artist named Beeple sits in his living room surrounded by loved ones as they all stare at his TV in disbelief. Beeple's newly created NFT has sold for \$69 million. This digital artwork, which is still in the infancy stage of popularity, has officially made Beeple the third highest-selling artist of all time. But what exactly is an NFT, and why are people spending thousands, if not millions, of dollars on art that can literally be saved on a computer for free? This is Bruckman's starting point as he navigates the

curiously bizarre trajectory of the NFT.

Bruckman does a great job of getting into the minds of these digital pioneers whose lives have changed forever by selling their art on the blockchain. After Beeple's historic sale ignited an all-out frenzy, many artists found themselves living out their own rags-to-riches stories. But all good things must come to an end. *Minted* goes into stunning detail about the conspiracy theories, celebrity endorsements, and dark side of this controversial new frontier.

Watching this film in hindsight, as the stock market is currently volatile, gives off an eerily uneasy feeling. Nicholas Bruckman could have never predicted the timing of this release to perfectly align with cultural events but it works so well in tandem. It forces the audience to question not just the monetary value of an NFT, but the very nature of art. This larger philosophical question is juxtaposed against composer Dan Deacon's bright and forceful score.

The question remains: Are NFTs dead? *Minted* hypothesizes that they may not be raking in millions of dollars like they used to, but there is still a market for them. However, what has died are people's hopes and dreams that this was sustainable. *Minted* made its World Premiere at the Tribeca Film Festival and is coming to Netflix on April 9th. •

Wind and Truth by Brandon Sanderson

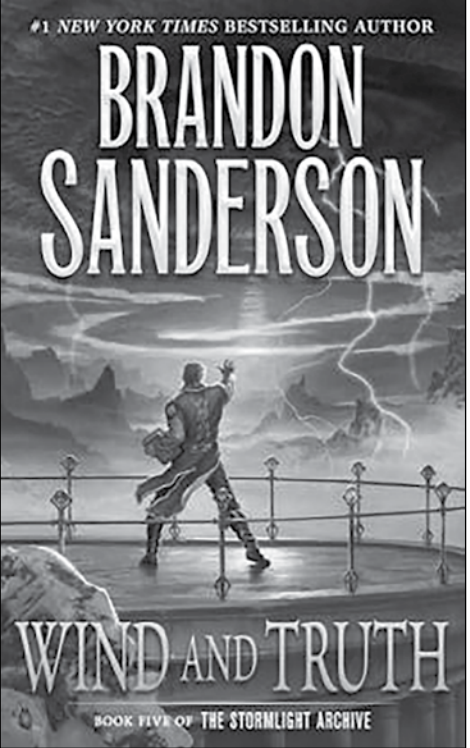

team goal is to return to the Champions Invitational next season and battle for a team and maybe an individual championship,” said Coach March. The fact that four of the five team members who played this year will return next year gives the Eagles a head start. This year’s team included Jack Harris, Lukas Da Silva, Joey Schobel, Shaan Ty Patel and Remy Romero.” That will make them better prepared for the 2026 Champions Invitational Tournament.

The prestigious tournament was played on both courses at Tahquitz Creek Golf Resort. The Legends course is a traditional layout that has been a Palm Springs favorite for years! Its 6,600 yards of tree-lined fairways have been recently renovated with the addition of over 40 challenging new bunkers. The par-72’s greens are severely sloped from back to front, making it challenging for any level.

The Resort Course is a 6,700-yard desert links-style golf course with beautiful mountain views, scenic waterscapes, and undulating greens that are friendly yet demanding, making for a challenging Par 72 course.

EDCO’s actual charges over the next 12 months, it was decided. The city’s contribution would be \$7.85 per household.

These rates are estimates, and EDCO can ask for a higher residential rate annually based on inflation. Boyles said it was the council’s original intent that 100 percent of solid-waste fees shift to the residents, but city leaders wanted to give people time, so they came up with the subsidy arrangement.

When El Segundo negotiated its current contract in 2019, residents paid \$15, and the city kicked in \$5 per household to cover the actual cost of trash pickup and hauling to the landfill. With tough budget decisions looming, the council decided the rate subsidy was a program it couldn’t afford to continue to offer.

Mayor Chris Pimentel, also a council member when the 10-year EDCO contract was approved, defended the cost-sharing for trash services and cast the lone vote to keep it. He said the issue divided the council back in 2019, too, adding that this was the only program of its kind in the city’s 100-year history.

“I think a \$100,000 worth of subsidy ... is a very easy and simple bargain for us with our fixed-income residents,” said the mayor, who is still irked the police department is spending \$50,000 to buy and install lockers at the station.

Each customer currently pays a monthly charge of \$18.26. The city pays the difference of \$7.61, or 29.4 percent of the actual charge. According to a city staff report, all payments made for household solid-waste services go directly to EDCO. Based on Finance Department estimates, the potential savings at City Hall are \$94,000 in the first year, climbing to \$150,000 in 2026-27 and reaching \$340,000 annually starting in July 2029.

Part of EDCO’s service includes a free paper shredding and e-waste collection event from 8 to 11 a.m. Saturday at the city maintenance facility. Up to two banker boxes of papers per household will be accepted for shredding onsite. The event at 150 Illinois St. is open to residents only. Unwanted electronics, including TVs, computer monitors, and printers, can be disposed of at the event.

Mulch and good-quality compost will be given away to residents while supplies last. Since this is a self-serve event, residents must supply their own shovels and containers for transporting the organic material. According to the city-sponsored event with EDCO,

people planning to fill truck beds or trailers should bring tarps.

The city’s eight pickleball courts at Rec Park are a moneymaker, pulling in \$430,000 in fees to the Parks and Recreation Department, according to a report on court usage and revenue from 2024. The data shows that court rentals for public play are the largest generator of fees, followed by leagues, instruction, drop-ins, and pickleball events.

The courts are open from 8 a.m. to 9 p.m. daily, and a volleyball court can be converted into a pickleball court when the demand is high. Residents can reserve courts 10 days in advance and have first priority. According to the Parks and Recreation Department report to the council, the city spent \$116,000 last year to pay for one staff member and some instructors, resurfacing the courts, and hosting events.

The data showed that despite the high demand for court time, the facilities weren’t reserved almost one-third of the time in 2024. By comparison, the park’s tennis courts were used about 50 percent of the time last year.

Currently, Rec Park offers five tennis courts, eight permanent pickleball courts, and two extra pickleball courts that use paddleball, basketball, and volleyball court space. The demand for court time in the city is so great that a privately operated indoor pickleball center is slated to open next month in El Segundo. •

community engagement, and self-actualization that address complicated issues such as identity, ancestry, and community. After completing his education, he went on to lecture at the University of Michigan, be a visiting assistant professor at the University of Tampa, and finally, be an English and Creative Writing professor at Loyola Marymount University.

Abimbola’s previous connection to El Segundo was a key reason he sought out the role of Poet Laureate, and he sees great potential here to reach a wide range of people looking for a meaningful creative outlet. “I believe in the power of poetry to transform communities,” he said. “Given my background in academia and non-profit work, both of which allowed me to cultivate writing communities from diverse backgrounds, the Poet Laureate position felt like a natural fit.”

Abimbola succeeds El Segundo’s first Poet Laureate, Hope Anita Smith, who received a commendation from the City Council earlier this month to recognize her contributions during her tenure. “I am so grateful for the strong foundation that Hope has left and endeavor to follow in her footsteps,” he said when introduced to the community during the Council meeting. In selecting Abimbola, members of the City’s Arts and Culture Advisory Committee, the former Cultural Arts Coordinator, and Smith found him to be the ideal candidate. The Poet Laureate program

aims to “promote diverse voices and perspectives in shaping and furthering the literary arts, culture, and creative expression,” according to the City’s press release. In addition to his broad academic experience, Abimbola is a published author of notable acclaim. His first full-length poetry collection, *Saltwater Demands a Psalm*, released by Graywolf Press in 2023, garnered the coveted Academy of American Poets First Book Award.

Through the various upcoming workshops, Abimbola’s master plan is to produce an anthology featuring work from El Segundo students and residents. The product, he explained, will “celebrate the natural beauty of El Segundo while also considering indigenous approaches to sustainability and conservation.”

He added, “In a similar vein, I also intend to visit classrooms and promote poetry and creative writing as tools of empathy, imagination, and self-expression.”

Impressed by El Segundo’s “natural beauty and embrace of the arts,” Abimbola can’t wait to hit the ground running and make a difference in the community and beyond. “In a geo-political moment rife with uncertainty and climate anxiety, I hope these workshops will serve as spaces for writers and community members to build a creative community and produce work that radically reimagines a sustainable future,” he said. “It is important to focus on the things that unite us...” •
