Council Tackles Pool Time, Park Makeovers and Affordable Housing

The topic of pool lane allocation at the new aquatics facility was on the El Segundo City Council agenda once again on Tuesday night, but this time no citizens came up to the podium to plead their particular case. This was because the user groups in question worked out an amenable arrangement with City of El Segundo staff to divvy up the hours. Under the agreement, Alpha Aquatics –because the club has the most El Segundo residents -- got 60 percent of the time and first pick of selection days. It chose Monday, Wednesday, Friday and Saturday. Beach Cities Swim Swimming received the other 40 percent and will use the pool Tuesday, Thursday and Sunday. A similar ratio is in place for the water polo clubs, with South Bay United at 60 percent and Trojan Water Polo at 40 percent. The Council members (with Chris Pimentel recusing himself and Don Brann dissenting) went with the staff recommendation on the allotment.

In other pool news, the Council heard from the architectural firm that designed plans for the Acacia Park renovation. The Parks and Recreation Commission recommended an option that does away with the pool there for financial reasons (an additional \$1 million cost not part of the original budget). Also brought up: the Acacia pool is only open during the summer, averages just 20 swimmers a day and is very shallow. That being said, Pimentel argued that this pool serves families with young kids who do not use The Plunge or aquatics facility – and those residents assume they won't lose this precious amenity. His colleagues agreed and voted for the pricier pool option, with the exception of Mayor Drew Boyles who said he couldn't wrap his head around the extra expenditure given the City's predicted structural deficit in the near future and the amount of alternate swimming options in town (including the larger Hilltop

Park). City Manager Greg Carpenter said he and staff will have to find that extra million and the Council might not be pleased with the potential cuts to make it happen.

Other components of the revamped Acacia Park (which could take up to a year to complete) include a new playground, sand areas, merry-go-round, slides and "sensory" landscaping. The architect also presented plans for Washington Park that will have revamped play areas.

A representative from D.R. Horton was on hand to discuss affordable housing options as part of the new condo and townhome complex built at the former Imperial Street School site. In trying to accommodate state mandates on such housing, the developer's original plan was to designate six of the 58 total units to low, very low or extremely low income buyers (two for each category). But concerns about ultimate affordability -- especially considering fixed homeowners' association dues and maintenance, among other costs -- led to the conclusion that this will set these families up for failure.

Then last fall, the developer requested to eliminate the affordable housing requirement altogether and replace it with an in-lieu fee of \$3.34 million paid to the City. That suggestion didn't sit well and so the applicant came back this past February with a new concept to increase construction to eight affordable units but for moderate income households. While the Planning Commission recommended the amendment, the Council was on the fence Tuesday and directed staff to reconvene with D.R. Horton to get a better understanding of the buyer selection process to ensure fairness as well as other elements of the deal that didn't seem clear. Mayor Pro Tem Carol Pirsztuk asked for a more accurate measurement of how many affordable units should be included in the development, feeling there was no science in choosing the

eight. Councilmember Scot Nicol predicted that for-rent affordable housing will be the ultimate future answer to comply with state regulations -- given that with appreciation and owner turnover, what is considered affordable today won't be deemed as such in 20 years.

The ultimate price of the homes in question will depend on income and size of qualifying households, with a very rough range estimate of \$550,000 to \$600,000 mentioned on Tuesday. The Council also wishes that members of the military receive priority in the selection process. City Attorney Mark Hensley said that is a legally acceptable request, but El Segundo residents cannot get the same priority. However, the City can choose to direct outreach to locals so they are especially aware of the opportunity. One such local spoke during public communications and described herself as low to moderate income with little to no financial breathing room available. She viewed the proposed plan as the only viable way she (and others like her) can afford to buy a home in town and invest in the community.

Meanwhile Councilmember Brann voted against the resumption of talks with the developer, stating that he prefers the in-lieu fee option to use those monies towards more affordable housing at Park Vista. Barring time restrictions that could delay it two more weeks, this item will come back to the Council on May 21.

Also on Tuesday, Hensley summarized a litany of potentially onerous issues from pending state legislation (Senate Bill 13) that would change regulations for accessory dwelling units (ADUs). Possible outcomes include not requiring owner occupancy (which Hensley thought would invite outside investors to buy up properties), allowing ADUs in garages, eliminating parking requirements, and cutting the permit approval process time in half, among other items. Another




Check It Out

The Snow Lion by Jim Helmore and Richard Jones

This week, I'm reviewing a lovely new picture book about friendship and finding courage to face the unknown: *The Snow Lion* by Jim Helmore and Richard Jones. Beautiful as it is poignant, the story follows shy heroine Caro who has moved to a new home and struggles to adjust. But then she finds the snow lion and her days are full of fun, playing games with her new friend. When a neighborhood boy invites Caro to come play, she's reluctant to leave her comfort zone with the snow lion...but with gentle nudging, she eventually finds her way.

Quiet yet sincere, my family and I enjoyed the soft illustrations, wise and thoughtful

Film Review

Mary Magdalene: A Timely, Quietly Captivating Biblical Drama

Just in time for Easter Sunday comes *Mary Magdalene*, another emotional drama from director Garth Davis (*Lion*) that brings the story of the apostle (or mythical apostle, depending on whom you ask) Mary Magdalene to light for the first time. Aside from the film's visual beauty, it's important to note that *Mary Magdalene* is the last film score by the incredibly gifted composer Jóhann Jóhannsson.

The film opens on a shot of a woman drowning -- her wavering, sinking body looking more like

Rooney Mara's ethereal beauty and wide-eyed innocence are natural features that make her the perfect Mary. She reteams with Garth Davis and delivers a simmering performance. From Jesus to the Joker in a matter of months, Joaquin Phoenix flexes his range as an actor as the proverbial Son of God. This film proves that he really can do it all.

Throughout the film, Davis is respectful to the religion and the beliefs of Christians, handling the crucifixion and miracles with sensitivity. He even goes so far as to dispel the popular "rumor" that Mary Magdalene was a prostitute. In one of the title cards at the end of the film,

an underwater ballet than a death. This imagery is strong, but should not be taken literally. It is made to resemble Mary's (Rooney Mara) suffocation at the hands of her father, her arranged marriage and her lack of a sense of purpose. Mary is beautiful and headstrong -- two qualities that aren't compatible with her time -- and so all she can do is pray for change. When news spreads that a mysterious man named Jesus (Joaquin Phoenix) has come into town, claiming he knows the path to God's kingdom, Mary finally sees a way out. Without hesitation, Mary follows her faith and blindly follows Jesus and his disciples, including Peter (Chiwetel Ejiofor), on his journey to preach the word of God.

Mary falls under the spell of the bearded messiah after witnessing him heal the blind and bring people back from the dead, but it is their intimate, abstract discussions that bond the two. There is no romance between Jesus and Mary. It is purely platonic (off-screen, however, Phoenix and Mara found love on the set). Mary is there with Jesus until the very end as he hung lifeless on the cross. She was there when he was buried in the tomb made of rocks. And she was the first person to witness his resurrection.

a statement reads this was a "misconception" started by Pope Gregory in 591 AD.

Believer or not, there is a quiet captivation in *Mary Magdalene* that audiences will find themselves lost in, be it the picturesque surroundings, Mara and Phoenix's chemistry, or the gift of hearing Jóhann Jóhannsson's final musical score one last time.

Mary Magdalene is rated R. 120 minutes. Now playing at Laemmle theaters and on VOD and digital platforms. •

proposed bill seeks to allow non-profits to buy properties in a community and sell the ADU portion separately from the primary unit. At Hensley's request, the Council agreed to send a letter in opposition to SB13 -- but warned that if the bill goes through, the City will have to move quickly to pass an urgency ordinance to comply with the new rules.

Public Works Director Ken Berkman discussed the upcoming solid waste collection service changes set to go into effect on May 1. He reported that new carts will roll out (literally) later next week, with EDCO dropping those off at single family homes and duplexes. The new hauler will take away old cans if residents leave a note on those bins to do so. Customers will receive bills next month for \$45 (covering three months of service in advance), with the statements going to the property owners

of said units and not renters. Nicol expressed concern about the sign-up process, saying he tried to do so online but was unable to set up an account and didn't receive an email. More information on the account initiation process will be forthcoming. In the meantime, Berkman also pointed out that street sweeping days may change for various blocks since EDCO will only collect four days a week with Friday now an off day. Information will continue to go out through the hauler and the City with updates and instructions.

At the beginning of the meeting, Fire Chief Chris Donovan announced his department received a \$758,000 grant from Chevron to purchase a new fire engine. This goes along with a second grant covering the cost of a new ambulance, thereby freeing up City monies to apply towards other equipment replacement. •

Eagles Take Another Step to Ocean League Title

With the Ocean League at its halfway point, El Segundo High School's softball, baseball and boys' volleyball teams are all poised to win Ocean League titles. The season has seemed to fly by, but each of these teams is playing with one goal in mind: to win a league title.

Softball Team Takes a Step Closer to Repeating

Head coach Megan McCann has her team rolling at the right time. Hit with a devastating injury that cost the team one of its top players before the season started, the Eagles have pressed on. Gabby Benjamin's injury was unfortunate, but the team has rallied

with the motto "next player up."

The Eagles are 17-6 overall and 7-1 in Ocean League play. They have a 10-game winning streak going and their last loss came a month ago to Culver City. The Eagles faced Beverly Hills in a doubleheader and played host to Culver City. They outscored their opponents in those three games 42-1 and in the process propelled themselves to the top of the Ocean League standings.

Wiseburn Looks at Small Reading Group Instruction at Cabrillo

Last Thursday evening, the Wiseburn School Board members viewed a presentation from Cabrillo Elementary Principal Lisa Baggio and her colleagues regarding the implementation of the school's "Small Reading Group" instructional program. Baggio and her presenting team opened with the tenet that their mission statement is to "nurture the whole child to love learning," adding the tagline that "we learn and grow together." The next slide of the presentation portrayed school 2019 goals, including the implementation of the small reading group program and development of an inclusive, multi-tiered system of interventions to support the program.

Baggio talked about what she termed the PEDR cycle as one the school's 2019 goals, which means "plan, execute, debrief, reflect." The presenters spoke of building foundational literacy skills as a cornerstone to enriching learning opportunities for Cabrillo students. Cabrillo students also were present and spoke to the Board about the value that they have gleaned from the small reading group program.

The presentation stressed the need to build on foundational skills to help students achieve at their highest levels, and delved briefly into the available research that shows the benefits of offering an environment "for teachers and students to provide extensive opportunities to express what they know, and receive feedback from other students, and the teacher." IT also noted that studies

show "instructional conversations are easier to support with a small group of students."

The next slide presented posed the question to instructors: "How am I meeting the needs of my students?," and noted how the best avenue was to propose one specific strategy or skill to a group of students who are at a similar reading level and utilizing the same book, as well as targeted mini-lessons and development of strategy groups that target skill rather than a specific rote reading level. These tactics intend to help English Language learners succeed by strengthening their grasp of vocabulary and phonics, as well as implementing decoding and comprehension strategies, developing vocabulary fluency, helping in the analysis of text, and opening avenues to participation in book clubs.

The presenters next played a quick video, which portrayed students' thoughts on participating in the small reading groups, and why the elementary school students felt it valuable. Six benefits of small reading group instruction were highlighted, including the benefits of individualized learning; the confidence gained by participants; the opportunity to glean effective feedback; the collaboration that takes place; the increase in students reading ability; and tracking individual strengths and needs.

The next steps highlighted were the continued use of data for the 2019/20 school year to bolster small reading groups, the continuing teacher-to-teacher observations

Want To Buy A Home? Do The Math

(BPT) - It is a common misconception that a 20 percent down payment is required to buy a home. Advice to wait and save a large down payment is often based on the theory that the cost of mortgage insurance (MI), which is required when you buy with a smaller down payment, should be avoided. This may not be the best advice and is, in fact, not in line with market trends, considering the median down payment for first-time homebuyers is 7 percent, according to the National Association of Realtors.

Yes, you can qualify for a conventional mortgage with a down payment as small as 3 percent of the purchase price. It is also true that you can reduce your monthly mortgage payment by paying for discount points at closing, but that can be 5 or 10 percent of the purchase price - not 20. And because every buyer's situation is unique, it's important to do the math. In today's market, it could take a family earning the national median income up to 20 years to save 20 percent, according to calculations by U.S. Mortgage Insurers using a methodology developed by the Center for Responsible Lending; a lot can change during that time, in the family's personal finances and in overall mortgage market trends.

How can buying now save you money later? Consider you want to purchase a \$255,000

home. A 5 percent down payment is \$12,750 versus \$51,000 in cash for 20 percent down. With a 740 credit score at today's MI rates, your monthly MI payment would be about



\$110, which is added to your monthly mortgage payment until MI cancels. MI typically cancels after five years; therefore, you will only have this added cost for a short

period of time versus waiting an average of 20 years to save for 20 percent.

With home price appreciation, today's \$255,000 home will likely cost more in the

years ahead and this will also have an impact on the necessary down payment and length of time required to save for it. There are other variables in the equation too, such as

interest rates. As federal rates rise from their historic lows, so too will the costs associated with financing a mortgage. The savings a borrower might calculate today could be altogether negated by waiting even a few more years. Another factor is that rents are on the rise across the nation, leading to a reduced capacity for many would-be homebuyers to save for larger down payments.

If you decide to buy today with a low down payment mortgage that has private MI, keep in mind that the monthly MI payments are temporary and go away, lowering the monthly payment over time. Again, private MI typically lasts about five years as it can be cancelled once a homeowner builds approximately 20 percent equity in the home through payments or appreciation and automatically terminates for most borrowers once he or she reaches 22 percent equity. Importantly, the insurance premiums on an FHA mortgage - a 100 percent taxpayer-backed government version of mortgage insurance - cannot be cancelled for the vast majority of borrowers.

So, do the math and let the numbers guide you. There are many online mortgage calculators that can help. Check out lowdownpaymentfacts.org to learn more.



about the program, and professional development opportunities for teachers that will be ongoing.

Post-presentation, Wiseburn Unified School District (WUSD) Superintendent Dr. Blake Silvers emailed, “Cabrillo is a dynamic school. Every time that I am at the school and see the Cabrillo staff, a smile comes to my face. The teachers and the entire Cabrillo community are exceptional and such an integral part of what makes our district tick. One word that would describe Cabrillo is...amazing!”

In Board member reports, which followed the Cabrillo presentation, Dr. Neil Goldman opined how he believed that “individualization is the key to success, if somebody knows that you care about them,” and how he was happy to attend the recent Anza Elementary open

house, commenting that he saw “joy” and that “if learning is fun, that is half the battle.”

President JoAnne Kaneda gave her blessing to the Cabrillo presentation, saying it was “so fun, and so professional. When you can combine that professionalism with fun, there is a lot of learning going on.”

In his comments, Silvers echoed the earlier remarks made by the Board regarding the recent Rock Around the Block (RAB) festivities, and drew attention to the Community Advisory Committee and the awards bestowed on District employees who have enriched the lives of children with disabilities. He mentioned honorees Lisa Downer, Madison Scar, Stacey Henry, Melissa Mathias, Dana Stern, Mathew Gomez, Pleshette Mojonier, Kim Jones, Cathy Ginter and Marie Hornback.

“I am proud to be a part of such a caring

group of educators who ensure all students receive a great education,” Silvers emailed. “But most noteworthy is the commitment and love that our teachers exhibit each day they work with the students.”

In other District news, the Wiseburn Education Foundation (WEF) Interim Executive Rebecca Hamburg reported on the RAB activities that took place on April 6. Hamburg emailed that more than 1,000 members of the Wiseburn community participated in the 16th annual festival that brings students, parents and community members together to support top-notch educational programs. Hamburg wrote that through programs like RAB, the WEF can further music and art instruction and continue to support STEAM education and the “Growing Great” nutrition program.

Hamburg emailed that more than \$70,000

was raised at RAB festivities, with food, games, community booths and a silent auction taking place. She noted the participation of Wiseburn High School’s rock band, as well as bands from the middle and elementary schools. She also touted the work of WUSD art students under the tutelage of Tiffany Graham, who staged a live painting event during the festivities that added to the proceeds.

Silvers was effusive in his praise if the people who planned and executed the RAB carnival. “I am extremely grateful to the WEF team,” he said, lauding the work of President Debbie Felt, as well as Hamburg. He also mentioned a new event that occurred at RAB: a fitness challenge led by Dana Middle School physical education teachers. “We continue to pride ourselves on providing diverse learning opportunities for our students that focus on the whole child,” Silvers said. “The expertise of our arts team was on full display, and it was evident that various forms of art bring our community together.”

Anza teacher Suzanne Guidi emailed information about her campus second annual Eagle Expo, which showcased learning in the area of the design thinking process, through 3D design and the additive process. She wrote that 68 students presented at the April 3 expo, which featured approximately 150-200 community members in attendance, including District administrators and employees. Guidi wrote that the expo highlighted a program that has helped young learners increase their proficiency in developing their design skills, acceptance of failures and motivation to quickly revise their design pathway.

Wiseburn’s spring break commenced on Monday, April 15. Upcoming WUSD events include the next regularly-scheduled Board meeting, on April 25, and Anza Elementary Math Night on May 2. •




