Kelsey Chittick: Tackling the Second Half of Her Life Journey

El Segundo's Kelsey Chittick was living a comfortable life in the first week of November 2017. She had a loving husband who had garnered an NFL Super Bowl ring as a defensive lineman for the 1999-20 edition of the St. Louis Rams and had settled into a new career, post-football, and a couple of great kids.

Then disaster struck the Chittick family. Nate Hobgood- Chittick suddenly died at forty-two on Nov. 11 from a massive heart attack. To make matters worse, Kelsey was in Jamaica on that fateful day when her husband died.

Life suddenly took the worst U-turn of all. Chittick was left without a husband and with two grieving kids, Jack, and Addison, who would be looking to her for strength in this devastating time.

Chittick was born in Bethesda, Maryland. Her father was in the Navy, but three weeks after Chittick was born, her father left the service, and the family relocated to Florida. She grew up in Winter Park and "had a great life. It was beautiful. There were lakes and trees and wildlife."

An accomplished swimmer, Chittick was offered scholarships to multiple colleges, but opted to "try something new" and accept a scholarship to the University of North Carolina.

While attending the UNC campus, Chittick first met Hobgood-Chittick, a defensive lineman in the Tar Heel football program. "I knew right away," she reminisced, "that he was different. He was not a typical football player, but a very deep, deep man who had big dreams in life, wanting to make the world a better place. He was on a quest to be the best version of himself."

The romance blossomed, and Hobgood-Chittick ended up having a six-year career in the National Football League. After Nate retired from the NFL, the couple ended up in Hermosa Beach. They attended a party in El Segundo, and Nate was so taken with the city's charms that he quickly decided to relocate.

Kelsey was not sold on the idea of moving here. But she overcame her initial reservations, and she and Nate made an offer on a house. Chittick said that both her and Nate's parents, living thousands of miles away, Googled their prospective new domicile, with the parental consensus being "holy [shoot], you are like a

El Segundo Rubber Ducky Adoption Event on the Horizon

It is early May, and the sun gleams brightly over Library Park in El Segundo. People are milling about, browsing booths of local goods, discussing new programs and opportunities, and participating in games. In the middle of the hustle and bustle, two large, round pools, about twelve feet each in diameter, sit side by side on the grass. Crowds gather round as the blaring beeps of a dump truck backing up fill the air. The truck backs up to the pools, lifts its load, and releases the gate. Out come dozens, hundreds, of small yellow rubber duckies.

It is Wild Rubber Ducky Adoption Day. The event was started by none other than El Segundo's own Shiela Fowler, a long-time city resident and former president of the local Rotary Club. Rotary is an international humanitarian organization dedicated to bringing service, improvements, and lasting change to the local communities and the international community.

The Rotary Club in El Segundo is responsible for many community events, programs, and installations. For example, they were the driving force behind the formation of the Literacy Garden outside of Center Street School, a peaceful and beautiful space for children and residents to read, study, and get outside. They also hold a holiday brunch every December at Park Vista and host the Good Friday


Charles Richard Johnson

Charles Richard Johnson (Dick) died peacefully at his home in El Segundo surrounded by his family on March 31, 2022 following a long illness. Dick was born on December 4, 1936 in Lewiston, Idaho to Lillian H. and Charles J. Johnson. His family moved several times around the country, but ended up back in Lewiston in 1949. His lifelong interest in classical music started with his playing the clarinet and violin in the Lewiston High School band and orchestra. He also acquired a passion for fly fishing leading to numerous trips in future years around the west to the best fly fishing rivers in the country. He also developed an interest in chemistry in high school and with a friend built a chemistry lab in a detached shed at his home. His superior performance on the chemistry achievement test was instrumental in his admission to Caltech and his future life in Southern California. Dick came to Caltech in 1955 and received a BS degree in applied chemistry in 1959 and a Masters Degree in mechanical engineering in 1960. The next year Dick was an exchange student for a year at

the Royal Institute of Technology in Stockholm Sweden, where he met his first wife, Gudrun.

Returning to Los Angeles in 1961, Dick joined Hughes Aircraft Company as a Member of the Technical Staff and married Gudrun in 1962. Dick had a varied and successful career in the Hughes Space and Communications Group (HSC) over the next 48 years. He started working as a

systems engineer on studies and government satellite proposals. Dick went on to work as the systems engineering manager on several government programs. He was the program manager of both HS-350, a large classified communication satellite program, and the UHF Follow-On program. Dick served as manager of commercial new business programs at HSC for two years. He also was manager of the HS-601 programs division, which developed the highly successful 601 satellite bus used by commercial and government satellite



programs. Before retirement in 1994 he was the manager of all HSC government new business. After a very brief retirement he came back to work in 1995 as a consultant offering technical support to numerous HSC/ Boeing programs, proposals, and several technical review teams until he fully retired in 2009.

Dick and Gudrun had an active family life during these

years, raising three children, Karin, Erik, and Anders. They had numerous trips to Europe, especially Sweden, and visited many of Gudrun's friends and family. They started their married life in Baldwin Hills, but moved to El Segundo in 1974 and lived here the remainder of their lives. Gudrun predeceased Dick, and he married Linda Yan in 2006. During this time Dick continued his interest in music as the president of the South Bay Community Concert Association for eight years. He spent many hours listening to CD's from prospective

performers to recommend artists to the board for upcoming concert seasons. Another of Dick's avocations was cooking. Taught by his mother, he developed his skills and did a lot of cooking in his retirement years, Dick and Linda took several trips abroad including one to China to meet Linda's family. They were both active in and sang in the choir of the United Methodist Church of El Segundo. Linda was devoted to Dick and attended him with great care in his declining years.

Dick is survived by his wife, Linda Yan Johnson, his brother, Bob Johnson, his three children, Karin Tan, Erik and Anders Johnson, and four grandchildren, Ginger and Serkan Tan and Steele and Kaylee Johnson. Dick's memorial service will be held on April 30th, 2022 at 2:00 pm at the United Methodist Church of El Segundo, located at 540 Main Street. There will be a reception at the church following the service. In lieu of flowers, donations may be made to the American Cancer Society, the United Methodist Church of El Segundo, or to a charity of your choice. •

Black Money in Lugano

Of all the places the Shipley clan ever lived, Lugano, in the southern Swiss Canton of Ticino, is the only long-term residence where we never bought a property. Prices were just too high, especially on the glorious slopes of Paradiso and Montagnola, or in Castagnola-Cassarate on Monte Brè, where we hung our hats and hiking sticks. And for that, we could thank the house-shoppers of the Sicilian Cosa Nostra, the Neapolitan Camorra, and especially the Calabrian 'Ndrangheta. Because Lugano, as the closest Italian-speaking community out of the reach of Italian prosecutors and revenue agents, has made a living out of safeguarding what the


financial world likes to call "Black Money".

There's a special cachet to visiting your bank in Lugano. You don't arrive without an appointment, and you don't walk in through a grandiose entrance past a line-up of obedient cashiers and eager lending officers. You wait by a non-descript door for the camera to transmit your likeness, then you take an elevator alone to the fourth floor, where an attractive man or woman escorts you into a tastefully neutered conference room. And although no one is tacky enough to mention the utter insignificance of your pile of dough, you can sense it. Because this is Switzerland, after all. For all the American attempts to penetrate the mysteries of the Swiss and their finances, the vast mega-piles of money just keep mushrooming year after year.

Money in these parts feels no need to advertise, and that's just fine for the cross-border fugitives who provide the bulk of it. You wouldn't even know it was here, if not for the half-finished construction projects that require vast outlays of expenses without ever coming to fruition (in some circles, it's called "laundering"). And then, there are the dazzling bling and sculpted bodies on the twenty-somethings wheeling their eighty-something amours around the Parco Ciani. And the neat perfection of those graveland flower-lined paths, the orderly procession of Ferraris and Bentleys along the Riva Abertolli, and the phalanx of correct, spotless Polizia waiting to pounce on the slightest infraction of—non-financial—laws.

So if you don't have a big enough pile to spend your days watching and counting, what is


there to do (besides playing Spot-the-Mobster) in this paradisical Swiss community? As it turns out, quite a lot. Lago di Lugano is the lone Swiss entry in what most people call the Italian Lake District. Lakes Maggiore, Como, and Lugano (and farther away, Iseo and Garda) drain the Swiss Alps and feed the Po River that stretches from Turin in the east all the way to the western Veneto coast.



All the ruins Black Money can buy.

Como gets most of the paparazzi and ublicity, and we've never understood this because Lugano, being Swiss, is by far the most pristine and tourist-friendly. The roads

City to Draft Its Own Retail **Cannabis Initiative to Compete Against Proposed Ballot Initiative**

On a 4-1 vote, the El Segundo City Council opted to draft its cannabis ballot measure to counter a cannabis ballot initiative. It legally had to do one of three things: adopt the ballot initiative and approve it without it going to the voters; approve the ballot initiative for the November 2022 ballot and let voters decide to support or deny the ballot measure; attempt to negotiate with the ballot initiative's authors to arrive at a mutually acceptable cannabis initiative. Mayor Pro Team Chris Pimentel was the lone dissenter.

The cannabis ballot initiative the city council was forced to deal with has also been thrust upon other local cities, including Redondo Beach, Hermosa Beach, and Manhattan Beach. Its authors include Catalyst Cannabis Co. CEO Elliot Lewis and Damian Martin, the company's attorney and co-founder, who opened their first recreational marijuana dispensary in Long Beach in 2017. They now operate 11 retail stores in cities such as El Monte (El Monte's city council opted to adopt the ordinance and not put it to voters), Bellflower, Palm Desert, South Los Angeles, Pomona, Santa Ana, and Northern California in Marina. For each city's ballot initiative, the authors have tapped a resident to be named on the initiative, a legal requirement for a petition to be launched in a city.

During public comment earlier in the meeting, an El Segundo resident told the council he had "happily signed" the petition but regretted his decision upon learning more about it. After learning more about the initiative, he said that he felt it was "just beneficial to whoever proposed it." Another resident, a father who has lived in El Segundo for ten years, said he is 100 percent pro-cannabis but 100 percent against the proposed ballot initiative, saying, "Don't let another Hyperion come in here and tell us what to do." He asked the city to draft its cannabis ballot initiative that would align with what benefits the city and more in line with his perception of how recreational marijuana should be allowed to be sold in the city. He said the city needs "to get a tax component on this," which the proposed ballot initiative does not include.

The city council voted unanimously to direct staff to draft a separate tax ballot measure. If any cannabis initiative passes (either the one backed by Catalyst or the one put forth by the city), voters could add in a tax component to allow the city to receive funding from the retail sales. City Attorney Mark Hensler noted that the tax measure on cannabis retail should be a separate ballot item. Councilmember Lance Giroux correctly pointed out that all tax measures have to be approved by the voters.

In addition to the proposed cannabis initiative lacking a tax funding mechanism, City Council also did not like the "third party point system" it uses to select the two cannabis retail outlets allowed to operate in El Segundo under the proposed ordinance. City Attorney Hensler noted that the system is a "political football" that isn't "cost-free" since any litigation would have to be monitored by city staff. The City of El Monte, whose city council opted to adopt the proposed cannabis initiative as presented sans going to voters, is now in litigation over the thirdparty point system selection process for its city's cannabis retailers. Hensler also noted that "there's a cost that goes with (getting) each measure to the ballot." That cost for



Film Review

Petite Maman is a Beautiful Storybook Rendering of a Child's Grief

Where to watch: In select theaters this Friday, April 22.

Céline Sciamma returns to the big screen with an intimate portrait of a girl in mourning in Petite Maman. Scaled back in both story and scope in comparison to Sciamma's last feature, Petite Maman packs a plethora of emotional catharsis and full circle sweetness into its 72-minute runtime.

Is Marion real? A figment of Nelly's imagination? Or something more? Sciamma plays with these ideas early on but does a fantastic job of staying rooted in reality. Instead of leaning into the abstract sci-fi realm, she expands on the whimsicalness of childhood imagination and optimism (although the comparison to Netflix's Dark can be made whole-heartedly). Her signature themes of female companionship and emotional intimacy

A beautiful gliding one-shot establishes the environment our 8-year-old protagonist, Nelly (Joséphine Sanz), finds herself in: a nursing home on a dreary afternoon in the French countryside. She goes room to room, politely saying "Au revoir" to the elderly women that inhabit the home, and we quickly learn that Nelly's grandmother was a resident there until recently. Packing up the grandmother's humble belongings is Nelly's mother (Nina Meurisse), whose vacant eyes express her inability to accept this new reality.

Upon returning to the family home, which Nelly's mother and father (Stéphane Varupenne) are tasked with clearing out, Nelly is free to roam throughout the untamed wilderness behind the house. Stumbling upon the fort that her mother constructed as a kid, Nelly meets another girl her age, Marion (Gabrielle Sanz). The two girls connect quickly, similar upbringings and temperament make them fast friends but a few too many coincidences lead Nelly to question who Marion really is and soon learns that Marion's presence can offer her a sense of closure in her Ryan Rojas

contribute to the film's most memorable moments, fitting nicely into her canon of highly impactful and poignant work.

Petite Maman is a beautiful story about a child's navigation through grief, told with a tenderness that quietly radiates with femininity and compassion.

sidewalk away from the runway [at LAX]!"

Undeterred, Nate and Kelsey bought their home, a decision that Chittick has never regretted. "The town has been exceptional," she said. "I adore my home. I am so grateful that we are here, for all the reasons, but especially after he died."

Fast-forward to early November of 2017. Chittick, always interested in bettering herself, had an opportunity to attend a retreat in Jamaica with a close friend, a retreat to focus on personal growth. Chittick said that she really did not want to leave the family, because she had a sense of foreboding that, "for a long time, something awful was going to happen." But Nate encouraged her to take the trip and took his wife to LAX. Which was the last time Kelsey saw her husband.

Kelsey related that the last time she saw Nate, "we held hands, we hugged, and he said the kindest things."

In Jamaica, Chittick received an urgent text from her friend Michelle Keldorf, saying that Hobgood-Chittick had fallen at a trampoline park while on an excursion with their kids. The communication was that Nate was OK, but Kelsey said, "I knew at that moment that he was dead." In a daze and still in her swimsuit, Chittick booked a flight to return to Los Angeles, a journey that she vaguely recalls.

Chittick, a stand-up comic for years, believed in the importance of keeping a journal. During her grieving process, she wanted to capture her emotions and feelings at the moment. "I wanted to put down all of the awful things that I was feeling," she said, and "let someone else 'hold it,' whether it be my computer or somebody else."

Two years after Nate's death, Kelsey felt that she had enough journals to coalesce into a book. She authored the book for her kids and because, as time passed, "you forget things. It gets fuzzy as time goes on. I just wanted the kids to know our love story, the story of their Dad."

Her book, "Second Half: Surviving Loss and Finding Magic in the Meaning, was published in 2021. She is working on a second-book proposal, a collection of essays that will embody "all of the opinions that I have."


Sarah Barlup has called Chittick a friend for six years. "I consider Kelsey one of my best friends, and I know she has many of those," Barlup emailed.

"Kelsey is like no other person in my life. She can read and understand a person better than they can themselves, and she will let you know through her guidance. She shows up even if you do not ask her to. Her spirituality and faith ground her and guided her through the most tragic events. When tragedy impacted her and her family, she met it with strength and work. Good god, did she work. She dug in, most would have perhaps gone a different path, and none of it was easy. And then, she writes a book, a bit of her own therapy but more so guidance for those who have experienced a similar tragedy. I realize I have missed her most unique trait. She is the funniest person I know. No one can make you laugh as Kelsey can!"

Chittick has done stand-up comedy gigs for more than a decade. But she said plying the comedian trade in the Los Angeles area, especially as a mother of two kids, is quite challenging, so she has veered into inspirational speaking, addressing groups like the El Segundo Education Foundation.

"I found out, over time, that doing standup was not that great for me," she said and has looked for events like gala's where she does not have to start her routine at midnight in a club in Los Angeles. She also has a podcast: KeepON, that she started with her friend October Gonzalez. "I am always intrigued by people who have gone through... really tough stuff," Chittick said, "and still seem in love with life." Chittick is looking forward to starting another podcast in May.

"El Segundo is the most special place. Everybody here has good hearts and intentions. We might disagree on issues," she said, "but I truly believe that everyone is here because they want to live in a town where they are safe, loved, and part of something that makes it feel like home."

For recreation, Chittick said, "I do a lot of walking. That is when I think the best," while noting how walking is the time "when I have the least amount of anxiety." She also does yoga and is a huge proponent of taking time to meditate.

Asked how she has evolved since the death of her husband, Chittick said that "I like this Kelsey much more. She is much more grounded, and here, and present. I think I [now] live life like Nate did. I am in awe of everything because I see how quickly life can change. I am the happiest that I have ever been, except for the grief that is always with me.

"I would not want to be anywhere else," she said. •

Mayor Floyd Carr started the Mayor's Breakfast as a way to bring the community together. Ever since its inaugural year, all El Segundo mayors past who can attend this annual event join the current mayor and residents of El Segundo for a morning meal. In fact, two benches in Library Park sponsored by the club are dedicated to two past El Segundo mayors who were Rotarians (members of the Rotary Club): Dick Van Vranken and Floyd Carr.

The Rotary also provides scholarships for local high school students based on a service-based application, small stipends to all graduates, and a special scholarship for a student in El Segundo's sister city in Guaymas, Mexico.

Fowler has been a member of Rotary for the last twenty years or so, and she's been a resident of El Segundo even longer. Fowler moved to El Segundo when her husband's job with Eastern Airlines brought them to the South Bay in the early 80s. Since then, they've raised their children through the entire El Segundo school system and gotten involved in several local programs and events.

Fowler served as the Rotary Club president in 2015 and 2016, and she currently serves as Director of International Service. Each year, the club assesses current needs globally and where they can best help. This year, the club will be traveling to Puerto Rico to aid hurricane relief.

During her presidency, Fowler was thinking of a way to raise money for the El Segundo Unified School District and El Segundo's local food bank, CASE (Community Alliance to Support and Empower). She needed something inexpensive but fun and something that could rally a crowd—a rubber duck formed in her mind.

Each year, the Parks and Rec department hosts the Hometown Fair, a celebration of the city and its residents, welcoming everyone. Working in tandem with the event organizers, Fowler planned a rubber ducky extravaganza.

This year, the event is being hosted by fellow Rotarians Jim Miller and Ryan Danowitz, with the help of Fowler, Jon Stabile, Meredith Beachly, and Len Bonilla. Residents can adopt up to 25 ducks, and then at noontime, several ducks are pulled from the pool, and major raffle prizes are given out.

"We let people 'adopt' rubber duckies, and they can buy anywhere from one duck up to twenty-five ducks," she says. Ducks are \$5 apiece, and they also come in "quack-packs" for special deals. Entrants can buy a graham quacker, which gets you three ducks for \$10, a six quack, which gets you six ducks for \$25, one dozen quackery, which gets you 12 ducks for \$50, or a flock of quackers, which

from front page is \$100 for twenty-five ducks.

The grand prize this year is a \$500 Amazon gift card. Other prizes include bikes donated by Bike-o-Rama, and a plethora of donations and gift cards from local businesses, big and small. Fowler said there were more than twenty winners in past events.

Fowler's favorite part of the event, she says, is the pulling of the ducks, when staff members take off their shoes and enter the pool in front of a crowd of interested children. The club typically hands out mini ducks to kids attending the fair, and at the end of the event, the ducks are dried off and stored for reuse in the future.

This year the event will be held on May 7th. Ducks can be purchased online at the El Segundo Rotary Club website or in person. At 12:30 pm, ducks will officially be pulled from the pools, and at 1:00 pm, winners will be announced on stage. •





are clean and well-marked, the buses, trains, and ferries leave on time, and if anyone litters, the trash and Shi Tsu droppings disappear within minutes. Yet there's a distinct tightening when you cross the border from Italy, a sense that no nonsense will be tolerated. It's a subtle reminder that Ticino might look like loosey-goosey Italy, but it thinks and feels like buttoned-up Switzerland.

One of our favorite recreations here is a day-trip up one of the long, winding fingers of the lake. Head east over the passes to Lago di Maggiore for a gander at Locarno or the odd, submerged Nativity Scene of Lavina-Mombello. Picture the young Italian partisans holed up here, plotting Mussolini's downfall and scampering across the Swiss border when

the Fascisti got too close. Picture Allen Dulles of the OSS negotiating with the German SS General Karl Wolff for the surrender of northern Italy—handing out a personal pardon (for 300,000 murders) in return for a few extra days of peace.

To the east, the road from Lugano to Saint Moritz pops through a tongue of Italy before hugging the deep-set Inn River and one scenic lake after another into the heart of Graubünden and German Switzerland. To the north, via the castles of Bellinzona, you can climb the Saint Gotthard Pass into Altdorf (of William Tell apple-shooting fame) and Luzern.

Or you can just hang out in the park, go for a swim at the Lido San Domenico, hike up and down the nearest Alp, and wait for the wine bars around Piazza Riforma to open. For special nights with a sense of history, there's the gourmet kitchen at Villa Principe Leopoldo, the onetime home-away-from-Prussian-home of the Hohenzollern dynasty.

Ben's father passed away in Lugano at the profound age of eighty-seven, and that event can't help but color our recollections of traveling here. Fortunately, we were able to enlist local friends and family in organizing the memorial on a blistering hot July afternoon at the ornate chapel on the way up to Breganzona. And the Ticino Canton officials proved unfailingly kind and helpful in resolving all of the details, important and petty, that attend such a misery.

On Dad's instructions, we spread his ashes in the freezing cold waters rushing down

from his favorite Alp into the lake at Foce del Casserte. According to legend or science—we really have no idea which—every drop of water on the planet circulates (through flow and precipitation) into every other corner of the planet within a five-year period. So when we gaze out from a beach in Southern California, a dock in Mumbai, or a Norwegian fjord, we find Dad still with us, just as we do when we return to Lugano. And for some obscure reason, that's a comforting thought.

They will be required to have 5,000 square feet of retail space, be housed east of Pacific Coast Highway, not fronting main thoroughfares. The proposed ballot initiative would allow the two retail cannabis sites in Smoky Hollow near Main Street and on both sides of a stretch of Pacific Coast Highway.

In other news, the council voted not to allow the Kiwanis to have alcohol at Recreation Park for its Chili Cook-Off. Instead, allowing them to have it at Library Park, where alcohol consumption has been allowed during city concerts in the park. The 2-2 vote (Mayor Drew Boyles recused himself) wasn't sufficient to tip the alcohol approval to Rec Park, with City Attorney Hensler noting doing so would set a precedent moving forward. Council

members Giroux and Scot Nicol favored approving alcohol for the event at Rec Park. Councilmember Carol Pirsztuk and Mayor Pro Team Pimentel were the "No" votes.

Several public comments opposed the use of the city's tennis courts for pickleball. One resident, who has lived in El Segundo for 51 years, told the council, "Pickleball is taking over our tennis courts." He also noted that for every four players on a tennis court, pickleball courts allow for 16 players per tennis court, which increases parking. He also stated that a tennis player fell and hurt herself due to a pickleball line left on the tennis court. Pickleball lines typically should be removed from tennis courts before tennis players begin to play. He suggested the city invest in creating new pickleball courts to allow for the uptick in pickleball play the city has seen recently.

Councilmember Nicol reminded residents of the El Segundo Citizen Hyperion online Zoom Forum on Thursday, April 21, at 6 p.m. The public can gain information from Hyperion staff members about what is going on at the plant, which suffered an emergency last July, and recovery and forward motion efforts are still underway. He said the city website has a link for registering for the event. • for misdemeanor DUI and for two outstanding misdemeanor warrants.
