City Using Key Performance Indicators to Track Services

In developing a three-year strategic plan last summer, the El Segundo City Council committed to achieve five major goals. The list includes enhancing customer service and engagement; supporting community safety and preparedness; developing as a choice employer and workforce; developing quality infrastructure and technology; and championing economic development and fiscal sustainability.

Under the umbrella of "enhancing customer service and engagement" are objectives for the City to be "transparent regarding services and performance" and to "report City-wide performance indicators." With that in mind, staff last month began to provide monthly reports of key performance indicators (KPI) to track how the City is doing in various areas ranging from public safety response time to filling both potholes and personnel vacancies. City Manager Greg Carpenter cautioned that the endeavor will take some time to bear fruit, as staff is still creating baselines for metrics that will more accurately measure the organization's performance over the long haul both here in town and in comparison to other municipalities. "It's still early in the process—it's like driving to San Francisco, but we're in the San Fernando Valley," Carpenter said. Still, some early numbers provide an interesting initial snapshot now that the City can make its first month-to-month progress notation. For example, the total number of plan checks run through the City rose from 51 in February to 63 in March. Department review of said plan checks took 15.8 days last month as opposed to just 13.6 days in February. The reports also figure in the amount of full-time employee (FTE) hours devoted to each plan check, with March

seeing the numbers grow to 7.9 per FTE versus 6.75 in February. However, the statistics can't be judged in a vacuum, according to Finance Director Joe Lillio who attributed the time upticks to the fact that staff received "more complex reviews" the second month.

In the City Clerk's office, turnaround time to process all City contracts decreased from eight days in February to 6.9 days in March—with the number of contracts also up from 14 to 39. The City also processed six film permits in February and four more in March with an average turnaround of 48 hours.

More people visited the library in March, with 16.612 stopping in compared to 12.386 in February. Attendance at programs also jumped considerably, from 333 up to 619. This despite a slight decrease in library card holders (19,586 down to 19,223).

In some encouraging news for January and February, the El Segundo Police Department indicated that Part 1 crimes dropped by 25 percent. The main drivers were declines in theft and larceny incidents. The number of Priority 1 (requiring immediate police response) calls decreased from 155 (with 6.5 calls per FTE) down to 112 (4.7 per FTE).

On the Fire Department side, the amount of time for dispatch to arrive at the scene for See City Council, page 7

El Segundo School Board Approves Comprehensive Campus Safety Plans

Fifteen days after a special education teacher and two of her young students were shot by her estranged husband in her classroom at North Park Elementary School in San Bernardino, the El Segundo School Board unanimously approved comprehensive safety plans at El Segundo Unified School District's four campuses. The plans, updated on an annual basis, serve as a guide for faculty and staff in dealing with emergency on-campus situations that might arise.

The plans typically first receive input from interested members of the public, are then crafted, and if necessary updated--incorporating suggestions from school safety committee members prior to review by law enforcement officials. The next step in the process is usually the adoption of the safety plan by the school site council, with the last step Board approval.


Prior to approving the safety plans, the Board members recognized standout District employees for sterling contributions. The Board feted educators of the year, including Marcos Bolanos (El Segundo High School), Scott Garinger (El Segundo Middle School), Renee Hoover (Center Street Elementary School), and Celia Plotkin (Richmond Street Elementary School). Ballmer's Latest Project Looks at the Big Picture

Steve Ballmer says he loves numbers because they reveal what's really happening within a complex system. He relied on them when he ran Microsoft Corporation and now as owner of the Los Angeles Clippers, that information and explains with numbers the areas where government makes money, loses money, or breaks even.

Ballmer wants the public to know upfront that USAFacts.org is nonpartisan and free to use. The billionaire owner and former chief

he depends on numerical data to run the team and watch games from the stands. The scoreboard doesn't just tell Ballmer who's winning. it breaks down the action on the floor into a measure of team performance.

In public life, Ballmer discovered it wasn't that easy. Anyone who wanted to understand the government's finances had to piece together local, state and federal data to get the big picture. Ballmer's latest project is a website called USAFacts.org that gathers executive at Microsoft financed it himself and hired a team of economists, researchers and writers who spent three years analyzing government data and looking for a clear meaning. For Ballmer, the project started with a conversation with his wife who wanted him to do more philanthropic work.

Before he increased his charitable work, Ballmer needed to grasp the bigger picture of where the money could do the most See Ballmer's, page 15

SWBIB to Award Students in Aero-Flex Pre-Apprenticeship Program

The South Bay Workforce Investment Board (SBWIB) has piloted an "earn and learn" model for high school students connecting interns with career pathways in engineering and advanced manufacturing. Up to 25 participating students in the SBWIB's Aero-Flex pre-apprenticeship program will gain work readiness and technical skills training along with their intensive internship. Once both programs are completed they will be awarded a \$500 stipend. In addition, students will receive many other benefits that will enhance their employment prospects.

One unique aspect of the program is that the employer is able to define the training plan that the students are taught, which allows the student to learn specific skills that the employer needs. Training in work readiness skills are

provided through online and in person courses and through work-based learning and on-thejob training. Additionally, students will receive an Industry-recognized stackable credential, and opportunity to advance to employment, complete college and/or enter into a Registered Apprenticeship. Membership into the Society of Manufacturing Engineers (SME) is also included, providing them access to SME mentor programs, SME Connect, scholarships, competitions and more. Students who complete the program can also earn qualified credentials to add to their college application and resume. Program expansion will later include post-secondary students, veterans, returning service personnel and other under-served or under-employed populations.

Wiseburn School Board Discusses San Bernardino Shooting

As construction at the Wiseburn/Da Vinci High school site on Douglas Street continues, with the first day of school slated to be on August 22 and the ribbon-cutting ceremonies set to take place on August 12, the Wiseburn Unified School District School viewed special presentations from Juan Cabrillo School Principal Margaret Lynch and District Program Specialist Peggy Mazzarella. They also addressed the recent campus shooting incident that occurred in San Bernardino, resulting in the deaths of an elementary school teacher and one of her students.

Lynch's presentation was supported by Juan Cabrillo counselor Elisa Lopez, who has established a program that has as one of its main components a school-wide Positive Behavior Support System (PBS). Lynch called her presentation a "thank-you note to the Board" because two years ago, the Board had approved a part-time counselor at Cabrillo. "This is the first year we have had a [full-time] counselor at Cabrillo School. We want to share with you how that is supporting students, and the data that is supporting the effectiveness of the program," said Lynch.

Lynch and Lopez spoke of "behavior expectations" at Cabrillo, as well as three tiers of support in place on the campus that teach students from Kindergarten through second grade. Lopez mentioned components of the counseling program, including "whole-body listening," "expectation assemblies," and the implementation of re-aligned "Cabrillo Cub cards" to reinforce positive behavior.

The presenters also shared gathered data on the decrease of negative disciplines at the school since the implementation of the PBS program. Data showed that student "warnings," "white slips," and "in-school suspensions" have decreased substantially since the advent of the campus counseling program.

Lynch and Lopez also spoke of the 3Bs that are among the cornerstones of the program, including Being Respectful, Being Responsible, and Being Safe. A behavior matrix has been created, and all campus staff members have been trained to consistently implement the matrix expectations and reinforcement with the Cub cards. Concluded Lynch: "I hope you can see that having a full-time counselor is making a huge difference for our students."

Board member queries about the Cabrillo program then followed. Superintendent Tom Johnstone then added his thoughts, also recognizing Lynch for a recent achievement. "We haven't really been publicly able to recognize Margaret for her achievement as elementary school principal of the year for the entire state of California," he said.

Mazzarella's presentation focused on the Wiseburn Child Development Center, which offers preschool and before/after school care See Wiseburn, page 7

Injuries and Inconsistencies Plague Dodgers Once Again

Emery's Surge Leads Eagles to Victories

As of last Sunday, the Los Angeles Dodgers hadn't won a series since beating the San Diego Padres in three of four games to begin the regular season. Being that it's only less than a month into the season, it becomes hard to form a concrete opinion about a team that still has over 135 games left to play. So far, a few major weaknesses have been exposed and injuries have already begun to pile up for a team that constantly seems to be plagued by them. If this is indeed the year for the "Boys in Blue," Dave Roberts and company may have a long way to go before Los Angeles becomes part of the league's elite.

In the very, very young baseball season, the Los Angeles Dodgers have found that playing any team other than the San Diego Padres has proven to be difficult. That's not saying much, either. Ask any baseball fans around Major League Baseball and they'd be hard-pressed to name even one player on the Padres. The Dodgers beat San Diego in three of four games to start the regular season and L.A. fans everywhere were comfortable with where the team was at after the first weekend. Since that time, however, the Dodgers went 6-9 dating back to last Sunday and were 5-7 against other NL West opponents.

In addition to not having as much fun playing baseball against other teams as they have against the Padres, Los Angeles has been exposed against left-handed pitching. Opposing managers know that if they start a left-hander against the Dodgers -even a rookie lefty making his first appearance in the majors--they will have an excellent chance at winning the ballgame. The 2016 Dodgers had the worst batting line against lefties of any playoff team in MLB history. Not much has changed in six months. Opposing pitchers had accumulated a 2.20 ERA and 1.21 WHIP against L.A at the time of this writing. Basically, if you start a southpaw against the Dodgers, you're going to get a win more times than not.

"I think you guys are making it a bigger deal than anybody else," Dodgers utility man Kike Hernandez stated about the stats. "It's still April. If we're still not hitting lefties or righties in September, then it's a different story, but we're still in April and we're not going to make a big deal out of it or get in our heads." Whether it's early in the season or not, offense has certainly been a problem for the Dodgers. That fact was no more apparent than in the series versus the reigning World Series champions, Chicago Cubs. The Dodgers were 1-21 with runners in scoring position in the series and seem to continuously miss on key opportunities every time they have a chance to score a run. Granted, the Dodgers do have the ability to get runners on base and even get them into scoring position. It's only once the team gets ready to score, however, that they fail by either grounding into double plays or continuously strike out under pressure. A team that can't play under pressure can't make it deep into the playoffs and that, after all, is what this year is all about for the Dodgers.

Injuries have certainly piled up for the Dodgers as well. So far, the team had already put 11 players on the DL only three weeks into the season. Logan Forsythe, Rob Segedin, Andre Ethier, Scott Kazmir, Grant Dayton and most importantly Rich Hill have all found themselves on the disabled list, among others. The Dodgers have some incredible depth on the roster, but depth doesn't matter when injuries continue to plague a locker room that has been marred by them for the better part of two years now. The "Boys in (Black) and Blue" better get healthy if they want any legitimate shot at playing into October.

Not everything has been negative surrounding the Dodgers, though. The bullpen has been mostly solid, the back end of the rotation has really stepped up and Clayton Kershaw is still really, really good. Players like Andrew Toles, Alex Wood and Ross Stripling have all stepped up to bolster a roster that has been plagued by the injury bug. Corey Seager and Justin Turner have proven to be invaluable and the Dodgers have many other skilled players in the minor leagues champing at the bit to get their chance at playing under the bright lights of the MLB (if Cody Bellinger gets a chance, watch out). Also, don't forget Julio Urias who is still waiting on his call to join the major league club and could do so this week.

The regular season always has its own way of playing itself out, especially when there are still over 135 games left to be played. The Dodgers haven't been left for dead yet, but there is still a lot of work left to be done, as there likely is with most major league clubs at this point in the season. The truth surrounding the Dodgers is that Roberts and the front office occupied by Farhan Zaidi and Andrew Friedman are taking their time in slowly evaluating a team that they are almost certain will be competing for a championship this year. The diamonds in the rough will undoubtedly rise to the top and the weak links will fall off of the chain as the regular season carries on. In the meantime, it sure is fun to dissect a team that may have its best chance at winning a World Series since 1988.

The El Segundo High School baseball team has had one of its most successful seasons in years. The Eagles are 17-6 overall entering this week's play. With convincing wins over Beverly Hills and a narrow loss to Redondo, the Eagles are setting their sights on a long playoff run. With Jake Palmer set to obliterate the school record books for batting average and Spencer Palmer not far behind, the Eagles will need others to step up as well. Sean Emery has emerged as another big hitter in an already deep offensive lineup.

Beverly Hills was leading the Ocean League along with Santa Monica before facing the Eagles. 


Check It Out By Gaslight

Author Steven Price's latest work is pretty heavy. Yes, it's an impressive weight, with over 700 pages and not for the faint of heart.

In those 700-plus pages, an entire lifetime is laid out, dipping into real history and blended with speculation. Allen Pinkerton and his sons William and Robert really did exist, of course. Founded in 1850 as the Pinkerton National Detective Agency, the business provided security as well as detectives. Pinkerton detectives were hired by Abraham Lincoln as his personal security force. However, William Pinkerton never went to Great Britain and assisted in criminal cases with Scotland Yard. But what if he had?

It is with that premise that Price uses as his hook and soon he has created a murky world of fog, grime and extreme poverty as William roams the streets and alleyways of 1885 London, pursuing a missing woman who seemingly jumps to her death in front of him. William is searching for someone else, someone his father knew during the Civil War. Maybe this woman, Charlotte Reckitt, knows where to find Edward Shade?

The novel is told from several viewpoints and each character has a different perspective. Edward Shade is a mysterious person who figures in several subplots and has at

least one other identity. His connection to the Pinkertons runs deep and spans many years. What exactly was the relationship he had to Allen Pinkerton and his network of spies?

While William is enmeshed with Scotland Yard investigators in the possible murder/ suicide of Charlotte, he also takes time to reminisce about his childhood, his difficult feelings toward his father and his guilt about leaving his own wife and daughters while in the pursuit of others. There are remembered previous cases from the American West, up against scenes following leads down into sewers in Victorian London, chasing perverse "beserkers." Memories of a character's previous days in South Africa's diamond mines also round out the tale.

The prose comes alive: the damp chill of the rain and gritty fear of the criminal underworld seem dangerously real while reading this book. Melancholy clings to the words and Pinkerton's world-weariness becomes contagious.

It's a crime novel, a mystery, a Western, historical fiction and a bit of Steam Punk as well. As a reader you start down one road, but end up traveling many other routes--never sure where you will end up. And that can be an interesting way to go.

<u>Film Review</u>

Mélanie Laurent Inspires Eco-Conscious Change in *Tomorrow*

On April 22, 2017, the "March for Science" took place in Washington, D.C. and in over 500 cities across the world, bringing government attention to the importance and impact of scientific research on the future of our global civilization (a cause that some in positions of power are planning to de-fund). It was opportunity to have a collective of voices heard and inspire others to make a difference. With a similar agenda, and timed for Earth Day, comes Tomorrow, an eye-opening ecodocumentary from French actress Mélanie Laurent (Inglorious Basterds) and activist, author and filmmaker Cyril Dion.

Tomorrow begins with shocking statistics about how the demise of the human race is due to three contributing factors: climate change, the destruction of the earth's surface, and population growth. It is nothing we haven't all heard before, but instead of just reciting facts and taking a doom and gloom perspective, this documentary gives insight into how we can make a difference locally, in our towns, and on our streets and backyards.

Divided into five chapters, Tomorrow looks at different countries and cities to explore how the local communities are living green and working together towards a happy and healthy lifestyle for all (and I'm assuming the filmmakers even planned their flights accordingly so as to not use too much fuel for their various travels).

Chapter One focuses on agriculture--mainly urban farming in Detroit. The main takeaway here is that cutting down on meat consumption, even if only one less day a week, will have a huge impact on reducing our carbon footprint and saving resources like fossil fuels and fresh water. Chapter Two is all about energy and the goal here is to eventually have all energy produced by the sun, wind

or water--and not carbon, coal or oil (plus, geothermal heat is free!). We travel to the energy-conscious city of Copenhagen, where 21 percent of people get around on foot, 26 percent use bikes, and 20 percent use mass transit. That means 67 percent of people don't drive. As a Los Angeles native, this is one of the most mind-blowing facts to comprehend.

Chapter Three focuses on the economy and the necessity for an ecosystem of currency--not just one universal standard. We visit Switzerland to get a better understanding of its two-currency system, which claims to be more resilient than just a single method of payment. Chapter Four talks about democracy and we look to India for a better understanding of how a proactive local government is giving a new meaning to the word "democracy." Chapter Five is all about education. We look to Finland to gain a better understanding of its inspiring school system, which educators say is due to the trust in child-centered teaching methods, no national testing and having teachers undergo lessons in child psychology before running a classroom. It is typical for a classroom in Finland to have two teachers per 15 students, a stark difference to the underfunded and overcrowded classrooms in America.

It's a scary thought to know that at this rate, catastrophic changes can happen by the end of the century. The silver lining that Tomorrow emphasizes is that it is not too late, but only if we act now. The consequences of our actions have been overlooked because these effects don't happen overnight but take time to develop. Unfortunately, we're feeling the heat (pun intended) and this is the critical time for humanity to understand that how we have treated our planet is catching up with us. Fortunately, we can still do something about it. The message is that we only get one world, so let's do our best to take care of it--starting today. •

emergency medical services edged up a notch from four minutes and eight seconds to four minutes and 14 seconds. Fire call response was up 24 seconds from the prior month (five minutes and 23 seconds in March).

The KPIs also include the number of Community Emergency Response Team (CERT) members who received training. Nine more individuals took CERT classes in March on the heels of 19 in February, with staff labor time adding up to 60 hours each month.

The Human Resources Department has also been busy as it oversees employee hires, with eight positons filled in March and 24 total year to date. There were no internal promotions last month after three in February. The City also lost six people—two full-time and four-part time. The lengthy (129-day average wait) period to fill recruitments may seem alarming at first, but Lillio explained that the numbers are skewed due to the necessary extensive search for major department head spots such as the new Police Chief and Information Technology Director.

Looking to keep an eye on local infrastructure repair, the KPIs also include a running number of potholes in town filled on a monthly basis with 254 done in March and 620 total for 2017. February and March additionally saw a combined 52 skin patches (to fill depressions in the road), 13 sidewalk grinding repairs and two digouts that all told required 139 labor hours.

And thanks to a heavy outreach campaign in which customers received flyer inserts and the City highlighted information on its website, online payments for water bills swelled by nearly 50 percent in March from the previous month.

While pleased with the progress, members of the City Council have already begun making some tweaks. Mayor Pro Tem Drew Boyles asked if stats on employee turnover can be annualized with percentages rather

programs. She gave her update, noting that "we are very, very busy. We are serving approximately 360 students throughout the District, and we are full." She also shared parental survey results, which gave the program very high marks in all categories, and highlighted how the positive behavior matrix developed at Cabrillo and was mentioned in the prior presentation is also utilized in Child Development Center programs. She noted ramped-up professional development opportunities for WCDC staff, and the increased access to technology for the District's young learners. Increased safety enhancements were broached--critical in light of recent school-site violence, including door-locking procedures and the installation of doorbell and video cameras as well as alarms. Increasing campus safety, always a priority, has been highlighted because of the recent horrific shootings in San Bernardino.

Mazzarella mentioned that preschool parent training sessions have taken place, although the parental turnout has been somewhat sparse. She indicated that the timing of the trainings may be altered, adding that "we are going to keep working on how we can get better attendance." She added that some changes this school year included new classrooms at Cabrillo, and elimination of "extended care, because we want to focus on instruction." Space was an issue, she said. She also addressed the strides being made in teaching special education students. After the presentation, Johnstone noted, "I don't think we could have done what we have" [without the seamless transition from the prior group that had run the program to the WCDC]. "We have taken an awesome program and made it that much better." Board members and District administrators then had their turn to make comments, with the presenters departing and one of the folks who left at this point of the 90-minute meeting jokingly imploring Board members to "make good decisions tonight." The success of recent District events, including "Rock-Around-the-Block," were lauded, with kudos

going out to the hard work of the Wiseburn Education Foundation. Board Vice President JoAnne Kaneda voiced her appreciation of how well the event was staged.

Kaneda also brought up the recent tragic events that took place at the San Bernardino elementary school. Said Board President Israel Mora, "Unfortunately, it is a reality of life and something that we are going to have to look at closely. We all know that we don't want our schools to be prisons." Talk ensued about how the San Bernardino shooter, who then committed suicide, easily gained access to the classroom to murder his estranged wife and an innocent student. Mora said it was an important topic, and if District personnel are having "issues" with a significant other, "maybe it needs to be discussed--but of course, nobody likes to do that. Things happen in the country, and we just can't say that it is not going to happen here."

Superintendent Johnstone, addressing the devastating fallout from the school-site shooting, said that the District was working on its sign-in protocol to limit visitors and family members on-campus during the school day and after-hours. He also touted the "activeshooter" training taking place for District teachers and "significant office staff" on April 27. Next year, he said, District members will become certified to deal with possible "active shooters" on campus, through the "ALICE" Training Institute. Action items were next on the agenda, including the approval of the safe school plans--a huge issue considering recent developments. Construction change orders at the new high school were next briefly mentioned, with all well heading towards the start of school on August 22. Consent items followed, with personnel issues quickly addressed. School open houses blanket the May District calendar, with Burnett holding its event on May 31. The next meeting Wiseburn School Board meeting has been moved up on the calendar, because of scheduling issues, and is now set for Thursday, May 4. •



(BPT) - Whether you're a high school senior or an adult looking to change careers, a college degree can be the key to a bright future. As acceptance letters arrive in the mail, another important document is not far behind: financial aid letters.

"College is a major investment, and many people require financial assistance to pay for it," says Harlan Cohen, New York Times best-selling author and creator of the Naked Financial Minute. "It's vital to understand financial aid so you can make informed choices and avoid surprises in the future."

The average cost of tuition and fees for the 2016-2017 school year is \$33,480 at private colleges, \$9,650 for state residents at public colleges, and \$24,930 for out-ofstate residents attending public universities, according to the College Board.

In order to find out what aid you qualify for, you should start by filing your Free Application for Federal Student Aid (FAFSA). After your information is processed, and you've applied to the colleges of your choice, you'll receive financial aid award letters in the mail with the results from each school where you were accepted.

Not all financial aid letters are the same, so deciphering and comparing them can be confusing. To help get you started, the experts at College Ave Student Loans share tips and tricks for how to easily understand your financial aid letter.

Know the difference between gift aid and loans: Gift aid is money that is awarded to qualifying students that isn't expected to be paid back. Gift aid includes things like scholarships, grants, and housing or tuition waivers. Not all applicants will qualify for gift aid, but most will be eligible for federal loans. As a general rule, you should expect that you'll need to pay loans back, usually with interest.

This is the amount of money your family is expected to contribute toward your college education based on their tax and savings information. This will impact your overall award package.

Think about additional costs: Your financial aid letter may not include all of the costs associated with going to school. Think beyond tuition and make sure you have an idea of what you'll be spending on housing, food, transportation, books, supplies, additional fees, and other living expenses.

Finally, if you're still unclear about the terms and conditions of any college award letter, it's important to reach out to the school to ask for clarification or discuss your options. You don't want to leave any money on the table.

good. What he didn't want was to duplicate government-funded services.

Specifically, he researched governmentfunded activities in health, education and human services, and quickly hit a wall. Information about how much the government spends taxpayer money wasn't being shared across federal, state and local levels. When the former chief executive of the world's largest software company Microsoft can't find data on the Internet, there is an information gap.

His discovery led Ballmer to create USA-Facts.org, which he launched last week. The website team is "passionate about making information available to the public." Calling it a work-in-progress, the beta version of the site released on April 18 is ambitious in its scope. And there's no political bent.

The government numbers and colorful charts tell the stories of American government activities, huge and complex as they are. Ballmer's team culled as much information as time and manpower allowed: 90,000 jurisdictions serving 320 million people. To be exact: 321,418,820 at last count.

"Whether government money is spent wisely or not, whether our quality of life is improving or getting worse--that's for you to decide," Ballmer's team says. The nonpartisan tone of the website is refreshing, as polarizing political viewpoints have no place in Ballmer's new project. In fact, he admits that his perception of "government bureaucracy" is different, knowing almost 24 million work in government. "People who work in schools, higher ed, public institutions of education--they are government employees," he realized. Those sectors alone account for nearly half of the 24 million jobs. The other big contributors to government employment are active-duty military and government hospitals, Ballmer learned. No longer faceless bureaucrats, the government workforce looks much different because "most of these people you like," Ballmer says. "Your tax dollars are helping somehow to pay 24 million people" who have mortgages, car payments and families to feed. How much money does state and federal government collect per year? The number is \$5.2 trillion, mostly from tax collection, according to USAFacts. Interestingly, the government also makes money on investments and runs several profitable businesses. State-run enterprises turn a profit on airports, public hospitals, transit systems and wastemanagement operations.

States that run a lottery lose money on that form of gaming and on gas and electric utilities. Ports, toll highways and parking lots break even, generating enough revenue to cover state expenses, according to USAFacts.

The federally-run business that weighs most heavily on Washington's balance sheet is the U.S. Postal Service. The nation's letter and package carrier didn't always lose money. The losses began in 2013 and have continued due to increased competition for package delivery and lower sales of stamps and postage. The Postal Service posted a staggering \$1.6 billion loss in 2015, the website shows.

Marriages, the nation's divorce rate and average family size are all listed here. And that's not all. Having run Microsoft and now the L.A. Clippers, Ballmer says he likes reading reports that summarize facts and figures into a simplified narrative. How are we doing financially? Are we meeting our goals? Were our projections right?

U.S. corporations must explain their finances and performance in an annual report called a 10-K, prepared for the Securities and Exchange Commission. Ballmer's website team has done the same, compiling an annual report about U.S. government performance and salaries. The president's salary of \$400,000 per year isn't a secret, but how much does the vice president earn annually? The answer is \$237,700, making the veep the third-highest paid executive in Washington. Chief Justice John Roberts is second at \$260,700, according to USA Fact's 10-K. Which state's governor had the highest salary last year? California finished third in this spending category, behind top-ranked Pennsylvania (\$190,000) and Tennessee (\$187,000). Being the top elected official in the state doesn't always translate into buck bucks, not for the governors of Arizona, Colorado, Kansas, Maine and Oregon who earn less than \$100,000 per year for their official duties. With the South Bay's reliance on space systems and defense, the categories that Ballmer labels "Provide for the Common Defense" and "Promote the General Welfare" include columns for the nation's spending on its military (\$812 billion) and space programs \$16.6 billion). States outspend the federal government by a nearly four-to-one ratio in support of the economy and on roads and bridges and other

essential infrastructure.

The California Legislature just passed a \$53 billion road repair plan for fixing local roads and state-maintained highways in South Bay cities and Los Angeles County and elsewhere over the next decade. Those repairs will be financed by higher fuel taxes paid by motorists and businesses, and vehicle registration fees. The bill, SB 1, from page 2

also charges electric-vehicle owners a new annual fee.

The billionaire sports owner says he's not trying to change anyone's mind about the role of government either. His mission is to keep connecting reams of spending and revenue data from across America's villages, towns, cities, counties and states, plus the federal government. •

at Richmond Street School, and Ochoa, called a "bedrock employee" by Farris, toils in the custodial department at the High School.

After Alex Nilsson's student presentation, Moore revealed the results of the District's Bond Feasibility poll, as the Board considers putting a school bond measure on the ballot in 2018. Pollster True North Research conducted the random poll, by phone and email, which yielded 352 participants.

District needs were delineated during the presentation, including the upgrade of classrooms and instructional technology to support student achievement; improved student safety and campus security; and the repair and modernization of aging classrooms and school facilities. Poll results showed that 32 percent of the participants have children who currently attend District schools; 86 percent rated the quality of the schools as "excellent" or "good"; and 69 percent felt it was "very important or better" to repair and upgrade aging school facilities.

Key takeaways from the poll included that initial testing showed community support, and

that the community was pleased with the quality of District schools. Other results indicated the need to clarify the usage of the proceeds from the former Imperial Avenue school site property, as well as the importance of further educating and engaging the community members. On the issue of spending the proceeds from the property sale, Moore said a special Board meeting has been slated for May 22 to tackle that topic.

Board Vice President Emilee Layne commented, post-presentation, that "we have not decided" to pursue a school bond. She implored community members to "really look at" the District's Long-Range Facilities Master Plan and give feedback to Board members.

Board Clerk Nancy Cobb mentioned the need to upgrade the District's technology infrastructure. She complimented the District on keeping the infrastructure viable with "band aids and duct tape," but said that upgrades are necessary.

The Board then discussed Southern California Regional Occupation Center (SoCal ROC) billing options. The presentation offered three billing options for the program, including leaving the current plan in place. Board President Bill Watkins, a long-time proponent of SoCal ROC, opined that a prorated billing option would best serve the students' and the District's needs. Currently District members pay \$1,234 per student enrolled per semester based on the prior year's enrollment. The plan that Watkins is in favor of would allow the students to drop a class early in the semester, with the District incurring only a cost of \$100.

Among the eight consent items quickly passed by the Board during the 125-minute meeting was an agreement with Quality Fence to install a "double-drive" gate at the western entrance of the Eagles' Nest preschool facility. The new gate will increase security at the preschool.

The Board also passed a resolution designating the week of May 1-5 as Teacher Appreciation week, as well as approving a new District job description "Athletics Field Marshall" that would have the employee monitor High School See School Board, page 17

The High School has recommended the creation of up to two part-time positions to be assigned evenings and weekends. According to District notes, the position pay range is from \$17.81 to \$21.63 per hour. Board member Jim Garza inquired about the funding for the position(s) and asked for more information on the proposed positions scheduling.

Information pending action items included consideration of Board approval of the Middle

School's Middle Years Programme (MYP) Design Course; as well as both the Middle and High Schools' summer reading lists. Moore then highlighted upcoming District calendar events, including Parent Math learning opportunities that will take place on May 1 at the elementary schools.

Board member reports followed, with Garza sharing comments on his time working with Bolanos, saying "he represents the best and the brightest of El Segundo High School. You can't buy that kind of dedication and passion for the kids and the community." Garza also expressed concerns about the District's enrollment for the 2107-18 school year.

Moore's report took note of a School Board workshop that took place on Monday evening, with the Board working with retired school superintendents Dr. Joe Condon and Paul Mercier in analyzing and reflecting upon the California School Board Association's (CSBA) self-assessment tool. Moore had previously noted the District's "continuous cycle of improvement," and said that the assessment showed

the Board's "significant strengths," noting the unity of the Board. Moore added that the selfassessment electronic evaluation helped the Board members conclude that the top three areas they want to prioritize going forward are the effective use of data in their decision-making process; a focus on informing the community about District priorities, progress and needs; and the use of cohesive messaging to reach out to the community and District stakeholders.

The next regularly scheduled meeting will take place on Tuesday evening, May 9. •



- 2. While the potatoes are cooking, heat a large skillet over medium heat. Add the olive oil, leeks and 1/8 teaspoon of the salt. Cook for 4 to 5 minutes, stirring regularly, to soften. Place the cooked leeks in the bowl with the potatoes.
- 3. Add the yogurt, paprika, oregano, maple syrup, mustard, 1 egg, the pepper, and remaining salt to the bowl with the potatoes and leeks. Mash the potatoes, stirring periodically, until smooth.
- 4. Place the potato mixture in the refrigerator for 30 minutes.

- 5. Preheat the oven to 425 F.6. Crack the remaining 2 eggs in a small
- bowl and whisk. 7. Add the panko to another small bowl.
- Season with salt and pepper.8. Make 2-tablespoon portions of the potato mixture and roll them into balls.
- 9. Working one at a time, dip the balls into the eggs, then dredge in the panko, pressing it to coat.
- 10. Place the balls on a baking sheet coating with olive oil cooking spray. Spray the tops of the balls with cooking spray as well.
- 11. Bake for 15 minutes and then, if needed, broil them for 2 to 3 minutes to brown. Serve immediately.
