

Resident Helps Home and Business Owners Get Organized

It can be daunting, and many of us don't know where to start. For those lacking organizational skills, getting things together in the house or at the workplace might seem like a monumental and exceedingly difficult task. Enter Alex Holz, an El Segundo resident who started her business, Tap to Organize, LLC, a year and a half ago. A professional organizer since 2015, Holz has a simple goal. "I help people get their homes or offices beautifully organized, one space at a time," she said. "I can take a space from chaos to calm, making the environment more functional and efficient."

Although she was already organized as a kid and loved visiting The Container Store every chance she got, Holz noted that this line of work was never on her career radar--and she wasn't aware such a vocation existed. A South

into the space utilizing bins, drawer dividers, and other useful products. The last stop is labeling to allow the clients to maintain order going forward. "I hope to touch as many homes as possible no matter what their budgets or circumstances are," Holz said. "From a simple purge to a whole house move-in, I hope to tailor my services to whatever stage of organization the client is at." Indeed, her client base runs the gamut in scope. For instance, she worked on a massive 12,000-square-foot home, but it can also go tiny. "The smallest areas I've organized were an under-the-stairs nook triangle space or a 12 1/2-inch-wide pantry," Holz said.

Holz is pleased to see a homeowner's stress level markedly drop once their space is free of clutter and in a sensible order. While she finds the job in general to be rewarding, some cases can be especially memorable and meaningful. "I helped an older woman move out of her home in the Palisades piece-by-piece because the thought of a big move in one day overwhelmed See Alex Holz, page 2

Bay native, she majored in Graphic Design at Cal Poly, San Luis Obispo, and landed her first job out of college in that particular field at the Eureka! Restaurant near SpaceX in neighboring Hawthorne. But her fortunes would change soon enough. "I started doing blog graphics for another home organizer, and at that time, organizing wasn't as saturated a market...so I didn't know it was a career option," she said. "I told her I liked organizing, so she put me on a job, and the rest is history."

Holz reported that business is going well so far but hopes to get the word out-especially considering that many people may not realize they can hire a professional organizer. In explaining the process of her service, she said it always starts with a home or office consultation where the conversation focuses on the particular space(s) to improve along with the clients' overall end goal. "Once I am on-site, I then take everything out of the space, categorize like items together, purge items that are no longer being used [she added that she even takes away donations] and finally organizes all of it back

Rules for Split Lots Changing

A 2024 state law is forcing California cities to rewrite their building codes for split lots and duplexes so they are treated the same as single-family homes. Because El Segundo currently uses different sets of requirements, city leaders have to make decisions about front doors, roof heights, and landscaping.

Community Development Director Michael Allen on Tuesday laid out the challenge facing city leaders in sorting out which design features to keep or throw out to comply with Senate Bill 450, enacted last year by Sacramento lawmakers. The purpose of the bill was simple: to remove barriers to developing more housing in classic residential neighborhoods with one home, a garage, and front and back yards.

In 2022, after California lawmakers approved SB 9, which cleared the way for more housing by allowing urban lot splits and accessory dwelling units, or ADUs, cities were told they could impose different requirements on ADUs and front houses with a second unit in the backyard. That's what El Segundo did.

The passage of SB 450 removed the flexibility given to cities, which now must make the development standards for R-1 single-family homes identical to those for R-2 developments with multi-family dwellings. It's up to each city whether to impose the R-1 standards covering front doors, front porches and landings, landscaping dimensions, and driveway widths or mix and match the different sets of building rules. her," she said. "So we'd meet weekly and take a carload of belongings to her new place in Beverly Hills until the house was practically emptied. We had planned to get the last load of miscellaneous items the day the fires broke out. I am truly grateful and humbled that her home survived and we were able to remove her memorabilia in time."

Holz lives in town with her boyfriend and is thrilled to reside in El Segundo. "Everything is walkable, we are closer to the beach, and the atmosphere is a little more laid-back than other cities," she said. Plus, The Container Store is only a few minutes away if she wants to visit her favorite old haunt. In addition to running her business, she is an ardent animal lover and parlays that passion into a sideline. "On the weekends, I am the manager at Down Dog Lodge, a local El Segundo doggy daycare," she said. "I love dogs so much and seeing some of the clients out and about here in El Segundo when I'm walking."

While readily available to set up an appointment, Holz was happy to share some tips with readers thinking about tackling an organizing project on their own. "I would recommend starting small," she emphasized. "Using the closet as an example, don't take everything out and throw it on the bed because then you will get overwhelmed. Start by category... one day, go through your shoes; the next, your hanging clothes; the next, your folded clothes. These small wins will give you confidence and make organizing a more rewarding experience." •

The El Segundo high school's athletic department can be proud of several teams that have started their CIF Sothern Section playoff run and the rest that will. Both of the lacrosse teams, the boys' volleyball and the girls' sand volleyball teams, began their quest for a CIF championship. The baseball team clinched their Pioneer League championship, and the softball team kept pace for a co-league championship. The golf team won their second consecutive Ocean League title and improved to 20-0 on the season.

Boys' Lacrosse Dominates First Round

The Eagles had a successful season, finishing second in the Ocean League, a half-game out of first. When the CIF-SS Division 2 playoffs were released, the schedulers were not kind to the Eagles. In the first round, they hosted the Orange Lutheran Lancers, one of six teams from the highly competitive Trinity League to advance to the playoffs. After a competitive first half in which the Lancers held a 5-4 advantage, the Eagles dominated the second half and came away with a 13-5 win.





At Tuesday's meeting, a sticking point for City Council members was how new homes should be landscaped. The current aesthetic for split lots calls for at least one 24-inch box tree to be planted in front of the main house and two trees on a wider lot. Single-family homes have no such requirement.

The council has a choice to make: either withdraw the tree requirement altogether or expand it to R-1 and R-2 new construction. Mayor Pro Tem Ryan Baldino got the tree discussion rolling, saying he watched the Planning Commission draft its recommendations to comply with SB 450. Out of that meeting came a suggestion that El Segundo keep the duplex-ADU tree requirement and apply it to single-family homes. The commissioners agreed that all new home construction would feature at least one tree in the front yard.

Baldino said that while he supports requiring landscaping and front-facing porches on all new homes, a tree requirement on new homes would interfere with homeowners' rights to choose their preferred landscape. He was a planning commissioner who helped get the ADU-specific building codes enacted.

He recalled how the Planning Commission hired an architect after SB 9 to draft objective standards so that subdivided lots didn't "destroy the residential feel of a neighborhood. "Then, lawmakers in Sacramento decided that building requirements on duplexes and ADUs had to apply to R-1 homes, too.

"Not everybody's a tree guy," he said. "I can be persuaded either way on the box tree, but right now, I'm leaning toward less is more. Just having the minimum percentage of landscaping is probably sufficient."

Michelle Keldorf, who also was a planning commissioner with Baldino before being elected to the City Council, said the trees were viewed as a way for new construction to blend with El Segundo's tree-lined neighborhoods. She said the Planning Commission wanted a duplex or split lot to share the mature appearance of El Segundo's existing housing. Trees are important to residents, she added.

"I know how sad everybody gets when we take down a tree," Keldorf said, sounding in favor of a tree in front of every new singlefamily home in El Segundo.

Councilman Drew Boyles gave a hard no to the Planning Commission's recommendation to expand the tree-planting requirement to new R-1 homes, while Councilman Lance Giroux said he supported the recommendation. Mayor Chris Pimentel indicated he'd go along with the Planning Commission's wishes.

Under existing building codes for split lots, one of the two housing units must be affordably priced, a provision that will likely be eliminated when the council makes a final decision at its next meeting. All R-1 and split lots would have the same roof heights: 26 feet for flat roofs and 32 feet for pitched ones.

Front doors must face the street on the front houses of a unit lot, which could also become the standard for single-family homes. El Segundo's building codes are currently silent about front

door placement on traditional homes. Under the proposal, front doors opening onto the porch could face away from a street.

The blending of building codes also covers driveways, second-story heights, roof heights, porches or verandas, garages, and floor-area maximums. In most cases, the Planning Commission thinks the R-1 standards should replace the current R-2 codes.

The council also considered a second buildingrelated proposal to delay collecting permit fees on new construction until the building is ready for occupancy. Under a fee-deferral program presented by Development Director Allen, developers would pay permit fees upfront only for immediate city services and staff time. He said no other city offers a deferral program for development permit fees.

The council adopted a similar change recently to the one percent Cultural Arts Development fee the city collects on new building projects to fund public art. Before, developers paid the public art fee upfront as part of the permitting process. Still, the new program allows them to make the payment when the city issues a certificate of occupancy after completing the final inspection.

Allen said no other city offers a deferral program for development permit fees, which could help El Segundo attract new businesses by easing developers' cash flow during construction. The Beach Cities' Media project on Rosecrans, for a 220,000-square-foot creative-arts office building, is paying the city \$1.5 million in fees, Allen estimated. The council voted to bring back the proposal for a final decision at its next meeting.

In other council matters:

The city's annual survey results, which measure satisfaction with city services, were revealed. Nearly 1,300 residents and businesses responded. Residents didn't see much improvement over the past 12 months and cited air quality, parking, odor, and noise as their chief concerns.

The city's businesses reported some improvement and praised City Hall for its business license renewal process. Services that could be better include more parking, the cost of business licenses and water, and public safety.

The Parks and Recreation Department revealed plans to launch an after-school program. According to Director Aly Mancini, who oversees parks and library services, parents have reportedly asked for a city-sponsored after-school program like the Camp Cowabunga summer camp. The council will form a committee to study the after-school kids' proposal, which could start in the fall and operate year-round.




where the top five total move on to the CIF-SS Individual playoffs.


