Council Discusses Downtown Specific Plan

The El Segundo City Council had a hefty agenda at its meeting Tuesday night, taking 4-1/2 hours to work through the items. The most extended conversation was an agenda item on the "Downtown Specific Plan Update, Environmental Impact Report Certification, Downtown Outdoor Dining Guidelines, Application Fee, and Renewal Fee," for which Mayor Drew Boyles and City Council mem-

District. The Rite-Aid, Chase Bank and Ace Hardware store on Grand Avenue will become part of the Grand Avenue District. Conditional Use Permits for museums (the new plan as drafted allows museums in the Civic Center and Richmond Street district(s) and nightclubs/entertainment and other possible uses, including for business and medical offices using Administrative Use Permits, were also discussed during the update on the new Downtown Specific Plan, as was parking and outdoor dining. City staff showed the "Preferred Concepts" for each street's/ district's constructs, which predominantly included widening sidewalks and turning two-lane traffic into one lane per direction. The staff mentioned the goal of the specific plan is to incentivize outdoor dining and to improve pedestrian bicycle mobility and public transit and vehicular circulation downtown. In some instances, parking was kept the same or lessened. The staff mentioned that the approximately 1,700 public and private parking spaces downtown are adequate and "adequate for future use." Mayor Pro Tem Chris Pimentel expressed "grave concerns" about going from two to one lane in the Grand Avenue and Main Street district, and City Council member Lance Giroux said he was "very confused on the nightclub aspect," which kept being brought up. "I don't know what the value of this is." Community Development Director Michael Allen explained that one person at a

Planning Commission recently had suggested that such use, regulated, could generate some foot traffic where there is none.

Interesting points were brought up during the discussion of the new Downtown Specific Plan, including whether or not to attach a CUP requirement (CUPs go to the city Planning Commission for approval before they can advance to the city council for approval and have a more robust application process that includes a public hearing) to any museum or nightclub use and attach an AUP use to office use, particularly on Main Street. "All manner of museums," said Pimentel, might head into the city's downtown without a CUP requirement. With regard to museums being required to gain a CUP to operate, City Council member Ryan Baldino said, "It's the fear of the unknown: the museum of novelties or something that is going to bring an element to the neighborhood we may not want but then we're crossing on certain ... " He stopped speaking as Pimentel said the city already has a different ordinance for dealing with "conceivably those issues." The trio agreed museums would not need a CUP. As for a nightclub, Giroux said, "I cannot imagine anyone could stay in business having a nightclub in El Segundo seven days a week. We barely have restaurants open seven days a week." He noted that, in general, for downtown, a nightclub would be a "pop-up situation." The trio agreed to add a CUP to See City Council, page 11

ber Carol Pirsztuk recused themselves due to property ownership in the area affected by the agenda item. Other items of interest

Tuesday night included e-bike riders in the city; updates on the neighboring Hyperion Water Reclamation Plant and odors; increasing wages to be able to attract lifeguards and other staff to be competitive; a presentation on the Arts and Culture Advisory Committee and its Cultural Development Fund for Fiscal Year 2024-25 Initiatives, and a presentation by Cal Cities on the California Business Roundtable "Taxpayer Protection Act" ballot measure that is eligible for the November 2024 ballot. Cal Cities is opposed to the measure, which it says threatens local control, upends local government tax and fee authority, reduces state and local government funding by billions annually, and opens the door to countless lawsuits against cities. The new Downtown Specific turns the current six districts into four: the Grand Avenue

District, The Civic Center District, the Main

Street District, and the Richmond Street

Board Recognizes El Segundo High School Boys Basketball Team

The Board of Education recognized the El Segundo High School boys basketball team for earning runner-up honors in the Division 5AA Boys CIF championship, and then advancing to the Regional State Championship. Team leadership included Head Coach Scott Martin; Assistant Coaches Bill Endo, Glenn Marx, Gene Laney, Ryan Booker, Visas Arora, and Marnello Berry; Team Manager Jayden Maxwell; and Athletic Trainer Erica De Leon. This season, the ESHS boys basketball team won an impressive 23 games, the most in the school's history. It was also their first appearance in the CIF Championship Game in 22 years, and only the fourth overall in the school's history. Individual player accomplishments included: Shane Biscaya: CIF Player of the Year (the first in ESHS history since 1967, and only the second ever), Second-Team All-Area, First-Team All-Pioneer League Alexander (Elijah) Coles: First-Team All-CIF Darreson Naruse: First-Team All-Area, Pioneer League MVP Gavin McKinnon: Second-Team All-Area, First-Team All-Pioneer League Jack Pintens: Second-Team All-Pioneer League Scott Martin: CIF Coach of the Year (first ever to be named Coach of the Year in his first season), Pioneer League Coach of the Year Congratulations

to all basketball team members for this accomplishment! This year's team included Timothy Anderson, Shane Biscaya, Logan Brooks, Alexander (Elijah) Coles, Vitor Dorn, Liam Endo, Nader Esdin, Gavin McKinnon, Darreson Naruse, Miles Nguyen, Grant Ostler, Jack Pintens, Tate Pintens, Keith Puckett, Ross (RJ) Puffer, Nicolas Shoepe, and Lucas Sun.

State of Eagle's Nest Preschool, TLC

Guadalupe Grijalva, executive director of Eagle's Nest and The Learning Connection (TLC), and Denise Azcuna, director of TLC, shared a presentation on the state of the programs. Highlights from the presentation included:

Eagle's Nest:

99 students were enrolled during the 2023-24 school year.

Students completing the four-year-old assessments are consistently meeting developmental domains and making gains from one year to the next.

For the remainder of the year, four-year-old students will be focusing on additional math experiences to prepare for kindergarten.

Survey results show high levels of parent satisfaction with the program.




Check It Out Buffalo Fluffalo by Bess Kalb Grumpy Monkey Spring Fever by Suzanne Lang



When the sun breaks through the storm clouds, the friendly animals find a surprise See Check It Out, page 10





The Contestant Shows a Darker, More Depraved, Real-Life Truman Show

Before The Truman Show became an Oscar-nominated film with undeniable cultural relevance, there was a real-life series that started it all. The year was 1998, and over 15 million people tuned in every week to watch Denpa Shonen: A Life in Prizes. This real-life Japanese

reality TV show pushed the boundaries of physical and mental endurance of its single, unwitting participant. In The Contestant, now streaming on Hulu, the unethical practices that went on during this show are exposed in fascinating detail, as well as the ramifications of being tortured for entertainment.

Tomoaki Hamatsu had a difficult childhood. His family was constantly on the move and schoolyard bullies were extremely unkind, specifically pointing out his physical appearance. They called him Nasubi-which translates to "eggplant"-and poked fun at his oblongshaped head. The name stuck, as soon Tomoaki embraced the name Nasubi, which he still goes by today. Embracing the name was both empowering and comedic, and soon Nasubi realized that comedy was a great deflection to the teasing. He decided to dedicate his life to making people laugh. However, he didn't expect to get recruited to participate in a new reality show that would have people laughing

all right... for all the wrong reasons. Trapped in a tiny apartment, naked and with nothing but stacks of magazines and hundreds

Eagles in the CIF Playoffs

The calendar says it's May, which means it is close to the end of the school year. It's also the time of year that high school sports begin their playoff schedule. Several El Segundo high school teams entered the CIF Southern Section playoffs after completing their successful regular season. The baseball and softball teams, the boys' and girls' lacrosse teams, the boy's golf and tennis teams, the track team, the swim team, and the boys' tennis teams all enjoyed a successful season to advance to the CIF-SS playoffs.

Baseball Team Handles Woodrow Wilson Bruins

The Eagles faced the Woodrow Wilson Bruins in the first round of the CIF-SS Division 3 playoffs at historical Blair Field. The setting didn't intimidate the Eagles, and it showed in their 11-7 win. The Eagles played flawless defense, got timely hitting, and held on for their first playoff win since 2019.

The Eagles spotted the Bruins a two-run second inning on the strength of two walks and a timely single. The Eagles responded with a four-run third inning highlighted by a two-run double off the leftfield wall by Logan Brooks to give his team a 4-2 lead. In the fifth inning, with the Eagles leading 5-2, they padded their score with two more runs. Lincoln Quaintance doubled, Brooks reached on a fielder's choice, and both scored. Austin Holman's ground ball scored Quaintance, and Brooks scored on Ethan Ayler's RBI single.

The Eagles blew the game open in the sixth inning by scoring four runs. Holman had a sacrifice fly ball, Ayler had an RBI double, Kyle Whalen had a run-scoring single, and Ben Lee had an RBI ground ball, extending the lead to 11-2. The Bruins made it close by scoring five runs in the bottom of the seventh





the 2024-25 school year. The state is aware that ESUSD is hoping to start the new school year in the new location. Updates will be provided to families as soon as information is available.

The Learning Connection:

248 students are enrolled at Center Street School, 227 students are enrolled at Richmond Street School, and 70 students are enrolled at El Segundo Middle School.

TLC was able to increase the size of the program due to hiring 12 new staff members this year.

The program continues to grow at the middle school level. Moving forward, TLC would like to help facilitate the transition between elementary and middle school for enrolled students.

Parent survey results showed that 99% of parents are satisfied with the program.

Additional Board Actions:

The board approved proclamations honoring Certificated Staff Appreciation Week (May 6-10) and Classified Employee Appreciation Week (May 19-25). The board thanks teachers and staff for the guidance, support, and inspiration they provide to students each day.

The board approved a new certificated job description for an AI (Artificial Intelligence) Instructional Technology Leader. This position will support district initiatives focused on artificial intelligence (AI), and how these tools can be safely and effectively used by students and staff.

The board approved Board Policy 6143 - Courses of Study, Board Policy 6159.2 -Non-Public Schools/Agencies, and Board Policy 6146.4 - Differential Graduation and Competency Standards. The board also accepted Administrative Regulation 6143 - Courses of Study. These updated policies and regulations are in alignment with updates to the California Education Code.

The board voted to amend the Use of Facilities Fee Schedule. The updated fee schedule adjusts fees to reflect increased costs for instructional technology, food services, and custodial staff. It also streamlines rental costs to be consistent across the district. The updated fee schedule will go into effect on May 1, 2024. •

nightclub use with standards about noise, lines outside the business, dance floor regulations, etc. Baldino noted that Rock' N Brews has a noise standard for noise outside the business and lines queuing around the building.

The plan also includes restricted uses for first-floor offices on Main Street, which Baldino asked, "Is that necessary?" He cited medical businesses (chiropractic, dental, physical therapy) currently occupying Main Street and noted that they enjoy the visibility the location brings. Said Giroux, "I think one of the public comments today was part of the problem is that you have a lot of just office on Main Street. And then at 6 o'clock [they] close down, and there's nothing going on, especially on the northern part. Are we looking to activate that part of town or not? And I think at this point with the way we're growing and the way entertainment and availability is going here, I think we probably want to activate that a little bit more." The trio agreed that a form of office could be allowed on Main Street with an AUP. They then addressed outdoor dining policies and fees, as well as parking. Pimentel noted how during COVID when Richmond Street was closed to through traffic to allow for outdoor dining, parking on Richmond was not allowed, and he'd heard that impacted would cascade parking to other areas, thereby reducing parking for those business's clients. Giroux said he felt that as long as a business's outdoor dining only used the outdoor space directly in front of their business, that a signoff by the neighboring businesses shouldn't be necessary. Pimentel noted he sees parking as a shared resource, and Baldino said that parking is not dedicated to the store it is in front of. "Sure, that's the ideal situation, but it's not guaranteed," said Baldino.

The three council members approved moving forward with the Downtown Specific Plan with the options in the plan left intact "We can always say, 'No' to the (entire) plan in the future," said Baldino, while Pimentel still voiced concern about "strangling retail

businesses by having a sidewalk lined with outdoor dining" and potential parking issues resulting from instituting the outdoor dining plan. Giroux said outdoor dining attracts more people to the downtown area, as witnessed during pandemic restrictions, which he views as increasing the potential of sales for downtown retail businesses near restaurants. The trio also opted to have staff "tinker" with the Downtown Outdoor Dining Guidelines.

The three council members then passed resolutions 3-0 and determined that parking is a policy, not a resolution or ordinance, so it can be brought back for a policy change should the need arise. Pimentel was the lone council member still expressing concerns about parking downtown. •

of postcards, Denpa Shonen: A Life in Prizes is a human experiment that forces the contestant to survive only on the prizes he wins from magazine sweepstakes. This includes food, clothing, and entertainment. To win the game and end the experiment, the prizes must equal more than one million yen.

A Life in Prizes coverage consisted of 24 hours of filming, 7 days a week, with two cameras, and eventually, a round-the-clock live stream was available online. Nasubi, who understandably started to lose his grip on reality from isolation and starvation, was in a constant struggle between sanity and madness. If he didn't win a sweepstake prize that day, he would go to bed hungry. On occasion, producers had to sneak into his room in the middle of the night to give him crackers so he wouldn't die from malnutrition. Audiences were obsessed with Nasubi's journey and cheered him on from the sidelines, but Nasubi had no idea he was gaining any notoriety. In fact, he didn't know he was being broadcast at all. Nasubi became the most famous television personality in Japan without even knowing it.

Through exclusive interviews with Nasubi and people close to the show, The Contestant exposes so many cracks in its foundation. For starters, Nasubi never signed a contract. The show's producer, Toshio Tsuchiya, initially persuaded Nasubi to strip naked by claiming that most of what he did wouldn't be aired. This overt manipulation tactic lowered Nasubi's initial hesitation, therefore making it easier


for Toshio to control Nasubi. When all was said and done, he spent 1 year and 3 months competing in A Life in Prizes.

Nowadays, it's not uncommon to look back on various forms of entertainment of the past and see how poorly it has aged with time. Britney Spears talks about it in her memoir, specifically how cruel the press and industry were to her as she was coming of age in the spotlight. Denpa Shonen: A Life in Prizes is another one of those moments in the cultural zeitgeist that would not exist if it were pitched today, based on the sheer torment and manipulation that Nasubi was put through. The Contestant reveals, in stunning detail, how Nasubi not only survived fame and famine, but everything in between. •

Salmon with Creamy Pesto Sauce

Directions

- Step 1: Season the fish as desired. Heat the oil in a 12-inch skillet over medium-high heat. Add the fish and cook for 3 minutes (try not to turn it sooner- it may stick to the skillet). Turn the fish over. Cook for 2 minutes or until well browned. Remove the fish from the skillet.
- Step 2: Add the tomatoes to the skillet and cook for 3 minutes or until they begin to burst, stirring occasionally. Stir the soup and water in the skillet and heat to a boil. Stir in the pesto and spinach and cook until the spinach is wilted.
- Step 3: Return the fish to the skillet. Reduce the heat to low. Cook for 1 minute or until the fish flakes easily when tested with a fork. Serve the fish and sauce over the rice.

Tips_

Try this grilled foil packet version: Omit the oil and cooked rice. Heat the grill to medium. Mix the soup, water and pesto. Reserve 1/4 cup soup mixture. Stir 3/4 cup uncooked instant white rice into the remaining soup mixture. Place 1/4 cup rice mixture in the center of 4 (12x18-inch) pieces heavy-duty foil. Top with the spinach, salmon, tomatoes and reserved soup mixture. Fold up foil into packets. Grill packets for 15 minutes. Let stand for 1 minute before opening.
