Tasty Topics in the Works for 15th Annual Author Fair

Food, or at least food for thought, will serve as the thematic thread for this year's El Segundo Public Library Author Fair. The 15th annual installment of the popular local event is set for Sunday, June 7 and will feature more than 40 authors representing a wide variety of genres. The festivities will also include book signings and sales, poetry readings, special children's programs, goodie bags, refreshments, live music, balloon sculptures and raffle prizes.

A Non-Fiction Author Panel will take place from 12:30 to 1:30 in the Friends of the Library Room with the theme "Dishing it Up: Foods to Satisfy Every Palate." Panelists will include noted food authors Linda Civitello, Jennie Cook, Richard Foss, Martha Rose Shulman and Clifford A. Wright. A moderator had yet to be announced as of press time. Then from 2:30 to 3:30 at the same location, Library Board member Kevin Smith (not the Fire Chief) will moderate "Genre Pairings: Tastes of Fiction and Non-Fiction." Panelists will include Rachel Howzell Hall (noir), Jillian Lauren (memoir), Isabel Quintero (young adult), David Rensin (biography) and Desiree Zamorano (noir/mystery)

Rensin's appearance represents a major coup for the event, according to Senior Librarian Julie Todd. "David is the co-author and friend of Louis Zamperini [the famed Olympian and World War II survivor who grew up in Torrance and was the subject of the Oscar-nominated film Unbroken released in November 2014 only a few months after his death]," she said. "David and Louis were friends for about 16 years and had worked together on Zamperini's biographies, including

Don't Give Up, Don't Give In: Lessons from an Extraordinary Life that came out last year, and Devil at My Heels from 2003." Rensin's extensive resume also includes collaborations with show business legend Bernie Brillstein, New Age musician Yanni, and several notable comics—Tim Allen, Jeff Foxworthy, Chris Rock and Garry Shandling. He has also been a contributing editor of Playboy since 1981 and written extensively for other nationally renowned magazines.

School Board Reveals New Richmond Street Principal

The Tuesday night meeting of the El Segundo Unified School District School Board featured a special presentation made by High School Assistant Principal Ali Rabiei recognizing a standout achievement by Business Pathway students in a recent debate competition.

But prior to the special presentations, Board President Jeanie Nishime announced that, in the just completed closed session, the Board had approved the recommendation of Superintendent Melissa Moore and ratified the appointment of Middle School Assistant Principal Alice Lee to become the new Principal at Richmond Street Elementary for the 2015-16 school year.

Completing her third year at the Middle School, Lee will take over for interim Principal Rebecca Jane Godbey, who had been filling the post since the requested leave and then resignation in February, for personal reasons, of Elizabeth Ramirez.

In a statement released prior to the open meeting, Moore noted that opening at Richmond Street had "attracted a large and highly competitive pool of applicants." She said that "in the end, Dr. Alice Lee

ESHS Receives Six Year Accreditation

The Western Association of Schools and Colleges (WASC) Visiting Team concluded their El Segundo High School accreditation visit on March 11th with a report to all stakeholders in the El Segundo High School library. The report was a summary of the group's findings after three and a half days of classroom visits, meetings and discussions with all ESHS stakeholders.

The library was packed with the entire faculty and staff, district personnel, members of the

committee is not authorized to reveal what their recommendation is to the commission. Their report and recommendation is read by the Commission and the Commission validates it by approving the recommendation. The ESHS stakeholders felt that the report was fair and accurately described every aspect of our school. Overall, they were very comfortable with the report.

On Friday, May 1st, ESUSD Superintendent Dr. Moore and ESHS Principal Jaime Mancilla each received an email from the WASC Accreditation Commission granting El Segundo

Board of Trustees as well as parents and students. All present had participated in some way or another in the school's year and a half long mandatory self-study that preceded this visit. Each member of the six-person visiting team presented a portion of the report and at the end of each segment the member shared his or her thoughts on the school's strengths and areas of focus. Some of the strengths mentioned were the overwhelming community support, a prominent school culture that embraces a Cycle of Improvement and the open access for all students to participate in rigorous classes. They noted that the areas we should focus on were deepening and strengthening critical thinking, reading and writing; improving college and career readiness; and continuing to align assessment and curriculum, assessments and instruction to Common Core and Next Generation Science Standards. These next steps received the full support of all stakeholders at ESHS. The team concluded their report and thanked the El Segundo community for its incredible hospitality. They also commented on the fact that the packed library epitomized everything they felt about their experience during their visit. This accreditation process truly reflected a community effort.

The visiting team left with their report and the recommendations that they would make to the WASC Accrediting Commission. As part of the process, the WASC visiting

High School a full six year accreditation with a one-day mid-term visit. This is the best term or outcome a school can receive and is a validation of all that is going well at El Segundo High School. Upon hearing the news, El Segundo High School Self-Study Coordinator, Mark Doering, stated "I'm very proud of all of the work that everyone has put in over the last year and a half. Film Review

Reality is Another Wonderfully Bizarre Outing From Quentin Dupieux

By now, fans of the eccentrically French filmmaker Quentin Dupieux should know that his highly original films are made for the cinematically adventurous type – those of whom feel comfortable knowing that for all of the elaborate tangents and philosophically-staged ponderings, his films might not make a lick of sense.

However, in Dupieux's refined Dadaist style, this happens to be for the very best, as his newest feature film *Reality* (*Réalité*)

to gut his claim. Much to his young daughter Reality's (Kyla Kenedy) amazement, a blue VHS tape fall out of the innards, but when pressing the witnessed impossibility, her father dismisses the notion of a video tape being able to get into the belly of such a woods creature – because *that* would be crazy. This is the sort of confounding anti-logic that both Dupieux and the film thrive on.

Meanwhile, in real time, filmmaker Zog (John Glover), sits on the edge of his seat at a remote screening room, where he watches

once again falls in line with his other realitybending comic send-ups (2010's *Rubber*, 2013's *Wrong Cops*) which makes for another wonderfully bizarre and absurd outing that continues to raise artfully interesting questions while confronting the very medium itself.

With his third feature film, Dupieux (AKA electronic music-maker "Mr. Oizo") has found a story about showbiz that he finally seems ready to tell. Gone is his freshman debut with the killer car-tire gag in *Rubber*, as well as his sophomore shenanigan-laden midnight movie *Wrong Cops*; in *Reality*, the story of a film director who discovers that his passion project film has already been made – and by his alternate-reality self. There are a million more moving pieces that propel the flat-out ridiculousness in this movie.

Reality certainly falls in line with what fans of Dupieux's should expect, but for those new to the director, it should be said that you might have to take a real leap outside of the comfort zone on this one.

The movie opens in a wordless sequence where a backwoods rifleman takes out a tranquil deer, brings it home, and proceeds that very scene of Reality and the videotape and the deer, seeing her stare back into the camera itself. It's a circus act of selfreferences and meta-dwellings that makes for a silly, fun watch.

Aside from this and many other head scratching rabbit holes, Reality mainly centers around a public-access channel camera operator by day, budding artistic filmmaker by later-that-day Jason (Alain Chabat), who sets out to find the ultra-specific and correct "dying human shriek" sound effect that he needs to make his new film about a killer microwave (no doubt a sly wink to Rubber). With appearances by Reality's cross-dressing principal, Henri (Eric Warheim), and publicaccess show host in-an-itchy-rat-costume, Denis (Jon Heder), the film circles around to these seemingly non-connected stories, but finds a common (if long-shot) thread to pull the entire story together in its final act.

So, where does a film like this, one built on the honest intention of being purely meaningless and non-logical, stand among his other films, and movies in general? Where



NRA Playoffs Fagles Complete One

NBA Playoffs Take Center Stage

After last Saturday afternoon's game between the Atlanta Hawks and the Washington Wizards at the Verizon Center in Washington, it became clear that the NBA playoffs have officially caught fire and continue to capture the attention of America. Even if you're not particularly into the game of basketball, you simply can't deny the drama and the intrigue of the second round of these playoffs. That is, if you've been among the fortunate enough to watch. Last week's buzzer-beater by the Bulls' Derek Rose combined with old faithful himself, Paul Pierce's game winner, both showed us all why these playoffs are so good. Maybe the first round fell flat as sort of a dud, but it looks as if the latter stages of this year's tournament are sure to tickle even the most blasé basketball-onlooker's fancy.

If you've been following basketball at all this postseason, then you've noticed that it was pretty obvious that the first round of the playoffs were a yawn fest. Almost every team that was expected to win won, and did so handily. The Golden State Warriors swept the New Orleans Pelicans in four games, Memphis and Houston almost swept Portland and Dallas, respectively (each team only gave away one game), Washington and Cleveland swept Toronto and Boston, and Atlanta and Chicago made quick work of Brooklyn and Milwaukee. Too much sweeping going on for my taste. The only thing not sullied and deserved of a good sweeping in the first round was the series featuring the Los Angeles Clippers and the San Antonio Spurs. That may go down in history as one of the best NBA playoff series ever. The Clippers eventually won in the seventh and final game, sending the defending champion Spurs into an offseason full of wonder and speculation that their dynastic team may at last be headed for a breakup.

The second round, though now almost completely over, began in a way that was distinctly different from the first. As if taking the lead of the Spurs and Clippers in round one, each of the four series was clearly headed for our own enjoyment and satisfaction from the very start. Each team that started off round two on the road won a game to immediately steal home court advantage from their opposition. While that in itself didn't tell us who was going to win the series, it did tell us that each one was going to be long, drawn out and intense in nature. Even when the first two games of each matchup were played, it strangely felt as if the series' were yet to begin. Every team, at one point, was tied at 1-1, and after a long and grueling 82 game regular season and first round of the playoffs, every team was dealing with their own set of issues.

You always know you're in for some good playoff basketball when the team that has home court advantage goes down early in the series. In round two, every team that had home court advantage trailed 2-1 after three games in the series. That includes the Cavaliers and LeBron James. What's interesting about James and his team's series against the Chicago Bulls is that James and company were forced to play with a distinct disadvantage from the get-go. In Kevin Love's very first playoff appearance ever against the Boston Celtics in round one, he dislocated his shoulder and is now out until next year. J.R. Smith punched a guy in the face and was suspended for the first two games, Iman Shumpert pulled his groin muscle and talk arose that Kyrie Irving's foot was less than 100 percent. Advantage Bulls, with a healthy and suddenly explosive Derek Rose; that was, until Pau Gasol went down with an injured hamstring. These two teams seemingly always have a way of evening each other out; but hey, at least that makes for good television. So did Rose's last second shot from beyond the arc that helped his team take an early 2-1 advantage over LeBron. In the next game, LeBron evened things once again with his own buzzer-beating game-winner.

Then there are the Houston Rockets vs. the Los Angeles Clippers and the Atlanta Hawks vs. the Washington Wizards. In both series, the team with home court is seemingly expected to lose. Through three games, the series played out that way. Both L.A. and Washington held 2-1 series lead. While the Clippers did so basically without Chris Paul, the Wizards used an old, ex-Boston Celtic to get the job done. After his game winning bank shot, Pierce proclaimed that he didn't call the bank shot. "I called, 'Game!" he declared. The old man's still got it. After nailing a game winning three-pointer against the Raptors in round one, Pierce exclaimed, "That's why I'm here." He showed again against the Hawks that indeed, it is. As for the Clippers, it looks as if their tough matchup of the playoffs was in the first round. They could have beaten the Rockets even if they had to do it without Chris Paul. Perhaps they deserved an easy second round matchup after opening against the Spurs, but now Los Angeles is headed for the Western Conference Finals for the first time even in the team's existence.

Then there are the Golden State Warriors.

The team that won 67 games in the regular season has the league MVP in Steph Curry

proved that she was the best selection to lead Richmond Street as a Principal. I am confident in Dr. Lee's leadership to serve the students and families. Three strengths Dr. Lee possesses include: she has grit, an internal strength to overcome obstacles, is compassionate, and is a relationship builder. Recent District hire, Guadalupe Grijalva, Director of the Preschool, then took to the presentation podium to make the State of the School address for the Eagles' Nest Preschool. Prior to the meeting, Grijalva emailed that "these last three months have been wonderful because Eagles' Nest is a great preschool, parents who are invested in their children's learning, and a school district that supports our program and our future students.'

Superintendent Melissa Moore then highlighted upcoming events on the District's calendar as the 2014-2015 school-year winds

- **4.** Add the remaining products and cook for 10 minutes on medium heat stirring occasionally. Season and enjoy. •











New audiences might find themselves unprepared for this offbeat brand of subversively alt-anarchic movie mayhem, but those with patience to try out a new midnight-movie with flair should find themselves oddly entertained. •


