New Mayor Chris Pimentel Sees Great Things Ahead for El Segundo

Seven years into his tenure on the City Council and now El Segundo's Mayor since December, Chris Pimentel is more enthusiastic than ever about the community's prospects. "It's such an exciting time to be in El Segundo," he said. "The world is at the cusp of significant technological advances, and they are starting all around us on Franklin Avenue and beyond. People come here from all over the world to be among our no-frills, can-do spirit of invention."

Born next to the B-52 taxiway at Castle Air Force Base outside of Merced, California, Pimentel credited his parents for their positive influence in shaping him and for being real characters. "I have an impossibly wise, humble, and otherworldly decent father, Colonel Antonio Pimentel, and the world's most loquacious, inquisitive, and generous mother, Jill," he said. "They are a hilarious pair of Portuguese-American and north woodsy Maine pragmatism. As a tidbit, my father and Councilmember Lance Giroux's parents went to the same high school."

Meanwhile, Pimentel went to high school in Wichita, known as the world's Air Capital. Though very different from the beach cities, there were similarities with an airport and Boeing buildings part of the local landscape in faraway Kansas. "When we were planning to move to the South Bay, my mother-in-law, who is from Iowa, told us that I would love El Segundo, and here we are," he said.

Before that move, Pimentel attended the University of Virginia on a Marine scholarship. There, he met his future and, he added, his "brilliant" wife, Laura, whom he said "does more good for more people in a typical day the anyone" he has ever met. The two have three children, and he gushed about their attributes. "Dash, a sophomore, has an encyclopedic knowledge of sports and innate kindness that

I marvel at every day," Pimentel said. "Mazzy, in eighth grade, has the dazzling ability to be good at most everything and is terrified people will find out how smart she is. And Iris, in sixth grade, might have the best sense of humor and quickest mind of all of us." Pimentel also gave a shout-out to his sister, who is a teacher in San Jose, and an older brother, of whom he jokingly (or maybe not) reported, "He makes a living torturing me."

A risk management executive and former Marine Corps Infantry officer, Pimentel won his first Council seat in 2018 and then earned a second term in 2022. Looking at his and his colleagues' achievements over that period, he pointed immediately to a little-understood but vital issue—the pension debt that threatened to derail the city's financial stability. "Most people's eyes glaze over when you discuss unfunded pension liability, but the City was in dire straits," he said. "By 2028 we would spend nearly 40 percent of every dollar just paying retirees if we hadn't built a plan and been disciplined enough the execute it. Our buildings would have been threadbare, our parks decaying, and our services shrinking. By leasing The Lakes driving range, putting in a policy for that revenue, preparing and timing a bond issue, and working with our labor groups, we balanced the books. It was a great escape and a massive near-miss. The city staff, led at the time by [Finance Director] Joe Lillie and [City Manager] Scott Mitnick, were ready with the process. [City Attorney] Mark Hensley was tremendous on The Lakes, and the Council stuck together to push through the reforms. I know it's dreadfully dull, but it was so important. It saved the city \$96 million in direct cash—a full year of our general fund budget-and the proverbial Dark Ages if we hadn't done it."

Dealing with long-term pension liability is one example of a collaborative effort between

the Council, department heads, and staff to tackle major issues. While never a simple process, Pimentel enjoys the deliberation and even, at times, heated discussion that leads to the end result. "We disagree on most things, but do it politely and respectfully," he admitted. "Critically, we all have different professional experiences../so our decisions benefit from varying expertise—be it land use, development, international trade, or entrepreneurship."

Despite his optimism about the city's future, Pimentel identified several key challenges that he and the Council must continue to monitor to preserve El Segundo's singular uniqueness and quality of life. "It involves a lot of listening and a lot of thinking through effects 5, 10, 20 years into the future," he explained." Along the same vein, our housing, and its cost, is a more tangible and difficult problem. Our population is slightly above where it was in 1970, after plummeting in the late '70s...but our people live in smaller families, so there is demand for more residences. And because our housing values have risen far more quickly than wages, we are pricing out the next generation. For all of our new exciting businesses, virtually none

Bob Motta Honored as El Segundo's Older American of the Year

The City of El Segundo has been recognizing our 'Older American of the Year' for over thirty years. Past recipients include Val Smith, Betty Jacobson, Sharon Hladek, and Nancy Jacobson. May is Older Americans Month, a perfect opportunity to show our appreciation for the older adults in our community. Older Americans Month 2025 theme is: "Flip the Script on Aging," which focuses on transforming how society perceives, talks about, and approaches aging. The Elderfest event will recognize the Older American of the Year, which will be on Saturday, May 17, from 11 am - 1 pm at the Joslyn Center. This year's recipient is Bob Motta for his contributions to the community and all of our Older Adults and their achievements.

So, how is the recipient selected? Ryan Delgado, who oversees the Joslyn Center, said, "We have a nominee form that is available at the Joslyn Center. Nominations come in along with information about the nominee. A group selects the person based on the nomination forms. All names are removed, so we do not know who we are reading about when selecting."

Bob Motta has served on the Recreation Commission for over twenty years. He has been a vital part of giving his input and helping to shape programs, events, and policies for the Recreation and Parks Department. How did Bob start on the Recreation and Parks Commission? His good friend John Gaines, who was on the City Council in 2004, persuaded him to apply for the Recreation and Parks Commission opening. He says he didn't plan on being on the commission this long but had his family's continued support. He says he wanted to continue using his vision to help make El Segundo better.

Besides volunteering on the Commission, Bob has served as the Babe Ruth League President for many years. He was in charge of guiding the program to a World Series victory and many strong runs in the All-Star Tournaments. According to Ryan Delgado, who played for Bob, "He was my coach during my 15-year-old season; we lost to Hawaii in the Pacific Southwest Regional Tournament final. He created a fun atmosphere where learning the game, playing hard, and working together was valued."

Bob is newly elected to the Babe Ruth League, Inc. International Board of Directors as Pacific Southwest Regional Commissioner. He began his journey with the Babe Ruth League program in 1979 as a Prep League coach for the El Segundo Babe Ruth League. Bob continued volunteering at the local league level for many years, serving as a coach, league Board Member, and President of the El Segundo Babe Ruth League. In addition, Bob served as Southern California District 2 Commissioner until being elected State Commissioner in 2017, a position he held until his recent election as Pacific Southwest Regional Commissioner.

Bob has been a staple in our community for his entire life. He graduated from El Segundo High School, became an Eagle Scout in Troop 267, and owned a successful business. He became a youth baseball coach by happenstance for over forty years. But what he's most proud of is meeting his future love of his life, Kathy Cason, in high school. They eventually married and had two children, Ray and Rebecca.

Over his decades of serving on the Recreation Commission, Bob has been an important part of many changes benefitting our community. His contributions include overseeing projects such as Campus El Segundo, the City of El Segundo Wiseburn Unified School District Aquatics Center, the renovation of Urho Saari Swim Stadium "The Plunge," the Renovation of the Teen Center and Plaza, the renovation of the Skate Park, and the athletic field/Facility

Use and Allocation Policy.

Bob didn't play baseball in high school or Babe Ruth baseball because of his dedication towards becoming an Eagle Scout. Though he didn't play, he was enamored with the sport and made it a passion to help mentor young athletes. He says it was fate that got him into coaching and where it led him for most of his life. "My brother Mark came to me in 1979 and told me he tried out for Babe Ruth but did not get drafted. They would start a prep league if they found a few coaches." That would be the start of a forty-six-year involvement in youth baseball, and he's not through yet.

After Bob's son was born, his son Ray showed interest in sports and excelled in baseball. So Bob coached Ray's Little League teams. When Ray tried out for Babe Ruth when he was 13, he was drafted to the Stars. They needed a coach, so Bob joined the coaching staff. Bob says, "When Ray was 16, he and I continued coaching the Stars until 2017." Bob was fortunate to manage or coach many All-Star teams and was lucky enough to be on the coaching staff of two World Series Championship teams in 2002 and 2013 and second place in 2004. He says his most memorable all-star team was in 2013 when his son Ray was also on the coaching staff. Bob says that it was a special moment to celebrate a World Championship with his son on the field.

Over the next 46 years of being associated with youth baseball, he has impacted literally thousands of young athletes. So, what was his goal? "I loved coaching, and it turned into wanting to make the program flourish and be one of the premier baseball programs around. Another goal was to get the players ready for the high school program. I wanted the players and their families to enjoy the experience and memories."

Of all the awards he has earned over the years, he says winning the Lefty Gomez Award stands at or near the top of his favorites.

Established in 1991, the Lefty Gomez Volunteer of the Year award is presented annually by Babe Ruth League International. Its recipient must exhibit Lefty's commitment to youth baseball and embody the spirit of the Babe Ruth League philosophy, which is to provide the best possible sports experience for every child who has the desire to play.

Bob's involvement with the El Segundo Babe Ruth League has been unmatched for longevity and arguably his success as a coach and the league's president. During his last 30 years with the league, Bob was responsible for coordinating All-Star tournaments, including hosting twelve District Tournaments, seven State Tournaments, and five Pacific Southwest Regional Tournaments. He says the success of putting on tournaments wasn't what he did but rather what all of the volunteers did to make it a success.

There are so many people to be thankful for, but he wouldn't be where he is today without the support of his wife, Kathy, and his kids, Ray and Rebecca. "Kathy knew, or at least I believe she knew, what she was getting into by being my best friend and the love of my life for all these years. My family has made it possible for me to continue volunteering and enjoying my passion for giving back to youth baseball and the City of El Segundo."

As to being named El Segundo's Older American of the Year Award, Bob said he was totally surprised, tremendously honored, and humbled. He says that the theme for Older Americans Month is "Flip the Switch on Aging," which he relates to. He says, "Staying engaged by volunteering, offering time and ideas has helped me "Flip the Switch on Aging." He concluded by saying, "Change is okay, but embrace the past!"

Well said, Bob. On behalf of the thousands of people you have impacted, thank you, thank you...., and thank you for your selfless dedication to the City of El Segundo. •

of them can live here, and that's a problem. If we do not have starter residences, we will age rapidly, and the businesses supporting our tax base will leave. An El Segundo with a tiny Eagle's Nest and a gargantuan ninth grade because parents cannot afford a home until they're older, and a tax base reliant on businesses with too much equipment to relocate, is not a healthy city."

Ongoing efforts to mitigate the impacts of the Hyperion plant remain a top priority for Pimentel. While the eastern side of town sends its waste to LA County and El Segundo maintains a leadership role in the system, the city has no say on the residential side where treatment is under the City of Los Angeles's jurisdiction. Pimentel pulled no punches in his assessment of the situation. "Hyperion is a case study in poorly run public amenities," he indicated. "Sometimes I wonder if this is what was was like to live in East Germany. They spend fortunes on equipment that they seem unable to run. They have extremely high staff turnover. They overcharge us, then issue credits in the future, and then repeat the problem over and over and over. It's particularly galling because, with the County system, we see the opposite: it's vastly less expensive, has almost zero turnovers, and responds to issues immediately."

Along similar lines, Pimentel hopes the State of California rethinks its approach to governance so that legislation does not adversely impact the city at the level it does currently. "They pass thousands of bills every year, which is an enormous burden on us to adapt to," he said. "Further still, they continually try to micromanage an incredibly large state with fabulously diffuse city cultures. Having someone who has never been to El Segundo presume to tell us how to build and manage our city is maddening. Central planning fails because information is imperfect, poorly defined, and untimely—but that lesson of history seems to elude the state government."

While the city continues navigating the frustrations of complying with outside agencies, Pimentel emphasized that those obstacles cannot detract from the community's inherent strengths. "There are a lot of things in a city that are easier to perceive than they are to measure – and one is happiness," he said. "When the schools and parks are full, when people are packing events and new neighbors are moving in, it's a testament to the people in El Segundo every day and the staff that supports them. Our Public Works team is incredibly responsive. When it's raining, they are fixing our potholes and, without asking, fixing things for our neighbors. Our Planning department is miles ahead of the cities in our county on efficiency and turnaround time. From Finance to HR, when people have questions, they really do all that they can to explain and correct issues. And this energy sits aside the more publicfacing directors, Parks staff, and California's best Police and Fire personnel. The effort of an accessible, energetic, and conscientious city is hard to count but easy to feel—and they are a team we all can be proud of."

While never an easy task to predict the future, Pimentel lauded El Segundo's resilience in coming through the pandemic era stronger than ever and poised to accomplish even greater things in the future. "I know it's easy to gush over your own city, but this summer, we'll have even more exciting things to share, as companies that want to be in the US bring their ideas and employees to 'The Most Important 5 Square Miles Economically in Southern California," he said.

When all is said and done, Pimentel pointed out that El Segundo has a distinct advantage that allows it to thrive. "I love how El Segundo is unabashedly proud of its uniqueness," he said." We prioritize events that get the whole city together, allowing us to know each other as individuals apart from our jobs, hobbies, politics, etc. The word 'community' is often overused in modern parlance, but El Segundo's sense of it—and the cultural values that we exhibit all the time: generosity, volunteerism, responsibility—really ring true and define us...'






