

Retail, Dining May Move Outside

Merchants and restaurants bursting at the seams to reopen after a 65-day shutdown received a promise Tuesday night that El Segundo is willing to relax longstanding rules against conducting business outdoors. As proof that no suggestion is off the table, city officials said they could close downtown streets to allow open-air dining if that's what restaurants need to stay in business and meet strict new occupancy limits.

The City Council is open to suggestions from owners of shops, salons and eateries, who have been confined inside four walls in the past. The extraordinary circumstances created by the coronavirus pandemic convinced El Segundo officials to go outside the norm and allow sidewalk signs and browsing, parking-lot sales and even outdoor dining in public right-of-ways, including Main Street and parking lots. The messages that came through Tuesday were that businesses could expect new freedoms to operate as they see fit to rebound from widespread closures. And, while the city can block downtown streets for restaurants and bar seating, the business recovery plan is all about removing the barriers once the order comes that it's safe to go out in public again. Each council member and the city manager gave full-throated promises on Tuesday night that the business community can expect flexibility and support when the lockdown order is lifted. That could come as early as July 4, though El Segundo will lobby county and state officials to allow South Bay cities some latitude for an early start date. El Segundo currently has three positive COVID-19 cases and could reach zero by June 1.

to limit indoor occupancy by 75 percent when table service is allowed again. Salons and retail stores will also be forced to limit the number of customers who can be inside at one time. The social-distancing rules for businesses will be part of the Phase 3 reopening, as new cases of COVID-19 and hospitalizations steadily decline and don't return to the alarming levels the county saw starting in early March. It now appears Phase 3 and dine-in restaurant service could return by July 4, and an Independence Day reopening could come with new freedoms.

Restaurants, which run on tight profit margins, will be hard pressed to survive the current pandemic, Councilman Scott Nicol said Tuesday. He, along with the rest of the

council members, favored a plan to close streets, alleyways and parking lots so food establishments and service businesses can expand outdoors where more people can shop and congregate safely. A business won't look the same when the all-clear order comes down from Los Angeles County to reopen.

Councilman Lance Giroux said, "we are not sitting idly by" waiting for the county. "We are coming up with as many contingencies and options as we can to help businesses," he said Tuesday. When the governor's requirements for shifting into Phase 3 have been met, El Segundo wants the pump primed and all businesses throughout the city ready to turn the key and reopen the next day.

Dear Neighborhood Therapist,

My son is "graduating" from high school this year and I'm still not sure what his college is going to do. He seems to be taking it in stride, but I fear he is missing out on one of the best times in life, and it makes me very sad. We've tried celebrating in other ways, but it's not the same. Is there any bright side to this?

– Disappointed, El Segundo

Dear Disappointed,

I'm not one of those people who believe that everything happens for a reason, that there is always a silver lining, or that thinking positively will get you through anything. You're talking about a sweet spot that only comes around once in a lifetime. For many, the last few weeks of school are a golden age when plans are discussed with a sense of optimism that a bright future lies ahead. The cap and gown, the proud walk across the stage, the joyful gathering with loved ones. It's a ritual that marks the transition from childhood to something more (I'm not going to say "adulthood" because I'm not sure any of us ever actually get there. Take note, kids.).

What if this is a freedom from expectations that was unavailable to previous generations? What if instead of getting a quizzical look when you say you're rethinking everything, people say, "Yeah, I get it"?

If you don't buy this view, don't try to sell it to your son. But if you think that maybe he might benefit from an opportunity to set aside certain expectations in exchange for increased freedom, then maybe that's worth a conversation.

The underside of great uncertainty is great possibility. I wouldn't call that a bright side or a silver lining. But it ain't nothin'.





So, he and friend Andrew Doan, who were, said Lauren, attending a bachelor party at the time, powwowed. Sure, why not, what else would you do at a bachelor party other than to brainstorm ideas about seamlessly securing baby bottles?

Doan, works in the tech industry, in Northern California with wife Nicole and children, said teaming with the Stuarts to develop the bokee has been a process he relishes, citing a "fantastic collaboration. My relationship with the Stuart's has been an incredible journey of playing-up our strengths," he said. "My family's technical depth married with the Stuart's brand and storytelling."

Doan's second child was born on the same August day that the Stuart twins arrived, and he was going through many of the same child-rearing tribulations as Stuart was. Doan's background is in engineering and the unique charms of El Segundo. Asked what brought them to settle in El Segundo, Brandon said that, other than the family connection, he had lived in different locales in the Los Angeles area, and that "this is the only place that feels like a community, and is a great place to raise a family."

Brandon, who is from Santa Clarita, currently works as an executive creative director for a San Diego company, mostly telecommuting from home or working at the local Uinta office-sharing building. He has also had stints working for DreamWorks and E! Entertainment.

A couple of his other brainstorms have recently become a reality. He has launched two ventures, including a tech reservation platform that is relevant now with the advent of necessary social-distancing, and a dog-food subscription service.



Elodie, Lauren, Brandon and Owen Stuart

was a childhood friend of Stuart's youngest brother Brady, who lives in El Segundo and works as an assistant equipment manager for the Los Angeles Lakers.

The two fathers pooled their collective entrepreneurial thoughts, and the bokee prototype was developed, with Lauren being chief prototype tester.

Here is how the product works: First, push the bokee down on a smooth and dry countertop. It then suctions to the tabletop surface. Then, you place the bottle or sippy cup into the bokee, and apply gentle pressure as you loosen or tighten the bottle as needed. A substantial upgrade tool in the way youngsters have been fed since the first baby bottle was invented in 1841. And if you do not happen to have children who necessitate bottle-feeding or sippy cups, Lauren said the bokee makes a perfect beer can or beer bottle holder. So, there is that option. The bokee hit the market in late September of 2019 and was recently recognized by the Junior Products Membership Association (JPMA), which touts innovative baby and children's products, as the 2020 "best product under \$25." Brandon said he was overwhelmed by the JPMA selection, saying that it was "one of the top-three moments for us, because we are such a small team." He said the co-founders "raised a celebratory glass," though it has not been discerned if they secured the glass in a bokee prior to the start of the celebration. The Stuart's have lived in El Segundo for eight years. Brandon's sister Taryn has been a resident of Candy Cane Lane for more than a decade, which is how he came to know Lauren, a University of Texas graduate, moved to the Los Angeles area near her brother, who had suffered the loss of his best friend who had suddenly died. Brandon and Lauren were married in 2012.

Lauren wears many hats in the business as the brand gets established in the marketplace. She works on brand partnerships, manages social media engagement sites, handles advertising, customer service, and even ships the product out to customers.

She said that while she "always wanted to be a stay-at-home Mom," returning to the workforce has been "refreshing," allowing her to utilize her sales and marketing skills without leaving the house. Working on the product launch, "reminded me that I was smart," she said. "I am so thankful," she said, noting how she can utilize her entrepreneurial skills while being constantly present for her children during their formative years. The Stuarts have invested their own money in the product and may look down the road at expanding the potential uses of the bokee. Lauren said that she had been contacted by people in the occupational therapy field who see applications for the bokee for stroke victims, people with arthritis, and those living with impacted motor functions. She said that the first production run of the product contained some flaws which did not allow them to go straight to the marketplace, so the Stuart's donated more than 500 units to the Amputee Coalition.



good at that. I've also looked into physical therapy as a backup."

Jonny has had many influential people in his life. He says his father, brother, his cross country coach and two cousins Brandon and Bryce have all had a part in who he has become and what his future is shaping up to be.

His father, Todd, was in Boy Scouts as a boy growing up and made it to the rank of Life Scout. Only a family tragedy prevented him from becoming an Eagle Scout. Todd says it was important for him to see that his sons reach the pinnacle of Scouting. Jonny says some of his best memories were Scout camping trips with his father. His Eagle Project was building a large shed for the Friends of the LAX dunes which restore the areas between the airport and the beach. Jonny's project taught him how to lead a group of people, organization and planning.

He says his cousin Brandon, a former Air Force Thunderbird pilot, was someone he looked up to. At family gatherings Brandon would encourage him to be the best he could be in whatever he decided. His cousin Bryce, who is a few years older than Jonny, is also interested in going into the medical field. a run each week and Jonny impressed his teacher so much he related his thoughts to the cross country and track coach Marcos Bolanos. Coach Bolanos talked to Jonny and the rest is history.

Jonny started his cross country as a junior. "Cross country changed my life a ton since I joined. I think the biggest lesson I learned was how to set and work towards long term goals as well as dealing with failure." At the start of each season, for track and cross country, the whole team would do goal setting. For cross country Jonny's goals were less time-focused and more aimed at becoming a better runner in general. On the other hand his track goals were much more defined.

In his first season running cross country as a junior Jonny was named the team's Most Valuable Runner. He says it wasn't something he envisioned but something he takes pride in since it was an award voted on. As a senior he was one of the team's top seven runners. Of the five varsity races he competed in he bettered his time in four of those races. He helped the Eagles advance to the California CIF State Cross Country Championships.

At the cross country awards banquet Coach Bolanos awarded Jonny the Coach's Award. It is in recognition of the runner who has improved the most, the hardest working runner and displays the most positive attitude on the team.

When Jonny decided to run track he focused on the distance events. He would set a time to aim for in his 1600 and 3200 meter races. About halfway through his sophomore year he ran a 5:39 1600 meter race with a goal of 5:30. As a junior at the end of the cross country season he ran a 5:12 during a time trial so of he set a goal of breaking 5 minutes. During his junior year he ran a time of 5:02. "I was just short of my goal but on the bright side, in one of my favorite races, I hit my 3200 goal with a time of 10:58."

As a senior Jonny was looking to accomplish his goals he'd set for himself. To add to his motivation Coach Bolanos announced it would be his last year teaching. This was the day before the Palos Verdes dual meet in which he was running the 1600. "I took my dad's advice and didn't start out too fast." In his previous races Jonny's first lap was always 10 seconds faster than his target pace was. "I would end up having a really slow mid-race, which would mess up my time."

Going into the second lap he was in dead last but was exactly on pace to go 5:00. He did that exact same thing for two more laps. He passed two big groups of runners who had slowed down from their first lap pace and Jonny came into the last lap feeling great. "I went all out and came in with the timer showing 4:55. This was by far my most triumphant moment."In the final meet of the season, before the Corona Virus shutdown all sports, Jonny bettered his 3200 meter goal by 23 seconds.

Jonny says he accomplished his goals he set out to do before it ended. He says running cross country and track for Coach Bolanos changed his life by making him more confident. "Knowing that I've made it through a ton of insanely hard workouts and races will serve as a reminder of what I'm capable of."

With graduation on the horizon he'll miss having a team to run with. He says, "It's much easier to improve when other people are holding you accountable." He's challenging himself these days by training for his first marathon. If all goes to plan, Jonny will accomplish another one of his goals when he crosses the finish line. •

Councilwoman Carol Pirsztuk said, "we want it to happen right away," echoing the united response by all council members.

Residents and the 60,000-plus people who work, dine and shop in the city during business hours can expect to see more outdoor tables for eating, clothing racks on sidewalks, parking-lot sales, and even commerce out the back doors and in alleyways. City Manager Mitnick can't promise every business request for a variance will receive a yes. Still, he promised Tuesday that City Hall staff would make as many concessions as possible to remove the already tall climb ahead for El Segundo's business recovery. "We're going to creative, innovative and flexible," Mitnick pledged as the council agreed to set aside longstanding rules against blocking pedestrian right-of-ways along Main Street with cafe tables, chairs, signboards and exterior displays. "We'll see what we can do to make it happen for each owner," he said, indicating that the variances and exceptions will be made on a case-by-case basis. The city promises to be lenient about special-use requests, fee and permit waivers, directional signs to sales and events, and putting out the welcome mat for ideas about bringing back the local economy.

way, the city won't dip into cash reserves, which may be needed for next year's budget.

The finance department's original plan was to delay the park construction for another year. Councilman Giroux pushed back on deferring all capital improvements, saying that construction costs are lower because of closure order lifted before the Memorial Day long weekend.

• Police Chief Bill Whelan said the El Segundo beach patrol would be on duty starting this weekend. No incidents or violations of the county's social-distancing order for active users of the beach and water were reported on

Open-air dining on the street won't be without wine and alcohol service either. The have remained open and non-essential activities that had to shut down since mid-March. El Segundo considers every enterprise important and essential to its future well-being. "The city's ability to survive right now is directly linked to the private sector's ability to survive," the city manager said, briefly touching on the tough budget, staffing, and service decisions that lie ahead for city leaders. Nearly \$14 million in business-related revenue the city had expected to collect in the second quarter of 2020 dried up because of the countywide shutdown orders. El Segundo was forced to revise its budget and freeze hiring to close the gap.

As a cost-saving measure, the city will defer planned capital improvement projects except for the Acacia Park remodel. The new neighborhood playground is expected to cost \$800,000 to finish and should be completed by December. The council gave Acacia Park the green light after City Finance Director Joe Lillio reassured members that \$300,000 could be transferred from the city's equipmentreplacement fund to pay for construction. This

the economic slowdown and that bringing crews into town would create a much-needed economic stimulus for local restaurants, retailers and building suppliers. Councilman Nicol abstained from voting because he recently sold a home near the park.

Restrooms and the pool will be removed in the reconstruction, according to the plans approved last year. The recommendation to remove the kiddie pool dates back to April 2019, when the council asked city staff whether funding could be found to upgrade and keep the pool. The cost and upkeep convinced the council that it was feasible.

The City Council closed the meeting with a moment of silence for fallen peace officers. Peace Officers Memorial Day is observed on May 15 each year. Other noteworthy actions and discussions at Tuesday's meeting included:

· Mayor Drew Boyles said he's in favor of the county opening the beach bike path because cyclists already are using it. He and other South Bay mayors are asking Supervisor Janice Hahn's office to get the bike-path the opening weekend, the chief said.

• The dog parks are open again. Dog owners are asked to bring hand wipes and sanitizers. The skate park won't reopen until Phase 3, which Los Angeles County just announced is set for July 4. There are no plans to issue the summer recreation program guide or offering camps or any summer programming for children. Meredith Petit, the director of the Recreation and Parks Department, estimates it would take 30-45 days to hire staff and ramp up the camps should the county give the order allowing small gatherings and children's classes.

• The Lakes golf course and driving range reopened and raised green fees and prices for buckets of driving-range balls. About 160 golfers hit the links per day for the reopening last weekend, and another 150 teed up on the practice range. The pro shop and restaurant remain closed.

• The restrooms at the check-in building at Rec Park are open now that paddleball, tennis and pickleball courts are open again and taking reservations. •
