## We Celebrate the Incredible Heroism of These Officers



Last Thursday, South Bay Police & Fire Memorial Foundation held their 49th Annual Medal of Valor Awards Luncheon honoring individuals who demonstrated extraordinary bravery beyond the call of duty. Congratulations to Lieutenant Luke Muir and Sergeant Alex Leavitt on receiving the Life Saving Award for their heroic actions. In March 2024, Lieutenant Muir and Sergeant Leavitt quickly applied tourniquets to a man's leg and arm to control the severe bleeding after he suffered a gunshot wound just outside the city. They remained with him, calmly explaining the procedure until ESFD paramedics arrived. Their quick thinking and decisive action most likely saved the man's life. Congratulations once again to Sergeant Alex Leavitt on receiving his second Life Saving Award, and to Officer Ryan Smith on receiving his first. In November 2024, they responded to a medical emergency, and without hesitation, administered CPR to a man in critical condition until ESFD paramedics arrived. ## Aquatics Center to Close July and August for Heater Repairs

Local swimmers may find water time a bit challenging this summer, with the planned closure of The City of El Segundo/Wiseburn Unified School District Aquatics Center (Aquatics Center) during July and August to replace the pool heaters at the site. With construction for the renovation at the Urho Saari Swim Stadium (The Plunge) still ongoing and a grand reopening not expected until early next year, residents will look for other options during the hiatus. “We understand the inconvenience closures can cause and do our best to provide alternatives,” said El Segundo Recreation Supervisor-Aquatics Joe Lormans. “When both pools are closed, Hilltop will be open for extended hours for introductory lessons and recreation swimming. For fitness swimming, we recommend looking into the surrounding cities’ aquatics programs.” A small outdoor pool with depth ranging from 1.6 to 3.6 feet, Hilltop Pool (at the corner of Maryland Street and Grand Avenue) will be open daily from June 16 to August 24, with swim lessons available Monday through Thursday from 8 a.m. to noon during that period. Public swimming hours will run from noon to 6 p.m. when the Aquatics Center is closed.

Originally open to the public in January 2019 after a two-year construction period, the Aquatics Center underwent temporary repairs in July 2022 when a couple of the heaters in the competition pool completely failed. The makeshift fixes, costing just under \$200,000, kept the pool in operation until a permanent solution could be implemented. The El Segundo City Council ultimately approved

a contract with Knorr Systems International to replace all the heaters for both pools at a total budget of \$700,000 (which includes \$86,000 in contingency funds in the event of additional unforeseen work). Wiseburn will reimburse the City \$300,000 at the completion of the job as part of the joint-use agreement between the two parties. The heater upgrade increases capacity for the larger competition pool (currently featuring two heaters at 1.24 BTU/hour each) and the practice pool (which now has one heater at 0.4 BTU/hour). The three new heaters will be at 2 million BTU/hour each. All parts and equipment for the

construction will be US-made.

The chosen two-month construction window in the heart of summer might seem surprising and ill-timed, but input from Wiseburn, El Segundo Unified School District, City staff, and various stakeholders zeroed in on July and August for a specific reason. “While it was difficult to pick a date for the repair, summer was selected to avoid interfering with the high school swim and water polo seasons,” Lormans explained. “Since this facility serves as the school’s only practice and competition site, we made it a priority

## Downtown Losing Rite Aid Drug Store

The Rite Aid store and pharmacy in downtown El Segundo will close starting June 18 after nearly 40 years of being the go-to place for health products, school supplies, and scoops of old-fashioned Thrifty’s ice cream.

The Rite Aid Corp. made the decision to go out of business and close 1,000 more stores after filing in May for bankruptcy for a second time. The retailer sold its pharmacy business to competitors, including Kroger, CVS and Walgreens, to pay down its debts after declaring for Chapter 11 on May 19.

According to a sign posted last week at the storefront, the pharmacy will not fill prescriptions after June 18. Prescriptions will be transferred automatically on June 19 to the Ralphs pharmacy on Pacific

Coast Highway and Mariposa Avenue. The Kroger Co. owns the Ralphs supermarket food stores.

“As we move forward, our key priorities are ensuring uninterrupted pharmacy services for our customers and preserving jobs for as many associates as possible,” Rite Aid CEO Matt Schroeder said in the release.

According to the retailer’s filing with the California Employment Development Department, the El Segundo Rite Aid employed 14 people, including two pharmacists, a pharmacy manager, and two technicians. The retail establishment was built in 1965 for Thrifty Drug Store, which became Rite Aid in 1986.

“What an honor it has been to care for you and your health and well-being.

## Film Review

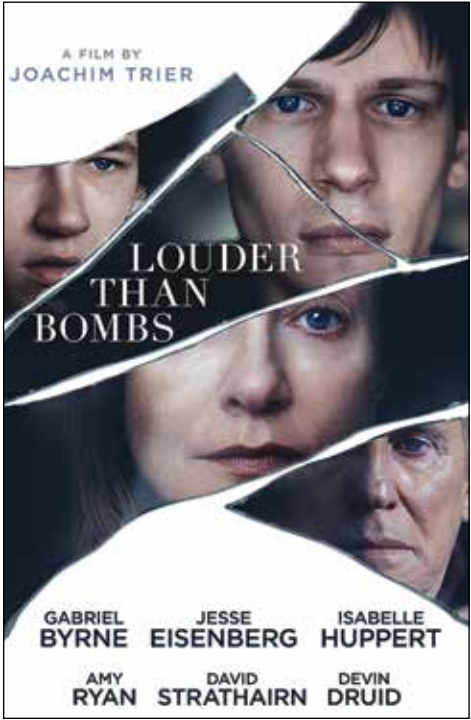
### Louder Than Bombs Review: Confronting the Human Desire for Connection

Director Joachim Trier captivated the 2025 Cannes Film Festival with his latest film, *Sentimental Value*. The film, which is an intimate and moving exploration of family, memories, and the reconciliatory power of art, received a thunderous 15 minute standing ovation. Ten years earlier, Trier made his English-language debut with the drama *Louder Than Bombs*, an intimate portrayal of one family’s relationship and the struggles they must overcome in the face of death. The film also made its debut at the 2015 Cannes Film Festival and quickly made waves in the indie/art-house film scene.

Isabelle Reed (Isabelle Huppert) a famed photographer who feels most comfortable in war and conflict-ridden areas, is the center of her husband Gene (Gabriel Byrne) and their two sons, Jonah (Jesse Eisenberg) and Conrad (Devin Druid), worlds. No one could have predicted that she would leave behind a familial conflict of her own doing after her untimely and suspicious death. Three years after the accident, Isabelle’s works are thrust into the spotlight when a museum in New York asks to use her photographs for a retrospective gallery installation. Her husband accepts, as he is slowly moving on with his life, and sees this as a great opportunity to honor her.

However, he discovers that an accompanying New York Times article speculating Isabelle’s actual cause of death is set to run simultaneously with the gallery opening. This threatens to expose the devastating truth that Gene is intent on hiding from Conrad. He has no choice but to enlist his oldest son Jonah to help him with another painful confrontation.

*Louder Than Bombs* is an unwavering look at the human desire for connection and the need to be understood. It’s obvious in Conrad’s behavior as he alienates himself from his father’s attempt to reconnect. It’s also seen in Jonah’s promiscuity, even when he has a wife and newborn baby at home. Gene’s attempt to bond with his two sons is affected by his flaws. This humanistic condition for connection is at the forefront of the film. It engages the audience in contemplating how and why we act the way we do, focusing on the relationships within our own family.

What sets *Louder Than Bombs* apart are the surreal moments Trier infuses within the story. He disregards the traditional method of linear storytelling by shifting between the past and the present. These added moments put visuals to feelings that have a hard time being expressed otherwise. They are not the character’s dreams, rather, they are daydreams- or what one wonders about without limitations. These moments are hauntingly beautiful and stand out as works of art.

On the acting front, the assembled cast could not have been better. Jesse Eisenberg is fantastic in the role of Jonah. His trademark quick-witted clamor serves as the voice of reason in the film. Gabriel Byrne plays Gene with sensitivity as a conflicted father who is not without his flaws. Devin Druid embodies the angsty, brooding teenager while still holding onto the innocence of being a misunderstood child. These, plus the stellar performances from Isabella Huppert, David Strathairn, and Amy Ryan, truly give the film its footing.

The title- *Louder Than Bombs*- suggests an epic, grandiose drama. Instead, Trier creates a meditative and restrained film that is not loud or brash. Rather, it celebrates uniqueness and coming together to fulfill the family dynamic. There is no doubt that Joachim Trier took a risk with *Louder Than Bombs*. It’s now evident that his creative vision has paid off tenfold. •

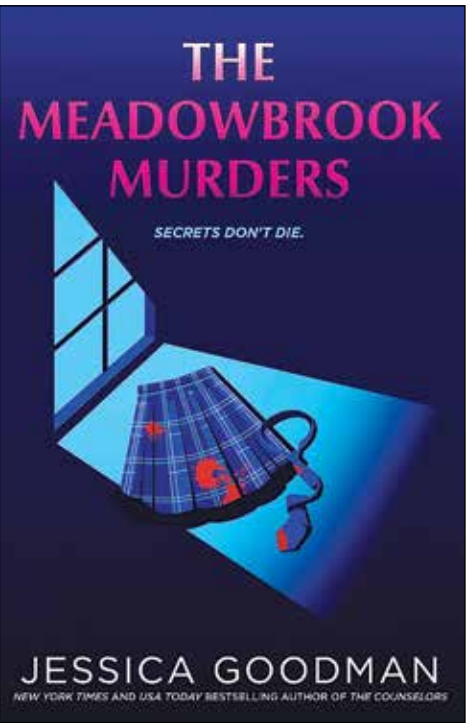
## Check It Out

not to displace their programs. By scheduling the repairs during summer break, we ensured that school athletics would remain uninterrupted while still addressing critical maintenance needs.”

Activities at the facility include public lap swimming and recreational swim hours, swim lessons for all ages, water aerobics and other fitness classes, competitive swim and water polo team practices, high school physical education and athletics for both Wiseburn and El Segundo Unified, special events and private rentals. The center hosts swim meets, water polo tournaments, and community events as staples in a busy calendar. “We’ve also hosted high school competitions, regional club tournaments, and City-sponsored activities like movie nights and holiday events,” Lormans added.

Lormans said the terms of which user groups receive priority are spelled out in the joint-use agreement. “During school hours, the District has priority access for PE and athletics. “Outside of those times, the City manages scheduling for community programs, public swim, and rentals. We strive to balance access among all competitive teams and public users.”



The two pools at The City of El Segundo/Wiseburn Unified School District Aquatics Center will get new heaters this summer.

In early discussions about the facility’s fiscal prospects, staff considered the potential to recoup operating costs through various revenue-generating methods. “Revenue comes from program fees, swim lessons, memberships, and lane rentals to user groups,” Lormans said. “While these revenues help offset costs, the pool is currently at about 70 percent cost recovery. The City regularly evaluates fees and usage to improve cost recovery.”

Meanwhile, the long-term partnership between the City and Wiseburn remains the key to the facility’s continued success. Under

the agreement, Wiseburn retains ownership, while the City oversees operations, staffing, programming, and general maintenance. The contract runs for 25 years as it stands, but may be renewed.

Lormans noted that the Aquatics Center has been a tremendous success since its debut five-and-a-half years ago, with strong participation from residents, user groups, and visitors across the board. “The response from the community has been overwhelmingly positive,” he said. “It has become a central hub for community recreation, swim instruction, fitness programs and competitive aquatics.” •

Please accept our heartfelt thanks,” the Rite Aid pharmacy staff wrote in a note to customers. Declining sales at many brick-and-mortar retailers, including Rite Aid, and e-commerce are behind the recent closures of several well-known retail chains, including the 99 Stores that went out of business and closed the El Segundo store last year.

“Rite Aid and Thrifty’s have been such a lynchpin fixture it’s difficult to think about an El Segundo without a small footprint ‘everything’ store right here,” Mayor Chris Pimentel said last week after the store closures across the region were announced.

For those holding onto Rite Aid gift cards, June 5 is the last day the store will accept payment by gift cards, according to the chain. Prescriptions can be transferred to another pharmacy other than Ralphs by speaking with a Rite Aid pharmacist in person or by calling 310-615-3025 before June 18.

Even after buying Thrifty’s and changing the store’s name, the retailer continued to serve hand-scooped ice cream in its stores. Rite Aid, as part of its bankruptcy proceeding, sold the Thrifty Ice Cream brand. According to published reports, the popular frozen treat will continue to be sold at grocers and markets.

Bolo Corp. Thrifty Payless of Harrisburg, Penn., owns the store and lot, according to property records. The property is valued at \$1.4 million and includes the 17,700-square-foot store that sits on 1.5 acres. The downtown location combined with the community’s long

history of supporting Rite Aid — and Thrifty’s Drug before it — is a big plus for getting the store leased again soon to another retailer, according to the mayor.

“The Rite Aid property has so much to offer with its location, parking, and its inclusion in the downtown zone. We anticipate a lot of interest in the area, and the revenue model for small-footprint retail, grocery, etc., is fully proven,” Pimentel said.

The modest-sized store offered convenience to residents on El Segundo’s west side and helped to avert homework disasters. Rite Aid could be counted on to stock glue sticks and glitter, scissors and construction paper, folders, and colored markers. The frozen treats in the coolers and juice boxes were lifesavers for team parents who’d forgotten it was their turn to provide the after-game snacks.

Being a short sprint from Recreation Park and the ballfields, the Rite Aid quickly became an oversized first aid kit for El Segundo parents and coaches, selling Bandages and bandages, pain relievers, sunscreen, and sunglasses year-round. Mayor Pimentel referred to the downtown Rite Aid as an “everything” store.

The mayor said he doesn’t expect the corner location to sit empty for long after Rite Aid’s final day of business later next month.

According to the company, Rite Aid operates 1,300 stores in 15 states, and its staff includes 4,000 licensed pharmacists. The retailer stopped honoring Rite Aid Rewards Points on May 6, it said in a press release. •
