ESFD's Deena Lee Becomes South Bay's First Female Battalion Chief

The City of El Segundo has made history again with a landmark hire. With the recent appointment of 16-year veteran Deena Lee as battalion chief for the El Segundo Fire Department, it marks the first time any female has ascended to that particular position in the South Bay. Lee's badge-pinning ceremony took place last Tuesday afternoon, followed by recognition at that evening's City Council meeting. "I am proud to be the first female battalion chief in the South Bay," Lee said. "I know there is a lot of responsibility that comes with that designation, but I am confident that I will do a good job and be a positive role model." Lee described the badge-pinning ceremony celebrating her promotion as the most memorable and meaningful experience of her career. "I am grateful for the recognition of my hard work, dedication and commitment to being the best firefighter I can be," she said. "As I looked out over the packed house in the Council Chambers, I was overwhelmed with all of the love and support from friends, family, fellow firefighters and fellow City employees." In rising to the rank of battalion chief, Lee competed in a rigorous promotional exam, finishing first on the list. "Her leadership skills, technical expertise and experience made her the perfect candidate for this position," El Segundo Fire Chief Chris Donovan said.

"Her dedication to fire service is unparalleled and I look forward to having her on the management team." Assigned to the B shift, Lee will lead training, health and safety efforts for the department.

While Lee's impressive resume and breadth of experience brought her to this point in her career, the Long Beach native didn't start off thinking she wanted to be a firefighter. ZENA," Donovan said. "It was during this time that members of the Long Beach Fire Department caught wind of her capabilities and invited her to do a ride-along."

Even by then, Lee still didn't picture herself as a firefighter – figuring that such opportunities were not there for women. "It was the Long Beach firefighters who told her that she would be a perfect fit and after

As Donovan recounted during last week's ceremony, she did knew early on that she wanted a job of service and to help people. "But back then, it was in the area of food service," he noted.

Lee, who has spent her entire life in Southern California, worked in the restaurant industry for a decade with initially no thought of putting out fires unless something started to burn in the kitchen. But thanks to the suggestion of a co-worker, she decided to enroll in an EMT class. That class spurred her desire to learn and also challenged her competitive instincts. She passed it easily, at the same time solidifying her interest in the medical realm as another (and perhaps more meaningful) way of serving people.

The EMT class led Lee to the emergency room of Long Beach Memorial Hospital where she began her new career as a technician helping move patients around and performing CPR, among other arduous activities. "Deena told me she would often perform CPR for over 20 minutes, earning her the nickname a ride-along at [Long Beach's] Fire Station #2, the hook was set," Donovan said.

Biting Dogs Have Mail Carriers in Every City on the Defensive

Something about the sound of footsteps approaching the front porch sends dogs into a defensive posture. Your dog may be friendly with everyone, but it doesn't matter. Regardless of the breed, the size or the animal's temperament, dogs will bite if they feel threatened.

That's why the United States Postal Service on Saturday started a public awareness campaign for pet owners across the South Bay. The mail carrier doesn't trust your dog as much as you do. Vice versa for your pet. And a screen door separating isn't enough to stop an attack.

South Bay mail carriers last year were on the receiving end of 31 dog bites, according to the Postal Service. With summer nearing, the postmaster for the Los Angeles region that includes Inglewood, Hawthorne, Lawndale and El Segundo reminds pet owners that dog attacks on mail carriers and children can happen in a split second.

Here are some suggestions for how to prevent a dog from biting the mail carrier or a stranger at the front door. When a letter carrier delivers mail or packages to a front door, place a dog in a separate room and close that door before opening the front door. Dogs have been known to burst through screen doors or plate glass windows to attack visitors.

Parents should remind children and other family members not to take mail directly from letter carriers in the presence of the family pet. The dog may view the letter carrier handing mail to a family member as a threatening gesture.

If a letter carrier feels threatened by a dog, or if a dog is loose or unleashed, the owner may be asked to pick up mail at a post office facility until the letter carrier is assured the pet has been restrained. If the dog is roaming the neighborhood, the pet owner's neighbors also may be asked to pick up their mail at the area's post office.

The number of dog attacks on postal employees locally and nationally declined last year, proof that the public-awareness campaign and safety tips for pet owners works, according to Postal Service spokeswoman Evelina Ramirez. The national dog bite awareness campaign ran for one week in mid-April, but South Bay mail carriers will participate in a more targeted campaign that will last through the summer months.

The Los Angeles postal region had the second highest number of dog attacks on mail carriers in the country last year. Houston was the worst city for dogs mauling letter carriers, followed by L.A., Philadelphia, Cleveland and Dallas. San Diego made the list at number 12.

Mail carriers across the Los Angeles region have started wearing t-shirts on Saturdays that ask all households with dogs to be responsible for pets. Postcards were left in mailboxes on Saturday for households with a known dog as reminders that dog bites affect everyone: the carrier, the Postal Service, the homeowner and the neighbors.


"Although our employees are provided with extensive training in preventive measures against dog attacks, we are asking for dog owners to aid USPS in lowering the number of attacks," said Los Angeles Postmaster Joe Zapata.

Those postcards bear the hashtag slogans #preventdog bites and Be a #ResponsibleDogOwner. The regional campaign asks homeowners living in Inglewood, Hawthorne, Lawndale and El Segundo to "help us to deliver safely." Each city had at least one reported dog bite of a mailman or woman last year, according to USPS See Mail Carriers, page 11

El Segundo High Selected as California Democracy School

El Segundo High School (ESHS) has earned recognition as a 2019 California Democracy School from the Los Angeles County Office of Education (LACOE) for creating and institutionalizing an effective civic-learning program. ESHS is one of only two schools in the South Bay to receive this honor.

Craig Gast, ESHS political behavior teacher, was instrumental in applying for the designation. "Often, government and civics are not always recognized by the public as being as important as some of the other areas of study," said Gast. "Many students do not even take government class until second semester of their senior year. By that time, they have already applied to college and have tentative fields of study chosen-all before ever being exposed to the field of study known as political science. I wanted to change that."

The California Democracy School Project is designed to institutionalize civic learning in high schools to prepare students for college, career and citizenship in the 21st century.

Key factors contributing to ESHS's selection included the collaborative Annual Civics Day program and the District's partnership with the City of El Segundo, as well as adoption of the new ESUSD Graduate Profile. In addition to the application process showing evidence of ESHS's related curriculum, LACOE conducted an interview with a selected community panel made of up El Segundo civic leaders and ESUSD representatives.

Part of ESHS' curriculum includes a mock congress where students take on national issues, conduct research and come up with their own solutions which they present to their classmates. Students then vote on the issues. Students also participate in mock elections, and all are given the opportunity to register to vote.

ES School Board Honors Retiring Teachers and Engineering Stars

Tuesday evening's meeting of the El Segundo School Board, initially graced by an overflow crowd, featured presentations from school site PTA administrators and high school faculty spotlighting the Advancement Via Individual Determination (AVID) program. The Board also honored El Segundo Unified School District (ESUSD) retiring teachers and El Segundo High School (ESHS) engineering students. The latter group received recognition for their recent first place selection in the Aerospace Corporation's Robert H. Herndon Memorial Science Competition.

ESHS Principal Dr. Melissa Gooden, in concert with AVID Coordinator Branka Cvejic, Assistant Principal Dr. Logan Fox and multiple teachers and students, updated the Board members on the strides made in the program. AVID is a college readiness program that aims to prepare students for matriculation into college and foster the development of myriad skills -- including writing, critical thinking, teamwork and organizational skills.

The AVID program, first implemented at ESHS in the 2006/7 school year, allows students to spend one period each school day with the same instructor for all four years of their high school tenure. Board President Nancy Cobb feels that the program fosters "in-class tutoring on all core subjects" and helps the students "effectively study, both independently and in groups, how to organize and manage their time, and how to stretch themselves independently with confidence."

The presentation highlighted how the AVID program tumbles barriers to higher education, including systemic, financial and personal roadblocks. The speakers also discussed the See School Board, page 8





figures. Gardena had the highest number of dog attacks on mail employees at six. Lawndale, Lynwood and Torrance had five dog bites reported by postal employees. Inglewood had four attacks, while Hawthorne and El Segundo had two and one bite respectively.

The actual number of pet attacks on the mail delivery person is probably higher, says the USPS spokeswoman Ramirez. Incidents involving aggressive dogs are left to the employees' judgment whether it was serious enough to warrant a report to a supervisor. The dangers to letter carriers are so serious that they receive special training to prepare them for the inevitable confrontation with a dog upset that somebody is trespassing in his territory. Bites are on the decline locally and nationwide since the training began.

Sixty carriers in the South Bay and Metro L.A. were bitten in 2018, which was an improvement from the previous year. The number of dog attacks was 67 in 2017, Postal Service figures show. Statewide, the number is dropping too, from 911 two years ago to

five games and raise his batting average to an eye-popping .405. Since joining the PB Cardinals of the Florida State League South, Nootbaar has helped the Cardinals to a first place lead of three games.

Jake Palmer (2017) was named Big West Player of the Week recently. He had been sidelined for an injury, but returned to put together a four-game stretch in which he had 11 hits and reached base 13 times in 20 plate appearances. Palmer, who is hitting .307 for UC Irvine, was 2-5 and scored four times against UC Riverside in the season finale. The Anteaters finished second in the Big West and are 37-17 overall. They'll wait for the NCAA selection committee for an invite to the tournament.

Spencer Palmer (2017), Spencer Long (2017), Jimmy Galicia and Brendan Casillas (2018) have led their El Camino College Warriors to a first round win in the California Community College Athletic Association state baseball tournament. Against the top seed from Northern California the San Joaquin Delta Mustangs, the Warriors won 5-3. The Warriors rode the arm of Galicia, who pitched 6.2 innings; and Long, who picked up his 10th save by striking out five in 2.1 innings. Palmer had a double in the ninth inning and scored an insurance run. Casillas was behind the plate and walked once.

say they were bitten from behind as they left the property. They have to be alert at all times when entering or leaving a property. The South Bay carriers will be attired in dog bite awareness shirts on Saturdays for the next three months.

The Postal Service's technology supports carrier safety in two ways. Handheld scanners used by carriers to confirm customer delivery have a feature that indicates whether a dog lives at the address. The Package Pickup application asks customers to indicate if dogs are at their address when they schedule package pickups, and carriers receive alerts.

"Most dogs will never bite, but it is important to remember that any dog can bite regardless of breed or type," cautions State Farm Insurance. In 2017, the insurer said it paid \$132 million as a result of 3,600 dog-related injury claims. California was the number one state for dog bites last year, according to State Farm. Those claims reached \$18.7 million.

A data-reporting group for the insurance industry estimated the average payout for a

dog bite claim exceeded \$37,000. When a postal employee is bitten, the pet owner is liable for the injuries caused by the animal. The Postal Service can sue to recover medical expenses and damages, including the cost to replace temporarily or permanently a carrier who was attacked. Owners are responsible for the actions of their pets under California law, even if they didn't have reason to believe a pet was dangerous.

There's liability for the Postal Service too if it hasn't done enough to protect employees with warnings, protective measures and warnings about where dogs live on mail routes and whether the animal has been aggressive in the past. L.A.-based law firms advertise themselves as dog bite experts in the law.

A January attack on a mail carrier in Whittier highlights the dangers from an aggressive dog getting loose in a neighborhood. The mail carrier was knocked to the ground and bitten on the face by a pit bull mix, according to Whittier news reports. She survived the Jan. 8 attack and was taken to the hospital for treatment of her bite wounds.

Deena Lee

Lee promptly switched majors from nursing to fire science (at Long Beach City College) and landed a position with the La Habra Heights Volunteer Fire Department working nights in the emergency room while enrolled in an 18-week academy. During a deployment to an area brush fire, she caught the eye of members of the La Verne Fire Department who encouraged her to join their agency as volunteer. "Deena was raising two kids, working 40 hours in the emergency room and volunteering Fridays at La Habra Heights and Sundays at La Verne Fire," Donovan said. "She had found her purpose."

After more than three years of testing and training, Lee formally became a firefighter in 2003 for El Segundo. Once done with the required probationary period, she took classes, obtained her fire officer certification and became urban search and rescue-certified. She earned a promotion to fire captain in 2007. Her responsibilities over the years have included safety equipment officer and platoon training officer. Lee was also an original member of the department's Rapid Extraction Modular Support (REMS) team, a specialized unit deployed to major incidents to provide support for firefighters who become ill or injured in remote locations.

"I love working for the El Segundo Fire Department -- it's the best job in the world," Lee said. "I work alongside a great team of firefighters who are dedicated to serving the community. We love being so involved with the people we serve. Most recently, we

celebrated Fire Service Day at Fire Station 1. We taught CPR to over 100 residents, served hot dogs and snow cones, and the children had the opportunity to run a miniature firefighter agility course."

Never content to rest on her laurels, Lee continued in her quest to learn and further her education. In addition to her fire science AS degree, she earned a BS degree in fire administration from Columbia Southern as well as a fire officer certification through the state fire marshal's office. She is additionally a state certified fire instructor and has taught at the El Camino College Fire Academy for 10 years. She has also completed prerequisite work to become a strike team leader for brush fire responses.

Lee emphasized the importance of giving back and raising awareness about the opportunities for women in her field. She volunteers with the Women's Fire Alliance and Girls Fire Camps and currently mentors a local high school student interning with the El Segundo Fire Department. "I am passionate about mentoring young women interested in this career path," Lee said. "I have been an advisor at fire camps for girls 14 to 19 years old. It is so rewarding to see the young women light up when they realize that they can do something that they never thought was possible. Now I can show young women that not only can you become a firefighter, but you can promote through the ranks and become a battalion chief. If you can see it, you can be it!" •
