

# **City Council Duties Closer to Full-Time Jobs Than Most Think**

Seems like it's a cinch at first glance. Get on the El Segundo City Council. Show up at the meetings a couple Tuesdays a month. Grin and clutch a humongous pair of mutant scissors at the once-in-a-blue-moon ribbon cutting. Answer a few letters here and there. Go home. A piece of cake, right? Wrong...and not so fast, not by a long shot. Just to give you an idea of what may be in store for those who put their hats in the ring and happen to come out on the winning side, we can look at just-elected Councilmember Don Brann's calendar over merely the first two weeks of May literally moments after taking the oath of office. In no particular order, he toured the new Ron Rubens Distilling and Brewing on El Segundo Boulevard, schmoozed for several hours at the Hometown Fair, attended meetings for the Library Board of Trustees and El Segundo Unified School District Facilities Master Plan, spent a Friday evening at Chevron Park mingling with local citizens during the Ed Foundation Gala, visited the South Bay Cities Council of Governments, represented the City at the Bisnow Future of El Segundo luncheon, networked at the League of California Cities program for new members, and connected with real estate bigwigs at Continental Development Corporation's projects and plans review. And that doesn't even cover every event during that period where he shook multiple hands, not to mention the various phone calls fielded from local constituents, Facebook and email messages exchanged, hours pored over scores of sometimes confusing Council meeting agenda documents, lengthy closed session time with his colleagues dealing with labor negotiations, and numerous stops at City Hall

to check in with staff and department heads. It was just another typical couple of weeks on the so-called "part-time" job for Brann, who just kicked off his second term on the Council and is getting back in the swing of things after a four-year hiatus from the dais.

But Brann wasn't alone. Other members of the Council also joined him for a number of the above activities and share many of the same responsibilities, a testament to the concept that what may appear at first glance to be a low-key, sideline, volunteer effort for low pay (\$900 a month) is in reality much closer to a full-time commitment. And yet Brann may be one of the lucky ones. He happens to be retired with some degree of extra free time on his hands. But the constant drive of community participation looms just as strongly for other Council members even if they have 40-hour or more day jobs. Just the spate of continual local appearances may seem daunting enough and yet El Segundo City Council members have considerably more on their plates once you also factor in their additional assignments. During the May 17 meeting, Mayor Suzanne Fuentes unveiled the other duties each of the members will take on over the next couple of years. The group unanimously approved her suggestions **See City Council, page 14**

# **Charter Reveals Plans for Time-Warner Customers**

The telecom carousel continues as Time-Warner Cable was sold to Charter Communications, leaving 1.2 million Southern California customers wondering how the transition will affect their TV, high-speed Internet and phone services and Dodgers baseball.

Time-Warner turned over its operations and cable and fiber-optic systems on May 18 to the much-larger Charter, which will now service the airport and South Bay communities. Charter says it won't be re-branding its trucks or equipment or making programming changes just yet, but changes are coming.

Time-Warner customers "won't see any

immediate changes," Charter spokesman Justin Venech told the Herald.

"The branding on the bill, current services, and channel lineups will stay the same."

Charter will phase in programming changes "in the coming months," said Venech without offering a specific date. The cable company will notify former Time-Warner customers about their viewing options once Charter migrates its Spectrum brand of programs and services to the Time-Warner cable systems in California and other states.

Charter says it has 25 million home and business subscribers in 41 states. The See Charter, page 2



More than 1,250 customers as of last week had filed complaints with the Public Utilities Commission, according to a spokesman with the commission. Frontier by its subscribers. # **Local Innovator Eddie Paul Remembers Path to** El Segundo as He Gears Up for Texas Move


It was a long and fruitful run, but eventually it was time to move on. Such is the case with one of El Segundo's most storied residents, Eddie Paul. One of the community's true innovators with a warehouse in the Smoky Hollow district for the last few decades, he is the guy who made a name for himself in the movie business by building the cars for film franchises such as The Fast and the Furious, crafting mechanical sharks for Discovery Channel's Shark Week, diving with Great Whites as an employee of the Cousteau family, creating the "pipe ramp" for use in the stunt world, and even doing stunts himself on notable shows including Dukes of Hazzard and Streets of Fire. He also patented numerous inventions ranging from fire pumps to 3-D filming apparatuses and was the go-to guy whenever the government needed some device built to solve a problem.

Paul, now 68, recently listed his residence on Walnut Avenue for sale with plans to head west and settle near Austin, Texas where his daughter resides. "El Segundo has been my home since the 1970s and that house has so many memories, especially from the early days of my career," he said. "It will be hard to leave, but family calls and I'm not getting any younger."

When Paul was younger, he could never have imagined the chain of events that would eventually lead him to his eclectic career path-not to mention a happy and productive life in El Segundo. It all started when he was still an 11th grader in nearby Westchester and his parents decided to divorce.

"I was pretty much living on my own with my Harley Davidson Chopper my only possession, but I did possess a bit of artistic skill," Paul recalled. "So I started doing any kind of painting I could so I could make money to buy more brushes and paint more." He painted store windows during Christmastime and pinstriped cars and motorcycles the rest of the year. He painted band names

no suspension and no front brake. And I had to ride it at about 50 miles per hour down a curved street next to a small pickup truck with a photographer for about 30 minutes as the camera snapped off shot after shot



Just a few of his recent cars built for movies. Mater, The XXX Gto and Lightning for Disney Pixar "CARS." on drum heads for well-known acts like The Turtles. Finally, he saved enough to purchase a camera and landed a freelance gig writing articles for motorcycle magazines at 100 bucks a pop.

"Coming up with different stories every month wasn't easy, so I had to think outside the box," he noted. When his editor came up with the concept "How to Ride a Bike," Paul suggested a unique lead shot. "I was sitting on the back of my Harley reading a book titled How to Ride a Bike. Sounds simple enough until you realize that the bike was a foot clutch, hand shift, ridged frame with

of the event. All this without touching the handlebars!"

Asked if he could pick up some press coverage along the way, Paul had contacted the Herald. "Little did I know this would start my connection with El Segundo," he said. The article brought him attention, with radio and other interviews following to hear from the crazy kid who would complete a project no matter how nuts it sounded. But after his early "15 seconds of fame," he was back to painting bikes and cars in his small garage in Westchester located directly beneath the noisy LAX flight path. At least now, El Segundo was now on his permanent radar.

"I would ride the Harley into town to steam clean it and found it funny that I could scarcely cross the city lines before I had an escort of El Segundo police behind me as I pulled into the car wash. They told me I better be good and that El Segundo didn't like bikers. At the same time, I was also impressed and thought if I could ever afford to live in El Segundo, I would come here. I thought maybe if I could ever land a movie job or something, but then I rolled my eyes and thought, 'Yeah, sure I will.""

Meanwhile, Paul's Westchester digs would soon be condemned so the land could convert to additional airport parking. Though he knew his days there were numbered, the thought of buying in El Segundo seemed a pipe dream given the "outrageous" price tag of \$40,000 for a small house. It was at this point that Paul got involved with the then-fledgling sport of hang gliding.

"It was up my alley since it involved design, fabrication and testing of the finished machine plus another opportunity to make a few dollars selling hang gliders that I was making out of my garage," he said. During its infancy, hang gliding proved a dangerous venture and most of the early practitioners lost their lives or suffered serious injuries. Paul would unfortunately not be immune to the trend, one day crashing to the ground from a 350-foot drop. He spent six months at Harbor General Hospital followed by another six months in a wheelchair. The dire circumstances wouldn't slow him down. "I still had more bills to pay and had to finish my first book I was commissioned to write on skysurfing-the sport of hang gliding," he explained. Then came the dreaded, but See Eddie Paul, page 18

# Film Review Former Cult Member Recalls Life as a Brainwashed 'Disciple' in "Holy Hell"



Movies about cults and the mysteries behind religious organizations usually always make for a fascinating watch. Take Alex Gibney's Emmy-Winning documentary "Going Clear: Scientology and the Prison of Belief," which provided an in-depth look at the infamous Tom Cruise-beloved organization. A handful of films currently streaming on demand also shed light on various cults, including the L.A.-bred "The Source Family," the evangelical "Jesus Camp" and "Kidnapped for Christ." With a plethora of these types of films already available for viewing, what makes director Will Allen's documentary "Holy Hell" unique is that for 22 years, he was a member of the Buddhafield Cult, the same cult he is now exposing.

Executive produced by Jared Leto, "Holy Hell" shows how one man's search for the truth unexpectedly lead him down a dark Knowing" (the ability to meet God), is really evolving into mental manipulation to feed Michel's narcissistic, maniacal ego.

"Holy Hell" takes twists and turns that are hard to digest, and this is only further supported by the endless amount of archival footage from Allen's camera. At times, it is heartbreaking; forced abortions, severing ties with loved ones, and the rampant occurrence of sexual abuse continues to evoke an emotional response from those who recount those experiences. One male member, in particular, describes being sexually abused by Michael every Monday for five years. It takes around two decades, but eventually enough of the pieces fall into place allowing some members to see the Buddhafield for what it truly is: a cult. It took Will Allen 22 years to figure this out before he finally left the group in 2007.

"Holy Hell," which premiered at the Sundance Film Festival this year, is a creepy

path of brainwashing, sexual abuse, and all around mental torture. Allen, who also narrates the film, explains how he was introduced to "The Buddhafield" by his sister Amy in the mid 80s. He recalls meeting The Teacher, a flamboyant man named Michel, who was the leader of the organization. Taking a liking to Allen quickly, Michel designates him as the group's filmmaker. That footage is what makes up most of this documentary, and it is as chilling and the process as stereotypical as one might expect.

The first act of the film shows beautiful hippie types, barely dressed and frolicking through the forest, hallucinating on happiness. However, the red flags surrounding the teacher becomes more the forefront of the film as we discover that this organization, which sets out to achieve growth and "The but fascinating watch and a good addition to the ever-growing genre of "religious cult" films. The film so accurately portrays Allen's memory of the Buddhafield because he was literally the one shooting the footage during those years. The film captures Allen's 180-degree shift in attitude from finding the truth to exposing a monster, condensing 22 years into a 100-minute runtime. While the ending of the film seems a bit silly- "Snow Patrol" by Chasing Cars plays to a music video of "disciples" aka group members in white shirts and pants dancing in a meadow, the parting words are enough to make us do a double take: "You've got a cult in your town, I almost guarantee it." Consider us warned.

"Holy Hell" is not rated. Now playing at the Laemmle's Monica Film Center. •

The Administration on Aging predicts the number of Americans age 65 and older will reach 98 million in less than 50 years, so it's possible many will struggle to take care of themselves physically, medically and financially.

Seventy percent of everyone 65 and older will need some type of long-term care at some point in their lives, the Department of Health and Human Services says. When health issues force seniors to require a higher level of care, you are still independent. As your care needs increase, you can move between accommodation and care levels.

• What should I know about entry and monthly fees?

Continuing care communities charge an entry fee that is typically in the range of \$150,000-\$200,000. Many seniors choose to fund this fee through the sale of their homes when they need to downsize into a more manageable living situation. Fees can vary depending on the type of accommodations and level of care you need. Monthly service fees average \$2,500-\$3,500, depending on the type of contract.



they can quickly exhaust their retirement savings. The burden of caring for them either falls on loved ones or Medicaid.

A growing number of seniors are turning to life care communities, like those operated by Brookdale Senior Living, to preserve their own long-term well-being and to ease emotional and financial stresses on their families.

A life care community - also commonly referred to as continuing care community charges an upfront entry payment and a monthly fee in exchange for long-term accommodations and health-related services. A contract formalizes the arrangement between the community and the residents, guaranteeing seniors receive the agreed-upon care even if their financial resources are eventually exhausted.

Here are some common questions about life care communities:

· Who is a candidate for a life care community?

Anyone older than 62 may be eligible to live in a life care community, if they meet financial and medical qualifications. Most continuing care retirement communities offer multiple types of accommodations - including independent living, assisted living, Alzheimer's and dementia care, and rehabilitation and skilled nursing. This means you can enter the community at any stage, including when While the fee may vary slightly from year to year and depending on the level of care you need, your community may agree to cap increases; Brookdale voluntarily caps annual increases at the consumer price index plus 2 percent at most of its life care communities. • How will entering a life care community affect my taxes and estate planning?

The IRS considers life care to be a pre-paid medical expense, so tax deductions are often available for portions of the upfront entry fee and monthly service fee - typically up to 40 percent of the fee. Because deductions can vary state to state, you should consult with your tax advisor to get a better idea of the tax benefits. Entering a life care community can also affect your estate planning. A life care contract takes care of the portion of your planning that would address funding your health care needs; the contract ensures your health care needs will be met even if you run out of money (through no fault of your own). You may also choose a refundable contract that returns a portion (up to 90 percent) of your entry fee to your designated beneficiary after you pass away.

• What are the health benefits of living in a life care community?

1. What tax deductions can I claim? Even if the expenses were incurred during the previous calendar year, the IRS allows businesses to deduct up to \$5,000 worth of certain start-up expenses in the year the business began (subject to limitations). In addition to these costs, corporations and partnerships are allowed to deduct up to \$5,000 of their organizational costs in their first year of operation.

2. Is my car mileage deductible? If you use your home as a place of business and consider it your principal place of business, car owners are typically allowed to deduct mileage costs from their home to businessrelated stops.

3. Can I deduct business travel expenses? When you are traveling away from your usual business location, you may be able to deduct ordinary and necessary expenses related to your work. These expenses include transportation costs, lodging, dry cleaning or

worn at work.

5. How does the Affordable Care Act (ACA) affect my taxes and deductions? The Small Business Health Options Program (SHOP) Marketplace allows for small business to purchase health insurance for their employees. If you pay at least half of your employee's premiums and have less than 25 full-time and equivalent employees with an average annual wage of less than \$50,000 (\$51,600 for 2016), you may be eligible for the small business health care tax credit. Filing a business return for the first time can be a daunting task, but it doesn't have to be. This season he has played both second base and left field and committed just one error all season. Palmer ended up hitting .315 for legendary coach Mike Gillespie who earned win number 1,101. Palmer also helped the team to a 13th consecutive 30-win season.

12. Unacceptable, but it gets worse. Told a technician it would be out on May 14 by 5 p.m. No show. It's now May 21 and nothing from Frontier regarding solution to this problem. They can't (or won't) tell me what the likely problem is and they lie."

Frontier blames corrupted software inherited from Verizon Fios for the repeated outages across Southern California and in several states. The telcom company promised state lawmakers last month it would correct the problems with slow internet speeds and service interruptions.

A Lake Elsinore reviewer explained that Frontier canceled a service call and re-scheduled it without checking with her.

"I have been on the phone with them multiple times due to not having internet service for last two weeks. They finally scheduled an appointment for a technician to come to my home then cancelled the day of and left an automated voicemail rescheduling the appointment for a day I would not be home," the customer wrote.

The Time-Warner sale to Charter is part of a shakeup of telecom ownership that started in July when AT&T U-Verse bought El Segundobased DirectTV. Frontier in April, wrapped up the deal to buy Verizon Fios and its landline divisions. All three pay-TV providers compete in the airport and South Bay cities.

Charter quadrupled its number of Southern California subscribers and now services 1.5 million homes and businesses, according to published reports. Time-Warner customers will be relieved to know that Charter has contracts with the Los Angeles Dodgers for baseball, USC football and Lakers games.

South Bay cities are yet to hear from Charter about its plans for the future. A change to the federal telecommunications act in 2006 stripped California cities of their authority over local cable TV providers. However, cable companies and cities have business relationships for public-access TV channels, some resident complaints, and maintenance contracts.

Manhattan Beach has a five-year contract with Time-Warner Cable to maintain the fiberoptic cables for phone service, according to management fellow Kendra Davis. The new owners, Charter, have not contacted either Manhattan Beach or Torrance yet to discuss future plans.

"As of this moment, the City has not received any communication regarding changes that may result from the sale of Time Warner to Charter Communications but is hopeful that it will not result in a disruption of service for the City or its residents," Davis said in an email to the Herald.

Charter Spectrum sent a letter last week to subscribers about the sale. City officials, however, say they learned from media reports and not the telecom companies themselves that the deal had closed. The Torrance manager of cable TV services also said that no one from Charter has contacted his office about the change of ownership.

"Because they are conducting business in our community, and their customers are our residents and businesses, they have a unique opportunity to gain insight to any local impacts," Cable and Community Relations Manager Michael Smith said. "We can also be a resource in dispelling any incorrect perceptions as well as mitigate customer service issues."

Time-Warner's performance in Torrance was solid, based on the number of complaints taken by Smith's office. Time-Warner subscribers lodged 15 complaints in 2014, 16 in 2015 and just two from January through May of this year, according to Smith. The majority of complaints were about billing and rates, according to the breakdown he provided.

Time-Warner Cable and Charter are the only two cable providers in Southern California that show Los Angeles Dodgers games. Time-Warner took the lead in 2013 and signed a 25-year deal with the Dodgers. The Dodgers own SportsNet LA, but TWC is responsible for getting other pay-TV companies to use it.

Frontier, U-Verse and Dish Network subscribers were shut out again this baseball season because their TV service providers refused to pay the Dodgers' asking price to televise home and road games. There was talk that AT&T's deal for Direct TV would require the new buyer to televise Dodgers games, but that didn't happen.



expected call. "I was told I had 30 days to move out of the Westchester house," he said. "I informed the City of Los Angeles that I couldn't do it in a month and had no place to move to, and that started daily negotiations between me and the airport. In order to get me to leave as quickly as possible, I talked them into helping me secure a loan for a small two-bedroom, rundown house in El Segundo over on Walnut."

Upon his arrival in El Segundo, Paul's fortunes immediately brightened. Shortly after renting a small shop on Nevada Street, he received a call from a studio asking him to build the 48 cars for the movie *Grease*. "Every penny I earned was reinvested back into either the house or tools for the shop," he said. "I knew it was the best investment I could make."

Things slowed down after Grease, but Paul worked around the clock in his shop during the day and in his garage at night. He built about 20 major vehicles out of his driveway while also adding onto the small structure between City inspections. During this period, he also began his TV stunt work. "On any given day, you'd see me building roll cages for the General Lee [the nickname for the 1969 Dodge Charger on the Dukes of Hazzard] late at night in front of my house and then going on location the next morning for stunts," he said. "Work was long, hard and dirty and sleep was pretty much nonexistent-but adrenalin was flowing with each phone call."

Notoriety from Paul's first "no hands" shoot led to another similar job offer, only this time it was a much longer 286-mile trek


from L.A. to Vegas. He agreed to do it even though most people thought he was off his rocker and an article about it appeared in the *Herald* in March 1980.

Paul credits his dad with instilling into him a relentless work ethic. "He taught me one important rule in life is to never turn down a job unless you absolutely can't do it," he said. "Because they may never call you again and the phone calls will just stop. So grab the work while you can. He told me this over 45 years ago and I took it to heart. I didn't turn down the jobs and my life was better for it. I'm hoping lots of other people benefited as well."

The house on Walnut will no doubt be snapped up by a hungry buyer aiming to enjoy El Segundo's unparalleled quality of life. If they choose to delve a little deeper into the history of their new property, they'll learn this was the home garage and birth of many famous cars and props for countless TV shows and films ranging from *Mork and Mindy* to *Walking Tall* and so many more in between. Yes, it was a very good run indeed for Eddie Paul in El Segundo. •


