# Josie Mendez: Feeding the Community at the La Paz Cafe

Restaurants come and go in El Segundo. And every other city in the United States. Some last for many years and then decide to shutter their doors. Unfortunately, some evaluate the public interest for their foodie fares, do not make the competitive cut, and are quickly gone. The National Restaurant Association estimates that some 30 % of restaurants nationwide must close their doors within the first year after their gala opening.

One restaurant that withstood the vagaries of customer tastes for more than 40-plus years is the La Paz Cafe, which was initially located on El Segundo's Main Street, and relocated to Center Street in the Mariposa Village in 2005. Josie Mendez runs the restaurant, the "administrator," she said, which is still owned by her mother, and was opened by her parents, Jose and Josefina, in its first iteration in 1976. Jose was alerted by a friend that there was a spot for lease on Grand Avenue in El Segundo. The Mendezs took the leap and leased the building in 1976 that now houses Ali'i Fish Company. The business, Josie relates, was doing well, but in 1978, the property owner raised the rent, so Jose and Josefina looked for a new spot to sell their Mexican cuisine. They landed on Main Street, bought the name, and took over

But after a great run on Main Street, the Mendez family business was again on the move. In 2005, the owner of the La Paz property, Josie said, tripled their rent. So, the Mendez's packed up and moved to their current Center Street address at 514, which landed them smack-dab between the Middle School and Center Street Elementary school.

The move definitely panned out. "It has been perfect," Josie said. "the best thing ever. "Parking was horrible on Main Street," she lamented. The Center Street restaurant provided "easy access for my customers," while also noting that the Center Street facility was much more spacious than their previous digs,

# **California Mortgage Relief Program for Property Tax Payment Assistance**

In December 2021, the State launched the California Mortgage Relief Program to provide assistance to homeowners who fell behind on their housing payments due to financial hardships they experienced during the COVID-19 pandemic. The program is funded by the 2021 American Rescue Plan Act's Homeowner Assistance Fund and administered by the California Housing Finance Agency Homeowner Relief Corporation.

The California Mortgage Relief Program is expanding to help homeowners who may be current on their mortgage payments but are delinquent on property tax payments. Eligible homeowners could receive up to \$20,000 to cover past-due property tax payments.

There is no cost to apply, and the funds never have to be paid back. Applicants seeking property tax relief must meet all of the following criteria:

• Faced a pandemic-related financial hardship due to the COVID-19 pandemic after January 21, 2020.

• Household income at or below 100 percent of their county's Area Median Income. See Mortgage Relief, page 5

#### **Obituaries** Gerald "Gerry" Earl Bushrow 1935-2022

Heaven has a new angel who knows how to use those wings! Gerald "Gerry" Earl Bushrow, an accomplished aviator, loving husband, patient father, adoring grandfather, and faithful servant of God has "flown west" to glory after a brave fight with acute myeloid leukemia. He was at peace, supremely confident in what awaited him on the other side. He was 87 years old.

Gerry was born the fourth of six children to Leo and Martha Bushrow of Saginaw, Michigan. The son of a hard working railroad supervisor for the C&O Railroad, he grew up in a time of economic hardship and world war that shaped him into a man who knew the value of a dollar, the meaning of commitment and honor, and the true cost of freedom. He met the love of his life and his partner of 67 years, Patricia (Pat), in 1953 and together they lived a life that honored God and set a shining example of love, dedication, and mutual respect for their four children and 12 grandchildren. They chose Southern California to raise their family in 1966, moving to their current El Segundo home in 1971 which is where the "King of Hillcrest Street" died on June 5. He had a joyful laugh, was quick to offer a clever turn of phrase or nuanced observation, and had a face always lit up by the never-ending smile and demeanor of a man who lived for others and relished every minute in their company.

Gerry was a man of service. He followed his older brothers in service to his country as an Aviation Cadet in the newly formed US Air Force, earning his pilot's wings at 19 and joining the emerging Jet Age to fly the KC-135 Stratotanker in operations around the world. He had a front row seat to the end of the Korean War, played a major role in the Cold War including operations during the Cuban Missile Crisis, and concluded his military service during the Vietnam War.

His love of flying was a centerpiece of his life. He transitioned from Air Force flying to airline flying as a Captain for American Airlines in 1966. His career there spanned 29 years with highlights flying the Boeing 747 and DC-10. When he wasn't actually flying he loved to talk about flying, and after he retired he spent many hours sitting outside his home near LAX greeting neighbors and watching the jets come and go, often commenting on their timeliness and the apparent skills of the airmen at the controls. He could recognize the type of aircraft by the sound of its engines, and frequently offered information about flight numbers and destinations to whomever would listen as they roared overhead. He loved to share this passion with others, and was a founding sponsor of an Aviation Explorer post that offered free ground school and discounted flight training to young men and women in Scouting. Through this Post, Gerry was able to ignite the love of flying in countless young people, including his three sons who learned to fly there.



town of El Segundo, especially at the El Segundo United Methodist Church where their deep and selfless involvement has continued unabated for over 56 years. Gerry was a popular lectern assistant, usher, newsletter author, historian, handyman, and more. He was also an active member of the Optimist Club, and he continued to recite and abide by "The Optimist Creed" to the very

end. The creed and the club's commitment to service represented so much that Gerry held dear. In retirement the couple enjoyed numerous extended trips around the country in their motorhome, basking in the company of family and friends across every corner of North America.

But the joy of Gerry's life was his family. He was an affectionate father who doted on his kids: Cheryl Barnes (Keith) of Northfield MN, Tim Bushrow (Sue) of Jasper TN, Paul Bushrow (Michelle) of Charlottesville VA, and Jay Bushrow of Gardnerville NV. He set high expectations, praised accomplishments, and provided supportive encouragement to keep going when they fell. He taught them to be self sufficient, and liked to say "Man made it, Man can fix it!" when faced with a particularly daunting technical challenge. He was no fan of a "free lunch," and taught his family that "anything worth doing is worth doing well." He took to the role of "Grandpa" with gusto, and particularly enjoyed sending unexpected gifts to his extended family and friends. He leaves behind his adoring grandchildren: Natalie, Nathan, Rachel, Sarah, Danielle, Christine, Charles, Ben, Brenna, Derek, Levi, and Dean, each of their lives indelibly shaped by and reflective of Gerry's love and devotion.

Gerry was preceded in death by his parents, Leo and Martha Bushrow, and his brothers, Norman Bushrow, Harvey Bushrow (Eileen), Raymond Bushrow (Beverly), and Albert Bushrow. He is survived by his sister, Brenda Gross and her husband Richard, Norman's wife Geraldine Bushrow and Harvey's wife Julia Bushrow.

The family is profoundly appreciative of the dedicated and professional care provided by Torrance Memorial Hospice during Gerry's final days. They will never forget the kindness of hospice nurse Al and the other hospice nurses, as well as the loving care of Gerry's niece Becky. They are especially appreciative of Gerry's caregiver Duncan, who became part of the family for the final month, showing such love and compassion for "The Captain" as he prepared for his final departure.

Robert was a butcher, cook, cafe owner, and dabbled in other entrepreneurial endeavors including bootlegging. Four-year-old Violet

sometimes sat on the tub hiding the bottled spirits to distract any curious authorities. Olga was a seamstress, a skill she passed to Violet, who would later sew countless prom dresses for her daughters and their friends and uniforms for ESHS pep squads.

After marrying in 1948, Violet and husband George resided in Columbus, Ohio, relocating in 1962 to El Segundo where Violet lived for the next sixty years. All holidays and special occasions were hosted at the family home. Thanksgiving was particularly memorable for the vast array of traditional dishes and homemade pies. Vi's grandson, Chris Voegtli, ably assumed the role of chef in the last few years, always under Vi's watchful eye. Vi loved to try new recipes, often adding inventive touches.

Violet's life in El Segundo touched many people, beginning with her work as a playground monitor at the middle school, much to her daughters' embarrassment. At the recreation park, Vi taught stitchery, macramé, and cooking to both youths and adults. For a time, Vi marketed her artistic creations in an area of the El Segundo Hardware Store which she named Vi's Corner. She also drove the Dial-A-Ride and took the Senior Striders to the Strand for walks. Vi enthusiastically participated in the exercise along with the walkers. Vi played tennis with a passion. She was self-taught and demonstrated a strong



serve and forehand, and very competitive spirit. She followed professional tennis, football, and basketball with great enthusiasm. She also loved horse racing. Some memorable birthdays were spent at Santa Anita Race Track with a large crowd of family and friends.

Vi was a voracious reader and a loyal supporter of the local library. She kept up with current events by reading the LA

Times daily and the New York Times on Sundays. She remained a skilled crossword puzzle enthusiast throughout her life. She was not shy about sharing her opinions and observations about many topics.

Vi opened her home to friends, extended family, and foreign exchange students who came to El Segundo through the AFS program. There was always room at the table for more people and always plenty to share. Everyone felt welcomed by Vi's hospitality and warmth.

Vi provided unwavering support and unconditional love to her family. She leaves daughters Kathleen, Cynthia, Emily, and Kim, and son, George. Her treasured grandchildren include Katie and Julianna Hunt, Chris and Lauren Voegtli, Andrew and Jack Morrow, Sam and Eric Long, and Grace, George, and Joe Wiley. Vi was also blessed with five greatgrandchildren, with another arriving soon.

Everyone warned us about Mexico City—everyone in our comfortable southern California beach suburb, that was. Stay clear of the buses and the gypsy cabs. Never walk about alone and never venture out at night. Avoid the markets and back streets, especially around la Merced and Tepito. Leave your watches and jewelry at home. Run from approaching cars. Stay away from the red lights of the Zona Rosa, and watch out for the crowds on the Zócalo. Watch out for earthquakes. Don't drink the water or eat the food.

What surprised us was how many of our suburban Latino friends joined in the chorus. The lone dissenter was our housekeeper, but she hailed from Guadalajara and had never spent much time in the capital. Yet, when we checked the more accessible statistics on the internet, they tended to back her view. Mexico City suffers fewer assaults than Toronto or Montreal. As for gun deaths, major US cities like New Orleans, Miami, Philadelphia, and even Boston (but not Los Angeles!) leave the Chilangos of Mexico City in the dust. As **See Travel, page 10**

# Your Neighborhood Therapist

#### Dear Neighborhood Therapist,

Reading the news, and in social media commentary, I often hear that a lot of today's problems are because of people's "mental health." My child - now a happy, thriving adult - was diagnosed with a mental health condition, and there were various points where this diagnosis could have derailed his life. Even though he is fine, he's always felt that there is a stigma attached to having a "mental illness," as if what he went through was somehow his fault, and that if he had only been tougher or stronger he would not have gone through what he did. He is plenty tough and plenty strong, and I wish people would understand this. Can you help spread the word that this isn't the case? - Unfairly Stigmatized, El Segundo

#### Dear Unfairly,

I will do my best to spread the word. You're right: there is a stigma around treatment for "mental health" or "mental illness." I have mentioned before that I don't like those terms, or at the very least, I don't like the way we tend to use them in our everyday life. While I think the trend is in the right direction, the term "mental illness" can still carry a social stigma that implies weakness or somehow not measuring up to others. Fear of being diagnosed with a mental illness can keep people who would really benefit from counseling from pursuing the help they need.

Many of us - I would actually argue most of us - have at some point in our lives had a condition that would be diagnosable according to the Diagnostic and Statistical Manual of Mental Disorders, commonly referred to as the DSM. Published by the American Psychiatric Association and recently updated, the DSM is used by professionals to make diagnoses about peoples' mental health that are used by hospitals, the legal system, insurance companies and others. Although the DSM is put together by hundreds of well-meaning clinicians and researchers, its history is a reflection of our society as much as anything else, and indeed it has been at times problematic: for example, as recently as 1974 homosexuality was classified as a "disorder." Our system is far from perfect.

Depression is an example of a condition that we often see as therapists that is also concurrently treated with medication. Many factors can contribute to depression. Sometimes depression is primarily a result of circumstances; sometimes it is primarily a result of brain chemistry; sometimes it is a combination of several factors. Yet we treat the many shades of depression and other problems as "mental illness" or "disorders," and with this classification we as a society tend to lay the responsibility for this at the feet of the person who is suffering, as if their suffering would go away if they would "get with the program" or "be normal" or change some behavior that isn't hurting anyone else.

Thank you for bringing this to light. Understanding about treatment for mental, emotional and physical problems involving the brain and mind is slowly becoming more complete, but there is much room for improvement. Both professionals and laypersons' everyday use of language around our well-being from the neck up remains sloppy. Let's remember that the word "mental" refers to the mind (roughly, our consciousness) and not the brain (that organ in our head). The two are not interchangeable. You don't get mental cancer and you don't get brainally prepared for the big game. We can all do better.







# *Remarkably Bright Creatures* by Shelby Van Pelt

The idea of a Giant Pacific Octopus as the main narrator of a story sounds preposterous. Shelby Van Pelt knows exactly what she is doing though, as she begins this whimsical story of grief, loss, love and loneliness. According to UC San Diego Scripps Institute of Oceanography, "Octopus are incredibly intelligent creatures. Our Giant Pacific Octopus recognizes her caretakers by sight and

smell, knows how to solve puzzles, open jars, and enjoys interacting with guests. Their big brains make captive octopus escape artists." Marcellus McSquiddles is just such an octopus. There were a few common storylines that ran throughout the 2022 Sundance Film Festival, Eco-consciousness and black trauma in white America being a couple of recurring themes. Another undeniably sensitive topic that connected a handful of films is abortion-or more specifically, highlighting a woman's right to choose. Recent political and public debate over this subject only increased the timeliness of directors Emma Pildes and Tia for themselves.

Those are only a few of the many horrifying tales discussed in The Janes. The heaviness of the past (and horror that history could repeat itself) is slightly relieved as we learn more about the women behind "Jane" and the impact they've had on so many young women's lives. JANE is the anonymous pseudonym for the Chicago-based underground network of women who provided safe abortions for people in need. They were both

The opening sequence of the film plays like a standard talking heads interview setup. Notably, though, it's missing the score. With no music to aid in relieving tension, we're left to ingest all of the horrifying statistics and personal anecdotes that are shared by the handful of brave women we see onscreen. The decision to not include any music during this scene makes a huge impact on the story and prepares us for the psychological and emotional journey that is to come.

In the 1960s, abortion wasn't part of standard medical practice, the women of The Janes recall. Abortion was a crime. Young women literally had to turn to the mob to get an illegal abortion in dingy motel rooms, left to bleed and care for themselves postoperation. Some women were assaulted by rogue male doctors AFTER they got their abortion but couldn't say anything to authorities because the procedure was illegal in the first place. And for those who claim that protection would solve the problem, interviewees recall that the law at the time stated that you had to be married to get access to birth control (a bit counterintuitive if you ask me). Some women found a workaround by buying fake rings to get contraceptives an unlicensed medical facility and a support group for women with nowhere else to turn. Their heroism and bravery in the face of total injustice are admirable, to say the least.

In a stunning mix of archival and presentday footage, co-directors Emma Pildes and Tia Lessin craft a powerful portrait of strength and resilience. It's incredible - in every sense of the word - that over 50 years later, we're still having the conversation around a woman's body and her right to choose. However, The Janes is another step in the long-treaded journey towards progress and activism. •







long as we weren't rich celebrities or drug dealers—and we were assuredly neither—all we needed to do was keep to our normal low profile and mind our own business.

As it happened, our boutique hotel sat on a quiet street just inside the infamous Zona Rosa. On our first night in town, the room was elegant, but small, the rarified evening outside was warm and balmy, and... next thing we knew, we'd forgotten all of the cautions. We walked for hours on streets with names like Insurgentes, Reforma, and Revolución. We ate at a crowded, but elegant Tex-Mex tourist trap (and yes, the Mariachis insisted on playing "Bésame Mucho" at our table), The city that came to us was an explosion of color—the "Thing" about Mexico City being how the intense artistic sense of its citizens spills out of their architecture, both sacred and profane, into the streets, squares, and alleyways of even the poorest neighborhoods. There is art everywhere, in the thousands of eccentric civic sculptures, in the choices of paint colors for dwellings and offices, in the arrangement of food, flowers, and furnishings in the markets, in the artful design of food on a plate in a beautifully decorated restaurant. You could spend an entire vacation just tracking down the murals of Diego Rivera, José Clemente Orozco, Alfaro Siqueiros, and their

but only because we were tired, and it was the first busy venue we came to.

It wasn't until the next morning that we really felt like we'd arrived. With a longtime interest in Russian history, we naturally wanted to find the house where Stalin's NKVD agent Ramón Mercader stabbed Leon Trotsky to death. At the time, Fridamania was in full swing, so we wanted to poke around Kahlo's Casa Azul in Coyoacán. Beyond that, we really—and uncharacteristically for us—had no idea. So we decided to just let the city come to us. And that meant riding the dreaded buses anywhere they took us. acolytes. But a simple stroll through Mexico City is as artistic an experience as a visit to any art museum.

The drama of this aesthetic extends to the citizens themselves. They dress practically, of course, but with as sophisticated and innate a flair as our favorites, the Parisians. The immaculate police direct traffic with loud blows of their whistles and the grand gestures of orchestra conductors. The lush parks overflow with art students at their easels and bemused entertainers in ancient Aztec costumes. Even on the dry, dusty balconies of el Templo Mayor, we found ourselves surrounded by

the exquisitely dressed contestants of a Miss Universe pageant.

As a country, Mexico came by its innate sense of style and drama—and its reputation for violence—the hard way, in the upheavals of the Aztec Empire, the Spanish Conquest, the Wars of Independence and the Reform, the French Second Empire, and above all, the Mexican Revolución. The ferocity and durability of those struggles was perhaps inevitable, given the staggering inequality in the country—an imbalance never imagined in the United States, that rivaled the Chinese and Russian regimes of the same period. So fierce were the arguments, that the Revoluwas dispossessing them to make way for his cattle ranch—but the carefully staged event looked more theatrical than threatening, and made a point of not interfering with the surge of Sunday traffic in and out of el Bosque de *Chapultepec*.

One topic where we arrived with a host of preconceptions was Mexican cuisine. And yes, in a capital as dominant as this city, you will find every regional variation, even the faraway Baja and Sonoran specialties we knew. In a tourist mecca, you'll also find every exported Mexican hyphenate returned to satisfy the untutored whims of foreigners. But once you get past the junk

ción saw every President between 1910 and 1934—along with two of the more colorful Mexican leaders, Emiliano Zapata and Pancho Villa—either exiled or assassinated.

The unbalanced wealth earned Mexico City its reactionary sobriquet as the City of Palaces, while the Revolución contributed its determinedly centrist political structures and a host of provocative, avant-garde street names. These make for an odd juxtaposition that, much to our surprise, seems to work. We did weave in and out of a demonstration around El Ángel on Reforma—a protest by peasants from the countryside against a Senator who and casual foods of the markets and street vendors, Mexico City boasts a cuisine every bit as sophisticated as any European culinary capital. In neighborhoods from la Condesa to Polanco to the crowded Barrio Chino, local and imported chefs infuse the foods of the world with a Mexican sensibility that is every bit as distinctive as the Parisian.

And yes, we keep coming back to thoughts of Paris in this city. Because either Mexico City is the Paris of Latin America, or Paris is the Mexico City of France—we don't know or particularly care which. But we can't imagine a greater compliment for either. •




