Heather Sutherland: Wife, Mom, Stepmom, Volunteer, Friend

Similar words and phrases were mentioned when I asked El Segundo's Heather Sutherland's friends and confidants what makes her a unique citizen. Like... "Generous. Real. Honest. Selfless. Giving. Caring. Genuine. Reliable. Hard-working. We are a better town because of her efforts." It sounds like a lady that the *Herald* readers should learn a little more about.

When I caught up with Sutherland, who graduated from El Segundo High School in 2002, she had just returned from a baseball tournament in Arizona in which her 18-year-old stepson Colby participated. And she was amid a walkabout around our city.

Some of the Sutherland [her family name is Escalante] background: After graduating high school, Sutherland, a softball player and first basewoman, attended Golden West College in Huntington Beach. "I was not particularly good [in school], did not take my SATs," she said, "but I was good at softball." During her tenure at Golden West, college recruiters were at her door, and the plan was for her to attend Stony Brook College in New York, but she suffered a torn hamstring, which "ended [her] softball life."

She decided to stay in Orange County and "got into hair school there." She worked in a few OC salons, then moved back to El Segundo in 2010. Her father, a Hawthorne police officer, owned the Quality Silk Screen business next door to the Grand Illusions Hair Salon.

Sutherland, Escalante at the time, took a job at Grand Illusion's and after a year, crossed paths with Steve Sutherland, who had graduated from El Segundo High School in the late 80s, and was divorced with three kids.

Heather met her future husband in 2010. She went to have a dental check-up, and Steve, after performing his dental duties, noted, "oh,

you are the hot blonde that works at the hair salon?" Steve asked Heather out on a date. Heather was leery; she was just there to "get my teeth fixed." She said that, over the years, she has counseled some of her single friends who were looking to meet a nice guy to "go to the dentist; you never know what you might find."

She and Steve have now been married for six years. She jumped into a "ready-made" family, with Steve having the three boys from his prior marriage, and she also counts two other children from other circumstances as her step-kids. She and Steve have their own pride-and-joy, Jax Hudson, born in 2014.

In ‘Fire of Love,’ Even Volcanic Dangers Can’t Extinguish Love

“This is Katia. This is Maurice... tomorrow will be their last day.” Making its World Premiere in the U.S. Documentary competition at this year’s Sundance Film Festival is *Fire of Love*, the incredible true story of a couple whose passion for chasing danger eventually caught up with them, but whose legacy made a lasting impact on their tight knit community.

In an effort to show the world the strength and beauty of the misunderstood natural phenomena of volcanoes, wife and husband Katia and Maurice Krafft routinely put themselves in the path of danger. One day,

Little League 11-Year-Old All-Stars Win District 36 Tournament

The El Segundo Little League All-Star teams have garnered some 39 championship Little League banners, including ones for winning District 36, Section 4, and one Southern California State Championship. You can add a fortieth banner to an already crowded and impressive history of El Segundo Little League. The 11-year-old All-Stars went through their District 36 tournament undefeated and capped their championship with a convincing 6-2 win over Palos Verdes Little League.

This year’s team is essentially the same one that captured the Southern California State championship last season as 10-year-olds. This team rolled through the District 36 tournament with relative ease, and when they defeated Palos Verdes Little League in the winner’s bracket final, it meant a trip to the championship final.

In the District 36 championship game, El Segundo faced Palos Verdes Little League for the second time. PVLL advanced to the elimination championship game after defeating Hermosa Beach Little League. El Segundo used great pitching and timely hitting to win 6-2.

El Segundo sent Jaxon Kalish to the mound to quiet a solid Palos Verdes lineup. The hard-throwing right-hander was unhittable through his four innings, striking out six and walking two. The closest PVLL came to getting a hit off Kalish was in the third inning when Robert Slane hit a ground ball between Colby Lee and Declan McRoberts into right field. Right fielder Lennon Salazar charged and fielded the ball and threw it to McRoberts at first base for the final out of the inning.

El Segundo took a 3-0 lead in the first inning.

Brody Brooks was hit by a pitch and scored on an RBI single by Kalish. Lucas Keldorf followed with a single, and McRoberts belted a double scoring Kalish to make it 2-0. Crew O'Connor then hit a towering sacrifice fly scoring Keldorf to make it 3-0.

In the second inning, El Segundo increased the lead on the strength of Brody Brooks' opposite-field solo home run to make it 4-0. Brooks, who had a perfect day at the plate, was 3-for-3 and scored three times. In the third inning, Keldorf was hit by a pitch and scored on a ground ball by Finely Green.

Palos Verdes scored two runs in the fifth inning of McRoberts. Robert Slane's two-run double scored Jeff Goldean and Luke Simon-sen, who each singled consecutively to open the inning. McRoberts got out of the inning with two strikeouts and a routine ground ball.

In the sixth inning, El Segundo scored an insurance run Brooks singled and scored on an RBI single by McRoberts to make it 6-2. Brooks took the mound in the sixth and limited Palos Verdes to a couple of hits but got Ashton Rigg to ground out to end the game.

In the four games El Segundo played in the tournament, they had four starters who hit .600 or better, led by Brody Brooks (.818), Quinn Boehle (.800), Jaxon Kalish (.643), and Lucas Keldorf (.600). El Segundo advances to the Little League Section 4 Tournament starting July 16 at Palos Verdes Little League. They'll face the District 25 winner from West L.A. at 3 p.m.

10-Year Olds Advance to Championship

El Segundo fell into the loser's bracket but played Rolling Hills Little League in the loser's bracket final. El Segundo had already played a defeated RHLL earlier in tournament play, and the winner would advance to the District 36 final. El Segundo pounded out 11 hits and won easily 9-2.

Ben Baker led off the game with a double followed by a base on balls to Logan Meyer, and both ended up scoring. In the second inning, Mikey Fennell doubled to center field and scored on an error by right fielder Carter Oldham to give El Segundo a 3-0 lead.

El Segundo had a four-run two-out rally in the fourth inning. The inning was highlighted

Rolling Hills would slice into the deficit with a pair of runs to make it 7-2 but the locals went on to win 9-2.

The win sends El Segundo into the District 36 championship elimination game on Tuesday against Palos Verdes. Should El Segundo win, the two teams would play a winner-take-all game tonight at 5 p.m. at Lunada Bay Little League located at 2020 Palos Verdes Drive West.

Babe Ruth All-Stars

The El Segundo Babe Ruth League is hosting the District-2 13-15-year-old All-Star tournament. The four-team tournament starts today, with Hartwell (Long Beach) facing Westchester at 4:30 p.m. and El Segundo taking on Tor-rance at 7 p.m. The tournament runs through Sunday, with the championship game starting at 11 a.m. and if a second game is needed ap-proximately thirty minutes after the first game.

American Legion Team Looking Good

The El Segundo Blues, a team made up of returning high school players, has had a successful run in the Pacific League this summer. The Blues were 10-3 at one point and gearing up for their league tournament, with

the winner advancing to the American Legion State Tournament. Should the Blues advance, they would start their state tournament on July 22-26 at Pete Biden Field in Fresno. •

they inadvertently found themselves caught in the middle of an unexpected volcanic eruption. Although their love story ended too soon and their contribution to the sci-entific community feels incomplete, what they did leave behind is hundreds of hours of in-depth and deep archival footage, which director Sara Dosa weaves together fervently to create a sweeping portrait of two people passionately in love with science, nature, and each other.

"Have you ever loved something so much, you would sacrifice your life for it?" We're left to contemplate this stirring hypothetical question as we're led through the vividly rich life of French scientists Katia and Maurice Krafft. Voiceover narration is provided by filmmaker and performance artist Miranda July, who so sensitively captures the couple's self-proclaimed "outsider" and "weirdo" personas. From their first meeting in 1966 to the very last image before their untimely

death in 1991, the common thread throughout *Fire of Love* is the Krafft's commitment to curiosity and exploration, which overrode any sense of fear.

Katia and Maurice documented volcanoes from all over the world, capturing some of the most breathtaking images in the process. Dressed like extras from Wes Anderson's *The Life Aquatic* in light blue onesies and red beanies, Katia and Maurice are as goofy as they are brilliant, and were as close to soul mates as you can get (if you believe in

that sort of thing). Their shared passion to educate the world on these natural wonders enabled life-saving research. It would prove to be bittersweet, as that same unwavering passion and fascination with danger ultimately led to their deaths.

In telling the Krafft's story, director Sara Dosa took inspiration from French new wave films with fun and light-hearted editing tech-niques (Dosa makes volcanoes and science fun!). Aesthetically, *Fire of Love* looks like it was pulled from a time capsule from the

70s with its retro fonts and text color, and it totally works.

If Katia and Maurice were alive today, I'd imagine they would be absolutely humbled by the attention this documentary will bring to their life's work. It encapsulates everything they sacrificed their lives for: an unfiltered look at the unmatched beauty of volcanoes and the mineral world, and how connecting with the earth can help us connect with each other, too.
