Steven Gebhart: All His Chips Are in as the New Principal at El Segundo High School

For those invested in the El Segundo Unified School District [ESUSD], you may have noticed quite a churn of the folks who have occupied the principal's office at El Segundo High School [ESHS] in the near decade since principal Jim Garza was in charge.

Steve Gebhart, who was selected as the new principal earlier this year, hopes to stem the tide of that churn. Gebhart officially started drawing a paycheck from the District on July 1, and last served as the principal at San Pedro High School, a post that he ascended to in 2020.

Before working at San Pedro High, Gebhart spent a half dozen years as the principal at San Pedro's Dana Middle School, served a stint as the assistant principal at Los Angeles High School, and entered the education profession in 2000, teaching English as well as serving as an instructional coach at Gardena and San Pedro High schools.

While growing up, Gebhart did his initial schooling in Gardena. He is from a family including four siblings, all girls, with two older and two younger sisters dotting the family tree. "I had a pretty normal life," he said, which included playing some basketball, and reading, and going to school. "Just a kid growing up," he said.

When the high school years beckoned, he attended North Torrance High School. In between his graduation from North Torrance High and his enrollment at Cal State Dominguez Hills [CSDH], where he notched both a bachelor's and master's degree, as well as his teaching credential, Gebhart worked in the private sector for a decade for TRW, Inc., [now Northrup Grumman].

He started in the mail room and then

transferred to the company's project security office, where he utilized his communications talents to write and edit plans and give security briefings. After ten years on the job, Gebhart decided to pivot and return to school to enter the field of education. He initially wanted to be a police officer, but that was during the infamous Rodney King era. He decided that police work may "not be for me, but I still wanted to do something to help society."

He left TRW and enrolled at CSDH to begin the educational career pathway. In 2000, he started his career in the classroom, spending four years at Gardena High and eight years at San Pedro High. He then transitioned into

It was the desire to sustain and grow this specific, communal happiness that led Andre to embark on one of his first major career endeavors: starting a New



Denial, Deception and Disinformation

I have been leading Alzheimer's and dementia support groups for those in mild stages of the disease and/or their families for well over a decade. As many topics as are discussed, among the most prevalent are the contrasts and interactions of the two generational groups—the elderly parents experiencing the disease and the adult children supporting and caring for them. Often the argument that arises comes down to adult children not being fully in touch with the needs of their aging parents. While this is common in any group, it is greatly visible in families living with Alzheimer's disease or other dementias. I label this "The 3 Ds: Denial, Deception, and Disinformation.

Denying Dementia

Let's face it, it's human nature to procrastinate or avoid facing something uncomfortable, giving rise to denial. "The house untidiness and stacked papers are not so bad," "He seems OK and comfortable, just a little tired and bored," "She says she is eating fine and seems to have food in the refrigerator."

Acknowledging Dad's declining mental capacity and isolation means having to react, and that's where the fear comes in. What are we supposed to do? Is it premature? Are we denying what he has left of his independence? How are we going to coordinate all this?

Making matters worse, medical professionals can't really offer much hope. With Alzheimer's, there isn't a cure or remission. The best drugs currently available do little to address the causes of dementia and have limited effect on symptoms. No wonder denial is such a powerful weapon. Fear associated with the inability to resolve the issue may convince us that it's "not that bad."

Deception with Dementia

Mom also has tricks up her sleeve. From a practitioner perspective, we call this masking. Often fearing the loss of independence, or perhaps not wanting to bother her adult children, Mom doesn't complain about her condition, even though she is fully aware of it, especially in the early and intermediate stages. As her memory function begins to

What started in late February, with the first Little League game, ended in late July. The remaining youth baseball teams completed the baseball season. The 11-year-old all-stars competed for the Southern California State Little League title and placed third while the American Legion baseball team's state title run came to an end. It was an incredible run for El Segundo youth baseball at both levels.

ESLL 11-Year-Old All-Stars **Suffer Defeats and Place Third**

The run for a second consecutive Southern California Little League championship ended for this group of 11-year-old all-stars, most of who were a part of last season's state championship team as 10-year-olds. El Segundo

had defeated La Verne in their opener and faced Sherman Oaks in the second game only to lose an epic walk-off thriller.

Falling into the loser's bracket meant playing each day in elimination games. El Segundo eliminated Long Beach 6-3 and Eastlake (Chula Vista) 13-4, only to face Scripps Ranch (San Diego) and fall 7-4 in the elimination final.

The devastating loss to Sherman Oaks was a rematch between the two teams that competed for last season's 10-year-old state title. In last year's state tournament, El Segundo and Sherman Oaks faced each other three times. El Segundo won the first game 5-4, but Sherman Oaks came through






Check It Out

Realm Breaker by Victoria Aveyard

Realm Breaker, by Victoria Aveyard, is a fantasy book centered around a group of unlikely heroes working together to save the world from those who would seek to destroy it. Taristan of Old Cor, an heir to a fallen empire, is tearing open portals to dangerous realms long closed off from the world. Willing to destroy the world to conquer it, Taristan is raising monstrous armies and building up a dark power alongside them. The only person able to stop Taristan is his niece, Corayne an-Amarat, the daughter of an infamous pirate. Hunted mercilessly by Taristan's soldiers, Corayne and her allies must locate the rifts and close them before they destabilize the world beyond the point of no return.

I really enjoyed this book and thought it was a great start to the series. It was a little slow at times and suffered from a necessity to provide exposition on the world and

characters, but the overall story was great. What is set up as a classic good vs evil story becomes more nuanced as the villains are more heavily developed, and by the end of the book I was at a point where I would be happy with either side winning. There are 10 main characters, 3 of whom are the main villains of the story. However, there weren't an overwhelming amount of character perspectives throughout the book. Generally, there are only chapters from the perspective of a few of the characters, and the rest are just very important side characters. I thought the villains were so cool in this book, and I honestly liked them more than the main heroes. Taristan, the conquering prince, and Ronin, the powerful wizard, are the two main villains and the two people working to open the tears between worlds. Additionally, the book also sets up a few romance plotlines, one with the protagonist (of course), and interestingly, one with Taristan (I am looking forward to seeing where this leads). I highly recommend this book to any lovers of fantasy out there. It's worth the read.

SXSW: I Love My Dad: A Cringe-worthy **Comedy About a Catfishing Dad**

Of everything I watched at this year's SXSW film festival, I Love My Dad was among the best things I saw. I'm certainly not alone in feeling this way, as the film ended up receiving the Grand Jury Award (the top prize) in the Narrative Feature Competition.

I Love My Dad is an enjoyable indie comedy that's heartfelt and easy to connect with. This is saying a lot for a film with a very awkward setup, one that allegedly happened to writer-director-actor James Morosini. Franklin (Morosini) is a depressive high schooler who one day falls for a girl burned all of the emotional bridges with his son after a lifetime of no-shows and disappointments. Even though Chuck hasn't been there for Franklin, he still wants to be in his life, especially knowing his son's struggle with depression. What follows is a cringeworthy comedy in which Chuck creates a fake account as a way to reconnect with his son. While it's an insanely stupid idea, it's clearly stemming from concern rather than cruelty, which Patton Oswalt brings to the character with sad sincerity.

We see the beginning of normal Facebook messaging between Franklin and who he thinks is the cute and kind "Becca" (Sulewski), and watch the relationship build.

(Claudia Sulewski) who Facebook messages him out of the blue. Except, it's not actually her he's talking to, but his estranged father Chuck (Patton Oswalt) who's using a fake account to reconnect with his son after being shut out of his life.

It's a very "out-there" setup (and crazier still considering it's based on true events). For it to work in movie-form, though, the audience has to understand why anyone would do that to their child. Well-meaning but self-defeating dad Chuck has clearly Rather than simply see Franklin and Chuck type and read their messages to each other, Morosini makes the stylish choice to bring Becca into the room with Franklin, and their online dialogue plays out by occupying real physical space-it kind of feels like that, doesn't it?-on a rooftop, in the supermarket aisles. It jarringly cuts back to Franklin alone when we need to snap back into reality. It's a clever and engaging way to tell the story.

The problem with Chuck's plan, of course,

fail, she develops techniques to help herself. Seemingly simple devices like attaching keys to her purse or keeping numbers handy with birthdates next to the phone help the dementia sufferer immensely. Post it notes all over the house are the new tool. To the casual observer, Mom is only a little more forgetful than before. In reality, her short-term memory may be seriously compromised. Again, denial accepts the deception and life goes on without addressing the situation.

Disinformation about Dementia

When we finally come to terms and acknowledge the situation, we may see a need to address changes in lifestyle and care for our loved one living with cognitive decline; and so, we head straight for Google. For good or for bad, we will find a treasure trove of information. Not only can this be too much and too quickly, but there is not a guide on authenticity, reliability, or even relevance to our particular situation. Google doesn't know Dad. Google hasn't assessed Dad. Google is simply sorting search results based on our search terms. And once we start clicking, even more opinions will be pushed our way. Unfortunately, many are self-serving promotions pushing more information and even requiring email addresses. From what I hear in my support groups, everyone has been besieged by phone calls and offers of services, resulting in overwhelmness and, back into denial.

There is a way out of the cycle

The first step is acknowledging the issue at hand and the obstacles in solving them. Is denial clouding a realistic view of the situation? Is further communication needed? Intervention?

Even when we acknowledge there is a problem, acting on it can be difficult; in part because it is often that the person with dementia refuses disruptive changes in their lives. But changes do not need to imply "bad;" there are many good changes that could happen with the proper help, and these changes could benefit the entire family. Especially when safety is compromised, denial, deception, and disinformation are something we cannot afford. Support groups are available to discuss experiences with others that have walked this path. Reputable websites such as Alz.org from the Alzheimer's Association have a number of curated articles and resources. And a conversation with our loved ones might be in order.

the administration side of education, taking a job as the assistant principal at Los Angeles High in 2012 and then becoming principal at San Pedro's Dana Middle School in 2014. In 2020, he took over as the principal at San Pedro High.

When Gebhart was alerted to the job opening at ESHS, he investigated it a bit and after speaking with his wife, Luisa, decided to apply for the job. He said that after working 22 years in the Los Angeles Unified School system, he was intrigued by the idea of "continuing to broaden my skill set and knowledge of education," he said. Someone who should know is Dr. Melissa Gooden, who served a stint as principal at ESHS and is currently working for the ESUSD at the District office as Executive Director of Human Resources. "Steve and I worked together many years ago at Los Angeles High School," Gooden emailed. "When the

position became available, he immediately came to mind as a perfect candidate who exhibited traits that students, staff, parents, and community members identified as being important qualities of the next principal.

"Steve is a seasoned administrator that understands the intricacies of running a to excel under Mr. Gebhart's leadership."

ing. He works on behalf of the kids, and the teachers, as well."

Rodney Lusain, who has known Gebhart for a decade, said that one of the traits that make his friend a successful administrator is that "he does a better job of any principal that I have ever worked with of shielding teachers from the bureaucrats, giving his team space to work. He trusts his teachers and his staff to do what they are supposed to do."

Gebhart said his over-arching educational philosophy revolves around relationship building. "Everybody has the ability to be their best," he said, "but not everybody can be their best," he added, citing mitigating factors. "But if [students] are in a place that values and validates who they are, then they will be able to perform at their best."

If you want to meet the new principal, the District will be hosting a "Coffee with the Principal" event on Aug. 11, which will take place in the campus cafeteria from 9 a.m. to 10 a.m., a few weeks before the resumption of classroom activities in the District. Participants will also be introduced to the 2022-23 ESHS administrative team.

For recreational activities, Gebhart said he cherishes family time, especially hours spent at the beach. He is an avid poker player, taking part in local poker games with friends, with the occasional foray to Las Vegas in the mix. It would not be a shock to see him participate in the El Segundo Education Foundation-sponsored Guy's Night Out shenanigans, which, I believe, have in the past entailed some card playing as well as sipping adult beverages.

Gebhart is looking forward to greeting his new charges as they settle into their classrooms on Aug. 23.

And to use poker vernacular, Gebhart seems to be pushing all his chips to the center of the table as he begins his tenure at El Segundo High School. •

Orleans-themed music festival in Rio. "I didn't know a lot about music, but I had a sense of what people liked," he explained. The festival, featuring a variety of Jazz and New Orleans grass bands, encouraged people from New Orleans to come together with people from Brazil and make music, producing new, collaborative sounds with their distinct musical styles. Running for several years, the festival eventually expanded to a small island in Brazil and Colombia.

"The festival was fun," Andre explained, "but not great for establishing a long-term, sustainable career."

After a few years, he moved back home, living part-time in Brazil and New Orleans. At this time in his life, Katrina hit, forcing him to consider relocating. He decided to move to Los Angeles, where he got a job at Sony Pictures in the International Media Department, where he worked for one year. After that, he transitioned to a career in advertising and sales, selling television slots to the same people he used to work for. He found the job nice and comfortable, but not terribly fulfilling.

It was around this time that Andre's old boss from Sony suggested he come to become a therapist. He thought it made sense. "I'm really interested in people and their stories," he said. Andre decided to go back to school, enrolling in Phillips Graduate University, all the while still working different jobs in media to support himself.

Upon completing his degree, Andre began working with Miracle Mile, specializing in low-cost counseling. When they opened an office in El Segundo, Andre started working there, eventually branching off to start his own practice with former colleagues.

Andre also works as the advice columnist for the El Segundo Herald, where he responds to anonymous queries related to personal and communal issues. He enjoys the position, seeing it as another way to connect to the community around him by trying to make people less unhappy as best he can.

Questions of identity, purpose and meaning sit at the forefront of his approach to therapy and counseling, as he believes that people constantly wrestle with these subjects throughout their lives. "Who am I, what am I about, why am I here, why am I doing the things that I'm doing? I don't know that we always have perfect, neat answers we can tie up with a bow, but I think the process of wrestling with these questions can help bring people a lot of peace and direction in life," he explained. "Saying I'm okay with imperfection can be really helpful to people." Andre also discussed the importance of being comfortable as things in life change and evolve. "Not feeling alone in the discomfort is extremely helpful."

According to Andre, this element of not feeling alone, and having a community of

support around oneself, is a vital part of personal growth and happiness. "Talking to people and seeing their experiences of doing amazing things in their lives and still feeling that they're not measuring up in some way ... if so many of us feel this way, maybe it's okay," he explained.

When asked if he had any advice for how people can better themselves, he said, "Assess how happy you are with your community and the people around you, because that makes a huge difference." He also expressed from front page

some hesitance with using the word 'mental health' when discussing personal growth and development, as he believes the word is often misused. "We focus too much on people 'working on their mental health when the first question we should ask is: have they suffered a mental injury?" By which, he means it is more effective to assess the circumstances surrounding the situation and the emotions it produces before diving in head-first to try to fix it. That, he explains, often neglects the issue entirely.

He also addressed some common misconceptions about therapy. "I grew up with this idea that you're gonna have to talk about your deepest, darkest, craziest thoughts and feelings in therapy, and it's not like that. It's not scary," he said. Andre also spoke about the difficulties of reaching out for help, specifically for men. "As a man, I get it, you know. It's a thing." To any men reluctant to get the help they may need, Andre suggested exploring alternative counseling methods, such as text or email, which may seem less confrontational than an in-person or phone session.

Above all, Andre is dedicated to doing what he can to make people happy or less unhappy. "At the beginning of my career, I decided to try to increase the total amount of happiness in the world, so I created a music festival. Now, being a therapist, I'm happy to work on both sides of that equation." •

is that the longer Chuck continues the rouse, the stronger Franklin falls for Becca. In a high-stakes and inevitable move, Franklin decides to meet Becca. Who else decides to drive him, but his nervously sweating father, Chuck. I Love My Dad takes it to the actually cringe-worthy lines when Franklin and Becca engage in deeply intimate messaging, leading to a climax involving Franklin and his dad-locked into continuing the facade-making for an awkward next morning.

Beyond being an enjoyable comedy, what makes the film emotionally engaging and smart is that Morosini doesn't overdo these deeply


