



# **"Poppa" Craig Parker was an El Segundo Legend**

When I spoke with Patrick Bentley recently, one of the takeaways that seemed to sum up the life of El Segundo's Craig Parker, who passed away from dementia on July 15 at the age of 76, was that Parker and wife Joan were, in his opinion, "Mr. and Mrs. El Segundo."

Bentley said that he has lived "around here" since 1986, and "I have never experienced people who were so involved in the community." Bentley said the Parkers got him immersed in the El Segundo scene, dragging him to Friday Night Lights high school football games, as well as encouraging his participation in the El Segundo Education Foundation,


Bentley knew Parker for 20 years, as he was coming to town in 2001 to take part in the building of a studio on Main Street for comedian Roseanne Barr. Bentley said that Parker, an electrician by trade, lived right behind the Barr building on Main Street, the soon-to-be christened Full Moon and High Tide Studios."Roseanne loved her some Craig," Bentley said. "Craig could crack her up, which is saying a lot." Parker "helped me to navigate the community," Bentley said, helping me to "put the (Barr studio) together." Bentley noted how the Parkers were instrumental in upgrading or establishing multiple El Segundo facilities, including the high school football field, the Military Entrance Test Site on Grand Avenue, and the Whole Foods establishment located on PCH. Parker lived at 419 1/2 Standard Street for 34 years and was always involved in El Segundo activities until his onset of dementia two years ago. One of Parker's daughters, Jennifer Parker Fogg Lickteig, shared that she had gone through his garage recently and found "tons of photos," including those of Parker hanging lights on Candy Cane Lane, painting handprints on

"Handprint Alley" on the west side of Main Street. A trove of mementos was in the house, from "city accolades" to letters from prior El Segundo mayor's.

Parker was considered a go-to guy by El Segundo civic leaders, who would often beseech him to lend a hand when the city had a need or a possible project in the works."And Dad would do it," Jennifer said, whether it be something needed by the city, or the fire department, or the police department. Parker would secure whatever was needed and then donate it to the city.

Jennifer said he helped set up the initial version of the Farmer's Market. "Most notable for me," she said, "was that when my Dad's

## **Kimberly Bredberg Explores Alternative Learning Methods for El Segundo Students**

The public school system in El Segundo is notoriously renowned. El Segundo high school ranked in the top 5% of high schools in California for math proficiency and reading proficiency, and the graduation rate is top tier. But what if the traditional method of learning doesn't work for your child? Standardized teaching methods have worked for decades, but what happens to the children who don't work well under these methods? This is a question Kimberley Bredberg set out to explore for her own child in the form of a new K-12 microschool called Waterhouse Guild.

A mother of four children, Bredberg's present journey began with her oldest daughter in the first grade. "My daughter was a super curious and precocious first-grader," says Bredberg. Her daughter was in a classroom of only eight students at a school Bredberg worked at in San Luis Obispo. Having a heavily pencil-and-paper policy at home, straying away from electronics, her daughter was already very versed and excited about reading and writing. The problem, she explains, was that her teacher would not let her read above the first-grade level.

"That made me so sad, because at the time she was reading at a high level, chapter books, and she would sit on the swing with a book in one hand and a slice of watermelon in the other," she says. So, in the transition to second grade, she pulled her daughter out of her school and decided **See Kimberly Bredberg, page 4**

## **Little Leaguers Win State Title and Babe Ruth All-Stars Fall in Regionals**

The El Segundo Little League All-Stars traveled to Imperial Beach and won the Southern California 8-10 State Championships. The El Segundo Babe Ruth League's 13-15s, 14s, and 13-year-old All-Star teams traveled to their respective Pacific Southwest Regional tournaments in hopes of winning and advancing to their individual World Series'. The teams were treated like royalty, and each of the teams won their opening round games. They went through the winner's bracket before getting derailed, falling into the loser's bracket. It was an unfortunate coincidence, but each team was eliminated on the same day.

## Little League All-Stars **Celebrate their Historic Southern** California Championship

A team of fourteen 8-10-year-old all-stars was El Segundo's surviving Little League all-star team after the 11s, and 11-12s were eliminated in their District tournaments. So after winning

their District 36 and Section 4 tournaments, El Segundo traveled to Imperial Beach to play Southern California's best in this age group. El Segundo won their first two games against Sherman Oaks 5-4 and Park View 6-0.

In their third game, El Segundo jumped on Orcutt National Little League (Santa Maria) early. With one out Lucas Keldorf's two-run double and Declan McRoberts' fielder choice, which scored Jaxon Kalish, gave El Segundo a 3-0 first inning lead. El Segundo hung on to that lead until the sixth inning when Quinn Boehle's single to center scored Finley Green and Benny Baker to give his team a 5-0 lead. Max Baker and Finley Green combined to shutout high scoring Orcutt and gave up one hit, two walks, and together struck out six.

In the winner's bracket final, El Segundo took on East Hills Little League from Yorba Linda. Timely hitting by Benny Baker's bases loaded two-run single, and Quinn Boehle's bases clearing two-run triple gave El Segundo all the runs they needed in their 4-0 win. McRoberts and Green combined to shutout East Hills and looked dominating at times.

El Segundo faced Sherman Oaks in the championship final and fell 5-2 to the same team they had defeated earlier in the tournament. Sherman Oaks used two two-run home runs to help propel them into a championship game. El Segundo's Jaxon Kalish pitched well enough to win by giving up five hits; unfortunately, two mistake pitches cost him.

In the championship game, that was streamed live to the Standard Station, as was each of the other games El Segundo played. A large contingent from both El Segundo and Sherman Oaks showed their support for two of the finest teams in this age group in Southern California. Costly errors by Sherman Oaks and great pitching by El Segundo propelled El Segundo to their 2-1 win. According to manager Danny Boehle it was the league's first ever State championship.

Sherman Oaks took a 1-0 lead into the fifth inning. Logan Meyer reached on a throwing error, and with one out Brody Brooks reached on a fielding error. With two outs, Jaxon Kalish was intentionally walked to load the bases. Quinn Boehle worked an RBI walk to tie the game 1-1. With Declan McRoberts at the plate and Benny Baker on third base, Baker waited for his opportunity to score. When he saw the pitch bounce away from the catcher, he used his speed to score on a wild pitch on a close play at the plate to give El Segundo a 2-1 lead.

Finley Green started and tossed 4.1 great innings before Brody Brooks came in relief and shut down Sherman Oaks the rest of the



way. Together they allowed just two hits to ensure El Segundo's historic win.

The State champions included Manager Danny Boehle and his assistants Tim Abrams, Edie Lee, and Rob Green and players Benny Baker, Brody Brooks, Colby Lee, Crew O'Connor, Declan McRoberts, Ethan Mooney, Finley Green, Jaxon Kalish, Lennon Salazar, Logan Meyer, Lucas Keldorf, Max Baker, Quinn Boehle, and Charlie Hedding.

## 13-15-Year-Old All-Stars Fall in Regional

El Segundo traveled to Bakersfield to play in blistering hot 100 plus degree conditions. Playing on a field with diminutive dimensions, the locals overcame an early deficit and then hung on for a 4-2 victory over Madera, the Central California champion. Dominik Kopecky started on the mound and gave up two first-inning runs. He was replaced by James Baldino, who came on in the third inning. He kept Madera scoreless until hard-throwing Max Martinez replaced him in the fifth inning with one out. See Sports, page 11







to experiment with homeschooling.

Her methods appealed to many parents going through similar struggles with their children. So about twenty years ago, she began developing Waterhouse Guild, a micro-school program with roots in homeschooling based here in El Segundo. The idea was to individualize education while still requiring rigorous academics, all based around the humanities.

experts in their field, be it chemistry or art, or music. "I think one of the sad things happening in our culture is that we seem to think that children have short attention spans when they really don't. I sometimes feel like two hours for science isn't enough," Bredberg laments, explaining her choice to go with longer learning periods. Of Bredberg's multiple degrees, she has

a particular love of science, in which she

Though all academic fields are studied in the program, Bredberg specifically wanted to focus on reading, writing, and critical thinking. Along with her other business, a publishing company, Bredberg and her team developed their own language arts curriculum. Class periods are in longer blocks to encourage focus and allow subjects to be fully explored. Teachers are

obtained a degree. Because of her experience in the field, she sought to find a way to make science more integrated and taught with context so that each subject wouldn't be taught in a vacuum with no relation to other courses or real-world application. She uses the human body as an example, explaining that it isn't only related to biology but also to chemistry, physics, and electricity. When a child comes out of school and into the working world, she says, science isn't segmented and separate like it was in school. So to her, it's important to teach children from a young age the way they'll be interacting with subjects outside of school.

Parent Josette Murphy describes her child's experience with math at Waterhouse Guild. Having gone to public school for a few years, her daughter was doing relatively okay in math but struggled to switch over to the Waterhouse method. Her teachers immediately saw the holes that needed to be repaired in her understanding of mathematics and asked that she stay an hour extra a week to work one on one with them. After going back and getting a firm understanding of past ideas and how they correlate with current lessons, her daughter felt comfortable moving on to the next level. This kind of individualized help to ensure a complete understanding before leveling up came from Bredberg's own experience in math.

Despite having a background in science, Bredberg describes math as her "arch-enemy" all the way up into high school. In the traditional system, students are required to finish each math level, but this doesn't always give them a firm grasp of all the concepts. Bredberg finally went to a teacher and just started crying because she couldn't understand what she was missing. This teacher sat down with her and figured out where the holes were, and worked with her until she could not only finish but understand the work required to pass her current course. This experience led to extremely considerate math teaching in her program. Another Waterhouse parent, Christa Engelskirch, also describes the soft skills side of the school. One of the things she loves about this alternative teaching style is the focus on practicing compassion and mastering empathy. "We can offer opportunities for children to problem-solve on their own, and not have to feel bad just because there is a squabble going on in the corner of a playground," she says, "Whether it's an error in judgment or their emotional maturity is just not quite there yet, it's not a punishable offense. It's a teaching situation." Bredberg built her school on a three-prong system: the spiritual (it's a non-denominational Christian-based school), the intellectual, and the social-emotional. She wants every child learning under her program to be cognitively present and recognize their value as a human being. She leaves on a hopeful note: "If I have any goal for Waterhouse Guild, it's that we can look at Waterhouse and we can change people's minds about the potential of education for younger children. And I think that we can, because we've already been doing it." •

health was declining, a lot of people helped him. My sister and I both live out-of-state," she said, so they could not lend a hand in caregiving as Parker's health deteriorated. Neighbors would pitch in and help "bailing my Dad out of situations," she said, as Parker's dementia worsened.

"He was such a great guy to everyone, and then dementia got ahold of him and changed his personality," Jennifer said. "He became angry and defiant, and kind of took it out on a lot of people, which was really hard to hear, because he was so giving," but after about a year, he was "cussing people out," yet the townspeople treated him with so much grace... he walked everywhere...then when he couldn't walk, we got him a tricycle, which he rode all over the place... The fact that the city took care of him is really a big deal." Over his final years, Jennifer said that her father "got into a fair amount of trouble. It was amazing that he was at one point recognized as Citizen of the Year!"

Parker went to work in Saudi Arabia in 1978, serving as a cost and scheduling engineer for the Fluor company. He returned to the states in 1982, and Joan, who he had met during his tenure in Saudi Arabia, followed him to America. The couple was married in 1985.

Parker moved to El Segundo on July 1, 1988. He loved the Fourth of July, Jennifer said, and he would stake out a spot at Rec Park to watch the iconic fireworks show. A member of the U.S Marine Corps from 1966-68, he never missed a Fourth of July show, always ensuring that he was in town on that special day.

As an electrician, Parker worked at Wise Electric until his retirement. He also served stints working in the television industry, toiling as a grip or key grip on a couple of television shows that you may have heard of, including M\*A\*S\*H and the Mary Tyler Moore show.

Parker loved the Christmas holiday season, lights, festivities, and the December parade down Main Street. In days gone by, El Segundo featured a Santa's Village in the area in front of City Hall. At that time, Candy Cane Lane had not been officially branded, but, Jennifer said, was "just a bunch of neighbors who did an excellent job with their lights."

Jennifer said that, sometime in the '90s, the city decided that the annual Candy Cane Lane extravaganza could benefit from a publicity push from the city. Talented electrician Parker was tasked with running the electrical gizmos that would make Candy Cane Lane a virtual power strip that the City of El Segundo could light up for a few weeks, drawing in non-residents to view the spectacle.

Parker didn't stop his civic involvement there. One of the early organizers of the Main Street "circle stones." Parker bought at least three of said stones. Two of which are located outside of his beloved Wendy's Café, where he took breakfast as often as possible. The other circle

stone embedded in the sidewalk on the west side of Main Street marked the spot that he and his family members would settle down to watch the annual Christmas Parade.

A tad bit to the north, Parker has his handprint memorialized in what might be termed "butterfly and handprint alley," which is located between two Main Street buildings. Jennifer said that Parker took it upon himself to repaint the signatures on the wall periodically.

With a keen eye on his El Segundo neighborhood, Parker would venture across Main Street to do a little gardening, cutting the grass at what is now Library Park, if he thought the grass was growing a little too tall. He also spent a good amount of time tidying up Main Street, picking up trash, and pulling weeds the day before the Christmas Parade, manned with his trash bag. Jennifer said that her father termed his duties "spiffing-it-up." Then when the family arrived, Parker would have their viewing spot set up, on their circle stone, with chairs. Over the 25 years or so, Parker would participate in the parade and drum up support for participation by others in the parade.

"He was Christmas," Jennifer said, mentioning how Parker was "always buying Christmas décor, stringing things up," and when the Santa's Village started to need a refresh, was always a guy who you could count on to take the time to "paint something, make it look better."

A Morningside High graduate in 1963, Parker



was an accomplished pole vaulter. After settling in El Segundo, he took advantage of the blue waters of the Pacific Ocean, surfing and boogie-boarding. He also had a standing tee time at The Lakes Golf Course on senior day and was a member of the El Segundo senior tennis player group.

In his later years, Jennifer said that Parker "broke a lot of clubs" on the golf course and seemed to remember brilliant shots, like a hole-in-one, that nobody else in his group could remember happening. And she shared that, eventually, Parker was banned from the tennis courts for his John McEnroe-ish bombastic behavior. "Dementia sucks; it just changed him," Jennifer said. "It is such an indignity to a strong man, with a strong spirit, like my Dad."

Back to his visits to Wendy's, "Most of all, Dad was a regular at Wendy's," wrote Jennifer. "He took breakfast there about three times a week for 33 years, as well as eating fish on Friday's." He met Wendy Wallace more than 30 years ago. It seems Wendy noticed Joan Parker's British accent and came over to chat with the Parkers, with Wendy being a Brit ex-pat and all.

"The first time (my parents) went to Wendy's," Jennifer shared, "Wendy said she loved my Mom and tolerated my Dad." Towards the end, "it seemed to be the only place that he could remember to get to. Wendy's was his touchstone. Countless times he would show up, and they would serve him, even though he may not have been in any shape to be served. They brought him home dozens of times. I am convinced they kept him alive longer than he would have survived by feeding him a daily meal. One of the hardest things I had to do was place my Dad's picture on the shelf above the cash register (where Wendy's stalwart customers who have passed are memorialized). I can remember all of the faces on that shelf, remember all of them aging, too, sitting at that counter, probably for their one good meal of the day---slugging each other's arms passing by, or just a nod as another 'old guy' sat down."

Jennifer was emotional during our phone call when talking about how the staff at Wendy's would always go far above and beyond to take care of her father. They took care of him when he suffered a bike injury, crashing across the street from Wendy's. And didn't create a ruckus when, in his final years, Parker would forget to pay his tab at Wendy's.

April Shevlin is a long-time waitress at Wendy's. She related that she, wink-wink, did not want to share certain, probably ribald, stories about Parker, but did text that "one of my biggest and fondest memories of him was when he played Santa at the tree-lighting ceremony. He was perfect for it (with his big belly and great laugh). I remember when he and Joan got Citizens of the Year," Shevlin texted, calling the moments she spent with Parker "always a good time, that laugh was the best!!!"

Over breakfast at Wendy's, one of Parker's granddaughters, Sarah, who called Parker "Poppa," related a story that sheds some light on the man. It seems she was 13-or-so, and Parker decided that it was time for her to learn to drive. Now, they were in Oklahoma at the time, which is where his daughter Jennifer lives. And the roads are a tad bit less congested than the mess that is our 405. Anyway, the barely aged teenager started barreling down the highway, with Parker riding shotgun, paying not-so-much attention to nascent driving skills, as he was more interested in sipping his Scotch and reading a book. However, he did glance over occasionally and advised Sarah of the necessity of gently tapping as opposed to stomping on the brakes when a stop or slowdown was required. It all ended well. Sarah and Parker survived the erstwhile driving lesson. Sarah said that the driving excursion epitomized her grandfather, saying that he was "born with the fun button stuck in the on-position." He was the ultimate good-time Charlie," Jennifer said. "He always made time for fun and lived at full throttle his whole life." Seems like a life well-lived, though cut too short. •
