Dale Snowberger is not Ready to Ride-Off into the Sunset

El Segundo resident Dale Snowberger is gearing up to celebrate his 70th birthday on August 16. So, is Snowberger going to sit back on a porch rocking chair, gaze out indolently at the comings and goings in his neighborhood, incessantly check his mailbox, and await the arrival of his next Social Security check?

Nope.

Because August 16 falls on a Monday this year and happens to coincide with one of Stoneberger's off-work days, who knows how he will celebrate his first day as a septuagenarian? But you can bet he will not be lollygagging around.

During our phone interview, the owner of the El Segundo Tonsorial Parlor, located on the west side of Grand Avenue, under the Grand Hotel, said that his two daughters, Christin, and Meghan, had been planning a surprise birthday party to mark the occasion. But with the advent of stricter COVID-19 mandates and the uncertainty of holding celebratory gatherings, it looks like his upcoming birthday will be noted with the sitting for a family portrait and a catered dinner.

If his birthday had fallen on a Tuesday thru Saturday, there is a good possibility he would have spent the day cutting and styling hair. Even as he approaches seventy, Snowberger said that he has no intention of retiring.

Asked how long he might continue working, he said, "until they tell me to step away from the chair." He mentioned that at the advent of the COVID lockdown 17 months

or so ago, and subsequent shuttering of his business, he looked at it as an opportunity to take a long-deserved vacation.

But as the lockdown stretched into a second and third month, Snowberger said that he realized how much he missed the daily interaction with his clients. He said that his first thought was that he missed the social aspect of hair-cutting and then concluded that "I also miss (the clients) money!"

So, what is a 'Tonsorial Parlor?' One definition: "A tonsorial parlor is an inner

sanctum where a man can receive the highest level of barbering services in a setting that compliments this ancient art. ... Barbers of former times were also surgeons and dentist, called barber/surgeons." And, yes, women too can have their styled inside the "sanctum" of the Tonsorial Parlor.

So, what is Snowberger's back-story? He grew up hunting and fishing and schooling in rural Ohio. His brother, Ronald, who was 17 years older than Dale, somehow ended


After graduating in the top four of her class in college, she jumped straight into

An Overview of Portal Schools

Last September, in my fifth column, "Schools of El Segundo," I focused on the growing number of high schools in this City. I noted that in the last fifteen years, high school options had increased from two (both ESUSD) to seven. Four of the "new" high schools are charters (see the column in 9/17/2020 Herald) opened by the independent Da Vinci Schools Board and authorized by Wiseburn Unified School District (the majority of Wiseburn's territory is in the City of El Segundo, although there are no residents allowed east of Pacific Coast Highway). The seventh high school option in El Segundo is a private or independent high school named Vistamar.

Beginning in the 2021-22 school year (this August), the eighth high school option is opening in El Segundo. Portal Schools, a new non-profit independent high school, will open its doors to a founding 9th-grade class. Portal's model presents a new opportunity for students and families, as it is quite different than the other high schools in the neighborhood. As a private school, Portal families will pay a modest tuition, which varies by scholarship and need.

Portal Schools' first site will be embedded within Belkin International, the leading global technology company that recently announced its move to El Segundo. Portal plans to add additional sites around greater Los Angeles in the coming years, all situated on corporate partner sites across a range of sectors. Each individual site will be a micro-school comprised of 60 or fewer students. Through this model, Portal students will benefit from small campuses with a high degree of personalization and leverage the larger network of campuses and corporate partners.

Lars Nootbaar Flying High for St. Louis Cardinals

El Segundo has had its fair share of professional athletes attend El Segundo high school over the years. We've had an NHL player, a couple of NFL players and General Manager, and a couple of professional basketball players. But the sport El Segundo is most famous for is its contribution to baseball at the professional level. Whether playing in an Independent League or on a Major League affiliate roster, our town has sent over 50 players to the professional level.

Eight former Eagles have played or coached in the Major Leagues, including George Myatt (player 1938- 1947 and coach 1950-1974), Kemer Brett (1967-1981), Bobby Floyd (player 1968-1974 and coach 2001-2004), George Brett (1973-1993), Scott McGregor (1974-1986), Zak Shinall (1993) and Billy Traber (2003-2009).

You can add Lars Nootbaar to that list now. The 2015 graduate was selected in the eighth round of the MLB amateur draft by the St. Louis Cardinals. His meteoric rise through the minor league system made him St Louis' first 2018 drafted player to make an appearance in a Major League game, and that took place on June 22.

Nootbaar has always been a gifted baseball player who has always played the game the same way. He led his Little League All-Star team to its best-ever finish and was within one game of leading that team to the Western Regional in San Bernardino. He led his Babe Ruth All-Star team to a third-place finish in the World Series and won the batting title

as a 14-year-old. And, he was named to the All-State baseball team as a senior in high school. Then he played three years at USC, where he won more accolades.

Nootbaar's name has been a topic of discussion from St. Louis fans wanting to get a glimpse of the young 23 years old and who

turns 24 in September. He was promoted to the Cardinal's Triple-A affiliate before the season after missing out on last season altogether because of the Covid shutdown. He was one of a select number of non-roster players who were invited to spring training with the parent team. He impressed with his work ethic,

athletic ability, and performance in spring training games. He was added to the team's Alternate Training Site or more commonly known as the taxi squad, to start the season.

For Lars, this is his third full year of proball, and he says the difference between Aball and AA-Ball is the talent gets better. He says he learned a lot his first year when he was sent to State College, PA, to play in the New York-Pennsylvania League to play for the Spikes. His next season, in 2019, he was on the move playing for the Peoria Chiefs of the Midwest League, then on to the Palm Beach Cardinals of the Florida State League. Before the Palm Beach Cardinals' season ended, Lars was promoted to the AA Springfield Cardinals, where he continued his success as an outfielder hitting .270.

"When you're playing baseball or any sport for that matter, it's all in how you handle adversity between the ears," he says.

Being invited to the Major League spring training camp was something Lars says, it was a pleasant surprise after sitting out all of the 2020 season. "When Covid canceled our season last year, I got a job that humbled me and made me miss baseball even more. So, I worked out when I could so I would be ready when we'd start up."

When Lars first walked into the locker room at the Spring Training facility at Roger Dean Chevrolet Stadium in Jupiter, Florida, he says he tried to play down his emotions. "On the outside, it was like business as usual. Inside I had some nervousness, but I kept telling myself I belonged here, and it's the same game I've always played." With the iconic Cardinals logo sprayed across the chest and the number 91 on the back, with his last name above the digits, the anxieties went away when he saw his uniform hanging in his locker.

When spring training camp broke, and the Cardinals were headed to St. Louis, it was then that Lars was notified he would be one of three outfielders on the Alternate Site roster. This roster included 13 pitchers, two catchers, three infielders, and the outfielders they would work out in the mornings at an alternate field site. Lars said that he was fortunate to attend Opening Day at Busch Stadium and admits to having some goosebumps. "I'd never been to an Opening Day, so it was pretty special.

Lars started the season at Memphis, the Cardinals Triple-A affiliate. Regarded as having one of the organization's top outfield arms, Lars was off to a great start with his bat leading the team with a .329 batting average. He said he got a call from his manager Ben Johnson, informing him he was being promoted to the Major League team. Then he received a phone call from Mike Girsch, the General Manager of the Cardinals, giving Lars the news every ballplayer dreams of getting.

Lars said, "I was surprised at first, and when the shock wore off, I had to tell my mom and dad, but they were celebrating their Thirtieth Anniversary in Tahiti." He continued, "The next person I thought of was my brother, and we Face-Time the call." Lars says he had an emotional exchange with his brother, Nigel. He said, "Nigel led the way for me to be here. He was the person I always looked up to; he was my hero growing up."

Walking into a Major League locker room can be a bit intimidating for a young rookie. Lars said he felt some anxieties but said he'd already made friends with most of the Major Leaguers during spring training. "They were all very nice and made me feel like I belonged," Lars said any trepidation quickly went away when he got to his locker. "I thought that some of my teammates are future Hall of Famers, and we all have the same job to do."

Lars says he's been asked about the number 68 he was given and said he had nothing to do about getting that number. He says his friend, Mike Bundy, wore number 6, and he wore number 8 in high school, but that's as close to any relevance to the number as he could come up with. "It's my favorite number now, though."

Lars has had plenty of support from the veterans on the team during Spring Training and during his call up. "Tommy Edmunds, Dylan Carlson, Yadi (Molina), Goldie (Paul Goldschmidt), and Nolan (Arenado) have all helped me."

Lars got his first Major League start against the Detroit Tigers at Comerica Park in Detroit. Though his parents couldn't get a flight to Detroit, his brother Nigel and his sister Nicole and friends, including Lars' longtime girlfriend Susana Kalish, Max Mendoza, Jake Palmer, Toni (Jake's girlfriend), Linnea Palmer and Ollie Linton (Lars' agent) were there to see history.

Before his first at bat, he said he was getting advice from some of the veterans like future Hall of Famers Yadier Molina and Nolan Arenado. The home plate umpire for the game is another future Hall of Famer, Joe "Cowboy" West. He has been umpiring for








Check It Out

How Beautiful We Were by Imbolo Mbue

There are times as a reader you begin a book and it grabs you by the throat. It is a magical experience to be drawn in by those first flawless sentences. How Beautiful We Were by Imbolo Mbue is one of these. "We should have known the end was near. How could we not have known?" So commences a journey of heartbreak, joy, pain and suffering, courage, rebellion, triumph, resilience, acceptance, love and death.



How Beautiful We Were by Imbolo Mbue.

Set in the fictional village of Kosawa in Africa during the 1980's, the population is devastated by the environmental effects of oil drilling by a foreign corporation welcomed by the governing body in return for monetary riches. This small, remote community is kept alive through the faith and belief of its members. Ancestral legend describes them as the sons and daughters of the leopard, descendants of a fierce warrior tribe. But this is not a foe to be vanquished by physical battle. "The sky began to pour acid and rivers turned green. We began to wobble and stagger." The death toll mounts while The Representatives from Pexton, the oil drilling company, keep assuring that all will be well. Of course, it will not.

Shockingly, it is the village madman Konga who confronts The Representatives – The

Leader, The Round One and The Sick One -- and a rebellion is born. The events that follow tell the story of the community whose families have lived in Kosawa since ancient times and their struggle to remain. This is their home and they refuse to leave. Everyone is connected and despite disagreement, they will stand together and fall together.

At once heartbreaking, thrilling, and tense, the saga plays out over generations and decades but feels so immediate. In beautifully written prose, the narrative of various tribe members is woven together to form the whole. At the heart of the community is Thula, a young woman who is bright and determined to do whatever she can to save the village. She becomes the catalyst for the hopes and dreams of the Kosawa tribe in expelling Pexton, forcing them to clean up their mess and restoring the land and river to the people.

Although it is set in the 1980's, this is a lesson for today in the fight against corporate malfeasance and political corruption. Detailing the environmental effects and resulting health issues of drilling for oil, careless of the destruction wrought upon people and the earth, this novel enlightens the reader to the devastating personal consequences of greed.

Imolo Mbue is a native of Cameroon and has a PEN/Faulkner Award for Fiction for her New York Times bestseller Behold the Dreamers.

Film Review

Homeroom: Capturing College and Covid-19 Anxiety

2020 was a challenging year for all of us but it was especially hard for high school seniors as the expectations of lavish graduation parties, prom dresses, and college-bound dreams were dashed in a matter of days. From director Peter Nicks and produced by Ryan Coogler, *Homeroom* - premiering on Hulu on August 12th - follows the 2019-2020 class of Oakland High School seniors as they attempt to create systemic change and leave a lasting

legacy in their hometown while adjusting to life in a pandemic.

Homeroom feels very much like A24's Boys State in the way it captures intimate and vulnerable moments from impressionable and impassioned teenagers. Sticking to his signature style of vérité filmmaking, Nicks observes a handful of students as they prepare to submit college applications, sit through mundane history lectures, attend various club meetings, and rehearse for the school play.

The documentary begins in the fall of 2019, pre-pandemic, when the biggest topic of conversation is the ethics of policing in schools. Students want to defund the police, citing that implicit bias sparks unnecessary fear, especially in predominately black and brown schools like theirs. Their arguments are articulate and strong, appealing to

city council members and school board members alike.

The film takes a turn with the introduction of COVID-19 in early March 2020, picking up a sense of urgency that differs from the more structured first Act. As *Homeroom* shows, the seniors of today are highly adaptable, goal-oriented, and inspired teenagers. They use their iPhones not just to create TikTok videos, but also to catch up on the latest from ex-President Trump's first impeachment trial. They're paying attention. They don't fear speaking up to authority figures; instead, they see teachers and faculty as their allies who share a common goal of unifying the school district in harmony.

From the everyday pressures of high school life to the unexpected introduction of COVID-19, Nicks lets the action and drama unfold onscreen without provocation, capturing a year's worth of trauma that is uncomfortable to relive. The murders of George Floyd and Breonna Taylor, "murder hornets," and the racially-charged murder of Bay area teenager Nia Wilson are just some of the devastating events that this class has had to navigate through.

Homeroom proves that the youth have the power, and fostering safe environments for them to grow and learn will be key in creating tomorrow's leaders. On a personal yet somber note, the film is dedicated to Karina Nicks, Peter's 16-year-old daughter who died suddenly in September 2019. As the final installment to Nicks' three-part trilogy of character-driven social issue films, Homeroom is a gratifying and inspiring ending to this chapter on Oakland, CA. •

Tips For Coping With Heartburn

(BPT) - If you've ever experienced heartburn, you know why it's called that - you feel a burning sensation in your throat and upper chest, and even a bad taste in your mouth. While heartburn can have many triggers and causes, it is essentially due to the backward flow of acid, called acid reflux, when the muscles controlling the flow between the esophagus and stomach don't close completely.

Heartburn can be very unpleasant, but fortunately there are simple things you can do to help prevent heartburn symptoms - and relieve them when they arise.

"Start by just taking note of when you experience your heartburn symptoms," said board-certified gastroenterologist, internist and wellness expert Dr. Roshini Raj. "That can help you figure out the best ways to prevent it from recurring."

Raj recommends keeping a simple diary or keeping track (in your phone or calendar) of when and what you eat for a few weeks, and what times of day you have heartburn symptoms. This can help you figure out which of the following strategies will be the most effective.

Notice Post-Meal or After-Snack Heartburn?

Some foods and drinks have been known to trigger episodes of heartburn, such as:

- Spicy, fried or fatty foods
- Garlic and onions
- Acidic foods such as citrus fruit/juice or tomatoes/tomato products
- Chocolate
- Coffee, tea, alcohol, carbonated beverages If you notice that you often have heartburn after eating or drinking one of these common

triggers, try eliminating it from your diet for a while to see if you notice a difference, then re-introduce it and observe if your symptoms return. Then you'll know what your personal heartburn trigger is.

In other cases, how you eat can be just as much the culprit as what you eat.

"Slowing down while you eat, and eating smaller meals more frequently, can help prevent symptoms from flaring up," said Raj. "Avoid getting overfull to help reduce heartburn."

Feeling the Burn After Intense Exercise?

"Exercise and keeping your weight at healthy levels are actually great lifestyle practices overall for heartburn prevention," said Raj. "But if you exercise too soon after a large meal, you could be experiencing acid reflux due to that timing."

Eat lightly before any vigorous exercise session, or wait longer after a meal before exerting yourself more than going for a walk. Exercises involving bending over or lying down, in particular, can provoke heartburn symptoms if you do them too soon after eating.

Heartburn at Bedtime?

Close to bedtime, your body slows down its processes in preparation for sleep, including digestion processes.

"Eating too close to bedtime can produce heartburn," said Raj. "Try not eating - not even snacks - for a few hours before bedtime and see if that alleviates your symptoms."

Another cause for heartburn at bedtime is simple gravity: When you're standing or sitting, acid from foods you've eaten tends to stay down in your stomach. But when

The advisor does not receive commissions or remuneration from third parties, meaning they're not going to sell you financial products that can rack up expensive fees and make you lose money. Instead, their compensation is based on an hourly rate, a percent of assets

under management, a flat fee or a retainer.

Commission-based financial professionals, on the other hand, may recommend investments with higher fees, riskier features and lower returns because they earn more money for the advisor, even if those investments are not the best choice for their clients. Because of the conflicts of interest inherent in these transactions, these advisors may have difficulty putting their client's interest above their own.

"Before you select a financial advisor, always ask them how they're compensated to help you understand the nature of the relationship. If they give you anything other than a straight answer, you should continue your search," says Brown.

2. A Fiduciary

"Fiduciary" is one of the key attributes you should look for when searching for an advisor. Financial advisors held to a fiduciary standard are required to act within your best interest, meaning they must:

- Disclose any conflict, or potential conflict, to their clients before and during the advisory engagement
- Adopt a code of ethics
- Explain their fee structure

While finding an advisor that adheres to a fiduciary standard is important, some use the term loosely, which can make it hard to decipher who is a legitimate fiduciary. NAPFA has a tool that can help you research and find Fee-Only, fiduciary advisors that are a good fit for you. "As consumers of financial services, we all owe it to ourselves to remain





over forty years at the Major League level. Lars said, "Nolan told me before you step into the batter's box look back and say, 'Hi Joe, how are you doing today.' So I took his advice. Joe looked at me and said, 'Hi Lars'."

In his first game, he started in left field and had a number of putouts and showed off his arm with a strong throw from deep in the left-field corner. Lars' first at bat in the Major Leagues was a success even though he didn't get a base hit. He grounded out to the second baseman on a ball that had an exit velocity of 109 miles per hour. In his second at bat, in the fifth inning, Lars collected his first RBI with a sacrifice fly ball.

Lars got to start in right field the next day, and he admits the first game jitters were gone. "It really is the same game I've played all my life, but the stakes are higher." He added that someone reminded him, "It's the same game with better announcers and bigger cameras."

In his second game, Lars collected his first Major League hit in the third inning. He hit one in the gap to center field for a triple. To put it into perspective, hitting a triple is the most exciting hit in baseball and the rarest to come by. Just two percent of all hits are triples and for it to be his first hit makes it even rarer. He also made his first assist in the sixth inning when he threw a strike to catcher Yadier Molina, who tagged out Isaac Paredes at home plate after fielding a single to right field.

When the Cardinals visited San Francisco, Lars was surprised by more friends attending,

including former high school teammates Hunter Lewis, Connor Underwood, Jacob Richmond, Parker Blacksten, Willem Mostert, Parshan Soheili, and Mikey Villa. He said after the game with the Giants, he was invited, by All-Star third baseman Nolan Arenado, to go for dinner. Lars said, "When you go to dinner with Nolan, it's not like going to Appleby's. You have to have a jacket to go where he goes." He said he thanked him for the offer but respectfully declined. "I told him I couldn't go because my mom and friends were taking me to dinner."

Through his journey from El Segundo Little League to the Major Leagues, Lars has not forgotten the special moments. He says there will be milestones in his life, but it's the small moments he cherishes. He says there are a lot of memories, but one that stands clear from others was a Little League championship game. "The Mets were the best team, and nobody gave us (the A's) a chance. We were down six runs in the sixth inning, and we came back with seven runs and won it with Ethan Swanson's RBI single." He says that he'll invite Hunter Lewis over, who pitched for the Mets, to watch the video. He also remembers winning the Home Run Derby and his brother throwing to him. "Nigel made it special, and I'll never forget that moment."

Lars wants to thank everybody for helping with his path to the Major Leagues. "Truthfully, I couldn't have had this opportunity without the support of all my family, friends, and coaches." He says that if he could say anything to a Little Leaguer about his journey, it would be to play as many sports as possible, play hard, have fun, and "Remember the little moments."

There's something else you should know about Lars besides being a gifted athlete and Major Leaguer. He is a very down-to-earth and compassionate person with a permanent smile that lights up a room. He speaks with his family daily, whether he's on the road or at home. And, more importantly, he is a friend first. When Lars found out I had cancer last year, he texted me with some encouraging words. When I was conducting this interview over the phone, some of the first words out of his mouth were, "How are you feeling, Mac?" He was genuinely concerned for my health. Only after we talked about my condition did he feel at ease with me asking him some questions.

From T-Ball to USC and now at the professional level, Lars Nootbaar has played the game the same way, the right way. And, through it all, he's played it with a smile and remembering where it all started. •

the field with a large and reputable firm, working for Richard Meier (Meier's career was catapulted into the mainstream after he designed the Getty Center complex here in Los Angeles).

Del Rio flourished, with credits working on the Eli and Edythe Broad Art Center at UCLA and the Crystal Cathedral in Anaheim. With such early success in the first few years of her career, del Rio began to wonder what would come next.

"The ego gets in the way, but I promised myself that in five years, I'm going to resign," she says, describing a promise with herself that she wouldn't get too caught up in the fast-paced industry that could consume her identity if she let it. She kept her promise, and after five years, she resigned and started her own company with an old colleague, designing custom homes. That is, until the 2008 housing crash. Her company came to a halt as the real estate industry slowed. Del Rio, not one to give up, turned to teaching, sharing her skills with budding designers.

One marriage and a child later, del Rio decided to take off a few years to be a new mom. As the time came for her to jump back into work, she realized her heart was not in the work like it used to be.

"I was so passionate about architecture, and I would live it 24/7, and now, it doesn't make me come alive," she realizes. Going through a divorce, raising her daughter, and trying to rediscover herself called for a change to be made.

About six months later, she signed up for a yoga challenge that required all of her attention and focus to meditate, release, and look inward.

"I took the yoga challenge, and then all this different imagery, a different language, very curvy...things came out of me that I was not familiar with, that I avoided because I avoided curves for plans all my life," she

says. She put pencil to paper and began to express these new shapes and feelings. She began by designing on coffee filters, working with the stains to create images.

One day, restless and needing to express herself, she grabbed a drop cloth, some paint, and a roller meant from her interior design work and painted what she was feeling. This was her first piece that was given a bigger stage, using paint. This piece is called Community of the Breath, and it depicts three women, each with three hearts, with a community of other women behind them on the verge of exploding, ready to be empowered. Del Rio says this is how she felt.

"My college friends would come up to me and see [my art] and say, 'What is going on with you? Where is your architecture? What is this?' They still struggle, but it's hard to explain; it feels so good," she says.

Del Rio considers this process healing. It helped her heal many unaddressed past traumas within herself, helped her heal from her divorce, and helped her to find her passion again. Today, she still practices architecture. However, she also works in a studio here in El Segundo that provides different modalities of healing, from acupuncture to her paintings, called MindSet Collective.

"I feel called, that anybody who sees the art needs to have it somehow... tell me your story, there's something you're feeling in the art, you have to have it," she says, saying she'd rather hear a client's story before discussing price or size or pickup.

Del Rio has heard many personal stories and connections through her art, including a woman who shared that she used her painting to get through chemo therapy, a woman who felt comforted by the art after a miscarriage, and a man who commissioned a map of El Segundo in the background of his painting for his wife as they moved out of the city so they could always remember it.

"My story," shares del Rio, "is just about creating harmony, peace, and wellness. My paintings are just switches and triggers for them." •

up in Manhattan Beach, plying his trade at his hair salon, Manhattan Fashions, down by the beach.

When Snowberger was twelve, he and his mother took a trip West to visit Ronald. and spent the summer in the South Bay. His brother had secured an apartment in El Segundo for Dale and their mother. Snowberger said that he was quickly hooked on the charms of the beach lifestyle. When he returned to the Buckeye State, Snowberger told all interested that he was moving to California after his high school graduation. And so, he did, landing here on July 12, 1971.

"I remember the first day at the beach in Manhattan," Snowberger said. "Ike and Tina Turner were listed on the marquee at (the long-gone) Cisco's Bar, across the street from Panchos. How cool, I thought."

Snowberger initially planned to attend college in pursuit of an art degree but was sidetracked when he decided to first attend cosmetology school to work in his brother's salon and earn some Benjamin's to pay his way through school. He cottoned to the hair salon business, but did end up attending some classes at UCLA, which led him to take on freelance graphics work. That work led to drawing a monthly column for a national magazine, teaching an art class at a middle school, and attempting to syndicate a couple of comic strips.

All these endeavors took place while Snowberger was simultaneously perfecting his hair-styling skills.

In 1974, Snowberger had an opportunity to work at the Tonsorial Parlor, which, at the time, was in Manhattan Beach on Highland Avenue near 33rd Street. "Eventually, I bought the business," he said, "which was started in 1968, and moved it to El Segundo six-and-half years ago." Snowberger said it took a couple of years to convert the space under the Grand Avenue Hotel to the hair-cutting salon he had envisioned.


Snowberger calls his shop "a combination hair salon and museum. If you saw my shops Old West décor, you would realize I love the history of the Old West," he said. "From the tin ceiling to brick and barn wood walls, and photos of the good and bad guys from the Old West, along with all the memorabilia. I am quite proud of it."

He said that even people who do not need their locks shorn would quickly visit just to "take a look" at the impressive retro décor. This scribe fits into this category, having recently received my every-three-week buzz cut courtesy of my brother. But I did drop into the shop on a Saturday morning to view the impressive array of Old West photos, brickbats, and memorabilia that adorn the walls and shelves.

Snowberger said that, over the years, he had pursued other entrepreneurial business opportunities, including participating in the venture of a coin-op laundry that he owned for 12 years with his brother, teaching martial arts, and acting professionally. He plays the guitar and bluegrass banjo and has participated in numerous road races, from 10K's

to marathons to 50-mile Ultra competitions. He also likes to get out on the road and ride his Harley.

Of his acting career: He is listed by the IMDb film website as receiving credits for acting in three films, including the 2001 Johnny Depp film "Blow," which

didn't have anything to do with blow-drying a clients hair and featured the at-the-time located in Manhattan Beach Tonsorial Parlor and its owner, Paul Barile, who was portrayed in the movie, under a different name, by none other than Paul Reubens, aka Pee-Wee Herman.

Back to reality. When not looking for adventure on the pavement atop his Harley, Snowberger has "ridden in a couple of weeklong cattle drives," as well as several other "historical horse rides." He plans to ride in the Eastern Sierra Rock Creek Pack station horse and mule drive in September, a four-day drive bringing the animals down to Bishop or Lone Pine from the higher elevations in the Mammoth Lakes area for the winter.

When he is not riding the Harley or driving the horses and mules, Snowberger, who moved to El Segundo in 1997 with his wife Janet, helped parent his two daughters through the El Segundo school system. He said that his two daughters, as well as their husbands, still "live and work here."

Regarding his wife of nearly 40 years, Snowberger called her "my childhood sweetheart and soul mate. Snowberger said he had of his for more than 55 years. The friends still get together whenever possible, and do some horseback riding, typically on Sundays.

Here is what McCown wrote about Snowberger: "Dale was a very good wrestler throughout our school years. Very popular with boys and girls alike. His talents (painting, writing, music, acting) always amazed me. He can sing and play many instruments. We both loved the outdoors (fishing, camping, hiking).

"He is very witty, and he is one of the

funniest guys I ever knew. In speech class, he would sit in the back making stupid faces while I would try to give a speech.

"I would beg the teacher to make him stop," continued McCown. "He never passes up a chance to make you laugh. His driving skills in high school were a bit suspect," McCown related. "I have been in many small accidents with him. He liked to get in punching fights while driving. For the last 25 years, we have both spent many hours on the back of a horse. The two of us have been on cattle drives in Colorado and horse drives in the High Sierras. We still ride once a week together. Dale is loyal; He will drop everything to come running when needed. I always considered myself as his frontman. I know his humor so well he would use me to set his jokes up. Most of all, Dale is about the best friend a man could ever have. He will stand by you at all costs."

Snowberger friend Phil O'Connor was there when Dale and he started the Lawndale Ensemble Theatre. Emailed O'Connor: "In the late 1980s, the city of Lawndale asked if I could look into setting up a community theater group, and Dale was one of the first residents to step forward. He was a major figure in our group effort to stage six productions before we were left without a performance space.

"Along the way, Dale became my barber, and as the years progressed, the barber of my now grown three sons.

"Over the thirty-plus years of our friendship, Dale has revealed himself to be a wonderful actor, musician, and artist. Honest and true with a great sense of humor, Dale has shared tales of his love of the Old West, cattle drives, the banjo, and his treasured family.

"The oft used moniker of 'Renaissance Man' seems to fit in Dale's case: a Renaissance Man with a Big Sky Country twist."

Said Snowberger: "I've been blessed and honored to have friends over the years come by and spend 30 minutes with me every month or so while I cut their hair and catch up on their lives and families, and then they give me money! It's a good life!"

The local "Renaissance Man" will be celebrating the big 7-0 in the next few days. And that day will mark a 50-year career barbering. Of his career path, Snowberger said that "my summer job became a career. Guess that I should have taken it more seriously - LOL." •
