Council Discusses Smoky Hollow Plan, Social Host Ordinance

After years of study, outreach, analysis and preparation, the updated Smoky Hollow Specific Plan still needs a few more tweaks before the El Segundo City Council is ready to adopt it. Based on feedback Tuesday night, a handful of items will go back to the drawing board and return to the group in a month's time.

Only three of the five Council members can vote on the matter. Mayor Drew Boyles, who was absent Tuesday, has a conflict because he owns property in Smoky Hollow. Councilmember Scot Nicol also had to recuse himself.

Smaller Council head count aside, the Smoky Hollow plan requires approval from all three members rather than a simple majority. While otherwise lauding the rest of the document as "fantastic," Councilmember Don Brann was not willing to give a final thumbs up due to concerns about two components: a request to increase the building height maximum from 35 to 50 feet (if a developer provides a community benefit in exchange); and a proposal to reduce the width of three lanes on El Segundo Boulevard in order to create a parking lane that would add 74 new spaces to the area. Brann wanted further justification from staff on the prospect of allowing buildings taller than three stories in Smoky Hollow. He also expressed concern about limited visibility on El Segundo Boulevard when coming out onto the road from a parking spot, with the worry that someone could get broadsided. "It's not a logical or safe way to obtain additional spaces," he said. Brann suggested trying out the parking lane in just the west section of the district to see how that works before committing to the east side. Planning Manager Gregg McClain, who made the Smoky Hollow presentation on Tuesday, earlier

argued that the narrower lanes on El Segundo Boulevard should slow down traffic.

Meanwhile, the plan also prohibits construction of residential housing. As one consequence, two properties – including one on Grand Avenue owned by Ron Swanson, who addressed the Council on the matter on Tuesday – got lumped into the Smoky Hollow plan and lost their prior R-3 (low-density, multiple-family housing) zone status. Swanson argued that residential complexes surround him (e.g. Grand Tropez and live/work lofts) and that these properties are meant to create a residential buffer on the north side of Grand from Smoky Hollow. He asked the Council to restore the R-3 overlay

(even if there are no imminent plans to build housing at his site). Councilmember Chris Pimentel agreed, further pointing out that it sends a negative message to "large interests" if the City of El Segundo is viewed as unwilling to add housing – or worse, looking to subtract it. McClain suggested that the Council address this by directing staff to add a separate new code amendment to reinstate the R-3.

For other elements of the plan, permitted uses will still include industrial/studio. Restaurants and assembly halls will require conditional use permits. Future self-storage, pet daycare and auto repair/body will no longer be allowed.

LAX Offers El Segundo Youth a Volunteer Program

Growing up next to Los Angeles International Airport comes with certain advantages for El Segundo kids. They learn early about the planes, and some dream about becoming pilots themselves. There's a new opportunity at LAX to get in on the ground floor of other careers.

The nation's second-busiest airport has created a program open to El Segundo youth called the LAXceeders Student Volunteer Program. The year-round program places high school and college undergraduates inside LAX terminals where they staff the information desks. The youngsters will direct guests and work at events inside the airport, and get an inside perspective of how LAX works.

One of the perks of becoming a volunteer is meeting and greeting travelers from around the world. This is also a chance to build communication skills and complete community service hours. Being a young ambassador requires a minimum commitment of two to three hours per week.

"At LAX, we are always looking for new ways to introduce young people to aviation-related career opportunities, and this program does just that," said Keith Wilschetz, Deputy Executive Director for Operations and Emergency Management.

What LAXceeders does is help local students ages 16 to 24 to learn about the skills they will need to succeed in the aviation

Warning on Catalytic Converter Thefts

Catalytic converter thefts are on the rise in El Segundo! These thefts are taking place because the converters contain metals that can be scrapped for a quick profit. The catalytic converter is part of your car's exhaust system and is found underneath your vehicle. Thieves will often crawl under a car to either unbolt the converter or simply cut the pipes and steal the item. You will immediately know if your catalytic converter has been stolen because your car will make a very loud continuous noise upon starting the engine.

Owners of a Toyota Prius, Honda Element and Toyota Camry should be particularly

aware because thieves have been targeting these vehicles.

To lessen the chances of becoming a victim, park your car in a secured garage whenever possible. If a garage is unavailable, park in a well-lit area so your car is visible to people passing by.

If you see someone crawl under a car that is parked on the street, or in a private driveway, and then hear the sound of metal being cut chances are the person is stealing the catalytic converter. If you see or hear anything like this, please call us immediately by dialing 911. See Something, Say Something!

Police Chief Participates in Navy Leaders to Sea Program



but businesses of those categories already in Smoky Hollow can remain there indefinitely as “non-conforming.”

For development standards, the plan seeks to raise floor area ratio (FAR) from 0.6 to 0.75 in the west section of Smoky Hollow and then from 0.6 to 1.0 in the east as it gets closer to Pacific Coast Highway. This will be calculated on gross square feet rather than net, McClain noted. Developers who desire additional FAR can offer a community benefit (e.g. public open space, parking, bike lockers, funding for streetscape improvements, public art) in exchange for the concession – with approval required by the Planning Commission to go up to 1.5 and by the Council if above 1.5.

Proposed building setback changes are to go from the current 4-10 feet in the front of properties to zero as an attempt to “energize sidewalks,” McClain explained. Rear setbacks would also go from 5 feet to zero, but to 10 feet if adjacent to an alley in case someone wants to use the area for a loading zone or employee basketball court, as examples. Loading spaces won't be required in most cases, but will still be needed for restaurants or very large buildings. The City will also explore having a common loading area on each block.

With parking identified as the top challenge in Smoky Hollow, staff looked to simplify requirements. The plan proposes one space be provided for every 400 gross square feet. For pre-existent non-conforming properties, changes in occupancy will trigger compliance.

McClain then went over the recommended in-lieu parking program that considers the City's actual cost to provide a parking space in Smoky Hollow. Under the arrangement, a property owner/developer can pay a set amount into a fund instead of providing an actual space. The money then goes into an account to build

future parking, though it doesn't guarantee a spot for that owner. After extensive analysis, staff arrived at an in-lieu fee of \$27,600 per space with recommended payment methods to remit the full total all at once or provide 50 percent up front and then 10 annual payments for the remainder. Mayor Pro Tem Carol Pirsztuk wondered if a smaller amount such as \$15,000 might be “more palatable” out of concern the larger price tag might “turn off” prospective investors. McClain indicated that staff would monitor the program and can revisit the terms if not proving to be popular. However, he reported that the City approached several developers with the proposed cost and most felt the amount was fair and doable.

In addition to the aforementioned changes to El Segundo Boulevard lanes, the plan also suggests moving the white dash lane on Grand one foot in towards the center so as to create space for shared bike lanes. It also addresses Franklin Avenue, viewed as “the backbone of Smoky Hollow,” with thoughts of making it a “more friendly street” with improved pedestrian, bike and (potentially) scooter access, and decorative crosswalks. The strategy for north-south streets is to create head-in, angled parking spaces on one side of the street and to make streets one way. The move could add 85 new parking spaces, but implementation will depend on the success of the in-lieu program. Additional funding can potentially come from district-based resources (e.g. special assessment districts, business improvement districts).

The Smoky Hollow plan came back with a mostly clean environmental impact report. Significant, unavoidable impacts showed up in three traffic-related areas: greenhouse gases, noise levels near PCH and traffic on PCH. Written comments from five groups in

Eagles Looking to Continue Their Gridiron Success in New Season

The 2018 high school football season is upon us and with it come high hopes and expectations that the Eagles will continue their success. Over the past 10 consecutive seasons, the Eagles have averaged eight wins and advanced to the playoffs each year. Both are school records.

So how does a small school like El Segundo High continue to be so competitive? Remember this is a school that frowns on transfers for the sole purpose of athletics, unlike some other campuses. The answer is the coaching staff and how passionate they are – and also how each year the players improve exponentially. Each season the coaching staff fills spots left void due to graduation with wide-eyed athletes craving to learn the game of football.

This season will be no exception when it comes to filling some positions. Question marks on both offense and defense will surface, but head coach Steve Shevlin and his staff will be ready to tackle the challenge. Defensive coordinator Dan Heck was surveying the team during practice and shook his head with some panic in his eyes. “Yes I’m worried how we’ll do -- just look at them,” he said. Then he reminds the coaches around him that they’ll be much different in October. That’s because of the coaching the players get and the significant improvements they’ll make.

The offense will once again be led by senior quarterback Matt Romero. As a junior he threw for over 1,700 yards with 19 touchdown passes, and he was an All-Ocean League first team and All-South Bay first team selectee. He is slated to be one of the top quarterbacks in the South Bay this season.

Romero lost his top three receivers to graduation, so he figures to target senior wide receivers Nate Kehl, Scott Melton and tight ends Alex Ron and Dylan Phillips. Of the four, Melton had the most catches as a junior. Kehl is a sure-handed receiver with good speed. Ron has good size and is tough in the middle, while Phillips looks to be a great blocker. One of the team’s top receivers could be Christophe Charles. The reigning Soccer CIF Player of the Year has good speed and athletic ability. Look for juniors Kyle Myers and Matt Kusserow to add depth to a talented stable of receivers. Sophomore James Pearson is another viable option with his size and speed.

The running game should be as good as last season’s when the Eagles averaged 173 yards per game. Romero was a scrambling quarterback who led the team in rushes and rushing TDs. That may change this season with senior running back Joey Gorte and junior full back Arman Sayson as the featured runners. Gorte has the slashing style that will find the open

lanes. Sayson has a bruising style that will challenge defenses. He will also be featured out of the backfield on passes in the flats. The depth in the backfield is evident with senior Dylan Marquez-Wasson and juniors James Fraelich and Alex Heflin looking to spare Gorte. Sophomore fullback Julian Rodriquez moves up from the freshman team where he was the quarterback.

The defense, which has been so good under the direction of defensive coach Heck, looks

Perhaps the strength of the offense is up front where there is plenty of experience. The absence of All-South Bay lineman Jess Caravello will be a big blow, but he helped mentor the linemen returning. Seniors Gunnar Rogers, a three-year starter, moves from guard to center; while Kaden Langlois, another three-

year starter, will help anchor one side of the line. Ben Rosas’ experience at guard gives the Eagles’ offense line stability. Two-year starter Justin Delgado and two-year letterman Gerardo Blanco round out a deep and talented offensive line. Adrian Wexler, just a sophomore, has the potential to be the next great lineman.

Rosas, Rogers and Bailey Greenburg shore up the rest of the defensive line. Others who will see significant playing time are seniors Connor Michel and Marcellus Henry and junior Sebastian Meza.

At the linebacker position, only James Amerault returns. He was second on the team with 82 tackles a season ago and should help the new faces around him. Juniors Jackson Ross, Jose Hurtado and Sayson as well as sophomore Julian Rodriquez have been locking down playing time in practice. Look for Marquez-Wasson and juniors David Madrid, Louis Beas and Ray Silva, who look promising, to give the defense the depth they’ll need.

The secondary lost nearly all of the starters to graduation. Heck will have seniors Gorte, Melton and Cory Craig at his disposal. All three have some experience on the defensive side and have adapted at being team leaders. With the speed of juniors Myers, Charles, Fraelich, Nick Villa and Elijah Dunn, they will challenge the opposition’s passing game.

Shevlin is optimistic about the season. He believes the offense can continue to put up arcade game-like scores with a standout quarterback, an experienced line and a wide-open offense. He’s encouraged with what the defense looks like and by how far the team has come since playing in the summer El Camino Passing League, the Redondo Tournament and the Rio Grande Tournament. The season starts Friday night at 7 p.m. when the Eagles host Peninsula.

spring prompted a revised EIR analysis that included nearby freeways. The results seemed to satisfy those parties, as no additional comment ensued.

The Council will reconsider the Smoky Hollow Specific Plan on Sept. 18.

Also on Tuesday, the Council heard from Police Chief Bill Whalen on changes to the proposed Social Host Ordinance. The item first came to the Council on June 5, but community input since that time spurred a number of changes to the original proposal. The goal, Whalen explained, is “to deter underage drinking” and marijuana/drug use and to provide the department with tools it doesn’t have now despite existing enforceable laws on the books.

The idea is to hold both the property owner/parent and minor responsible for a violation of the ordinance if the former intentionally provided alcohol or marijuana to a minor at the gathering; knew or should have known the latter would imbibe on the premises; or

was present at the premises during the party.

Under the revised ordinance, a formal warning will be issued for a first offense if the “responsible adult” is not present at the gathering and there is no evidence that a minor is intoxicated. If the adult is present where there are three or more minors drinking, that triggers the first offense. The proposed fines for violations are now lower than previously recommended: \$1,000 for the first offense, \$2,500 for the second and \$5,000 for the third – within a 12-month period. In consideration of those who may be financially hampered, a clause proposes that the first offense can be written off by performing community service (hours and type to be determined). The community service option would not be available for subsequent offenses.

Whalen reported only six incidents to date in 2018 where the ordinance would have been applicable. Though such gatherings may not be rampant in El Segundo, he spoke of the

education component and the importance of providing a way for “parents and kids to have a conversation” about the fact that “this [underage drinking gatherings] can’t happen or else there will be repercussions.”

With the first reading on Tuesday, the Social Host Ordinance will go back to the Council for final vote on Sept. 4.

Presentations at the beginning of the meeting included Chief Chris Donovan’s introduction of new firefighter Matthew Goodenough. Whalen introduced nine police department cadets (seven were present) and said they showed a great return on investment by bringing in \$700,000 in revenues (e.g. parking ticket citations) to the City since January 2017 while also taking on other duties such as traffic control to reduce the burden on police officers as well as overtime costs.

The Council also issued a proclamation recognizing firefighter Jose Zambrano “for his incredible efforts, dedication, endurance, physical

and mental toughness and most importantly compassion towards the 19 Granite Mountain Hotshots killed in the line of duty.” On June 23, 2018, Zabrano initiated a memorial to raise funds for the Kevin Wojack Explorer for Life Association. Wojack was one of the Hotshots killed in a devastating wildfire in Yarnell, Arizona five years earlier. His family subsequently started a non-profit to help young men and women participate in fire explorer programs.

With his memorial, Zambrano ran 370 miles over a week starting from Bellflower California and ending in Yarnell. He wore full turnout gear the entire way and carried an American flag, averaging over 50 miles a day despite stretches of severe heat. Chief Donovan praised the accomplishment and showed a video montage from the run. In explaining what motivated him to embark on such a journey, Zambrano said, “They were sons. They were brothers. They were fathers. In the end, that’s what I wanted to honor...” •



The Remarkable *My Gentle Barn*

One day someone may ask you, "What book made the biggest impact on you?" This week, I will tell you about a book that has educated me, a book that has made me start dreaming big dreams again, a book that has validated my hope that there are still good people in the world. It is a book that is so many things in one small package.

Reading Ellie Laks' story is alternately happy, sad, touching and motivating. I identified with

much of her description about her special relationships with animals. I was lucky enough to have many pets throughout my childhood in Ohio and a mother who shared my love of animals. But Ellie wasn't so fortunate when she was growing up. Her parents were either indifferent to her pets and animals in general, or at times actually full of contempt for their daughter and the animals. "Ellie, stop your nonsense. They're just animals," her mother would chide her after she would come home to find her dog, her duck and her rabbits gone.

Ellie says that she always felt like a misunderstood outsider with other people. She didn't relate as well to other humans as she did to animals. She especially felt she had a calling to rescue and heal abused animals. She was lonely and was alone. Ellie at one time even contemplated suicide. She became addicted to drugs and reached a very low point in her young adult years. After experiencing an epiphany about her current degradation, she was able to find help and climb out of the abyss.

My Gentle Barn is more than her life story; that part is just the foundation. The *real* substance is that of her all-encompassing compassion

for animals facing death in shelters, farms, slaughterhouses and animal hoarders' homes. Ellie and her family were able to start a charity that actively rescues and heals sick and hopeless animals. By opening up her farm to the public, she has found a dual mission healing abused and at-risk children who visit her "Gentle Barn." By introducing and telling each animal resident's particular story to these kids, Ellie and her team of staff and volunteers can reach children who have closed down or are acting out or headed toward a life of crime.

It hasn't been easy establishing this entity. Ellie writes in sometimes excruciating detail of sacrifice, loss, financial hardship and times when she has felt like giving up. She tells of the neglect and horror the animals endured before finding a haven on her land. She reveals that she felt that she had been an inadequate mother to her own children while she grew her business. But every time she was knocked down, a "miracle" would happen. Like angry and defiant Ethan, a member of an at-risk youth group that was visiting the Gentle Barn. Ethan was in the back of the group and refused to come closer to hear the stories of the formerly abused animals. But then Ellie told the tale of Bonsai, the miniature horse that had been mistreated by an alcoholic owner. Ethan perked up and asked for the story to be repeated. Again. And again. Finally, he asked to meet Bonsai. As he wrapped his arms around the little horse's neck he murmured, "It's gonna be all right, you're gonna be OK."

Through laughter and (many) tears, this book has had a big impact on me and I recommend that you give it a chance to do the same for you. The original Gentle Barn (there are now four) is located in Santa Clarita and you can find it online at <https://www.gentlebarn.org/> or on Facebook.

Film Review

Watch Ed Sheeran Create His Most Personal Work in *Songwriter*

Ed Sheeran fans rejoice: the English singer-songwriter is getting candid by inviting viewers to take an intimate look into his artistic process in the documentary, *Songwriter*. Directed by his cousin, Murray Cummings, the documentary follows Sheeran throughout the creation of his chart-topping album

to play multiple instruments, get a glimpse into his family home life, and revisit his high school days. Seeing Sheeran's determination and grit to get to where he is today will only gain him more respect as an artist.

Songwriter plays also like a private acoustic concert for an hour and a half. Sheeran's talent is undeniable -- even when dressed in a green t-shirt, blue plaid pajama pants and

"÷" (divide) which, after just one week on sale, became the biggest-selling album of 2017. From early jam sessions in his tour van to brainstorming lyrics and chords with friends in Malibu, *Songwriter* is the ultimate film for Sheeran groupies, music fans and anyone pursuing a creative passion.

Ed Sheeran is more than just a talented singer -- that we know. His songs have found their way on to multiple "Best Of" lists and his last record, "x" (multiply), earned him his first number one spot on the Billboard 200. But what sets him apart from others in the industry -- besides his shaggy red hair and colorful tattoos -- is the authenticity in his music and his poetic way with words. Sheeran is involved in writing all of his own songs. It's a process that is taxing yet ultimately rewarding and fascinating to see play out on the big screen.

The phrase "it takes a village" is at the core of Sheeran's success, and the film does a fantastic job of showing how much he values and depends on collaboration and input from his creative team, which includes musician Foy Vance, producer Benny Blanco and his brother Matthew, among other singer-songwriters. Seeing (and hearing) their ideas bouncing around the room gives off a vibe of infectious happiness and an "anything is possible" attitude. Much like the Showtime documentary, *Lost Songs: The Basement Tapes Continued*, *Songwriter* is an equally powerful look into the writing and recording process that is neither as glamorous nor as easy as one may think.

Director Murray Cummings incorporates archival footage from Ed's younger days that shows just how far back his passion for music goes. We see him learning how

fuzzy moccasins. His soothing and uplifting voice is always on point, a juxtaposition that makes for some (perhaps unintentionally) funny moments.

I personally will never tire of music documentaries, and *Songwriter* is a beautifully composed and inspiring addition to this genre. Fun fact: at one point Sheeran admits that this is the first time he has ever written a song on camera -- an act that typically leaves him feeling self-conscious. *Songwriter* made its North American premiere in the Documentary Spotlight category at the Tribeca Film Festival, and just before the screening, was acquired by Apple in a seven-figure deal for worldwide distribution. Above all else, Sheeran shows that his story is just getting started, which should excite fans everywhere.

Songwriter is not rated. 84 minutes. Opening this Friday at ArcLight Hollywood and streaming exclusively on Apple Music on August 28. •
