In-N-Out Up in the Air; El Segundo Downtown Businesses in Rent Flux

City of El Segundo officials hope for resolution in the coming weeks regarding the future of the proposed In-N-Out Burger on Sepulveda Boulevard and Mariposa Avenue. Approved by the El Segundo Planning Commission in June 2013 and originally scheduled to open by the first quarter of this year, the project has almost literally run into a roadblock. “The deal hasn’t fallen out, but there is an issue with the turning radius and requirements from Caltrans,” said City Planning and Building Safety Director Sam Lee. “Our staff is working with both In-N-Out and the shopping center ownership group [Decron Properties] to work it out and see if we can come up with any alternatives.”

According to Lee, Caltrans expressed concerns about project plans to create dual left turn lanes for cars to head onto Sepulveda from westbound Mariposa. “Caltrans is saying that a dual left on westbound Mariposa will create greater conflicts with the turning movements of large trucks turning eastbound onto Mariposa from northbound Sepulveda,” said Lee. Paying for traffic improvements was one of 100 conditions agreed upon by the project applicant to gain Planning Commission approval to move forward. The two lanes would allow vehicles entering Ralphs across the street to enter the left lane during afternoon peak traffic periods and create a controlled left turn light with green and red arrows directing flow on both the westbound and eastbound lanes—with the goal of minimizing pedestrian and vehicle conflicts that adversely impact traffic currently.

Lee confirmed that the stakeholders had yet to find a viable solution as of press time, but hoped to minimize any potential

revisions so the project can get back on track. “Depending on how substantial the changes are—and going to one lane instead of two would be considered substantial—the project may have to go back to the Planning Commission and it’s also possible that the applicant could decide to pull out of the project altogether,” said Lee. “I hope that we will know something either way in the next month.”

Lee had nothing new to report on the long-vacant Stick & Stein property a couple of blocks away. “We get a call every few months from a potential prospect,” he said.

Discussions last year with TGI Fridays to take over the space did not come to fruition after it became apparent that the chain was not a good fit for the particular footprint. “TGI Fridays met with us about the requirements for that lot and we got the sense that what they wanted to build didn’t match allowance for that land,” Lee explained. “They wanted to build their own building.”

Meanwhile in Downtown El Segundo, the former El Segundo Bakery property has remained vacant even longer than the Stick & Stein. Lee reported that an applicant

School Board Presentation Details iPad Rollout

The Tuesday night El Segundo Unified School District School Board meeting featured a special presentation about the recent rollout of the 1-to-1 iPad initiative in grades 6 through 12. The special presentation portion of the 90-minute meeting included the student representative report by Cassidy Shevlin, as well as a report by El Segundo Ed! Foundation CEO Carol Pirsztuk. Next up was the recognition of the District Technology team, and then the update on the 1-to-1 iPad initiative that is taking place at the Middle School and High School.

Pirsztuk spoke about the current Ed! fundraising plan, including a new interactive mural that adorns the Center Street Elementary wall on the corner of

Mariposa and Center. She recommended that ESUSD supporters, after donating to the cause, have their picture taken in front of the mural and post on social media. Pirsztuk also noted the upcoming Skechers Pier-to-Pier Friendship Walk that will be taking place on Sunday, Oct. 26. Last year, Ed! received \$50,000 from Skechers, \$91 per walker who supported the ESUSD.

Next up was the recognition of the District Technology Team, as Superintendent Melissa Moore took to the presentation podium. Moore spoke of the tireless work that has been done by District employees to prepare for the transition to the Individualized Technology Initiative (ITI) in the District. In an email sent prior to the meeting, Moore noted

ESMS Unveils 21st Century Library

After a summer of relative silence at El Segundo Middle School, student voices once again fill the classrooms, corridors, open spaces, and soon, a newly renovated library. On September 2nd, ESMS unveiled a fully transformed library and media center with high tech features and functional workspaces in an inviting atmosphere designed for student collaboration, creativity, and even a bit of good-old-fashioned lounging.

At a festive ribbon-cutting ceremony, ESMS Principal Jack Plotkin explained the motivation behind the redesign: "We have the prestigious International Baccalaureate program here along with a new technology initiative putting iPads in the hands of every student. Our campus needs to provide spaces for students and teachers to

be innovative within the program and creative to fully recognize their potential utilizing the best learning tools." The ribbon cutting ceremony provided a peek at some of those tools.

Among the library's new features are a large flat screen equipped with Apple TV to project from any iPad, 10 new 21.5" iMac computers and 8 laptops installed with Project Lead the Way engineering software like AutoCAD, a full whiteboard wall where students can work out problems and express their thoughts, and a stunning photo mural showcasing school pride. Lounge furniture provides space for students to relax and modular desks allow for creative rearrangement to meet classroom needs.

"I'm really looking forward to using this space with my students," 7th grade science teacher Donna Tucker commented. According to Tucker, the library was previously underutilized and

the layout was not conducive to collaboration or teacher demonstrations. The new space reflects an open, fluid arrangement attractive to students with calming colors and tones.

"It's pretty much awesome," beamed 8th grader Ramzy Latif. "It's just a lot more comfortable to learn in there now."

"I love the bulldogs on the wall," chimed in 7th grader Samantha Maxwell, pointing to the photo mural across the library's north wall. "And the whole thing is just inspiring."

Though an extensive project, Plotkin noted his team largely remained on time and under budget. "We undertook a lot here and could not have made such progress and produced this outcome without several key players," he explained. "First, we are fortunate to have a fully certified city librarian, Ms. Kim Harris, who spent countless hours updating our collection

and finding space for our new features." Plotkin also noted the diligence the ESUSD work crew and the help of Debby Adelman with Creative Spaces Design. Adelman, an El Segundo resident and business owner, kept the project under budget and worked tirelessly on the installation. "She spent a great deal of time here to ensure everything was perfect," stated Plotkin.

Plotkin also acknowledged Liz Hornquist with Colors Custom Furniture, John Worthington with Smith Systems, Dawn Von Flue with Von Flue Art, Bruce Witkin with Whitey Board, and Elvy Hightower, who designed the photo mural. "This was a collaborative project with many hands working for the benefit of our students. That's why we were here and that's why any of this is here," Plotkin concluded. •

GO-Biz Awards \$2 Million Grant to SBDCs

The Governor's Office of Business and Economic Development (GO-Biz) today announced the awarding of \$2 million in matching grants to 34 Small Business Development Centers throughout the state of California to assist small business owners and entrepreneurs in obtaining capital.

The 2014-15 state budget signed by Governor Brown authorized one-time grants through the creation of a new program called the Capital Infusion Program (Program), which offers the California SBDC network grant funding to provide one-on-one business consulting services to assist small businesses with capital infusion including SBA loans, non-SBA loans, non-traditional lending, and non-owner equity investment.

Through the grant program, which will be matched on a one-to-one basis by federal funds,

the SBDCs will deploy regional consulting programs in order to increase the number of small business owners and entrepreneurs receiving debt and private capital financing. The program will operate for a year with metrics reported out on a semi-annual basis. Through its network of centers, California's SBDC Network provides free consulting and low-cost training to more than 63,000 small business owners every year.

The SBDC network is a national program funded in part by the U.S. Small Business Administration that relies on the support of match funders in order to provide regional services. A History of El Segundo High School

Most of us who live in El Segundo know that our town name means "The Second," in Spanish, because this is where Chevron opened their second refinery. Beyond how

In 1914 Pacific Electric Rail line operated a rail into the heart of the town. And so, by 1917, El Segundo became an incorporated city with a population of 1,000 and a total of 50 business licenses. This means that our home

we got our name, it seems my peers and I know little else about how the town and high school we call home came to be. So, I decided to do a little research for the edification for all of us.

The history of how El Segundo High School came to be is actually quite interesting. To start, the "El Segundo" area was initially a part of Rancho San Pedro. In 1911 Standard Oil bought just over 5 square miles, to establish its "second" refinery. Later that year, the refinery opened and laborers settled in the area, initially living in tents before eventually building bungalow-style homes within walking distance to work. Richard Hanna, the Superintendent in charge of building the refinery brought along his wife, Virginia, and she is the one who came up with the name El Segundo in honor of it being Standard's second refinery. Later, Standard Oil became Chevron.

Soon thereafter, El Segundo's first businesses opened along Richmond Street and Franklin Avenue. Other shops appeared on a dirt road that later became Main Street. By 1912 there were 180 homes and 20 businesses, a school, a bank, and a church.

will host its 100th birthday in just 3 years!

With workers, homes and business came children! A little school was erected in El Segundo, but there was no high school. In fact, high school students had to attend Inglewood High initially. But, in 1925 a \$500,000 bond measure was passed to finance building El Segundo High School, and in 1927 El Segundo High School was built (three years before Los Angeles International Airport opened). Architects Alfred W. Rea and Charles E. Garstang designed the building in a style meant to emulate the classic design of buildings at East Coast Ivy League schools. Because of its classic and beautiful architecture the school went on to become one of the most filmed high schools in the world; Personally, I enjoy seeing the school on the show Beverly Hills 90210, and it is always a thrill to catch a glimpse of our high school in commercials.

El Segundo High's first 124 students began classes at the new school on Jan. 3, 1928. On opening day students walked through the main entrance and above them was the motto, "Enter to Learn -- Go Forth for Service."

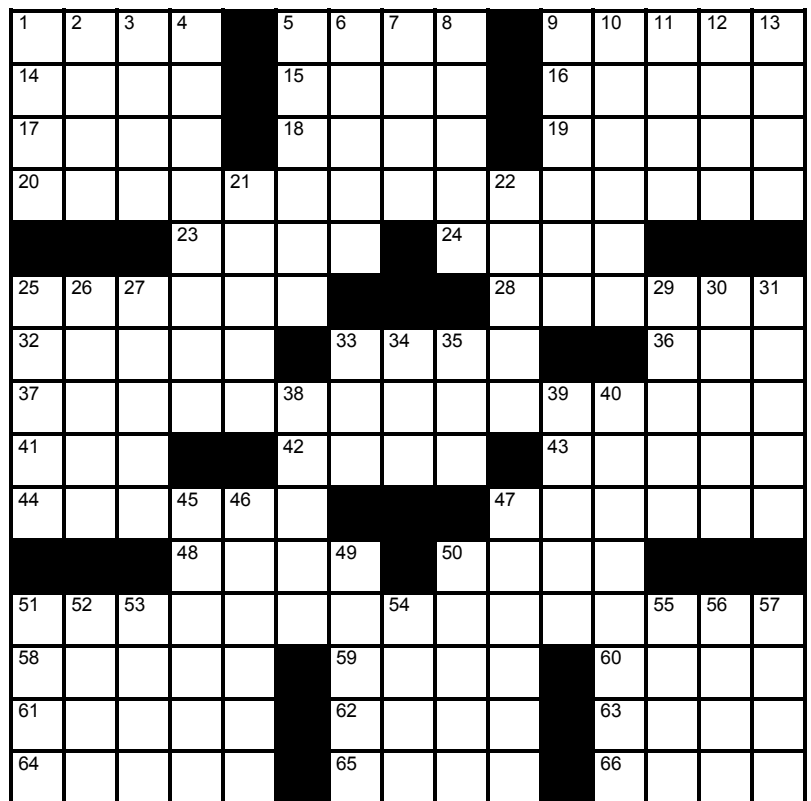

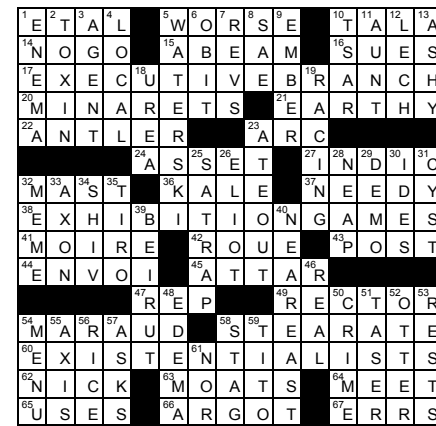

The first phase is "attrition, 'the time for carrying out attacks,' 'spectacular operations which will create a positive impact.' The terrorists use the attacks as a recruitment tool and morale boost for potential Jihadis."

Phase II is a "time of relative strategic balance" to build an army to hold territory that has been wrested from the incumbent regime." Phase III is a time of "internal discord and political upheaval for the "collaborationists." ISIS therefore had first established a goal, followed by a strategy to accomplish the goal.

By contrast, President Obama has admitted he has neither a clear goal, nor a strategy to deal with ISIS. California Democratic Senator Dianne Feinstein has criticized Obama for being "too cautious" while the King of Saudi Arabia has urged Obama to accelerate his decision-making since ISIS could launch an attack on Europe in a month and the U.S. a month after that.

Job Growth Continues to Challenge Some Cities

In terms of long-term job growth and stability, a casino is not an ideal establishment. In recent weeks it was announced that four casinos way out in Atlantic City were to close their doors and leave an estimated 8,000 people without work. This struck a chord because of the talks regarding the establishment of a casino in the City of Hawthorne. While the proposal to legalize gambling, which would in turn open the gates for a casino in the city, have been put on hold, it does bring me back to the idea of sustainable jobs in the region.

It is hard to establish a local economy that everyone can consider ideal. Without a doubt, a casino would create a large amount of employment opportunities: from card dealers, to a waiting staff, maintenances crews and security personnel, many will be employed. However, there are the negative side effects that come with any establishment that allows gambling. From feeding into people's gambling addiction to a probable spike in crime trends, there are various reasons to oppose opening a casino in one's community.

Personally, the biggest reason to not allow a casino to move into your city is because the establishment will infuse employment opportunities without much room for growth. For instance, the aerospace industry, which has a strong presence in Hawthorne and the South Bay, creates jobs with room for growth. The need to develop technology will never cease and engineers will always be hired; these engineers will become supervisors, managers and so forth. Casinos are there

to provide a form of entertainment and a result the type of professional growth that can significantly stimulate a local economy is limited.

Unlike the food service industry or other customer-service based businesses, people do not have to gamble. Communities will continue to buy food, gas, do laundry and so forth: people don't have to gamble. Furthermore, some of Hawthorne's neighbors already have casinos [Inglewood and Gardena]. That means that a casino in Hawthorne would have to compete with three well-established gambling houses. In order to compete, the new casino would have to draw people from the surrounding areas, which is will create at the very least traffic problems in the area.

There are certainly more than a handful of problems in Atlantic City that led to the closure of the four hotels which will now leave a huge chunk of unemployed people. There is no more of a guarantee that a casino in Hawthorne would succeed than it would encounter an eventual shutdown. However, one thing is certain in my mind: a casino in the city is not the best solution. Whatever business opens up in Hawthorne should provide as much economic growth and development as possible, with as little detriment to the community. Communities need entertainment venues but when a casino is the base of a locality's tax revenue, it leaves a city vulnerable to financial setbacks and potential hardships. If a casino opens only to fold years later, the city will be back to square one. I just hope Hawthorne gets it right the first time. •

Getting to Know an Ace

When you hear the name Clayton Kershaw, you automatically think about the Dodgers and the pitcher that takes the mound every fifth day for the "Boys in Blue," who are currently in a race with the San Francisco Giants for first place in the National League West. The Dodgers may, indeed, capture that first place title this year and soar into the playoffs with Kershaw at the helm, on their way to a World Series title, idealistically if you're a Dodger fan. There is, however, much more to the Dodgers ace than meets the eye. Sure, he may be the next Sandy Koufax. He may be the best pitcher baseball has seen in almost 50 years. But this Clayton Kershaw is worth noticing.

"Just use my quotes from his last game," said Dodgers manager Don Mattingly when referring to Kershaw's latest impressive outing versus the Washington Nationals. Indeed, that is what it has been like watching Kershaw pitch this year. A miraculous, unrelenting consistency that has opposing batters guessing and opposing managers tearing their hair out. "He just didn't give us any opportunities," Nationals manager Matt Williams said. "That's why he's doing so well. He's just not making any mistakes." Even after missing four starts at the beginning of the season, Kershaw has still found a way to make his way to the top of the league, once again, in virtually all pitching statistics. As of his last start against the Nationals, Kershaw has a league leading 17 wins, a league leading 1.70 ERA, a league leading 0.83 WHIP (walks and hits to innings pitched) and has surpassed the 200 strikeout mark for the fifth consecutive season, joining him with the likes of Hall of Famers Koufax, Don Sutton and Don Drysdale as the only four players ever to do accomplish that feat. By the time this comes hot off the presses, those stats most likely will have inflated even more so.

"It's unbelievable how he just hits his spots," Dodgers rookie Joc Pederson explained of Kershaw. "It's like a video game, to be honest. It's a joke." When Kershaw's not on the mound, it seems like the Dodgers can't hit a lick. When his presence isn't felt in a game, they look like the Arizona Diamondbacks (59-81). No offense, Arizona. But when Kershaw comes in the game, something miraculous happens. All of a sudden Hanley Ramirez, Adrian Gonzalez and Matt Kemp start to hit again. The 0-18 and 0-22 slumps disappear and the Dodgers' otherwise stagnant offense comes to life, if just for one game. Kershaw has also been known to contribute to that offensive surge himself. In the same game against Washington, he kick-started the offense

himself with a one-out single to center field to allow the game's first run of the day. "You always want to be consistent," Kershaw said. "You try to give your team a chance. When you only get to contribute once every five days it's important for the starting pitcher to get some momentum." Kershaw, however, has been utterly consistent in his approach to contributing both on and off the field, alike.

What many may not know about the Dodgers best player is that he is just as involved in the community here and abroad as he is involved on the mound. Not only has Kershaw received the Roberto Clemente Award for sportsmanship in 2012, but he takes time out of every year to make a difference in the lives of the less fortunate. Last Thursday night was a prime example of his willingness to help when Kershaw held his second annual "Ping Pong 4 Purpose" event. This charity of Kershaw's partners with local communities here in Los Angeles and in Dallas to renew hope for children one life at a time. In addition, it has helped him and his wife Ellen Kershaw to construct and support an orphanage in Zambia over the past two years.

Kershaw's ping-pong challenge has enabled the ace pitcher to develop an outlet to help underprivileged children across the world to find some sense of hope in their lives. Together, with stars like Jimmy Kimmel, Chris Paul, George Lopez and Chris Harrison (who all attended his event), Kershaw is bringing attention to the plight of the disadvantaged and is using his platform as a professional athlete to make a difference in their lives. It may just seem like a game of ping-pong, but the tournament involving celebrities is actually a fundraising event held on the field at Dodger Stadium. The tournament proceeds, a high-end silent auction and more will all benefit the efforts of "Kershaw's Challenge" to transform at-risk communities and the lives of children in those communities.

He may be a Cy Young Award winner, an MVP candidate and maybe even the best pitcher in the game. Perhaps the greatest thing about Clayton Kershaw, however, is his willingness to give back to his own community and beyond. On his way to an unprecedented fourth consecutive Major League ERA title, the Dodgers lefty has his team at 19-4 when he takes the mound for a start. They are 59-57 when he doesn't. Kershaw truly knows what it takes to carry his team and to become one of the best pitchers that the game has ever seen. For him, though, that is simply not enough. It is not only a World Series that would make this pitcher smile. Rather, it is helping the world. •

Eagles Roll to Easy 51-0 Win over Leuzinger

The El Segundo Eagles opened their season with an impressive 51-0 win over the visiting Leuzinger Olympians. The Eagles, who reached the CIF Northwest Division finals in 2013 looked to dominate in every aspect of the game. An overflow home side crowd witnessed one of the most impressive season openers by the Eagles in decades, maybe in the school's history.

Leuzinger has had their share of challenges recently but the school's football program once featured one of the most feared offenses in Southern California. The Olympians once employed a Wing-T offense that averaged over 500 rushing yards per game. But times and coaching changes over the years have helped lead to the program's demise, especially over the past eight years. The Eagles are moving from the Pioneer League, where they have enjoyed particular success recently, to the Ocean League. The defending Pioneer League champions had their way with the Olympians, who are moving from the rugged Bay League to the Pioneer League.

This is the first time the Eagles and Olympians have played each other in decades. The Eagles took advantage of their experienced roster as well as the underdeveloped but on the rise Olympians. "They have a good coaching staff and athletes and over time they'll get back to where they were before," said Eagle head coach Steve Shevlin.

The Eagle's defense was particularly good and showed absolutely no early season flaws. The Olympian's only first down in the first half came on a penalty. The defense was so stout that Leuzinger gained just 22 yards on the ground and most of those came in the second half against El Segundo's second and third stringers. For the game Leuzinger netted just 35 yards of total offense.

Two-time All-Pioneer League linebacker Jackson Walz led the defense with seven tackles. Jake Barone and Mike Villa also had impressive starts to the season with their defensive play. Joey Garza's interception and return to Leuzinger's 3-yard line, to start the second quarter, led to an easy El Segundo score. Dwayne Polk sacked Olympian QB Edson Santos, forced a fumble and scooped up the loose football and went 47 yards for the score, giving the Eagles a 28-0 lead.

The offense was clicking from the start. Ryan Kelly rushed for seven yards to open the season's offense. Lars Nootbaar tossed a screen pass to Miguel Wagner-Bagues for another 17 yards. On the next play Wagner-Bagues picked

up seven yards more yards to the Olympian's 12-yard line. That set up Kelly's 12-yard rushing touchdown and an El Segundo 7-0 lead.

Two possessions later the Eagles were fortunate to have great field position. Starting from the Leuzinger 39-yard line, Nootbaar directed a six play drive that resulted in Wagner-Bagues' 3-yard dive play up the middle to make it 14-0.

Wagner-Bagues was being counted on to be a big playmaker as a junior, but he was injured prior to the season starting that sidelined him for the season. So a revitalized Wagner-Bagues showed glimpses of what his teammates may have missed a season ago. "It felt great being out there being able to contribute," he said.

Nootbaar, who was 7-13 for 148 yards and three touchdowns, found Nick Karsseboom open for a 30-yard touchdown pass to give the Eagles a 34-0 lead. With the big lead in the second quarter the offense found another weapon in their multi-dimensional offense. A seven-play drive that started at the Leuzinger 47 yard line was run to near perfection. Sophomore sensation Taz Tuaeese was the focus of the drive and he picked up nine yards in two plays. Three plays later, Nootbaar found Tuaeese open for a 28-yard touchdown pass. Tuaeese, just a sophomore, looks to have the 'it factor' and down the road could be a game changer with his speed.

With the Eagles in blow-out mode, the teams went to half-time leading 41-0. The offense was in such control that they scored on five of their seven possessions. The Olympians ran 22 plays for a net of 10 yards. Defensive coordinator Dan Heck was more than ready to praise his defensive scheme. "They ran what we thought they would and it played into our game plan," he said.

The Eagles took opening drive of the third quarter 65 yards for another score. This time Nootbaar directed the seven-play drive and featured Wagner-Bagues. Back to back rushing plays picked up 13 yards for a first down. Tuaeese picked up 19 more yards on a pass and Wagner-Bagues squirted through the line for five more yards to the Leuzinger 40-yard line. On third-and-15 Nootbaar through a pass in the flat to Wagner-Bagues who the pass, broke one tackle and then ran the distance to the end zone.

Jason Kehl took over the offense late in the third quarter and led his team down to the Leuzinger 30-yard line. On fourth and long Jake Palmer drilled a 40 yard field goal for a 51-0 lead to wrap up the scoring.

It was nice start to a season that has many

submitted a plan check this past January to remodel the space into a restaurant, but nothing has progressed since. "We sent back plan check corrections in February, but have yet to receive any revised plans to address those corrections," he said.

Both future and existing Downtown tenants face the prospect of significantly higher rents than ever before, with some property owners

now asking for well north of \$3 per square foot. Realtor Bill Ruane said that average rents on Main Street were in the \$1.75 to \$2 per square foot range just four or five years ago. He attributed the spike in rents to higher than usual Downtown property ownership transfers in recent times—with several of the cases due to estates opting to sell after the original owner passed away. "Probably half the buildings in Downtown have changed hands in just the last five years," Ruane said. "Longtime owners have been selling their properties and the new owners must recoup their costs through the rents because of larger loan payments plus much higher taxes and insurance payments due to the properties getting reassessed after the sales. In some cases, property taxes have gone up by 10 times what the previous owner paid. If you own your property free and clear and charge \$1.50 a square foot, you're still making a profit. But now someone new coming in may need to charge \$3 a square foot just to break even." As a result, a number of today's lease deals include a "triple net" provision in which the tenant also pays property taxes and insurance as part of the total monthly outlay.

Ruane himself is currently attempting to lease the longstanding El Segundo Centinela Medical Center building at 455 Main, with prospective candidates including a large restaurant with an outdoor dining component as well as a medical

firm. The Meschuk family sold the Centinela building late last year after decades of ownership. Other recent Main Street transactions Ruane noted include the sale a few weeks ago of the BAD Sushi and Lan's Hair Styling buildings (357 and 359 Main) that had been under the same ownership for over 50 years. Additionally, the State Farm building at 432 Main where Ed Moore had his office for many years changed

hands six months ago after a 40-year ownership run. Wedgewood Enterprises also divested of its five Main Street properties (at the 136, 319, 333, 426 and 439 addresses) over the past year, while Pacsan Management sold the multi-tenant Citizens Business Bank complex on Main between Grand and Franklin.

Higher prices also impact the type of businesses able to come to town. "Manhattan Beach has been seeing a lot of professional service and medical offices come in to lease prime space in their downtown as of late," Ruane said. "These categories of businesses are usually willing to pay the most for space and so retailers might find it difficult to compete as demand increases. We have the same kinds of challenges here in El Segundo."

With the turnover, some tenants have worked out deals on new leases to keep increases nominal. Others are not so fortunate and may face rents of more than double their previous rates when it's time to renegotiate. One Downtown business owner who did not wish to be identified contended that some of the new property owners "see dollar signs" and are willing to squeeze out mom and pop operations in hopes of finding the next Rock & Brews-like success story. "My prediction is that in a year or two, you'll see several small Downtown merchants go out of business," the business owner said. •

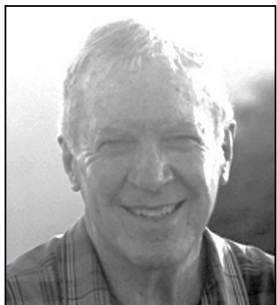



Planning For Your 20-Year Vacation

(BPT) - Are you ready to be on vacation for 20 or 30 years?

That's what planning for retirement compares to for many people as life spans have increased dramatically over the past few decades. A male who celebrates his 65th birthday today can expect to live until age 84 on average, according to the Social Security Administration. A woman can expect to live to age 86.

With the potential to live decades in retirement, it's more important than ever to start saving as soon as possible. The more time you have, the better your chances of accumulating enough assets to live comfortably once you stop working.

No matter where you are on the retirement planning continuum, there are specific time-related and time-tested strategies that can help you prepare.

"When you invest for a long-term goal like retirement, an event that for many of us is years and years down the line, time is on your side," says Elaine Sarsynski, executive vice president for MassMutual's Retirement Services division. "The sooner you start saving and investing, the more time you have to accumulate retirement savings and put the power of compounding to work. Time also allows you to ride out stock market volatility and potentially recover from underperforming years."

Although the stock market can fluctuate daily, monthly and yearly, the Standard & Poor's 500 has netted an average annual return of 9 percent since its inception and 11.5 percent in the past 30 years.



The longer-term gains attributed to stock investing are particularly helpful to younger investors in their 20s and 30s, according to Sarsynski. By saving and investing 10 percent of your income a year, including an employer match if available, you can potentially accumulate enough assets to replace between 60 percent and 80 percent of your income in retirement, she says.

Those who are well into their 30s, 40s or older and who haven't started saving should consider putting aside 15 percent or 20 percent of their income. Saving larger percentages of salary can help late savers

catch up, Sarsynski says.

What if you are in your 50s or older and have little retirement savings? Time can work for you as well if you extend your retirement date by working longer, giving yourself more time to save and postpone taking your Social Security benefits. The IRS allows Americans age 50 and older to save an additional \$5,500 above the \$17,500 annual limit on retirement plan contributions. In addition, Social Security retiree benefits increase by 8 percent every year income is deferred past the full retirement age.

A key benefit in saving and investing

for retirement, no matter what your age, is the power of compounding, according to Farnoosh Torabi, best-selling author and financial planning coach. Your percentage of earnings growth is derived from your current and past contributions as well as previous earnings, exponentially increasing with time. That's why it's so important to start saving as early as possible, Torabi says.

As an example, a 30-year-old who has \$10,000 in her 401(k) retirement plan and contributes \$300 a month until retiring at age 67 would accumulate \$761,261. That's based on an annual interest rate of 7 percent, compounding monthly.

Conversely, a 50-year-old with the same amount in his retirement plan and who contributes \$300 a month would wind up with \$149,795 at age 67. Even doubling the monthly contribution would yield only \$266,833. So time is of the essence.

Many employer-sponsored retirement plans such as 401(k), 403(b) and 457 plans feature calculators to help you determine how much income your savings can generate both today and the future. The SSA also features calculators to help you determine your Social Security retirement benefits.

"Everyone should take the time to calculate their estimated income and expenses in retirement before deciding when they will retire," Torabi says. "If you have a gap between your projected income and expenses, you need to increase your savings. Many people ultimately decide to live a little more frugally today so they can afford to retire more comfortably tomorrow." •

This motto has stood the test of time and welcomes current students daily.

El Segundo became one of the first cities in California to form its own unified school district in 1936. By 1940 ES had 4000 residents and by 1960 14,000. Thus, the acres of strawberry fields were replaced by new blocks of housing and paved roads; how the roads got "tree names" is a mystery as far as my research shows. In 1958 our beloved Recreation Park was dedicated, providing a respite for not just teens, but kids of all ages.

Today, in 2014, we have 17,000 residents and over 1200 attend El Segundo High School, many of which are second and third generation students; there is something very special about a place that can boast to third generation high school students. Our current student body is comprised of 56% Caucasian, 14% Hispanic, 4% Asian, 3% African American, 1% American Indian,

1% Filipino, .6% Pacific Islander (and approximately 20% other).

Today, the little El Segundo High School that opened its doors in 1928 is one of the top public High Schools in the nation! Our High School was awarded "California Distinguished High School" in 2003 and 2007. US News and World Report ranks us the 77th best High School in California, and awards a gold ranking to us nationwide, which is only awarded to the top 2% of public high schools. Approximately 97% of our graduates go on to college; 37% to four-year universities, and sixty percent choose community colleges or vocational education.

My endeavor into the history of El Segundo High School is quite full of historical events that cumulatively lead up to the town we all know and love today. Thank you to Chevron for creating the impetus for "The Second," but to me our town will always be Number One. •

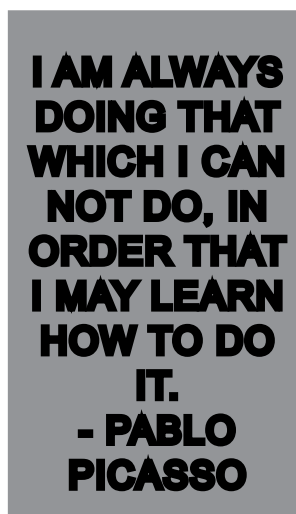

that "this presentation is significant because the District began the ITI implementation in sixth through 12th grades this year, with each student receiving an iPad for the purpose of a learning tool" as the District transitions into implementing the new mandated Common Core standards and the continued support of 21st century learning skills stressing creativity, collaboration, critical thinking, and communication.

The iPad rollout information was presented by Marisa Janicek, Director of Educational Services, and Daniel Gauna, Director of IT Technology. Their presentation highlighted the steps that have been taken to make sure that the iPad implementation went as smoothly as possible. Janicek thanked all involved, noting that the rollout went well, and congratulated all concerned with tackling the daunting task of implementing the new District technology.

With no discussion items on the agenda, the meeting moved into the consideration of consent agenda items.

The consent agenda featured the Board approval of the High School's AVID field trip to college campuses; the approval of a contract agreement with JW Photography for

services at Richmond Street Elementary for fall and spring photos; the approval on an internship contract with Mattel; the approval of a contract agreement with Amy Shertzer photography for services at the Eagle Nest preschool for fall and spring photos; and agreements with Art consultants at Arena, Richmond Street, and Center Street.

The AVID collegiate field trip is slated to take place from November 6th through the 8th. Approximately 40 students will travel north to visit five college campuses, including UC Santa Barbara, Cal Poly San Luis Obispo, San Jose State University, Santa Clara University, and the University of San Francisco. This annual trip, which will run about \$300 per student, and is typically paid for with AVID fundraisers, ESHS ASB funds, and donations, will expose students to the different opportunities available on the various campuses, as well as providing workshops to help the students prepare to successfully navigate the college application process. The trip fulfills an AVID program requirement to visit colleges so that the participants will be able to make an informed and educated selection as they matriculate.


The Mattel internship contract will allow ESUSD High School students to intern on site at Mattel. This ongoing program has allowed myriad students over the years to have an opportunity to explore "real world" career opportunities, as well as form mentor relationships with working professionals in the innovative world that is Mattel.

Tamara McGongle has been selected as the art consultant at Arena High. The popular, expanding class will take place once a week during a two-hour block. Dawn Von Flue and the District reached an agreement for Von Flue to work as the art consultant at Richmond Street Elementary, and Kenneth Powell was hired as the art consultant at Center Street Elementary. According to District provided


notes, each of the art consultants will be paid at the rate of \$20 per hour.

With no information pending action items on the agenda, the informational calendar was read by Superintendent Moore, with the upcoming events at the High School highlighting the calendar offerings, as well as the back-to-school nights taking place in the District.

Board member reports followed, with the members congratulating Moore on her very recently achieved Doctorate, and then Moore made her Superintendent report, speaking of the recent Board retreat, and the fact that she feels the Board members complement each other very well. The next regularly scheduled Board meeting is slated to take place on Tuesday, Sept. 23 at 7 p.m. •
