Survey Asks for Citizen Input in Addressing Community Hazards

City officials are asking local residents and business owners to participate in an online survey to get a sense of the community's views and concerns about the potential hazards facing El Segundo. The 12 questions cover a variety of topics and the results will be instrumental in formulating El Segundo's soon-to-be revised Hazard Mitigation Plan (HMP). "We are subject to 13 types of hazards in the city from earthquakes to climate change--which is on the rise and affects everything from air pollution to vector control," said City of El Segundo Emergency Management Consultant Denise Davis. "Knowing what residents and businesses are really concerned with helps the City so we know where to put our resources and planning. The outcome is we can continue to focus our education and outreach on what the public wants the most."

Federal law requires the City to update its HMP every five years, and the Federal Emergency Management Agency (FEMA) approved the last one in 2009. El Segundo was to complete its latest plan this past June, but a technicality delayed the process. "We were applying for a federal grant to cover funding [roughly \$60,000] for updating the plan itself and so we were told to hold off starting work on the new plan or else we would no longer be eligible for the grant," said Davis. "But as it turned out, the grant monies had to be allocated to other projects and were no longer available for hazard planning."

Meanwhile, another grant opportunity materialized that would provide almost \$400,000 in funding for the City to retrofit Fire Station 1. But there was a catch. "In order to apply for the retrofit grant, we now have to complete the Hazard Mitigation Plan and get it approved as soon as possible," said Davis. If the City

obtains the grant for the retrofit, it will also save money allocated for this project in the 2014/15 general fund budget.

FEMA requires community input as part of the HMP and that includes a public outreach program to gauge citizen opinions and recommendations. This prompted Davis to post the online survey. "The survey is targeted at what hazards citizens in the community are most concerned with and if they have taken precautions or readiness measures to prepare their home and family or business," said Davis. "It's basically what they believe the City should focus on for hazard mitigation."

Among the survey items, Davis asks

residents and businesses to rate their level of concern about potential hazards ranging from earthquakes to terrorism to tsunamis. Another question attempts to learn which preparedness steps people have taken in their households--such as storing water and food, creating an evacuation plan, installing smoke and carbon monoxide detectors, and purchasing flood or earthquake insurance. Other questions address the preferred means of communication for receiving hazard and disaster preparedness information, the types of projects the City should prioritize to reduce damage and disruption from hazard events, and assessments

School Board Hears Presentation for Project Lead the Way

A month into the 2014-2015 school year in the El Segundo Unified School District, the only special presentation item on the Tuesday night School Board agenda was a trip to the podium by Director of Educational Services Marisa Janicek and Middle School Science and Design teacher Megan DeLong, who talked about the Project Lead the Way program in the District.

A Science, Technology, Engineering and Mathematics (STEM) program, Project Lead the Way began at the High School back in 2010, thanks to funding from Chevron, Murad, El Camino College, and the Ed! Foundation.

Janicek noted that one of the main focuses that the program works to develop is in the area of problem solving, not rote memorization. The program has

successfully spread to the Middle School, as well as to the upper grades at the city elementary schools.

Following the presentation, the Board quickly addressed the consent agenda items, which included an agreement with JW Photography for Services to be rendered at Center Street Elementary; a contract agreement with a gardening consultant at Richmond Street Elementary; the approval of a "Sports Days" field trip for the Eagles' Nest students; a Pre-school Parent Education night; and the approval of a student teaching agreement with Loyola Marymount University. The student teaching agreement reached with Loyola Marymount University will provide teaching experiences for the university students, and is set to run until July 2017.

Paul Bibas and Nick Paz each had two goals; Joe Doucette and Lukas Frerichs had one. Justin Knoll blocked 13 Crescenta valley shots. On September 18 - 20, the Eagle varsity water polo team traveled to the Inland Empire to participate in the prestigious Riverside Poly water polo tournament. In their first game on Thursday, the El Segundo Aqua Men dominated San Gabriel, winning 20 to 5, with eight El Segundo players scoring. However, the Eagles

found themselves matched in the same bracket with Redlands, and in a hard fought contest, El Segundo proved to be its own worst enemy, missing on several shots which might have turned the contest around. El Segundo lost 3 to 8. The following day was a different story. El Segundo played a strong Corona High School at Corona’s home pool and defeated them 13 to 9. The next day the Eagles had two games scheduled, the first being Citrus Valley, whom El Segundo easily upended 13 to 7. In El Segundo’s final game of the tournament, they met Beaumont and handily picked them apart, 14 to 8. Of the 32 teams participating, El Segundo placed 9th. El Segundo’s next contest will be on the road to Downey High School, Thursday, September 25. •

Working Smoke Alarms
Save Lives!

Fire Prevention Week is from October 5th – 11th, the El Segundo Fire Department is joining forces with the nonprofit National Fire Protection Association (NFPA) to remind local residents about the importance of having working smoke alarms in the home and testing them monthly. Among the safety tips that firefighters and safety advocates will be emphasizing: Install smoke alarms in every bedroom, outside each separate sleeping area and on every level of the home; testing alarms at least monthly by pushing the test button; replacing all smoke alarms when they are 10 years old or sooner if they don’t respond properly; making sure everyone in the home knows the sound of the smoke alarm and understands what to do when they hear it; and putting together a home escape plan, identifying two ways out of each room and practice the plan twice a year, once at night and once during the day. This year, The El Segundo Rotary Club is sponsoring the annual Fire Prevention Week Poster Contest with the Fire Prevention Week theme “Working Smoke Alarm Save Lives, Test Them Monthly”. For 55 years, students in El Segundo schools have participated in a poster contest where they create posters depicting the Fire Prevention Week theme. This year, winners from the 3rd, 4th and 5th grades will be honored at a luncheon on October 9th at Chevron Park. New Bike-Safety Law Well-Meaning but Difficult to Enforce

With the new three-feet for safety law now in effect, motorists and cyclists throughout the state will have to begin obeying new traffic laws intended to protect people on bicycles. The new law does bring some peace of mind, knowing that there is a new law attempting to protect and ensure the well being of people on bicycles, especially since I do have plenty of friends who ride a bike to work or for recreational purposes. However, I believe that there will be a significant challenge in enforcing this law.

In short, the new law mandates that drivers give bicyclists traveling in the same direction three feet of clearance when passing. In the case that there is no space on the roadway to provide a cyclists three feet of space, a driver is going to have to slow down to a "reasonable and prudent" speed so that the cyclist is not in danger.

While the intentions of this new law are good, and hopefully the new law does make road conditions much, much safer for cyclists, it will be challenging for drivers to properly calculate three feet of distance when driving at 35-45 miles per hour. I'm not implying it is impossible nor that it can't happen, but it will be difficult for some drivers to be accurate with this three-foot rule. For the majority of us who can properly gauge three feet as we drive, the challenge then becomes the slowing down requirement of the law.

Even before this law took effect, I slowed down whenever I saw a bicyclist on the road simply because it is terrifying to ride a bike and have a half-ton vehicle speed past you. In many instances the driver behind me was either not paying attention or simply speeding, and had to slam on their brakes. So my point is that the law has the potential to cause other traffic incidents. That is not to say that there should not be rules in place to protect cyclists on the road but there will be other risk factors that one will have to deal with until the driving culture in our state adapts to said changes.

In addition, there is the issue of enforcement. Police officers will now have to determine what constitutes an unsafe speed and distance when bypassing a cyclist. The distance issue should not be too difficult for officers to determine however, what is a safe speed? How much should a driver slow down? If it's a 40-mile-per-hour zone, should we reduce the speed to 35? 30? 25? What if it's a residential or school zone? Should it be reduced to 20 miles per hour? Maybe 15-miles-per-hour is safe? I am not opposed to slowing down but what's the standard? For such a law we should have a set standard rather than the vague "prudent speed" requirement. "Prudent speed" is pretty loose language and will leave every citation issued up for dispute.

I sincerely hope that this new law helps everyone stay safe and uninjured on the roadways. I do, however, question the full effectiveness of this attempt at cyclist safety. •

Keep Pets Safe During Disasters

September is disaster preparedness month. The recent earthquake that occurred in Napa is a wakeup call to be ready. Let's look at some easy ways to get things in order just in case of an emergency.

For small dogs and cats, keep a pet carrier handy. If possible, keep it in the house and use it as a hide-away for your pet. Keeping the carrier familiar to your pet will make it easier if you have to evacuate your home quickly. Make sure the carrier has a luggage tag with contact information. If you can't get to the carrier in time, remember, a pillow case makes a good temporary pet carrier for cats. For larger dogs, keep the leash and harness in an easily accessible location.

For major disasters, you may be separated from your pet for a period of time. Make sure to keep an identification tag on your pet's collar. Keep current photos of your pet on your phone. Record the number to your pet's microchip and check to see the contact

information connected to the chip is correct. Your veterinarian can help you check the microchip number with their scanner.

Keep a backpack or other bag handy that contains bottled water and some canned pet food – and remember a can opener. You should

medication, try to keep a one-week supply in the disaster kit. Every disaster kit should also include a blanket and a flashlight.

Vaccine information: Record and list all of your pet's vaccinations. The most important vaccine information to record is the rabies

plan on keeping enough water for five days. Figure your pet needs at least one ounce of water for each pound of body weight per day. A 25-pound dog may need about one liter per day. If your pet is older or has certain medical conditions, it may require more water.

Create a list of past and current medications your pet takes. Include flea and heartworm medication too. If your pet is taking chronic

vaccine. Your veterinarian will provide you with a copy of a rabies certificate. The certificate will have the date of the vaccination, the name of the maker of the vaccine and the lot number. It will also tell you whether the duration of the vaccine is one year or three years. Take a picture of the certificate with your phone. Check and see if your pet is current on its rabies vaccine. September 28th

is world rabies day, and the United States has an unsurpassed record of identifying and controlling this deadly virus by requiring pets be vaccinated. Help keep it so. Worldwide, as many as 50,000 people still die every year from this terrible disease.

Keep a file of your pet's medical records. The file should include vaccine history, medical conditions and prescription medication information. A paper folder file is fine but put the information on your cell phone in case the written records are not retrievable. You can use an application such as pawplanner or dozens of other programs. Keep your pet's city license current. If your pet is picked up by animal care services during a disaster and ends up in the shelter, the best way to be reunited with them is a current license. Update everything once a year. Hopefully, your disaster kit will gather dust and never get used. But, if the big one hits, you and your special friend will be ready.

Managing The Aches And Pains Of Arthritis

(BPT) - Arthritis can strike at any age. In fact, of the 50 million Americans suffering from arthritis, two-thirds are under the age of 65. Each year, arthritis accounts for 44 million outpatient visits, over 900,000 hospitalizations and has quickly become the leading cause of disability in the United States, outnumbering activity limitations caused by heart disease, cancer or diabetes. Making the right lifestyle and medication decisions can be the difference between living a healthy, full life and living with a serious disability.

The specially trained pharmacists in the Express Scripts Rheumatoid Arthritis and Inflammatory Disease Therapeutic Resource



Center, offered through Accredo, have disease-specific expertise and spend the majority of their time counseling patients with these conditions.

“It's important to know that arthritis is not one condition, but a complex family of musculoskeletal disorders consisting of more than 100 different diseases,” says Phyllis Crockett, specialist pharmacist at Express Scripts. “Of the arthritis population, 60 percent are women and several types of arthritis are more prevalent in women.”

The most common forms of arthritis are osteoarthritis (OA), rheumatoid arthritis (RA)

and juvenile arthritis (JA), which account for about 58 percent of all patients. OA is characterized by a breakdown of joint cartilage and primarily affects elderly patients. RA is characterized by inflammation of the membranes lining the joint. Lastly, JA describes many autoimmune and inflammatory conditions that can affect children ages 16 and younger.

“Managing the disease so that patients can continue to live normal lives is important,” Crockett says. “Each patient is different and so are their treatment plans, but there are a few things everyone can do that can help

manage symptoms.”

Crockett offers the following suggestions to help the arthritis population.

- **Do not self-medicate:** Combining over-the-counter medications with prescription medications can be risky and can cause side effects such as an increase in gastrointestinal irritation or a gastrointestinal bleed. Check with a doctor or specialist pharmacist before adjusting doses or making changes to the medication regimen.
- **Take as directed:** For patients who already are on medication to treat the condition, adherence is critical. If patients do not take their medication as prescribed they may be faced with disability or rapid progression of the disease.
- **Watch for drug interactions:** Some common medications such as acetaminophen can have a drug-drug interaction with arthritis medications. Limit intake and remember that acetaminophen is often a component in common sinus, cough/cold and pain medications. Some foods and beverages can also block the effects of arthritis medications. These include grapefruit, apple and orange juice as well as milk and yogurt. Wait at least four hours after taking medications before ingesting these products. Exact times can vary depending on the disease and the treatment. Check with your healthcare professional if you have any questions.
- **Stay active:** OA and RA patients particularly can benefit from both endurance and resistance training. Additionally, every pound of weight lost reduces the pressure on each knee by 4 pounds. Maintaining a healthy weight and protecting against joint injury can help prevent OA. •

Smokey Bacon Mac and Cheese

Prep Time: 1 hour

Ingredients

1 pound bacon, diced into 1/2-inch pieces
3/8 cup reserved bacon fat
2 cups large onion, diced
1 tablespoon oil
1 tablespoon garlic, chopped
1 tablespoon cajun seasoning
5 tablespoons butter, unsalted
1 tablespoon whole grain mustard
1 1/2 cups all-purpose flour
1/2 cup Holland House Sherry Cooking Wine
3 quarts milk
1 tablespoon hot sauce
1 tablespoon Worcestershire sauce



2 tablespoon salt
1 1/2 teaspoon black pepper
3 cups shredded cheddar cheese
3 cups, divided shredded Swiss cheese
1 - 1 pound box Cavatappi pasta

Directions

In a large pot bring salted water to a boil to cook the pasta. Cook the pasta until just tender, cool pasta under cold water and reserve.

While the pasta is cooking, heat a medium sized skillet over medium high heat and caramelize the onions with the oil until very brown and soft. Reserve.

Dice the bacon and cook in a large pot until crispy, remove bacon from pot and add butter to the hot bacon fat in the pot. Turn the heat down to medium and once the butter is melted, add the flour and mix until the mixture begins to brown, 3-5 minutes.

Add the Cajun seasoning, Holland House Sherry Cooking Wine, garlic and mustard to the pot and stir until combined. With a whisk slowly add the milk to the pot until it is fully incorporated. Turn heat to medium low and continue to stir until the milk mixture becomes thick like an Alfredo sauce, making sure not to scorch the bottom of the pan.

Add the cheddar cheese and 2 cups of the Swiss cheese while whisking until fully incorporated and then finish with the caramelized onions, Worcestershire sauce, hot sauce, salt, and pepper for seasoning. Puree sauce with stick blender or transfer to blender and blend until smooth.

Turn on broiler to high. Add the sauce to the pasta and mix and place in a casserole dish and top with remaining Swiss cheese and broil until golden brown. Top with crispy bacon bits. •

Eagles Rout Bishop Montgomery

For the third consecutive game this season, the El Segundo football team was not challenged by their opponent, rolling to a 30-0 halftime lead and defeating Bishop Montgomery 37-6. It marked the sixth win in seven games the Eagles prevailed over the Knights.

The defense once again shone, and for the third straight game, didn't give up a touchdown. The Knights couldn't get anything going throughout the game, even when the Eagles were playing their second team. Perhaps the best offense the Knights could muster up were the penalty yards they racked up thanks to 12 flags thrown at the Eagles for 116 yards. The Knight's gained their first down of the game well into the second quarter.

Defensive coordinator Dan Heck believes the defense is playing so well because of the leadership and experience. "When you have the athletes that we have and their understanding of our system you can see why we've been so good so far."

To make a case on how good the defense has been early in the first quarter the Eagles had elected to go for a first down on fourth and short. The resulting play was a 26-yard loss. It gave the Knights great field position and backed El Segundo's defense up deep in their end of the field. The Knight's offense was stopped and they attempted a short field goal. Dwayne Polk broke through the line and blocked the kick and the Eagles recovered on their own 5-yard line. That was all that was

needed to kick to offense that gained 400 or more yards for the third consecutive game. Six plays later, Lars Nootbaar found Miguel Wagner-Bagues for an 81-yard catch and run for a touchdown.

The offense continued to assault the porous Knights defense. On the Eagles' next possession they went 73 yards in eight plays to increase their lead. Wagner-Bagues picked up 29 yards receiving and another 5-yards rushing, including a 3-yard touchdown run to increase El Segundo's lead to 13-0.

The defense came up with another significant play on fourth down. To open the second quarter the Knights were forced to punt. Mateo Fabbri took the snap and attempted to get off a punt when Tyler Stephens broke through and blocked the punt. Joey Garza was there to scoop up the ball near the Eagles' sidelines and took the loose ball back 13 yards for the touchdown.

On the Eagles' next possession it resulted in longest drive of the night. When the drive stalled the Eagles settled for a 27-yard field goal by Jake Palmer to give the Eagles a 23-0 lead. The Eagles scored one more time just before halftime. After forcing the Knights to punt, the Eagles received great field position. On the fourth play Ryan Kelly keyed off a great block by center Michael Rincon. Kelly dodged through the line and went 37 yards untouched to the end zone for a touchdown and a 30-0 first half lead.

El Segundo took the opening second half kickoff and scored on the second play from

No. 20 in the Windy City

Nothing was usual about the way that Clayton Kershaw became the first pitcher in the major leagues to pick up his 20th victory of the season. Traveling to Chicago to take on the Cubs, Kershaw not only needed a win for number 20, but he also needed one to keep his team alive in the playoff hunt. Sure, at the time they were leading the second place San Francisco Giants by two and a half games, but if you're a Dodger fan, you're keen to their propensity to make huge mistakes in the biggest, most pressure-filled situations.

It was a bright and sunny day in the Windy City, with the temperature at about 75 degrees Fahrenheit and not a cloud in the sky. See? Nothing was usual about this day. The one thing that remained status quo, though, was Kershaw's pitching routine. Stepping softly out of the visitor side dugout, Kershaw took to the field to inspect the mound. As he stood there and looked over the edges of the circle and the dirt that surrounded it, he decided to give it a try. Without a ball or a glove in his hand, "Kersh" stared in to an empty home plate with an intent look on his face and almost not one other soul in sight. He looked ready.

What took place on the field last Friday afternoon suggested otherwise. Kershaw struggled with his control all day long, falling behind in the count to batters, walking batters and very uncharacteristically giving up three runs in just the first inning. Kershaw wound up pitching his shortest outing in three straight months as he went only five innings, giving up those three runs with nine strikeouts while issuing three walks for the first time since May 23. All in all, Kershaw pitched 106 long, hard-fought pitches. Certainly, that effort was not characteristic of an NL MVP or Cy Young Award winner.


The truth is, everyone around the Dodgers organization, fans included, have come to take their ace for granted lately. It is just assumed that every time Kershaw steps to the mound he will be in the hunt for a perfect game or a no-hitter. No -- he too is fallible and human. Kershaw, just like every other pitcher, has the ability to give up runs. Realistically, however, that is what he has a team behind him for. "Obviously, you want to get eight or nine [innings] and be the reason why the team won," Kershaw said of his performance last week. "Sometimes, the team does it for you and you just happen to be out there. So that was the way it happened today and I'll take it." Truth be told, the Dodgers were lucky that one of Kershaw's worst performances in a long time came against the Cubs. Perhaps the team's ace came out a little lackadaisical because he spent so long sitting on the bench in the first inning while his team racked up six runs to jump out to an early 6-0 lead. "It's not easy, but for six runs you'll take it and sit there for two hours if you have to," Kershaw continued. "My velocity was there. I think I was out of it. My control wasn't good, the fastball was all over, the breaking ball wasn't breaking. Just chalk it up to a bad day."

It's nice to know that even on a bad day Kershaw can still come away with a "W" that meant he was a 20 game winner for the second

time in his career, nonetheless. Behind home runs from Matt Kemp, Yasiel Puig and two from A.J. Ellis that came out of nowhere, the Dodgers cruised to an eventual 14-5 victory. Leave it to a catcher to pick up for his pitcher. With the win, Kershaw joined Pedro Martinez as the only other pitcher since World War II with 20 victories in fewer than 30 starts. Kershaw was 20-3 in just 26 starts at the time of his 20th victory. Also, after having gone 20-5 in 2011, he became the first pitcher to reach the 20-win mark twice since Claude Osteen (1969, '72) and with his 20-3 record this year, he has the best win percentage as a Dodger (.870) since Preacher Roe went 22-3 (.880) in 1951. Sweetspot TV recently put together a list of the greatest pitching seasons of the last 50 years. At the very top of that list is Pedro Martinez in 1999. That year, Pedro was 23-4 with a 2.07 ERA with 313 strikeouts in 213 1/3 innings pitched. By comparison, Kershaw so far this year (after his start vs. the Cubs) is 20-3 with a 1.80 ERA with 228 strikeouts in 190 1/3 innings pitched. This year for Clayton Kershaw could be one of the best in baseball history.

By giving up three runs on the day, Kershaw's ERA actually rose to 1.80 as Cubs hitters rejoiced despite their loss. "Nice to see the leadoff hitter walk, couple guys get some hits," Cubs infielder Chris Valaika explained. "It makes us feel like he's human." Kershaw may indeed be human, but he is still the leading candidate for the Cy Young Award and should still be the overwhelming favorite to capture this year's MVP as well, depending on how the voters vote. He is once again in line to capture the pitching Triple Crown, as (dating back to last Sunday) he leads the league in wins (20), ERA (1.80) and WHIP (0.86). With one start left against his archrivals the San Francisco Giants, you can expect Kershaw to be itching to rebound from his previous "lackluster" performance. He only hopes that his team keeps their offensive prowess going as well. In the same game, Matt Kemp drilled his 14th home run since the All-Star break as he looks to be returning to the Kemp (.281 BA) of old. Yasiel Puig (.300 BA) appears to have found his swing again and perhaps most surprisingly, Juan Uribe (.309 BA) has been getting one hit after another, leading the team in batting average this year.

On the same day that Kershaw earned his 20th victory, the Dodgers clinched at least a wild-card berth into the playoffs. A feat that two years ago would have been rejoiced, has not gone without much celebration. As of last Sunday, there is still a lot to be determined in terms of an NL West champion, but there is no doubting that the Dodgers have their minds set on going into the playoffs with the best record in the National League. With their offense on track and a 1-2-punch like Kershaw and Greinke at the top of the order, the Dodgers, when they're clicking on all cylinders, know no bounds. The season is quickly coming to a close and with the playoffs on the horizon the only question that may remain is: can these Los Angeles Dodgers be your 2014 World Series Champions? Anything short of that may just be a failure for this year's Boys in Blue. •



Next week, on October 1st and 2nd, the Eagles Nest students will be participating in “Sports Days.” The preschool children will get to learn about sports outside the classroom, rotating through different stations that will be set-up on the High School field. The event will introduce the young participants to varied sports, and allow them to participate in athletic contests with their peers.

Kirk Foster has signed-on as the Garden Education consultant at Richmond Elementary. He will work with all K-5th grade instructors and students, as well as support the Garden Committee and administration. He will advise each classroom teacher and “coach” the students up to six times during the school year. According to District provided notes, there are a total of 22 classes participating, with the amount budgeted for the program not to exceed \$6,600 for services, and \$1,500 in materials reimbursement.

On October 21st Pattie Fitzgerald will be presenting a parent education program for the

Eagles’ Nest parents. Fitzgerald is a certified prevention educator, speaker and author. She will instruct the parents on implementing “safe-smarts” strategies to keep their children safe. The presentation will be funded by the Eagles’ nest PTO.

The action items portion of the brief 35-minute meeting featured the acceptance of gifts to the District, including four bestowments by the Target chain of stores to the ESUSD, totaling a little more than \$4,500.

The probability of a new ESHS course, AP Physics I, was the only item on the information pending action docket of the agenda. The course, which meets University of California approval and will be utilized for graduation purposes, would take the place of the current AP Physics B course.

Superintendent Melissa Moore then highlighted the upcoming informational calendar, including Thursday’s Hall-of-Fame induction ceremony at the High School, as well as the

festivities surrounding High School homecoming Friday night, and, in October, the always much-anticipated Skechers Pier-to-Pier Walk that will take place on Sunday, October 26.

Next-up were the Board member reports, and Moore’s Superintendent report. Prior to the meeting, Moore responded in an email, sharing her thoughts, one month into the school year.

“It is hard to believe we are already one month into the school year. I have had an opportunity to visit both the Middle School and High School classrooms and observed students actively engaged with iPads as a learning tool,” she wrote. “I observed 70 sixth-grade students using Notable and an iBook. I also observed high school students using an entire host of iPad strategies.

“At the middle school level, sixth grade students are acquiring new skills. I liken it to learning a new language. What our parents need to remember is that our children are digital natives, and will quickly pick-up these new

skills at an accelerated rate of speed.

“As adults, we are all technological immigrants,” she wrote. “Use of technology is not something that is native to us. As a parent of three sons, I know that I have learned so much when my own son comes over to the computer and shows me a more efficient way to navigate a program. Please know that the District appreciates all of the parents’ patience during this acquisition process as our sixth, seventh and eighth grade students increase their proficiency levels and become comfortable with using these new learning tools.

“In order to support these efforts, a Family Technology Learning Night has been scheduled at the Middle School for parents and their children to come together and allow the children to show off how to navigate using their new iPads.” The event is scheduled for next Thursday, October 2 in Bulldog Hall from 6:00 to 7:00 p.m. The next regularly scheduled Board meeting is slated for Tuesday, October 14, at 7 p.m. •

of community-wide activities and actions designed to reduce the risk of hazards in town. Once Davis completes a draft of the HMP, she will put it up on the City's website for public comment. "It is extremely important for people to take this survey," said Davis, who is also making presentations to community groups and appearing at local events to spread the message.

Davis went on to note that the retrofit for Fire Station 1 is an ideal project for hazard mitigation. "The station was damaged during the Northridge quake in 1994--and although it is not at a level where we think the facility at risk, there is still damage and it is vital we fix that prior to having another major earthquake. We're a small city and this is our hometown fire station, so it is at the top of the priorities list."

Speaking of earthquakes, a seismic incident is at the top of the Calculated Priority Risk Index (CPRI) of potential hazards for El Segundo due to the community's proximity to the Newport-Inglewood and Palos Verdes faults. "A large quake affects the entire city and we would see damage across the entire city," explained Davis.

Number two on the CPRI is hazardous material, of which El Segundo has an unusually large quantity given the number of industrial and manufacturing companies in town. Despite rigid quality control measures taken by the businesses themselves and the El Segundo Fire Department, Davis noted that the sheer presence of so much hazardous material makes some sort of future incident likely--although such an event would be more area-specific as opposed to community-wide in the case of an earthquake. "We are also impacted by entities outside of El Segundo such as Scattergood and LAX, so we must always be vigilant," added Davis. "The emergency operations themselves are extremely important, but hazard mitigation is what we can do ahead of time to prevent incidents and limit the possible damage. That is another reason why this plan is so important. Hazard mitigation activities and planning efforts can reduce the effects of hazards, protect people and property, and improve our preparation to respond to and recover from disasters."
