Local Middle Schooler Achieves Soccer Dreams on Thai National Team

El Segundo has had its share of celebrities from the sports world, with storied names like Urho and Roy Saari, the Brett brothers, Keith Erickson, and Scott McGregor among those who rose to major fame over the last eight decades or so. But if you happen to live in Thailand today, the most well-known El Segundo athlete of all might just be Trinity Parascandola. The 13-year-old lives on Sycamore Avenue and just started eighth grade at El Segundo Middle School. She also has legions of fans following her from thousands of miles away as the starting center forward for the U16 Thailand National Team for Woman's Soccer. Trinity recently helped her squad sweep four games against tough competition from Jordan, Laos, Guam and Myanmar to qualify for the Asian Federation Championships (AFC) next fall.

Born in Santa Monica and an El Segundo resident since the age of two, Trinity is the first non-native female to earn a spot on the Thai National Team (she is half-Thai on her mother's side). To qualify, she first had to make the field of the top 30 prospects who then attended an elimination camp leading to the AFC qualifier tournament from Aug. 26 to Sept. 5.

"She and her mother were in Thailand for five weeks in the summer visiting family--and at the tail-end of the trip, it was arranged through persistent efforts by several family members to get Trinity a tryout for the top 30," Trinity's father, Tony Parascandola, explained. "In reality, we just hoped the

team would simply assess her for possible future seasons when she became 15. But two days after the tryout, she was invited to attend the residential elimination camp that started on Aug. 7."

Despite getting through to the top 30, Trinity still faced several major obstacles. In addition to her young age, she lacked familiarity with the area and language—not to mention the punishing humid climate. The pool of athletes already selected came almost exclusively from various Thai sports schools and had the advantage of playing

together on different teams for extended periods. They also enjoyed a several-month head start preparing for the camp and spoke Thai fluently. Except for one player who knew just a smattering of English, all the others conversed in Thai exclusively. Only the head coach was proficient in English, having been a former U.S. National Team assistant. So Trinity had to pick up the Thai language on the fly to communicate on and off the field with her would-be teammates.

"I was really nervous when I tried out for

School Board Passes Resolution Postponing Next Election

The Tuesday night meeting of the El Segundo Unified School District School Board featured the Board consenting to an action item, in the form of a resolution, that should postpone the next School Board election until 2018 to dovetail with the current state cycle elections that take place in even years, in the hope of not only cutting down on election-year District expenses, but also increasing voter turnout.

With the passing of the election time-frame change resolution, which must be approved by the Los Angeles County Board of Supervisors, the next ESUSD School Board election would be slated

to take place in November of 2018. All current Board members will have their terms extended for one year.

The 80-minute meeting kicked-off with three special presentations. Alex Nilsson, the student representative to the Board, was up first. She mentioned recent events at the High School, and promoted the upcoming homecoming parade that will take place on Friday night, October 14.

The next presenter was Arena High School student, junior Charlotte Kendall, who had switched from the High School to Arena in February of last year. She talked for five minutes, extolling the virtues of Arena High and the low-stress

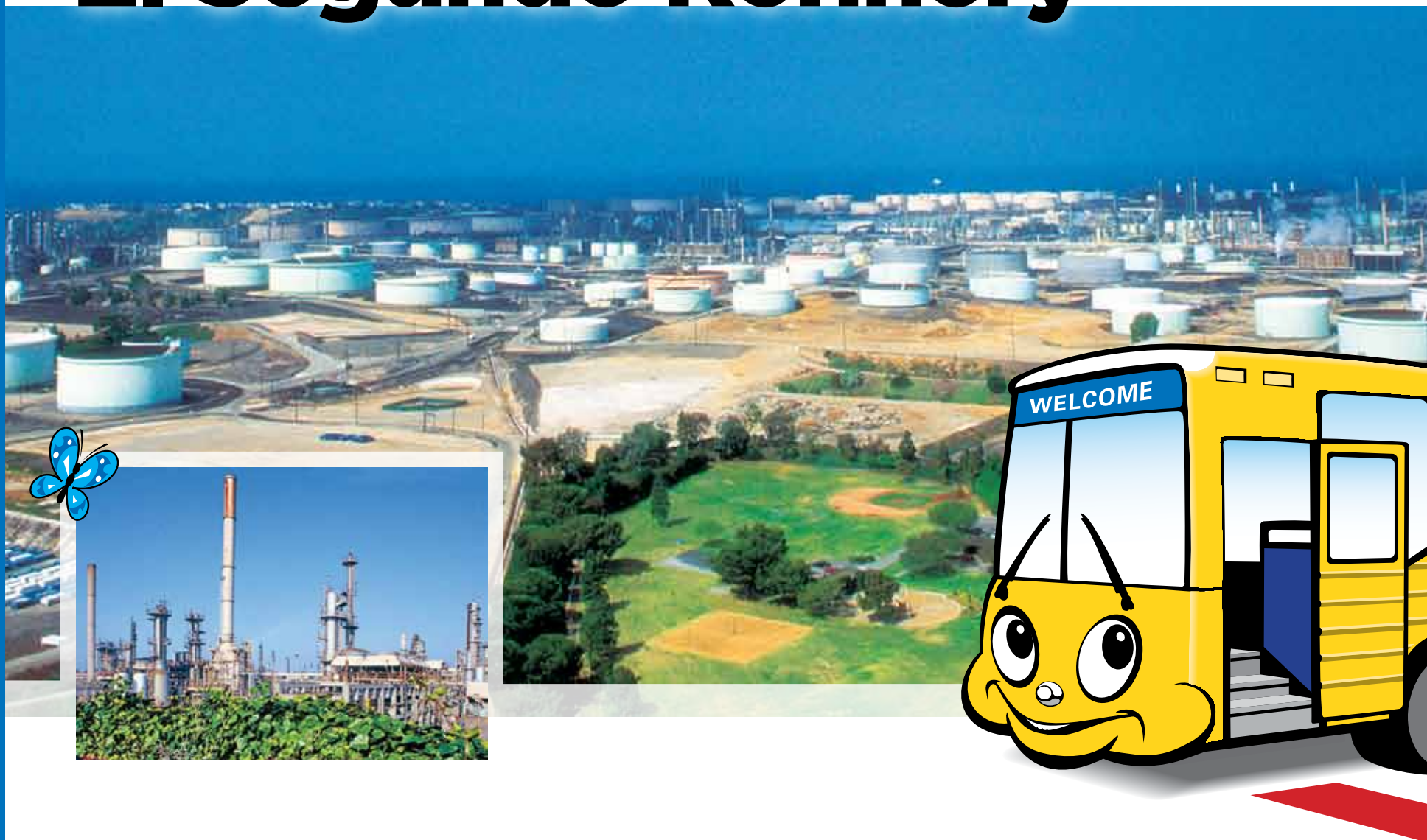

How Grocery Bags Got on the November Ballot

Grocery bags appear on the Nov. 8 ballot, which may surprise Californians who thought a plastic-bag ban was decided by lawmakers. They would be correct.

The California Legislature in 2014 banned stores from using the thin-plastic carryout bags out of a concern that the plastic litters coastal waters and harms wildlife. Gov. Jerry Brown signed the bill, called SB 270. The law was to take effect on Jan. 1, 2015, except the plastic-bag industry blocked it by declaring its intent to take its case for a repeal to the California voters.

The industry immediately announced a petition-gathering drive to put the plastic-bag law on a referendum. The American Progressive Bag Alliance funded the signature-gathering

drive that qualified Prop. 67.

The alliance has spent \$6.1 million to defeat the legislative plastic bag ban, according to the Secretary of State’s Office in Sacramento. It’s been widely reported that out-of-state manufacturers of store checkout bags are the major funders of Prop. 67. Though the plastics industry is bankrolling both Prop. 67 and Prop. 65, they aren’t asking for a yes on both.

The alliance of plastic-bag makers urges a no vote on Prop. 67. Why a no vote on a measure they pushed themselves? It’s because the alliance is attempting to overturn an existing law, so the question before the voters is whether to keep the statewide plastic-bag ban. Yes to preserve the ban; no to reject it.

ESUSD's New Band Director Robert Soto Sets the Bar High

Already well ensconced in production of the El Segundo High School Band's fall field show "Romeo and Juliet," Robert Soto, El Segundo Unified School District's new band director, is setting the bar high for ESUSD music students.

"I am envisioning an exciting fall competitive season for us. While my focus is on high quality performances, I feel this year's band is going to make a good run for the top at the championships," says the professional bass trombonist, teacher and performer.

Over the summer, Soto wrapped up his first assignment for El Segundo High School – a two-week Summer Band Camp. The intensive program focused on marching techniques, skills and musicianship.

"Summer Camp allows us accomplish a lot before the academic year even begins," Soto said. "The band quickly learned two movements of the music for the field program, including the marching drill for their entire opener."

Soto brings a wealth of teaching experience to his new position – he's been named director of El Segundo High School's (ESHS) marching band, wind ensemble and concert band, as well as the El Segundo Middle School band and choir. He earned a master's degree in music from Yale

University and a bachelor's degree in music education cum laude from the University of Texas El Paso (UTEP). His past music and band teaching experience includes middle schools and high schools in El Paso, Texas; and Hollywood, West Covina and Chino Hills, California.

The prolific musician is also an adjunct professor of trombone at Fullerton College and has performed with the Orange County Symphony Orchestra and Wind Symphony, Golden State Pops Orchestra, as well as in the orchestra for various community theaters. He has recorded and performed with top artists and orchestras in the U.S., Mexico, Canada, England, and Brazil.

Soto says his primary goal is to provide students with an extensive and varied experience in music and band. "I want to continue the quality music education program already established by my predecessor, Steve Fox, and ESHS Assistant Band Director Edie Rice."

In the future, he envisions the band participating in regional competitions, such as Bands of America, and performing in a prestigious event such as Pasadena's Rose Parade. "I want the El Segundo Unified music program to be recognized and renowned throughout California," he said.

As for El Segundo Middle School's band, choir and orchestra, Soto says he hopes the students experience how much fun performing music can be, and wants to inspire them to continue their music education in high school.

Previewing what's in store for the ESHS marching band's 2016 field show, "Romeo and Juliet," Soto says, "We're taking a straightforward approach in telling the story of the conflict between the two families." At every home football game, attendees will see the field show change and progress, until the last home game when the band will perform the complete show during halftime.

Soto appreciates the support that El Segundo's music program receives from the District, the El Segundo Education Foundation, parents and the community.

Dodgers Beat Giants, Gain Ground in NL West

On a night that Vin Scully was being honored by ESPN and the Los Angeles Dodgers had the entire nation watching on a publicly syndicated game, they defeated their hated rival San Francisco Giants by a final score of 9-3 last Wednesday night. The win wasn't only great because it was a win over the Giants, but it was also great because it won the three game series by a total of two-games-to-one and lowered the Dodgers magic number down to five. It's always great to get a win over your most hated rival, but with only 10 games remaining on the schedule after the conclusion of that series, an NL West pennant began looking like even more of a sweet reality.

The Dodgers and Giants gave all of their fans a glimpse into what makes the rivalry so great between the two teams after Game 1 of their three game series two Monday night's ago. The Giants held a 1-0 lead entering the ninth inning of a game that Madison Bumgarner was dominating Dodgers' hitters. Bumgarner and Yasiel Puig saw tensions heighten as the two argued and shoved at each other at the end of the seventh inning. As Bumgarner yelled, "Don't look at me!" at Puig, Puig responded with what seemed to be, "What are you going to do?"

It was typical Dodgers, Giants hatred. The two teams have obviously never gotten along and even Puig and Bumgarner specifically have a history with one another. "Those two like each other a lot," Dodgers third baseman Justin Turner sarcastically said of Puig and Bumgarner. "They probably go out to breakfast every night they're in town."

Bumgarner was the more successful player on the night, striking out 10 batters through seven scoreless innings while allowing just one hit. The Dodgers, however, came out as the better team, using the bottom of the ninth inning to stage a comeback. Adrian Gonzalez hit a walk-off double with one out in the inning to give his team an extremely exciting 2-1 victory. It felt as if the playoffs had already begun.

The Giants were able to take the second game of the three game series when they handed the Dodgers a 2-0 loss Tuesday night at Chavez Ravine. "Tonight we grinded one out and got the victory, and that's a good start" Giants manager Bruce Bochy said. "It's the type of win you can build on, and we know we have guys who have gotten the job done before." Instead of letting Bochy's guys get the job done again, the Dodgers ruined the Giants plans of putting together a winning streak by dominating on Wednesday night

with a 9-3 victory

"We'll just keep plugging away," Dodgers manager Dave Roberts said. "You can't let yourself get too high or too low." L.A. pitcher Kenta Maeda recorded the win, striking out six and allowing one run on three hits in the Dodgers series clinching win.

The victory extended the Dodgers lead to six games in the race for the NL West. With only 10 games left on the schedule after their series win over San Francisco, the Dodgers looked toward their final three series' of the season to not only clinch the NL West pennant, but to also get healthy and start clicking on all cylinders heading into the playoffs. Alex Wood rejoined the bullpen for the Dodgers in their series against the Giants, where Clayton Kershaw also looked extremely impressive and seems to be returning back to Cy Young form. Brett Anderson also pitched in the first game of the series against Colorado last Thursday night, but the veteran likely won't get any play in the postseason unless it's from out of the bullpen.

After the Giants loss, they remained tied in the standings with both the Mets and the Cardinals for the final NL Wild Card spot. Dodger fans everywhere are undoubtedly foaming at the mouth as they look forward to the next time that they will match up with San Francisco. The series will be both teams' final three games of the season and L.A. will have the ability to knock the Giants out of the playoffs altogether. For the Dodgers, however, it looks more and more likely that they will get a first round playoff matchup with the Washington Nationals. Washington is probable to finish the year with a better overall record than the Dodgers, but L.A. has won five of the six games that the two teams have played against each other this season.

2016 has gone from a year that featured low expectations for the Dodgers to the team's fourth National League West division title in a row. With a rookie head coach at the helm, fans and front office people alike are hoping that the new direction that the team decided to go in over this past offseason will turn out to bring better luck to the team in the long run.

The Dodgers have been successful in the past, only to falter in the opening round and Championship Series of the playoffs. One would have to think that anything less than a World Series appearance and title would mean failure for the Dodgers, who are now becoming used to playing extra ball in October. The way that this team is shaping up to look, though, the World Series may not be as far off as most people had originally thought. •

Eagles Keep Rolling with Win Over Torrance

The Eagles have played well this season and have responded to adversity including injuries. The win over Mira Costa two weeks ago could have created a letdown scenario against a hapless and winless Torrance team. Instead the Eagles blasted the Tartars from the start in front a throng of fans that were loud and appreciative of the their team.

The first three times the Eagles had the ball they scored with relative ease. Billy Brasher


opened the first scoring drive by picking up 32 yards on a pass from Jake Palmer. Taz Tauaese picked up another 13 yards on dive play and then scored on an 8-yard touchdown run. On Torrance's ensuing possession, Dylan Radke and Adrian Johnson sacked Ryan Carroll for a big loss on third down. A poor punt gave the Eagles possession at the Tartars 38 yard line.

Film Review

Movie Stars Captured by Their Biggest Fan in “The Lovers and the Despot”

In May of 2015, episode No. 556 of the podcast *This American Life*, host Ira Glass told a story about two South Korean nationals, both celebrities in the filmmaking world, and the harrowing tale of kidnapping and brainwashing at the hands of North Korean dictator Kim Jong-il, and also their Hollywood-style escape. Listening to the podcast, my mind raced with thoughts—mostly second guessing every other sentence because there is no way this could be a true story, right? Directors Ross Adam and Robert Cannan take this fascinating historical case and add visuals and firsthand accounts to the story, making it one of the year’s most terrifying films in “The Lovers and the Despot.”

The lovers, in this case, are South Korean filmmaker Shin Sang-ok and actress Choi Eun-hee. They met on a movie set in the 70s and fell in love, however, relationships in the film industry are hard to sustain (just ask Brangelina), and the two eventually divorced after Shin fathered two children with his mistress. As their relationship is crumbling, across the water in North Korea, movie buff and despot Kim Jong-il complains about the state of his country’s film industry, particularly the excessive crying scenes. “This isn’t a funeral. Is it?” he demands. Upset that North Korean films have been overlooked by the global film festival circuit, he asks how he can get the famous Shin Sang-ok and Choi Eun-hee over to his country to rebrand the flailing movie business. It is then that their fate has been decided.

What follows is an outlandish story that seems like a script to a Hollywood blockbuster rather than the actual account. Choi and Shin were kidnapped separately, sent to Kim Jong-il, where they became his personal filmmakers. The duo always planned to escape, but necessary for their survival, it couldn’t be until the time was right. In the

meantime, they knew they had to adhere to his fascist regime. The duo went on to make 17 feature films before they finally found an opportunity to escape.

Perhaps the craziest thing of all is the fact that what makes all of this true hangs on one piece of evidence: taped recordings of Kim Jong-il planning the capture of Shin and Choi. We hear those tapes for the first time and it is enough to send chills down one’s spine. Without saying how the tapes were obtained, we are told it was a “source” who smuggled them out which adds another layer to the mystery!

With a story like this, the interviews should carry the film with very little reliance on distractive filmmaking. For the most part, Adam and Cannan stick to this method of cinematic subtlety. Interviewees include Choi, her adoptive son and daughter, and other government and undercover officials. To visualize their journey, the directors use clips from Shin’s previous films, which can get confusing at times as to whether or not what we’re watching is a dramatization or the actual footage. Gaining access behind North Korea’s guarded gates is a rare feat on its own, and the glimpses of daily life seen in the film are some of the most powerful visuals. Out of control weeping at Kim Jong-il’s funeral, manic zealousness at Kim Jong-un’s inauguration, it is all so absurd and must be seen to be believed.

“The Lovers and the Despot” was nominated for the Grand Jury Prize at this year’s Sundance Film Festival, among others. With the popularity of the cultural/political blend we see in shows like “Making a Murder,” “The Jinx,” and podcasts like “Serial,” now is the perfect time for this documentary/thriller to hit theaters, as it’s truly the most terrifying film you’ll see all year. “The Lovers and the Despot” is not rated. 98 minutes. Now playing at Laemmle Theaters. •

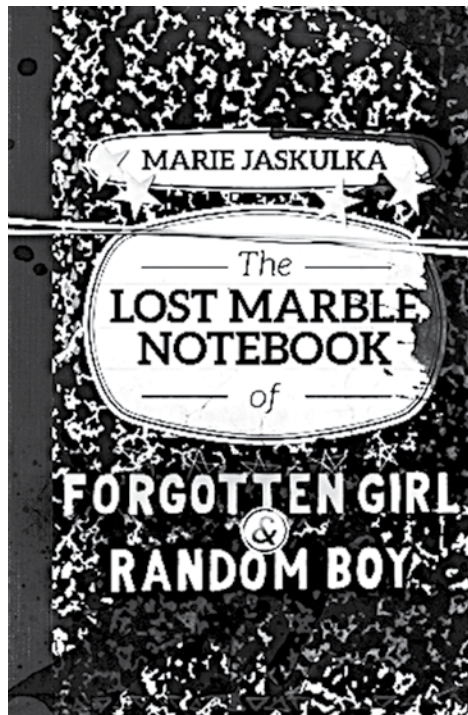

environment, virtual schooling, and small class sizes, which have helped her to lessen her social anxiety. “The best part of Arena, in my opinion,” she said, “is that you can work at your own pace, which you do not get to do at a traditional high school. And you get to work on your own methods.”

The final presentation was spearheaded by Executive Director of Educational Services Marisa Janicek, and detailed an overview of the District’s K-12 mathematics initiative program. School site principals and a vice-principal were also involved in making the presentation.

Janicek framed the presentation, saying that because of the implementation of fairly new state standards and assessments, the District has to “make sure that we are doing the right things for our kids. We are in a good place,” she said, while noting that “we are not done yet, we still have work to do.” She mentioned, as did the other District administrators who presented, the impact of the Mathematics Leadership Corps, and mathematics mentors, with the need for instructors to continually evaluate their teaching strategies.

Summing up the math presentation, Janicek emailed prior to the meeting that “we are working with K-12 administrators, teachers and parents on an initiative to implement California standards for math using the most relevant research and data learning. We are working in conjunction with research universities as well as the Cotsen foundation to hone our teaching and learning practices

district-wide to improve student outcomes and ensure our students exit El Segundo Unified, college and career ready in mathematics.”

Next up, the Board members tackled 11 consent agenda items, including the approval to enter into agreements with local businesses to partner with the High School in offering internship programs; an agreement for Richmond Street Elementary instructors to receive continuing professional development training; the approval of the Eagles’ Nest PTO sponsored “sports days”; and the approval of a consultant agreement that will provide school sites with “cyber-safety” assemblies.

Among the local businesses that will be participating in the High School internship program are: Davis & Derosa, the Crowne Plaza Hotel, El Segundo Animal Hospital, El Segundo Museum of Art, El Segundo Performing Arts Center, El Segundo Police Department, Kinecta Federal Credit Union, Mychal’s Learning Place, and Team CJ Fitness.

Richmond Street teachers will have Growing Educators, LLC provide twelve days of lab demonstration and one two-hour period of professional development. Their program features the development of “balanced literacy” amongst the instructors, and in the classroom.

The Eagles’ Nest “sports days” will feature student rotation through different sports stations set-up on the High School field. Hoping to introduce the children to different sporting endeavors, the event will be taking place on October the 5th and the 6th.

Jon Moffat, of Cyber Education Consult-

ing, will provide age-appropriate assemblies for 4th thru 8th grade students, as well as an evening presentation for all interested educators, parents, and High School students. October is Cyber Safety awareness month in the ESUSD, and Moffat will make his cyber safety presentations on October 20

Action items were next on the agenda, with the resolution regarding changing the Board election- cycle first-up. The last El Segundo School Board election took place in November of 2015, with the next election date scheduled for 2017. Board members whose terms were set to expire in 2017 (President Jim Garza, Vice-president Bill Watkins and clerk Emilee Layne) will now serve an extra year, with members Nancy Cobb and Jeanie Nishime will having their terms extended to 2020. As mentioned earlier, the resolution will be forwarded to the LA County Board of Supervisors for approval of the re-alignment.

Superintendent Melissa Moore said that the Board was as transparent as possible when communicating to the public the possible election-cycle change, and had not received any pushback from community members. ESTA President Daphne Moote had spoken earlier in the meeting about her organizations full-support of the change in the School Board election cycle.

The second resolution that was passed by the Board involved the replacement of the main artificial turf field at the High School. Initially installed in 2011, the replacement field, deemed FieldTurf Revolution 360, will cost in the neighborhood of \$150,000 of District-budgeted dollars, and will be backed by an eight-year warranty. If all goes according to plan, the new turf field would be installed after the graduation ceremony in June of 2017, with the upgrade process taking in the neighborhood of four-to-six weeks.

Superintendent Moore then referenced the upcoming District’s informational calendar. District events taking place in October include National Walk to School Day on October 5, the Richmond Street Fall Festival on the 7th, the High School coronation dance on the 8th, the High School homecoming parade and football game on the 14th, and the always popular Skechers Pier-to-Pier Friendship Walk taking place on Sunday the 23rd.

Board member reports followed, with the members noting how they were pleased with the pending summer upgrade of the turf at the High School. President Garza mentioned that he wanted to thank all of the corporations that were “stepping-up and giving our students an opportunity” with their involvement in District internship programs.

Moore concluded the meeting with her Superintendent’s report, in which she mentioned the importance of the Cyber bullying program that the District has embraced, and the collaborative efforts that have sponsored funding for the October 20 presentations.

The next regularly scheduled Board meeting is on the calendar to commence at 7 p.m. on Tuesday evening, October 11. •

The game was less than six minutes old and the Eagles had a 20-0 lead.

Torrance’s offense continued to sputter and pinned the Eagles on their own 1-yard line after a 38-yard punt. It didn’t phase El Segundo’s offense that they were facing 99 yards to get another score. The Eagles went seven plays and tied a school record with their 99-yard drive. CJ Shevlin picked up 27 yards on a pass play to midfield. Then Brooks punctuated the drive with a 50-yard catch and run touchdown from Lagarde.

Just when Torrance showed a bit of success on offense El Segundo’s defense spoiled their party. It was during their longest drive of the night, that covered 49 yards, when Brasher stepped in front of Torrance’s Ethan Myers and intercepted Ryan Carroll’s pass and raced 85 yards for a touchdown. With less than three minutes remaining in the half, the Eagles had a 34-0 lead. The game was being dominated by the Eagles on both offense and defense.

Defensive coordinator Dan Heck was mostly smiles during the first half but still had some words for a few of his players. “We continue to make mistakes in the secondary and commit too many penalties,” he said. He was referring to three pass interference penalties. He did, however, praise the defense’s overall performance and said, “We picked up right where we left off after beating Mira Costa so I was glad there was no letdown.”

The Eagles cleared the bench in the second half. After Tauaese was injured in the first half, Isaiah Gray took over at running back. On the third play of the third quarter,

the speedy Gray found a seam and went 41 yards to score his first touchdown. El Segundo scored its last touchdown of the night on their next possession. This time it was all Ashton Saltz as the junior fullback carried the ball five times for 45 yards and scoring on a 9-yard blast and a 48-0 lead.

Defensively the Eagles had one of their best efforts in a couple of seasons. Torrance was literally shutdown throughout the game. Though they managed to gain 12 first downs most came on penalties or in the second half when the second and third string players were in the game. The defense allowed a meager 11 yards on 31 carries or an average of .35 yards per carry compared to Tauaese who gained 125 yards on six carries or 20.83 yards per carry.

the team,” she said. “In my eyes, they were all better than me, faster than me, used to playing with each other, and I didn’t think they would want me to join the team. The first tryout I had was really too late, but my relatives Pe Taan and Pe Aey kept making calls until they [coaches] would see me. We scrimmaged a boys’ team, and to be honest I thought I was just average.” But

the next day, Trinity received an invite to a team tryout about an hour away and fared much better as she earned an invitation to the elimination camp.

By the time of the first game in late August, Trinity was brimming with confidence. “I was speaking Thai almost 24/7, living with two roommates, learning what it is to be a Thai National Team player even though I was just a hopeful,” she said. “The girls ended up being great to me even if they didn’t understand a lot of what I said. Then when I saw the line-up for the first game, I was listed as starting center forward. At that point, I was dialed in. Plus, my dad flew from America to watch and my mom and her sister were there to cheer for me.”

With the odds stacked against her, Trinity had managed to not only make the team, but start in three of the four contests. She logged 90-plus minutes in each of the first two games and 50 minutes in the fourth game. The starters sat out the third match against Guam to allow other roster players an opportunity to get on the field.

The exposure virtually turned Trinity into

an overnight star in Thailand. “I had a lot of supporters,” she said. “The games were on True4U TV, and I even did a TV promo. I was interviewed a few times. One fan built a Facebook page for me and many people waited after the games to take a picture with me. When we went back to Bangkok, I was recognized and people still wanted to take pictures together. It was an experience to

remember.” The fact that she was not native also led to comparisons with the current men’s Thai National Team star Charyl Chappuis, who was born in Switzerland.

Trinity began playing AYSO soccer in El Segundo at the age of five, with her dad becoming coach halfway through her first season. She remained on his teams up to the U12 level. Last year, she was part of Coach Kate O’Riley’s U12 All Stars squad that captured the Western States championship. It was the first time in the region’s 39-year history that a girls’ team went to the finals. Trinity was also the captain.

Outside of AYSO, Trinity played two years in Manhattan Beach for Sand and Surf club soccer, earning both Offensive Player of the Year and Goal of the Year honors during her second campaign. Last year, she played with an older team—the U15 Strikers from Fountain Valley--and traveled with the group to Sweden for a tournament. “It was the first time I played soccer in another country,” she said. “We played Finland, Madrid, Espanyol, Oslo and Sweden. That was when I first learned how different the game was in

other parts of the world—faster, more tactical, greater use of the keeper in offensive play—and how I needed to raise my game to reach my goals.”

With the Strikers, which included some players from El Segundo, Trinity made a second major trip this past May to Austria to compete in the Cordial Cup—the largest international youth tournament of the year.

Now a seasoned veteran at 13, Trinity envisions a bright future in her sport. “Ever since I was little, I’ve always wanted to play in the World Cup and someday on a professional team,” she said. “I think by that time, women’s soccer will be a much bigger sport with more teams and regular TV coverage. Maybe I can be on the first Los Angeles women’s team because Los Angeles should have a team.”

While Trinity hopes to achieve her dreams as a soccer player, she has even loftier aspirations in the academic realm. In fact, she laid out a specific game plan that most kids don’t even think about until they get to college—much less while they are still in middle school.

“This surprises most people, but I want to work for NASA,” she said. “I am working on math and sciences so that one day I can work at JPL [Jet Propulsion Laboratory]. My goal is to work in the command center, first as an intern and then as a scientist and to be a part of our space program.” Trinity credited her experience in Thailand with helping

her realize that she must never impose limitations on what her future might hold. “I think what I did this summer is a big step toward believing that if I really try, there’s nothing I can’t do.”

While winning all four games and achieving celebrity status were certainly major highlights of the summer, Trinity also found it particularly rewarding to receive the continued

support of her teammates throughout the process even with the language barrier. Yet the most memorable moment of all for her may have been the small opening ceremony for the starting players.

“We lined up and walked out through a tunnel with the FIFA music playing over the loudspeakers,” she said. “I remember seeing all the relatives and my parents in one spot, all the fans cheering their hearts out, the huge Thai flag and the substituting players that I worked so hard to beat to become a starter. When I looked over at them, that was when I realized that I made it and I was going to do everything that I could possibly do to stay on that field for all 90 minutes. From the first whistle to the end of the game, the fans were playing drums at both ends of the stadium and large groups of fans and kids from the various sports schools were singing and cheering. There were actually times when I was playing that I couldn’t even hear the coach in the coach’s box and could only hear my heart pounding to the beat of a drum and everything moving around like a movie in a dream. I’ve never felt so free and alive.” •

Beans was born with a condition called eyelid agenesis, meaning he did not have any upper eyelids. His left eye had to be removed due to infection and structural abnormalities. Beans does not need special medical care beyond a simple, over the counter nighttime lubricant ointment given once per day. (A tube is around \$10 and lasts

several months.) He's a playful boy who loves to romp with other kitties. Currently, Beans is good buddies with a lynx point Siamese, Robert, and they would love to be adopted together. Once he knows them, Beans gets along with all other kitties and would ideally have a forever kitty friend in his home.

Gingi is a short-haired classic orange tabby with beautiful markings and color. He is the largest in a litter of four and will be a big handsome marmalade cat when he matures. He is a very active and friendly kitten and very socialized to people and petting. Gingi was rescued as a very young kitten together with mother Cleo and three siblings. He is still with his mother in foster care and is healthy and well adjusted, but now he needs a home of his own. He would do well with another cat and gets along with the foster family dog.

Cleo is a long-haired, smoky calico and white tabby girl with a beautiful plume of a tail. She was rescued with her four tiny kittens from the yard of a non-profit after-school facility. She is a very special too-young mother cat who faithfully cared for her kittens under dire circumstances. Just barely a year old, Cleo is in a foster home raising her healthy, happy kittens who are now ready to go out on their own and be adopted. Lulu and Pitti Pat are two more of Cleo's kittens (and Gingi's siblings). Lulu is a female short-haired calico with white mittens and very pretty orange facial markings. She is the smaller female of the litter and has a very sweet passive nature and loves to be held and cuddled. Her sister, Pitti Pat, is also a short-haired calico with white mittens. She is the largest girl of the group and will be a lovely big cat when she matures. She is very active and independent and would do very well with older children or adults. Both are healthy and well adjusted, and would do well with another cat. They also get along with the foster family dog.

Last, but not least of Cleo's family, is **Jesse**. He is a short haired black tipped Agouti tabby with a white bib and mittens. He has classic eye markings and a lovely even pattern. This friendly boy will become a large and beautiful cat as he grows up. Jesse is very active and very playful. He needs a family that will play with him or a kitty playmate - maybe his brother Gingi? He gets along with the
