Taking a Look at Measure W

City Attorney's Impartial Analysis

The El Segundo Municipal Code currently prohibits all commercial cannabis activity in the City and no person can be issued a license or permit for the cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, labeling, transportation, distribution, delivery, or sale of cannabis or cannabis products. Measure W would repeal the prohibition and replace it with an ordinance that would allow for specified types of commercial cannabis businesses to operate in the City, subject to a licensing and regulatory scheme, if they are: (i) located more than 1,000 feet from any school or day care center, (ii) located more than 600 feet from any youth center, and (iii) located east of Pacific Coast Highway (PCH) but not located on PCH, El Segundo Boulevard, Rosecrans Avenue, Imperial Highway, or Aviation Boulevard. In addition, each cannabis retail business must contain a minimum of 1,750 square feet of gross floor area. Specifically, the ordinance would permit cannabis retail sales, cultivation, manufacturing, distribution, testing, and microbusinesses. A cannabis "microbusiness" is a business that engages in at least three of the following: cultivation, manufacturing, distribution, or retail sales. Measure W does not place a cap on the total number of commercial cannabis permits ("CBPs") for retail-only cannabis businesses. Rather, it authorizes the City Council to establish the maximum number of permits by resolution. Measure W provides that the maximum number of CBPs that may be issued for other types of commercial cannabis businesses is zero unless the City Council subsequently decides to allow such permits by resolution.

process would require applicants to submit a list of owner and manager qualifications, along with several different plans. The city manager would be required to issue a CBP to an applicant that submits all required application materials and passes a criminal background check. Once issued, a CBP would remain in place indefinitely unless suspended or revoked.

Measure W was placed on the ballot by the City Council.

A "yes" vote by a simple majority of the votes cast would repeal the City's current prohibition on commercial cannabis activities and instead permit commercial cannabis activities.

A "no" vote would maintain the City's prohibition on commercial cannabis activities.



West Basin, Hyperion and LAWA Updates

It was an evening of updates, a \$75,000 grant, and discussion of a new pilot program for residential sound insulation to combat airport noise, excessive commercial fire alarms, and city proclamations for National Bullying Prevention Month and Breast Cancer Awareness month during Tuesday's regularly scheduled El Segundo City Council meeting.

The most extended update came from the West Basin Water District's Scott Houston, who oversees the water division in El Segundo and is vice president of the board of directors. Houston delivered a 30-minute presentation on the current drought and was followed by an update on the city's neighbor to the west, the Hyperion plant, by city staff. Due to ongoing issues with odors and emissions from the plant, which the city has declared a public emergency and is preparing for litigation against the City of Los Angeles, which owns and operates the Hyperion Water Reclamation Plant. The plant's July 2021 emergency sewage spill into the ocean and plant flooding continues to impact El Segundo residents, who say they are experiencing health issues that lower their quality of life. Roughly \$5M in short term projects have been approved to redo skate park, teen center, basketball courts, Joselyn Center, baseball fields and irrigation, yet there is approximately \$60M capital improvements that are unfunded. How can this be addressed and what would be your priority?

Ryan Baldino: We have 9 committees and commissions which advise our City Council. One such committee is the Capital Improvement Advisory Committee which reviews our infrastructure needs and develops a 5-year Capital Improvement Program which ranks and prioritizes all infrastructure projects and makes recommendations to our City Council. Our Parks and Recreation Commission is currently working on a field use assessment to determine how our fields are being used in order to plan what updating and improvements are needed at Rec Park. They recommended, and the city recently approved, the modernization of the Teen Center and the Council. The five candidates running are Ryan



ful, so we are replacing them. Joselyn is a rebuild; it's too far out of code to update. The future clubhouse permutation accounts for half of the park's needs. This can all be done with financial discipline. Since 1960, mega-projects incorporating many large projects, are replete with delays and budget overruns. . . just take the 105. . .

2. Residents have written to say crime is up, electric bikes are a menace on sidewalks and streets with no ramifications and the police seem to be patrolling less. How would you address this?

Ryan Baldino: Everyone deserves to feel safe in our town. The overall increase in crimes and thefts in the South Bay region has also been felt here in El Segundo. The explosion of electric bike use is a concern in our community, and the safety of the children and adults who do not obey traffic signs is a real problem. One of many benefits of living in El Segundo is having our own Police and Fire Departments who recognize our concerns and engage with our community. From having "coffee with a cop" events or by recently "greeting" our middle schoolers on their way to school to remind them of the importance of helmet and bike laws, our police continue to demonstrate their understanding of the ever-changing safety issues our town is facing. I will work to continue the open dialog and engagement our public safety officers have with our community.

Michelle Keldorf: From the rapid increase in the number of electric bikes to catalytic converter theft and homeless outreach, our Police Department is tasked with a wide range of present-day public concerns. As a City Council member, I am committed to working with our department heads to secure the resources they need to be successful. I See City Council Candidates, page 12



Joslyn Center, and I believe that is a great start. My priority in renovating our park facilities will be based upon listening to the information and advice from our residents who serve on these commissions, as well as the feedback they receive from fellow engaged citizens. Informed decisions only come from input from our community.

Michelle Keldorf: Maintaining our parks and facilities is key to a vibrant community. While there has been discussion of a bigger spending initiative to redesign Recreation Park, I am a proponent of completing these short-term projects as soon as possible. Further delays bring diminished enjoyment along with cost escalation. We need to identify a funding source for public infrastructure improvements. I would prioritize updates to our water and sewer systems while concurrently developing a comprehensive plan to address our streets and sidewalks. Over the next two years, I would engage staff to evaluate potential financing mechanisms to determine the path most aligned with our community's goals and objectives. In the near term, we need to spend responsibly. I believe in order to avoid runaway spending, we must budget first and design accordingly for future projects.

Robin Patch: The Parks and Recs Department has proposed both a long-term and short-term strategy to remodel Rec Park and its facilities. The approximately \$60 milliondollar unfunded capital improvements would be incurred *if* the City approved a long-term complete overhaul of Rec Park. This would include reconfiguring the entire park layout, demolishing several current structures and constructing new buildings in their place. I am opposed to this plan because it is highly expensive, and would also require the Park to close during construction. I am in favor



of the lower cost short-term plan to revamp the Park's existing buildings and fields on a case-by-case basis. This way residents can still utilize the Park while it is under construction, and will also benefit from updated facilities in a shorter time frame.

John Pickhaver: My top priority would be funding these short term projects to ensure residents are getting the most of our facilities and amenities. There's a considerable amount of money already allocated for these purposes. We need to work diligently to see those funds are appropriated to get these projects done. As for more broad capital improvement projects, I would approach this on multiple fronts. First, earmarking an increase in our local sales tax could be used to fund these projects in the long-term. This option increases the pool of contributors to this new fund because most of our local tax revenue actually comes from those living outside of El Segundo spending at businesses throughout town. Additionally, I would engage in discussions with El Segundo residents about a CIP bond to raise such funds. Whichever approach we pursue it must start with communication with residents to determine the best course of action.

Chris Pimentel: Mega-projects are seductive, conceptually efficient, and nearly impossible for cities to do well. There may be \$40-60 million of theoretical work in Rec Park, but the idea that the city embarks on a grand overhaul, and tax you for it, is a canard. That's just dumping money into the "Government Big Idea Woodchipper" (imagine a trip to the River Delta Tunnels on the Bullet Train and seeing the Sepulveda Pass Light Rail as we go!).

Smart governance means adopting a park plan, prioritizing projects, and allocating specific funding. The restrooms were aw-



1. What one agenda item would you bring back for Board consideration, and, if elected, why that item?

Tracey I. Miller Zarneke: "While I do not question any Board decisions of which I have been a part in the last four years, I would like to take a deeper dive into how we as a District can partner with the greater El Segundo community to further infuse good character and kindness lessons into our daily lives. Social, emotional and mental health programming and practices are all within the District staff's current training protocols and focus, but I want to seek more paths to intentional collaboration in this space with our willing parents and community members, as we all know "it takes a village" to raise the next generation. Anxiety levels amongst students are higher in today's world than what any of us current adults experienced in our youth, and I'd love to see the El Segundo on the five-member El Segundo School Board. Five candidates have entered the fray. The list includes incumbent and current School Board President Tracey I. Miller-Zarneke, Meredith J. Beachly, Yadranka Lucia Draskovic, Dawn

reading, the feeling was that the school was promoting and/or recommending students read these titles. Although there was a brief discussion from the board afterward, they quickly decided to leave said books on the list. It seemed clear that parent concerns were summarily dismissed. One of the five goals on the district website is to have parent involvement in their child's education. Are we meeting that goal? I feel that is a question worth asking."

Frank Glynn: "I have full confidence that the previous decisions of our ESUSD school board were taken in the best interests of students with careful consideration of information available at the time. However policy implementation may uncover unintended or unavoidable consequences resulting in a need for a course change.

"Recently the district adopted digital technology as the primary mode of instruction. As a parent, the shift from traditional textbooks and chalkboard instruction felt abrupt and not the best solution for all students. The use of iPads brings a myriad of challenges for parents and teachers including difficulty in ascertaining if short cuts are being taken, and safeguarding student from access to inappropriate content.

"With the benefit of hindsight and knowledge gained, I suggest revisiting this issue to better understand how to mitigate against learning loss for those who do not thrive, implement input from teaching staff, and provide better content security."

Meredith J. Beachly: "I'm not sure that we need to bring back decisions made by the current board as they had information I do not have. I would like to focus my efforts on present and future of our district for our students."

Garrett, and Frank Glynn. Current members Paulette B. Caudill and Emilee M. Layne opted not to seek re-election. As election day nears, each of the candidates elaborated for the Herald on their qualifications



Unfortunately, there was not enough time to reconvene City Council to vote on whether to pull its own initiative before the deadline passed. The City of El Segundo's measure remains on the ballot for our community to vote on and determine.

The measure was written with what we, the El Segundo City Council, believe is in our community's best interests. Voters will decide if dispensaries will be allowed to open and operate in the city. It is important to note that while this measure does technically provide for "unlimited" business licenses, it

purposefully limits where in El Segundo those companies can be located. This measure allows dispensaries only in a small specific area on the city's east-side - away from schools, residential neighborhoods, public parks, playing fields, and major thoroughfares. Specifically, you will not see dispensaries west of or on Pacific Coast Highway. In addition, this measure retains local control about who can operate within the city and where.

We feel that if the voters want to have dispensaries in El Segundo, that this measure will allow it to happen with the least amount of negative impact to the community, in a responsible way, and maintained local control. •




Check It Out Picture Book Spotlight: *Pirate Dinosaurs*

just chosen not to do so at this time." Added George, "And from what I understand also, it's not very costly to add those two monitors the city attorney is referring to, so we will continue to press them on that."

Earlier, during the Public Comment portion of the meeting, a resident asked for more information regarding the El Segundo Police Department's internal review of an incident in late May in which a reported unresponsive driver with a reported handgun parked on Center Street near two public schools during daytime hours eluded the response, which included police officers, K9 units, armored vehicles, drones, and crisis negotiators. The resident said that the subsequent arrest of the individual believed to be the driver in question was not an adequate explanation of what had transpired. "For you to continue to do nothing and allow trust and faith in our government to continue to drop, and allow public doubts about whether there will ever be any real accountability for law enforcement to continue to grow, I think that we can all agree that is not a good outcome here." In response, George told City Council he had "fully reviewed" the report and appreciated ES Police Chief Jaime Bermudez' efforts "toward identifying what shortcomings were identified. There were several items in the report of recommendations to improve efforts." He said he'd speak with the chief "about potentially making the report available and get back to the council on that."

In other news, the city accepted a \$75,000 grant from Chevron for economic development, bringing the total dollar value the oil company has provided the city during the last ten years to \$1.3 million approximately.

Mayor Drew Boyles asked questions to which George and City Attorney Mark Hensley responded. When asked about potential state legislation that would authorize an air quality management district to require and enforce the presence of specific air monitors that detect specific chemicals in the air at wastewater plants (like they can do with refineries), Hensley noted that the state legislature is a couple of months away from being in session to work on such matters.

Of the two recent samples taken by Hyperion, George told City Council, "It's my understanding that the samples do not include any testing on the presence of H2S (Hydrogen Sulfide) or NOx (Nitrogen Oxides) fumes. So, they have been hesitant about including those other two tests for those chemicals. We are pressing them on that." Hensley added that according to the city's Public Works Director Elias Sassoon, Hyperion has the ability to test for such chemicals. Said Hensley, "The monitors they have, at least the hardware can plug in these different monitoring devices. They've that is offered jointly with the Federal Aviation Administration. That change to the city code will be brought back to be approved by the council at their next meeting on Oct. 18.



support a recent budgetary adjustment that allocates \$450K in discretionary funds for additional patrolling services. With regards to electric bike safety, I believe we need consistent education for residents along with warnings, and ultimately citations for dangerous behavior on the roads or sidewalks. As parents and residents, we have a community obligation to assist Police Chief Bermudez and Fire Chief Lee in reinforcing such safety efforts.

Robin Patch: I am pro Law Enforcement and believe in providing more resources to the ESPD, including additional personnel. Addressing crime in the City is my primary policy concern. In the last two years auto-related thefts and armed robberies have increased significantly, and many residents feel there is not enough police presence to combat the spike in crime. In my opinion the ESPD is understaffed and needs more Officers so that police can increase patrolling across the City, especially in areas where thefts are more prevalent. In regard to electric bikes, I propose creating a program that would require all electric bike owners to register them with the City. This would provide additional revenue for the City and make it easier to cite bike riders who break traffic laws. In the case of minors, parents would register the bikes and would be held liable for citations if their children impede public safety.

John Pickhaver: If people aren't moving to El Segundo for the schools, they're moving here for our public safety reputation. In addition to partroling, we must strengthen our outreach with residents regarding best practices they can take to avoid being a victim of such crimes. As far as ebikes, we need to understand the way people *move* is changing. Therefore, the City must adapt and become more friendly to bikes, ebikes, and E3s (golf carts). At the same time, operators of these vehicles must understand they do NOT rule the roads. We need enforcement of safety regulations and a public education campaign around the safe use of operating and interacting with these vehicles on the road to prevent accidents from occuring.

Chris Pimentel: Regardless of statistics, none of us feel safer than we did ten years ago. From 2016, California voted to release criminals from prison and made it difficult to return them. In effect, thefts of less than \$950 ceased to be crimes. Bikes, catalytic converters, packages, and retail items are treated as petty. The Mayor, Police Chief, City Manager, and I met with the District Attorney and Deputy District Attorney to get more arrests prosecuted. We've seen benefits, but time will tell if the dip in property crimes continues. As the pandemic subsides courts and jails are open, and that should help.

Quality of Life issues, those below the level of criminality but violate the municipal code, are priorities. We are hiring an additional Code Enforcement officer and have fully budgeted for park staff; roles that take pressure off police. Electric bike interventions are occurring, and we are adding "returning" police.

3. The joint use agreement with ESUSD has been extended for more discussion. What is your position on this agreement and relations between the city and school district in general?

Ryan Baldino: From providing library services, crossing guards, and police resources on our campuses, there is a long history of our city supporting our schools. While I understand the view of those who want to run it like a business and debate a cost benefit analysis for city contracts, I am The renewal of the facilities joint use agreement is crucial to support our student athletes as it guarantees access to city fields for baseball, courts for tennis, pool space for water polo, and other equipment and space for all of ESUSD sports programs. Athletics are one of the great things our schools offer our kids as participation in sports instills valuable life lessons that cannot be taught in the classroom. I will work to ensure the City and ESUSD always maintain a healthy and supportive working relationship.

Michelle Keldorf: I am often asked how I feel about the relationship between city leadership and our school district. Like many other families, El Segundo's school system was a big factor in our decision to move here. And, while they are separate and distinct entities, there is no doubt that we share an important and mutually beneficial relationship. Our community is strong because of our schools and our schools are strong because of our community. Students deserve the guarantee that they will have continued access to city-owned fields and sports courts. And residents, particularly youth sports leagues, rely on school fields for recreational activities. Approving a longterm joint use agreement with ESUSD is necessary to ensure this stability.

Robin Patch: Creating more opportunities for youth in ESUSD, especially High School Students, is a top priority of mine. I am in favor of extending the joint use agreement with ESUSD and would like to build a stronger relationship between the City and School District. One of my proposals is to establish an official City-sponsored internship program, so that High School students can gain real-world experience via volunteering. This would provide an excellent opportunity for the City to become more involved with the School District and for youth to improve from page 2

care for Elementary School students. I am a single mother of three and understand parents' struggle to find affordable care for their young children. I propose that the City establish a liaison with ESUSD to create strategies to combat this issue that so many parents face.

John Pickhaver: Our schools are the heart of our community. It's why families move here and it's why businesses set their headquarters here. The City must be an ongoing champion of our schools and ensure that we support them in any way we are able so we can remain the destination district we've been for decades. I was disappointed to see that the joint use agreement was extended for more discussion. Stakeholders from both sides spent considerable amounts of time working out the details of this deal all in good faith. As a Councilmember, I would make approving the joint-use agreement a top priority.

Chris Pimentel: Families in general, and schools in specific, anchor our community. The concept of joint use allows us to share amenities that serve the 3,000 students the community and the 13,500 non-students. These range from library attendants, youth sports on school fields, pool access, etc. Balancing access to our finite resources involves engagement and communication. Joint School Board - City Council meetings are an important part of these. The current agreement is being extended largely because the school's physical structures are changing so radically. The \$100 million update of the school property will have direct and indirect effects. With the addition of a gym, and removal of soccer fields, where does that use go? With a tennis team but no tennis courts, how do we balance these uses? These decisions warrant informed discussion when the constructions is complete so that our


