Napolitano Hopes to Take Problem-Solving to Next Level

While still a college senior at Loyola Marymount University (LMU) in 1990, Steve Napolitano opened up a newspaper and learned it was the last filing day to run for the Manhattan Beach City Council. Born and raised in the South Bay coastal community and a resident there to this day, the then-24year-old had seen first-hand various changes over the years that didn't sit well with many of the locals. "We went from a little beach town with low-profile development to one where people were coming in and tearing down the old beach cottages and putting up huge homes that covered the entire lot that they would then sell on spec," Napolitano recalled. "I decided I had a choice to either just complain about the way things were going in the city or do something about it."

So with just two hours to get his paperwork together before the deadline, Napolitano scrambled to compile the minimum 20 signatures from registered voters required for him to make it onto the ballot. He managed to do so and filed in the nick of time—only to find out that one of the "voters" on the list was not registered after all, thus nullifying his submission. Rather than wait another two years to give it another shot, Napolitano opted to run as a write-in candidate. "That's not an easy thing to do when your name is Napolitano," he said. "People have to write your name down correctly on the ballot and punch the hole. A friend and I went doorto-door across the entire city—something nobody had done before—and spent about \$1,200. I had a whole lot of ballots thrown out for misspellings and hanging chads before anyone else knew what a hanging chad was. I beat one of the incumbents, but finished in third about 100 votes away from victory."

Undaunted, Napolitano joined a commission soon after the election and ran again in 1992—this time garnering the most votes and becoming at 26 the youngest person ever elected to the Manhattan Beach City Council. He won again two more times before terming out in 2005. During his lengthy tenure, Napolitano initiated a number of "firsts," including emergency call boxes, campaign finance reform, a tree ordinance, required

postings of construction site rules, and the volleyball walk of fame, among other items. "We reduced bulk and density in homes, protected our environment through our innovative 'Ocean Safe Campaign,' created a private/ public partnership that resulted in the Metlox project, built a new public safety facility, redid The Strand, created playing fields out of TRW parking lots along Marine Avenue, and rezoned Rosecrans from industrial uses to allow commercial development. We were also one of only three cities in the state to

Foundation CEO Carol Pirzstuk; and an appearance by GB Architects representative David Bannon and team regarding the process in place for the planning and preparation of a long-range facilities master plan for the ESUSD.

The meeting also introduced to the audience new Board member Nancy Cobb, who won election to the Board during the

November 3rd election. She will be sworn in at the next Board meeting, which is on the docket for December 8.

Mancilla's presentation included a snapshot of where the High School is currently with respect to statewide standardized tests as well as where the school needs to improve according the findings made during last year's accreditation visit by the Western Association of Schools and Colleges.

The Apple "Distinguished School" presentation recognized the High School for the successful implementation of its 1:1 Individualized Technology Initiative, which facilitates "unprecedented access to curriculum, the Internet and apps by





Referencing the November 3rd City Council meeting and the November 5th El Segundo Herald regarding the two public input speakers on the matter of the police officers union contract.

Her husband's base salary in 2014 was \$79,836 and with overtime and special compensations his total earnings were \$113,891 –source the City's website El Segundo.org. Speaker No. 2 is a city police officer. His 2014 base salary was \$79,836 and with overtime and special compensation his total earnings were \$136,785, same source as above. City Statement Related to Ongoing Labor Negotiation

The contracts for the labor groups in the City of El Segundo expired September 30, 2014. With the expiration of those contracts, the previous benefit reductions, or "cuts", have expired and pay and benefits have generally been restored to previous levels. In addition, the Police Officers Association (POA) received a 1.8% salary increase during this period.

The City Council began comprehensive evaluation of labor issues shortly after the election in April of 2014. This evaluation looked at total compensation including salary, special pays and benefit costs. The challenge facing the city is balancing the desire to provide competitive total compensation against the variety of financial demands, including: services, buildings, streets, sidewalks and equipment.

The expenses associated with providing our workforce are significant. The city currently spends approximately 80% of its general fund budget on employee salaries and benefits. The cost associated with providing pensions is over 10 million dollars per year. In the case of public safety employees, the pension rates have increased 73% over the past 5 years and will continue to increase as CALPERS stabilizes its investment portfolio and passes costs onto cities.

In order to develop a consistent approach to discussion of total compensation with employee groups, the City Council has developed the following Guiding Principles:

- The City is assessing the status of the salary and benefits provided against similar positions in nearby cities with the intent to be competitive.
- The City seeks to create greater equity among the labor groups with respect to this competitive status.
- The City seeks to simplify the labor contracts to be more transparent and logical related to the compensation and benefits provided.
- The City is asking employees to pay their share of their retirement costs.

In order to ascertain the City's competitive situation, a comprehensive compensation study was prepared by a 3rd-party firm that looked at total compensation provided in El Segundo and 11 other nearby cities. The survey, along with other compensation information, is available

on the City's website at www.elsegundo.org. The general findings of the survey found that:

- The total compensation for police and fire personnel is among the highest of the survey cities. A significant amount of the total compensation for police and fire is provided in the form of special pays;
- The total compensation for general employees (not including police and fire personnel) was at or below the average provided in the other agencies.

To date, progress has been made towards resolving a number of issues. The City has reached a tentative 3-year agreement with the Fire Fighter's Association. That agreement will:

- Freeze or eliminate most special compensations for current employees while eliminating them for new hires;
- Reduce retirement related expenses as well as expenses associated with overtime and leave payouts; and
- Provide a 2% salary increase in the second year of the agreement and a 3% salary increase in the third year of the agreement.

With respect to our police employees, the City and the POA have been meeting for nearly a year and a half, since June of 2014. The City has proposed an MOU that:

- Freezes or eliminates certain special pays for current employees and eliminates them for future hires;
- Reduces the City's expense related to overtime and leave payouts; and
- Increases the amount that each employee contributes to their retirement costs and provides salary increases to partially offset the retirement contributions.

Unfortunately, the City and the POA have been unable to reach agreement and we are now at the point where we are at impasse. The next steps include mediation and 3rd-party fact-finding followed by a City Council decision on whether to impose the City's offer. This process typically takes 3-4 months to complete.

The City Council's desire is to reach agreement with all of our employee groups in the near future and refocus on the issues and challenges facing the City.

Film Review

AFI Fest 2015 brings Tale of Tales, **Disorder, and James White**

As each fall season brings the year's Academy Award-vying Oscar hopeful films, so to brings AFI Fest presented by Audi, which CINEMACY attended this former weekend. Held in the heart of Hollywood at (formerly Grauman's) TCL Chinese Theatre, the film festival features an impressive range of diverse films and special make folklore so timeless. Tale of Tales, the English-language debut of celebrated Italian director Matteo Garrone (Gomorrah) is the twisted fairy tale fantasy that cinema needs right now. The film takes three fairy tales of unorthodox royalty from Garrone's homeland and remarkably reimagines them as stories happening in neighboring kingdoms. There are

Tale of Tales by Jasper Bernbaum


For the entirety of this decade, studios have been dusting off the storybooks of lore. The myths of beanstalks and glass slippers have been twisted into dark and angsty spectacles for the post-Harry Potter world. The results are quite fantastic visually, and - hey, the box office may very well speak otherwise - however, there has been a lack of merrymaking that kings who keep giant pet fleas, princes born from the blood of sea monsters and witches whose milk turns the elderly young again. Tales is dark, twisted and bonkers, with a pitch black sense of humor to boot. A far cry from Garron's more celebrated works, though a welcome addition to this decades affinity with our classic fables. Tale of Tales will be distributed by IFC Films.

Disorder by Morgan Rojas

Eagles Playoff Bound

It's been a successful fall season of sports for the El Segundo Eagles. The boys' water polo team and the girls' volleyball team qualified to advance to the CIF Southern Section playoffs. Both boys' and girls' cross country teams will advance to the CIF prelims after doing well at the Ocean League finals while the football team was 8-2 but did not advance.

The water polo team tied with Santa Monica for the Ocean League title but lost the coin flip and will advance as the number two team. The girls' volleyball team finished in second place in the Ocean League.

Head football coach Steve Shevlin's team was looking for program's eighth consecutive appearance in the post season. The Eagles finished in a three-way tie with Lawndale and Hawthorne; both teams are teams they lost to and an at-large bid might not have been in the cards. With the mounting injuries that the team suffered in the Culver City, Hawthorne and Lawndale games it was probably just as well that they'll be sitting out this year's post season.

Coach Shevlin was still upbeat but torn with his team not advancing. "We've had a lot of success (wins) but we all realized where we'd be playing. Playing with a patched together team probably isn't the way we want to remember this season and then getting annihilated without our best team on the field."

Shevlin was speaking of most likely going on the road and playing one of the top seeded teams such as top ranked Calabasas and their 27 transfers they've brought in in the past two years. Without the team's starting quarterback and three starting linebackers as well as an offensive line that has been decimated with injuries it just wasn't in the best interest for the Eagles.

El Segundo wrapped up their football season with a 49-7 pounding of Santa Monica to finish the Ocean League 3-2. For a team that looked so good against the Vikings and finish 8-2 it will look odd not seeing the team in the playoffs, but Santa Monica wasn't very good and it reflects in their 0-10 record on the field (they did have one loss converted to a forfeit win).

On Senior Night this game was dictated and predictable from early on. The only thing the Eagles lost was the coin flip and the Vikings deferred. Their on-sides kick to start the game back fired but the Eagles failed to take advantage of great field position. After failing to pick up a first down the Eagles' punt backed the Vikings up on their own 2-yard line. On the first play a bad snap rolled out of the end zone and the Eagle's rout was on.

Dodgers Prepared for Changes

The World Series is now over and the Kansas City Royals are Major League Baseball's 2015 champions. Even though the sport is now weeks into its offseason, teams like the Los Angeles Dodgers are intent on using this "down time" to attempt to better their lineup and team as a whole. While football and basketball are currently dominating national sports headlines, baseball is using awards and big-name free agents to attempt to stay relevant in the minds of America, despite the long, impending offseason.

There is certainly no doubt that the Dodgers will be at the center of award and free agency talk this offseason. The first casualty to Southern California's baseball offseason, though, was undoubtedly Don Mattingly. After five seasons at the helm of the Los Angeles Dodgers, including three straight NL West titles and one NLCS appearance, the Dodgers front-office decided that it was time to move on from the former New York Yankees great. While Mattingly was great in the regular season, managing the Dodgers to a 446-363 overall record, he was quite awful in the postseason. With an 8-11 record in the fall, Mattingly clearly fell short of

expectations. Managing a \$300 million roster in the regular season may not be the hardest thing to do, but getting the team to win when it counts most is clearly something that just wasn't happening for the Blue Crew. Mattingly ultimately signed with Miami to be the new head coach of the Marlins.

The Dodgers head coaching position is currently left vacant as the search continues for the next person to be placed under immense pressure and scrutiny as they inherit a perennial playoff team. Among the names at the top of the list are former Dodger great Kirk Gibson, former San Diego Padres head coach and Angels pitching coach Bud Black, Dave Roberts, and Gabe Kapler. The Dodgers have been outspoken about their willingness to take their time with the search. Perhaps a more looming question, however, is what may happen with the roster.

The biggest decision that the Dodgers have to make this offseason is whether or not to throw money at last year's Cy Young Award favorite, Zack Greinke. Greinke recently opted out of the final three years and \$71 million of his remaining contract with the Dodgers and filed for free agency. The move was expected.





achieve a AAA bond rating—and there is no better measurement of fiscal responsibility."

Now no longer the new kid on the block, Napolitano hopes to make a difference on a broader scope in his quest for a seat on the Los Angeles County Board of Supervisors to serve the Fourth District. If he succeeds, his goal is to build on the legacy of Supervisor Don Knabe who will leave the County in 2016 due to term limits after 20 years. Napolitano has served as Knabe's long-time Senior Deputy, originally joining the team only a month after departing the Manhattan Beach City Council. "When I got the call from Supervisor Knabe, I saw it as a great opportunity to do what I had done in Manhattan Beach on a bigger scale—work to make a difference, make things better, and give a voice to those who felt they had none," he said.

Over the past decade, Napolitano has become a fixture at countless events in the South Bay as the Supervisor's representative and point person for El Segundo, Hermosa Beach, Lomita, Manhattan Beach, Marina del Rey, Playa del Rey, Redondo Beach and Torrance. More than that, though, he views himself as a problem-solver who oversees several departments (e.g. Beaches and Harbors, County Counsel, Arts, Museums, Libraries) for the Supervisor as well as economic development, transportation and environmental issues. Listing some key accomplishments for the Fourth District, Napolitano noted that he helped create the County's new Business Concierge program, worked to reduce film permit fees, and averted a major problem after the Health Department suddenly decided that snack stands at Little League fields had to meet the same rules and permit requirements as standard restaurants. "Working quickly with the Health Department, the Supervisor and others, we were able to get new rules in place to keep the snack stands open without the onerous restaurant requirements," he said.

Napolitano added that he worked on several environmental and green initiatives, leads the Supervisor's \$45 million Operation Libraries project, administers Knabe's Arts Education Partnership Program that provides grants for many area schools, and oversees the LA County Arts Commission. "In tracking the legal issues that County Counsel has to deal with, I also review and make recommendations to the Supervisor on the many practical and legal issues facing the County, including jail reform and use of force issues, improvement in our healthcare system, and the County's foster care system," he said.

The arts and legal realms were no strangers to Napolitano. While still serving on the Manhattan Beach City Council, he parlayed his Fine Arts degree from LMU into a freelance graphic design position that he eventually put aside in order to study law. He passed the bar in 2000 and practiced education law until 2005. To top it off, Napolitano was also a substitute teacher for the Lennox School District while attending Loyola Law School.

Looking at the issues that face the County moving forward, Napolitano pointed to the need to address rising crime in the wake of the AB109 and Prop 47 legislation that have upped the rates of offenses throughout the South Bay and beyond. "We haven't been able to recruit enough sheriffs to address the problem," he said. "I want to work with the Sheriff [Jim McDonnell] to increase hiring, including a veterans hiring initiative."

Another stated priority is for the County to get its fair share of transportation. "The Fourth District is a net donor to the Metro [Metropolitan Transportation Authority] system because LA City has the votes and gets the money for their projects," Napolitano noted. "It's time to expand the Metro board for better representation and a fair allocation of resources so we can expand rail to LAX, the east and the south.'

Napolitano also spoke of the importance to "protect our most vulnerable"—looking after children, seniors and veterans in need as well as addressing a recognized crisis in homelessness. He called for diversion programs, as well as housing, to help these people—along with a way to track those programs and ensure that the money spent leads to positive results.

Calling it the "best anti-crime program" as well as the "best employment program," Napolitano stressed that it is also critical to support early child education. "We're facing shrinking resources and need to look at prioritizing prevention through early childhood education in addition to diversion for long-term success," he said. Napolitano additionally pledged to continue Knabe's efforts in supporting the Safe Surrender program and keeping up the fight against sex trafficking.

Napolitano explained that he applies certain values to all of his decision-making--first and foremost putting people and communities first by solving problems, keeping citizens safe, supporting non-profits and always being accessible. "We need to make LA County more business-friendly and jobs-focused," he said. "I want to continue to find ways to reduce costs and regulations to get businesses running and keeping them running."

Napolitano emphasized the need to protect the environment by reducing air and water pollution, creating more open space, recycling/reusing, and taking the lead on water conservation. Other focuses include fiscal responsibility by making sure the County does not spend more money than it has; not approving taxes without a vote of the people; and making government smarter, more open and accessible. "Dealing with the County should be as easy as dealing with Amazon," Napolitano said. "We need to use technology to better engage the public and measure our programs and adjust for improvements."

Next fall's election will include no less than races for President, State Senate, Congress, and Governor. While Napolitano acknowledges that citizens will have huge choices to make across the board, he believes that the vote for Supervisor will be the most important one for those living in the Fourth District. "They'll be electing one-fifth of the governing body of the nation's largest county with over 10 million people, a \$27 billion budget, and the 19th largest economy in the world," he explained. "No other level of government has a bigger impact on people's daily lives than LA County—from public safety to transportation, from education to the environment, from the local economy to healthcare, to the arts and beyond. LA County does it all, and the politicians and special interests are scrambling to create a supermajority to take over the Board and its budget. That's why it matters who gets elected next. This isn't a job you inherit. It's one you have to earn. I'm not a politician. I'm a problem-solver with 25 years of experience in local government who wants to keep LA County working for all of us..." •

with older and better players."

ex-soldier suffering from PTSD, who has been assigned to provide personal security to a highprofile and possibly-shady businessman's wife, Jessie (Diane Kruger, Inglorious Basterds) and her young son, Ali. Struggling to keep his traumatic past behind him, and despite piercing bouts of panic attacks, Vincent's paranoia serves as foresight when masked men forcibly put his and the lives he's promised to protect in danger. Schoenaerts and Kruger create a quiet sense of unrest throughout the film, adding person and emotional tension between the two against the backdrop of the suspense of the film. With the sharp sound design from electronic music-maker Gesaffelstein, Disorder falls into the same vein as other traditional Hitchcockian films: progressively stylized and a great character study into the mental landscape of a man unhinged. With distribution from IFC Films, look for Disorder to release in theaters in March 2016.

James White by Ryan Rojas

One of the most incredibly acted films to play in the "American Independents" section of the festival was the altogether arresting *James White*, which also astonishingly counts as the first feature film from Josh Mond (*Martha Marcy May Marlene*, Producer). Told in month-long

chapters during one New York winter, White is the story of a son (Christopher Abbot) whose estranged father's death and mother's (Cynthia Nixon) cancer diagnosis forces him to confront his personal demons through self-destructive and reckless behavior, which risks his own demise. As the titular character and lead role, Abbot is given a wonderful opportunity to showcase his talent in a movie vehicle unlike any before (fans will remember Abbot as controversially leaving the HBO critical darling Girls, for reasons unclear), and that he does. Abbot, whose unhinged and drunkenly erratic behaviors - evocative of a Streetcar-era Brando - match the reflective and quietly powerful moments as a heartbroken young son, gives an incredible performance not soon to be forgotten. Cynthia Nixon also stuns in delivering some of the best work of her career as a single mother battling cancer in its ugliest and heart-wrenching forms. Josh Mond's highly personal story (while not a direct autobiography, the story is lifted from very similar personal experiences) reveals in incredible fashion hardship and the human spirit, and should serve to boost the filmmaker and his actor's profiles with even more recognition to come. James White opens in LA on November 20th. •

Greinke is coming off of a remarkable year in which he went 19-3 with a 1.66 ERA to lead the National League. In his three seasons with the Dodgers, Greinke amassed a 51-15 record and 2.30 ERA. He's certainly worth the money that he'll undoubtedly be searching for on the free agent market, but don't expect the All-Star to give the Dodgers a hometown discount. Before coming to Los Angeles in his last free-agency period, Greinke famously quoted, "Money is obviously the No. 1 thing. I could play for the worst team if they paid the most. ...If the last-place team offers \$200 million and the first-place team offers \$10, I'm going to go for the \$200 million." At least he's honest. The Dodgers, after all, were a horrible team when Greinke first stepped foot on Chavez Ravine's mound as a homeplayer. All-in-all, don't count out the Arizona Diamondbacks or Philadelphia Phillies if they offer more than L.A.

Clubhouse managers and Greinke aside, the Dodgers will have other decisions to make this offseason as well. Decisions like who to go after in free agency. They need a major boost at the back end of the starting rotation (especially if Greinke's gone), their bullpen needs a complete overhaul, and they can use some more pop in the lineup. David Price, Scott Kazmir, Johnny Cueto and Jordan Zimmerman head a list of the most highly touted starting pitchers that the Dodgers could go after. Jason Heyward is a young outfielder that can give the Dodgers the pop in the lineup that they need, and he is tremendous defensively. The 24-yeard-old utility man could become the Dodgers everyday second baseman next season. They may need it. Neither Utley, Kendrick or even Jimmy Rollins, for that matter, gave the Dodgers the defensive strength up the middle that the front-office predicted that the players would. Hernandez is no Ozzie Smith, but a serviceable job at the position will get his bat into the lineup on an everyday basis.

The Los Angeles Dodgers very well could look like a completely different team next season. They're already well on their way. With a new manager set to take over any week now, the Dodgers should be looking at a way to compliment their new skipper with an offense that isn't led by Adrian Gonzalez in every single statistical category and pitching that isn't completely reliant on one or two starters only. The Dodgers have been good for some time now - skating through the NL West for what has now been three straight seasons. An NL West pennant isn't going to get you into the record books. It's time for the Dodgers to take the next step and spend their money wisely to put together a team that is going to win Los Angeles a world championship. •


