CPA Larry Mitchell Has Found His Home in El Segundo

When Kris Cindrich first met El Segundo CPA Larry Mitchell during their college years, Cindrich said that Mitchell did not look like a guy who would excel in the accounting field and later pilot his CPA firm. It seems that Mitchell and Cindrich were assigned to a workgroup in one of their college classes. Mitchell, said Cindrich, "had long, blonde hair, a bandana, and looked like one of the 80's bands metalhead guys. Look at this guy," he thought when they first met. The workgroup consisted of five members, and once Cindrich found out he would have to collaborate with Mitchell, he remembers thinking, "not this guy, anybody but this guy, but as it turned out, he was great." Cindrich, who is also a CPA, and Mitchell soon became fast friends. Segundo Saxes Quartet Shares Music in El Segundo

Every now and then, enhancing the ambiance of small-town El Segundo, residents get the chance to hear the smooth tones of a saxophone scoring their walk through the farmer's market or stroll down Candy Cane Lane. For over a decade, Segundo Saxes, an amateur sax quartet based in El Segundo, has rehearsed and played everything from classical music to Black Sabbath at shows and events around town.

The Segundo Saxes was formed in 2006, sponsored by the South Bay Music Association (SBMA). After the original quartet split off about twelve years ago, the group's current longest-standing member Dave Young took over responsibility for the Saxes and saw them through several member changes, dozens of performances, and a slate of music reaching across decades and genres.

"I've been an amateur musician since junior high school," says Gold, "I'm 62 now, and so I would've been playing the sax for something like fifty years." According to him, unusual for a saxophonist, Gold does not play any other instruments outside some percussion. Though he started with winds and strings in junior high, he picked up the saxophone at his brothers' suggestion after they told him it was a "cool instrument."

Lady Eagles Look to Repeat Soccer Title

El Segundo's Cinderella 2021 season was a magical one, to be sure. They weren't picked to win their first league title since 2008-09, but they had the talent to get the team back to the playoffs for the first time in three seasons. El Segundo got into the playoffs as a third-place team, and from there, the Eagles discovered that they not only could compete at a higher level, they could win. Head coach Skip Jones says something sparked his team after their first-round 3-2 overtime win against highly touted Granite Hills. "After that first-round win, on a cold, windy day on the road, we knew something special might be in the works."

This season the Eagles will have a bullseye on their back, says Coach Jones. "We from Division 3 to Division 4."

What has the team done to prepare for the upcoming season? A group of seniors organized twice a week practices which were open to all levels and all players. A majority of the players participate in either club or recreational soccer, and most have been involved in cardio workouts.

The Eagles have plenty of talent returning. The team returns eight starters and a few others who played a major role off the bench. Returning starters include Chelsie Charles, the CIF Player of the Year, Michaela Turner, Jaden Fode, Ciera Doggett, Holly Wilbanks, Barcelona Heredia, Isabella Munoz, Charlie Gerson, and goalkeepers Delaney McRoberts and Nili Kovacs. In addition, the Eagles get back three players from injuries that would and sophomore goalkeeper Tanner Ijams. The Eagles will look to unseat West Tor-

rance as defending league champions and fend off South High to win the program's first Pioneer League title in 13 years. That's when the Eagles won the Pioneer League title and advanced to the CIF-SS semifinals. They'll lean on their experience and Chelsie Charles' scoring. In winning the CIF Player of the Year award, Chelsie matched her brother Christophe who also won the award in 2018 in the same sport. It's a true rarity that a brother and sister have won the player of the year award in the same sport. You might have to go back to the siblings, Cheryl (1982) and Reggie Miller (1983), who won the CIF Player of the Year award in basketball, to find that.

In C'mon C'mon, Joaquin Phoenix Sees Life Through a Child's Eyes

Watching a Mike Mills film is always a very intimate experience because he draws inspiration from his own life. Beginners was for his dad, 20th Century Women was for his mom, and his new film, C'mon C'mon, is for his kid. Acting as a time capsule of childhood innocence, viewed from the perspective of the young at heart, C'mon C'mon is an earnest and delicate relationship drama that reflects on the importance of human connection.

Johnny (Joaquin Phoenix) is a middle-aged, single man who is consumed with his job as his own nuclear family, C'mon C'mon is an ode to the overall challenges of parenting in the 21st Century. It's easy to see the Mills' school of thought here - the uncertainty and amazement of raising a human being while you yourself are still figuring out how to co-exist in the world.

Joaquin Phoenix gives a phenomenal performance as Johnny (a man who Mills admits is partly based on himself). Phoenix's organic embodiment of the character and emotional translucency is on full display. British-born Woody Norman is the film's biggest revela-

a field radio journalist in NYC. His current project is interviewing young people about their candid thoughts on the future. His ability to connect with these kids is a foreshadowing of what the universe has in store for him next.

Johnny has a semi-estranged relationship with his sister, Viv (Gaby Hoffmann), so it's a little surprising that she calls him asking for a favor. Viv is desperate for him to watch her young son Jesse (Woody Norman) for the few days she will be gone. Hesitant at first, Johnny sees this as an opportunity to re-connect with the nephew he barely knows. What becomes revealed as Johnny and Jesse spend time together is the epiphany that, despite being generations apart, they are actually more alike than they know.

In addition to being a touching tribute to

tion; with his mop of messy hair, charming doe-eyes, and precocious sensibilities, his ability to hold his own against a Hollywood heavyweight like Phoenix is not only admirable but downright amazing.

Shot by cinematographer Robbie Ryan (The Favourite, American Honey), black & white gives C'mon C'mon an obvious "cinematic fairytale" look that is more intentional than simply for aesthetic purposes. Life, as well all know, is never black or white. We live in the grey. C'mon C'mon also lives in that grey, tackling philosophical issues that have no clear answer and proposing hypothetical questions that receive varied reactions. What Johnny and Jesse navigate throughout the course of the film is a whole lot of greyness-and it's

Sacred Cows and Curries— **Dining Out (or Not!) in India**

It will either infuriate you or endear them to you, but the British, with their astonishing tin ear for foreign languages, have left a trail of odd monikers everywhere they've ventured on the globe. Venice, Florence, and Naples instead of Venezia, Firenze, and Napoli. Frogs for French, Jerries for Germans, Eyeties for Italians. Bombay and Mysore for Mumbai and Mysuru.

In the 19th century Indian Raj, one favorite culinary mangling gave us the term "curry"from the Tamil "kari", which means nothing more than "sauce" or "stew". Even today, tikka masalas are all the rage in England, but the word "masala" means nothing more than "mixture". Neither of these terms, in fact, says a thing about the ingredients in a dish.

But they do key in on one timeless bit of foodie serendipity, which is that roasted and ground spices are the key to Indian cuisine-just like sauces to the French, pasta to the Italians, broiling to the Americans, and chopping and dicing to the Chinese. Every venerable Indian amah guards her secret masala recipe, passed down and augmented through Lord knows how many generations. And at the opposite extreme from fast food, every Indian meal you consume will be a unique product of that chef's family, culture, religion, personal tastes, and mood.

After five years of traveling in India, we no longer buy pre-mixed powders, but roast, grind, and mix our own. We still blend something you'd recognize as curry powder, but only for

western and Jamaican dishes (deviled eggs, anyone?). For Indian food, there's nothing like the aroma that greets the visitor when you throw together a five-course meal with that morning's fresh spices. And it's really not that ambitious.

The possibilities are mathematically endless, but savory Indian dishes start in two basic directions:

Coriander-cumin-turmeric (in the Indian shops: dhanya-jeera-haldi). Mix in a variety of other spices, and you have something you'll recognize as western curry powder.

Cardamom-cumin-cinnamon (elaichijeera-daalacheenee). Start here, and eventually you'll arrive at garam masala.

To these bases, Indian chefs and amahs add saffron (kesar), peppercorns (kalimirch), chili (laal mirch), fenugreek (methi), fennel (saunf), cloves (laung), nutmeg (jaiphal), anise (chakri phool), dried bay and curry leaves (karee pattee), and the seeds of celery (ajavaayan), caraway (shah jeera), poppy (khas-khas), sesame (til), and black mustard (raai). Not to mention asafoetida (don't ask). Not to forget garlic, ginger, onions, tamarind, and tomatoes. Not to neglect ghee (butter), coconut, and yogurt.

Like any other cuisine, there are distinct regional variations in Indian cuisine. On the west coast of America, you'll most likely be familiar with Punjabi, from Northwest India, Kashmir, and Pakistan (think lamb, tomatoes, marinade, Tandoor). The British started out in Bengal in Eastern India, so that tends to See Travel, page 20





Your Neighborhood Therapist

Dear Neighborhood Therapist,

I feel like I am grateful for the things I have, but I still feel guilty about wanting more. And I do want more. I have tried to do a better job of practicing gratitude, but everything I try doesn't seem to be working. I know there are so many people having a hard time out there, and I am worried that I will come off as insensitive, or unfairly ambitious. I feel worse when I try to change the way I feel and can't do it, like there is something deeply wrong with me. Any ideas? – Ungrateful? - El Segundo

Dear Ungrateful: Have you tried eating at restaurants with the word "Gratitude" in their names? How about buying products with clever phrases about gratitude stamped on them? Have you meditated on it? Do you have a gratitude journal and a gratitude mantra hanging over your bed and another one in your kitchen? Try doing all that first. If it doesn't work, read on.

I kid, of course, but for a reason. It is indeed gratitude season, and gratitude is an industry, and if it helps then I am here to officially tell you that you don't have to practice gratitude if you don't want to.

Consider who benefits most from the social norm that we should be thankful for what we have and not want more: anyone who benefits from the status quo. You mentioned you are concerned about inequality, and that seems like a pretty unfair message for those people who live at the bottom of a society where inequality is at record levels.

If you're worried that you don't feel grateful enough, the best way to feel truly grateful is to first experience what it's like not to have comforts and luxuries for a period of time. Are you to spend some time living on society's minimums in wages, healthcare, transportation, housing? Are you prepared to give away your material possessions until others have nearly as much as you do?

Instead of worrying about practicing gratitude, try making it a point to practice decency (I don't mean to imply that you don't do this!). The best way to practice decency is to treat everyone with dignity and respect, always.

That's not as easy as it's supposed to be. We all have our tribes, and as such we tend to think of others as a little bit less than members of our tribe. Yes, in our minds we all dehumanize others to one degree or another. But that doesn't mean we have to treat people as if they are inferior to us.

Even if you tell yourself it's ok for others to have less because - insert your reason here - you don't have to act like you feel that way. Look people in the eye. Thank them even when you are paying them to do a service for you. Ask what they would like and take their word for it. Choose to accept their sincerity even if it sounds ridiculous to you.

It is easier to practice gratitude than it is to help others, and I suspect that nagging feeling you have speaks to your understanding and dissatisfaction with that reality. So treat the problem, not the symptom: find a way to help people who need it. If you do, I suspect you won't find yourself worrying so much about being sufficiently grateful.

Larry Mitchell

University for a couple of years. When his parents moved back to California, Mitchell initially stayed in the Great Lake State, but was soon intrigued by living in California again. Seems he was speaking to his Cali resident brother one day, who was regaling Mitchell with stories about "swimming in the pool in January" while the snow-bound Mitchell was "chipping ice off my window."

Enough of the frigid winters. Enough of scraping icicles off everything, right? Time to head West.

Mitchell soon came to California to live with his parents, but that living arrangement did not last too long. About six months, Mitchell said; at that point, his "construction marauder" parents re-located again, this time to Pennsylvania.

At that point, Mitchell was heading towards attaining his collegiate degree in business, concentrating on the accounting field. Postgraduation, Mitchell moved to Hermosa Beach to work for the accounting firm Deloitte. After a stint at Deloitte, Mitchell concluded that he was not in line for what he termed "the cool jobs" with the firm, so he "bounced around" to a couple of other accounting firms,

He ended up making partner at a Pasadena accounting firm, and in 2001, decided to "go out on my own." He partnered with another gentleman to form a firm based in Santa Ana. Five years later, when the partnership was dissolved, Mitchell landed in a business suite in El Segundo, where he established Lawrence R. Mitchell & Company.

Mitchell said he became interested in accounting back in his Michigan high school days. Not wanting to follow the chosen career path of his father, he assessed his employment options. "Looks like I am good at accounting," he remembers thinking, so he followed that schooling pathway through his graduation at Cal Poly San Luis Obispo.

Mitchell's firm has worked for numerous local businesses, residences, and non-profit organizations. He said that "one of our favorite clients is the El Segundo Chamber of

He also works for the Foundation that spearheaded the fundraising campaign for the aquatics facility built adjacent to the Wiseburn High School.

Mitchell met longtime local Don Brann while they were involved with the ES Chamber. Brann touts Mitchell's civic involvement. "Larry has a long-standing history of supporting local El Segundo causes such as the Chamber of Commerce and South Bay Sports Health and Recreation Foundation," Brann emailed. Liz Odabashian, a former El Segundo resident, currently living in Hawthorne, has worked with Mitchell multiple times. They have been acquainted for more than 25 years. "Larry has such a well-rounded firm and can help with the small and the big," she said. "You feel like you are the only (client). He is going to make sure that whatever you need is done and is done perfectly. I am very thankful that I can not only call him my colleague, but my friend. He and his team contribute a tremendous amount to our community."

So, what does a CPA firm do for its numerous clients? My guess is count and account for stuff, but I am a layperson when it comes to that level of finances. According to the Larry R. Mitchell website, his firm is a "full-service tax, accounting and business consulting firm." That definition works for me.

Suffice to say, Mitchell finds the businessfriendly environment fostered by the City of El Segundo to his liking. And like many who live, work, and play in our town, marvels at the fact that El Segundo remains a well-kept secret. "I am continually amazed," he said, "that so many people do not know the name of the city," and that it is often referred to by outsiders as the area "over there by LAX," not realizing the town is home to Fortune 500 companies and iconic titans of the aerospace industry, with the massive Chevron campus sprawling to the South.

Mitchell and wife Anna had lived in North Redondo until about two years ago, when the couple decided to plant their roots in town, buying a house in the Freedom Park area of El Segundo. Echoing the comments of many residents, Mitchell says he is very impressed with the friendliness of his neighbors, which was not always the case in North Redondo, from front page

he said.

And he also touts the relative compactness of the residential part of town, where he and his wife like to stroll through the city streets, occasionally stopping at a local establishment for a slice of pizza and a glass of wine.

So, Mitchell was asked how did the COVID scourge affect his company. He said that the virus, a death-knell to many businesses, had actually sent his CPA firm's workload "through the roof. CPA firms and that includes all my colleagues, were the first responders to businesses. We do not get any news coverage for this, but if you ask any of my employees, in the year 2020, we actually had never worked more," as reeling business entities struggled to track their finances and struggle to keep their doors open.

When Mitchell is not looking at ledgers and numbers, peering under his green-tinted accounting visor (very, very old-school reference) to formulate the best possible financial outcome for his clients, what does he like to do? He said that he and Anna like to retreat to their cabin in Big Bear to decompress. Mitchell said that buying the Big Bear cabin was "the best thing that we ever did." He also likes to partake in wine-tasting excursions and, as mentioned earlier, yearly "get-out-of-Dodge trips" with longtime friend Cindrich and assorted mates, as well as just enjoying the colloquial charms of El Segundo. Basking in the two-to-three times weekly three-or-so mile walks around the local environs with Anna, walks that had helped Mitchell dissolve ten-or-so of the fifteen pounds that he said that he gained when the lockdown started.

the name suggests. A saxophone quartet is a musical ensemble that contains four saxes, typically: soprano, alto, tenor, and baritone. As Gold describes it, players are encouraged to improvise and are often highlighted in solos during performances. Because the instrument is so flexible and the quartet is able to build off the other members, all kinds of music are explored by the Saxes.

"We play classical music as much as we play show tunes. We play rock. We play popular tunes, you name it," says Gold. He describes one recent concert of his, *A Brief History of Jazz*, as a journey through the different eras of jazz music throughout the decades, from the roots of jazz and gospel and the blues to ragtime big band and swing to Bebop and Bossa Nova, all the way to modern electronic pieces. He followed that up with a concert playing all of Beethoven's 3rd symphony.

Many of the quartet members have played in the El Segundo Concert Band, a local community band that produces three to four family-friendly concerts a year and which is also a part of the South Bay Music Association.

In 2014, the SMBA was officially formed and had blossomed into the organization it is now. Today, the association provides mini-grants for alternative music teaching methods due to Covid-19, scholarships for student musicians, private lessons, free music concerts, and inschool musical clinics by professional musicians.

A former president of the association himself, Gold explains that the SBMA is a registered 501(c)(3) nonprofit organization that helps to fund music teachers and programs in El Segundo. The SBMA started in 1998 as a group of a dozen El Segundo parents of band students performing "Louie Louie" as a surprise for their kids. The group loved it so much that they formed the El Segundo Concert Band.

At any given time, the Concert Band is comprised of about 20% of high school students who qualify to join. The band and organization offer music mentoring and encourage all younger members to continue their

musical journey.

Every February, the group hosts an annual Comedy Night and Silent Auction to benefit the El Segundo High School Eagle Band. again, safely.

Often playing civic events and local shows for veterans, the Segundo Saxes are also available for hire for public or private events. All

Gold says that the Segundo Saxes rehearse often and thoroughly to ensure that their performances are the best they can be. The pandemic threw a wrench in the quartet's plans. Members shifted, and the number of shows dipped as gatherings dwindled. The last show the quartet was able to play was at a luncheon for the Daughters of the American Revolution in Palos Verdes less than a week before everything was shut down.

"It could have been a disaster...seriously a disaster," he says. Thankfully, as Gold continued to follow up with them long after the show, no members present at the luncheon contracted Covid from the gathering. As everything opens back up, Gold says the Saxes are ready to roll

tion, so in addition to helping fund a local community program, booking the quartet is also tax-deductible.

Currently, the Segundo Saxes are focusing on filling the fourth seat of the quartet after some scheduling conflicts, and pandemic interference caused two members to leave. With the addition of a new member, the Saxes are hoping to play at the upcoming Candy Cane Lane, pending Covid restrictions and permissions. As the Segundo Saxes continue to develop, Gold expresses his hope of supporting music education and sharing the sounds of the saxophone with the community.

dominate their preferences (the color yellow comes to mind). One of our favorite styles originated in Kerala in the south-think seafood, chilis, and coconuts. In the big cities like Mumbai and Delhi, you'll find everything from extremely sophisticated (and expensive) inter-regional feasts to some of the most renowned street food in the world.

Four common threads run through most Indian cuisine:



Best seat in the house for Mumbai street food from Bademiya. Not a lot of chilis:

As Westerners, we naturally expected our mouths to demand CPR after every blistering bite, but most Indian cooking is actually quite mild. And subtle. Even coconut, which can overwhelm a Thai curry, is held on a tight leash. There's a spice in everything you eat, but if one taste (cumin?) blows away the others, you might want to request an upgrade. Not a lot of alcohol:

Alcohol isn't necessarily banned, especially at the big western hotels. And in Maharashtra

and Karnataka, India boasts two of our favorite wine regions on the planet. And there's nothing for atmosphere quite like a gin and tonic on a steamy afternoon at a crumbling colonial tennis club. But Indians just aren't big drinkers. Most of the time, with our meals, we take a spectacularly refreshing mango lassi (mango, yogurt, cardamom, and mint). Not a lot of meat:

14% of the country is horrified by the taste of pork. 80% reveres the cow for befriending and comforting the deity Krishna through his

ancient tribulations. Unfortunately for fish, sheep, and chickens, their ancestors never made the honored (or dishonored) lists-but there's 30% of the population who don't much care for consuming any living being. So this is an easy (if less than doctrinaire) country to be a vegetarian. Again, there are exceptions, and you can find pretty much any meat in some obscure corner of the culture. But as a visitor, why would you want to? We consume as much as we want, but no one ever suffered a guilty conscience from gorging on vegetables. Not a lot of drama:

In general, we expected a much more

complicated relationship with food than we found in India. In a mega-state like Maharashtra, there exists the potential for every kind of misery (New York and London come to mind), but widespread hunger, at least in the urban areas, isn't the scourge it used to be. Obesity is rare, but so is visible malnutrition. Famine has all but disappeared. Indians might not over-eat, but they relish the foods of their culture and will welcome

Maybe someday we'll find out the hard way. Maybe we won't.

So...

As Indian-obsessed foodies, we're just getting started. We did take lunch with one of the premier chefs of India, where the chocolate dessert truffles were served suspended in a magnetic field (we have no idea why, but it took the waiter longer to suspend them than it took us to swallow).



A little of this, a little of that — a midday Mumbaiker Thali with a refreshing plain lassi. your awestruck admiration.

As for the foreigner's digestive adjustment-to put it delicately-that issue has never proved more than vaguely inconvenient for us. We both sport pretty weak stomachs, and face an amoebic challenge flying coast to coast in America, much less to Europe, Africa, or Asia. A week or so before arrival in-country, we start a regimen of probiotics, but only because we drop all inhibitions at the first exotic aroma. And as for ice cubes, brushing teeth, suspicious plastic bottles, and all the other water-based shibboleths, we keep meaning to start paying attention.

But our most memorable meals have been among the least gaudy and expensive. And that is the true secret of Indian food-simple ingredients blended with mouth-watering spices and cooked to perfection. So easy. So relaxed. So good.
