

Council Gets Hyperion Update; Announces Holiday Happenings

In a meeting that snuck in under an hour at about 55 minutes, the El Segundo City Council started with an update on the city's ongoing battle with the Hyperion Water Reclamation Plant. Then they approved continuing with its teleconferenced meetings, heard an update on the city's Certified Unified Program Agency 2022 program, announced appointments to its Diversity, Equity, and Inclusion Committee, and opened recruitment for other city committees, commissions and boards.

The Christmas Eve Dinner first came about in 1983 when then-resident Bill Kaufman started what has become an El Segundo tradition. This year, the El Segundo Rotary Club is sponsoring the dinner, which will

be held from 12-3 p.m. Event organizers are planning for some 75 people. The dinner originated to offer a Christmas Eve Dinner event to those unable to afford their dinner See City Council, page 12

Yadranka Draskovic: Working to Make a Difference in El Segundo

El Segundo's Yadranka Draskovic recently waged a seemingly uphill battle to nab one of the El Segundo Unified School District [ESUSD] School Board seats. Three spots were available in the election that culminated on November 8; alas, Draskovic did not finish in the top three. She was running against the incumbent school board president, a retired ESUSD educator, and two long-time residents of El Segundo.

And, less than a week before the election, her campaign had to contend with a 3/4-page advertisement in this very paper, placed by "former and retiring El Segundo Unified School District Board Members" endorsing four of the five candidates running in the school board election. And none of those candidates were named Yadranka Draskovic.

Draskovic said she was not surprised at seeing the ad, but, after prodding by this scribe, did say, "El Segundo is kind of going through this back-and-forth, tug-of-war if you will. They want to be a more diverse community, they want to be more open, but who did they elect to the School Board? People who have all been entrenched in El Segundo politics, if you will, for years. They did not want to pick an outsider.

"It was pretty obvious that the powers that be," she said, considered her election to the school board "too much of a risk. It See Yadranka Draskovic, page 6



Big Red: A Novel Starring Rita Hayworth & Orson Welles by Jerome Charyn

Classic film stars gallivanting in Old Hollywood – what could be more exciting? Author Jerome Charyn does not let the

reader down in this marvelous tale revolving around the relationship between femme fatale Rita Hayworth and "The Boy Wonder" Orson Welles.

Columbia Pictures head honcho Harry Cohn hires a "spy" to be placed near this power couple of the day. Rusty Redburn, a budding gossip columnist who works in the publicity department of the studio is selected to keep tabs on Cohn's creation: beautiful dancer Margarita Carmen Cansino, transformed into "The Love Goddess" --- Rita Hayworth.

Cohn places Rusty into the position of Rita's personal secretary. She will gather "information" and report back to the Boss on a weekly basis. Almost immediately, Rusty becomes an advocate for Rita by tutoring her in literature so she can overcome her intimidation of Orson's intellect. As she is incorporated into their household, Rusty is swept along into their adventures, including Orson's spectacle, the Mercury Wonder Show. Using the character of Rusty as narrator, the

Sisterhood is Survival in Women Talking, **One of the Year's Most Powerful Films**

It's been a minute since we've seen a memorable arthouse output from Orion Pictures, the production company behind box office classics like The Terminator (1984), RoboCop (1987), and The Silence of the Lambs (1991). Their re-introduction to the art-centric, indie crowd hits a high note with writer/director Sarah Polley's powerful feminist drama, Women Talking. Based on Miriam Toews' 2018 novel of the same name, Women Talking is an unapologetic statement of radical awakening and action, where feminine needs are the focus and sisterhood is an act of self-preservation.

At first glance, it looks as though we've been transported to a remote compound in the early 1900s. Kids running around outside free



from screens, conservatively dressed women unloading goods from horse-drawn buggies, and pencils and paper taking the place of computers. But this is not a time-period piece. This is what an isolated religious community looks like in 2010, as close to Amish as one can get without directly saying so. The audience is dropped into the middle of heightened tension as soon as the film begins – clearly, there are disturbing issues that must be dealt with. A group of women from the community's most prominent families are appointed to sort out the impending dilemma.

The men of the community, who have been mysteriously absent from the compound since the beginning of the film, are accused of sexually violent acts towards the women and children. Outraged and disgusted by their predatory and vile behavior, there is no disagreement from the women the men need to stop. Where it becomes a point of contention is how - or if - the women choose to retaliate.

Within the group are those who want to stay and keep things status quo, those who want to stay and fight, and those who want to leave. The arguments for their varied positions all come back to their interpretation of the Bible, which some take literally while others interpret it more vaguely. Everyone is sensitive to the religious element but that doesn't stop the women from candidly voicing their opinions, no matter how divisive. Acting as the group's secretary is the affable school teacher (and sole male) August Epp (Ben Whishaw), who writes down the points and arguments made by the passionate and illiterate women. Shot almost entirely in the hayloft where these conversations take place, the tension builds like a pressure cooker until a decision is finally reached. See Film Review, page 5





Charyn's alter ego. Jerome Charyn has taught film history and his extensive knowledge of his subject informs Rusty's savvy observations as she navigates the seamy side of the movie business while cracking wise in the faces of the rich as well as those on the long slide downward.

There is so much information for those who enjoy history of the Golden Age of Hollywood. Quickly turning the pages, I questioned how much was fiction and how much was reality. I found myself fact-checking much of the asides and backgrounds only to find how much was TRUE! Sure, there's some manufactured humor, manipulation of events, exaggeration of characters and situations, but much of what you read in Big Red can be verified. There's a melancholy associated with Rita throughout the novel that is rooted in truth regarding her childhood. The author uses that information to imagine later interactions with her parents that are truly painful to absorb. Rita never seems truly able to harness her own star power and allows her lack of self-confidence to put her on a path to ruin. Rusty tries but fails to protect

McNeil, August Winter, and Ben Whishaw give some of the year's best performances. Like a delicately woven web, the characters' lives intertwine amongst heartache, elation, and love. Despite their differing views, they continue their heated conversations for the greater good and immediate future of the women of their community (a gentle reminder that earnest communication can de-escalate many problems).

Resilience is the backbone of Sarah Polley's script adaptation, beautifully realized on the big screen. The film lacks saturation, giving off cool blues and greys, perhaps in an attempt to show how devoid of color and joy this moment is in all of their lives. The trauma these women are dealing with is both felt and seen. Behind the scenes is another strong female force in composer Hildur Guðnadóttir. Her layered, transcendent score builds throughout the entire film until it culminates in a glorious final sweeping shot that will evoke goosebumps. Explosive, euphoric, and powerful, Women

Talking is a passionate piece of filmmaking from all sides. It broaches difficult subject matter with empathy and compassion and encourages audiences to do the same.

was incredibly unfair. Why were they working so hard to keep me out?"

But Draskovic was still optimistic, even after not winning a seat on the School Board, and has not ruled out another run for a spot on the board in 2024.

Her campaign for a seat on the school board was somewhat a Don Quixote experience. Maybe tilting at windmills? "This is a town," she said, "that really likes to stick with the status quo. I was not being naïve, but I was not sure that it would turn out to be as ugly as it was," mentioning that "I got some pretty nasty things written about me on Facebook... but that's OK. I am a confident person, and it is not going to ruin me, based upon what someone who does not know me says on social media."

So, who is El Segundo's Draskovic? She was born in Los Angeles and grew up in Inglewood, moving to El Segundo in the early 80s. Her mother and father are immigrants from the former Yugoslavia, with her mother hailing from Serbia and her father from Croatia. She said her parents moved to the United States because her Dad had an uncle who lived in the States, and it was time for the family to explore other opportunities.

"Even though they were united by Yugoslavia," Draskovic said about her parents, "the two have a very different culture, language, and religion. I cherish my background and think that the diversity I was exposed to at an early age helped develop my character as an adult and interest in travel."

As many do, the family landed in El Segundo because of the strength of the El Segundo Unified School District. Her husband Paul and Yadranka have two sons, Sasha, an El Segundo High School graduate, and Luke, who is a seventh grader at the El Segundo Middle School. attempted to "put my foot in and make a space for [herself]." After graduating from El Segundo High School in 1987, Draskovic matriculated to Loyola Marymount University, where she earned a degree in business administration and history.

Asked why it is important to work for and but because of the pandemic, she thought running a campaign at that time might have been too difficult. But in 2022, she was, she said, approached by some parents who were aware of her background in education and asked her to run.

Draskovic said she wanted to thank the "wonderful supporters" who backed her school board run. "It was a very positive experience," she said. "I would be open to trying again."

As an El Segundoan, Draskovic touts the quaint city she lives in, where, because of the perimeter borders, allows the "people who live in town, to stay in town. 
"I admired Yadranka because she is a very authentic person. She will always tell you her truth from her heart. She is a hard-working woman willing to help others and her community.





In other news, the council cleared the way for Mr. S. Claus based on a recommendation from city staff. In doing so, the council approved all of the following agenda items: "Recommendation -

1. Approve and immediately issue a Conditional Use Permit to Mr. S. Claus.

2. Approve the use of air rights and waive the Santa Monica Radial 160 R procedure (FAA should be contacted).

3. Grant a free business license to S. Claus Enterprises, a non-profit organization.

4. Waive ESMC 8-4-11B (Driveway Permits Required) and ESMC 8-5-11 (Parking on Grades).

5. Waive the Noise Ordinance (ESMC 7-2-3) to permit the clatter of reindeer hooves, the shouting of reindeer names, and the sound of bells on December 24 and 25, 2022.

6. Waive the Trespass Ordinance (ESMC 7-6-3) to allow Mr. S. Claus to deliver gifts.

7. Waive the Animal Control Ordinance (ESMC 6-2-1), including section 6-2-8 dealing with "Animals at Large," to allow eight reindeer to land on rooftops in El Segundo.

8. Waive of the Pooper-Scooper Regulations (ESMC 7-1-4)."

Earlier in the meeting, City Manager Darrell George delivered an update on activities at and concerning Hyperion, the city's western neighbor where an unplanned plant emergency in July 2021 damaged the plant and spilled sewage into the ocean and plant, resulting in ongoing health and safety concerns for some El Segundo residents. George noted that current construction work at the plant would cease starting Monday, December 26, and last through Monday, January 2. He said the perimeter road construction is 69 percent complete, and the sheet pile work is expected to be completed by the end of January. He noted that the contractor is attempting to keep construction noise and vibrations down, and the three fence line air monitoring systems have been installed and will run on a 24/7 basis to provide detection of hydrogen sulfide. He said that the air monitors are not set up to detect or measure any other chemicals.

City Attorney Mark Hensley noted that the South Coast Air Quality Management District board is not pleased with the amount of information they are receiving from Hyperion. SCAQMD held a hearing on Hyperion on December 15 that city staff attended. Hyperion's lack of compliance with the air quality district's abatement orders was discussed and noted by George and Hensley. George confirmed that the city had sent a letter to SCAQMD outlining issues and concerns the city had before the hearing. It was also mentioned that California State Senator Ben Allen's office is trying to work with the City of Los Angeles, which owns and operates Hyperion, to sit down and talk with the City of El Segundo representatives. Mayor Boyles said the city had just communicated with the City of LA, which looked promising. Council member Pirsztuk asked for an update on "covers" and the reported manufacturing delay that has resulted in those covers not being put on tanks from which odors emanate. Updates on and information about Hyperion can be found on the city's website at www. el.segundo.org/hyperion.

In other holiday news, the city will hold a Hanukkah Menorah Lighting tonight (Thursday, December 22) from 5:30-6:30 p.m. at City Hall, 350 Main Street, West Conference Hall.
