Council Covers the Gamut from Creative Economy to Park Place

Tuesday night's El Segundo City Council meeting featured an extensive and sprawling agenda covering a wealth of areas. Consultant Dr. Robert Kleinhenz kicked things off with a report about El Segundo's creative economy that has seen significant growth in recent years. The main business categories include architecture and related services; creative goods and products; entertainment and digital media; fashion; and fine arts and performing arts. Much of the growth, Kleinhenz said, is in the entertainment and digital media sector. Though the firms are smaller, they have more flexibility to expand over time. El Segundo's creative economy provides direct jobs for 6,000 workers - similar to a decade ago, with a hefty decline in the fashion area. More than half of those employed here are in entertainment and digital media. Creative wages in El Segundo are 50 percent higher than elsewhere in LA County (though women earn only 77 cents for every dollar their male counterparts earn), Kleinhenz pointed out, and the workforce is on the high end of the education spectrum. The creative firms in El Segundo generate \$3.2 billion in economic activity, but that doesn't include a ripple or multiplier effect with additional chains of expenditure that occur both locally and throughout the county. There are also

indirect impacts from vendors doing business with these firms and the workers themselves spending their own wages.

Kleinhenz noted El Segundo's advantages including quality of life, historical assets, creative and collaborative economy, and other components.

Challenges include lack of parking and inadequate high-speed Internet.

Also on Tuesday, the Council moved forward with the long-desired Park Place extension and grade separation project near PCH and Rosecrans - in the process certifying the See City Council, page 11



Community Briefs Attention Three- and Four-Unit Property Owners and Tenants

Please make sure you/your property owner have set up service with EDCO or another City-licensed hauler to meet your property's trash collection needs, as you are no longer part of the City-sponsored residential trash collection program. If a three- or four-unit property chooses to start collection services with EDCO, the owner or property manager needs to contact EDCO to subscribe to service by calling EDCO's Customer Service Office at 310- 540-2977.

As part of its contractual obligations, EDCO will provide the same level of collection services for three- and four-unit properties at the same rate as the one- and two-unit properties (\$21.26/month for each unit for automated

three-cart service). Please note that EDCO does not have an exclusive franchise agreement with the City to serve commercial and multi-family properties. Therefore, you are free to consider any waste hauler authorized to conduct business in El Segundo to provide the services for you. West Basin Announces Legislators of the Year

The West Basin Municipal Water District (West Basin) Board of Directors announced the Legislator of the Year awardees last week. This annual award recognizes legislators who have been instrumental in advancing the development and protection of reliable water supplies through legislation and advocacy in the past year.

Last year was a special one for West Basin at the U.S. Capitol, as Congress officially passed the Water Resources Development Act of 2018. This bill included a modification to West Basin's Harbor South Bay Water Recycling Project funding, increasing the total authorization to \$70 million that includes an additional \$35 million for future projects. This funding is crucial to West Basin's ability to costeffectively expand its water recycling system and could not have been accomplished without the support of West Basin's Congressional Delegation, including Representatives Karen Bass, Nanette Diaz Barragán, Ted Lieu, Alan Lowenthal, Grace Napolitano, Lucille Roybal-Allard, Adam Schiff, and Maxine Waters; and Senators Dianne Feinstein and Kamala Harris.

"The West Basin Board celebrates this esteemed delegation with our Legislator of the Year award for their environmental stewardship and support of recycled water in our region," said West Basin Board President Scott Houston.

At the state level, two awardees were recognized for their leadership on Assembly Bill 1668 and Senate Bill 606 that will transform how Californians use and think about water by making conservation a way of life. They were Assemblywoman Laura Friedman and Senator Bob Hertzberg.



El Camino Debaters Were Talk of National Collegiate Tournament

El Camino College rules after being crowned national champions of college forensic debate in Salt Lake City. The South Bay's representatives swept three titles, including best forensic team at any U.S. college – Ivy League schools included.

The March competition drew teams from 153 schools, including community colleges and four-year universities that went head to head in the parliamentary style of debate. Two-member teams take turns arguing the pros and cons of an issue before a judge. Despite going up against four-year schools from Arizona, Texas and Oregon, the El Camino debaters beat all comers and never lost a match.

El Camino traveled to Utah State University for the grueling three days of argument about public policy issues, which the National Parliamentary Debate Association sanctioned. The debates are extemporaneous and handsfree: participants don't have speeches prepared and don't carry notes. This freestyle can prepare college students to enter careers in government, law or business, according to parliamentary debate organizers.

It was only the second time in the tournament's history that a community college earned the top spot. The tournament drew 153 teams from two- and four-year universities. Pac-12 schools, including the universities of Arizona and Oregon, took part in the finals. El Camino defeated every team in the debate competition to capture the coveted national title.

It was a record-setting season for the South Bay team. El Camino won seven tournaments in a row, taking home the sweepstakes trophy for every competition. "This may be the best team we've ever had," said Professor Francesca Bishop, director of forensics. El Camino planned to enter two more competitions after Salt Lake City.

Bishop coaches the national championship program along with debate professors Mark Crossman and Joseph Evans, and Assistant Coach Brittany Hubble. Damon Lawson is a student coach for the competitors from the El Camino College communication studies



program. The National Parliamentary Debate Association says that up to 250 schools attend at least one tournament each season. The debate format is two-on-two, and the association says the format of the competition encourages quick thinking and public speaking.

The college students at the Salt Lake City debates sparred over public policy issues -the same way that lawmakers in a Parliament setting do. The political topics serve to make the competitors more knowledgeable and engaged citizens, the tournament sponsor says.

El Camino took home the two-year college tournament sweepstake trophy from Salt Lake City, along with the two-year college season champions award. Winning the overall Season Sweepstakes Title for two- and four-year schools established El Camino as a powerhouse going into next season.

Team members are heavily recruited by four-year institutions and receive scholarships to attend those universities after leaving the Torrance campus, the school says. The Forensics Program is open to students of all majors. The competitions give South Bay students training toward careers in media, management, sales and education too.

A background in communications studies at El Camino is a solid beginning to a rewarding career, according to the department. "Students who learn to communicate ideas in a way that promotes understanding with precision, logic and professionalism will have an advantage in today's fast-paced competitive world." Advertising agencies, law firms, schools, political candidates and officeholders, and social services look for talented people with skills in public speaking and research to work with clients and run campaigns.

Parliamentary debate at colleges began in the 1990s and high schools are embracing the competitions in which one team represents the government and the other is the opposition, says the American Association of Parliamentary Debate. It also involves role-playing for the government team, which is composed of a prime minister and a political ally. They argue the pro-government position, while their two opponents must demonstrate that the government's case is incorrect. The judge, called The Speaker, decides at the end of the round which team met its burden more convincingly -- either for or against the issue.

Debaters weren't the only award winners this semester at the Torrance campus. Journalism students who produce a weekly newspaper, The Union, won several awards at an annual statewide competition of the Journalism Association of Community Colleges held in March. The Union newspaper print and online editions both received praise for general excellence. Staff writer Omar Rashad was honored with the top award in feature writing for his story on Assembly Bill 705, which uses multiple measures when placing students into English and math courses. Staff writer Jose Tobar won second place awards for an editorial cartoon and an illustration, and an honorable mention or a story about homeless students. Staffer Zach Hatakeyama won second place for a feature story about NASA Community College Aerospace Scholars. Miyung Kim took home a third place in the news photo category. Sarah Desmond placed fourth for a magazine profile, as did Alexa Mancilla for a magazine news feature she wrote.








The Eulogist by Terry Gamble

Irish immigrant Olivia Givens tells an expansive story of her life after landing in Cincinnati, Ohio in 1819. She and her parents, with her brothers James and Erasmus, sailed to America "to pray and prosper." Almost immediately Olivia loses her possessions, her mother and soon her father. The Givens boys and she were left by themselves to scrape up a living between them.

The siblings live in a boarding house, and James begins a slow climb to self-reliance through candle-making. Younger brother Erasmus helps out and Olivia begins to tutor some of the local children. Erasmus experi-

ences a spiritual awakening and tries his hand at being a traveling preacher. He departs from his siblings to the wilds of Kentucky, across the river.

James marries a local businessman's daughter, Hatsepha. Erasmus finds himself married, then a father, then widowed. Olivia, James and Hatsepha take in William, Erasmus's motherless son, when it becomes plain that Erasmus feels the pull of the river back to his itinerant preaching.

Olivia is a woman who chafes at the conventions of the times and feels out of place. She meets a physician and man of science, Silas Orpheus, never guessing how their lives will soon be entwined. The "peculiar institution" of slavery becomes the backdrop for the Givens' family story. Each character has a particular viewpoint and through reversals of all kinds, experiences heartache and frustration due to the relationships they have with slaves and slave-holders. Criminal activity as well as many forms of intrigue give flavor to this saga of black and white and the many shades of grey that color perspective and belief. Olivia holds fast to her own values and risks mortal danger many times to do what she thinks is right. Her courage endures and makes the following generations wiser and stronger.

The book on CD format provides a richer interpretation thanks to the narration and vocal characterizations of actress Cassandra Campbell. Ms. Campbell invents a slight brogue for Olivia and manages to convey the difference in gender and age of the other people in her story.

The author, Terry Gamble, reveals that her own ancestors emigrated first from Scotland, then to Northern Ireland, and finally to Cincinnati in 1819. She became interested in her family history while she was sorting through items such as correspondence and photos belonging to her parents. While researching the history behind this tale, she found herself lurking in historical societies and museums, speaking with historians, reenactors and librarians. She attended Civil War meetings and toured the Underground Railroad Freedom Center. Her account of her research on her website fills in some blanks about the characters in her book, who are vividly real. Many of them, it seems, are based on actual people whose stories she unearthed. If you are interested in historical fiction, I suggest you seek out this book. •

Highlights from the Tribeca Film Festival

Although this is his first feature, you may already be familiar with this director's work. Nabil Elderkin – or just Nabil, as he is more widely known – is the man respon-

sible for the aesthetically brilliant music videos for the likes of Kanye West, Bon Iver and countless others cultural icons of the moment. Nabil takes the same cinematically-styled approach as he does in his music videos to bring screenwriter Marcus J. Guillory's emotionally-drenched drama, *Gully*, to life.

Gully is billed as a "slightly dystopian version of LA." While there is truth in that observation, the dystopia isn't a farfetched depiction of chaos. It's all rooted in reality, which makes for an even more affecting watch. Best friends Jesse (Kelvin Harrison, Jr.), Calvin (Jacob Latimore) and Nicky (Charlie Plummer) live within blocks of each other on the streets of South Central LA and all come from troubled backgrounds. They may have been forced to grow up prematurely, but these are still young boys in need of a childhood, trying to figure out who they are and where they're going amidst the chaos and unfair dealings that life has in store for them.

Standing Up, Falling Down

If Ben Braddock of *The Graduate* had a wise-cracking older mentor in his life to help guide him through the anxiety of post-graduate adulthood – and if that mentor was the inimitable Billy Crystal – you might get something similar to *Standing Up, Falling Down*, a feel-good buddy comedy about the unlikely friendship between an unsuccessful young comedian and his life-affirming dermatologist.

With his career going nowhere fast, stand-up



comedian Scott (Ben Schwartz) leaves L.A. to move back in with his parents in Eastern Long Island. At 34, it hits on a certain anxiety of this millennial generation that feels honest. Now home, Scott is forced to confront the life he left behind for the dreams of L.A. – and the people he left, including sister

(Grace Gummer) and ex-girlfriend (Eloise Mumford). In his grief state which warrants a medical check-up, he meets the karaokeloving dermatologist, Marty (Billy Crystal). It's not long before Marty's natural cheer mixes with Scott's cynical self, and the two find themselves getting along – having drinks, smoking pot, hanging out and without knowing it helping each other move on from a rut.

Come to Daddy


The funniest and wildest movie we saw at

final environmental impact report. The project will extend Park Place from Allied Way to Nash Street. The Council agreed to proceed with staff's preferred Alternative 1C (one of several options provided), which will relocate the existing BNSF rail tracks to allow for a single grade separation. The tracks will run over a bridge while Park Place will extend underneath. This configuration will include a roundabout at Park Place and Allied Way to allow for better traffic flow. Planning and Building Safety Director Sam Lee said that Alternative IC meets the project needs to close the gap on Park Place and provide an alternate east-west route between PCH and Douglas Street to relieve traffic congestion along Rosecrans and adjacent arteries.

A representative from consultant EMG provided an update on the citywide facilities condition assessment, the first study of its kind, with the goal of establishing a shortand long-term capital improvement program for the 31 City-owned buildings (e.g. City Hall, Fire Stations, Police Department, Library, Park Vista, etc.). EMG's analysis dug deeply into building systems and components, going so far as to bar-code all equipment. The assessment considered exterior systems; interior construction; interior finishes; health/ fire/life safety systems; heating, ventilation and air conditioning; plumbing; electrical and service distribution; and fire suppression.

The findings reported that City buildings are in good shape overall, with no urgent safety improvements needed right now. Existing minor safety issues such as missing fire extinguishers and potential trip hazards can be easily addressed.

All the buildings currently fell in the 0 to 5 percent range of the "facility condition index" – indicating they are "in new or well-maintained condition, with little or no visual evidence of wear or other deficiencies."

Initial outlay calls for about \$90,000 this fiscal year (already budgeted) to address items such as a new fire alarm control panel at City Hall, waterproofing at Library Park's south wall, and rain gutters at Camp Eucalyptus. Second-year needs estimate about \$140,000, but then replacement costs for various facilities will begin to escalate over time and will require approximately \$45 million over the next 20 years. Next steps will be to prioritize future projects and create a separate capital improvement plan for City facilities. Council will discuss the matter during upcoming summer strategic planning sessions.

Environmental Committee Chair Tracey Miller-Zarneke provided the quarterly update on the seven-member group's activities and achievements. She presented the committee's top five goals, which include eliminating single-use plastics (straws, bags, food containers), establishing a green business recognition program, expanding local water conservation efforts, developing policy to set green construction standards, and investigating joining a clean power alliance (to potentially lower rates and consider potentially cleaner electricity alternatives).

Park Maintenance Superintendent Christopher Hentzen provided the Council with the latest update on the Gateway Committee's (comprised of representation from City committees, commission and business sectors) efforts in regards to the Main Street and Imperial Highway Entryway Capital Improvement Project. The longstanding entryway was a project driven by the El Segundo Woman's Club in 1959/60 with the still-present rock walls and service club signage the end result. Landscaping followed in the mid-1970s. Hentzen said in revamping the entryway, the committee is looking for something that represents El Segundo's current status via a horizontal layout that is "safe and fun," "unique, kinetic or even moving" and includes new landscaping and lighting. Initial thought is to keep the rock walls, but remove the service club signage and also carry the theme over to the east side of the street. Committee member George Renfro added that the goal is to create something "Instagrammable" that can represent "an aspirational view of the city."

For the next step starting June 1, the committee will reach out to artist teams to present possible concepts for the entryway. Submissions will be due by the end of that month. A selection team (expanded with Council and/or other committee members added to the mix) will review the submissions in July, choose finalists in August with six to eight weeks of concept development to follow and finalist selection in October.

Renfro returned to the podium to make a pitch (with fellow organizer John McCullough) for the Council to again allocate funding for this summer's El Segundo Art Walk. The City provided \$33,000 along with a headquarters/ beer and wine garden space on Main Street for last year's three events to help the Art Walk grow. Renfro reported that the 2018 events (third Thursdays in June, July and August) drew the largest crowds ever with about 3,500 attendees each time and 48 businesses participating. He pointed to a successful social media and advertising campaign. This year's goal is to increase artist participation, grow attendance by 500 per event and continue to bolster El Segundo's reputation as a cultural destination and arts hub.

Renfro and McCullough asked the Council for \$39,000 (\$13,000 per event) -- an uptick of \$6,000 from last year -- to provide more event infrastructure and staffing, additional security and more local/regional marketing. While noting tax dollar recoup from the events won't match the City's outlay, Deputy City Manager Barbara Voss pointed to possible "longer-term benefits" from those visiting downtown during the Art Walk and becoming patrons in the future.

After much discussion, the Council agreed to subsidize the \$39,000 with the stipulation that Art Walk organizers look for other sponsorships in the future and work towards becoming self-sufficient – considering the City faces budget deficits in a few years and may not be able to allocate funding for the event.

The Council also spoke at length about a request from the local PTA Council to maintain fees for the Run for Education at last year's level of \$6,000. Costs doubled for this year's event, swelling to over \$12,000 (thanks mainly to road closures and fully burdened costs for Police and Public Works). The Council approved a fee waiver system in 2015 with an associated scorecard that set waiver percentage for various special events. The Run for Education came in with a score of 16 (25 is the max) that qualified it for up to a 50 percent fee waiver. The Council agreed on Tuesday to revisit the scorecard (which may be outdated) to see if the Run for Education might qualify

for a bump up to a 20-plus score and 75 percent waiver to push the fees back down to last year's level.

And last but not least, Finance Director Joseph Lillio provided a mid-year budget overview showing revenues tracking just slightly above budget and expenditures on target. Thanks mostly to continued unfilled vacancies, the City realized additional surplus funds -- \$864,000 in unassigned reserves. The Council agreed to allocate the extra dollars as staff recommended: \$250,000 additional funding to the 115 pension trust, \$150,000 to LAX legal fees, \$120,000 to Richmond Field improvements; \$100,000 to residential sidewalk replacements (the Council on Tuesday also authorized a study on this topic to prioritize where to add new sidewalks), and \$39,000 for the El Segundo Art Walk Funding. The Council opted to put the remaining \$204,000 into the 115 pension trust.

During reports, Public Works Director Ken Berkman praised new hauler EDCO for a smooth first week of service after taking over the solid waste collection contract on May 1. He described the company as responsive to any initial hiccups. He also reported that a notable number of owners of triplexes as well as four- and five-unit complexes that aren't part of the City contract (which only covers single-family and duplex owners) have begun to sign up with EDCO for their collection services.

Presentations at the beginning of the meeting included a proclamation for National Police Week (May 12-18) coinciding with Peace Officers Memorial Day on May 15 to commemorate law enforcement officers past and present who dedicated their professional lives to uphold the law and ensure public safety. Chief Bill Whalen made mention of the many officers in the region killed in the line of duty over the years, including four in El Segundo.

A second proclamation designated May as Older Americans Month with long-time local resident Cecelia "Bebe" Buchen recognized as the 2019 El Segundo Older American of the Year as the City gears up for the Elderfest Celebration on Saturday, May 11 at the Joslyn Center. •

In order to accomplish the change in election date, the term of City Council Members elected in April 2016 and 2018, who would otherwise be up for election in April 2020 and April 2022, would instead expire in March 2020 and 2022.







Dylan Chen placed fourth in the girls 50 freestyle and seventh in the 100 freestyle,






