## City Council Begged ‘To Just Get Along’; Valentine Chosen as New Mayor Pro Tem

The Hawthorne City Council met on Tuesday for the first meeting of 2014 with a gallery of citizens waiting to hear the exchanges from the dais. With the last time this body was gathered resulting in contentious exchanges documented and observed by many, a number of citizens approached the podium during public comments to admonish the “disrespectful” tones used by certain seated Council members towards Mayor Chris Brown.

Comments included that elected officials have an obligation to serve the people and not their individual interests, as well as the fact that they can be removed from office by the people. Other comments also pointed out that new businesses considering Hawthorne as a location will be reluctant to do so when it is possible to read of dissension among the elected officials. One citizen questioned if the wrong Council members have been elected to serve the people.

Mayor Brown nominated Councilmember Olivia Valentine to be the Mayor Pro Tem and with a vote of 4-1, with Councilmember Nilo Michelin casting the sole dissenting vote, Valentine will serve for a two-year term. But even the term for a Mayor Pro Tem was questioned by Councilmember Alex Vargas, who argued that there is no precedent for the term of a Mayor Pro Tem despite the fact that the mayoral position has always been for two years and the Pro Tem position historically followed suit.

The City Attorney will draft an ordinance for the next Council meeting to delineate the length of service for the position of Mayor Pro Tem for the future. It was pointed out that the mayoral position will be a four-year term beginning with the election in 2015, which could affect the Mayor Pro Tem position that is an internal election by the seated Council members.

The consent calendar included the opening of sealed bids for the vendor choice to install

a system on Crenshaw Boulevard that will allow the recognition of license plates, identifying any that may be wanted, thus serving as a tool for the police department in finding violators of laws. Only one bid was received and awarded to PTM General Engineering Services, Inc. of Riverside. The bid was accepted at the rate of \$33,332, to be furnished with gas tax funds. The work will consist of conduit, poles, pull boxes and the camera equipment. No date for the commencement of the project was announced.

Two ordinances were approved after the second reading. The first will regulate used car dealers and their location in specific zones in the city. The second ordinance confirms how cottage foods/made-at-home foods will be regulated within the municipal code.

Purchases will be made after approval at the meeting of new video cameras and audio equipment for the City’s Cable Department. Approval was also obtained for bids to be sought in order to upgrade the central air conditioning system throughout City Hall with new compressors, and all attending equipment.

Mayor Brown made appointments to the Planning Commission and each member received a unanimous vote from the Council. The three appointments, constituting a quorum, will allow the Planning Commission to convene on Wednesday, January 15, the first meeting of the Planning Commission since mid-November 2013. The three Planning Commissioners are Pat Carey, Rula Alshanableh, and Robert Smith. The other two appointments, to complete the five-member panel, will be made on January 28.

The Hawthorne representatives to the various committees and boards of which municipalities are members in the South Bay and in Los Angeles County were also decided by Council on Tuesday. These appointments include Mayor Brown as the delegate to the LA County Sanitation Board,

SCAG, and the West Basin Water Board; Valentine as the delegate to Centinela Youth Services, Independent City Risk Management Authority, and the South Bay Cities Council of Governments; Angie Reyes-English serving as delegate for the League of CA Cities and the South Bay Corridor Steering Committee; and Vargas as the City Selection Committee and Independent Cities Assn. delegate.

The Hawthorne Chamber of Commerce will sponsor the State of the City Luncheon on March 28 at noon at the Hawthorne Memorial Center. Tickets can be purchased through the Chamber of Commerce.

Ronald Garcia introduced himself as the new Southern California Edison representative for Hawthorne. Citizens are urged to call 800-611-1911 whenever there is a problem with the electric service, downed wires, or blackouts and to report claims and complaints.

The New Star Family Justice Center at 14221 Hawthorne Boulevard will have an open house on January 25 at 1 p.m. with a ribbon-cutting ceremony and a tour of the new facility and introduction of the services the center will provide.

Police Chief Robert Fager announced that the Hawthorne-originated program “Coffee with a Cop” is spreading across the country. Hawthorne Police representatives will travel to several cities in North Carolina to introduce the program and explain how it works to those local police departments.

Claudio Taniguchi, the Emergency Preparedness Director, announced that the Map Your Neighborhood program did a presentation to the Holly Park Homeowners Association and urged other HOAs and organizations to schedule the presentations at their meetings.

The Walking Program will have an event in the Holly Glen area on Saturday, January 25 at 10 a.m.

The next meeting of the Hawthorne City Council will be held on Tuesday, January 28, 2014 at 6 p.m. •

10 Simple Ways to Instantly Improve Your Finances in 2014

McAuliffe suggests 10 simple ways for you to start improving your finances immediately:

- 1. Stop, think, save - When out shopping, don't mindlessly pile things in the cart. Take a moment to stop, think what you really need, and save by not buying extras. Cutting unnecessary spending is easy when you make a habit of briefly pausing to analyze what you really need.
- 2. Cut 5 percent - If your employer cut your paycheck by 5 percent, you'd be unhappy, but you'd still be able to survive. Why not make that cut now? Reduce the extras like your daily latte or weekly visit to the salon and the savings will mount quickly.
- 3. Save - Every little bit counts when it comes to savings. If you save just \$5 a day - the cost of a fast food lunch - you'll have \$1,800 in a year. It's OK to start slow and build momentum. The ultimate goal should be to save at least 10 percent of your net



income (income after taxes and other deductions).

- 4. Budget - It sounds simple, but most people don't have a solid budget. Create a spending plan now and stick to it. List all expenses and see where adjustments can be made. Refer back to your budget regularly to stay on track.
- 5. Keep multiple

savings accounts - The less accessible your money is, the easier it is to reduce spending. Keep multiple savings accounts and pay yourself first. One savings account could be designated for an emergency fund, another for a new car or a future vacation.

6. Make it visual - Discourage overspending by reminding yourself why you are trying to save. A photo of your vacation destination, for example, illustrates what you're saving for; put it everywhere you spend money - wallet, computer monitor, vehicle, etc.

7. Make your money work for you - Consistent contributions add up over time, and thanks to the power of compound interest, the longer you leave your money untouched in a savings account or other investment, the more it can grow.

8. Home savings - If you own a home, you know it can cost a lot of money. Cut costs by doing home improvements and maintenance jobs yourself rather than hire out. Call your insurance agent and see if there is a lower rate for homeowner's insurance. Check into refinancing while rates are still low.

9. Manage checking accounts - You need a checking account, but are you really keeping track of your money? Online banking makes it easier than ever to balance your checkbook, track your spending and set up alerts when your balance goes under a certain amount.

10. Review your credit report - From mortgages and car loans to employment and renting eligibility, your credit report and score affect many aspects of life. You can review your credit report for free annually by going to www.annualcreditreport.com. Make sure you know what's on it and make corrections as necessary. •

# Wiseburn’s Preschool Looks to Improve

During its January 9 meeting, the Wiseburn School Board heard a presentation from Melissa Coughlin, Program Specialist at the Wiseburn Child Development Center (WCDC), on how the center is hoping to improve its program and the education of preschoolers. The WCDC is a new part of the Wiseburn School District. Getting familiar with how Wiseburn operates has been a top priority, although far from the only item on the center’s to-do list. “Our team is new faces and our first job is getting to know each other,” said Coughlin. “That said, that’s not all we’ve been doing. We’ve been working very hard. There’s a lot of heart in what we’ve been doing these part few months.”

The most important task for the WCDC is to create a developmentally appropriate curriculum. To do this, Coughlin said it is looking at the California Department of Education’s preschool framework, which focuses on the areas of pre-academic readiness, critical thinking and communication skills. However, these are only the building blocks for where these kids are going, so any new curriculum also has to take into account the new Common Core State Standards. By addressing these two sets of guidelines, Coughlin thinks students who come through the WCDC will be better prepared for elementary school.

“One thing that’s been very important for us to remember is what are preschool students supposed to be learning. We know we need to get them ready for kindergarten, but they aren’t yet ready to learn kindergarten skills,” said Coughlin. “We want our kids ready for kindergarten and looking at these two pieces, that’s how we’re going to get them there.”

Another project the WCDC has undertaken has been forming at Teacher Assistance Team to implement intervention and monitor the progress of children struggling to make the transition to school. “We know that there are students out there—there’s going to be a certain percentage of students—who require more intensive intervention. They require something that’s a little above and beyond,” said Coughlin. “This is going to be our tool to provide intervention and document what the need is, what’s the intervention, how we’re implementing it and what the progress is.”

Coughlin said the ultimate goal of the Teacher Assistance Team is to give students the extra attention they might require before it’s too late. “We need to be cognizant that there are children out there that are going to fall into that bracket and we need to make sure we’re supporting them,” said Coughlin. “We want to make sure we catch them early.”

The staff at WCDC is also now benefiting

from regular professional development, consisting of five days of training on topics like behavior support, classroom management and abilities awareness. This is paired with coaching and feedback from site managers. Coughlin noted that staff at the WCDC has been happy to receive the additional training. “They’ve been thrilled that there have been these professional developments,” said Coughlin. “Their response has been, ‘This is what teachers get.’ They are really excited.”

Another goal for the WCDC staff has been to modify the handbook given to parents describing the program. The chief concern has been to make sure it addresses what the community wants for its children, as well as to be in line with the philosophies of the Wiseburn School District. “We’ve taken a look at the handbook and we think there’s some refinement that would be beneficial,” said Coughlin.

One of the toughest areas to refine has been the subject of discipline. Due to the young age of the students served by the WCDC, handling behavioral issues is harder than in kindergarten and beyond. To address this area, Coughlin said both guidance from the Teacher Assistance Team and open communication with the child’s parents have been key, although nothing can prevent the occasional issue. “We know that with little ones, sometimes you have behavior issues,” said Coughlin.

The last goal Coughlin addressed was the desire for the WCDC to work closely with the elementary schools in Wiseburn. She would like to increase communication between the two entities to provide feedback on how changes to the WCDC curriculum is affecting student learning. Coughlin said the common goal of bringing the best education possible to the community’s students has brought together the staff on both sides. “I’m a firm believer that you have to breathe in the environment to actually understand it,” said Coughlin. “We’re really trying to merge the worlds and they really are a lot closer than we thought they would be.”

Overall, the Board seemed pleased with the direction in which the center is moving. Board member Nelson Martinez said he expects this program to fare better than its predecessor Rainbow River, where his children attended preschool, because of the close support the District is providing. “This is exactly what I want to see. Parents have an idea of what to expect from the very onset and then have continuous meetings so by the end of the year... the expectation is met,” said Martinez. “We’re lucky Rainbow River had an establishment, but I want to see continuous improvement. With Wiseburn managing it, we can do much better.” •

### California Drought

We need rain. This dry, warm weather is nice to enjoy during the winter, but it will have a dramatic effect on us this summer and for many months to come. I share with you a portion of an article I read from Paul Rogers, a reporter for the San Jose Mercury News dated January 13, 2014:

As California struggles through a run of historically dry weather, most residents are looking at falling reservoir levels, dusty air and thirsty lawns. But meteorologists have fixed their attention on the scientific phenomenon they say is to blame for the emerging drought: a vast zone of high pressure in the atmosphere off the West Coast, nearly four miles high and 2,000 miles long, so stubborn that one researcher has dubbed it the "Ridiculously Resilient Ridge. "Like a brick wall, the mass of high pressure air has been blocking Pacific



winter storms from coming ashore in California, deflecting them up into Alaska and British Columbia, even delivering rain and cold weather to the East Coast. Similar high-pressure zones pop up all the time during most winters, but they usually break down, allowing rain to get through to California. This one, ominously, has anchored itself for 13 months, since December 2012, making it unprecedented in modern weather records and leaving researchers scratching their heads. "It's like the Sierra -- a mountain range just sitting off the West Coast -- only bigger," said Bob Benjamin, a forecaster with the National Weather Service in Monterey. "This ridge is sort of a mountain in the atmosphere. In most years, it comes and goes. This year it came and didn't go."

### Hawthorne in the News

Again this past week we found Hawthorne to be in the news. First a resident decided to run over his dog and is caught on video intentionally speeding car up his vehicle to run over his pet. The second incident involved a robbery on Imperial Highway where a gunman accidentally fired a shot and struck a store clerk. Finally the last incident involved a young man who had recently moved to Hawthorne and was sitting on a bus bench on El Segundo Blvd and was struck by a swearing car. The man was critically injured. In a city of over 85,000 residents and thousands of commuters traveling through it, there are accidents that will happen and bad behavior that will take place. 99% of our citizens are hard working, law abiding neighbors who only want a peaceful place in which to live and work. We again are thankful for our great police and fire departments that respond to all of these tragic events in a timely and protective manner.

Watching the devolvement of Obamacare is like a rerun of the old joke about the fool who fell off the roof of a high rise building. The tenants on each floor could hear him shouting as he flew past, “So far, so good!”

### Finally, Somebody Steps Up to Prevent Mass Spying of Citizens

Due to the repeated admission by federal administrators that there has been a widespread effort to spy on American citizens who are innocent of any wrongdoing, Senators Ted Lieu and Joel Anderson introduced a bill seeking to ban state agencies, officials and corporations that currently provide a service to the state from assisting the federal government in its efforts to spy and collect certain data on Californians.

It is troubling and disheartening that the federal government has spent so much time and resources on domestic espionage of people who have done nothing wrong. It is even more frustrating that since the tragic events from September 11, there are leaders still willing to exploit the fears and anguish of the victims of that day to justify these types of espionage tactics on private citizens. Sens. Lieu and Anderson are taking a stand, for now symbolic, against such invasive practices.

It is no surprise that the government, on any level, can spy on citizens. However, the steps that the NSA took to collect information on millions of citizens are as ridiculous as they are criminal. One report indicated that the NSA collected phone information on an estimated 317 million Americans. Of those citizens whose privacy was violated for no good reason, about 38 million are Californians. The NSA and President Obama’s administration can claim that these actions were taken in the name of national security, but the truth is that such an explanation is simply

a copout. It is difficult for me to believe that 38 million Californians are involved in criminal activity. It is even harder to accept that 317 million Americans are such a threat to national security that we need the NSA to spy on their phone calls.

Conducting secret surveillance on a group of individuals involved with criminal activities is a legitimate security measure. In order to do so, there are several steps that must be followed, such as obtaining warrants and other paperwork that help maintain transparency throughout the process. The bill introduced by Sens. Lieu and Anderson attempts to preserve that process in order to maintain the privacy rights of every law-abiding Californian. Maybe I’m old-fashioned in believing in the Fourth Amendment to the United States Constitution and the right of Americans to not be subjected to “unreasonable searches and seizures.”

In California, the NSA would rely on the services provided by the state and private entities to collect and conduct such surveillance. With the bill attempting to ban state agencies, officials and corporations providing any services to the state from giving support, from participating or assisting any federal agency in spying efforts, at least Californians will be more protected than your average American. The first step has been taken with the bill introduced by Sens. Lieu and Anderson. Maybe the rest of our elected officials in Sacramento can pass the bill and enforce it for the well-being of every Californian. •

### Leuzinger Breezes Past Hawthorne

After several successful seasons, Leuzinger High’s boys’ basketball team is facing rebuilding with a 6-10 overall record. The Olympians, however, continued to own their cross-town rival Hawthorne as they coasted to a 60-51 non-league victory last Friday at Leuzinger.

The game was close most of the way, although the Olympians led during most of the contest. Leuzinger led by just two at 25-23 at halftime and by eight (41-33) after three quarters, but had a big first five minutes of the fourth period with a 15-1 run to build a 56-34 lead that put away the Cougars (5-7).

Despite the loss, Hawthorne finished with a flourish behind four three-point baskets by Markell Gray, who scored 15 of his team-high 16 points in the fourth quarter. “We had our ups and downs,” Leuzinger head coach Ali Parvaz said. “We won three of our last four

The Olympians were led by Davon Abner, who topped all scorers with 22 points. Isaac Stell added 14 points.

During the week between Christmas and New Year’s, Leuzinger competed in the highly competitive Maxpreps Holiday Classic in Palm Springs, losing four of five. The Olympians lost to Catalina Foothills from Tucson, Arizona, 54-47, Rancho Cucamonga Los Osos, 35-33, and Oceanside El Camino, 63-59, before recording an easy victory over Garden Grove Orangewood Academy, 76-46.

Ricky Bryant chipped in 11 points in Hawthorne’s loss to Leuzinger. A day earlier at St. Bernard in Playa del Rey, the Cougars topped the Vikings 48-44. Brian Ross led Hawthorne with 15 points. Marlon Towns contributed 12 points and Bryant had eight points.

Leuzinger began the Bay League at Palos Verdes last Tuesday and will host Rolling Hills Estates Peninsula in its second league contest Friday at 7:30 p.m. The Olympians will play in the Martin Luther King Shootout at Price Christian High in South Los Angeles next Monday before resuming league at home against Mira Costa on Tuesday at 7:30 p.m.

The Cougars started the Ocean League at home against Beverly Hills on Wednesday and will visit Inglewood Friday at 7:30 p.m.

Hawthorne visits Morningside in Inglewood next Wednesday at the same time.

Over the past few seasons, Lawndale High’s boys’ basketball team was unable to defeat powerful Leuzinger, but this year the Cardinals finally got the edge. At Lawndale on January 8, the Cardinals picked up clutch plays to top the Olympians 51-45.

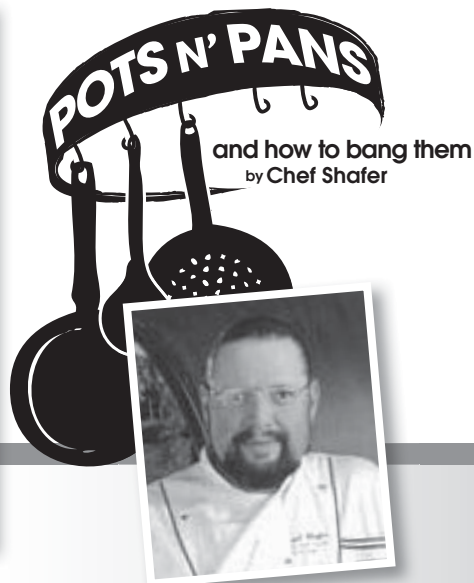
