# **DMV Ready with TSA-Compliant Driver's Licenses**

A new driver's license is coming to California, starting on Jan. 22 when the Department of Motor Vehicles begins offering a federally accepted identification card that meets Homeland Security requirements at airports. But there's no need to rush to the nearest DMV office to apply for one. Current driving licenses and identification cards will be accepted at TSA airport checkpoints until Oct. 1, 2020, according to the DMV.

Even after that date, TSA agents will allow passengers to board domestic flights if they produce photo identification other than a driver's license, the DMV explained ahead of the Jan. 22 implementation of REAL ID. "If a customer has another federally approved identification, does not fly, or does not plan to visit a military base or certain federal facilities, they do not need a REAL ID and will have the option to apply for a federal non-compliant driver license or ID card," according to a DMV announcement issued in mid-November. California for several years postponed implementing the federal REAL ID. Congress in 2005 passed a law requiring all states to comply with post-9/11 security requirements for driver's licenses and ID cards for airline passengers and visitors to a federal building or military base. California was one of the states that received two-year extensions from the federal government. The consequence for not meeting the federal deadline of Jan. 1, 2018, was that passengers from California would have been required immediately to show an alternative form of acceptable identification at TSA checkpoints, according to the Department of Homeland Security's website.

includes a valid U.S. or foreign governmentissued passport or U.S. passport card, or a military ID, according to authorities. A permanent-resident or border-crossing card, and a Department of Homeland Security Trusted Traveler card also are valid.

Children under 18 aren't required to get the new identification cards. TSA does not require minors to provide identification when traveling with a companion within the United States.

Drivers can wait for their renewal notices to arrive before applying for the federally compliant licenses, department spokesman Jaime Garza noted. Applications for REAL ID must be made in person and cannot be processed by mail. Applicants are advised to save time by scheduling an appointment.

Renewals of REAL ID licenses or

are informed about their choices starting in January 2018," DMV Director Jean Shiomoto said. "If you choose to apply for a REAL ID, consider waiting until your renewal date, if possible."

The DMV's rollout campaign emphasizes frequent flyers stand to gain from choosing the new-type of ID. A sample of the new license shows the word "USA" printed at the top. A golden bear has been added in the upper corner of the card.

The cost of a federally compliant license versus a traditional California one is the same: \$35. A DMV-issued identification card is \$30 for either type, according to Garza with the DMV headquarters in Sacramento.

The DMV has created a page with frequently asked questions at www.dmv.ca.gov/portal/ dmv/detail/realid/realidfaq. Anyone who plans to visit a military base or federal facility should ask about their identification requirements, just in case.

identification cards can be done by mail or online, and won't require an in-office visit every five years. The same applies to the identification cards, which are good for six years for adults under 62, and 10 years for seniors.

To apply and obtain the TSA-approved license or ID card, state residents must have a copy of a U.S. birth certificate, a valid U.S. passport, a foreign passport, or a work permit or permanent residency card. Other documents needed to process a REAL ID application include proof of Social Security card, proof of California residency and a court document approving a name change due to marriage or divorce.

People who never fly or visit a secure federal facility or military base don't need a REAL ID driver license or ID card, according to DMV officials. A federally compliant driver's license isn't needed to drive in California, vote, enter a post office, or apply and receive federal benefits, the DMV assures the public.

#### One more thing ...

Airline passenger identification isn't the only change coming in January for the state's drivers. The department has begun collecting a new car registration fee to fix California's aging roads and highway system. Lawmakers last year approved a Transportation Improvement Fee as part of a 10-year statewide road repair plan that also raised gasoline taxes after Halloween.

The improvement fee is based on a vehicle's current value and could increase annual vehicle registration from \$25 to \$175 this year. An automobile worth \$25,000 or less would incur a \$50 TIF. A car valued between \$25,000 and \$34,999 would be subject to a \$100 fee. The fee jumps to \$175 for vehicles worth \$60,000 or more.

Customers with a vehicle renewal due in early January saw the fee on their 2018 notice from the DMV. •

# Film Review

Golden Globe-Winner Oldman's Career Best as Winston Churchill

In a very powerful opening shot, dropping us into the world of 1941 British Parliament, it's clear that Joe Wright's latest film will not only be a showcase for the work of actor Gary Oldman, but also a reminder of the great cinematography of Bruno Delbonnel -- whose keen eye previously brought life to *Inside Llewyn Davis* and *Amelie*, among others. Like in his previous films, Wright doesn't miss any opportunity to let the camera do the storytelling and his collaboration with Delbonnel proves to be a great combination right from the get-go.

Darkest Hour is foremost a biography film about Winston Churchill, a leader who remains a political hero across all party lines. The film takes place in May 1941, with World War II and a German invasion imminent. Through peculiar circumstances, one man is at the helm of the island-based empire. Unconventional casting pays off immensely. Gary Oldman, who in real life looks or sounds nothing like Churchill, is given one of the most hard-earned scene-chewing roles in ages. The biography wisely focuses on a very critical period of his career and world history, and that helps the film itself remained focused.

Oldman is unrecognizable. It would take a more trained eye to tell what is makeup and what is weight gain. He completely disappears into Churchill as a fully formed character. It helps that he's a bit of a caricature, especially compared to the more ordinary supporting characters in the cast, but there is never a doubt of who we are watching on screen. It goes without saying that this is the type of performance that an awards season soaks up (case in point, last Sunday night's Golden Globe win) and I expect many to come Oldman's way. Interestingly, Ben Mendelsohn plays King George VI, a role that has already been immortalized on film by Colin Firth, yet Mendelsohn takes the opportunity to also make his mark in this role. British royalty and leadership are the Shakespearean characters of our time, worthy of numerous portrayals and character interpretations. In today's political climate, when American politicians are nearly all bought and sold by corporations, it's unfortunately hard to imagine a time when solutions to the great problems were black and white and great minds could disagree through discourse instead of stomping their feet. This highlights the great void between the many classic political films of yesteryear, which makes it difficult to apply the lessons of leaders like Churchill by today's standards. Regardless, there are lessons here we can apply to our daily lives. Never surrender in the face of adversity and

reach out to the people around us for wisdom, even if they are your opponents. These are the qualities that make Winston Churchill, and all those who portray him, live on in the generations to come in the event that we must face our own darkest hour. •



MAKE IT GREAT IN ONE EIGHT




# <u>Community Brief</u> **Rotary Club Feeds 30 Local Families for Holidays**

# **Rams Fold Under Playoff Pressure**

Coming into last Saturday night'S Wild Card NFL playoff game against the Atlanta Falcons at the Los Angeles Memorial Coliseum, the Los Angeles Rams had everything going in their favor. Thirty-one-year-old rookie head coach Sean McVay was on the sidelines, second-year quarterback Jared Goff was under center and running back Todd Gurley had just completed an MVP-like season. What the Rams didn't have, though, was experience. A 26-13 loss to last year's Super Bowl runner-ups proved to be too much for a young Los Angeles team to handle. In what was perhaps the worst first-round matchup that the team could have possibly been faced with, the Rams wound up tumbling out of the playoffs almost before they had a chance to even begin at all.

Fans showed up in droves last Saturday night to pack the Coliseum for what was the first Rams playoff game at that location in 39 years. Dallas wound up blowing out the Rams 28-0 in that game. Although last week's matchup wasn't quite as lopsided, fans were forced to commute home with the same distinct feeling of loss that they felt almost four decades ago.

A crowd full of 74,300 people in the heart of Los Angeles – the biggest crowd all season long – was rendered silent throughout the first quarter of play as Gurley, Goff and the rest of the Rams continuously came up short on drives and eventually fell behind by a score of 13-0 in the second quarter. "They made one more play than we did," Rams defensive tackle Aaron Donald said after the game. "We were trying to dig out of a hole, but we kept fighting. We just kept fighting. But we fell short."

One of the main reasons that the Rams were forced to attempt to dig out of a hole all game long was because of the play of Pro Bowl special teams player Pharoh Cooper. Cooper muffed a punt, bobbled a kickoff and insisted on attempting to return the ball every time he touched it. It seemed as if the Pro Bowler-to-be was drastically close to coughing up the ball every single time that he touched it. "I'm sure he'd like to have a couple of those plays back." McVay explained. "Any time you lose the turnover battle, you're going to make it very hard on yourself,"

The Rams' only touchdown of the game came in the second quarter of play when Goff hit rookie wide receiver Cooper Kupp in the back of the end zone. Los Angeles went into halftime down by a score of 13-10, which was the closest the Rams would get all night. One of the main reasons that the highest-scoring offense in the league this season was unable to get off of the ground was because of Atlanta's amped-up defense. That same defense sacked Goff twice in his team's first two possessions to set the tone. They were also all over the wide receivers in the secondary and found it rather easy to bottle up Gurley, at least early on in the game.

Los Angeles was able to gain just 44 yards in the first 24 minutes of play. They were held to their first scoreless first quarter in 13 weeks of play. The Rams were also shut out in the third quarter and only managed one field goal in the fourth. "We wanted to come out here and we didn't want this to end at all," Goff solemnly explained postgame. "We've got such a special group of dudes in there, and coaches and everybody. It's such a special group, and you don't want it to end this early by any means. So it's tough right now."

After an incredible resurgent year that proved all who said he would be a rookie bust wrong, Goff finished his first playoff game ever by completing 24 of 45 passes for 259 yards and one touchdown. Gurley, on the other hand, may have seemed like he was bottled up all night, but still managed to finish the game with over 100 yards rushing on just 14 carries. Though Robert Woods enjoyed an incredible game, going for 142 yards on nine catches, the normally spectacular Rams offense was clearly not itself due to the incredible defensive effort brought to the table by the Falcons.

Despite this year's early postseason exit, any Rams fan would be lying if they told you that they expected to be in playoff position following the team's 4-12 record of one season ago. An explosive offense and an elite defense turned those expectations around for the Rams and their fans this year. Los Angeles has now become a team that has improved mightily and progressed drastically, all within a one-year period. Not only did this year's Rams return to the postseason for the first time since 2004, but they were also good enough to host a playoff game in Southern California for the first time since Jan. 4, 1986. Fans can now expect all of that improvement and progression built this season to keep moving in the right direction for years to come. • - Aserrao6@yahoo.com



Arecibo Planetary Radar Returns with Images of Asteroid Phaethon



for planetary defense work because of its unique capabilities," said Dr. Joan Schmelz, director at Universities Space Research Association (USRA) and deputy director of Arecibo Observatory. "We have been working diligently to get it back up and running since Hurricane Maria devastated Puerto Rico."

The Arecibo Observatory has the most powerful astronomical radar system on Earth. The telescope suffered minor structural damage from the category 4 hurricane, the strongest to hit the island since 1928. Some days after the storm, the telescope resumed radio astronomy observations, while planetary radar observations, which require high power and diesel fuel for generators at the site, resumed operations in early December after commercial power returned to the observatory.

Asteroid Phaethon was discovered on Oct.

11, 1983, by NASA's Infrared Astronomical Satellite (IRAS). Observations of Phaethon were conducted at Arecibo from Dec. 15 through 19, 2017, using the NASA-funded planetary radar system. At time of closest approach on Dec. 16 at 3 p.m. PST (6 p.m. EST, 11 p.m. UTC) the asteroid was about six million miles (10 million kilometers) away, or about 26.8 times the distance from Earth to the Moon. The encounter is the closest the object will come to Earth until 2093.

Radar has been used to observe hundreds of asteroids. When these small, natural remnants of the formation of our solar system pass relatively close to Earth, deep space radar is a powerful technique for studying their sizes, shapes, rotation, surface features, and roughness, and for more precise determination of their orbital path. •

After several months of downtime in the aftermath of Hurricane Maria, the Arecibo Observatory Planetary Radar returned to normal operation, providing the best images to date of near-Earth asteroid 3200 Phaethon, which is thought to be the parent body for the Geminid meteor shower. The radar images, which are subtle at available resolution, reveal the asteroid is spheroidal in shape and has a large concavity at least several hundred meters in extent near the leading edge and a conspicuous dark, circular feature near one of the poles. Arecibo's radar images of Phaethon have resolutions as fine as about 250 feet (75 meters) per pixel.

"These new observations of Phaethon show

it may be similar in shape to asteroid Bennu, the target of NASA's OSIRIS-REx spacecraft, but 10 times larger," noted Dr. Patrick Taylor, Group Lead for Planetary Radar for Arecibo Observatory. "The dark feature could be a crater or some other topographic depression that did not reflect the radar beam back at us."

Radar images obtained at Arecibo indicate Phaethon has a diameter of about 3.6 miles (six kilometers) -- roughly 0.6 mile (one kilometer) larger than previous estimates. Phaethon is the second largest near-Earth asteroid classified as "potentially hazardous." Near-Earth objects are classified as potentially hazardous asteroids (PHAs), based on their size and how closely their orbits approach Earth.
