Deal Makes Filing Software Free to Millions of Taxpayers This Year

Tax season opened on Monday with predictions of smaller federal refunds and more questions about standard deductions under the revised tax code and which write-offs are still in play. Taxpayers expecting refunds - a practice known as the "Uncle Sam Savings Plan" - may be disappointed. However, a deal with tax Software companies and the government could soften the blow.

The Internal Revenue Service estimates 100 million U.S. taxpayers can file their federal returns for free this year because of a deal the government has with the leading tax software companies. In exchange for not releasing its own free tax software, the IRS cut a deal with software developers, including TurboTax, to let taxpayers prepare and file their federal taxes at no cost. The arrangement between the revenuecollection agency and private industry will run through the fall of 2021. The software partners include H&R Block, TurboTax, Credit Karma Tax, TaxAct and FreeTax USA. Uncertainty about the new law laws should boost interest in the free offer. Taxpayers who claim \$66,000 or less of income after deductions for last year are eligible for the free software and filing. Individuals and couples with more than \$66,000 of adjusted income are able to prepare, but not electronically file their returns online. Instead, they must download, print and mail their federal returns. This public-private partnership began in 2002 and has some new features.

military option, the IRS said last month as it struggled to get ready for the Jan. 28 start of tax season. The government shutdown left the IRS severely shorthanded because thousands of agency and field employees were furloughed, waiting to be called back to work.

The top official at the IRS called the file-forfree choice a great partnership with the software developers. This is the first year taxpayers and their preparers will apply new tax brackets and standard deductions. Past filers may notice additional features while taxpayers who haven't tried Free File should think about it, says IRS Commissioner Chuck Rettig said. "This is a great year for people to consider using this option for preparing their taxes," he believes. After all, why pay for something that's being given away for nothing? That's the substance of the deal between the IRS and TurboTax and other branded companies that sell their software to taxpayers from late January through April 15. The IRS estimates this freebie offer can be used by 70 percent of taxpayers. Californians have a similar free option from the Franchise Tax Board, too. Workers, families with children, first-time filers and seniors who meet the income criteria are all eligible for Free File. The software supports all the new tax law changes, plus includes the longstanding Earned Income Tax Credit for lower-income working parents with children living at home. How does it work? Free File is only available at IRS.gov. Start at IRS.gov/freefile, answer a few questions and see if you're one of the 70 million American taxpayers eligible for a free return. The IRS website matches an individual taxpayer or couple with a brand name software

product - at no cost to them. "Generally, taxpayers will have several options from which to choose," it says.

Taxpayers can browse the various companies and offers before selecting one. The actual federal return will be prepared on the software company's website. A smartphone app also is available for viewing the file-for-free service at the IRS. Taxpayers can use the IRS2Go app on their phones or tablets.

This latest version of Free File is available through the mid-October deadline for extension filers. Taxpayers can use the software or app to file an extension so they don't miss the

April 15 deadline.

Some consumer protections have been added by the software companies at the direction of the IRS. No confusing buttons pointing taxpayers to for-fee services will appear on the Free File software anymore. The dozen software companies must direct taxpayers who don't qualify for a free tax preparation back to the IRS website to search other Free Filer offers that may accept them.

No longer can the software companies market fee-based tax preparation services to free filers who return the following year. To prevent upselling by the online tax services, any email welcoming a free filer must link them to the free service first. No commercial offers can be included in the welcome email, per the IRS. Despite the longest government shutdown

Despite the longest government shutdown in U.S. history, the IRS promised to issue tax refunds immediately. Refunds will start going out the first week of February and the agency "will be doing everything it can to have a smooth filing season," Rettig said. Tax-filing season opened a day earlier than last year, he noted. •
