

Darby Park to Receive New Fitness Equipment

Upon the recommendation of the Parks, Recreation and Library Services Department, the Inglewood City Council voted to award a contract to Carolino Construction Corporation to complete the Darby Park Fitness Equipment Project.

The agreed upon contract between the City of Inglewood and Carolino Construction Corporation is in the amount of \$46,250 with an approved contingency fund worth \$3,000, all to be paid for via a grant fund.

Inglewood's Darby Park is located at 3400 W. Arbor Vitae. The 14-acre park, which sits just east of Hollywood Park and the iconic Forum, is home to several baseball fields, tennis courts and basketball courts. It is also host to a skateboarding area as well as long stretches of walking and jogging paths.

On Oct. 16, 2014 the City of Inglewood was granted Los Angeles County Proposition A excess funds. The new source of monies were to be used to upgrade the heating and cooling system in the Martin Luther King Recreation Center, while also installing new outdoor exercise equipment and fitness stations throughout Darby Park. The upgrade-process of the heating and cooling system in the recreation center was completed during the month of December 2014.

"Staff is now prepared to move forward with the installation of six fitness stations, which will be adjacent to the MLK Recreation Center in Darby Park," states the staff report presented to the council.

Carolino Construction Corporation was chosen as the lowest, responsible bidder and will install a four-person twisting station. This fitness station allows a person to stand or sit as they face a place to hold on to with their hands. As the person holds on, the lower

body conducts a twisting motion from left to right, which causes the waist and upper body to stretch while aiding the individual in the "recovering lost agility" states the staff report.

Another one of the stations will include the two-person vertical press, which allows park patrons to sit at a station, grab on to two

handles placed at chest level and push up. This exercise strengthens shoulder and arm muscles. The fitness stations will also include equipment that will allow for cardiovascular exercises.

A third fitness station will include a twoperson cross-country ski where the two people mound equipment in a standing position and facing each other. Each person grabs a set of handles and places their feet on ski-like platform, at which point limbs are moved back and forth emulating a skiing motion. The staff report indicates that this exercise strengthens leg muscles, improves cardiovascular endurance, helps recover lost agility and is also considered a social activity exercise.

In similar fashion to the two-person cross-country ski, a different fitness station will host the single elliptical. This machine is mounded similar to the two-person cross-country ski but the ski-like platform moves in a circular motion from behind, submitting the body the same motion as if it were running, but without the impact on the joints. This exercises is also described by the staff report as good

for strengthening leg muscles and improving cardiovascular endurance.

The last two fitness stations to be installed include a recumbent bike, which strengthens calves, hamstrings, quadriceps and glutes while increasing cardiovascular endurance. A rowing machine will also be added to the park, which is also attributed to increasing cardiovascular endurance as well as strengthening back muscles, shoulders, arm muscles and abdominal muscles

Carolino Construction Corporation was also selected to complete the project due to its previous history with the city, as it not long ago completed the Vincent Park Lighting Upgrade Project, as well as the Darby Park Lighting Upgrade Project. Based on the agreement, all work related to the project is to be completed 30 days after the notice to proceed has been issued.

CITY TO HOST FREE DONATION DROP OFF, DOCUMENT SHREDDING



Mark Smoke Larson, a 1938 graduate of Inglewood High School, died in Sedona, Arizona after a short illness. An electronics technician for NASA, he designed and built radios used in the Apollo space program. An accomplished double bass player as well, he contributed to the jazz scene in Virginia and Texas until the demands of the Space Race required all of his attention to work.

January 9, 2015 was a sad day for us, but we can feel good about, the honorable life Mark lived. He was a good and talented He lived through history-making times of manned spaceflight and the Apollo Moon Missions. He was a part of making that history. His own electronic hardware contributions at NASA-Houston were flown on many Apollo launches. He was a master carpenter as well, building three houses during the course of his life, houses that, like his NASA radios, were built way beyond spec.

What more is there to say about one of us when we are departing? Just this:

Devoted Husband, Dad, Grandfather, Great grandfather, Brother, Uncle. Master Electrician, Mechanic, House-builder, Traveler, automobile fixer and driver extraordinare, Landscaper, Best friend to all Dogs, Mr. fix-it.

Gone, greatly missed, but never forgotten. Thanks for everything, Dad. •

WATER RESTRICTION GUIDELINES

Here are the restriction guidelines that the City Council of Hawthorne has voted upon regarding residential water use: "In response to the ongoing severe drought, the State Water Resources Control Board approved an emergency regulation to ensure water agencies, their customers and state residents increase water conservation in urban settings. With this regulation, all Californians will be expected to stop: washing down driveways and sidewalks; watering of outdoor landscapes that cause excess runoff; using a hose to wash a motor vehicle, unless the hose is fitted with a shut-off nozzle, and using potable water in a fountain or decorative water feature, unless the water is recirculated.'

Outside watering of lawns and gardens can take up to 70 or 80% of our home water use. A lot people are looking to install drought resistant landscapes in the yards. There are rebates available if you install artificial turf. Water is a precious commodity, let's all do our part to conserve. •



Leuzinger Advances to Quarterfinals

Leuzinger High's boys' basketball team advanced to the CIF-Southern Section Division IIIA quarterfinals by way of a 46-43 second round victory over host Bishop Amat last Friday in La Puente. In a defensive battle, the Olympians, who improved to 16-12 overall after winning the Pioneer League at 8-2, won the game on a three-point basket by Kavon Fair with six seconds left in the game. Fair led Leuzinger with 13 points.

In the first round on February 18 at Leuzinger, the Olympians rallied from a 13-point second quarter deficit to top Lakewood Artesia 51-44. Leuzinger started off slowly trailing the Pioneers 20-7 early in the second quarter. The Olympians cut the lead, trailing 24-18 at halftime. They got close but the turning point came with 2:57 left in the game when junior Darrion Williams went toward the basket but was fouled by Artesia's Gary Williams. In frustration, Williams slammed the ball to the court causing a technical foul and giving Williams four free throws. That was with the score tied at 39. It was right away that Leuzinger made the sixpoint play when Williams made all four free throws and, after the Olympians inbounded the ball, Christian Odionu rebounded a missed shot and scored giving Leuzinger a quick 45-39 lead and never trailed from there. That was the kickoff of a 14-0 run that gave Leuzinger a 51-39 lead dimming any hopes of an Artesia comeback.

"That technical definitely helped us," Leuzinger head coach Ali Parvaz said. "Before, we kept coming to tie but we weren't able to pull ahead."

Against the Pioneers, a once-proud program that had numerous CIF-Southern Section and California state championships during the 1990s and up to several years ago before a scandal caused them to not be at the same level, Leuzinger's sloppy start saw it fall behind by as many as 13 points before slowly inching in. The Olympians were able to tie the game several times and Artesia would lead by between two and four points

throughout the third quarter and up to the critical technical foul on Williams.

Darrion Williams led Leuzinger with 18 points. Davante Carr added 11 points and Odionu chipped in 10. The Olympians outscored the Pioneers 22-11 in the fourth period, as Darrion Williams and Odionu combined for 14 of those points.

Leuzinger hopes to advance to the semifinals for the second time in three seasons as it hosted Tahquitz from Hemet last Tuesday. If the Olympians win, they will play in the semifinals at a site to be determined Friday at

7 p.m. The championship will be on March 6 or 7 at either Azusa Pacific University or Godinez High in Santa Ana.

Ask DMV: Questions and Answers for February 2015

The DMV is now using TouchScreen technology to administer the driver knowledge exam. How is it different from the written version?

Instead of using a paper and pencil to the take the exam, you now simply touch the correct answer on monitor screen. The TouchScreen system guides you through the testing process and gives you immediate feedback if you answer a question incorrectly. It is currently offered in both English and Spanish. Additional languages will be added.

This technology reduces test times, improves field office wait times, minimizes fraud by randomizing test questions and answers, and provides easier maintenance of test questions, currently conducted manually.

Make sure you review the California Driver Handbook. You can find it at www. dmv.ca.gov. Do not forget to make an appointment. Good luck!

Do I need to visit a DMV office in order to renew my driver license?

Most drivers are not required to visit a DMV office each time they need to renew their driver license. Most of the time, a driver license can be easily renewed online at www.dmv.ca.gov, by mail, or by calling 1-800-777-0133.

However, the DMV generally mandates individuals with a clean driver record to visit

a DMV office once every 15 years in order to provide an updated driver license photograph and a vision test. You should carefully check your DMV notice to find out if you must appear in-person. If you are required to visit a DMV office, you are encouraged to schedule an appointment.

The DMV recently expanded the number of appointment opportunities available. Please be considerate of others. If you do not show up for your appointment, you prevent someone else from being able to use that time slot.

Are you required to make an appointment at the four Driver License Processing Centers to apply for an AB 60 driver license?

Appointments are not required, but strongly recommended, if you plan to visit one of the four Driver License Processing Centers located in Granada Hills, Stanton, San Jose, and Lompoc. These centers only process driver license transactions. They are open Monday through Saturday from 8 a.m. to 5 p.m.

Remember, that if you are applying for an original California driver license and plan to visit one of the other DMV field offices, and not a Driver License Processing Center, appointments are required.

The DMV lists several passports as acceptable documents to be used when applying for a California driver license under the AB60 law. Why is the country

of Colombia not on the list?

The DMV continues to work with countries and their consulates not identified on the current registration list. This list is not final. The DMV must go through the regulatory process to add documents to the current list of acceptable documents. Please keep checking our website, ab60.dmv.ca.gov, for updates on additional documents that will be accepted. DMV also offers another option for people from countries whose documents are not accepted. Under that option, applicants can present one of several documents which are available in this country and be interviewed by a DMV employee who will attempt to verify the applicant's identity. California is the first state in the nation to offer a secondary review process for applicants that lack typical identification documents to prove identity.
