Inglewood Police Department to Receive New Uniforms, Safety Equipment

The Inglewood City Council approved a purchase order with Galls Uniforms in the amount of \$42,500, which will be allocated to the purchase of uniforms and safety equipment for the police department's personnel.

Approved in the agreement was the additional purchase of helmets from Galls Uniforms for \$20,000. The city is also slated to make payment on past dues invoices to Gall Uniforms for past uniform and safety purchases in the amount of \$60,000.

Based on a Memorandum of Understanding [MOU] for general bi-weekly employees, police officers, civilian police and police management "the City must provide employees with the uniforms and safety equipment required to perform their assignments upon hire," indicates the staff report. The staff report identifies civilian police personnel as custody officers, records technicians, property offices and public safety dispatchers.

Among the items included in the department's safety equipment are: holsters, duty belts, helmets, ballistic vests and "other standard issued equipment." However, the city adopted a "blanket purchase" in order to make sure that all of the required items and equipment were obtained in a more time-efficient manner. Upon approval of the blanket purchase, the department's employees will be allowed to make purchases from Galls Uniforms, a California-based company, and it will also signify that the police department will receive a significant discounted rate on most products.

The neighboring City of Los Angeles has itself established a purchase order with the

retail business for its police department's public safety uniforms and equipment. Surrounding cities with their own police department base their public safety purchases on the wording of that purchase agreement established by the City of Los Angeles.

While these purchases will be covered by the general fund, last year the Inglewood Police Department received the Urban Area Initiative grant in the amount of \$228,500. Part of those funds were assigned to purchase personal protective gear for department personnel such as hazmat suits, armor and helmets. The department requested that the second purchase agreement be made by the city for the purchase of helmets, in order to be in compliance with the above mentioned grant.

During the 2014 Fiscal Year the police department had a purchase order in the amount of \$60,000 and has since received the corresponding invoices, which must be paid as soon as possible.

Budget Amended to Include Senior Nutrition Program

Members of the council agreed to amend the budget to reflect receipt of the Nutritional Supplemental Funds, as well as reaching an agreement with Tender Loving Care Catering [TLC] to increase the maximum contract by \$40,656 in order to provide more meals for the city's senior nutrition program.

The City of Inglewood has received grant funds through AAA from the Older Americans Act Grant Act of 1965. Through titles B and C the city is able to operate its nutrition program for seniors living in Inglewood and neighboring City of Hawthorne, Lennox and

Ladera Heights.

Through its Senior Nutrition Program, the city is able to provide meals to four senior centers, conduct at-home deliveries to "frail and home-bound" seniors citizens. In December 2014 the city's Parks, Recreation and Library Services Department presented a request for funding based on a survey from AAA "regarding additional nutrition funding to support unmet needs for meals, equipment and supplies for SNP services" indicates the staff report. W

"The senior population is continuing to grow rapidly, especially the segment age 85 and older," indicates the staff report. "More and more seniors are unable to prepare their meals and are experiencing severe financial straits. As a result, they have insufficient money for food."

On Feb. 15, the council received the notice that the request was approved and that nutritional supplemental grant funding would be awarded. The funding to be awarded is always based on the number of meals being provided and reported in the AAA Get Care System. The city will receive \$57,035 in grant funds for the meals and home delivery costs.

"The Nutritional Supplemental Funds will help the City's SNP services by providing funding to purchase approximately 13,906 additional home delivered meals for seniors and a steam table for food service," states the staff report.

However, as a condition of the funds, the city is expected to spend the funds by June 30, which marks the end of the AAA's 2014-2015 Fiscal Year. •

The Link Between Snoring And Heart Disease

(BPT) - Snoring isn’t pleasant for anyone - not the partner who has to sleep beside the snorer, nor the snorer whose breathing may pause repeatedly throughout the night. But did you know that loud, excessive snoring is often a sign of obstructive sleep apnea, a condition that - if left untreated - can cause you to be five times more likely to die from heart disease?

Along with good nutrition and regular exercise, healthy sleep is essential for a healthy heart. Heart disease is the leading cause of death in the U.S, so treating sleep apnea is good for your sleep and your heart.

According to the National Healthy Sleep Awareness Project, obstructive sleep apnea is a chronic disease that afflicts at least 25 million U.S. adults.

“Obstructive sleep apnea is destroying the health of millions of Americans, and the problem has only gotten worse over the last two decades,” says Dr. Timothy Morgenthaler, president of the American



Academy of Sleep Medicine and a national spokesperson for the Healthy Sleep Project. The project is a collaboration between the AASM, the Centers for Disease Control and Prevention, the Sleep Research Society and

other partners.

Sleep apnea involves repetitive pauses in breathing during sleep, which can put an enormous strain on the heart. Severe sleep apnea can reduce the amount of oxygen in your blood and cause dangerous surges in your blood pressure. This stress triggers your body to respond in ways that may promote heart disease.

Sleep apnea may be far more common than you think. Between 30 percent and 40 percent of adults with high blood pressure also have sleep apnea. The rate of sleep apnea soars to 80 percent among people with high blood pressure that do not respond to treatment with medications. Research even shows that sleep apnea can affect the shape, size and performance of your heart.

“The good news is that detecting and treating sleep apnea can improve your heart health and other clinical outcomes,” Morgenthaler says.

The primary treatment for obstructive sleep

apnea is continuous positive airway pressure therapy. CPAP therapy keeps your airway open by providing a stream of air through a mask that you wear during sleep. Treating sleep apnea with CPAP therapy improves blood pressure control and reduces the risk of heart disease. It can even reverse the changes to the shape and size of the heart that can be caused by sleep apnea.

Excess body weight is the leading risk factor for sleep apnea, and loud snoring is a common symptom. Other warning signs for sleep apnea include choking or gasping during sleep, and daytime fatigue or sleepiness. Visit stopsnoringpledge.org to pledge to “Stop the Snore” by talking to a doctor about your risk for sleep apnea.

“Treatment of sleep apnea can be life-changing and potentially life-saving,” Morgenthaler says. “For the best possible clinical outcomes, people with heart disease should discuss their risk for sleep apnea with their doctor.” •

A week after Lawndale High's boys' basketball team blew a 28-point lead late in the third quarter and lost the CIF-Southern Section championship to Anaheim Canyon 103-98 in double overtime on March 7 at the Honda Center in Anaheim, the Cardinals regrouped and recorded two easy wins over Van Nuys Grant and Redlands East Valley in the Southern California Regional Division II playoffs last week at Lawndale.

Against Grant, the CIF-Los Angeles City Division II runner-up, Lawndale had little

trouble in an 87-45 victory. Against East Valley, the Southern Section Division IIA finalist that fell to Compton, the Cardinals shut out the Wildcats 14-0 in the fourth quarter for a 75-50 win.

Lawndale, which began the tournament as the fourth seed, traveled to top seed La Costa Canyon in Carlsbad, a CIF-San Diego Section Open Division team that moved down to Division II in the regional semifinalist last Tuesday. If the Cardinals win, they will face the winner of Tuesday's other semifinal between Compton and La Mirada for the Division II championship and a right to play

for the California State Division II title at University of California in Berkeley at the Cal State Long Beach Pyramid Saturday at noon.

So far, Lawndale fixed itself well after that disastrous game against Canyon on March 7. Last Saturday, the Cardinals led East Valley throughout most of the three quarters with their biggest being 17.

The Wildcats, though, made some threats and got as close as seven points late in the third period, much due to the hot three-point shooting of Alexious Ziska, who led East Valley with 19 points that included six three-point baskets. Four of those came in the third quarter. In the fourth period, Lawndale's defense stiffened as it constantly clamped down on the Wildcats that resulted into holding them scoreless.

"We had some nightmares but this time I was more clear," Lawndale head coach Chris Brownlee said. "We needed to finish. Unfortunately last week, we didn't. We put it behind. We have to earn it next week. La Costa Canyon's a good team. We're going to keep working for it."

Chimezie Metu led the Cardinals (22-11) with a game-high 20 points and 12 rebounds. Among those for the six-foot-10 University of Southern California-bound senior was several spectacular dunks. Lawndale's other six-foot-10 player, San Diego State University-bound senior Brodricks Jones, added 14 points. Quincy Pinkard chipped in 12 points and Deandre Snedecor contributed 11.

The game started more than an hour later than its original 6 p.m. time due to East Valley's team bus breaking down in Ontario. The Cardinals were led by Jones with 17 points, 10 rebounds and four steals in their win over Grant. Tedric Johnson finished with 15 points and Snedecor had 13 points.

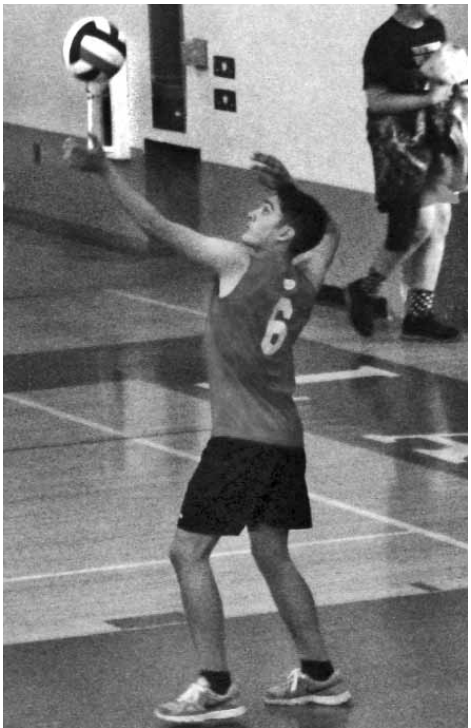
HAWTHORNE SWEEPS LAWDALE

Dawn Spacecraft Becomes First to Orbit a Dwarf Planet

NASA's Dawn spacecraft has become the first to achieve orbit around a dwarf planet. The spacecraft was approximately 38,000

miles from Ceres when it was captured by the dwarf planet's gravity at about 4:39 a.m. PST Friday, March 7. Mission controllers at NASA's Jet Propulsion Laboratory (JPL) in Pasadena, California received a signal from

the spacecraft March 7 that Dawn was healthy and thrusting with its ion engine, the indicator Dawn had entered orbit as planned.

"Since its discovery in 1801, Ceres was known as a planet, then an asteroid, and later a dwarf planet," said Marc Rayman, Dawn chief engineer and mission director at JPL. "Now, after a journey of 3.1 billion miles and 7.5 years, Dawn calls Ceres home."

In addition to being the first spacecraft to visit a dwarf planet, Dawn also has the distinction of being the first mission to orbit two extraterrestrial targets. From 2011 to 2012, the spacecraft explored the giant asteroid Vesta, delivering new insights and thousands of images from that distant world. Ceres and Vesta are the two most massive residents of our solar system's main asteroid belt between Mars and Jupiter.

The most recent images received from the spacecraft, taken on March 1, show Ceres as a crescent, mostly in shadow because the spacecraft's trajectory put it on a side of Ceres that faces away from the Sun until mid-April. When Dawn emerges from Ceres' dark side, it will deliver ever-sharper images as it spirals to lower orbits around the planet.

"We feel exhilarated," said Chris Russell, principal investigator of the Dawn mission at the University of California, Los Angeles (UCLA). "We have much to do over the next year and a half, but we are now on station with ample reserves and a robust plan to obtain our science objectives."

Ceres appears to be differentiated into a rocky core and icy mantle, and may harbor a remnant internal ocean of liquid water under the layer of ice. The surface is probably a mixture of water ice and various hydrated minerals such as carbonates and clay. In January 2014, emissions of water vapor were detected from several regions of Ceres. This was somewhat unexpected, because large bodies in the asteroid belt do not typically emit vapor, a hallmark of comets.

Italian Giuseppe Piazzi discovered Ceres on January 1, 1801 while he was searching for a star. He first believed that he had discovered a comet, but he was not confident in his belief. By the end of the year, with the help of other astronomers, he had collected enough evidence to call it a planet.

It takes approximately 4.6 Earth years for Ceres to make one revolution around the Sun. Ceres is located 415 million kilometers from the Sun and revolves around the Sun in an orbit between Mars and Jupiter. In 1802, additional objects were also found to be orbiting in the same area. Sir William Herschel labeled these objects as asteroids, so in 1802 Ceres became known as an asteroid, not a planet. Ceres was the largest known asteroid in the asteroid belt until 2006. In 2006, the International Astronomical Union formed a new class of solar system objects known as dwarf planets. By definition a dwarf planet is spherical and travels in an orbit around the Sun. Ceres fit the definition perfectly. •
