City Council Approves Consulting Services for Project Management City's RSI Program

Members of the Inglewood City Council approved an agreement with SMF Consulting for professional services that would assist in the accounting and analysis work relating to project management of the Residential Sound Insulation Program.

The agreement for services is in the amount of \$360,000, which are being made available from available grant funds. The staff report listed the expenditure of the total amount of the agreement as being derived from the general fund's Noise Mitigation Fund in the amount of \$337,500 while the remaining \$22,500 will be provided from the general fund's non-departmental miscellaneous contract services.

In the past SMF Consulting has worked in assisting the City of Inglewood and its staff with the accounting obligations by "identifying and documenting standard operational procedures and internal controls" states the staff report. In addition, SMF Consulting has been involved with the RSIP project management obligations in the past. The consulting firm has been a part of the city's finance department's efforts to resolve "major audit findings from prior years audits that have now been eliminated."

Since SMF Consulting has already been active in assisting the city during several months, the consulting group has been instrumental in working with city staff, Los Angeles World Airport and a PSOMAS database. Through its work and efforts, the city will be able to use all data collected to support grant reports to LAWA.

With the work already accomplished by SMF Consulting it was city staff, which requested he continued utilization of the firms services in order to continue managing the RSIP.

"In the upcoming months, there are some significant deadlines and due dates that are approaching and with the assistance of SMF, staff anticipates that these due dates and deadlines will be met," indicates the staff report

In addition to the duties already accomplished SMF will continue working to address in other areas within the finance department in an effort to "improve efficiencies" and help in the elimination of audit findings. In addition to the analytical work being conducted by the firm, its presence has assisted with the completion of work that has added up due to department vacancies and "extended employee absences." The reduction of the workload has had an overall positive impact on the entire department.

OF INTENTION TO AMEND CALPERS CONTRACT

The city council waived further reading and approved a resolution to amend the existing CalPERS contract that allows for miscellaneous city employees to receive credit for their cost sharing of the City's contribution rate.

The current agreement, a Memorandum of Understanding, was approved July 2014 and requires "classic miscellaneous employees" [SEIU, IMEO and IEO] to contribute two points of the employers contribution to CalPERS and 3.75 points for

new miscellaneous employees.

When the council approved the MOU, CalPERS was contacted so that the process of amending the city's contract be initiated to include the cost sharing by all miscellaneous employees. Once CalPERS made the amendment, the city was left with the final step of approving the contract.

With the new agreement, CalPERS will accept the employee's contributions "without applying them to their account but it is more beneficial to each employee to each employee if their contributions are applied to their respective account," states the staff report.

In addition, the staff report indicates that with increased member contributions, city employees are now paying the full employee contribution, which will be credited to each member's account as a normal contribution. This makes the contribution refundable when any member decides to step away from CalPERS covered employment. Upon such a decision, the once member can withdraw the contributions made, unless they prefer to wait until retirement.

The modification of the city's "CalPERS contract ensures that the cost sharing amount by the employee of the employer contribution is properly credited to the employee's CalPERS account," reads the staff report.

This change is considered to be more beneficial to employees than is the city was to approve a resolution of intent that would amend the PERS contract. In addition, this means there is no out of pocket expense to the city through the amending of the existing contract. •





Is A Line Of Credit Right For Your Business?

(BPT) - From time to time, your small business may face revenue swings, prompting you to borrow money to meet your shortterm cash and working capital needs. One option is to secure a business line of credit.

Small Business Administration defines a line of credit as a loan given by a financial institution to finance short-term current capital needs, such as inventory purchases or operating expenses.

"A line of credit is a useful tool for businesses with regular expenses, like paying employees or restocking inventory," says Jim Salmon, vice president of business services at Navy Federal Credit Union. "It can be tricky deciding whether a line of credit is the right tool for your company, so we help our business members weigh the pros and cons before making the financial decision that's right for them."

Below, Salmon outlines the pros and cons of a business line of credit.

Pros

The main benefit of a line of credit is that it acts as a safety net for your business, Salmon says. "It acts like working capital and makes funds available for your business while you wait for payments on accounts receivable," he explains. "You can rest easy knowing your employees will get paid even with unpredictable, temporary cash flow



slowdowns or problems."

A line of credit is also a means of leverage to help kick-start business growth. "Having the funds for extra inventory for a seasonal push can be tough for a small business," Salmon says. "The line of credit could permit for that additional purchase of stock and allow you to be more opportunistic."

A less obvious benefit is that it can strengthen your relationship with your financial institution. Making payments on time and abiding by the arrangements associated with its use shows viability of your company and character of management. Should you decide to expand your business, a strong relationship with your financial institution will help you gain future acquisitions faster. Cros

Salmon warns that a line of credit can be easy to misuse and "can get you into trouble."

"As a business owner, you want to monitor how much you access your credit line. Most are variably priced, meaning the rate can change quickly," he says.

Salmon also points out that just like a credit card, you should make the required payments, or your rate could increase sharply. In addition, owners should be aware of any added requirements that might be associated with having access to the line. For example,

quarterly accounts receivable reporting and financial requirements regarding liquidity and reporting are common. "Owners should ask themselves if they are ready and willing to commit to such oversight," he says.

Having a line of credit means there is on-record indication of how responsible you are with managing or mismanaging your money. "It will count in the grand scheme of potential credit and be incorporated in any future decisions with your financial institution," Salmon explains.

If you're interested in obtaining a line of credit for your business, talk to your financial institution about your options. Each institution has its own criteria for obtaining a line of credit, such as two-years-in-business minimum or collateral. Salmon adds that sometimes, "a small business is able to secure a line of credit with the collateral being the assets of the business or personal assets if need be."

If your business doesn't qualify, Salmon says there are other loan alternatives. For example, Navy Federal recommends a business credit card as a viable option for its members that need funds from time to time for small purchases or cash advances.

Follow Salmon's advice above and talk to your financial institution to see if a business line of credit is right for you. •



Bacon Pretzel Twists

Ingredients

- 1 pound bread dough (you can buy some Brigford frozen bread dough or make your own favorite recipe)
- 12 to 14 thick sliced of good quality bacon
- ½ rock salt or course sea salt

Preparation

- **1.** Roll out the dough so it looks like a rectangle 4 inches by 12 inches
- 2. Cut into 12 to 14 ½ inch strips
- **3.** Wrap the bread strip with the bacon then place on a parchment paper lined sheet pan
- **4.** Sprinkle with the salt and bake at 350 for 12 to 15 minutes or until golden brown
- 5. Serve warm with spicy mustard
