City Council Approves Agreement with National Recreation and Parks Association

Based on the recommendation by the Parks, Recreation and Library Services department, members of the Inglewood City Council approved an agreement with the National Recreation and Parks Association for the receipt of \$10,000 in grant funds.

The funds from the agreement will be made available from March 31, 2015-March 1, 2016 and will fund what the staff report identified as “out-of-school programs” throughout the year. The agreement was approved along with a resolution amending the 204-2015 fiscal year in order to account for the NRPA grant.

Through the OrganWise Guys Program the city’s youth has been provided out-of-school time program sites during the fall and summer. In order to operate the program, the City of Inglewood approved accepting of a NRPA grant worth \$30,000 back on May 13, 2014. The agreement included in-kind nutritional literacy material valued at \$10,000, as well as a \$1,200 stipend to cover travel expenses to Reston, West Virginia for staff to attend “evidence-based nutrition literacy training” for the OWG program.

The staff report indicates that on Feb. 4, “the NRPA announced the availability of \$10,000 additional grant funding from the Walmart Foundation to support children’s health through park and recreation programs.”

The \$10,000 in supplemental monies will allow the city to continue funding existing staff [program liaison], whom perform the duties of program specialist.

“The program specialist will continue coordinating the OWG nutrition literacy program, as well as the Summer Food Service Program [SFSP] and After School Recreation

Program [ASRP] for youth at ten out-of-school time program sites in the summer and fall of 2015,” indicates the staff report presented to the council by Sabrina Barnes, Parks, Recreation and Library Services Director.

The NRPA grant approved by the city council will focus on the four following goals: to increase the number of healthy meals children in low-income communities receive through the SFSP and Child and Adult Care Food Program [CACFP] during out-of-school times; provide evidence-based, age-appropriate nutrition literacy to children that create behavior change by teaching the importance of healthy eating; to implement nutrition standards that increase access to healthier foods and support a healthy eating environment; and to promote meal and program efficiencies that will reduce costs, maximize existing resources, decrease food waste, and lead to more sustainable meal programs.

“The NRPA grant is a great opportunity to continue the City’s role as the community’s health and wellness leader by helping increase access to healthy foods and improving opportunities for physical activity,” states the staff report. “The City will also receive additional support for meals provided through USDA afterschool and summer feeding programs as well as nutritional literacy materials to help ensure life-long healthy habits for the City’s youth.”

CITY AGREES TO FIVE-YEARS WITH TIME WARNER CABLE

The Inglewood City Council with Time Warner Cable Business Class agreed upon a five-year agreement in the amount of \$64,651 dollars, at a yearly cost of \$12,931.

The City of Inglewood entered “into a Cable Television Ordinance” with Theta Cable Television back in Dec. 14, 1971. At the time Theta Cable Television agreed to “furnish, without installation, charge or monthly service fee live connections” to City Hall, the city’s fire stations, police department, main library and public works.

“Throughout the years, the City has received cable vision television services under different franchise names,” states the staff report presented. “Presently, Time Warner Cable Television services the City of Inglewood.”

However, the ordinance [Ordinance No. 2536] expired on Jan. 12, 2014, at which point the city began paying a monthly fee of \$22.75 in addition to taxes and fees per cable box. Initially the city had a total of 76 cable boxes; however, staff was able to determine that a certain number of cable boxes could be shared among several divisions within the city’s departments. The staff was able to reduce the amount of boxes needed to 49 at a monthly coast of \$1,077.51.

“Cable television service is an important asset for the Inglewood Police department as well as the City of Inglewood Emergency Operations Center [EOC] Team,” indicates the staff report. “It allows the Inglewood Police Department and EOC to have instant information fed from the various news outlets available through cable service. Management staff is able to view the Council meetings via the cable service and receive information from various news outlets as well.”

The cable service does not give staff access to any entertainment stations such as HBO, Showtime, On Demand and other premium stations. •

Three Hawthorne Officers Received Medals of Valor

Hawthorne PD officers Shaun Kemp, Michael Murray, and Gustavo Rubio received the Medal of Valor “Life Saving Award” by a committee of the joint South Bay Chambers of Commerce. The awards were presented at a luncheon on May 20th, and the guest presenter was0 KTLA anchor Glen Walker.

Officer Shaun Kemp has been with the

Hawthorne PD for five years and is a certified EMT and Tactical Medical Instructor. In 2014, Officer Kemp responded to a radio call and found a non-responsive baby girl at the scene. When Officer Kemp ascertained that the baby was not breathing, he began infant CPR and “mouth-to-mouth” breathing for several minutes until the fire personnel arrived. The ambulance personnel were able to regain a pulse during the ambulance ride, and the baby recovered. Officer Kemp received the Life Saving Award for his quick response and actions.

Officer Murray, an EMT and Tactical Medical Instructor who has been with Hawthorne PD for seven years, also responded to a call in 2014 of a child barely breathing and blue around the mouth. Office Murray found the child in dire respiratory distress and used his “Bag Valve Mask” to provide lifesaving breaths for the child. When paramedics arrived, they were able to take the child to the hospital for treatment and recovery. Office Murray was awarded the Life Saving Award for his fast decisive actions.

Officer Rubio is a 14-year member of the City of Hawthorne, and has worked in the Patrol Officer, Motor Officer, and SWAT

departments. In February 2014, Officer Rubio was attending his daughter’s volleyball game when the mother of a player collapsed in the bleachers. Officer Rubio quickly assessed the woman and determined that her condition was critical. He quickly began administering CPR

and continued with the help of the woman’s husband until another person arrived with an Automated External Defibrillator (AED). Officer Rubio used the AED to regain the woman’s pulse, and then the fire department personnel were able to transport her to the hospital. Officer Rubio’s extensive training and knowledge prepared him for this important task and he also received a Life Saving Award. •

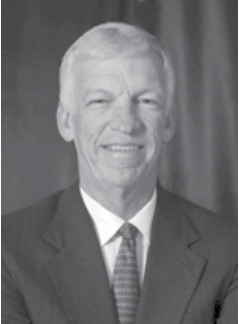
The ceremony begins at 10 a.m. and will be followed by a luncheon.

A REAL AMERICAN HERO

I had the privilege to visit with a very special veteran recently. His name is Bob Farner. He lives in Vista and just happens to be my brother-in-law’s father. I had heard a few stories about his military service, but until I sat down in his living room to converse with him, I didn’t realize what a great American story his life has been. After running away from his Colorado home at age 15, he hitched a ride on a freight train ending up in San Francisco. He sold flowers to make some



money. He lied about being 18 to enlist in the Marines and was sent to China during WWII. He was transferred to Manila when the Pacific Theater heated up and was assigned to help guard General MacArthur. The Japanese army overran the island and took him to the worst of the worst prison camps in the Philippines. In that prison he had

both of his arms broken and his head smashed against the brick walls numerous times. After more than a year of torture Bob was loaded onto a slow barge of a boat and taken to mainland Japan where he found the prison work and treatment much easier to tolerate. Later he found out from a US submarine commander that they decided not to waste a torpedo on his rickety old boat. After the Japanese surrender, Bob and his POW buddies boarded trains to begin their trip back to the States. Bob loved the action. He loved his service to his country. He reenlisted several times after WWII and served his country in the Korean War. Bob came very close to signing up again to go to Viet Nam. In his retirement, he started an animal rescue farm in his large back yard of his home on a hill in Vista. For two decades he had mountain lions, coyotes, cougars, exotic birds, and even an alligator roaming around the caged area of his property. I only sat down for 30 minutes or so to talk with Bob. I told him we need to write a book. He told me I would have to sit for a week to recount everything. We honor Bob and all of the veterans who served their country so proudly this Memorial Day Weekend.

Spinach Turkey Sliders with Lemon Yogurt Sauce



Serves 10 | Prep time: 25 minutes | Total time: 45 minutes

Ingredients

- 1 can Pillsbury(TM) Grands!(TM) Jr. Golden Layers Butter Tastin'(TM) refrigerated biscuits (10 biscuits)
- 4 tablespoons Crisco(R) Pure Olive Oil
- 2 teaspoons Watkins(TM) Sesame Seeds
- 1 box (9 ounces) Green Giant(TM) Steamers(TM) frozen chopped spinach
- 1 1/4 pounds ground turkey
- 2 containers (5.3 ounces each) 100-calorie fat-free lemon Greek yogurt, stirred
- 1/4 teaspoon Watkins(TM) Garlic Powder

Preparation

1. Heat oven to 400 F. Separate dough into 10 biscuits and place 2 inches apart on ungreased cookie sheet. Brush tops of biscuits with one teaspoon of the oil. Sprinkle with sesame seeds and press in lightly. Bake eight to 11 minutes or until golden brown.

2. Meanwhile, microwave frozen spinach as directed on box for 3 to 4 minutes to thaw. Drain well and squeeze dry with paper towels. In large bowl, gently mix spinach, ground turkey, 2 tablespoons of the yogurt, the garlic powder, 1 1/4 teaspoons salt and 1/4 teaspoon pepper just until combined. Shape mixture into 10 (3-inch) patties.
3. In 10-inch nonstick skillet, heat two tablespoons of the oil over medium-high heat. Add 5 patties and cook 4 to 6 minutes, turning once, until meat thermometer inserted in center of patties reads 165 F. Drain on paper towel-lined plate. Repeat with remaining oil and patties.

4. In small bowl, mix remaining yogurt, 1/4 teaspoon salt and 1/4 teaspoon pepper until blended. Split biscuits and spread 1 tablespoon yogurt sauce over cut side of each bottom biscuit. Fill biscuits with patties. Serve with remaining yogurt sauce.



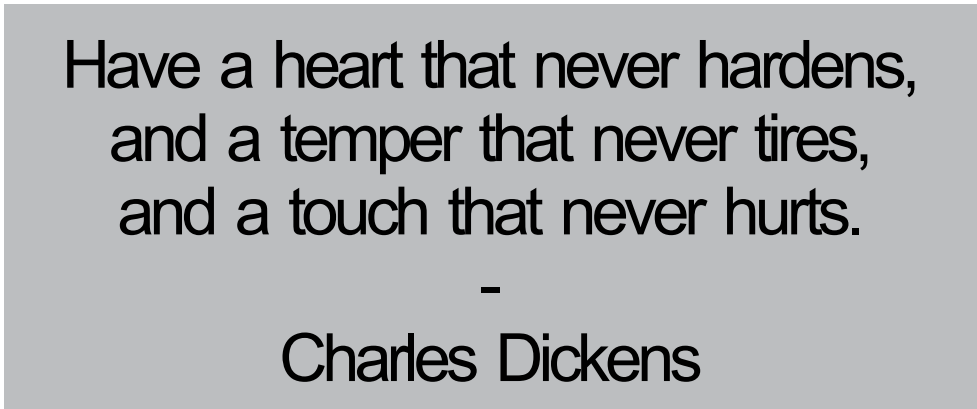
