Turf Installation Proposals Rejected

Through the recommendation of the Parks, Recreation and Library Services Department, the Inglewood City Council rejected every bid that the city received for the Vincent Park Turf Installation Project. In addition, the council authorized city staff to rebid the project.

On June 30, 2009 and July 20, 2010, the city council and mayor approved a Community Development Block Grant Award for a total of \$1,239,748 to be used to improve public facilities to multi-purpose fields at Edward Vincent Park, via the installation of artificial turf. In addition, on April 19, 2011, \$700,000 in CDBG funds were awarded to the city.

"The initial scope of work funded by CDBG included installation of artificial turf on only one of the two fields," indicates the staff report signed by Parks, Recreation and Library Service Director Sabrina Barnes. "Additional funds were required to install turf on both fields." The city council and mayor made approved agreement No. 11-070 with PSOMAS for professional design and engineering services in the amount of \$191,700, on June 7, 2011. The final design, the specifics and total cost of plans were completed and scheduled construction to begin during the summer of the same year. However, in December of 2011 representatives from the United States Department of Housing and Urban Development [HUD] carried out a site visit of the fields at Edward Vincent Park. "The purpose of the visit was to see the site and confirm the project's eligibility," states the staff report. "HUD provides federal funding for the City's Community Development Block Grant [CDBG] program."

ordered stopped "citing the need for further review of the project to ensure the end users are low/moderate income eligible residents within the CDBG benefit areas." As a result, from February 2012 through September 2013, CDBG and Parks, Recreation and Library Services Department staff responded to several information requests made by HUD. The information was to determine the city's overall low and moderate percentage, the project's funding sources [aside from CDBG], as well as usage of the facilities and purpose of the fields, users, and the procedures used to account for the program's received income

from all fees implemented for field use. It wasn't until December 2013 that the Proposition A funds, according to the Count of Los Angeles Department of Parks and Recreation is for the "acquisition, development, rehabilitation, protection and restoration of beach, wildlife, park and natural lands with the County, tree-planting, gang prevention and intervention, and improvement of recreation facilities for youth and senior citizens."

For the city to move on with the project, the engineering firm on record [PSOMAS] was to become involved with revisiting and revising the original PS&E package but with the new design recommendations made by WILLDAN Engineering. PSOMAS completed the new design in February and the bid invitation was published, resulting in eight contractors attending the pre-bid conference on April 15. Those contractors included: ABC Builders, Inc., Asphalt Fabric and Engineering, Inc., Green Giant Landscape Inc., Hellas Construction, Inc., Los Angeles Engineering, Inc., Ohno Construction, South Bay Landscaping Inc. and Sprinturf Co. The three bids considered by the city's staff proposed by: Green Giant Landscaping, Inc. [\$1,487,505], Ohno Construction, Inc., [\$2,869,993.60] and Los Angeles Engineering, Inc. [\$3,000,337]. "Staff reviewed the bids and recognized the considerable differences in costs between the two lowest bidders," states the staff report. "Therefore, staff determined to modify the scope of work and reclassify bid items and update the budget to allow for maximum flexibility. In order to avoid legal trouble while rehabilitating the two soccer fields into multipurpose fields, the city exercised its right to reject the bids received based on the city's "best interest as provided in the bid specifications." •

city was granted authorization though the CDBG division to move forward with the artificial turf project. However, since the initial design plans, specifications and costs estimate [PS&E] were two years old, city staff worked with WILLDAN Engineering to review the first PS&E proposal. The report produced by WILLDAN Engineering suggested a new design and revised the total cost, which again was short of the amount of funds available to the city.

"On June 3, 2014, the Mayor and Council Members authorized the use of Los Angeles County Maintenance and Servicing Funds [M&S] in the amount of \$896,870 for the Edward Vincent Park Artificial Turf Project grants to cover the associated increase in project costs associated with the new design recommendations," states the staff report. "The funds are available through the Los Angeles County Prop A Maintenance and Servicing Fund, a fund designed to offset the increase in maintenance and servicing costs resulting from Proposition A grant-funded projects."

Film Review Me and Earl and the Dying Girl Is a Sincere, Offbeat Dramedy.

It's hard to deny the power of the two anchoring performances in Me and Earl and the Dying Girl-those of Thomas Mann, or Me, and Olivia Cooke, or the Dying Girl. Mann plays Greg, a reserved teenager whose high school life depends on a carefully cultivated neutrality and lack of involvement, soon threatened when his mother decides he should befriend an ailing classmate he barely knows. So we meet

Rachel (Cooke), a teenager recently diagnosed with cancer who rejects Greg's obligatory pity before she's eventually charmed by his awkward magnetism.

Me and Earl and the Dying Girl thrives on the strength of these two characters and the easychemistry of the perfectly cast young actors. Their first full scene together, wherein Greg breaks through Rachel's depressed façade with some off-the-cuff observations about the attractive pillows in her room-don't worry, it works better in context-is easily one of the film's best. Though this relationship is surely the film's most important, it doesn't always get the focus it deserves, as the film spends much of its time rounding out the supporting players in Greg's life. Greg makes arthouse parody films with his best friend, or "coworker" as he insists on calling him, Earl (RJ Cyler), he endures the doting of Rachel's wino mother (Molly Shannon), he enjoys exotic foods courtesy of his anthropologist father (Nick Offerman), he watches movies during lunch in the office of a cool teacher (John Bernthal)-the list goes on. There are certain clichés that almost inevitably come with any modern independent coming-ofage tale, and unfortunately, despite its strong lead performances, Me and Earl doesn't completely avoid those clichés. The movie hinges upon the

arc of Greg, a mostly well-sketched character whose crippling self-esteem issues come to the film's forefront once he unwillingly embarks on a near-endless endeavor to create a movie for Rachel. There's real poignancy to the tale, as Greg is forced to confront his own feelings of self-hatred along with a newfound fear of death that comes from being in such close proximity to someone who is really, truly, slowly dying.

It's puzzling then, why director Alfonso Gomez-Rejon felt the need to dilute the poignant tale with so many extraneous stylistic choices, with so much quirk. The movie opens with an unrelated voiceover and a couple cutesy claymation interludes as Greg ponders the best way to begin a story-both the claymation interludes and the voiceover continue intermittently and unnecessarily throughout the film. In one scene, Earl and Greg get unexpectedly high, and even hallucinate giant costumed animals, after consuming some mysterious drugged comestibles. One puzzling subplot involves a pretty classmate who unknowingly leads Greg on, only for her to inevitably profess actual interest in him, though he's hardly said more than a dozen words in her presence.

It's not that these clichés are inherently bad, but it's hard to justify their existence within the context of Me and Earl, when the film's runtime would be better spent allowing the characters to develop naturally. While Greg may be well-drawn, many of the supporting players never get their fair share of screen time or development due to the film's preoccupation with such quirk. In spite of his title billing, Earl for one never really develops beyond a straight-shooting comic relief who occasionally doles out information on the source of Greg's insecurities, hinting at strained relationships with his parents-relationships that also get short shrift. The film is instead crowded with diversions that don't really do anything to propel the narrative or its characters forward. Plus, they're just not very funny or interesting. It's a shame, as Me and Earl and the Dying Girl is often far smarter than its cookie-cutter coming-of-age plot might imply. There's a lot to enjoy when the film occasionally finds its groove, letting the characters develop and bounce off of each other naturally, but there's a lot to groan about too. The former slightly outweighs the latter, and the film is made worth seeing thanks to the occasional flashes of brilliant writing and


HOLLY PARK HOMEOWNERS ASSOCIATION TO HOLD PANCAKE BREAKFAST

Eight Scholarship Recipients Recognized During Board Meeting

Hawthorne School Board members, along with Terry Hays-Horner and Ann Paour from American Association of University Women Beach Cities Branch, recognized eight of the district's seventh grade students for earning the AAUW Beach Cities Branch Tech Trek Science Camp Scholarships.

The Hawthorne School District students, all girls, Jacqueline May, Shelbie Nguyen and Shannon Sukantri from Bud Carson Middle School; Isabella Cruz, Valeria Iniguez and Amy Johnson from Hawthorne Middle School; Shemiah Nesbeth and Yamileth Sanchez from Prairie Vista Middle School were present at the meeting, with the exception of Johnson.

"We are honored and privileged that the American Association of University Women are here to present some scholarships to our middle school students," Hawthorne Superintendent Dr. Helen Morgan said. "We have eight recipients this year which is more than we have had in a long time." All nine of the scholarship recipients will have the opportunity to attend Tech Trek, a science and math summer camp designed specifically for girls with the goal of sparking an interest in the seventh-grade students to pursue science, technology, engineering and math [STEM] careers. "The best thing about it [Tech Trek] is that it gives the girls the opportunity to stay on a college campus. They stay at the dorms, the go to classes throughout the day and take field trips to different areas," Paour said. "All of the activities are tied to science, technology, math and engineering. The camp takes place Monday through Friday and it is a good opportunity for the girls to experience college life, away from their families."

who has an AA degree.

"It [AAUW] is the oldest and largest national organization working for equality and the advancement of women through education," Paour said. "It works in coalition with a number of other organizations supporting legislation involving child care, educational equity, pay equity, parental leave, school based public centers, gender balance and responsible funding for education."

During the late 1990s, an AAUW member near Stanford expressed their concern regarding the fact that there weren't enough women in the math and science careers, also referred to as STEM careers. As a result, in 1998 the AAUW started this program on the Stanford campus and named it Tech Trek. There are now eight campuses in the state, four in Northern California and four in Southern California [UC San Diego, UC Irvine, UC Santa Barbara and Whittier College], that are dedicated to operating these summer camps. "Since I have been a member of AAUW in 2006, we started giving scholarships to girls in the Hawthorne School District," Hays-Horner said. "What was very cool, because I worked here, is that I was able to speak to the principals to start this with the seventh-grade girls. Why seventh grade girls? That is when girls might start having interests develop in different areas, so we introduce them to this." The AAUW Beach Cities branch was named the Manhattan Beach branch but with members from Redondo Beach, Hermosa Beach, El Segundo, Santa Monica and Pacific Palisades, the name was changed to reflect its more inclusive efforts. In order to select the scholarship winners each year, science teachers at the middle schools are asked to nominate girls who demonstrate an interest in the sciences. Once the science teacher nominates the student, the student is responsible for filling out and submitting an

application, which includes writing an essay that is read by AAUW branch members. The girls are then interviewed by a couple of the branch members and a decision is made based in all three requirements.

"One of the reasons our beach cities branch has moved toward looking into Hawthorne, Lawndale and Wiseburn is because there are some families in this area where the girls might not be as encouraged to go on to college," Paour said. "This gives them a exposure to college and gives them that

opportunity to say 'This is something I can do and that I want to do.""

The scholarship recipients are asked to pay \$50 but the cost of the scholarship itself is \$900 per student, which covers the week's activities at Tech Trek.

"These girls are amazing," Hays-Horner said. "First they have to be nominated by a teacher and then they have to go through a vigorous selection process. No parent can pay for their child to go to Tech Trek; it has to be a nomination." •

Pluto's Moons Seen in Highest Detail Yet


Much ink has been spilled over Pluto's reclassification as a dwarf planet. And yet, such discussions have not diminished scientific interest in Earth's most distant cousin. A new study is the first to reveal fascinating details about the orbital and rotational patterns of Pluto and its five known moons.

The study, published in the June 4, 2015, issue of the journal Nature, describes a system dominated by Pluto and its largest moon, Charon, which together form a "binary planet." Four smaller moons orbit this pair. The paper reports the techniques used to discover the two smallest moons, Kerberos and Styx, and also provides a detailed description of the strange and unpredictable rotational states of the two slightly larger moons, Nix and Hydra.

Later this summer, NASA's New Horizons spacecraft will pass by Pluto and its five known moons, providing the most detailed look at this planetary system to date. Kerberos and Styx were discovered in 2011 and 2012, respectively, while Nix and Hydra were first discovered in 2005.

"Like good children, our moon and most others keep one face focused attentively on their parent planet," said Douglas Hamilton, professor of astronomy at the University of Maryland and a co-author of the Nature study. "What we've learned is that Pluto's moons are more like ornery teenagers who refuse to follow the rules."

The imbalanced and dynamically shifting

gravitational field created by Pluto and Charon sends the smaller moons tumbling in unpredictable ways. The effect is amplified by the fact that the moons are roughly football shaped, rather than rounded spheres. The findings are the result of a comprehensive analysis of Hubble Space Telescope data regarding the orbits and properties of the four smaller moons.

In contrast to these seemingly random rotational

motions, the moons follow a surprisingly predictable pattern as they orbit the binary planet formed by Pluto and Charon. Three of them-Nix, Styx and Hydra-are locked together in resonance, meaning that their orbits follow a clockwork pattern of regularity. The same effect can be seen in three of Jupiter's large moons.

"The resonant relationship between Nix, Styx

and Hydra makes their orbits more regular and predictable, which prevents them from crashing into one another," Hamilton said. "This is one reason why tiny Pluto is able to have so many moons."

The study also revealed that Kerberos is as dark as charcoal, while the other moons are as bright as white sand. "This is a very provocative result," said lead author Mark Showalter, a senior research scientist at the SETI Institute. Astronomers had predicted that dust created by meteorite impacts should coat all the moons evenly, giving their surfaces a uniform look.

"Prior to the Hubble observations, nobody appreciated the intricate dynamics of the Pluto system," Showalter said. The New Horizons flyby in July may help solve the mystery of Kerberos' dark surface, and will refine scientists' understanding of the odd rotational and orbital patterns uncovered by Hubble. The New Horizons team is using Showalter and Hamilton's discoveries to help guide science planning efforts.

Among other expected insights, a more detailed study of the chaotic Pluto-Charon system could reveal how planets orbiting a distant binary star might behave. Although many exoplanets have been found to orbit binary stars, these star systems are too far away to figure out their rotational patterns using existing technology.

"We are learning that chaos may be a common trait of binary systems," Hamilton said. "It might even have consequences for life on planets orbiting binary stars." •

He is already being compared and, possibly, ahead of the efforts of 1980's Hawthorne High stars Henry Thomas and eventual Olympic gold medalist (200 meters and 4x100 relay in 1992 in Barcelona, Spain) Michael Marsh. •


Ingredients
