Imported Banners Raise Red Flag

Life hasn't been the same since 9/11. The Homeland Security Agency was created to intercept and prevent terrorists from launching attacks on U.S. soil. Flying became more of a hassle as airports erected checkpoints and scanned passengers boarding flights for weapons and explosives. And, American-made products grew in demand.

With the Commerce Department slapping higher tariffs of thousands of Chinese-made products, the interest in buying products made in the U.S.A. could peak again like it did after Sept. 11, 2001. The current dispute between the U.S. and its trading partners, including Canada and Mexico, almost certainly means higher prices on automobiles, clothing and foods.

Consumers are caught in the middle until a truce is called in the trade war over protecting home-grown industries. That's the purpose of the tariffs, according to experts, and every major trading nation uses them. The North American Free Trade Agreement (NAFTA) with Mexico and Canada eliminated most of the import taxes -- particularly those on farm products, garments and automobiles. Even that agreement and its future hangs in the balance right now.

One avenue to avoid price increases is to buy American-made products until the dust settles. Consumers trust the "Made in U.S.A." tag on a product and expect the claim to be true, according to the Federal Trade Commission. The FTC explains on its website that "Made in U.S.A." means "all or virtually all" the product has been made in America. The materials and labor that go into manufacturing also must originate in the United States, according to federal law. The FTC polices "Made in the USA" claims and prosecutes companies it suspects of cheating.

The sale of American flags after 9/11 soared,

according to the trade group calling itself Flag Manufacturers Association of America. The Wayne, Pennsylvania-based group issued a reminder ahead of the July 4 holiday to read the label before buying a new or replacement banner. Not all American flags are created equally, the group says.

"How would you feel if the American flag you so proudly display was made in another country? Kind of defeats the purpose of being a true symbol of patriotism, doesn't it?" asks the Flag Manufacturers Association of America on its web page explaining its certification program to ensure the American flags are "homegrown with pride."

U.S. law requires every flag be labeled with its country of origin, the group says. The red, white and blue national banner is protected from foreign competitors in other

ways, too. The U.S. Pentagon only buys flags made in the U.S.A. that fly at military bases and installations here and abroad.

The biggest exporter of American flags to the states is China, though sales accounted for just over \$5 million in 2017, according to U.S. Census Bureau data. U.S. flag manufacturers dominate the marketplace, with Mexico and the Dominican Republic being the biggest customers for the star spangled banner.

April, May and June are the busiest months for flag sales, according to industry figures. Memorial Day, Flag Day on June 14, and Independence Day are considered the most popular times to fly the American flag. It's acceptable to display the flag every day of the year, though etiquette calls for the flag to be taken down for inclement weather and after

Johnstone Attends Final Regular Wiseburn School Board Meeting

Two days and counting until Dr. Tom Johnstone, long-time Superintendent of the Wiseburn Unified School District (WUSD), heads off into retirement. While most retirees are aware of the date of their last official day on the job, Johnstone, courtesy of a retirement countdown clock that was gifted to him by a WUSD food services employee more than two years ago, has been noting his countdown date for a while.

Johnstone noted that he originally planned to say goodbye last year, but decided to stay on until the Wiseburn High School opened. "I wanted to work here in this [new] building for a while," he said. Meanwhile, he attended his final official School Board

meeting Tuesday evening. He will also be in attendance Friday morning when the Board is scheduled to okay the District's 2018/19 budget at a brief gathering. Johnstone was selected, for the first time in 10 years, he said, to lead the assembled members and audience in the Pledge of Allegiance to kick off the meeting's open session.

Dr. Blake Silvers, who had been serving as Dana Middle School's principal, becomes superintendent upon Johnstone's retirement. Silvers, in his comments Tuesday evening, noted how Johnstone is a man who doesn't take no for an answer when it involved the welfare of the WUSD. "There's always a reason not to do something," Silvers

In the past he has collaborated with James Patterson on children's books such as the *I Funny* series. *Welcome to Wonderland: Home Sweet Motel* is perfect for young readers who enjoyed either of the series I mentioned above. I would highly recommend this book to 8-12-year-old readers.

P.T. Wilkie is a 12-year-old boy who absolutely loves the Wonderland Motel in Florida where he lives with his mother and grandfather. The motel was originally opened by P.T.'s grandfather, who is responsible for the "zany decorations" and known to tell a tall tale or two. P.T. believes that the Wonderland Motel is positively the *best* place a kid could

However, Wonderland doesn't have many customers and it is in a bit of trouble financially. When Gloria and her father check into Wonderland, an outrageous plan to save the motel is hatched. Moreover, when two elderly jewel thieves come looking for diamonds they lost at Wonderland years ago, P.T. and Gloria decide this is their chance to save the motel. This book is quirky and upbeat. It is full of laughs and some mystery as well as a bit of danger. Grabenstein has delivered another book that is sure to have young readers cracking up and eagerly awaiting the next installment of the series.

Film Review

Robert Pattinson Is a Quirky Cowboy in Western Spoof *Damsel*

Fresh off the heels from starring in the Safdie brothers' stylish crime drama *Good Time*, Robert Pattinson finds himself working with another set of director brothers to show off his more comedic side in the wacky Western *Damsel*. Trading cool for kooky, Pattinson plays a man desperate to be reacquainted with his one true love, despite the physical -- and, as we find out, emotional -- distances between them. David and Nathan Zellner, collectively

that it feels awkwardly split into two very distinct acts: the first being Samuel's journey up the mountain to find Penelope, and the second being Penelope's journey back down the mountain to independence. However, there is little-shared overlap in the middle. We initially become so invested in Samuel's story (who himself is a delightful character) that when the focus and story shifts to Penelope (who unfortunately isn't as cartoonish a character as Samuel), she seems resigned to swat away the advances of every male she

Samuel Alabaster (Pattinson) is a man on a mission. With an engagement ring in one hand and a miniature horse on a leash in the other, he has traveled to a small, dusty Western town to enlist the help of Parson Henry (David Zellner) -- the local pastor who also happens to be the town drunk. While the exact details of the journey remain unclear (or may not yet be fully revealed), Parson, who is not one to turn down monetary compensation, agrees to follow Samuel on this mission. After traveling for days on horseback, Samuel finally explains to Parson that he is en route to rescue his fiancée Penelope (Mia Wasikowska) from her evil kidnapper so he can marry her and live happily ever. The only problem is, once the duo reaches Penelope, it turns out that not everyone is on the same page -- namely, Penelope. From here, it's a comedy of errors as Parson attempts to piece everything together on his own while the situation unfolds very quickly. No one is safe, no one is certain of what is going on, and no one wants to be where they are.

Damsel has the structure of a good comedy -- its deadpan delivery evokes the humor of Wes Anderson and its silliness is one whiskey shot away from being another *Three Amigos!* or *A Million Ways to Die in the West*. However, *Damsel's* biggest flaw is

encounters like flies. This creates somewhat of a disappointing end.

There is no denying that *Damsel* is in a league of its own and that the Zellner brothers have effectively combined modern deadpan comedy with old Western tropes to transcend time periods. However, while it's clear that Penelope may not need help finding her way out of a messy situation, this *Damsel* could use just a little bit more saving.

sundown unless the flag is lighted after dark. A few fun facts about the U.S. flag: Mother's and Father's days are considered U.S. flag holidays. So is New Year's Day and election days, according to the American Legion. A complete list of flag days is found at the American Flag Foundation website. Anyone can buy a U.S. flag that flew over the U.S. Capitol in Washington, D.C., too, according to the foundation. Hundreds of flags are flown over the Capitol dome each day to accommodate the number of requests for these flags.

Flag Day on June 14 celebrates the unveiling of the first U.S. flag in 1777. There have been 26 versions of the national flag. The one used today featuring 50 stars and 13 stripes was designed in 1958 by a 17-year-old high school student. Robert Heft of Lancaster, Ohio submitted his sewing project to the White House. Legend has it Heft received a B-minus from his home economics teacher for his design. President Dwight Eisenhower chose the young man's submission out of 1,500 entries. The rest, as they say, is history.

quoted Johnstone. "You have to find a reason... to do something."

Johnstone's achievements included piloting the unification of the Wiseburn K-12 school district, as well as spearheading the groundbreaking of the high school facility that houses Da Vinci Communications, Da Vinci Mathematics, and Da Vinci Science schools.

Accolades received during Johnstone's 10-year tenure included his 2012 selection as Superintendent of the Year by Pepperdine University, as well as a similar selection by Region 14 of the Association of California School Administrators in 2014.

Johnstone said that he hoped the initial phase of his retirement would allow him to relax and recharge his batteries. "I want to unwind a little bit because I have been wound pretty tight since 1984," he admitted. He added that he "had a very blessed career," noting how he has been able to spend the entire time (he came to the WUSD from the Lennox School District) locally and that allowed him to know the community. "You spend a lot more time here than you do at home," Johnstone said. "The South Bay has been home for the past 38 years. We were able to accomplish some pretty wonderful things."

Board Vice President/Clerk Roger Banuelos emailed, "I have had the privilege of working with Tom over the past eight years as a Board member, and I, as our Wiseburn community, owe him a tremendous debt of gratitude. His commitment, passion and leadership have allowed our schools and students to achieve at the highest possible levels. Above all, Tom has demonstrated through his consistent actions, that he cares. He has always cared about our

community, all the students, and those of the South Bay -- which is why he has endeared himself to so many and is beloved. His leadership has allowed our community to achieve its dreams...and for that, we will be eternally grateful. The very best in his retirement with his wife Terry and family."

Anza Elementary Principal Alberto Paredes has worked with Johnstone in multiple districts. He spoke at the meeting and emailed that "[Tom] is amazing. Every decision he makes is in the best interests of the students. He truly believes in educating the whole child. This is made evident by his commitment to bringing quality academics and arts programs to our schools. His work has not only impacted the students of the District, but the community as well. When asked 'What makes Wiseburn?' -- one will automatically think baseball, softball, soccer, awesome school and Superintendent Johnstone. My family and I moved into Wiseburn because of the great work that he was doing. We knew eight years ago that Wiseburn was the right place for our children, and we have not had one regret."

Assistant Superintendent Mary Ring emailed, "Dr. Johnstone has embodied outstanding leadership and success as the WUSD superintendent and has provided exemplary service to the community over the last decade. He is known for his professionalism, leadership, budget and accounting, curriculum and instruction, administrative management, community outreach/business and community partnerships, student capacity building, and civic activities."

Ring noted many of Johnstone's major achievements, including leading the charge

to unify the District; captaining the passing of bond Measure AA that funded Wiseburn High, and being selected as Educator of the Year by Loyola Marymount University in 2013.

Johnstone, Ring wrote, has long been involved in community activities, including participating in food banks, as well as with local AYSO soccer programs and Little League volunteer assignments. "Tom has acted as a mentor, leader, supporter and friend for the past decade," Ring wrote. "Administrative leadership and the teaching staff has gained in their knowledge relating to parent involvement and engagement, thinking outside the box and becoming a culture of 'YES.' We will miss him greatly."

Chief Business Official David Wilson emailed, "Tom was steadfast in his resolve to get unification for Wiseburn. He has led the District to a 21st century type of education via common core and cognitively guided instruction."

and significant achievement. Through Tom's leadership, the WUSD continues its mission to develop life-long learners and productive citizens. He will be sorely missed!"

The only special presentation that took place Tuesday came from Wiseburn Education Foundation (WEF) Executive Director Carolyn Niman along with WEF President Debbie Self. Self presented a \$106,000 check to the Board -- funds earmarked for the purchase of musical instruments and materials and to partially subsidize visual and performing art teachers' salaries at the elementary level. WEF donated a total of \$170,000 to the WUSD during the 2017/18 school year.

Self also announced the formation of a scholarship in honor of Johnstone that will provide District graduating seniors with funds to pursue their college education.

Board members and District administrators then made their reports. Congratulations and thanks were sent Johnstone's way, with member Dr. Neil Goldman adding that the retiring superintendent "knows everybody, he is liked by everybody, and he is respected by everybody."

The Board next tackled agenda action items, including giving their blessing to multiple construction "change orders" for the high school, as well as facilities upgrades and new construction projects. Action consent items quickly passed included multiple consultancy agreements, as well as District personnel comings and goings

The next regularly scheduled Wiseburn School Board meeting is slated, at this time, for Thursday, July 19. •

Step Up, America: 5 Ways Public Transportation Is Crucial To Our Small Towns

(BPT) - If you've ever had to scramble to get to work because your car isn't running - or you've been unable to drive due to an injury - you understand some of the challenges of the vast number of Americans who rely on public transportation in small towns.

And as baby boomers move into their golden years, they're creating demand for more investment in public transportation options - especially in small towns and rural areas.

Those are the findings of a study by the American Public Transportation Association (APTA) showing such small-town ridership grew nearly 8 percent from 2007 to 2015, even though rural populations declined by more than a half million residents. The top users of such rural amenities? Seniors, veterans and those with disabilities.

In many cases that population would otherwise find it problematic to find regular transportation to and from jobs, healthcare facilities

and stores, explaining why it's important to convince legislators to invest in creating more small-town infrastructure and programming.

"It's no secret we are a major retirement area for millions of seniors moving from other areas including many, many veterans," states Brad Miller, CEO of the Pinellas Suncoast Transit Authority in St. Petersburg, Florida. "Public transportation is so critical as we all are aging and need mobility options as we get older."

Some other important facts about the demand for more widespread public transportation:

- A full 33 percent of U.S. veterans who are part of the VA health care system - some 2.9 million people who have worked to defend our country - live in rural and small towns. Many have been wounded and rely on public transportation due to limited mobility.
- Americans with disabilities who live in small towns require 50 percent more public transportation trips than unimpaired people.

• Because many seniors prefer to age in place rather than move to high-employment urban areas, seniors make up 17 percent of populations in rural areas compared to 13 percent of urban populations.

• Transportation can take a big financial bite out of those living in rural areas; on average, they spend 7 percent more on transportation than city dwellers.

• Rural public transit boosts safety and reduces the overall risk of traffic accidents, and not just among vulnerable populations. U.S. commuters as a whole reduce their crash risk by more than 90 percent when choosing public transit over driving; overall, transit-oriented communities undergo just 20 percent of the traffic casualties suffered by auto-oriented communities.

To help address transportation issues for seniors, the San Joaquin Regional Transit District in San Joaquin, California, is offering a transportation service allowing them to meet

non-emergency medical appointments.

"We need to connect seniors to jobs, and especially to their medical transportation services," emphasizes CEO Donna DeMartino. "They may have healthcare, but if they can't get there it does them no good."

Transportation is also key to older residents of State College, Pennsylvania, one of the fastest-growing retirement communities in the nation.

"We do have a number of people who have stayed in the area or are coming back home, and they want independence and to stay in their homes," notes Louwana Oliva, general manager of the city's Centre Area Transportation Authority. "A lot of times, transportation is that key. They can manage to stay at home if they have transportation that gets them to healthcare and out to socialize."
