Car Technology Not Looking So Good for Drivers 55 and Older

Attention, drivers 55 and older. That video screen that you’ve come to rely on for directions in the car can navigate the way to an old friend’s house or to a new restaurant. The technology increases comfort and extends mobility for seniors. However, it can be a menu for disaster when the driver’s focus is on the screen and not where it needs to be.

The Automobile Club’s safety division watched the driving habits of people in automobiles equipped with navigation and entertainment systems, which have become standard equipment on cars, minivans, SUVs and trucks. Motorists between 55 and 75 took their eyes and attention off the road longer than young drivers, the observers noted. When performing simple tasks like programming the navigation or tuning the radio using in-vehicle infotainment technology, seniors looked away eight seconds longer than 21-to-36-year olds who participated in the AAA study.

The danger of their findings is clear: looking away from the road for just two seconds doubles a driver’s risk of a crash. Eight seconds is simply too long to be distracted in a moving vehicle in city traffic. Fortunately, the AAA Foundation for Traffic Safety included suggestions for seniors who purchase a new high-tech vehicle or rent one which is challenging enough.

Three simple rules for drivers to follow are:

- Practice using the voice command and touch screen functions in a safe place, like a parking lot or in the driveway.
- Program the navigation system when the

vehicle isn’t moving.

- Seniors especially should avoid car models with music and mapping technology that is operated from the center console. “These kinds of systems are especially distracting and potentially dangerous,” caution the AAA’s traffic-safety engineers.

Dr. David Yang, the executive director of the AAA Foundation for Traffic Safety that ran the study, said that seniors shouldn’t avoid or fear car technology. It offers drivers convenience and peace of mind when they want to explore new places and stay active socially.

“Voice-command functions found in new in-vehicle technology are intended to help drivers by keeping their eyes and attention on the road,” Yang said. “Unfortunately the complexity and poor design of some of these systems could cause more harm for older drivers in particular, instead of helping them.”

Seniors are becoming the fastest-growing demographic in the U.S., so carmakers are busy designing technology to improve driver comfort and safety. One in five U.S. drivers will be 65 or older by the end of next decade, according to population researchers.

The AAA Foundation for Traffic Safety partnered with University of Utah researchers to test the visual and cognitive demand created by the infotainment systems in six 2018 vehicles. Study participants in the older and younger age groups were required to use voice commands, touch screens and other interactive technologies -- including buttons located on the steering wheel -- to make a call, send a text message, tune the radio or

program navigation.

The technology created potentially unsafe distractions for all drivers, thought researchers called the safety risk “more pronounced” for older adults, who took longer to complete tasks, experienced slower response times and increased visual distractions. The younger group needed 18 seconds to pick a music station or cue up a song. That compared to more than 25 seconds for the seniors in the study group.

The slower times were seen with voice texting, making a hands-free phone call and programming the navigation system while the car was being driven, researchers found. The study, which observed the driving habits of 128 people, discovered that some participants overestimated their skill level when balancing driving with using a touch screen or voice-activated feature of their vehicle. Many didn’t realize how long they were distracted.

Carmakers could do a better job of designing technology for America’s graying population of motorists, a spokesman for the national AAA said. Some of the systems in the 2018 cars used in the study had too many menu options -- even the voice-activated ones -- which “significantly reduced older drivers’ ability to easily complete seemingly simple tasks,” Jake Nelson, AAA director of traffic safety advocacy and research, noted.

As mentioned before, drivers 55 and older can do their part by steering clear of vehicles with technology that is more of a hassle than a help. The carmakers can use the results of

City Council Continues Focus on Affordable Housing Initiatives

Inglewood residents packed Tuesday's meeting of the City Council hoping to be winners in a much-anticipated first-time homebuyer lottery. In rather dramatic fashion, City Treasurer Wanda M. Brown drew cards from a brass-plated drum, reading names out loud until all 48 eligible applicants had been drawn. The first five will go immediately into the program, with the other 42 placed on a waiting list.

The drawings drew applause and congratulations. Applicants endured an extensive submission process, including verification of residency and ability to qualify for a loan of \$250,000. The chosen five will now have six months to locate an eligible property and facilitate the transaction, said Housing Manager Roberto Chavez.

Mayor James T. Butts added to the largesse of the occasion, bringing a motion to keep the waiting list viable for three years and asking for additional funds to be earmarked. "If at some point the Council finds additional funds," said Butts, "that would allow positions one through nine to participate."

Councilmember Eloy Morales added, "Our intention is to help as many people as possible. I would like to see us exhaust the list as funds come in."

With this program, the City of Inglewood adds yet another initiative designed to meet the needs of its citizenry. Last month, the Council passed a landmark rent control measure, capping increases on many Inglewood rentals at no more than 3-5 percent a year. With its sizable low-to-moderate income population and 65 percent renters, it's viewed a step in the right direction.

The Council also approved an agreement with developer Thomas Safran & Associates to build 43 units of affordable housing at 716-720 West Beach Ave. The City-owned parcel is adjacent to a property recently acquired by TSA and will allow additional units to be developed.

A public hearing was opened for comment on the approval of the draft annual action plan for 2019-'20. That plan will draw grant monies from both Community Development Block Grants and HOME Investment Partnerships Act to fund programs and services for youth and seniors. The plan also earmarks money for homeless housing and services. It will also underwrite a rehabilitation program for homeowners, allowing seniors and other low-and fixed-income homeowners to receive

grants for targeted repairs to their residences. The program will provide 30-40 low-income, owner occupied homes with "minor repairs and improvements," with a priority placed on health and safety repairs and code violations. The \$500,000 in community development funds will be allocated in grants of up to \$15,000 per residence.

Habitat for Humanity will administer the program and handle contracting and construction in conjunction with Inglewood's minor home rehabilitation program. Habitat galvanizes volunteer and low-cost service providers to build homes in low-income communities. It administers similar programs in cities throughout Los Angeles County. Details for the application and qualification process, as well as an interest list, are available through City Hall, according to Deputy City Manager Harjinder Singh.

During his comments, Councilmember Alex Padilla lauded Sharon Garret and Chris Jackson for putting on a recent "boot camp" for restaurant operators and interested parties. "They are helping our small businesses be positioned [for success]," said Padilla.

Butts noted that increased traffic in the city with the stadium and other developments coming will have a positive impact on small businesses that remain viable and have great products to offer.

Upcoming events include Assemblywoman Autumn Burke's 5th Annual Back-to-School Health Fair, this Saturday from 10:30 a.m. – 3 p.m. Free health screenings and dental check-ups are available, and 500 children will receive backpacks and supplies.

The Chamber will also sponsor the 14th Annual Police and Fire Appreciation Day, Sept. 19 at 11:30 a.m. at the Airport Crowne Plaza.

The Council approved in-kind funding for a marathon race this fall at Edward Vincent Park. On Sept. 28, at 7:00 a.m., Councilmember Herbert Dotson will host the 1st Annual District 1 City of Champions 5K Run/Walk. Proceeds and revenue generated from the event will support youth tennis programs in Inglewood.

Butts requested the meeting be adjourned in memory of Compton School Board Trustee Margie Garrett, a career educator and community advocate.

The Inglewood City Council meets every Tuesday, unless otherwise noted, at 2 p.m. in the Council Chambers on the 9th floor, Inglewood City Hall. •

The household size and income criteria identified below will be used to determine eligibility for free, reduced-price, or full-price meals. Children from households whose income is at or below the levels shown are eligible for free or reduced-price meals. Applications are required annually. Children who receive CalFresh, CalWORKs, Kin-GAP, or FDPIR benefits are automatically eligible for free meals regardless of the income of the household in which they reside, with a completed application. Applicants will be notified by mail or email of their eligibility within 10 days of submission; if not, applicants should contact the Nutrition Services Department at 14120 S. Film Review

Once Upon a Time in... Hollywood is a Glamorous Tale of the '60s Gruesome End

When watching a Quentin Tarantino film, here's what you can expect to see play out in 35mm. You'll find satire mixed with dark humor, excessive violence, a large ensemble cast of who's who, and a killer soundtrack, to name a few. His ninth (and possibly final?) film, *Once Upon a Time in... Hollywood*, is

himself" Tex, Al Pacino as the stereotypically greasy Hollywood agent, and rising star Julia Butters who plays an overly mature child actor starring alongside Rick Dalton. A near-perfect ensemble, many players here have overlapped in previous films, the most obvious being DiCaprio's reunion with Rob-bie (*The Wolf of Wall Street*), although their

classic Tarantino in the best way possible. There are just enough surprises to make this 3-hour cinematic experience stand out among his infamous repertoire.

Once Upon a Time in... Hollywood is a love letter to the Los Angeles of 1969. The hippie movement was infiltrating into the status quo, movie stars still carried an air of mystery, and the Playboy mansion hosted the most banging pool parties. The times may be calling for peace and love but Rick Dalton (Leonardo DiCaprio), a washed-up TV western star in a midlife crisis, feels that his best years are behind him. His former stuntman-turned-personal assistant, Cliff Booth (Brad Pitt), echoes a similar sentiment -- although he expresses it in more controlled outbursts.

The duo's woes are only one of the film's multiple parallel storylines. There's Sharon Tate's (Margo Robbie) blossoming film career and relationship with Roman Polanski (Rafal Zawierucha), the rise of Charles Manson's (Damon Herriman) "family," and other one-offs. Because the film is similar to *Pulp Fiction* in some ways, fans of Tarantino's will appreciate his diversion from the traditional linear storyline for a more inventive and unique approach.

It's undeniable that this cast is something extraordinary. The dynamic between DiCaprio and Pitt is one of the most organic relationships I've seen in a long time. They achieve a certain soul-brother vibe that I can only imagine occurs once in a great while. Giving praise to the rest of the brilliant cast would take too long, but some standouts include Margaret Qualley as Manson flower child Pussycat, Austin Butler as "the devil

shared screen time here unfortunately lasts only a few minutes.

Perhaps it's Tarantino's own nostalgia seeping into the script. Having grown up in Los Angeles, the film feels very sentimental and nostalgic of a time and place that holds a special place in his heart. The local hotspots, like Musso + Frank, El Coyote, Frolic Room and even a loose reference to the theater that he now owns, The New Beverly, all feel like personal touches that Angelinos will fall in love with when they see those landmarks on screen.

There have been a lot of rumors swirling around Tarantino's ninth film. Some claim it's his last, others claim its sexist, but one thing is certain: when the film premiered at Cannes Film Festival earlier this year, it received a seven-minute standing ovation. Selfishly, I hope that *Once Upon a Time in... Hollywood* is not Tarantino's last film -- but if it is, he has gone out on top. •

NASA Mission to Uncover Questions on Planetary Creation

The climes are nigh combustible and I don't stray too long out in the open lest I start to wither and broil. I'm a constant shade-seeker always in pursuit of a good book and air conditioning. That usually means a library is my ultimate and go-to summer destination.

So come and cool down with some nonsense knowledge acquisition in the stacks. As a JPL Solar System Ambassador, I can't tout the Science section shelves enough. Here you can delve into a whole galaxy of resources to learn about the churning cosmos above. Or mosey on up to the reference desk and barrage our helpful librarians about upcoming NASA projects. Projects like the looming Lucy Mission...

The Lucy Mission's objective is to learn more about Jupiter's bevy of asteroids that may provide insight into the primordial material that initially formed the outer planets. Contained therein are tiny time capsules from the very birth of our solar system approximately four billion years ago. This is information that can help us form a better understanding of the complexities of the universe's genesis. The Trojan asteroids are primitive celestial bodies that wield significant clues critical to our understanding of the origins of life and organic material on our own earth. The first NASA project ever to study the Trojans, the Lucy Mission space probe will be an ambitious and monumental achievement in space exploration.

The mission is named in honor of the first fossilized human ancestor that was so instrumental to our understanding of our genetic evolution. Lucy was, in turn, named after the classic Beatle's song "Lucy in the Sky with Diamonds." The Lucy skeleton yielded a wealth of information to scientists about humanity's origins. the AAA study to go back to the drawing board and redesign infotainment systems for simplicity. Specifically, the AAA thinks carmakers should remove center console controls and positioning system controls to allow drivers to keep their eyes on the road. These design changes "would better meet the needs of older adults and make the systems safer for all drivers," Nelson said.

The U.S. Centers for Disease Control reported that 7,400 older adults (aged 65-plus) were killed and more than 290,000 were treated in emergency departments for

motor vehicle crash injuries in 2016. There were almost 42 million licensed older drivers that year, a 56 percent increase from 1999.

As cars get more complicated, seniors can turn to mature driving improvement programs offered by agencies and driving schools that serve the growing population of 65-plus residents. Many of the programs and phone numbers are listed at the Department of Motor Vehicle web site by typing "mature driver improvement courses" into the search field. The DMV site is found at www.dmv.ca.gov on the web. •
