Medicare Cards Are New-So Is This Scam to Steal Your Identity

Medicare cards designed to prevent fraud and identity theft are being mailed to eligible South Bay residents, and seniors should beware of a scam arising from the distribution of these new cards.

The Los Angeles County District Attorney's Office issued a warning and advised seniors to be careful about sharing their personal information with anyone claiming to be a healthcare provider either in person at their door or over the phone.

The Medicare card fraudsters will call seniors and tell them they must provide their Social Security number or other personal information, or make a payment to receive or activate their new Medicare cards. That simply isn't true, according to the DA's office.

Medicare enrollees should receive their new cards automatically from the Centers for Medicare and Medicaid Services. The agency began mailing the new cards, which no longer include Social Security numbers, in April and will continue through April 2019, officials said.

Tips for protecting personal identity and Medicare benefits include:

- Don't share your Social Security number, personal information or Medicare number except with legitimate health care and insurance professionals with whom you initiated contact.
- Don't make any payments to receive or activate your Medicare card.
- If you receive a suspicious call, hang up and call 1-800-MEDICARE for any questions

about your benefits status.

Medical identity theft occurs when someone steals or uses your personal information, says the Center for Medicare and Medicaid Services. Obtaining an insured person's name, Social Security or Medicare number allows thieves to submit fraudulent claims to Medicare and other health insurers.

"Medical identity theft can disrupt your medical care, and wastes taxpayer dollars," the federal health insurer for older Americans says on its website. Medicare will mail new identification cards to its 55 million beneficiaries, the federal government said.

The new Medicare ID cards have only one purpose: to help prevent identity theft. The number on the current Medicare ID card is the person's Social Security number. This is used too by the Social Security Administration, healthcare providers and health plans.

"In the hands of an unscrupulous person, a Social Security number can open the door to all kinds of mischief and misuse," explains an article on the website Next Avenue. Retired PBS news anchor Bill Moyers is behind the Next Avenue site, which addresses health, financial and social issues affecting Americans 55 and older.

The CMS is replacing the old Medicare numbers - a do-over for seniors and recipients who've been targeted before by identify thieves. "Once bitten, twice shy" is the warning com-

ing from the area's top cop and government officials trying to manage Medicare costs and premiums by limiting fraud in the system.


The new cards will be distributed to Medicare beneficiaries and to people who are eligible for Medicare through the Railroad Retirement Board's pension plans. There is one important exception: People who are enrolled in a Medicare Advantage plan (like an HMO or PPO) will continue to use the plan's ID card as their main card for Medicare. Those cards already have a unique ID number that is not the Social Security number. Also, Medicare prescription drug plans will continue to assign and use their own cards.

Each new number will have 11 digits and will be assigned randomly. The new numbers are "non-intelligent," which means that they don't have any hidden or special meaning. They will be a combination of single-digit numbers and upper-case (capital) letters. All the letters of the alphabet will be used, except S, L, O, I, B and Z, to make the combination easier to read -- if not to remember.

The new cards will be printed on regularweight paper and will be a little smaller than the old ones -- about the size of a credit card. Another change: the new cards do not indicate gender.

A 2015 report prepared for the Centers for Medicare and Medicaid Services estimated that \$60 billion of American taxpayer money,

Film Review

American Animals: Achieve Greatness, Steal a Masterpiece

It's an intrinsically American thing, the feeling of wanting to leave behind some sort of legacy after we're gone. To the impressionable young person, it's a pressure that can drive them to the most extreme of actions. Sure, one can strive to leave behind their own legacy through hard work. But if one were smart enough - or just

the friends planning, performing and living with the consequences of their heist. These stylistic touches won't be too surprising if you've seen Layton's previous work, the critically-acclaimed documentary The Imposter, in which the director brought the story of a real-life identity-assuming person to the big screen with cinematic flair.

foolish enough – couldn't one also just steal it?

This impressionable young-person-sets-outto-steal-greatness is the story of American Animals (now available to watch digitally and On Demand), an enthralling and electrifying film that derives its plot from true events. Based on the real-life story of a group of friends who, feeling the monotony and complacency of their small-town Kentucky undergraduate lives, devise a plan to steal some of the rarest artifacts of this country's history. Complete with costumes, makeup and prosthetics, the boys -- Spencer Reinhard (Barry Keoghan), Warren Lipka (Evan Peters), Eric Borsuk (Jared Abrahamson) and Chas Allen (Blake Jenner) -- make American Animals one of the most stylish films to come out this year.

American Animals is a unique viewing experience for the different genres that it brings together, which I was certainly not expecting. It's a devilishly fun heist movie, bringing the most heart-pounding and suspenseful sequences when it needs to do so. But it's clear that Animals writer and director Bart Layton is interested in exploring the psychology of a young person's head -- specifically the question of what would make these misguided and impressionable people go through with a plan like this. Think Ocean's Eleven meets The Social Network.

The stylistic hybrid filmmaking comes into play with Layton's inclusion of interviews from the real-life heisters themselves. As they comment on what was going on in their heads, the film cuts between the narrative of Ryan Rojas.

To this end, American Animals also brings forward larger and more conceptual ideas that concern Layton: authenticity, deception, perception and memory. These themes are all explored with editing and story tricks - for example, the real-life characters will walk into frame as one of the background actors. Plus, blink-and-you'll-miss-it editing puts the viewer into off-ground, which is a fun place to be in the hands of Layton, who very clearly enjoys throwing the audience off the trail.

If you're looking for a film that will offer some of the most visually and narratively interesting ideas of this year, look no further than American Animals.



A Trio of Great Books That **Examine Art in Unusual Ways**

Our library acquires truly interesting reading material. I would like to encourage you to browse among our nonfiction books and you may come across mind-blowing items like Odd Is Art, a compendium of artworks ingeniously made from such things as postage stamps, coffee beans, fingernail polish and thousands



of matchsticks. Fantastical photographs adorn the pages with descriptions of methods and a few short essays of featured artists and art. Not all is odd -- some are breathtaking. There is a sculpture made from scavenged driftwood from the coast of Florida, images made by a flat-bed scanner that look exactly like astrophotography, and ceramics that could easily be mistaken for carvings made of wood. Pieces that are wildly creative are pictured in page after page. And there are the odd ones:

By Roz Templin, Library Assistant, El Laurent's painting Gutenberg, Inventor of the Printing Press and a photograph by Andreas Gursky that illustrates 1 million-square foot Amazon warehouse of books. Quotes about reading are included, which makes leafing through even more enjoyable.

> Finally, historian Nell Painter is Old in Art School, as she recounts her experiences in returning to school in her sixties to study art. She finds that not only is there a wide gulf in age between her and her much younger fellow students, but there is a disconnect between her opinions and those of her (younger) art instructors. Nell struggles to let go of her own preconceived ideas and embrace new "deconstructed" views and methods, all the while trying to take care of her aging parents in Oakland, California (she is living on the East Coast). She questions what exactly makes art art? Who

counts as a critic? Nell discovers that gallery representation is required if you are counted as "an artist." How do you get your work in a gallery? It must be interesting. What art is "interesting?" It looks like art. Art is what's in galleries. There are laughter, tears, anger

a cityscape made of Jell-O, an Etch-A-Sketch re-creation of the classic Gone with the Wind film poster and The Last Supper made from laundry lint. These works are from the collection of Ripley's Believe It or Not! locations throughout the world.

Nearly 300 artworks are reproduced in Reading Art, all celebrating the image of the reader and books. In the preface, David Trigg notes that the book was once a revered object that was treasured and accessible to only a few (mostly wealthy) people. Books could be works of art in their own right. Now with the advent of technology, we find that books have become part of our "throwaway society" and are sometimes even the raw materials used to transform them into paintings, sculptures and installations. Trigg offers a lengthy essay ("The Art of Reading") preceding the colorful plates and there are expanded descriptions of particular artists and works like Jean-Antoine

or more than 10 percent of Medicare's total budget, was lost to fraud, waste, abuse and improper payments four years ago.

An attempt by someone to steal your identify isn't always obvious, so officials offer some defensive tactics that seniors and healthcare consumers can take so they don't become victims.

They start with the advice to just walk away if someone approaches you in parking lots, shopping centers or other public areas and offers you free services, groceries, transportation or other items in exchange for your Medicare number.

When the phone rings, simply hang up if someone calls you claiming to be conducting a health survey and asks for your Medicare number.

Under no circumstances should you give information to telephone marketers who pretend to be from Medicare or Social Security and ask for payment over the phone or Internet. They may want to steal your money. The Los Angeles County District Attorney publishes regular announcements about fraud schemes and tips for holding onto your money and identify.



<u>Looking Up</u>

Last year, physicists at MIT, the University of Vienna, and elsewhere provided strong support for quantum entanglement, the seemingly far-out idea that two particles, no matter how distant from each other in space and time, can be inextricably linked, in a way that defies the rules of classical physics.

Take, for instance, two particles sitting on opposite edges of the universe. If they are truly entangled, then according to the theory of quantum mechanics their physical properties should be related in such a way that any measurement made on one particle should instantly convey information about any future measurement outcome of the other particle—correlations that Einstein skeptically saw as "spooky action at a distance."

In the 1960s, the physicist John Bell calculated a theoretical limit beyond which such correlations must have a quantum, rather than a classical, explanation.

But what if such correlations were the result not of quantum entanglement, but of some other hidden, classical explanation? Such "what-ifs" are known to physicists as loopholes to tests of Bell's inequality, the most stubborn of which is the "freedom-of-choice" loophole: the possibility that some hidden, classical variable may influence the measurement that an experimenter chooses to perform on an entangled particle,

making the outcome look quantumly correlated when in fact it isn't.

On Jan. 11, 2018, in a new experiment to test quantum entanglement, MIT's David Kaiser and other team members

pairs of entangled photons and beamed particles from each pair in opposite directions toward each telescope.

In the fraction of a second before each entangled photon reached its detector,

gathered on a mountaintop in the Canary Islands and began collecting data from two large, 4-meter-wide telescopes: the William Herschel Telescope and the Telescopio Nazionale Galileo, both situated on the same mountain and separated by about a kilometer.

One telescope focused on a particular quasar, while the other telescope looked at another quasar in a different patch of the night sky. Meanwhile, researchers at a station located between the two telescopes created

the instrumentation determined whether a single photon arriving from the quasar was more red or blue, a measurement that then automatically adjusted the angle of a polarizer that ultimately received and detected the incoming entangled photon.

"The timing is very tricky," Kaiser says. "Everything has to happen within very tight windows, updating every microsecond or so."

The researchers ran their experiment twice, each for around 15 minutes and with

two different pairs of quasars. For each run, they measured 17,663 and 12,420 pairs of entangled photons, respectively. Within hours of closing the telescope domes and looking through preliminary data, the team could tell there were strong correlations among the photon pairs, indicating that the photons were correlated in a quantum-mechanical manner.

The team performed a more detailed analysis to calculate the chance, however slight, that a classical mechanism might have produced the correlations the team observed.

They calculated that, for the best of the two runs, the probability that a mechanism based on classical physics could have achieved the observed correlation was about 10 to the minus 20—that is, about one part in one hundred billion—outrageously small.

Sorry, Professor Einstein—it looks like "spooky action at a distance" is proving to be a reality. •

Changing Addresses? 10 Tips For Busy Baby Boomers

(BPT) - For many Americans, moving households represents a fresh start and a chance to improve quality of life. Last year, some 39.4 million Americans changed residences, thanks in part to better affordability in the housing market.

That doesn't mean, however, that everyone's moving process was friction-free. The logistical coordination and the physical work involved with DIY packing and loading can be a major chore in the best of circumstances. And that's doubly true for baby boomers who are downsizing or moving to new communities, yet challenged by the physically grueling aspects of a DIY move.

Fortunately, forming a plan that troubleshoots the most common challenges can help enormously. Consider how these tips could keep your next move smooth and free of unnecessary stress.

1. Protect your treasures: Avoid the heart-

break of damaged belongings by stocking up on bubble wrap and other efficient packing materials. You also could optimize household items such as towels, blankets and coats.

- 2. Stagger your packing: Pack too early and you may need items you've stashed away; pack too late and you may be crunched for time. Start with non-essentials and out-of-season belongings a few weeks before moving day, sorting discards as you go. Save necessities for the last 48 hours.
- 3. Label, label, label: This may seem unnecessary while you're packing, but will save you time and frustration upon arrival when you're desperately looking for your essentials. It also allows you to immediately sort boxes by room and store items that are infrequently needed.
- 4. Secure transportation early: Instead of procrastinating and missing out on the truck you need, hop on your smartphone at least

two weeks ahead to easily reserve a vehicle at PenskeTruckRental.com.

- 5. Right-size your truck: Rather than guessing what size moving vehicle you'll need, plan on about 150 cubic feet of truck space for each fully furnished room in your home. That means a move from an apartment might necessitate a 12-foot truck offering 450 cubic feet, while a move from a house might require a 26-foot truck offering 1,400 feet.
- 6. Recruit help: The packing and transporting may sound easy until you try to do it all yourself. This is the time to call in favors or perhaps pay some teens to help with the lifting and hauling.
- 7. Pack your truck strategically: Optimize your space by positioning your furniture and other large, heavy items in the back of your vehicle before proceeding with lighter items. That optimizes the vehicle's power and allows you to fit smaller items into smaller

spaces.

8. Follow ergonomics: The last thing you need is to injure your back through haphazard movement during the loading process. Stretch beforehand, avoid twisting your torso as you load and remember to lift with your legs by crouching rather than bending from the waist.

- 9. Strategize your route: Map out the way ahead of time, review weather forecasts, avoid rush hour and leave yourself plenty of time for breaks, refueling and unloading.
- 10. Drive like a pro: Many people are unfamiliar with the difference between driving a car and a big truck. Read all instructions provided and understand how to drive differently to remain safe (and legal).

ORDINANCE NO. 2152 ANORDINANCEOFTHECITYCOUNCIL OF THE CITY OF HAWTHORNE, CALI-FORNIA, ADDING A NEW CHAPTER 8.21 (COMMERCIAL DEVELOPMENT CENTER CLEANING SCHEDULES) TO TITLE 8 (HEALTH AND SAFETY) OF THE HAWTHORNE MUNICIPAL CODE. REQUIRING CLEANING SCHEDULES FOR COMMERCIAL DEVELOPMENT CENTERS, AND ADOPTING FINDINGS

RELATED THERETO WHEREAS, the City of Hawthorne has numerous shopping centers that have re-cently experienced a decline in sanitation and cleanliness, including, but not limited to, the accumulation of trash and debris in common areas and parking lots; and

WHEREAS, the decline in sanitation and deanliness in these shopping centers (commercial development centers) has created an unsightly and unwelcoming appearance for residents and visitors, which deters additional patronage, is detrimental to property values in the area and encourages acts of vandalism and littering; and

WHEREAS, Section 7 of Article XI of the California Constitution provides that a city may make and enforce within its limits all local police. sanitary and other ordinances and regulations not in conflict with general laws; and

WHEREAS, pursuant to its police powers, the City of Hawthome has the authority to enact regulations for the public peace, morals and general welfare of the City;

WHEREAS, City Council has determined

that a lack of sanitation and deanliness at commercial development centers is hazard-

ous and injurious to the public health, safety and the general welfare and that regulations related to maintenance, and specifically, regulations that require a cleaning schedule for commercial development centers will enhance habitability, occupancy, use and safety of these WHEREAS. City Council wishes to adopt

this Ordinance in order to preserve the public peace, safety and the general welfare of the City of Hawthome

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HAWTHORNE DOES ORDAIN AS FOLLOWS:

SECTION 1. CEQA. The City Council has determined, based on its independent judg-ment and analysis, that the adoption of this ordinance is not a project for purposes of the California Environmental Quality Act (CEQA) in that it is a general policy and procedure for maintenance of the private property, and even if it were a project, it would be categorically exempt from CEQA pursuant to Section 15061(b)(3) in that it can be seen with certainty that the proposed ordinance does not have the potential to significantly impact the environment. The action is also categorically exempt under section 15308 (actions taken to ensure the maintenance, restoration or protection of the environment).

SECTION 2. Language. A new Chapter 8.21 of Title 8 (Administration, Civil Service and Personnel) of the Hawthorne Municipal Code ("HMC") is hereby added as follows: CHAPTER 8.21 COMMERCIAL DEVELOP-MENT CENTER CLEANING SCHEDULES 8.21.010 Purpose.

The purpose of this Chapter is to ensure that commercial development centers are consistently maintained in a clean, sanitary and aesthetically-pleasing manner in order to preserve property values, deter criminal activity. and encourage patronage. **8.21.020 Definitions.**

"Cleaning schedule" shall mean a task sheet which lists cleaning tasks to be accomplished on a regular, fixed schedule upon all areas of the commercial development, including, but not limited to, common areas and parking lots. "Commercial development center" shall mean and include shopping centers, strip malls, mixed use projects, or any other collection of commercial spaces that share parking, or access, or have reciprocal easements for parking or vehicular access, whether under a common ownership or divided into multiple ownerships. "Owner(s)" shall mean and include any person having legal title to, or who leases, rents, occupies or has charge, control of possession of, any real property in the city, including all persons shown as owners on the last equalized assessment roll of the Los Angeles County assessor's office. 'Owners' includes powers of attorney, executors or estates, trustees, or who are court appointed administrators, conservators,

guardians or receivers. 8.21.030 Requirement. A. Owners of commercial development centers shall be required to create and maintain a written cleaning schedule for the property, including, but not limited parking lots, and which shall be available for inspection at all times by the City. B. The cleaning schedule shall include, but not be limited to, a regular and fixed schedule for the following: high pressure deaning, graffiti removal, building façade cleaning, stairway or elevator cleaning, external landscaping maintenance and litter removal. High pressure cleaning (or power washing) shall be scheduled no less than once every 7 calendar days. Litter removal shall be scheduled once every 24 hours, including weekends.

C. All cleaning schedules shall contain the name and phone number of the owner or other person responsible for adherence to the cleaning schedule. D. Cleaning schedules shall be posted in at

least three (3) locations on the commercial development center by the owner and shall be distributed to all tenants. 8 21 040 Enforcement

Violation of any of the provisions of this Chapter may be enforced pursuant to Chapter 1.20 of he Hawthorne Municipal Code. 8.21.050 Duration of Ordinance.

This Ordinance shall be deemed automatically repealed six months from its effective date. SECTION 3. Severability. The provisions of this Ordinance are severable. If any provision of Chapter 8.21 or its application is held invalid, that invalidity shall not affect other provisions or applications that can be given effect without the invalid provision or application. The provisions of Chapter 8.21 are hereby declared to be severable. If any provision, clause, word, sentence or paragraph of Chapter 8.21, or the application thereof to any person, establishment, or circumstances shall be held invalid, such invalidity shall not result in the invalidity of the entire chapter which can be given effect without the invalid provision or application. The City Council of the City of Hawthome hereby declares that it would have adopted this ordinance irrespective of the invalidity of any particular portion thereof. SECTION 4. City Clerk. The City Clerk shall

certify to the passage and adoption of this ordinance or a summary therefore, pursuant to State law, and shall cause this ordinance to be published within fifteen days after its passage, in accordance with Section 36933 of the Government Code.

SECTION 5. Effective Date. This ordinance shall take effect thirty (30) days after passage PASSED, APPROVED AND ADOPTED this
