### City Approves Program to Provide Healthy Meals for Kids

In a unanimous 5-0 vote, the Inglewood Mayor and City Council approved a resolution that would allow One Hundred and Eighty Degrees and Still Standing [180SS] the ability to serve free meals to Inglewood's younger-than-18-year-old children through the city's out-of-school programs.

The free meals would be served through the Child and Adult Care Food Program [CACFP] from Sept. 14 to June 19, 2015. The city's "out-of-school time programs" are operated through the Parks, Recreation and Library Services Department and include After School Recreation Program [ASRP].

The staff report presented to the council indicates that the mayor and city council approved a grant by the National Recreation and Parks Association [NRPA] on May 13 in order to allow for an increase in the amount of healthy meals that kids in low-income communities receive via the Summer Food Service Program [SFSP] and the CACFP during the months in which said kids are not in school. The grant was awarded by NRPA on April 1 in the amount of \$30,000, along with \$10,000 to purchase "in-kind nutrition literacy materials." The grant also provided \$1,200 to cover travel expenses to Reston, Virginia where "evidence-based nutrition literacy training" for Organ Wise Guys [OWG]. OWG is designed for "youth at out-of-school time program" sites throughout the summer and fall.

Through this grant and the nutrition programs that it funds, Inglewood kids are taught healthy eating habits and the importance to maintaining healthy diets. The nutrition literacy program aims to establish behaviors and habits conducive to healthy eating as well as engaging in physical activity.

The agreement with NRPA will also provide funding for a program specialist that is responsible for the coordination of all OWG nutrition literacy materials for kids at 10 different out-of-school time program sites. With the agreement, OWG will continue it nutrition literacy program through the city's ASRP sites, located at: Bennett-Kew, Centinela, Highland, Hudnall, Kelso, Oak and Worthington Elementary Schools, as well as La Tijera and Parent Schools.

Through this grant and the nutrition programs that it funds, Inglewood kids are taught healthy eating habits and the importance to maintaining healthy diets.

The staff report indicated that ASRP is a fee-based program that operates for 40 weeks in one school calendar year and which has "served thousands of underserved students and their families" in what is described as "as safe and supervised environment where City of Inglewood elementary and middle school children receive educational, enrichment and recreational instruction."

ASRP usually provides the staff to help kids with homework or additional tutoring needed five days a week. The program also engages children in sports, games, arts and crafts, reading and other mentoring activities. "The program is designed to help our participants develop socially, succeed in school, stay physically active, and prepare for positive futures," stated the report.

The staff report also indicated that many of the participants in the program are yet to receive the full benefits of the education and recreational activities provided by 180SS. It is estimated that 180SS will provide 400

free "suppers per day" at each of the ASRP sites, as well as Inglewood's main and Crenshaw-Imperial Library branches, Darby Park and Rogers Park. The suppers provided will include both cold and hot meals, milk, fruit and certain desserts. As the city's SFSP contractor for 2014, 180SS is already familiar with providing meals in the city during the summer and will now be able to extend its operations for the entire school year.

The meals provided meet the standards and guidelines established by the Los Angeles County Health Department and the serving of the meals are subject to monitoring by state and federal agencies.

#### CITY TO HOST HISPANIC HERITAGE FESTIVAL

The City of Inglewood will once again host its Hispanic Heritage Festival on Saturday Sept. 20 from 11 a.m. to 4 p.m. The event will take place at Crozier Middle School, located at 120 W. Regent St. This annual event not only celebrates Hispanic and Latino American heritage and culture but it recognizes the many contributions made by the Spanish-speaking community.

This year's festival will include live performances by Grupo Folklorico Macias, Sonsoles and The Reel Band. Radios personality Josefa Salinas [HOT 92.3 radio], who was part of last year's festivities, will serve as this year's mistress of ceremonies. The day's activities will be family-friendly and include face painting, carnival games, vendors, information booths, authentic Mexican food, health screenings and other interactive activities. The event is free and open to the public.

### Wiseburn After-School Program Developing

The Wiseburn Unified School Board invited Wiseburn Child Development Center program director Melissa Coughlin to their September 11 meeting to share with the public a recap of the changes going on at the center and what's in store for its future.

It's been just over a year since the Wiseburn Unified School District took over operations at the Wiseburn Child Development Center (WCDC), with the goal of providing low-cost, educationally appropriate summer and after-school programs. Superintendent Tom Johnstone said that while there have been a few complications with the center's launch, most notably on tuition costs, the center has overall improved since the district's takeover.

"I think that there were a lot of challenges and a lot of growing pains during the first year," said Johnstone. "But I'd also say that we're doing outstanding over there, we are light-years ahead of where we were at this time two years ago. We are very happy."

One of the changes Coughlin shared were the changes to curriculum at the WCDC. She said the new lessons are research-based and line up more appropriately with what students are learning in the classroom during the school day. The more rigorous lessons are being supported by additional training for the staff. "Our teachers are getting great training," said Coughlin.

The WCDC has also been working on reaching out to new families. The center put out a new brochure touting their new programs, and Coughlin said the response has been positive. Currently the center is at full enrollment, and Coughlin hopes the advertisement will keep it that way. "We are pleased to say . . . we still have people waiting to get in. We are very successful," said Coughlin.

The center has been calibrating its performance by conducting parent surveys covering topics like satisfaction with WCDC staff, value of the programs offer, and educational quality. The results show that parents of students in the WCDC are pleased with what their children are doing.

"I'm thrilled to say that out of a 1-5 rating we were close to 5 in every single mark. Our families are very happy," said Coughlin. "One of the best parts of the survey results is when I see what parents would say in terms of whether they would recommend the program. Out of all of them, a vast majority said they would."

While the WCDC's first year of operation has seen the center make a number of

changes, there are still more planned for the future. Coughlin said there are plans to continue making activities and lessons more academically based, along with possibly adding more technology, a book club and a newsletter to what the WCDC offers. However, this doesn't mean that parents are unhappy with what the center is currently offering. "My favorite [response to the parent survey] was when asked what we could improve, one parent said 'Nothing. You guys rock," said Coughlin.

The board also heard from budget and accounting director David Wilson on the district's new food service program. While it has only been in place for a few days, Wilson said it's already received rave reviews. "Everyone is very pleased, they are over the moon about it," said Wilson.

One person who spoke up about how pleased she was with the program was Laura Sullivan, principal of Peter Burnett Elementary. She said she's heard from students, parents, even custodians about the improvements in the new lunches.


"My students are eating more and they aren't wasting food," said Sullivan. "They like the food. My custodians said they could tell because the trash is so much lighter. The parents are saying they want to eat there. It's a good program."

Similarly, Ana Elementary's principal Sarah Nitsos said the new meals are popular with her students and have been replacing unhealthy meals. "It's really a huge hit," said Nitsos. "It's a tremendous improvement to see our children eating food that is healthy."

In addition to the new healthier menu, the new program involves changing how lunch is served. Dana Middle School principal Blake Silvers said his school's single wrap-around lunch line has been converted into a number of individual lines.

"It was surprisingly very effective," said Silvers. "It was very natural. They just walk up and order their food, and the food is great."

However, the rollout wasn't completely without issues. Wilson said some schools experienced long lunch line delays as both students and staff adjusted to the new lunch system. There were also some complaints that the containers for the mac and cheese weren't able to contain the food, although Nitsos said she personally didn't have any problems. Wilson said he expects to iron out these complications as the program continues. "We've had a couple hurdles," said Wilson. "I think we are going to work out those details." •

#### **CHAMBER OFFICERS** TO BE INSTALLED



### Don't Make These Common Mistakes When Something Hurts

(BPT) - Managing pain can be tough, whether you're one of the 100 million Americans with chronic pain, or only suffer from the occasional backache or headache. September is National Pain Awareness Month, the perfect time to make sure you're managing your pain the best way possible.

While many people can manage pain on their own, or can be helped by a primary care physician, those with unrelenting, challenging pain should consider seeing a pain medicine specialist.

"One of the biggest mistakes patients make is not visiting a pain medicine specialist such as a physician anesthesiologist when they experience persistent, complex pain," says Dr. Richard Rosenquist, chair of the American Society of Anesthesiologists (ASA) Committee on Pain Medicine and chairman of the Department of Pain Management in the Anesthesiology Institute at the Cleveland Clinic. "Physician anesthesiologists and other pain medicine specialists can fully assess a patient's pain and prescribe a treatment plan. This may incorporate medications, injections that can control pain for up to a year, spinal



cord stimulation, physical and psychological therapies and alternative therapies, such as acupuncture."

The ASA and its physician anesthesiologist members note these five mistakes patients in pain often make:

1. Taking medication incorrectly. Whether you're taking opioids (narcotics) for chronic pain or an over-the-counter pain remedy such as ibuprofen for a sore back, don't take more than prescribed or recommended by the manufacturer. With prescription pain medication, taking more than directed can lead to addiction or even accidental overdose. It's critical to follow your physician's instructions carefully. If you're still in pain after taking the prescribed dose, contact your physician to discuss other pain relief options.

2. Choosing the wrong medication. Overthe-counter pain relievers can help you manage the pain of a sprained ankle or twisted knee without seeing a doctor. But choosing the right pain relief medication can depend on your health history. If you have liver problems or consume three or more alcoholic drinks a night, avoid acetaminophen which can cause liver damage. And anti-inflammatory pain relievers such as ibuprofen and naproxen can make high blood pressure and kidney disease worse, so ask your physician or a pharmacist for an alternative recommendation.

3. Demanding an X-ray. Studies show tests such as X-rays and MRIs do not do a good job of pinpointing the cause of pain. For example, you might have pain, but nothing shows up on the image. And vice versa sometimes things show up on X-rays that aren't causing problems or pain. That's why it's so important to see a physician who can assess your symptoms and order the most effective tests when necessary.

4. Not thinking outside the pill box. Many treatments that don't involve taking medication help people in pain find relief. For example, spinal cord stimulation uses electrical signals to short circuit pain in the lower back and legs. Other alternative treatments that may help include injections, acupuncture, massage, meditation and physical therapy.

5. Neglecting your overall health. Studies show people who smoke are more likely to have chronic pain, so if you smoke get the help you need to quit. Also, be sure to eat healthy. Studies show following an antiinflammatory diet of wholesome, unprocessed foods (vegetables and foods high in omega-3 fatty acids, such as wild salmon and walnuts) may help reduce pain. The healthier you are, the better you'll feel and the less pain you'll have. •



### Half of All Exoplanet Host Stars Are Binaries

Imagine living on a planet that has two suns. One you orbit, and the other is a very bright, nearby neighbor looming large in your sky. With this "second sun" in the sky, nightfall might be a rare event, perhaps only coming seasonally to your planet. A new study suggests that this could be far more common than we realized.

NASA's Kepler Space Telescope has

confirmed about 1,000 exoplanets. Until now, there has been an unanswered question about exoplanet host stars: how many host stars are binaries, or double stars? Binary stars have long been known to be commonplace—about half the stars in the sky are believed to consist of two stars orbiting each other. So, are stars with planets equally likely to have a companion star, or do companion stars prevent the formation of planets?

The study, by a team of astronomers led by Dr. Elliott Horch, Southern Connecticut State University, has shown that stars with exoplanets are just as likely to have a binary companion: 40% to 50% of the host stars of confirmed exoplanets are actually binary stars.

Their study makes use of very high spatial resolution observations that were carried out on the WIYN telescope located on Kitt Peak in southern Arizona and the Gemini North telescope located on Mauna Kea in Hawaii. The technique used by the team is called speckle imaging and consists of obtaining digital images (15 to 25 times a second) of a small portion of the sky surrounding a star of interest. The images are then combined in software using a complex set of algorithms, yielding a final picture of the star with a resolution better that that of the Hubble Space Telescope.

By using this technique, the team can detect companion stars that are up to 125 times fainter than the target but only 0.05 arcsecond away. For the majority of the Kepler stars, this means companion stars

with a true separation of a few to about 100 times the Sun-Earth distance. By noting the occurrence rate of these true binary companion stars, the discoveries can be extended to show that half of the stars that host exoplanets are probably binaries.

Co-author of the study, Dr. Steve B. Howell (NASA Ames Research Center), commented, "An interesting consequence of this finding is that in the half of the exoplanet host stars that are binary we cannot, in general, say which star in the system the planet actually orbits."

The Kepler orbiting telescope has discovered a number of circumbinary planets, that is, a planet that orbits both stars in very close binary systems. There also exist exoplanets that are known to orbit one of the stars in very wide binary systems. If the two stars are very close to each other and the planet far away, a circumbinary planet will be reminiscent of the planet Tatooine in "Star Wars." If instead the exoplanet orbits one of the stars in a very wide pair, the companion star might appear simply as a bright star among others in the night sky. "Somewhere there will be a transition between these two scenarios," Howell said, "but we are far from knowing where."

The accompanying figure marks out the Kepler Space Telescope's field of view (the part of the sky being studied here), located between two bright stars in the "summer triangle," rising over the Kitt Peak telescope in southern Arizona.
