Salvation Army to Host, Organize Miracle on Manchester Christmas Event

Food baskets and toys will be distributed by the Salvation Army on Friday Dec. 19 from 8:30 a.m. to 4:30 p.m. as part of the Miracle on Manchester Season of Giving, which runs from Nov. 1 to Christmas.

"For Christmas we are set to serve 1,000 children through the Toy and Joy Center which includes roughly 600 families and we are excited about that." Salvation Army Corps Ministry Leader Lt. Christopher Golden said. "We served a lot of families last year and this vear they will come in and be able to shop for two toys for their child, get a food box and a Christmas blessing."

The Christmas outreach event will take place at the Inglewood location at 324 E. Queen St. in Inglewood. Each client has previously registered and has been allotted a time throughout the day to go in and obtain their items. While the Salvation Army prefers that everyone receiving a food basket and toys register, they do their best with any extra items to help people who were unable to register.

"We don't traditionally help walk-ups but it is not to say we won't help," Golden said. "I hate to tell people no: it is never a good feeling but sometimes things are beyond our control but we do everything that we can."

For Thanksgiving the Salvation Army helped and served 847 clients in a two-day period. The first day they were able provide 375 turkeys and food boxes for individuals with the help of the Los Angeles Lakers. The following day was the community feeding where the Salvation Army set up tables, table clothes, napkins, and served a turkey dinner out of

their Inglewood office located at 324 E. Queen St. in Inglewood.

In addition to these holiday efforts to assist people and families in difficult situations, the Golden and everyone at the Salvation Army Inglewood Citadel Corps works year round to operate programs such as their daily lunch program which serves 75 people Monday through Friday. There is also the Emergency Food Pantry Program which will resume on Jan. 5, 2015 and which helps people who qualify every 30 days. There are also programs for kids such as the Tuesday Night Music where children are trained in a musical instrument

during the school year. For working families, the Salvation Army also provides their Spring Break Day Care at a low cost [\$60 a week], which includes two field trips, breakfast and lunch. They also offer a seven-week summer day camp program [\$65], which includes breakfast and lunch as well as two field trips. This and more is available alongside the church services and Bible study component, which is at the core values of the Salvation Army.

"Our motto is to do the most good and I feel that we are doing it all the time," Golden said.

While many of the people being helped are known by name since they are part of the Inglewood location's yearly programs, all person seeking assistance are required to prove hardship and need of assistance.

"We have a responsibility to our donors who are giving money. They want to see that we are helping people that are in need," Golden said. "We don't retain that information and it is only used during our monthly emergency food pantry program. People have to prove hardship and that is how it is at many agencies."

From the Inglewood office, the Inglewood Citadel works with several communities including the home city, Culver City, Lennox, Westchester, Gardena, El Segundo, and parts of Los Angeles.

"We do a lot from this office and serve a lot of different people," Golden said. "We try to have a presence in all of those communities even though our office is located here in Inglewood. Sometimes people are reluctant to provide that [proof of income/hardship] information but in order to receive many of our services we have to understand that people are really in need."


"Money is always needed and people get to see, and we invite people to see, where their dollars go," Golden said. "We are able to show our community and donors what we are doing. Money is always helpful to sustain what we do year round. We visit seniors all the time, especially the shut in so that they know they aren't forgotten." •

Lawndale City Council Approves Proposed Consolidated Disposal

At the meeting of the Lawndale City Council, held on Monday, December 8, in lieu of the regular first Monday of each month meeting last week, not many items were agendized for consideration. A public hearing was held to examine the proposed increase in rates requested by Consolidated Disposal Services, Inc., for residential, commercial and multifamily rates for trash collection. The increase, an average of 3.1 percent for all collection/ recycling services, was requested in a proposal on September 24, 2014 by the vendor. There has not been an increase since the seven-year franchise agreement with Consolidated was put into effect on January 1, 2011. The increased rates are written in to the franchise agreement and are valid according to the contractual stipulations that increases for fuel, labor, and equipment costs are necessary for the Producer Price Index and Consumer Price Index that effect rates periodically.

During the public hearing a codicil to the services provided was requested to include a pickup bin for medical waste for residential and multi-family customers to accommodate proper disposal of supplies for diabetics and others who require special medical supplies. The company representative commented that this accommodation is not currently part of the agreement, but can be written in and would be "absorbed" by the costs with the requested increase.

Several requests were made that disposal of large items be advised to the vendor by the customer so that proper equipment is dispatched to the location; that recycling be sorted properly and disposed in the correct containers; and that those customers who will need a medical waste container advise Consolidate Disposal so that the proper equipment can be delivered.

The City Council unanimously voted to accept the requested increase in rates for collection of solid waste from residential, commercial, and multi-family customers, effective January 1, 2015.

On the consent calendar agenda, the City Council considered an approval of the agreement with CleanStreet for street sweeping services. The contract with this vendor has been in effect since 2001 and this is for another renewal of a three-year term. The agreement for weekly street sweeping services and debris diversion covers 56 miles of residential streets; twice weekly sweeping for business district streets, not including Hawthorne Boulevard; bi-weekly sweeping of medians and city parking lots; once a week services for all alleys; and five times a week along both sides of Hawthorne Boulevard. The total of 125 curb miles per week is \$15,000 per month. Reference checks with the cities of Hawthorne, Manhattan Beach, and Culver City verified that CleanStreet continues to provide quality street sweeping services in those cities.

The total of \$180,000 per year for three years will be funded by the gas tax revenues of \$183,000 per year. The new agreement was approved for CleanStreet to continue providing street sweeping services for the city of Lawndale.

Hogan Park will be expanded and bids will be requested for the project plans and specifications as presented. Once bids are received, the City Council will witness the bid process and, if reasonable bids are received, make further recommendations to the staff about Hogan Park.

The public was asked to advise the city as they see that storefronts are messy and dumpsters of stores that are placed in alleys and parking lots appear to be overflowing with debris. Code Enforcement will check out locations that are reported, write warnings and/or violations as deemed appropriate, and will be on the alert for repeat offenders. Likewise, if street lights are not working properly, citizens are asked to report these outages or any damage to light poles or wires to Southern California Edison. Each lightpole has a phone number to call to report issues to the energy vendor.

The public safety report included an assault of a female victim and cell phone theft by

two suspects who drove away in a vehicle, but a witness wrote down the license plate number, resulting in the arrest of the suspects. A deputy, responding to a call of a fight, saw two men sitting in a vehicle and approached to ask them if they had seen anything. The deputy asked that the driver exit the vehicle after strong odors were detected on the driver and in the vehicle. The suspect began assaulting the deputy and a backup team of deputies as they attempted to handcuff him. Refusing a field sobriety test and continuing to beat on the deputies, a Taser was necessary to finally subdue the suspect who admitted to heavily drinking and ingesting cocaine. An assault with a deadly weapon call resulted in the arrest of three males positively identified by the victim and the weapons recovered a short distance away.

The Lawndale Wall of Distinction was discussed following a staff report of a formal process and program for those former citizens to be honored posthumously who demonstrated exceptional civic volunteerism during their lifetime serving the city of Lawndale. The south and west walls on the third floor of the Harold E. Hofmann Lawndale Community Center will be the designated location of the plaque(s) to be dedicated once a year when no less than two (2) and no more than four (4) deceased citizens who served the city will be named to the Wall of Distinction and enshrined on the plaque(s). The nominations will be filtered through the Historical Society (three members) and the Senior Citizens Advisory Committee (two members) who then will propose the names to the City Council for approval. The process and the program for the Wall of Distinction will continue to evolve as staff prepares ideas for plaques, wording on plaques, inclusion of photos or no photos, and how large each individual plaque will be on a larger perpetual plaque. Final designs will be approved by the City Council.

The next meeting of the City Council will be held on Monday, January 5, 2015 at 6:30 p.m. •

"Eye Of Sauron" Provides New Way of Measuring Distances to Galaxies



(BPT) - A team of scientists led by Dr. Sebastian Hoenig from the University of Southampton has measured the distance to the NGC 4151 ("Eye of Sauron") galaxy with unprecedented accuracy, using the W. M. Keck Observatory Interferometer in Hawaii.

The team employed a new technique they developed, which allows them to measure distances to galaxies tens of millions of light-years away with 90 percent precision. The technique is similar to that used by land surveyors on Earth, who calculate distances by measuring the angular—or "apparent"—size of an object of known dimensions.

Previous reported distances to NGC 4151, which contains a supermassive black hole, were far from consistent-ranging all the way from 4 to 29 megaparsecs. Using this new, more accurate method, the researchers calculated the distance to the supermassive black hole as 19 megaparsecs (a megaparsec is equal to 3.26 million light-years).

Galaxy NGC 4151 is dubbed the "Eye of Sauron" by astronomers for the similarity of

its appearance to its namesake in the film trilogy, "The Lord of the Rings." As in that saga, a "ring" plays a crucial role in this new measurement. All big galaxies in the universe host a supermassive black hole in their center—and in about 10 percent of all

galaxies, these black holes are growing by swallowing huge amounts of gas and dust from their surrounding environments. In this process, the material heats up and becomes very bright—resulting in the most energetic sources of emission in the universe, known as active galactic nuclei (AGN).

This hot dust forms a ring around the supermassive black hole and emits infrared radiation—and the researchers in this study used this dusty ring as their "ruler." However, the apparent size of the Eye of Sauron's ring is so small that the observations had to be carried out using the Keck Interferometer, which combines Keck Observatory's twin 10-meter telescopes—already the largest telescopes on Earth—to achieve a resolving power equal to that of an 85-meter telescope.

To measure the physical size of the dusty ring, the researchers measured the time delay between the emission of light from close to the black hole and the more distant infrared emission. The distance from the center to the hot dust is simply this delay divided by the speed of light. By combining the physical size of the dust ring with the apparent size measured with the Keck Interferometer, the researchers were able to determine the distance to NGC 4151.

"One of the key findings is that the distance determined in this new fashion is quite precise—with 90 percent accuracy," Hoenig said. "In fact, this method, based on simple geometrical principles, gives the most precise distances for remote galaxies. Moreover, it can be readily used on many more sources than current methods. Such distances are key in pinning down the cosmological parameters that characterize our universe or in accurately measuring black hole masses. Indeed, NGC 4151 is a key to calibrating various techniques of estimating black hole masses. Our new distance implies that these masses may have been systematically underestimated by 40 percent."

Hoenig, together with colleagues in Denmark and Japan, is currently setting up a new program to extend their work to many more active galactic nuclei. The goal is to establish precise distances to a dozen galaxies using this technique—and then use these precise distances as stepping-stones to vastly improve the precision of all distance measurements for the cosmos. •

Hawthorne Loses Three of Four at West

Hawthorne High's boys' basketball team started the season with a 1-3 record in the West Shores Tournament last week at West Torrance High. The Cougars began the First Annual Classic with a 74-68 loss to Marina High from Huntington Beach on December 1 and fell to the host Warriors 63-50 a day later.

On December 3, Hawthorne got its first win of the season by crushing Port of Los Angeles High from San Pedro 98-33, then fell in the fifth place final to Crenshaw 71-58. Against Crenshaw, whose mascot is also the Cougars, Hawthorne was behind throughout virtually the entire game. Crenshaw (2-2) took a 20-13 first quarter lead and led by as many as 14 points (29-15) in the second period.

Leading 35-28 at halftime, Crenshaw steadily pulled away and won handily. "We missed too many lay-ups," Hawthorne head coach David Gray said on Hawthorne's loss to Crenshaw. "We mentally broke down."

Hawthorne managed to get balanced scoring, led by Christian Brown with 10 points. Curry Aksquin added nine points and Marquel Grey and Chigbo Anakpain each chipped in eight. Crenshaw's Chris Kendrick led all scorers with 23 points.

In Hawthorne's easy win over Port of L.A. (0-4), the Cougars scored 64 first half points to 19 for the POLA. The Cougars continued to pour it on by outscoring Port of L.A. 33-14 in the second half.

Michael Blackwell and Brown shared Hawthorne's high scoring honors with 14 points apiece. Cesar Orasco contributed 10 points as all Cougars scored. Grey led the Cougars with 17 points in their loss to West (2-2). Dayvian Lee led Hawthore with 18 points in its loss to Marina. Bruce Hegan and Sal Tai each put in 10 points.

The Cougars are currently playing in the Artesia Tournament in Lakewood where they opened against Claremont last Monday. Hawthorne also faced Corona on Tuesday and will visit Costa Mesa in a non-league game Friday at 7 p.m. The Cougars will play in the Westminster Tournament from next Monday through December 20.

LEUZINGER GOES 1-2 AT ROSE CITY

Leuzinger High's boys' basketball team went 1-2 in last week's Rose City Classic at Maranatha High in Arcadia. The Olympians' only win came against St. Anthony High from Long Beach 59-45 last Thursday.

Keying the Olympians was Davion Crowder with 21 points. Christian Odiona tallied 14 points. Last Friday, Leuzinger fell short of Cajon from San Bernardino 74-68. Crowder had a big game with 27 points. A bad first quarter plagued the Olympians as the Cowboys scored 32 points to 16 for Leuzinger. The Olympians managed to outscore Cajon 25-20 in the fourth period but fell short.

On December 2, Leuzinger lost to Oak Park

51-49. Leuzinger led by four (39-35) after three quarters but Oak Park came back to outscore the Olympians 16-10 in the fourth period to pull off the two-point win. 

Butternut Squash Tart with Fried Sage, Prosciutto and Pecorino Cheese



Serves 4 or 6
Prep Time: 15 minutes
Cook Time: 40 minutes

Ingredients

- 3 slices prosciutto, thinly sliced
- 1 butternut squash (1 1/2 to 2 pounds)
- 1 sheet puff pastry
- 1 egg + 1 tablespoon water, beaten
- 2 tablespoons extra virgin olive oil
- 10 sage leaves
- Shaved pecorino cheese

Preparation

Preheat oven to 425 F and cover a baking sheet with parchment paper. Place prosciutto onto baking sheet and bake for 15 minutes until crispy. Set aside until needed. Reduce oven temperature to 375 F.

Microwave the whole butternut squash for 3 minutes. This will not only make the squash easier to peel and slice but aids in pre-cooking. Using a vegetable peeler, peel the squash. With a knife, slice the neck of the squash into 1/8-inch thick rounds. You will need 18 slices.

Roll the thawed but cold puff pastry into a 12-inch square and transfer to a baking sheet covered with parchment paper. Using a pastry brush, brush the puff pastry with the egg wash. Arrange butternut squash slices in an overlapping pattern on top of the pastry leaving a 1-inch border on all sides; season with a pinch of salt and pepper. Bake for 40 minutes until puff pastry is golden.

While the tart is baking, heat olive oil in a skillet over medium-high heat. Working with five leaves at a time, place the sage leaves in the hot oil and fry for 20 seconds until leaves are bright green and crisp but do not turn brown. Place on a paper towel to drain.

Once the tart is finished, top with crumbled prosciutto slices, shaved pecorino cheese, and fried sage. Drizzle lightly with additional olive oil and season with salt and pepper to taste. •

One Man's Opinion

A Government of Laws

"We are a government of laws, not of men" – President John Adams

How many times have we collapsed back into our plushy seats in our favorite movie theater, licked our popcorn buttered fingers, slurped a Big Gulp, and watched the latest western morality play? The plot is familiar because it contains an expectation that we have always believed; that we are a nation of laws passed by our elected representatives, and that at the end of the movie, those laws will define our civilization, protecting us against insurrection and mayhem.

The theater darkens, the credits have rolled,

and an agenda requiring a government of men, and not of laws. President Adams' claim be damned.

Rationally, the question must be asked of the vigilantes, "cui bono"? Who benefits from the insurrections? Certainly it is not the people injured or killed; not the businesses damaged or destroyed; not the local consumers who have lost accesses to goods and services; not government budgets that have been decimated; and not the cause of the vigilantes because civil rights are not advanced by looting and killing.

But it is not senseless violence. There are, in fact many who benefit. Some like Al Sharpton exploit anger to gain elective office. There are

and the movie begins: There is a killing on the streets of a small Midwestern town. The killer is a deputy sheriff who claims selfdefense. Immediately, outside rabble-rousers invade the town to incite a vigilante mob to insurrection, destroying businesses, many of which are owned by the individual vigilantes themselves.

Correctly, the law focuses on the legal culpability of the deputy sheriff rather than any extraneous grievances of the vigilantes, and finds there is little reason to indict him; but with support from outside agitators the vigilantes sustain their rampage. As the movie ends the rule of law has prevailed but the audience leaves with the very uneasy prediction that there will be another fire in an unknown location at an unknown date, and this one will be bigger than the last.

The vigilantes have a new martyr to stoke their next act of violence. They have a cause others like Jesse Jackson who become wealthy by exploiting minority grievances against major corporations. There is the president, presuming White law enforcement culpability, who sent his Attorney General to the site of the shooting to broadly indict the city and local law enforcement for civil rights violations, even

in advance of the city's Grand Jury decision.

The greatest beneficiary of civil unrest, however, is the political Left. It prospers as long as there are divides that can be exploited between Blacks and Whites; rich and poor; women and men; citizen and illegal immigrant; Christian and Godless; and public sector and private sector dominance. A unified country is the Left's greatest nightmare.

As this movie ends, ask yourself, "Will there be a sequel?" Did this violence advance the cause of civil rights? Will the next violence bring a positive result? Importantly, who benefits from civil unrest? •

Athletes Should Make More Political Statements, Even if Only Symbolic

There has been no lack of commentary about the incidents in Ferguson, Missouri. 
