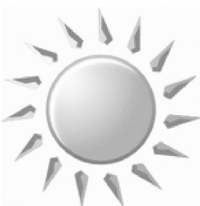

Inglewood Adds Another Jewel in an Expanding Landscape

The city of Inglewood celebrated another milestone with the opening of the Inglewood Senior Center last week. The entire city council and guest of honor Congresswoman Maxine Waters welcomed a crowd of over 500 with ceremonial speeches and a ribbon-cutting, which quickly turned into the party of the new year.

As the automatic doors parted and the community streamed into the new facility, it was hard to know which way to turn. The two-story facility features an immense glass and steel-encased foyer with multi-use spaces at fore and aft. A rhythm and soul band in the massive great room on the north end was a definite draw. Attendees were delighted to sample a lavish buffet catered by Red's Flavor Table, an Inglewood favorite. Colorful and tasty, the appetizers flowed throughout the almost three-hour event.

Instructor Penny Pearl led a lively and animated session of line dancing, including the perennial favorite electric slide, and several original variations. "I'm so excited with this location," said Pearl, who leads senior classes at the other city parks. "I didn't know we were moving here."

While some ventured up the stairs and to the rear of the building, visiting the upstairs lounge and exercise room, still others found their way to the choral studio in the rear. There they found Chair Elizabeth Payne, head of the senior advisory committee, holding court in the sunlit room replete with a sparkling grand piano. "This piano isn't for plunking," quipped Payne. She explained the exquisite, and expensive, piece was a donation from a longtime member of the advisory board. The room, she noted, will house rehearsals of the Senior Inspirational Choir.

Payne, who has spearheaded senior input into every phase of the center, says the committee goes back over 12 years. It moved its meetings from the old senior center to the veterans' center

on Centinela, as development progressed on the new building. "Many didn't get to see this come to fruition," she mused.

Payne is a member of the choir and also the Travelaires club, which she is proud to say she founded. "We have been everywhere, even abroad," she beamed. Her exuberance for the new center was palpable, as she invited everyone to join the center. "Don't sit at home and be bored. Whatever you want to do, it's here, so sign up!"

In mid-sentence, Payne was interrupted by peals of laughter and a greeting. "It's been so long," shrieked Jeanette Taylor, as the two friends exchanged hugs and squeals of remembrance. "It is a reunion," said Taylor, who sat on the advisory board for several years. Taylor said she started coming to the old senior center in 1985. "I remember when the Lakers were at the Forum, they used to come and support us."

"I had to be here," Taylor continued. "We struggled for a long time to get this." As she took a tour, entering room after room, she settled on another sunny room. "This one would make a great card room," she thought. "I hope we'll get to use it for Bid Whist."

Senior Michael Benbow chairs the city's parking and traffic commission. He walked the facility with his friend, Bill Widener, also a member of the advisory committee. "We're living a dream that a lot of people worked on," said Benbow. "We've got so much ahead of us."

The 35,000-square foot facility features an industrial kitchen, administrative offices and 148 underground parking spaces. It contains a 400-seat auditorium and is constructed to allow a shelter in place and provide hundreds of meals in event of disaster, according to Mayor James Butts.

During remarks, the mayor acknowledged the role of Rep. Waters in seeing the center built. Waters helped secure \$4.5 million in federal grants to support the \$27 million development.

In her honor, the 5,000-square foot Sycamore Room will be named the Maxine Waters Room. "I am overwhelmed," said Waters. "I am so inspired and motivated to do even more for the seniors and for this community."

"There is a lot of history being made here today," said Butts, as he asked the gathering to listen as he read the words of Councilman Eloy Morales, Jr. "At the groundbreaking ceremony in Feb. 29, 2016, Eloy said this, 'You have in life two opportunities to be a senior. The first is in high school. The second is here and now.'"

Butts continued, "Eloy is the senior member of the council. He is the first Mexican American to be elected to the city council." The mayor then announced that a section in the Inglewood Library will be named after Morales, commemorating his leadership and vision for the city.

Councilman Morales took the podium, noting his father was raised in Inglewood. Morales spoke to the diversity and comradery within the council and the community at large.

Councilman George Dotson could not understate his pleasure. After all, the center, which will serve seniors from Inglewood, Hawthorne and Lennox, is located within his District 1 area. Face beaming, Dotson said simply, "We can do it in Inglewood. That's what the headlines should say." •

The ASCAP Music Café is a great place to regroup after spending the day in the snow or a theatre, and this year it celebrates its 20th anniversary with an impressive lineup. Brett Dennen and Ethan Gruska are just a couple of the artists set to perform, spotlighting music's essential role in the art of filmmaking. And in keeping with the theme of music, another scheduled event is the "Scoring for Sundance" panel, which gives the opportunity to hear from various composers as they discuss the art of music over a hot cup of coffee.

When all is said and done, however, it is the films that inspire us most. Out of 13,468 submissions, 110 feature-length films were selected to screen at this year's festival. What is Cinemacy most looking forward to? For starters, covering master filmmaker Gus Van Sant's drama *Don't Worry, He Won't Get Far*

On Foot starring Joaquin Phoenix, Jonah Hill and Rooney Mara; cinematographer-turned-director Reed Morano's sci-fi feature *I Think We're Alone Now* starring Peter Dinklage and Elle Fanning; and the sensitive drama *Burden* starring Garrett Hedlund, Andrea Riseborough and Forest Whitaker.

(BPT) - Bluetooth technology is steadily expanding the role of modern hearing aids from tiny marvels that make use of artificial intelligence to process sound into true, state-of-the-art multimedia hubs now capable of two-way communication.

voice pickup, allowing people to have two-way conversations through their hearing aids. Thompson stated this is the first time this has ever been done with hearing aids.

"This is indeed the first time a hearing aid wearer can have a true hands-free conversation without having to touch the phone at all," she said. "This is especially convenient in the car, where your phone may be in a pocket or purse, or if you need to have a conversation while leaving your phone on the table or countertop, for example if you're cooking."

They stream wireless stereo sound directly from your TV

According to research firm Statista, Americans spend an average of 4.5 hours per day watching TV. And if you are or live with someone who has hearing loss, you probably know that sometimes the volume of the TV can become an issue.

"With a card-sized TV Connector, hearing aid wearers simply plug the device into the back of the TV," added Thompson. "The 'plug and play' TV Connector instantly pairs with Bluetooth hearing aids, allowing viewers to stream high-fidelity TV sound in-stereo at their preferred volume level, independent of other viewers. Wearers have reported a markedly better experience in understanding dialogue, especially when the person on TV is talking fast."

Ducks Win Battle of SoCal Hockey

For now, though it may even only last a week, the Anaheim Ducks have earned bragging rights over the Los Angeles Kings. With a 4-2 victory against their rivals last Saturday night, the Ducks came out feisty and ready to assert their dominance. That's exactly what they did. The Kings may indeed be the better team in the standings, even with the loss last week. Anaheim walked right into Staples Center, however, and proved that it is currently the team containing more fight.

Speaking of fight, there was plenty of it to go around on the ice last week in Los Angeles. Before even three minutes could tick off of the game clock, the Freeway Faceoff rivals would drop the gloves to go at it, as everyone might have expected. What most may not have expected, though, was that it would happen two more times on each ensuing faceoff after that. "That's good hockey right there," Ducks captain Ryan Getzlaf explained. "That's just guys who are sticking up for each other. It was good to see it on both sides."

Perhaps nothing encapsulates a Ducks vs. Kings game more than three fights taking place over the course of four seconds of clock time in front of a sold-out Staples Center crowd on a Saturday night. Despite who landed more physical blows to their opponent, Anaheim proved to be the team to come out with more fight in the game. With two goals in the first period of play, the Ducks jumped out to a big lead and took the air out of the building. Though Los Angeles fought back late, the damage had already been done as the Kings were unable to mount a comeback after being down 3-0 in the third period of play.

"It was obviously an emotional game," Kings captain Anze Kopitar said. "The start was physical. With three fights in a row, everybody got fired up pretty quick. I think the first 40 minutes on our part were not to the level that we want to play. Third period we're playing catch-up and with desperation, which we should do the first two periods." Los Angeles didn't end opposing goalie John Gibson's shutout bid until the third quarter when Nick Shore snapped his 27-game goal drought. Just a few minutes later, Kopitar would scratch on a one-timer for his 18th goal of the year to make things a bit interesting for the first time all night. It was Corey Perry, however, who would crush the hopes of the Kings and their fans as he flung the puck into an empty net from 170 feet away in a play that proved to be a microcosm of the Kings' entire night.

The loss marked the third straight for L.A. – a team that is once again falling victim to what looks to be another rollercoaster type of season. "I thought we had a lot of guys who showed up ready for the physical challenge -- we had some guys that didn't," Kings coach John Stevens explained postgame. "It cost us. It's a good lesson for us. We cannot win a game like that unless we have everybody, and we needed more tonight." The Kings are going to need more if they wish to stay near the top of the Pacific Division standings. Since Dec. 1, Los Angeles ranks dead last in the NHL in shots per game. The Kings had 25 against the Ducks in the game one week ago, but will certainly need to manufacture much more offense in the coming weeks as the schedule will only continue to get harder and harder.

"I think both teams understand the implications of these games," Stevens went on to say. "I think everybody's coming to the game knowing that the chips are on the table and everybody's going to be all in." The Kings will have to be all in the next time they take on the Ducks, with a rematch that just so happens to be this week. The Ducks aren't the only daunting team coming up on the schedule for L.A., though, as the Kings will also face off against the likes of the Calgary Flames, Nashville Predators and Tampa Bay Lightning in the coming weeks.

After winning the last five consecutive Pacific Division titles, this season has been somewhat trying for a Ducks team that has been forced to deal with their share of injuries to start the year. The team's victory against L.A. put it just four points behind the Kings for second place in the standings. With Anaheim's history of great play late in the season, one would have to think that the Ducks are right where they want to be heading into the latter portion of the schedule.

The Kings, on the other hand, must get back down to the details, eliminate self-inflicted wounds and eradicate their tentative play at the beginning of games. If Los Angeles can learn to consistently put together three periods in a row of high-intensity play, ditch the rollercoaster and get back to winning, then their playoff chances will certainly be looking bright. For now, though, the Ducks not only have bragging rights, but also seemingly have all of the momentum that they need moving forward into the second half of the season.

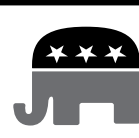

Looking Up

Two Astronomers a Century Apart Use Stars to Measure the Universe

How far away is that galaxy?

Our entire understanding of the universe is based on knowing the distances to other galaxies, yet this seemingly simple question turns out to be fiendishly difficult to answer. The best answer came more than 100 years ago from an astronomer who was mostly unrecognized in her time -- and today, another astronomer has used Sloan Digital Sky Survey (SDSS) data to make those distance measurements more precise than ever.

"It's been fascinating to work with such historically significant stars," says Kate Hartman, an undergraduate from Pomona College. Hartman studied "Cepheid variables," a type of star that periodically pulses in and out, varying in brightness over the course of a few days or weeks.

The pattern was first noticed in 1784 in the constellation Cepheus in the northern sky, so these stars became known as "Cepheid variables." Cepheid variables went from interesting to completely indispensable in the early 1900s thanks to the work by astronomer Henrietta Leavitt. Leavitt's contributions were largely ignored for one simple reason -- she was a woman at a time when women were not taken seriously as astronomers.

In fact, when Leavitt was first hired by Harvard College Observatory in 1895, she was hired as a "computer." In the days before modern computers, a "computer" was a person

hired to perform complex calculations, assisted only by pencil and paper. Although the work was demanding, it was not taken seriously by the male professional scientists of the time -- it was seen as rote work not requiring intelligence or insight that could be done by anyone, even a woman.

So in 1908 when Leavitt discovered a relationship between the brightness (or "luminosity") of a Cepheid variable star and the time it took to go through a full cycle of change (its "period"), her work was not immediately recognized for its significance. It took years for the mostly-male astronomy community to realize that this relationship (today known as "the Leavitt Law") means that measuring the period of a Cepheid variable immediately

gives its true brightness -- and furthermore, that comparing this to its apparent brightness immediately gives its distance.

Using the period-luminosity relationship that Leavitt discovered, others later calculated the distances to Cepheid variables in galaxies outside our own Milky Way. In doing so, they discovered that our universe is expanding, starting from a single point more than 14 billion years ago at the Big Bang -- a discovery that would have never been possible without the discovery of the Leavitt Law.

More than a century later, astronomers like Hartman are carrying on Leavitt's work. Her announcement came about as a result of a ten-week summer research project at Carnegie Observatories. Hartman worked closely with

her research advisor, Rachael Beaton, a Hubble and Carnegie-Princeton fellow now based at Princeton University.

The tool that Hartman and Beaton are using to improve our knowledge of Cepheid variables is the Sloan Digital Sky Survey's Apache Point Galactic Evolution Experiment (APOGEE), which is systematically mapping the chemical compositions and motions of stars in all components of our galaxy.

The very property of these stars that allowed Henrietta Leavitt to discover the Leavitt Law -- their predictable variations in brightness -- creates challenges for APOGEE. "Over a pulsation cycle of a Cepheid variable, the star's properties change," says Beaton. "Its temperature, surface gravity and atmospheric properties can vary greatly over a fairly short time. So how can APOGEE properly measure them? I thought it would be an excellent summer research project to find out."

The undergraduate to take on the challenge was Kate Hartman. She was able to demonstrate that it is possible to get consistent measurements of the chemical makeup of Cepheid variables, regardless of when in their cycle they were observed by APOGEE.

Hartman explains, "I had to look at multiple spectra from the same Cepheid variable and measure the amount of different elements in the star. When we looked at a star's spectrum across its entire pulsation cycle, we found no significant differences in the results. That means that we're getting reliable results every time we look." •

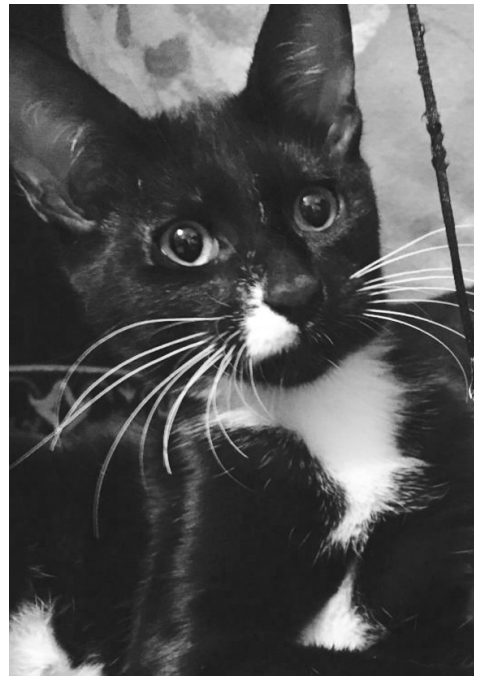
Aisha is a very sweet little girl who came a long way to find her forever home. She was
