Flight Industries Land Major Vote of Confidence to Stay Competitive

South Bay’s space and air defense companies are one step closer to having a state commission to make sure their industry remains competitive and stays grounded in California.

Assemblyman Al Muratsuchi, D-Torrance, introduced a measure to create a California Aerospace and Aviation Commission. Its purpose would be to advise policymakers about what the \$100 billion flight and defense sector in the state’s economy needs from state elected officials. The commission would “serve as a central point of contact” for the flight and space mission companies and “support the health and competitiveness” of the businesses -- including those in the South Bay -- that form the backbone of the aerospace and aviation industries in California, according to the bill.

The Assembly voted 75-0 to create a commission dedicated to smoothing the way for the industry’s growth as the nation sets its sights toward missions to Mars someday. The 15-member commission would operate without taxpayer dollars and be overseen by the Governor’s Office.

“The goal is to bring together the stakeholders and bring together policy recommendations so we can continue to grow and lead the nation and the world in innovation, advanced manufacturing and job creation,” Muratsuchi said last month as the bill was advancing in the Assembly.

The advisory commission would have 15 members, with nine being appointed by the governor to represent aviation and aerospace companies, their suppliers and labor unions. The other members would be selected for expertise in economic development, transportation and higher education. Members would serve for two years and be limited to three terms.

Muratsuchi said he spent a year working on his bill and building support among

Sacramento lawmakers. He is chairman of the California Assembly’s Select Committee on Aerospace.

California held nearly one-tenth of the combined space and aircraft market in the world in 2016, according to the bill. The aerospace industry is “being challenged” by foreign competitors with emerging economies and the technology they lacked in the past. The commission-creation measure says the state must prepare in case of military base closures by the Department of Defense and shifts in funding priorities by NASA.

Florida has enticed at least one California aerospace company to relocate, and industry leaders say that Space Florida has the money and clout with lawmakers that is lacking here. Sean Casey, managing director of the Silicon Valley Space Center, told an industry publication that other states take a more aggressive approach to convincing companies to leave California.

The Assembly’s full-throated endorsement of a California Aerospace and Aviation Commission delivered a message that it’s taking the challenge by Space Florida very seriously. Judy Kruger, who oversees aerospace sector activities at the Los Angeles Economic Development Corporation (LAEDC) had high praise and hopes that the commission will become a reality soon.

The Assembly vote was a small step for the South Bay players in aerospace, which according to the bill is among California’s largest industries and employers. It generates \$140 billion per year within the state, making it a global leader, according to figures provided to the Legislature.

The state Senate still must vote on the measure, and the governor needs to sign the bill. The momentum so far in the lower chamber in Sacramento is one small step for California, and one giant leap for a South Bay industry that designs, builds and supports air and space travel.

“The state hears and sees what’s happening in the industry and wants to protect it and grow it,” Kruger said, adding “it also sends a message outside the state of California.”

Texas, Georgia and Michigan are moving forward to create commissions, which the LAEDC says are completely dedicated to growing their states’ aerospace industries. The work envisioned for the California body will be to market the state’s tax and business climate at industry events where other states will have a presence.

The LAEDC has backed the bill to create a California commission to protect against states looking to “poach our aerospace assets,” it says. The bill got another huge lift right after the Assembly voted: SpaceX in Hawthorne successfully launched its powerful Falcon Heavy into space. The company calls its Falcon Heavy the most powerful rocket in service today, able to carry a fully loaded and fueled 737 jetliner weighing 141,000 pounds into orbit.

The Legislature lately has shown a willingness to help defense contractors to be competitive in bidding for federal contracts. Lawmakers in 2014 supported an enhanced tax credit and tax exemption for Lockheed Martin and Northrop Grumman, both of whom were competing for federal Department of Defense contracts.

In 2016, the Legislature again approved a tax measure favorable to defense and aerospace manufacturers. Lawmakers extended a sales and use tax exemption on manufacturing equipment.

Aerospace is prized by state and local lawmakers because average salaries top \$100,000 and contractors and their suppliers create manufacturing jobs -- some of which require a high school diploma. The demand for workers with technical skills is expected to grow in the Los Angeles metro area, according to a recent LAEDC report about the future of work in the region. •

Black Panther Review: A New Kind of Superhero Roars to the Big Screen

Black Panther, the latest standalone superhero movie from the Marvel cinematic universe, roared to a record-shattering \$218 million US debut over this past Presidents' Day weekend, making it the highest debut ever for a February film and fifth highest opening of all time. Further positive word-of-mouth reviews are sure to continue to make this a must-see movie -- and for good reason: Black Panther is a vibrant and exciting movie that energizes the superhero genre and feels vital to these times.

For those who have been keeping up with the entirety of these Marvel movies, Prince T'Challa -- aka Black Panther (Chadwick Boseman) -- was first seen in 2016's Captain America: Civil War, in which he witnessed his father's passing at his feet. Black Panther sees T'Challa returning home after the events of Civil War to his homeland, the African nation of Wakanda, to succeed the throne as king and rule over his people as the Black Panther. Holding court over his inner circle of royals, including mother Ramonda (Angela Bassett), Wakandan guards Okoye (Danai Gurira) and W'kabi (Daniel Kaluuya), sister Shuri (Letitia Wright), an untested T'Challa finds himself with the responsibility of governing over his people in this new position.

T'Challa finds that it's also up to him to keep his country flourishing, which it has done for generations by staying hidden away from the rest of the world while mining a rare resource called vibranium. This is an element stronger than steel that the Wakandans put into everything from their buildings to their clothes, and from what his sister Shuri makes the Black Panther costume and gadgets. But little does T'Challa know that vibranium is also being coveted by enemies abroad, including Klaue (Andy Serkis) and the American Erik Killmonger (Michael B. Jordan). It's Killmonger who we learn is more than meets the eye and has more than a bone to pick with T'Challa as he challenges him for the throne and for

control of how to lead the nation forward with less than peaceful results.

While Black Panther is the latest superhero flick sandwiched between the rest of the Marvel catalogue, it's not your traditional superhero movie. First of all, there's a new visual identity that director Ryan Coogler (Fruitvale Station, Creed) injects into the movie that keeps the whole thing lively and excitable. And largely, there is a mythos to Black Panther that makes the movie feel even weightier next to its contemporaries. Scenes of T'Challa connecting with his ancestors for wisdom and guidance while he connects with his destiny is a drama more akin to Shakespeare than Superman.

It's all pop entertainment escapism, but it's undeniable that there is political juice in this thing. An interesting point of the movie is that Black Panther must learn how to govern in a political sense and do what's best for his people, which is a discourse that's ever more prescient today. Scenes in which King T'Challa is confronted with how to rule over Wakanda -- whether to continue hiding from the rest of the world and take care of its own people with its rare resources -- is especially prescient to these times.

It can't not be said that Black Panther is also the face of a new kind of hero that has been missing from these movies in quite some time. Having embodied some of history's most important African American figures, such as Jackie Robinson and Thurgood Marshall, Boseman gives an effortless grace and presence to his king-in-making. Jordan is a mad dog off the leash, and other standout performances include Lupita Nyong'o as Nakia and Forest Whitaker as Zuri. Seeing people of color in major roles in native worlds is empowering and gives Black Panther a further distinction and importance compared to others in the genre.

Common Tax Mistakes to Avoid in 2018

(BPT) - Life changes - getting married, having a baby, buying or selling a home, sending a child off to college or retiring - often come with changes to your tax situation. Overlooking these changes when filing your taxes can lead taxpayers to make mistakes that leave money on the table, potentially impacting their refund at a time when the average refund is about \$2,800. Here is a list of common tax mistakes to avoid in the 2018 filing season to help ensure you don't miss any deductions or credits that you deserve.

One of the most common mistakes taxpayers make is selecting the wrong filing status. A taxpayer's filing status can affect which credits and deductions they're eligible for, the value of their standard deduction and their tax bracket. One situation that can make choosing a filing status difficult is when more than one filing status seems to fit.

In addition, common clerical errors such as mixing up names, forgetting to include information reported on your W-2, 1099 or other forms, or even making mathematical errors can also affect your tax benefits.

Most taxpayers file their taxes using the standard deduction, but you may be eligible for a variety of itemized deductions that could possibly save you more. Also, you may be eligible for "above-the-line" deductions and tax credits, none of which require you to itemize. And it's important to note that the newly passed tax reform generally does not impact these credits or deductions until you file your 2018 tax return in 2019.

Twenty percent of eligible taxpayers, particularly lower-income workers, do not

claim the Earned Income Tax Credit (EITC). Depending on their income and the number of children they have, these taxpayers may be eligible for an EITC of \$503 to \$6,242.

Under the PATH Act, taxpayers who claim the EITC and who file early will have their refunds delayed until mid-February. Despite the delay, taxpayers should file as they normally would to get their refund as soon as possible.

Depending on your academic program, what year the student is in, income and other restrictions, there are federal tax credits that can help offset the costs of higher education for yourself or your dependents. To qualify, you must pay for post-secondary tuition and fees for yourself, your spouse or your dependent. Depending on the criteria, a student may use the American Opportunity Credit of up to \$2,500 or the Lifetime Learning Credit of up to \$2,000.

Itemizing can save taxpayers hundreds of dollars, as only one third of taxpayers itemize but millions more should - especially homeowners. Owning a home is often the key that unlocks itemization, but some taxpayers with high state taxes and charitable contributions may also be able to itemize.

On average, the IRS announces annually that approximately \$1 billion goes unclaimed in federal tax refunds. Taxpayers can claim a refund for up to three years after the filing deadline. So, in addition to filing your 2017 return, keep in mind to file your 2015 return by April 17, 2018. If not, you will lose your 2015 refund. •

Kings Make History in Buffalo, but Will They Even Make the Playoffs This Year?

With no disrespect to the people of Buffalo, who could possibly want to travel there in the month of February? Not many are brave enough to battle the 20-degree weather, even if you're used to playing a professional sport on a slab of ice. The Los Angeles Kings were forced into Buffalo last Saturday and instead of simply laying down their sticks, did something that they hadn't done in the last 15 years. They won. Now, with just over 20 games remaining in the regular season, the only question left to be answered is whether or not the team will play well enough to make it into this year's postseason.

Anze Kopitar and rookie Michael Amadio each scored twice for the Kings last weekend when the team acquired its first victory in Buffalo since Feb. 21, 2003. Maybe Amadio is the good luck charm that changed L.A.'s fate once and for all. Or maybe it was the play of goalie Jonathan Quick, who made 33 saves for Los Angeles on the way to a 4-2 victory against the Sabres at KeyBank Stadium. "I don't think we were worried about the 15-year drought in here," Kopitar explained after the game. "We had a three-game slide that we certainly wanted to stop. I thought today we came ready to play."

The Kings can get excited about that victory all that they want to, but it's important to remember that it came on the heels of a three-game losing streak for Los Angeles.

That same losing streak saw the Kings lose to two different elite teams who go by the names of the Tampa Bay Lightning and the Pittsburgh Penguins. Now is the time of the regular season when Los Angeles must decide what team that it wants to be. Does it want to be the team that loses to other good teams and drops to fifth place in the Pacific Division standings? Or does it want to be the team that looked almost unbeatable over a stretch of over 10 straight games in October?

While the Vegas Golden Knights may have first place wrapped up in the division, the end of the regular season is going to come down to inter-division play for L.A. As of last weekend, the Kings were in an absolute all-out brawl for playoff positioning with their enemies from Calgary, Anaheim and San Jose. On one hand, that's good news, because who doesn't like to watch two huge rivals stick it to each other on the ice and drop some gloves while they're at it? On the other hand, the Kings' recent record against other teams in their division could spell trouble for a team that's looking for a boost in points over the last month or so of play.

Los Angeles was horrible against all other opponents from the Pacific Division last season and not much has changed this year. As of last weekend, the Kings were 7-9-3 within their own division while putting up

His reemergence has the ability to help the Kings finally begin to put some pucks into the back of the net. Also, head coach John Stevens must ask himself the question of how much is too much of Quick. The Kings goalie has looked nothing short of lackluster since before the All-Star break, while his backup Darcy Kuemper has done a more than serviceable job.

It's getting late in the season and it has certainly become clear that the Los Angeles Kings have a lot of work to do if they wish to not only get into the playoffs, but get





Congress Finds a New Target to Attack

In all honesty I never thought that Congress would come out one day and pass legislation attacking people with disabilities, but the day has come. The House of Representatives passed the ADA Education and Reform Act with a 225-192 vote. In essence, this act would require people with disabilities to provide a written notice that a business does not provide adequate access to persons covered under the American With Disabilities Act. Through this law, for which there is no version of in the Senate yet, a business would have 60 days to respond to a written complaint, as well as another 60 days to actually begin improving their location to accommodate people protected under the ADA.

For 28 years, the ADA has ensured that the public is protected from discrimination "on the basis of disability in the full and equal enjoyment of the goods, services, facilities, privileges, advantages, or accommodations of any place of public accommodation" -- Title III/Specific Construction of the ADA. Why then, does the House of Representatives find it necessary to make this modification? Current and potentially new business owners already know some of the basic requirements (access ramps, modified restrooms, etc...) set by the ADA, so they do not need a written notice. Requiring people with disabilities to give a written notice shifts a business responsibility from the owner to the public for no good reason. Supporters of the bill argue that this will keep money-seeking lawyers from filing frivolous lawsuits against local businesses for ADA violations, hence saving the business

money. Well, you know what else would save the business money? If they just complied with the ADA requirements. They've been in place since 1990. How much more of a warning do you need? Are these accommodations expensive? Yes, they are, but we are at a point where these accommodations are part of the business expense. They aren't surprise requirements.

The amendment also requires that a model program to "promote alternative dispute resolution mechanisms to resolve such claims" be created in order to have a method to determine "relevant facts related to such barriers." All this was done with the "goal" of resolving an accessibility issue before resorting to litigation. So not only do these amendments give business owners a way out of complying with ADA requirements, but they place the unnecessary burden of proving that a business is not complying on the people who are supposed to be protected by the ADA. If they are lucky, people with disabilities will see modifications begin happening 120 days after their complain. That's if the model program doesn't kick in to continue stalling.

There is no need for this amendment. The ADA requirements have been in place long enough. Maybe some corporate donors become a little more generous and are looking forward to future projects where they can skip meeting these ADA requirements. Or maybe Congress has just really does not care about people. It's anyone's guess. Fortunately, you don't have to guess who voted for this amendment and can see the full list at <https://www.govtrack.us/congress/votes/115-2018/h80>. •

Marinated Garlic and Lemon Roasted Chicken

Recipe provided Nestle's Balance Your Plate

5. Make sauce in a small bowl by whisking together the mustard and honey. Add water as needed for a workable consistency.
6. With a small pastry brush, brush sauce over chicken and broil 5 minutes until bubbly. Place chicken pieces on a serving platter and sprinkle minced parsley over all.

A Piece of Mars Is Going Home

Based on a Press Release from JPL, Provided by Bob Eklund

A chunk of Mars will soon be returning home. A piece of a meteorite called Sayh al Uhaymir 008 (SaU008) will be carried on board NASA’s Mars 2020 rover mission, now being built at the agency’s Jet Propulsion Laboratory in Pasadena, California. This chunk will serve as target practice for a high-precision laser on the rover’s arm.

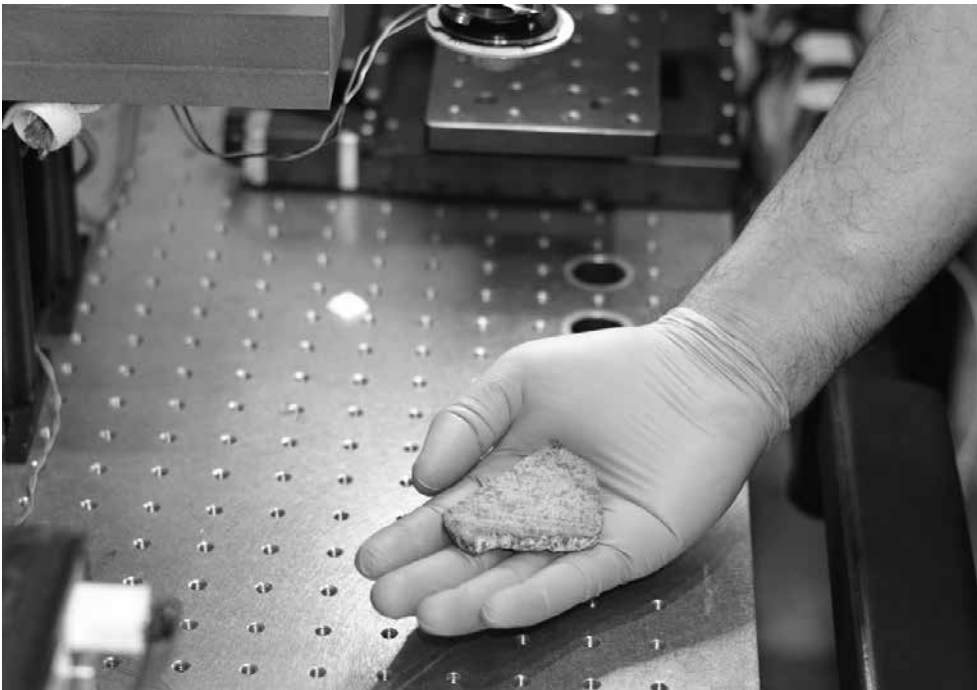
Mars 2020’s goal is ambitious: collect samples from the Red Planet’s surface that a future mission could potentially return to Earth. One of the rover’s many tools will be a laser designed to illuminate rock features as fine as a human hair.

That level of precision requires a calibration target to help tweak the laser’s settings. Previous NASA rovers have included calibration targets as well. Depending on the instrument, the target material can include things like rock, metal or glass, and can often look like a painter’s palette.

But working on this particular instrument sparked an idea among JPL scientists: why not use an actual piece of Mars? Earth has a limited supply of Martian meteorites, which scientists determined were blasted off Mars’ surface millions of years ago.

These meteorites aren’t as unique as the geologically diverse samples 2020 will collect. But they’re still scientifically interesting—and perfect for target practice.

“We’re studying things on such a fine scale that slight misalignments, caused by changes in temperature or even the rover settling into

sand, can require us to correct our aim,” said Luther Beegle of JPL. Beegle is principal investigator for a laser instrument called SHERLOC (Scanning Habitable Environments with Raman and Luminescence for Organics and Chemicals).

SHERLOC will be the first instrument on Mars to use Raman and fluorescence spectrometers, scientific techniques familiar to

forensics experts. Whenever an ultraviolet light shines over certain carbon-based chemicals, they give off the same characteristic glow that you see under a black light.

Scientists can use this glow to detect chemicals that form in the presence of life. SHERLOC will photograph the rocks it studies, then map the chemicals it detects across those images.

Martian meteorites are precious in their

rarity. Only about 200 have been confirmed by The Meteoritical Society, which has a database listing these vetted meteorites.

To select the right one for SHERLOC, JPL turned to contacts at NASA’s Johnson Space Center in Houston, as well as the Natural History Museum of London. Not just any Martian meteorite would do: its condition would need to be solid enough that it would not flake apart during the intensity of launch and landing.

It also needed to possess certain chemical features to test SHERLOC’s sensitivity. These had to be reasonably easy to detect repeatedly for the calibration target to be useful. Experts tried several samples, cutting off thin bits to test whether they would crumble. Using a “flaky” sample could damage the entire meteorite in the process.

The SHERLOC team ultimately agreed on using SaU008, a meteorite found in Oman in 1999. Besides being more rugged than other samples, a piece of it was available courtesy of Caroline Smith, principal curator of meteorites at London’s Natural History Museum.

“Every year, we provide hundreds of meteorite specimens to scientists all over the world for study,” Smith said. “This is a first for us: sending one of our samples back home for the benefit of science.”

Along with its own Martian meteorite, SHERLOC’s calibration target will include several interesting scientific samples for human spaceflight. These include materials that could be used to make spacesuit fabric, gloves and a helmet’s visor. •
