# Voters Place Confidence in Incumbents at City Hall, School Board

Inglewood voters brought back into office District No. 1 Councilman George W. Dotson and District No. 2 Councilman Alex Padilla during the April 4 municipal election. Also reelected were Inglewood Unified School Board Members Seat No. 2 representative Carliss Richardson-McGhee and Seat No. 3 member Melody O. Ngaue-Tuuholoaki, while Dionne Faulk will fill Seat No. 1.

"Every election cycle we hear so many things that people blame--correctly or incorrectly--on the City, but I am a firm believer that the people always get it right," District No. 3 Councilman Eloy Morales, Jr. said. "Sometimes we don't agree with the outcome and some people may not agree with this one, but I will tell you that based on everything that has been going on the last couple of years in the city and having knocked on doors, there is a good feeling."

Councilman Padilla, who ran unopposed, received 638 votes. For Councilman Dotson, who received 934 votes, his reelection bid put him up against retired graphic designer Leroy N. Fisher (94 votes), community advocate Maxine Toler (371 votes) and Inglewood resident Hugo Ramirez (22 votes) also in the District 1 council race.

"I want to thank everybody that came out to vote. It shows that you care about what is happening in Inglewood," Padilla said. "Not only did we have a couple of important seats open on the City Council, but also in the School District. I want to thank the City Clerk for all of her work and her staff. It's a lot of work, but they always come through and they do a great job."

Of the three seats in dispute for the Inglewood Unified School District

Advisory Board of Education, Faulk (1,977 votes) edged out Odest T. Riley, Jr. who received 1,013 votes. The seat was left open when incumbent Margaret Richards-Bowers decided not to file for reelection. Richardson-McGhee and Ngaue-Tuuholoaki ran unopposed and earned 2,475 votes and 2,444 votes respectively.

The most contested item on the ballot was Measure DE, which passed 1,654 to 1,247 votes and officially authorizes that the "Inglewood City Charter be amended to allow the Board of Education for Inglewood City Schools to change the method of election of the Board of Education." The approved measure will ensure that School Board members are elected by the District instead of through at-large elections.

After the State of California took over Inglewood Unified due to financial woes, the School Board was stripped of its powers and control of the District was transferred to a State-appointed administrator. It was then that members to the Board of Education were only allowed to serve in an advisory capacity.

As a condition for the State to return control of the District to the Board of Education, nine demands have to be met. One complete fiscal year must have passed since acceptance of the emergency loan and the State Superintendent of Public Instruction (SSPI) has approved all recovery plans for the District; the State administrator must determine and notify the SSPI and County Superintendent that future compliance by the School District with recovery plans is probable; the Fiscal Crisis and Management Assistance Team must complete at least two progress reports on the District's implementation of improvements

in the recovery plan; performance under the recovery plans completed by FCMAT has to be proven to the satisfaction of the SSPI, but must include at least an average score of six in all operational areas with no individual scores below four (powers may be returned incrementally by operational area); the administrator must certify that all essential collective bargaining agreements are negotiated, ratified and that the agreements are consistent with the terms of the recovery plans; the District has to complete all reports required by the SSPI and administrator; the administrator must certify the required training via SB 533 of all Board members and District personnel; the SSPI must conclude that future compliance with recovery plans is probable; and lastly, a 60-day notice needs to provided to the Legislature, Department of Finance, the Controller, and County Superintendent that conditions for return of powers are expected to be met.

The District is said to have completed requirements one, three, five and six, but is on the cusp of accomplishing the remaining criteria. When that happens, expected within the next three years, the Board will have its new election method in place.

"I am very proud of this city, of this council and where we've come--in particular during the last four years--and we have done things that no other city has been able to do," Mayor James T. Butts said. "Not only have we changed ourselves economically, but we have changed our brand--changed the way that people in the city and outsiders think of Inglewood. It is an entirely different thing wherever you go and whatever you do when you say Inglewood. There is a respect that the city carries."•

### Is Hidden Salt Hurting Your Health? Five Tips for Taking Control

(BPT) - A typical soup and sandwich lunch can seem like a healthy meal. However, the bread, cold cuts and soup can be packed with something that can have a negative impact on your overall wellness: salt.

"Even meals that seem healthy, like a turkey sandwich with a side of cottage cheese, can have high levels of salt. It may not even taste salty," says John Meigs, Jr., MD, president of the American Academy of Family Physicians.

Meigs says one of the biggest mistakes people make is to assume if they aren't adding salt with a salt shaker, their sodium levels are under control. The truth: The Centers for Disease Control and Prevention estimates Americans get 77 percent of their salt from processed foods and restaurant meals, compared to 6 percent from the salt shaker at the table and 5 percent added during home cooking.

According to the CDC, the top 10 foods that contribute to a significant amount of the salt Americans consume are:

- 1. Breads and rolls
- 2. Cold cuts and cured meat (e.g., deli or packaged ham or turkey)
- 4. Fresh and processed poultry

- 6. Sandwiches such as cheeseburgers
- 7. Cheese
- 8. Pasta dishes (not including macaroni and cheese)
- 9. Meat-mixed dishes such as meatloaf and tomato sauce
- 10. Snacks such as chips and popcorn

Some salt is necessary for the body to function properly, but too much can contribute to high blood pressure, heart disease and stroke. The CDC says most people should limit total salt intake to 2,300 milligrams a

"There are 2,300 milligrams of sodium - the chemical name for salt - in a single teaspoon of table salt," Meigs notes. "It's a real challenge to reduce salt intake, even for people who are highly motivated to do so."

Meigs offers some easy strategies to lower hidden salt intake and take control of your nutrition:

### **Know your Numbers**

Talk with a doctor about your blood pressure, cholesterol levels, family health history and ways to prevent health problems before they start. Visit familydoctor.org to learn more.



### **Read Nutrition Labels**

It takes mere seconds to read nutrition labels to see which items are high in sodium. Sometimes this information is even printed on the front of the package.

Keep in mind, different brands of the same foods often contain varying levels of salt. For example, a slice of white bread can range anywhere from 80 to 230 milligrams of salt. Salt levels in a can of chicken noodle soup can range from 100 to 900 milligrams per serving.

### Be a Smart Diner

Dining out can still be a healthy treat with a little proactive effort. If nutrition information isn't included on the menu, do some homework in advance by visiting the restaurant's website. You may be surprised to find that items billed as "light or healthy fare" are often high in salt.

### **Opt for Whole Foods**

Whether eating out or dining in, filling your plate with whole foods - items in their natural state or close to it - will help you lower your sodium levels. Non-processed fresh foods that are high in fiber are ideal, for example, fresh fruits, vegetables, lean meat and whole grains.

### Prepare Food at Home

It's easier to regulate salt consumption by preparing meals at home. Not only can you select healthy ingredients and pack your plate with whole foods, you can control the salt you add to dishes by manipulating recipes and including flavor-enhancing alternatives like fresh herbs.



### **Inglewood Native Serves Aboard** Navy's Most Advanced Submarine



A 2010 Morningside High School graduate and Inglewood native is serving in the U.S. Navy as part of a crew working aboard one of the world's most advanced ballistic missile submarines, USS Alaska. Petty Officer 2nd Class Saad Shoroye, an electronics technician, serves aboard the Kings Bay-based boat, one of 14 Ohio-class ballistic missile submarines. As an electronics technician, Shoroye is responsible for maintaining communications equipment aboard the submarine. "I like my job because I really enjoy the company of the other sailors who are in my division," said Shoroye. "We work together as a team to get the job done,

and when our equipment is working well, we take pride in that."

The Navy's ballistic missile submarines, often referred to as "boomers," serve as undetectable launch platforms for intercontinental ballistic missiles. They are designed specifically for stealth, extended patrols and the precise delivery of missiles, and they are the only survivable leg of the nation's strategic nuclear forces, which also include land-based missiles and aircraft. The Ohio-class design allows the submarines to operate for 15 or more years between major

"The best thing about serving on a submarine is the mission we do, and how important it is," said Shoroye. "The strategic deterrence mission is crucial, and I am honored to serve on an SSBN." As a member of one of the U.S. Navy's most relied-upon assets, Shoroye and other sailors know they are part of a legacy that will last beyond their lifetimes. "The Navy has taught me more self-discipline and kept me in great physical shape. It has also given me technical knowledge that I will be able to use in the civilian world, if I decide to transition out of the Navy." - Content Provided by Rick Burke, Navy Office of Community Outreach

# Hawthorne Volleyball Wading in Ocean League

For the Hawthorne boys' volleyball team, this year has been a tale of two seasons. The Ocean League is always sure to present its share of rough currents and big waves for all those who play games within the division. The Cougars and head coach Christine Regadio-Auberry are learning that fact firsthand this season. After an excellent start to the year, divisional play has presented Hawthorne with its own share of problems and setbacks. Despite the team's struggles against their rivals, however, two victories over the Beverly Hills Normans have certainly helped to ease the Cougars' pain a bit.

The boy's volleyball team simply couldn't lose at the beginning of the season. The Cougars weren't just winning, either. They were shutting other teams out. Hawthorne began the year with eight straight victories, including their league-opening 3-2 victory over their division rivals, the Beverly Hills Normans, on the road at the Normans' own gym. Of the Cougars' first eight victories, six were shutouts. Behind the offensive efficiency of senior outside hitter Ryan Jotie and the defensive prowess of junior middle blocker Alejandro Caso, Hawthorne was very rarely giving up a set, let alone a match.

The Normans learned just how lethal the Cougars could be. Hawthorne jumped on Beverly Hills right away in the Ocean League opener, taking the first set by a final of 25-23. No divisional matchup is ever going to be as easy as those played against non-league opponents, similar to the ones in which the Cougars previously enjoyed so much success. That being said, Beverly Hills, of course, battled back. The Normans took the lead by capturing two straight sets against Hawthorne, but behind the hitting skills of Caso, the Cougars were able to get right back into the match.

Caso finished the afternoon with 15 kills, which were just one more than his teammate Jotie was able to accrue. Jotie finished the day with three service aces, but it was Caso who was a beast on the net. He finished the game with 11 total blocks, nine of which were solo, as the Cougars rallied in the fourth set for a 25-21 win to tie the game at two sets apiece. With momentum back on their side, there was no stopping Hawthorne from there. Caso and Jotie sparked the Cougars to a 15-10 victory in the fifth and final set to finally pull out the close victory in extra time.

Hawthorne went on to win its second game of the season against Beverly Hills last Wednesday afternoon at home. The Normans took the first set of the match, but Hawthorne rallied to win three straight and take the 3-1 victory. Despite

Hawthorne's recent success against Beverly Hills, the team has been struggling against all other Ocean League opponents. After Hawthorne's great 8-0 start, the Cougars dropped three of their next four games to Santa Monica (twice) and Culver City. A 9-3 overall record is only tarnished by a below average 2-3 record in league play, which has dropped Hawthorne to fourth place in the standings. A rematch against Culver City and games against Lawndale and El Segundo remain before the season comes to a close. If the Cougars string together a few victories over their divisional foes coming up, they may just have a chance at climbing up the standings and gaining a spot in this year's CIF playoffs.

### **LAWNDALE HIGH**

The Lawndale Cardinals have been led by their captains Anthony Sanchez and Randy Fuentes in a season that had previously started out much better than it has currently become. Sanchez, a senior outside hitter, and Fuentes, a senior setter and defensive specialist, have been instrumental in the Cardinals' six victories this season. Unfortunately for Lawndale, not one of those six victories has come inside of Ocean League play. Wins against Morningside, Leuzinger and Marquez got the Cardinals off to a fantastic 4-1 record to start the year. Interdivision competition always proves to be much tougher, however, and that's when the Cardinals' (6-6, 0-4) season took a turn for the worse.

Three straight losses to Santa Monica, Culver City and El Segundo immediately put Lawndale in a bad position and gave the team an uphill battle to get themselves back into good positioning within the Ocean League. With games still remaining on the schedule against Hawthorne and Beverly Hills, the opportunity for wins remains alive for the Cardinals. As a team that currently sits in last place out of six squads, however, Lawndale will most likely need an extreme transformation in a hurry in order to get back into the thick of things within its own division.

### **INGLEWOOD HIGH**

The Inglewood Sentinels find themselves competing in a Bay League division that is stockpiled with volleyball superpowers. Matches against the Redondo Union Sea Hawks, Mira Costa Mustangs and Palos Verdes Sea Kings give Inglewood almost no chance at competing for a top seed within its own division. The Sentinels have already lost six straight games to begin the season and have been shut out five times. Inglewood's best chance for a win comes in its last game of the season when it will take on the 0-5 Morningside Monarchs
