Steve Ballmer's Latest Project Looks at the Big Picture

Steve Ballmer says he loves numbers because they reveal what's really happening within a complex system. He relied on them when he ran Microsoft Corporation and now as owner of the Los Angeles Clippers, he depends on numerical data to run the team and watch games from the stands. The scoreboard doesn't just tell Ballmer who's winning, it breaks down the action on the floor into a measure of team performance.

In public life, Ballmer discovered it wasn't that easy. Anyone who wanted to understand the government's finances had to piece together local, state and federal data to get the big picture. Ballmer's latest project is a website called USAFacts.org that gathers that information and explains with numbers the areas where government makes money, loses money, or breaks even.

Ballmer wants the public to know upfront that USAFacts.org is nonpartisan and free to use. The billionaire owner and former chief executive at Microsoft financed it himself and hired a team of economists, researchers and writers who spent three years analyzing government data and looking for a clear meaning. For Ballmer, the project started with a conversation with his wife who wanted him to do more philanthropic work.

Before he increased his charitable work, Ballmer needed to grasp the bigger picture of where the money could do the most good. What he didn't want was to duplicate government-funded services.

Specifically, he researched government-funded activities in health, education and human services, and quickly hit a wall. Information about how much the government spends taxpayer money wasn't being shared across federal, state and

local levels. When the former chief executive of the world's largest software company Microsoft can't find data on the Internet, there is an information gap.

His discovery led Ballmer to create USAFacts.org, which he launched last week. The website team is "passionate about making information available to the public." Calling it a work-in-progress, the beta version of the site released on April 18 is ambitious in its scope. And there's no political bent.

The government numbers and colorful charts tell the stories of American government activities, huge and complex as they are. Ballmer's team culled as much information as time and manpower

allowed: 90,000 jurisdictions serving 320 million people. To be exact: 321,418,820 at last count.

"Whether government money is spent wisely or not, whether our quality of life is improving or getting worse--that's for you to decide," Ballmer's team says. The non-partisan tone of the website is refreshing, as polarizing political viewpoints have no place in Ballmer's new project. In fact, he admits that his perception of "government bureaucracy" is different, knowing almost 24 million work in government. "People who work in schools, higher ed, public institutions of education--they are government employees,"

Wiseburn School Board Discusses San Bernardino Shooting

As construction at the Wiseburn/Da Vinci High school site on Douglas Street continues, with the first day of school slated to be on August 22 and the ribbon-cutting ceremonies set to take place on August 12, the Wiseburn Unified School District School viewed special presentations from Juan Cabrillo School Principal Margaret Lynch and District Program Specialist Peggy Mazzarella. They also addressed the recent campus shooting incident that occurred in San Bernardino, resulting in the deaths of an elementary school teacher and one of her students.

Lynch's presentation was supported by Juan Cabrillo counselor Elisa Lopez, who has established a program that has as one of its main components a school-wide Positive Behavior Support System (PBS). Lynch called her presentation a "thank-you note to the Board" because two years ago, the Board had approved a part-time counselor at Cabrillo. "This is the first year we have had a [full-time] counselor at Cabrillo School. We want to share with you how that is supporting students, and the data that is supporting the effectiveness of the program," said Lynch.

Lynch and Lopez spoke of "behavior expectations" at Cabrillo, as well as three tiers of support in place on the campus that teach students from Kindergarten through second grade. Lopez mentioned components of the counseling program, including "whole-body listening," "expectation assemblies," and the implementation of re-aligned "Cabrillo Cub cards" to reinforce positive behavior.

The presenters also shared gathered data on the decrease of negative disciplines at the school since the implementation of the PBS program. Data showed that student "warnings," "white slips," and "in-school suspensions" have decreased substantially since the advent of the campus counseling program.

Lynch and Lopez also spoke of the 3Bs that are among the cornerstones of the program, including Being Respectful, Being Responsible,

and Being Safe. A behavior matrix has been created, and all campus staff members have been trained to consistently implement the matrix expectations and reinforcement with the Cub cards. Concluded Lynch: "I hope you can see that having a full-time counselor is making a huge difference for our students."

Board member queries about the Cabrillo program then followed. Superintendent Tom Johnstone then added his thoughts, also recognizing Lynch for a recent achievement. "We haven't really been publicly able to recognize Margaret for her achievement as elementary school principal of the year for the entire state of California," he said.

Mazzarella's presentation focused on the Wiseburn Child Development Center, which offers preschool and before/after school care programs. She gave her update, noting that "we are very, very busy. We are serving approximately 360 students throughout the District, and we are full." She also shared parental survey results, which gave the program very high marks in all categories, and highlighted how the positive behavior matrix developed at Cabrillo and was mentioned in the prior presentation is also utilized in Child Development Center programs. She noted ramped-up professional development opportunities for WCDC staff, and the increased access to technology for the District's young learners. Increased safety enhancements were broached--critical in light of recent school-site violence, including door-locking procedures and the installation of doorbell and video cameras as well as alarms. Increasing campus safety, always a priority, has been highlighted because of the recent horrific shootings in San Bernardino.

Mazzarella mentioned that preschool parent training sessions have taken place, although the parental turnout has been somewhat sparse. She indicated that the timing of the trainings may be altered, adding that "we are going to keep working on how we can get better attendance." She added

that some changes this school year included new classrooms at Cabrillo, and elimination of "extended care, because we want to focus on instruction." Space was an issue, she said. She also addressed the strides being made in teaching special education students.

After the presentation, Johnstone noted, "I don't think we could have done what we have" [without the seamless transition from the prior group that had run the program to the WCDC]. "We have taken an awesome program and made it that much better."

Board members and District administrators then had their turn to make comments, with the presenters departing and one of the folks who left at this point of the 90-minute meeting jokingly imploring Board members to "make good decisions tonight." The success of recent District events, including "Rock-Around-the-Block," were lauded, with kudos going out to the hard work of the Wiseburn Education Foundation. Board Vice President JoAnne Kaneda voiced her appreciation of how well the event was staged.

Kaneda also brought up the recent tragic events that took place at the San Bernardino elementary school. Said Board President Israel Mora, "Unfortunately, it is a reality of life and something that we are going to have to look at closely. We all know that we don't want our schools to be prisons." Talk ensued about how the San Bernardino shooter, who then committed suicide, easily gained access to the classroom to murder his estranged wife and an innocent

student. Mora said it was an important topic, and if District personnel are having "issues" with a significant other, "maybe it needs to be discussed--but of course, nobody likes to do that. Things happen in the country, and we just can't say that it is not going to happen here."

Superintendent Johnstone, addressing the devastating fallout from the school-site shooting, said that the District was working on its sign-in protocol to limit visitors and family members on-campus during the school day and after-hours. He also touted the "active-shooter" training taking place for District teachers and "significant office staff" on April 27. Next year, he said, District members will become certified to deal with possible "active shooters" on campus, through the "ALICE" Training Institute.

Action items were next on the agenda, including the approval of the safe school plans--a huge issue considering recent developments. Construction change orders at the new high school were next briefly mentioned, with all well heading towards the start of school on August 22.

Consent items followed, with personnel issues quickly addressed. School open houses blanket the May District calendar, with Burnett holding its event on May 31.

The next meeting Wiseburn School Board meeting has been moved up on the calendar, because of scheduling issues, and is now set for Thursday, May 4. •

25 YEARS AGO

It is hard to believe that the Rodney King Riots were 25 years ago this weekend. I was the principal of South Bay Lutheran High School at the time and we had a thrift shop located at the corner of 130th Street and Prairie Avenue. On the morning of May 1st I was sitting at home and received a phone call from the City of Hawthorne indicating that our thrift shop had been fire bombed the night before. I have never thought that our shop was a specific target for the racial tension. The thrift shop was simply full of old clothes and was easy to set ablaze. This paradoxical act of destroying a shop that was set up to support the education of African American teens was demoralizing just for a short time. Our volunteers were determined to reopen and we did by moving two short blocks south on Prairie. The local NBC-channel had a brief clip on our rebuilding effort when we held our grand re-opening two months after the fire. The aftermath of the fire gave us the opportunity to really show others that our Christian faith community was color blind and we worked across any racial barriers to reach out to again motivate and inspire youth to make something better for their lives. The quote, "Can't we all get along?" was joked about, but our answer was, "Yes we can" when we know the love of God.

School Board Adopts New ELA/ELD Instructional Materials

At its most recent meeting, members of the Hawthorne School Board unanimously approved a recommendation by Associate Superintendent Educational Services Dr. Brian Markarian to adopt new English Language Arts/English Language Development instructional material that will be aligned with academic standards set by Common Core. Through an extensive review process that analyzed materials, needs and purpose, the 30-person English Language Arts/English Language Development Instructional Materials Adoption Committee made the recommendation that the School Board adopt instructional material from Benchmark Advance/Benchmark Adelante.

"We want to be inclusive and transparent in this process and the way we accomplish that is by including teachers from each grade, representatives from each school, as well as support staff and instructional coaches that have received that additional professional development training and know what to look for," said Dr. Markarian. "We like to hear from everybody and one of the things I am really proud of is that all of our committee efforts, for math in middle school and elementary and for language arts in middle school and elementary, have made unanimous votes. It's telling in that we are consistent with what we are doing and that in the end we know what the right tools are for us."

The adoption will update the Hawthorne School District's 1997-based state standards for ELA and literacy. Dr. Markarian's presentation for the adoption highlighted the 12 shifts that Common Core requires of school districts to align those with curricular materials and classroom instruction (six in math, six in ELA/Literacy). Shift 1 is referred to as Balancing Information & Literary Text and will enable students to read a real balance of informational and literary texts. Shift 2 is Knowledge in the Disciplines through which students will be capable of building knowledge of the world through text rather than the teacher or activities.

"The fact that they have developed a program that is really aligned with the new standards as opposed to taking a current program and revising it, I think has been a strong selling point for their product," said Dr. Markarian. "They designed it from the ground up and based on the current standards and usually with a larger pre-existing adoption, that's not always the case. They make such an investment into an adoption that they don't normally start from scratch, but this is a program that in every aspect mirrors what the standards ask for."

Shift 3 is called the Staircase of Complexity and will allow students the ability to read the main, grade-appropriate text from which instruction is centered. This will help create more time, space and support in the curriculum for close reading. Shift 4 is Text-Based Answers in which students will engage in "rich and rigorous evidence based conversations about the text." Shift 5, Writing from Sources, will emphasize the use of evidence from sources to make an argument and inform. Shift 6, Academic Vocabulary, will have students build a vocabulary that will be implemented to understand complex, grade-level texts.

"Beyond the shift to Common Core, we also have the new English Language Arts and English Language Development framework which really integrates both the ELA and ELD standards so the expectations for supporting English Language Learners are throughout all components of instruction," Dr. Markarian said.

With the Board's adoption, the logistical steps are underway with the benchmark to finalize the order and it is expected that all materials will be made available to the District by the summer. In addition, there will be new professional development efforts launched in order to have each school ready for instruction under the new material by the fall. For several years the District has engaged teachers in professional development--so with this shift in instructional materials, it will only have to align the current adoption requirements to its current professional development standards.

"Our administrators and our coaches will begin their professional development now with the instructional materials that we do have," said Dr. Markarian. "Once we receive all other materials, we will have our full district-wide professional development."

Much of the content in the adopted instructional material is digital and facilitates the process by which new content can be added and revised. Furthermore, much of the materials are consumable, meaning that any necessary changes will be made in the upcoming batch. Hence, it allows students to take notes on the text.

"In any adoption, in any area, there will always be opportunities to enhance a program over time with supplemental materials that we deem to be appropriate," Dr. Markarian said. "When you start adoption on day one and look down the road eight years later, there are usually some pieces that have been added... The publishers will often send supplements when they see that things are needed." •

Da Vinci Student, Inglewood Resident Wins Edison Scholarship

She woke up at 4 a.m. every day and stayed after school until 6 p.m. to focus on her homework and go to tutoring. Her dream is to develop technology that will make renewable energy more efficient and inexpensive.

Centinela Valley Goes One-to-One with Chromebooks

On April 4, the Centinela Valley Union High School District Board of Education voted unanimously to approve the Digital Learning Initiative (DLI) in support of 21st Century Learning. Starting next school year, the new one-to-one initiative will provide all incoming ninth graders (approximately 1,500 students) with a brand-new Chromebook for use in school and at home. The initiative has a four-year rollout plan so that by the 2020-21 school year, all CVUHSD students will have their own Chromebook. Over 1,600 DLI surveys were completed by teachers, students, parents, administrators and staff to ensure stakeholder input and the results were 90 percent showed positive support for the program. The voter-approved local parcel tax will fund the initiative, so there will be no impact on the general fund, and it will save the District money in the long-run by phasing out textbooks.

CVUHSD teachers who implement one-to-one in their classroom will be provided Professional Learning to support the management of student devices in the classroom, effective use of

technology for learning, and digital lesson design. Students will be trained on the necessary care and maintenance of their computer, and how to behave safely and appropriately online. They will also receive instruction on Digital Literacy to improve computer and software skills. Parents will be provided information and tools to support their student's effective and safe use of their laptop at home.

The success of the one-to-one initiative is highly dependent on a network that supports uninterrupted, fast Wi-Fi connections in all classrooms, and reliable content filtering both on and off campus. The district's IT Department has taken many steps to safeguard the initiative and will continue working hard to ensure a successful rollout.

This year, the district implemented a pilot program with 25 teacher "Piloteers" to test a class set of Chromebooks and Canvas, the District's learning management system. The pilot program provided the needed groundwork in order to rollout the initiative next school year.

Animo Schools Honored with California Gold Ribbon Awards

Two Green Dot campuses, Animo Inglewood Charter High School and Animo Leadership Charter High School, last week earned California Gold Ribbon Awards, honoring the outstanding progress of their students in both math and English. To earn a Gold Ribbon, schools must exceed the state average for student performance on the Smarter Balanced Assessments. As well as using student performance, the California Gold Ribbon Schools Program takes into account a school's success in implementing a variety of educational policies and programs, including local accountability plans. The program replaced the Distinguished Schools Program, which honored schools based on student outcomes

measured through standardized tests.

The schools join Animo Pat Brown Charter High School, which won the Gold Ribbon the last time they were given to high schools in 2015. All three schools topped the state average for the number of students who meet or exceed state benchmarks on both English and math assessments in 2016, as well as the state's 2015 graduation rate. Animo Inglewood had 83 and 43 percent proficiency on the two tests respectively, and had an 86 percent cohort graduation rate. Animo Leadership achieved 85 and 35 percent marks, with a 94 percent cohort graduation rate. The state averages were 59, 33 and 82 percent.

Lawndale Youth Parade Street Closures

The 2017 Lawndale Youth Day Parade is set for Saturday, April 29 at 10 a.m. with marching bands, community organizations, school groups, classic cars and other participants on hand for the festivities. For entry and exit into or out of the area bounded by Manhattan Beach Boulevard to the south, Hawthorne Boulevard to the west, Marine to the north and Prairie to the east, Freeman Avenue at Manhattan Beach Boulevard and Marine will be the entry and exit points. There may be delays entering and exiting this area based upon the location of the parade. Seating areas for the parade will be available at any place along the route on Manhattan Beach Boulevard, Hawthorne Boulevard, Marine and Prairie.

Lawndale Baseball Heading in Right Direction

Head coach Robert Dempsey has his Lawndale Cardinals baseball team headed in the right direction after a rough start to the regular season. A five-game losing streak that was almost immediately followed by a four-game losing streak earlier in the year had Cardinals fans reminiscing about an unfortunate season last year when Lawndale went 10-12 on the year and only finished above Hawthorne in the Ocean League standings. A recent three-game winning streak, capped off with a win against the North High Saxons last Tuesday afternoon on the road, has recently given the Cardinals and their fans something to be optimistic about going forward.

Lawndale's recent winning streak was at its beginning stages almost four weeks ago when the team took on the University Wildcats. The Cardinals offense exploded and accounted for 10 total runs with the help of back-to-back four-run innings. Senior Jesus Sanchez was instrumental in breaking Lawndale out of its slump and finished the day with a double, two runs scored and four RBIs. Senior Salvador Mercado also doubled and drove in three in the 10-2 victory for the Cardinals.

An inner-division game against Culver City was next up on the schedule for Dempsey and the Cardinals. "We lost to the Centaurs earlier in the year," Dempsey explained. "It's important for us to go out there and win these games in the division that really count in the end-of-the-year standings." Sensing the importance of the moment, the Lawndale offense came alive again and brought the team back from an early 3-0 deficit that Culver City jumped out to in the first inning. Leo Cervantes gave up an early three runs on the mound, but soon settled in to pitch a total of five innings while striking out two. Cervantes was also one of four Cardinal batters to double in the game and knock in a run. Junior Julian Diaz had two hits and an RBI as Lawndale put together back-to-back two-run innings in the sixth and the seventh to take a 6-3 victory over its divisional rivals.

The Cardinals' most recent game was up next and the offense didn't slow down one bit. Last Tuesday at North, Lawndale jumped out to an early 4-0 lead on the Saxons before exploding for five runs in a sixth inning that sealed the win for the team. This time Sanchez was on the mound, going five innings while allowing four hits and two runs. North was able to tag Cervantes for three runs and senior Michael Zambrano for another, but Lawndale's offense was too much for its opponent once again. Mercado went four for five with two RBIs and

scored one run. Diaz scored three times and drove in two runs, while senior Roberto Novela also had a hit and drove in two.

The Cardinals (5-9, 1-3) are gaining momentum when they need it the most down the stretch run of the regular season. The team will still be tested with upcoming games against the second place El Segundo Eagles and the third place Beverly Hills Normans. If Dempsey and his hot-hitting team can string together a few more wins in the final stages of the season, they may even be able to challenge some of the Ocean League's best for a top seed in the division.

HAWTHORNE HIGH

The Hawthorne Cougars have been unsuccessful in their recent attempts to take down two of the Ocean League's top three teams. Despite junior Johnny Pacheco's recent dominance at the plate, Hawthorne has been unable to keep the opposition off the scoreboard. Pacheco had an incredible day in the Ocean League opener, going two for four with four RBIs in the game. The pitching staff has been Hawthorne's weak link all season long, though. A total of 10 walks and eight hits given up by four different pitchers led to 12 runs for Santa Monica in a 12-4 loss for the Cougars.

Hawthorne moved on to battle the Beverly Hills Normans and lost back-to-back games against its league rival to drop to 0-4 in league play this year. In the series finale, the Cougars kept things close. Pacheco pitched three solid innings, but only after the Normans were able to get to senior Andres Cordova for three runs over two innings. Cordova went one for three at the plate with a double and an RBI, but it wasn't enough in his team's 3-2 loss. Hawthorne (5-9, 0-4) will take on Culver City this week as the team looks to get out of last place in the Ocean League standings.

INGLEWOOD HIGH

After a great start to the season, the Inglewood Sentinels baseball team has run into a Bay League schedule that simply has their number. The Sentinels latest hurdle came in the form of the Redondo Union Sea Hawks in a game that took place last Wednesday afternoon at Redondo. The Sea Hawks didn't hesitate to put runs up on the board, scoring four in the first inning alone. Redondo used four different pitchers in the game, accounting for 12 strikeouts and zero runs scored. Inglewood's 12-0 setback at the hands of Redondo marked its third loss in a row. The team has been outscored by a total of 46-1 across those three games. The Sentinels will move on to battle against Mira Costa and Peninsula down the stretch run of the season.

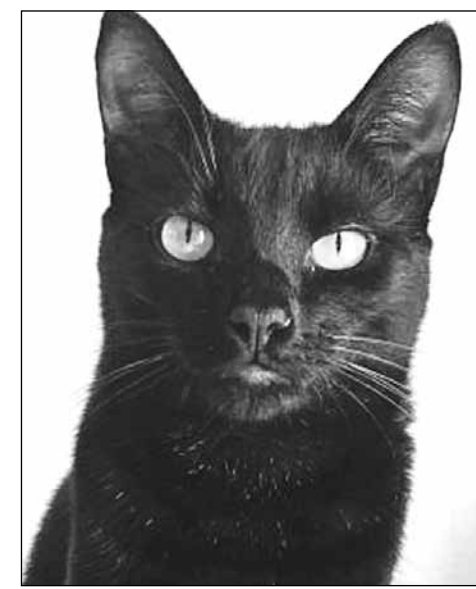

he realized. Those sectors alone account for nearly half of the 24 million jobs.

The other big contributors to government employment are active-duty military and government hospitals, Ballmer learned. No longer faceless bureaucrats, the government workforce looks much different because "most of these people you like," Ballmer says. "Your tax dollars are helping somehow to pay 24 million people" who have mortgages, car payments and families to feed.

How much money does state and federal government collect per year? The number is \$5.2 trillion, mostly from tax collection, according to USAFacts. Interestingly, the government also makes money on investments and runs several profitable businesses. State-run enterprises turn a profit on airports, public hospitals, transit systems and waste-management operations.

States that run a lottery lose money on that form of gaming and on gas and electric utilities. Ports, toll highways and parking lots break even, generating enough revenue to cover state expenses, according to USAFacts.

The federally-run business that weighs most heavily on Washington's balance sheet is the U.S. Postal Service. The nation's letter and package carrier didn't always lose money. The losses began in 2013 and have continued due to increased competition for package delivery and lower sales of stamps and postage. The Postal Service posted a staggering \$1.6 billion loss in 2015, the website shows.

Marriages, the nation's divorce rate and average family size are all listed here. And that's not all. Having run Microsoft and now the L.A. Clippers, Ballmer says he likes reading reports that summarize facts and figures into a simplified narrative. How are we doing financially? Are we meeting our goals? Were our projections right?

U.S. corporations must explain their finances and performance in an annual report called a 10-K, prepared for the Securities and Exchange

Commission. Ballmer's website team has done the same, compiling an annual report about U.S. government performance and salaries. The president's salary of \$400,000 per year isn't a secret, but how much does the vice president earn annually? The answer is \$237,700, making the veep the third-highest paid executive in Washington. Chief Justice John Roberts is second at \$260,700, according to USA Fact's 10-K.

Which state's governor had the highest salary last year? California finished third in this spending category, behind top-ranked Pennsylvania (\$190,000) and Tennessee (\$187,000). Being the top elected official in the state doesn't always translate into buck bucks, not for the governors of Arizona, Colorado, Kansas, Maine and Oregon who earn less than \$100,000 per year for their official duties.

With the South Bay's reliance on space systems and defense, the categories that Ballmer labels "Provide for the Common Defense" and "Promote the General Welfare" include columns for the nation's spending on its military (\$812 billion) and space programs \$16.6 billion). States outspend the federal government by a nearly four-to-one ratio in support of the economy and on roads and bridges and other essential infrastructure.

The California Legislature just passed a \$53 billion road repair plan for fixing local roads and state-maintained highways in South Bay cities and Los Angeles County and elsewhere over the next decade. Those repairs will be financed by higher fuel taxes paid by motorists and businesses, and vehicle registration fees. The bill, SB 1, also charges electric-vehicle owners a new annual fee.

The billionaire sports owner says he's not trying to change anyone's mind about the role of government either. His mission is to keep connecting reams of spending and revenue data from across America's villages, towns, cities, counties and states, plus the federal government. •
